The ornamental design for a belt accessory holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of the belt accessory holder of the present invention;

FIG. 2 is a top perspective view of the belt accessory holder thereof;

FIG. 3 is a top perspective view of the belt accessory holder with the belt strap fastened;

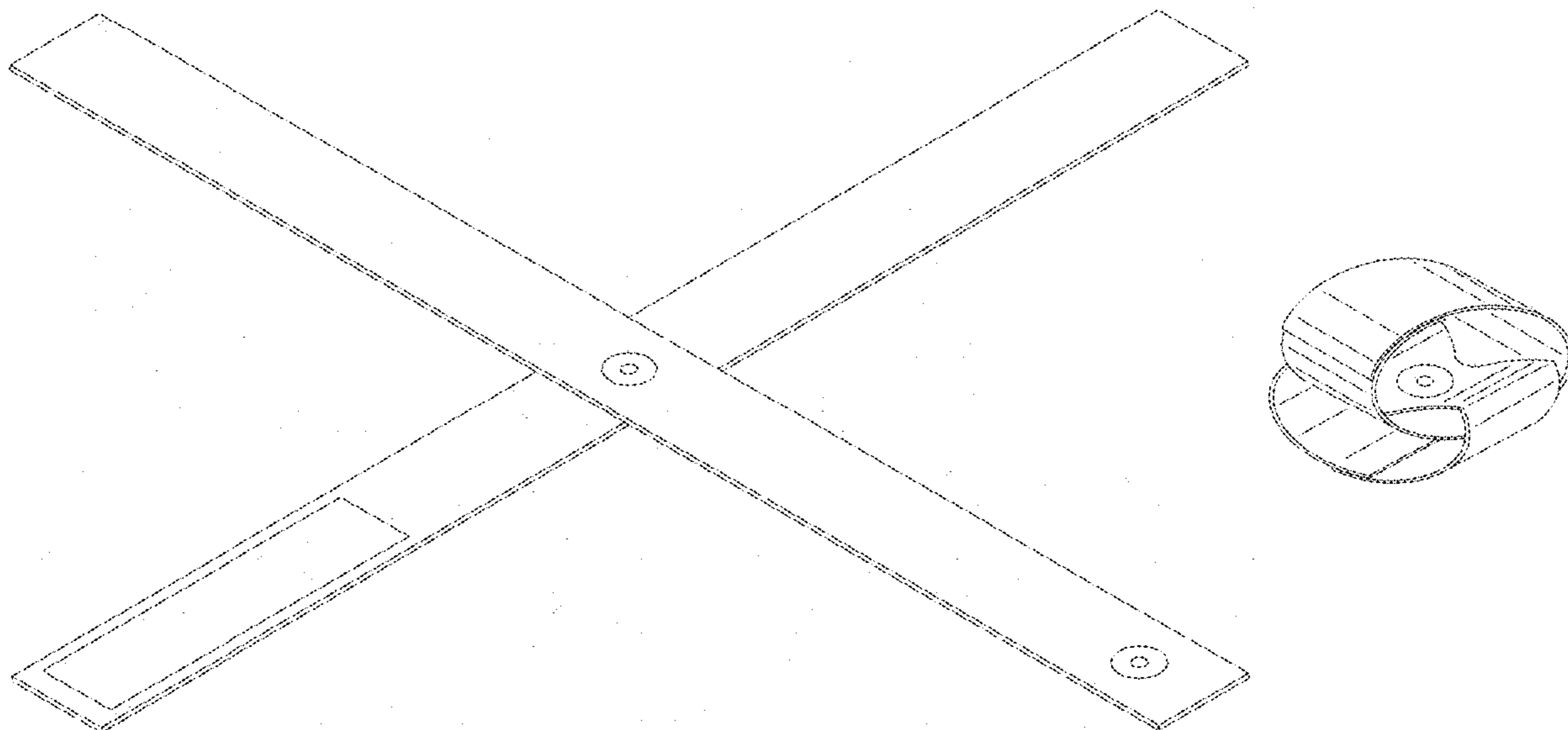
FIG. 4 is a top perspective view of the belt accessory holder with the belt strap and accessory strap fastened;

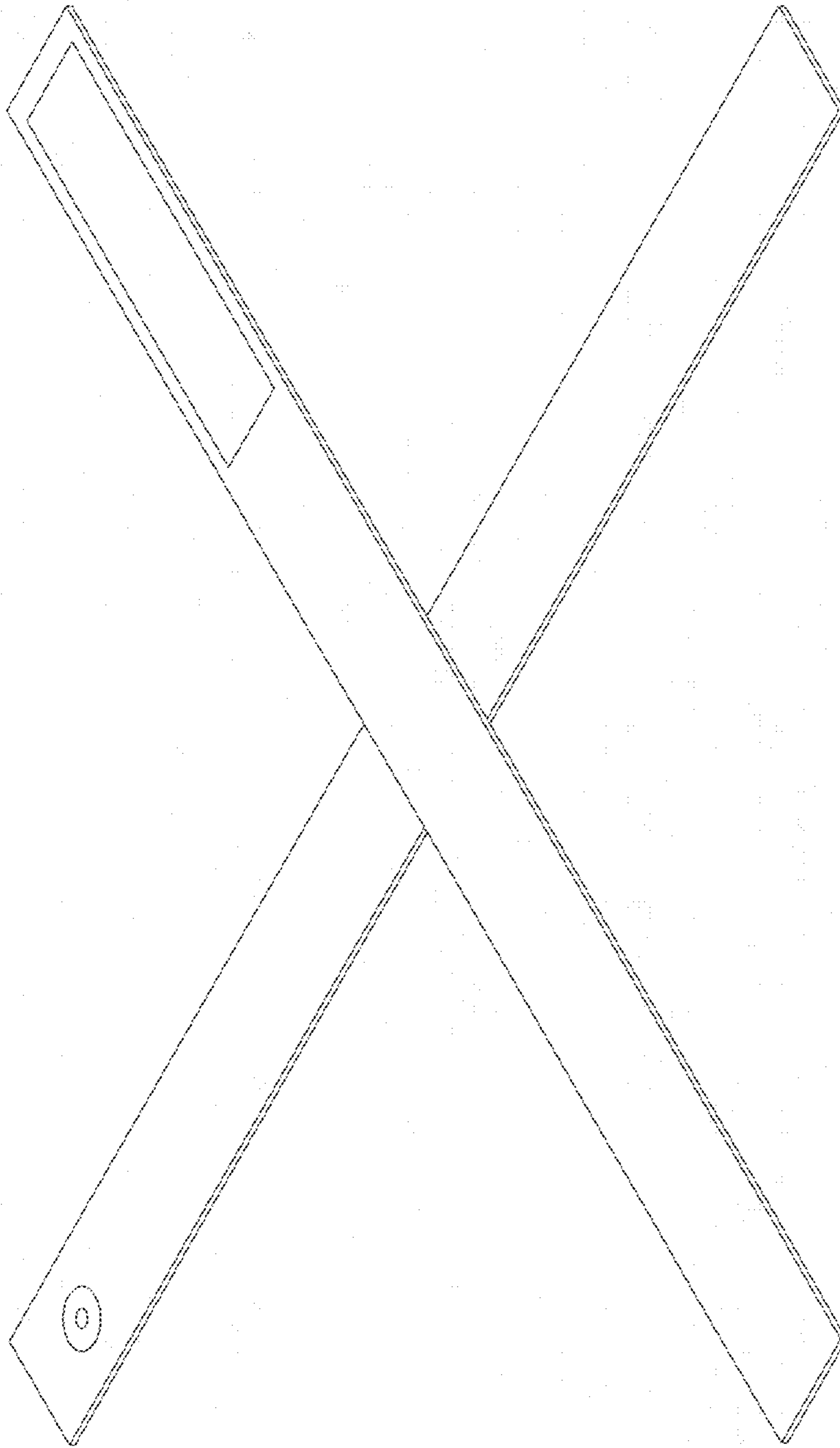

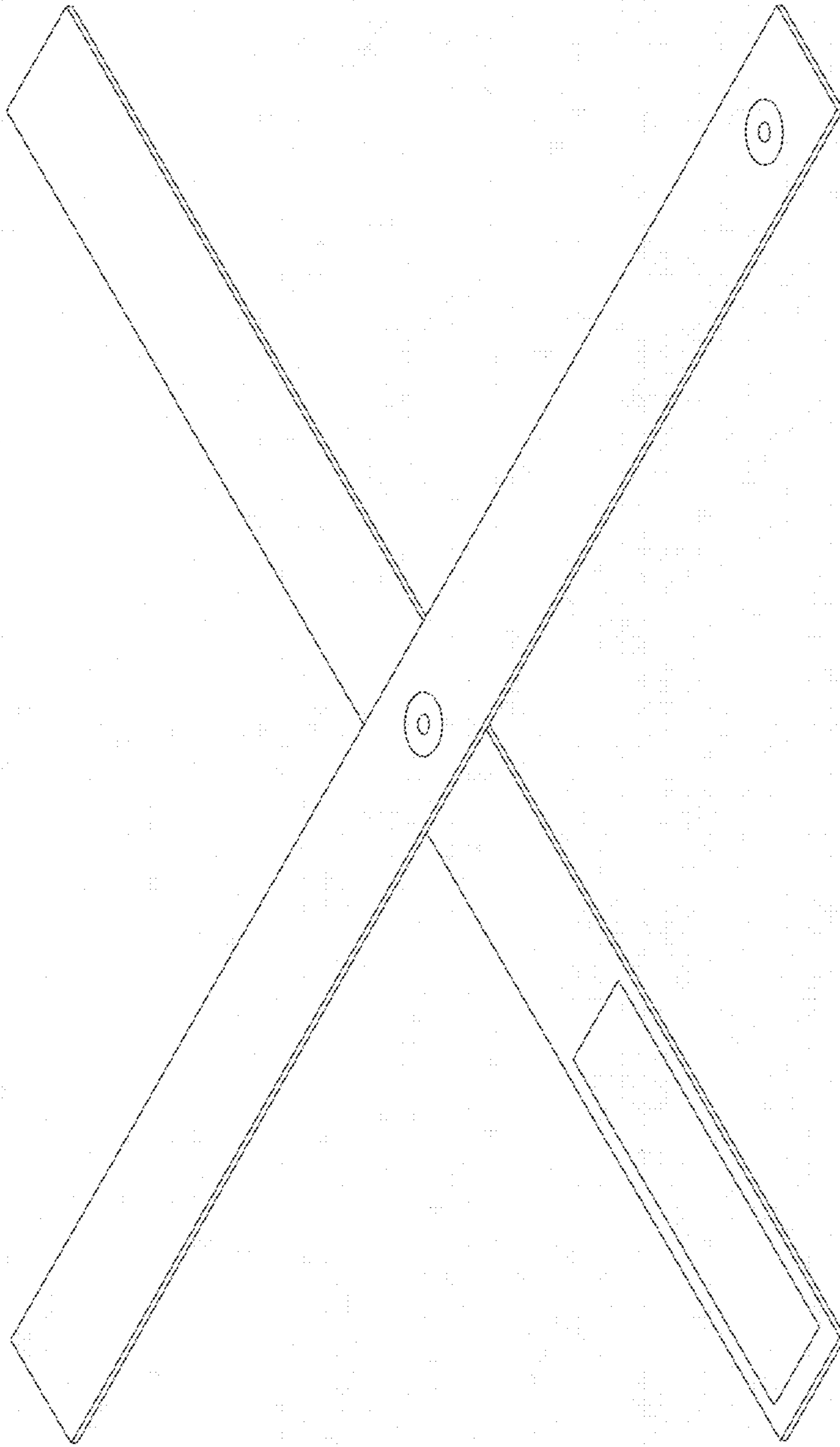
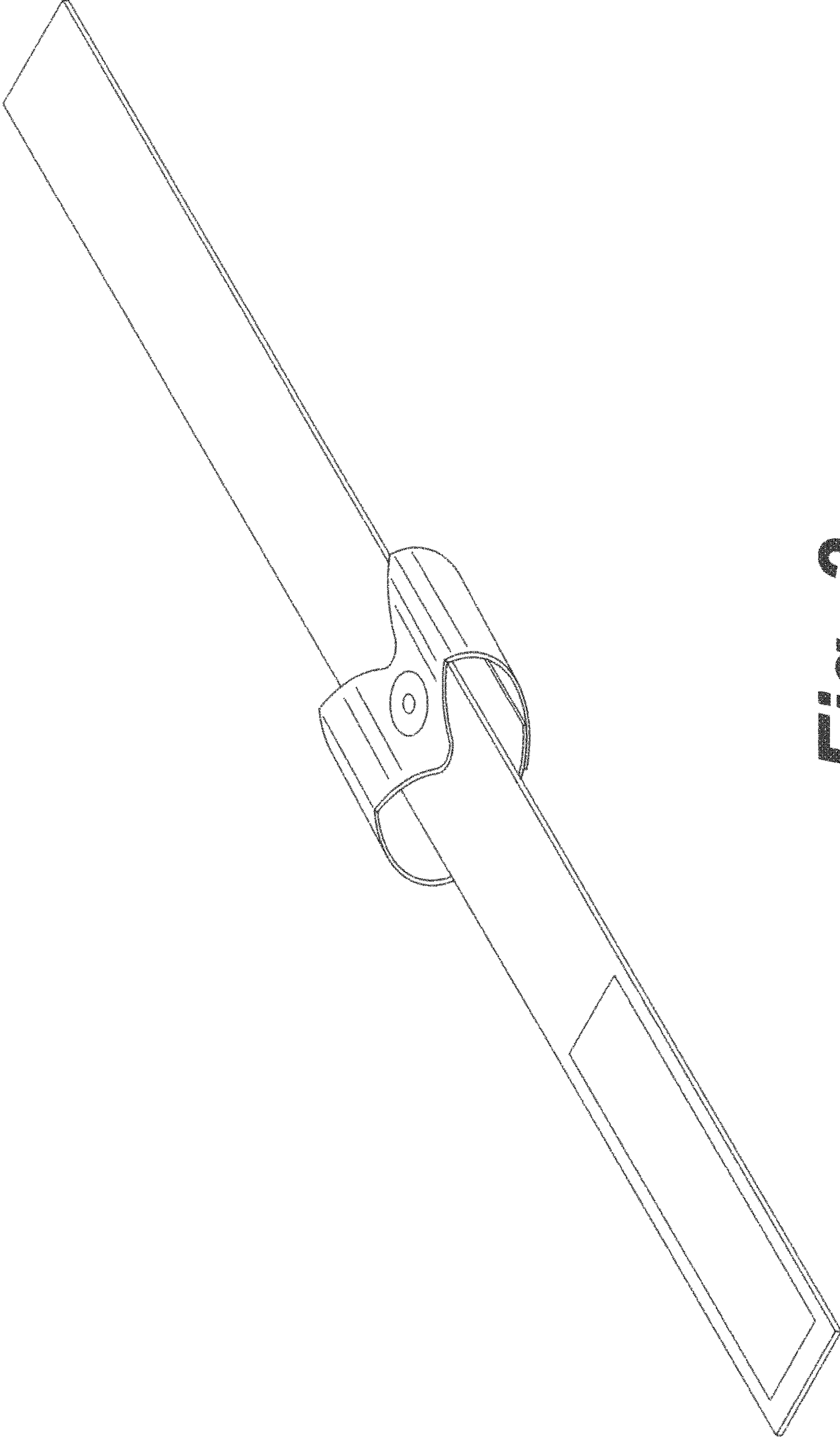
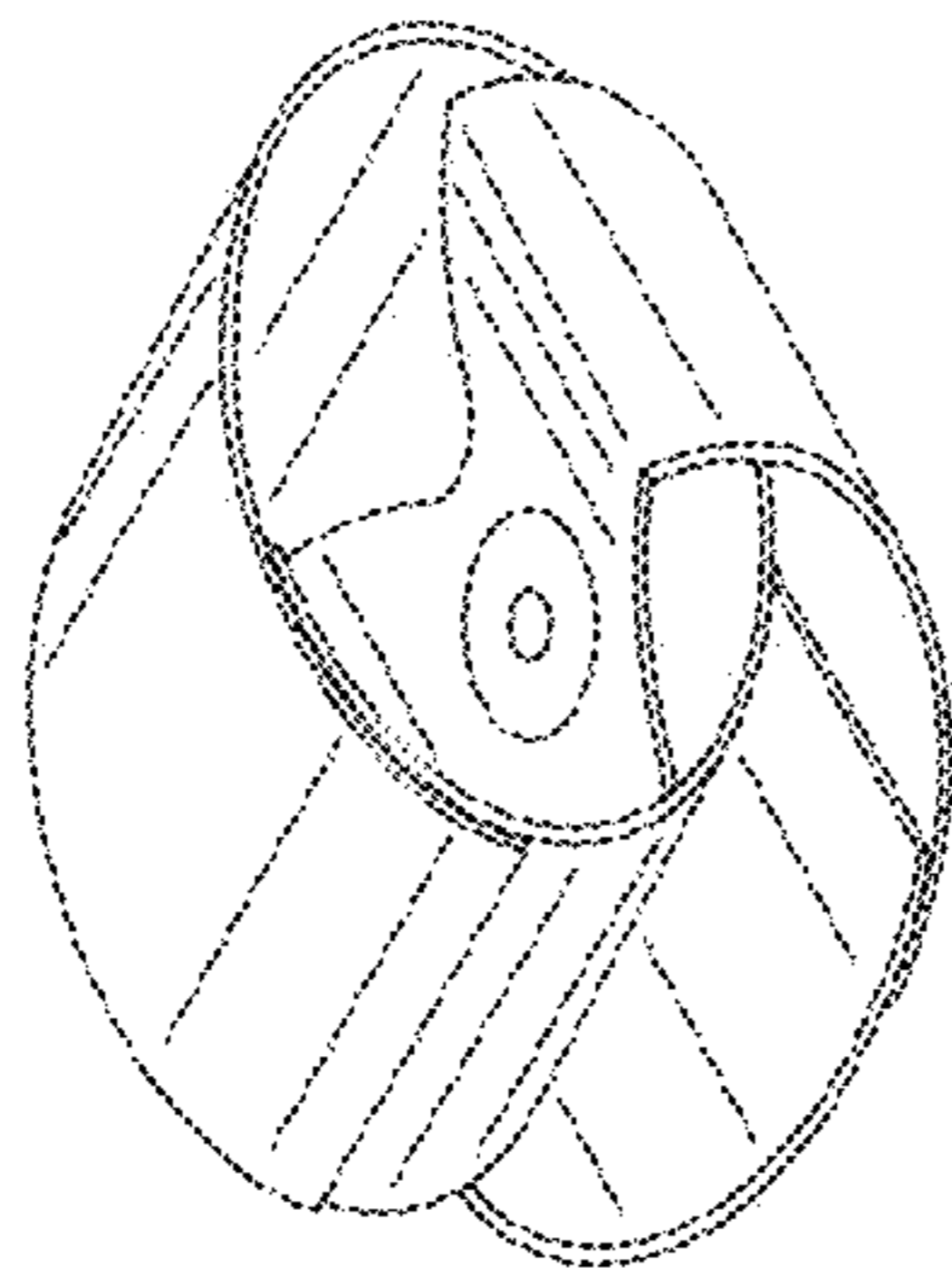


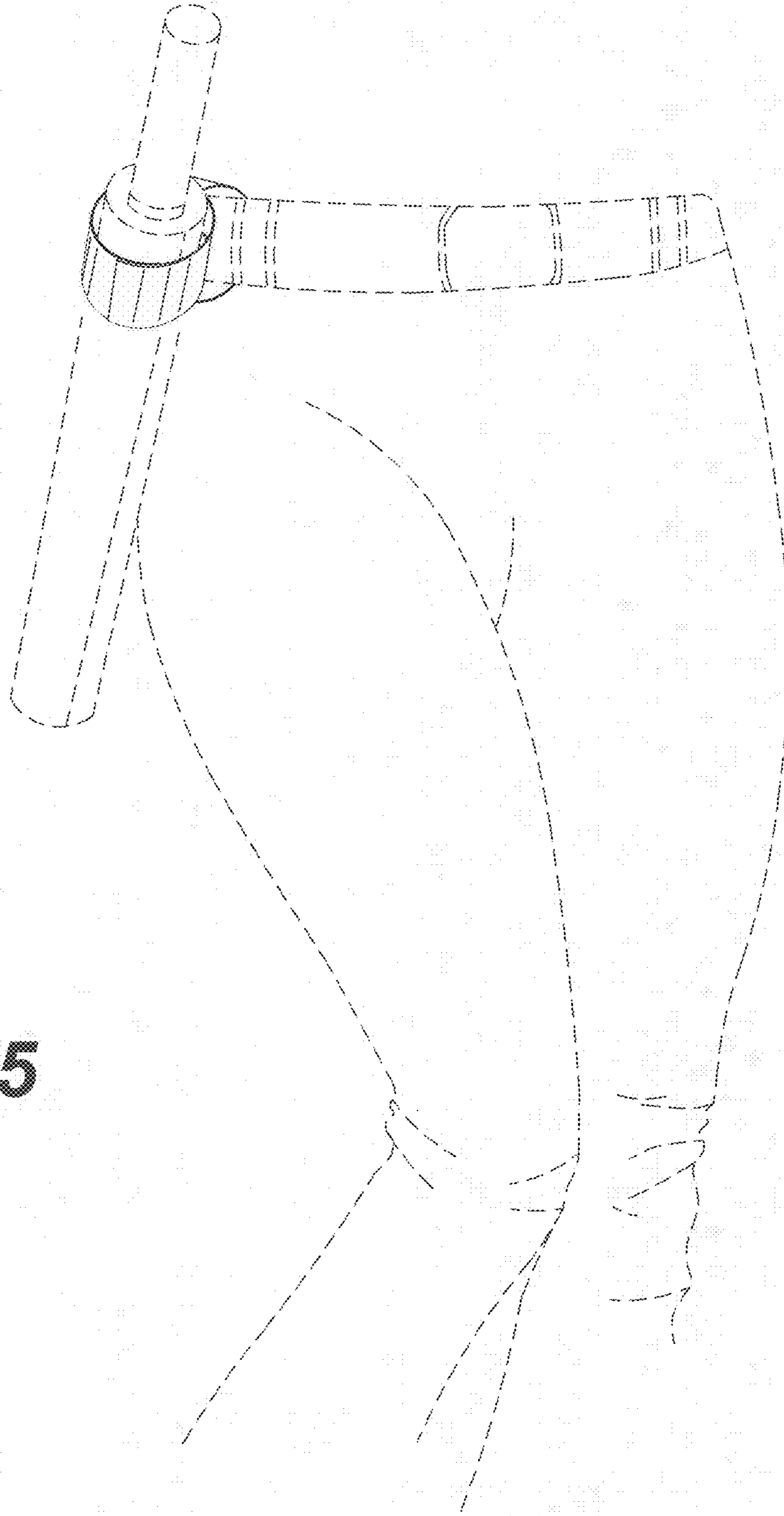
