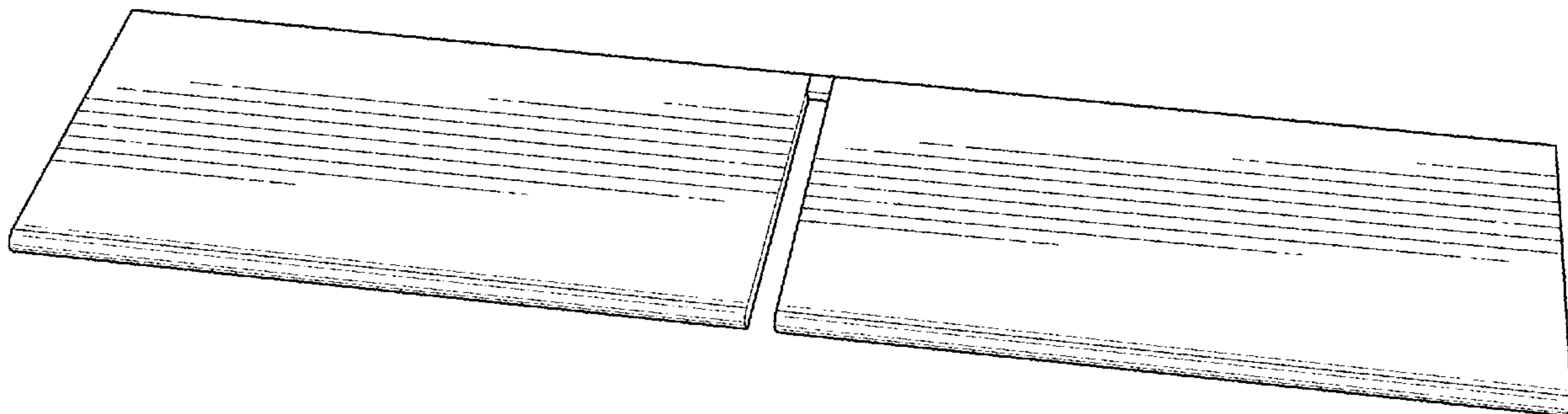
(57) **CLAIM**

The ornamental design for a charcoal grill divider, as shown and described.

**DESCRIPTION**

FIG. 1 shows a perspective view of the charcoal grill divider.  
 FIG. 2 shows a front elevation view of the charcoal grill divider.  
 FIG. 3 shows a rear elevation view of the charcoal grill divider.  
 FIG. 4 shows a left side elevation view of the charcoal grill divider.  
 FIG. 5 shows a right side elevation view of the charcoal grill divider.  
 FIG. 6 shows a top plan view of the charcoal grill divider; and,  
 FIG. 7 shows a bottom plan view of the charcoal grill divider.  
 The shade lines in the Figures show contour and not surface ornamentation.

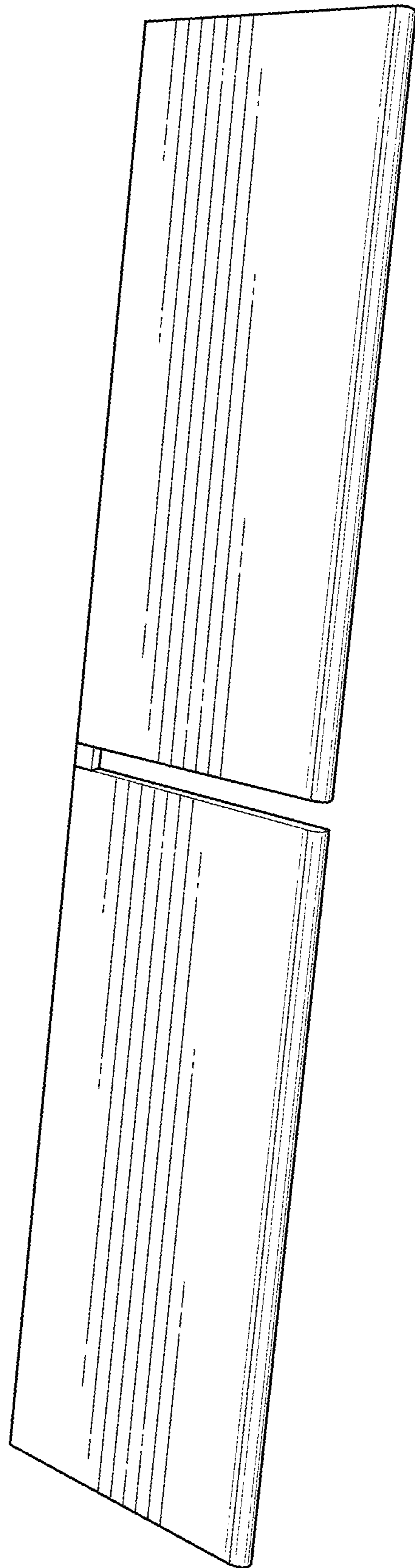

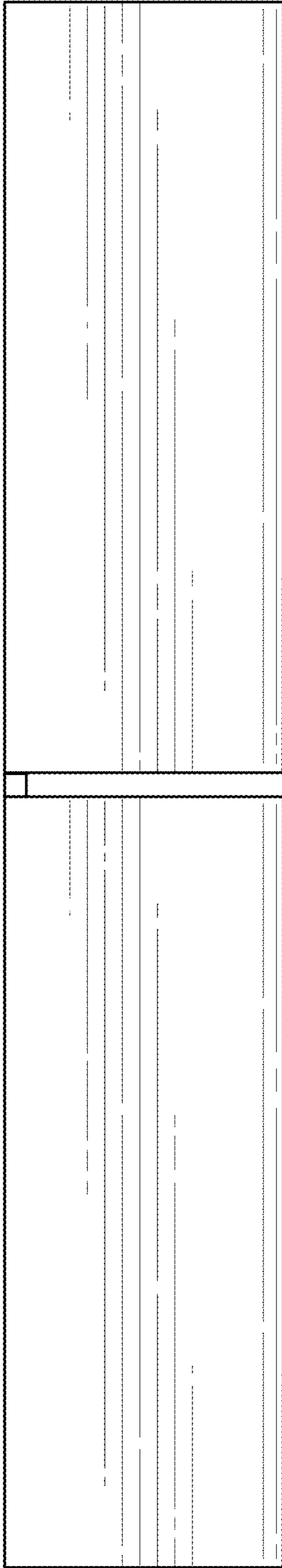

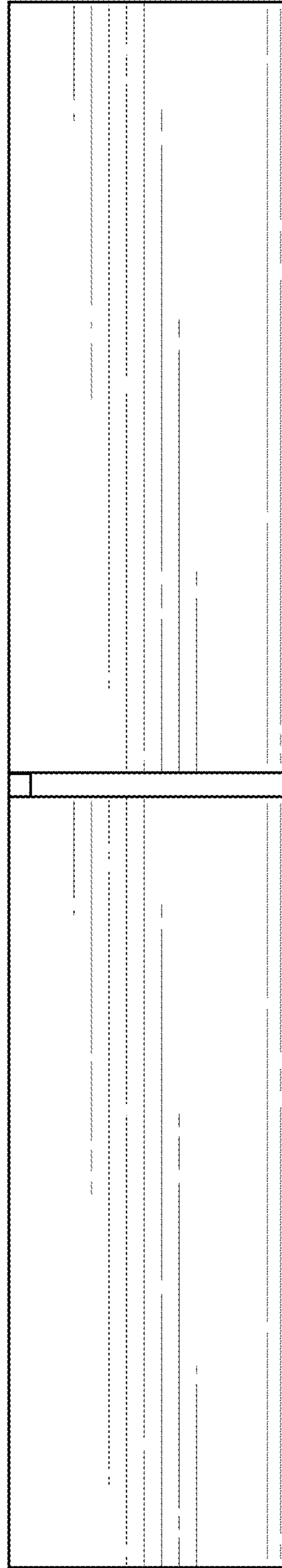
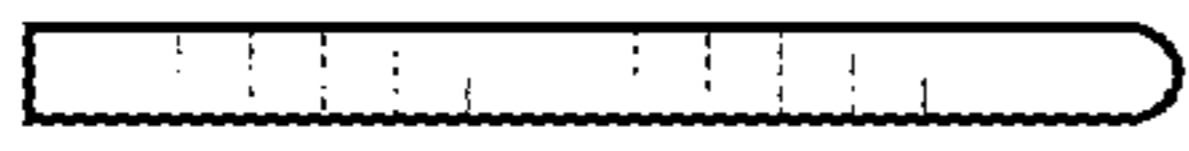
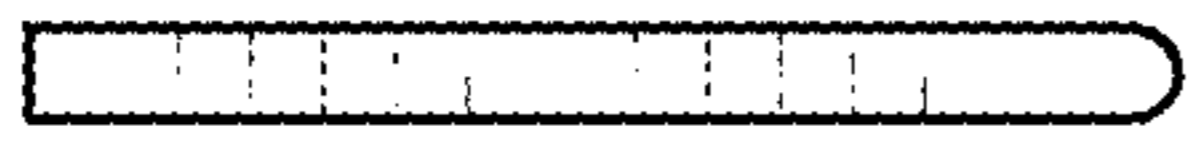
