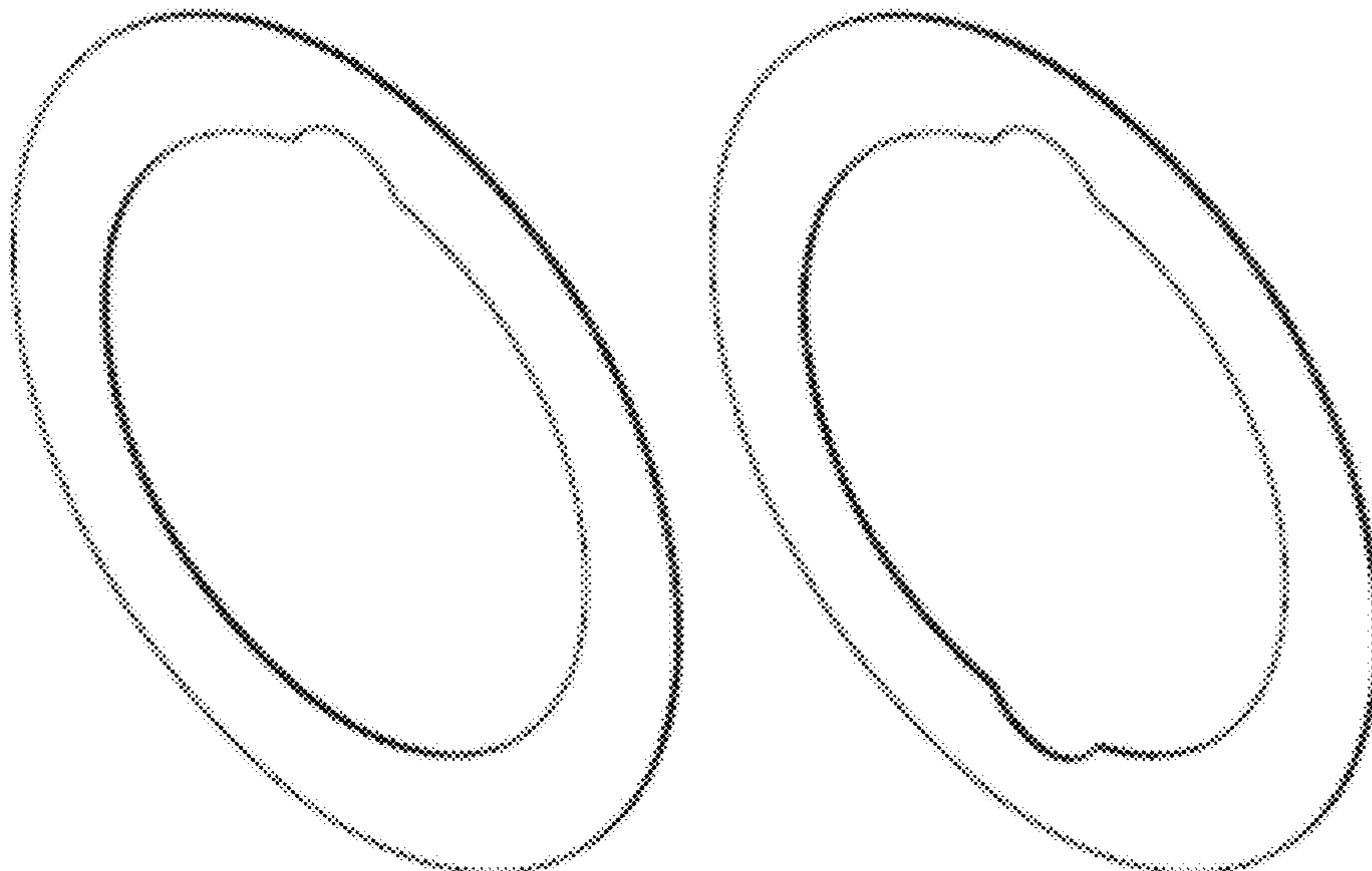
(57) **CLAIM**

FIG. 1 is a perspective view of a first embodiment of a shim;
FIG. 2 is a front view of the shim of FIG. 1, with the rear
view being a mirror image thereof;
FIG. 3 is a side view of the shim of FIG. 1;
FIG. 4 is a perspective view of a second embodiment of a
shim;

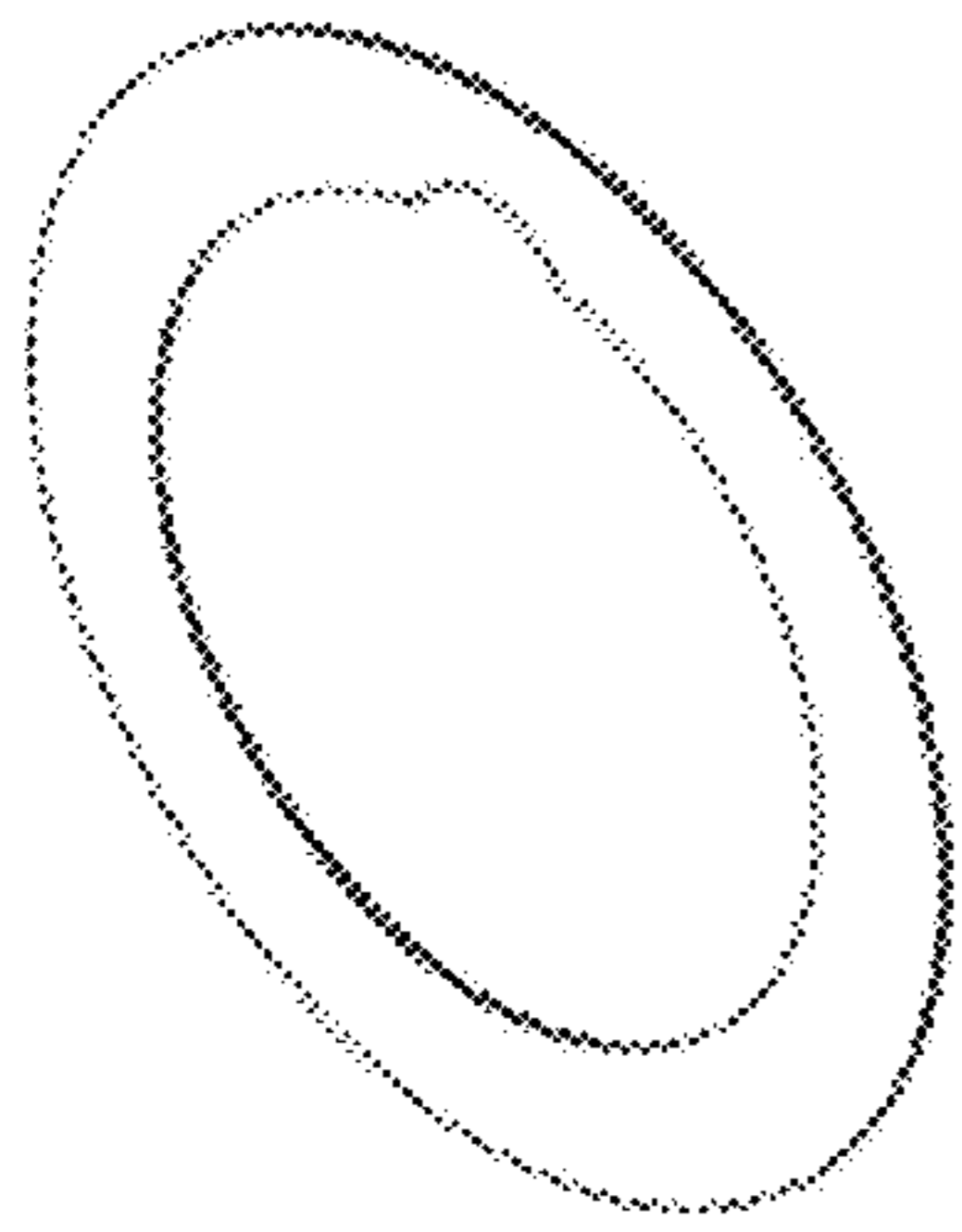

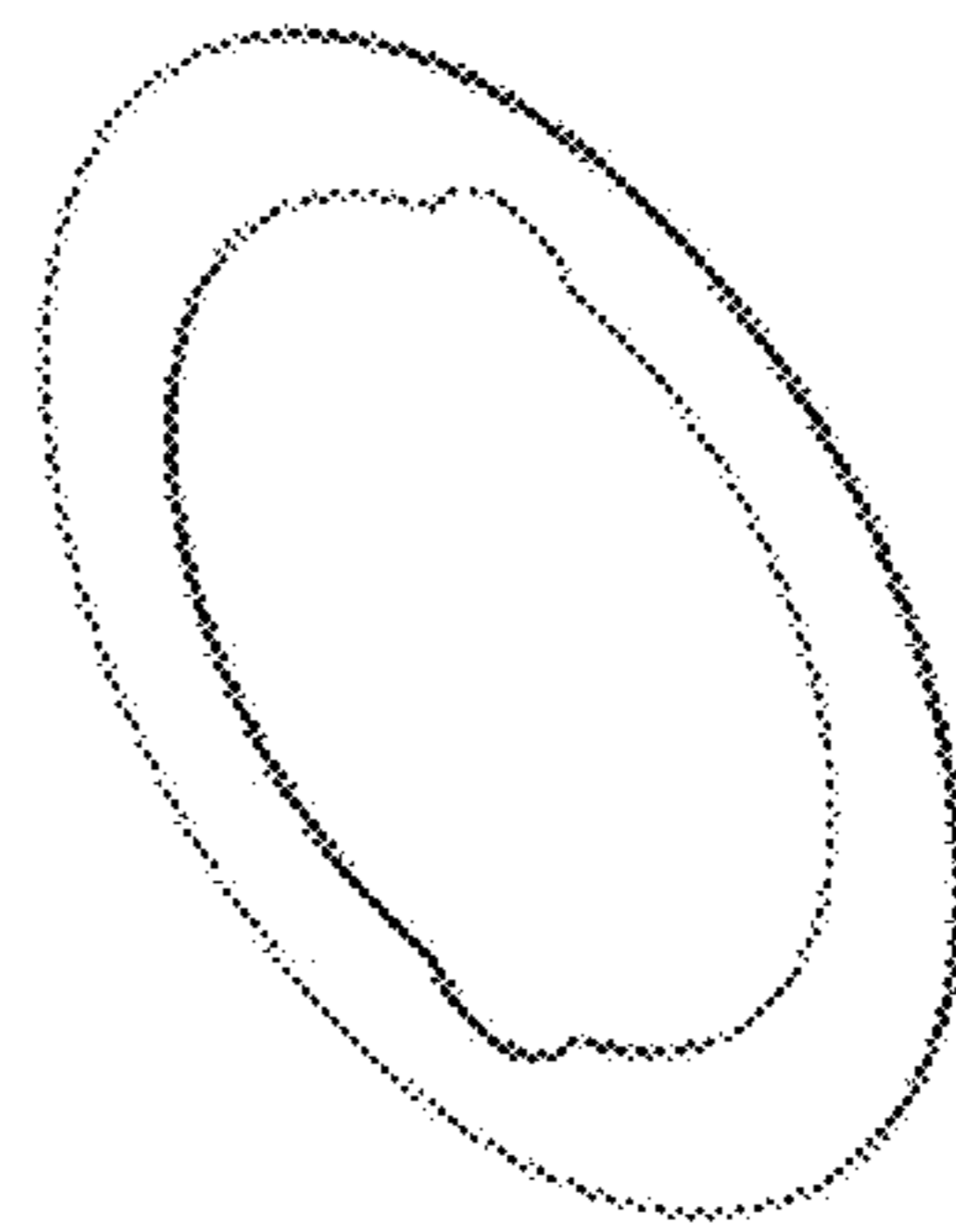

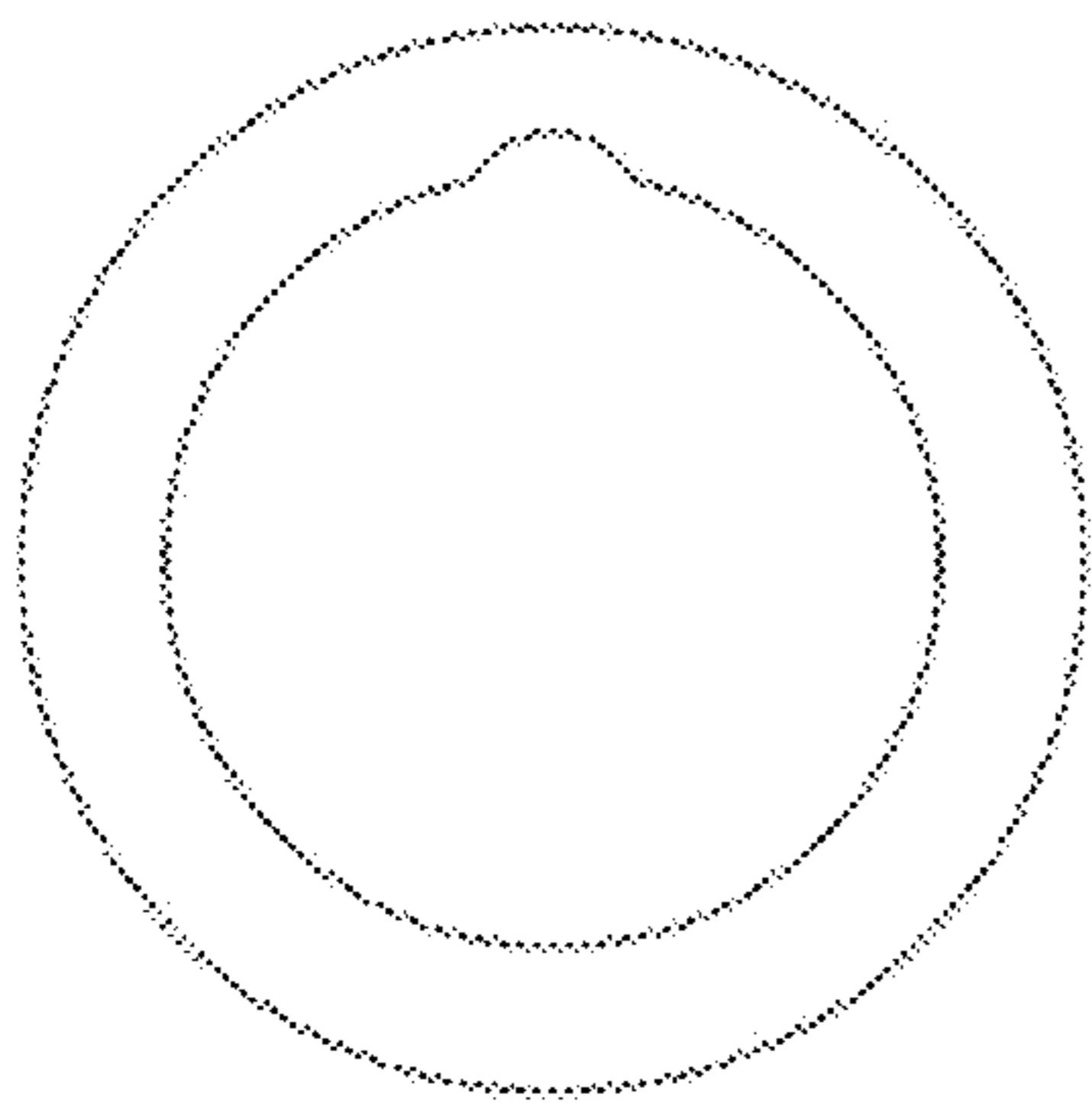

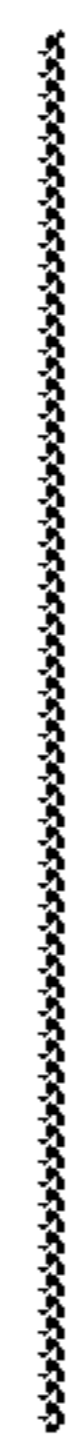

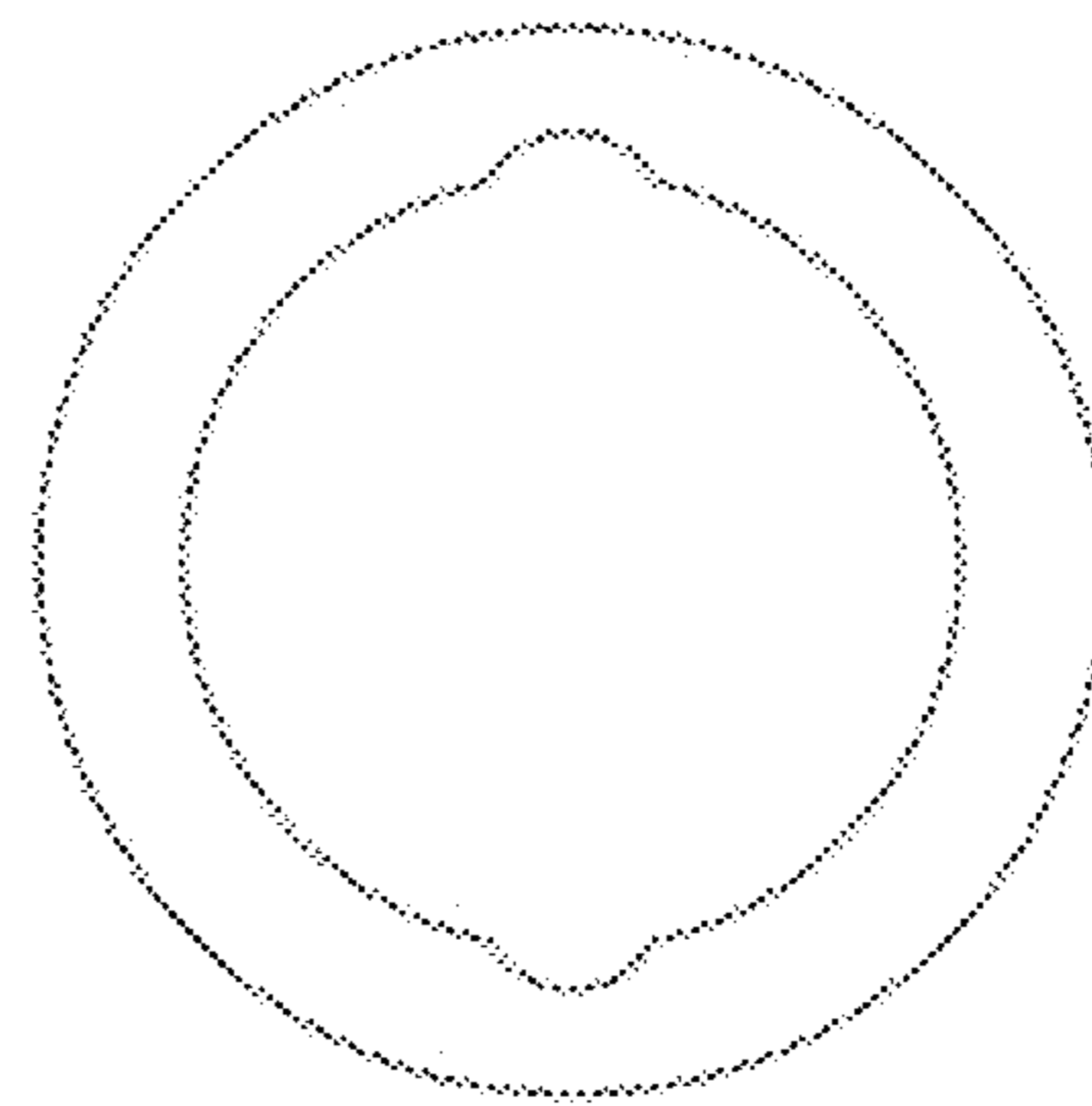
