(57) **CLAIM**

The ornamental design for an operating panel for elevator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an operating panel for elevator showing a first embodiment of my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a partially enlarged view taken along line 8-8 of FIG. 1; FIG. 9 is an enlarged cross-sectional view thereof; taken along line 9-9 of FIG. 2, with the internal system omitted; and, FIG. 10 is a reference view showing the state in use.

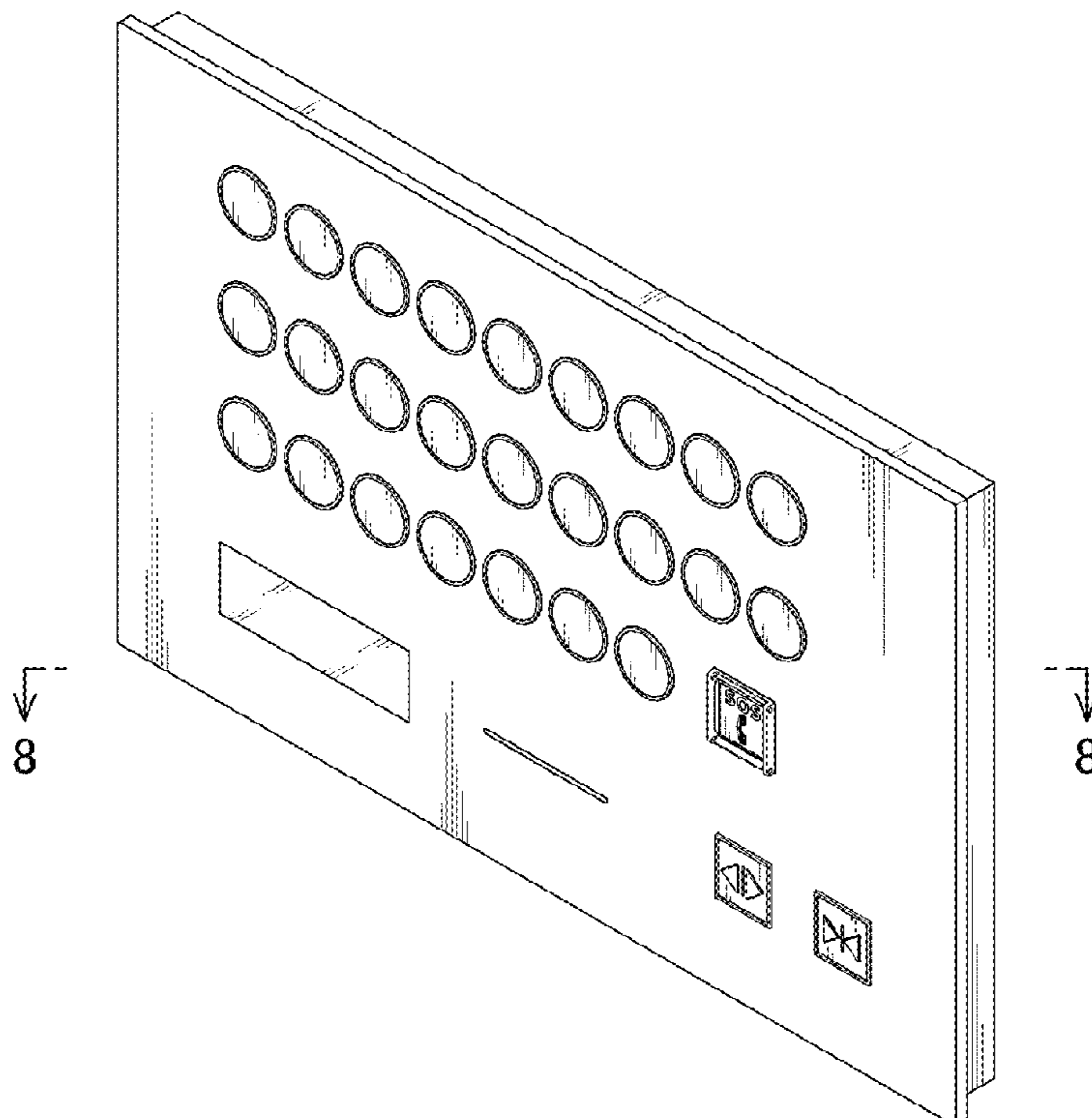

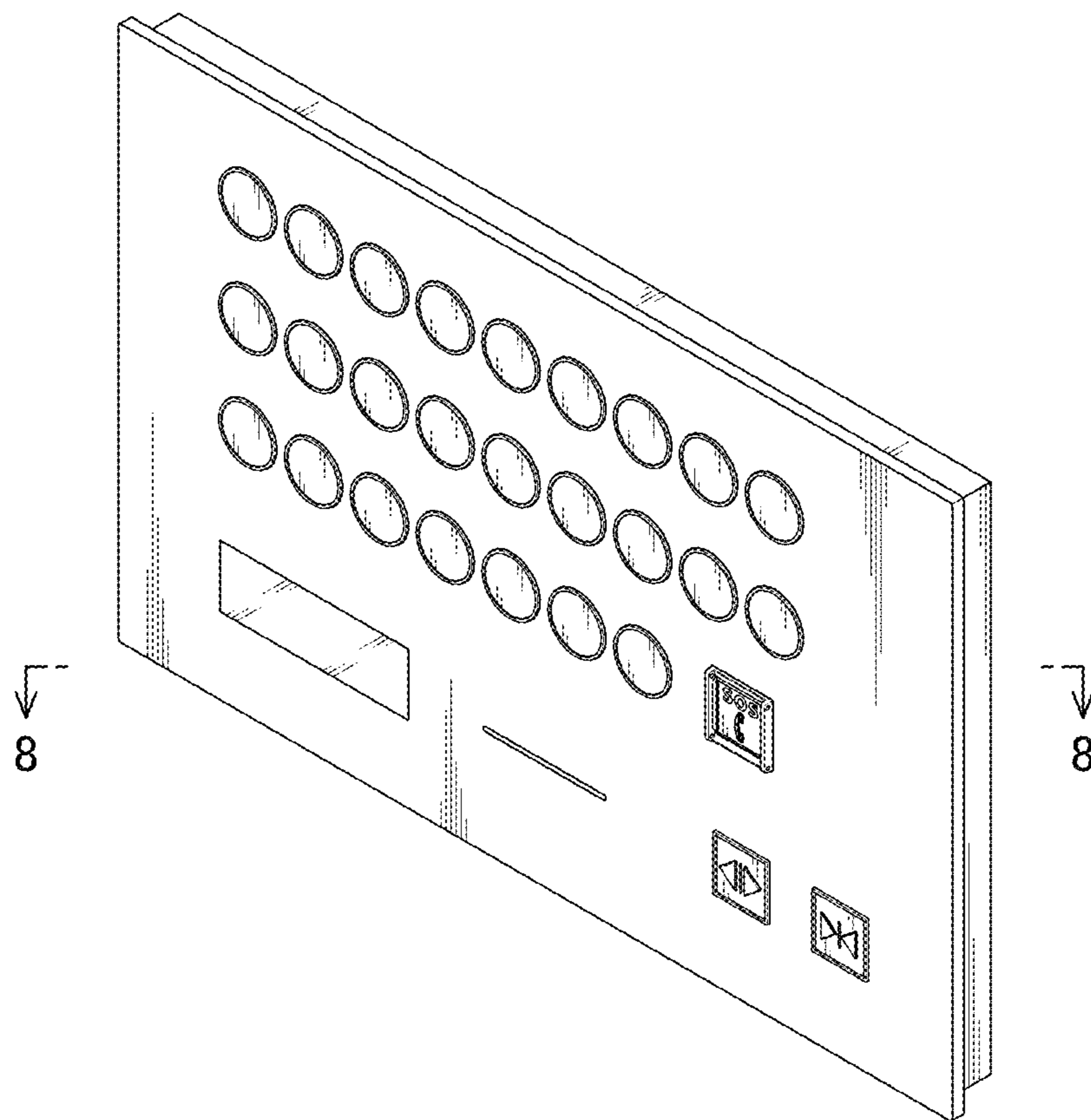

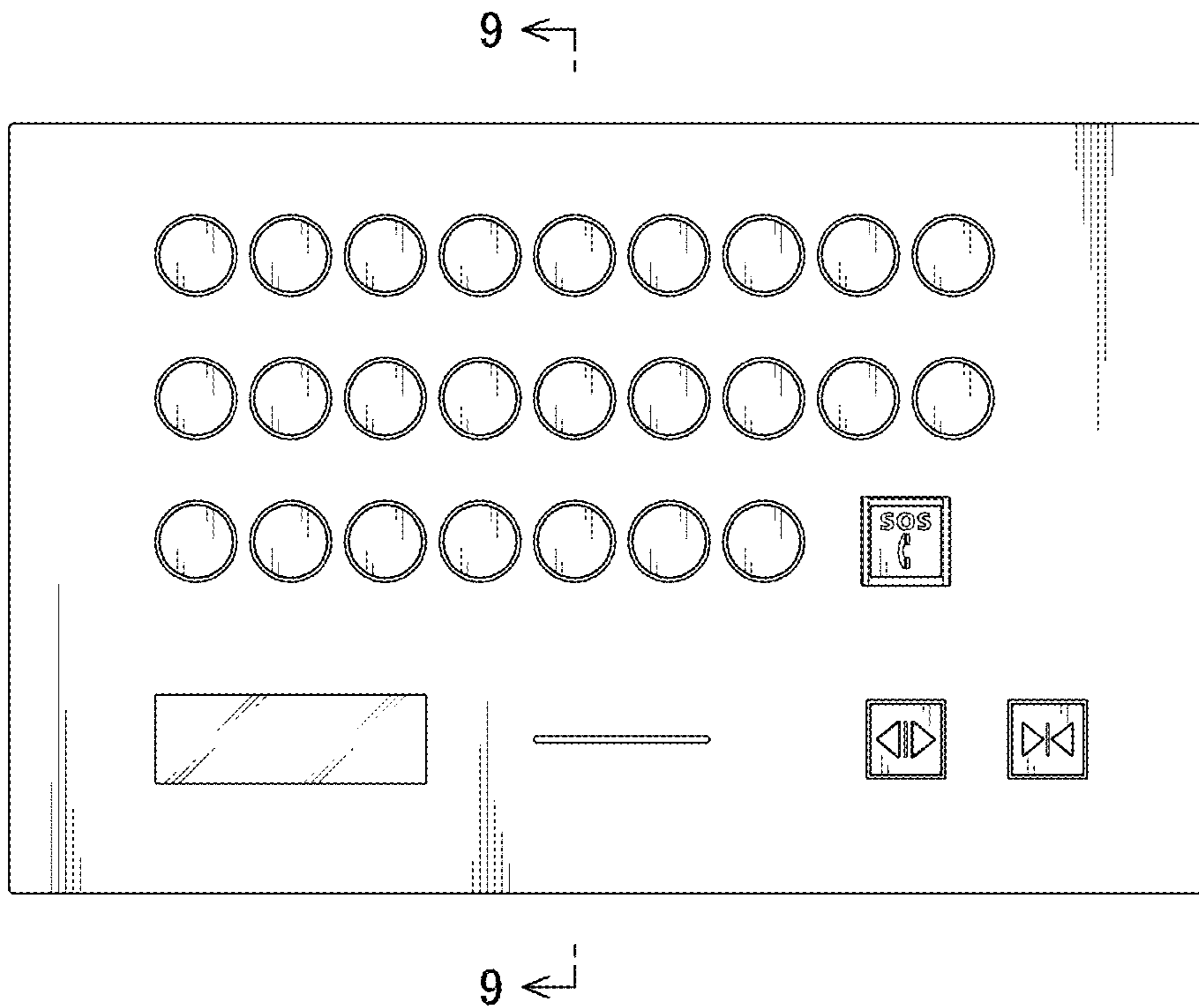

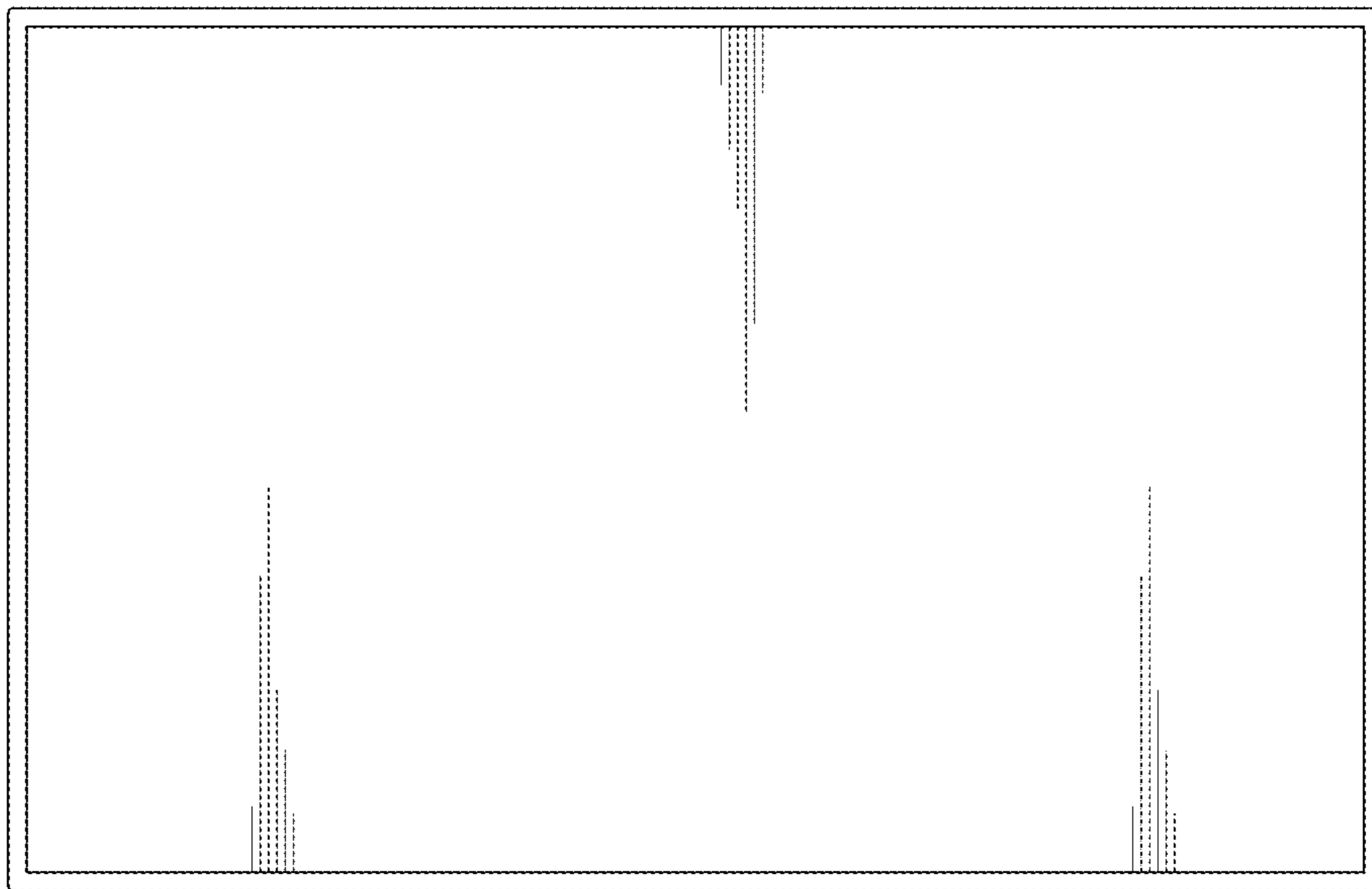

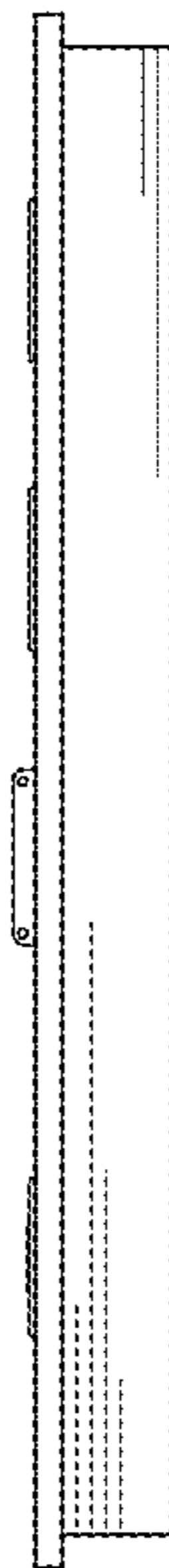

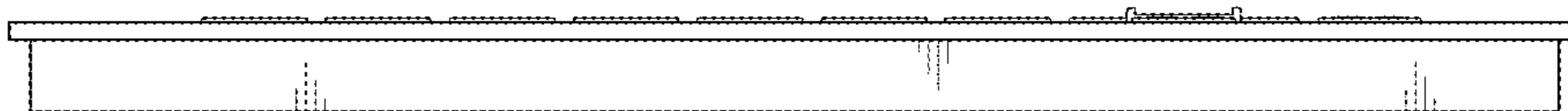

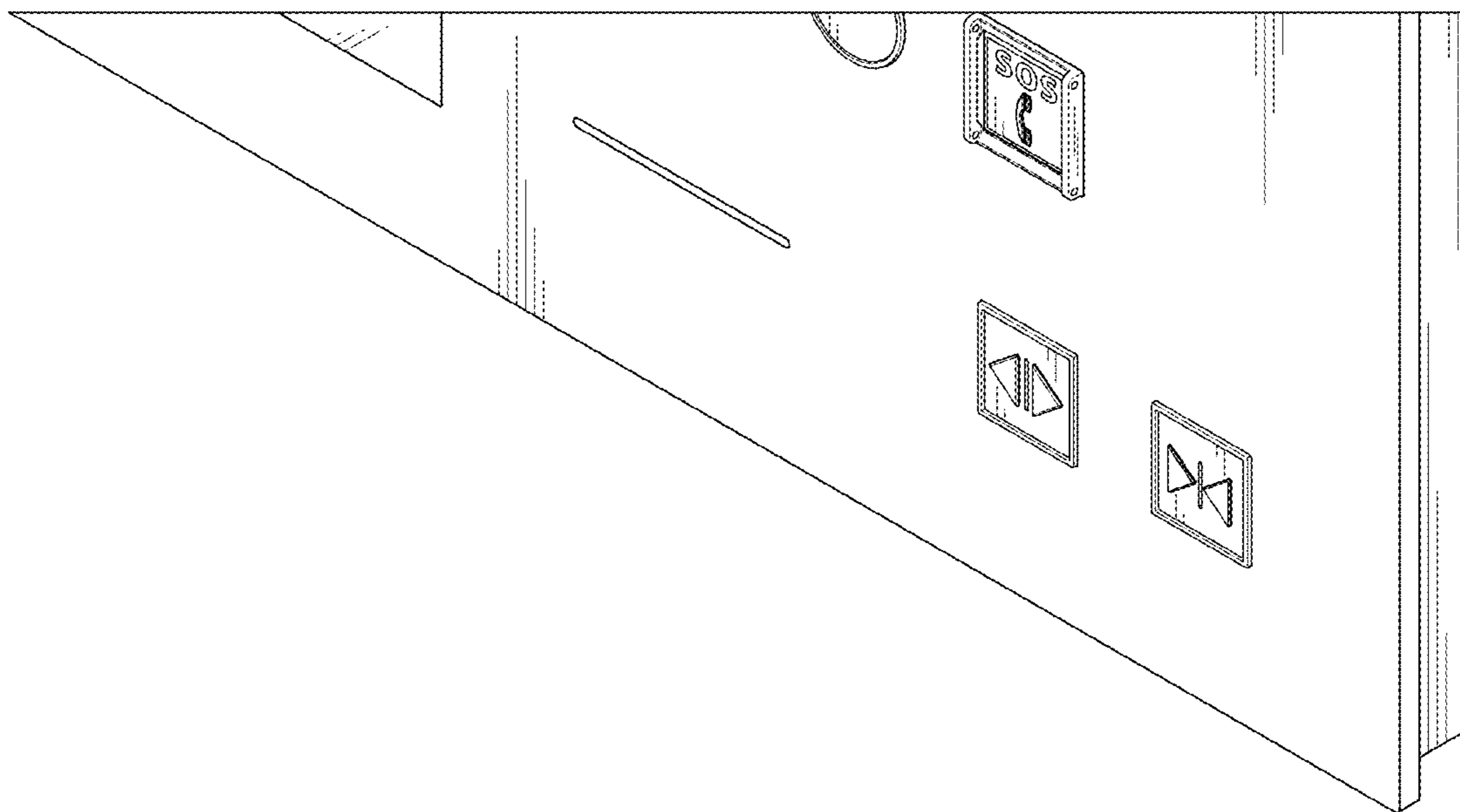

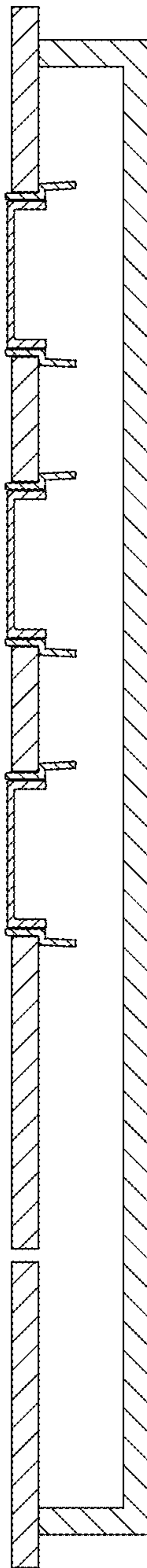
