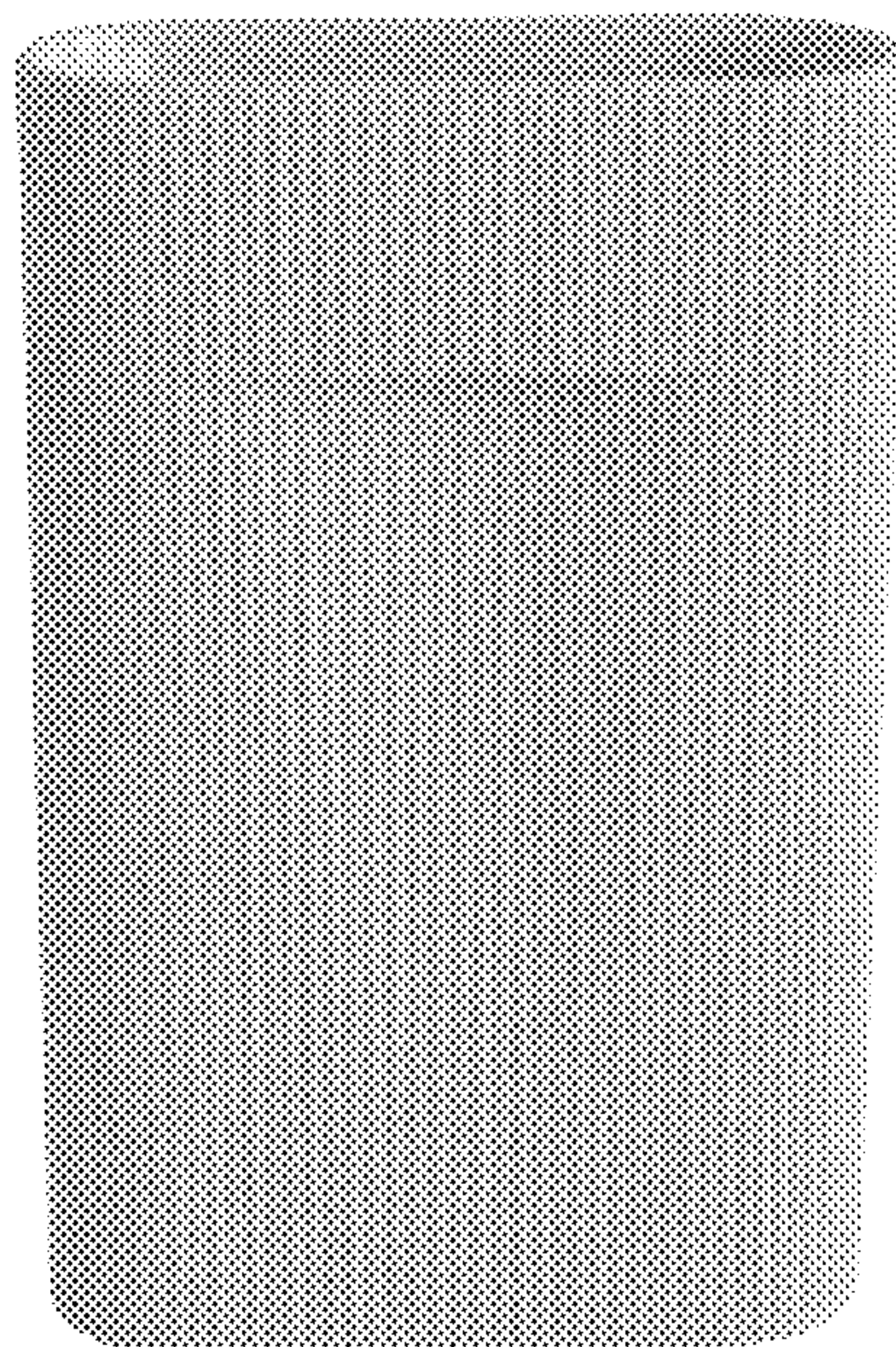
(57) **CLAIM**

The ornamental design for a ridge vase, as shown and described.

DESCRIPTION

- FIG. 1.1 : Is a front perspective view of a ridge vase embodying my new design;
- FIG. 1.2 : Is a rear perspective view thereof;
- FIG. 1.3 : Is a left perspective view thereof;
- FIG. 1.4 : Is a top, front, and right side perspective view thereof;
- FIG. 1.5 : Is a top plan view thereof;
- FIG. 1.6 : Is a bottom plan view thereof; and,
- FIG. 1.7 : Is a partial and enlarged front elevation view thereof, in which the area of enlargement is taken at the top.

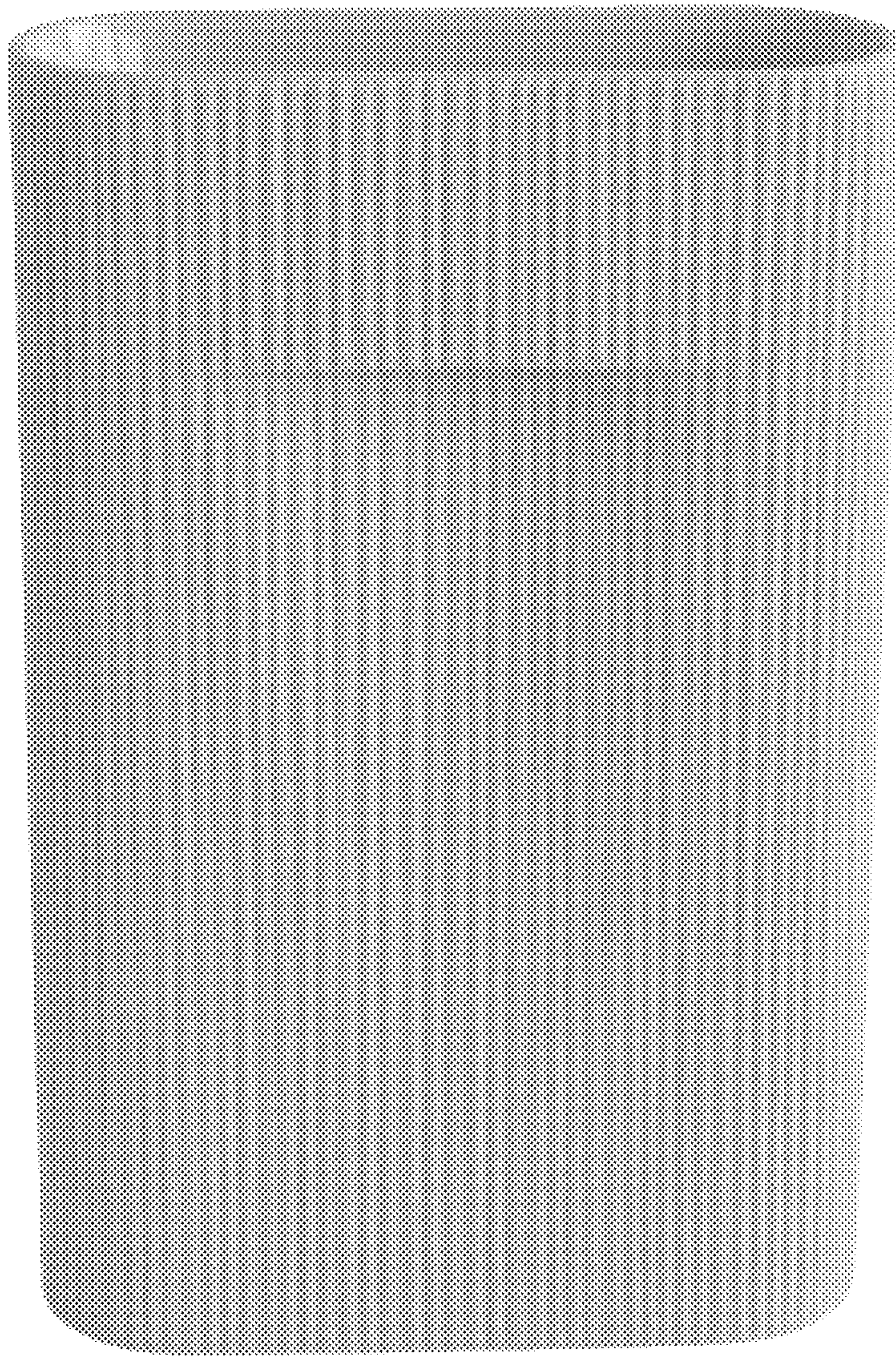

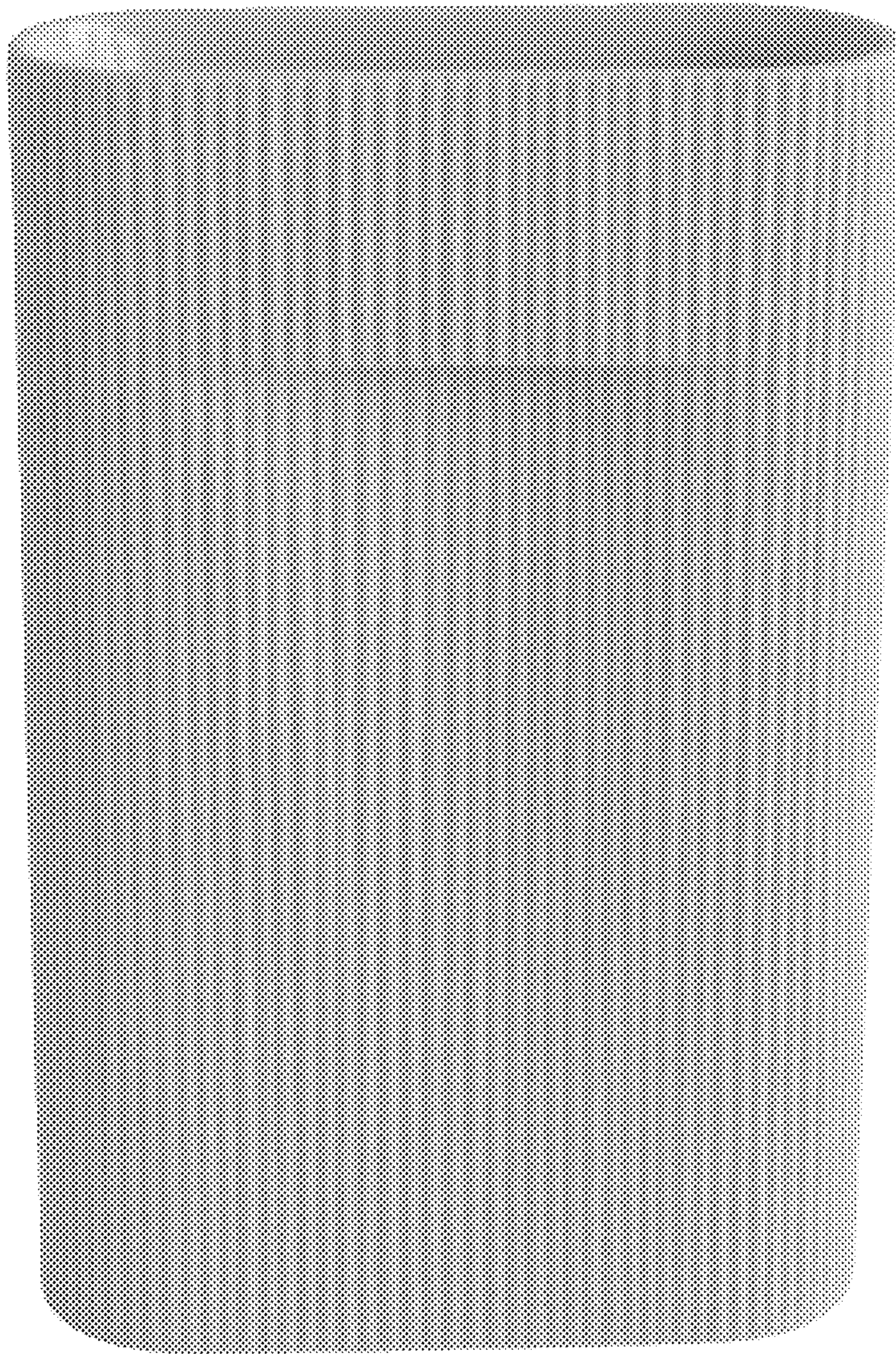

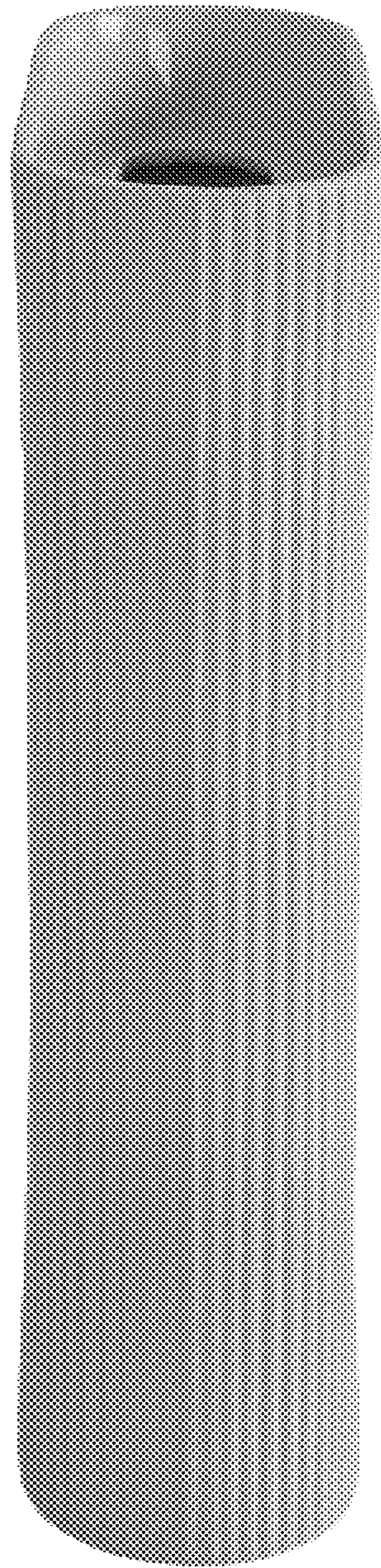

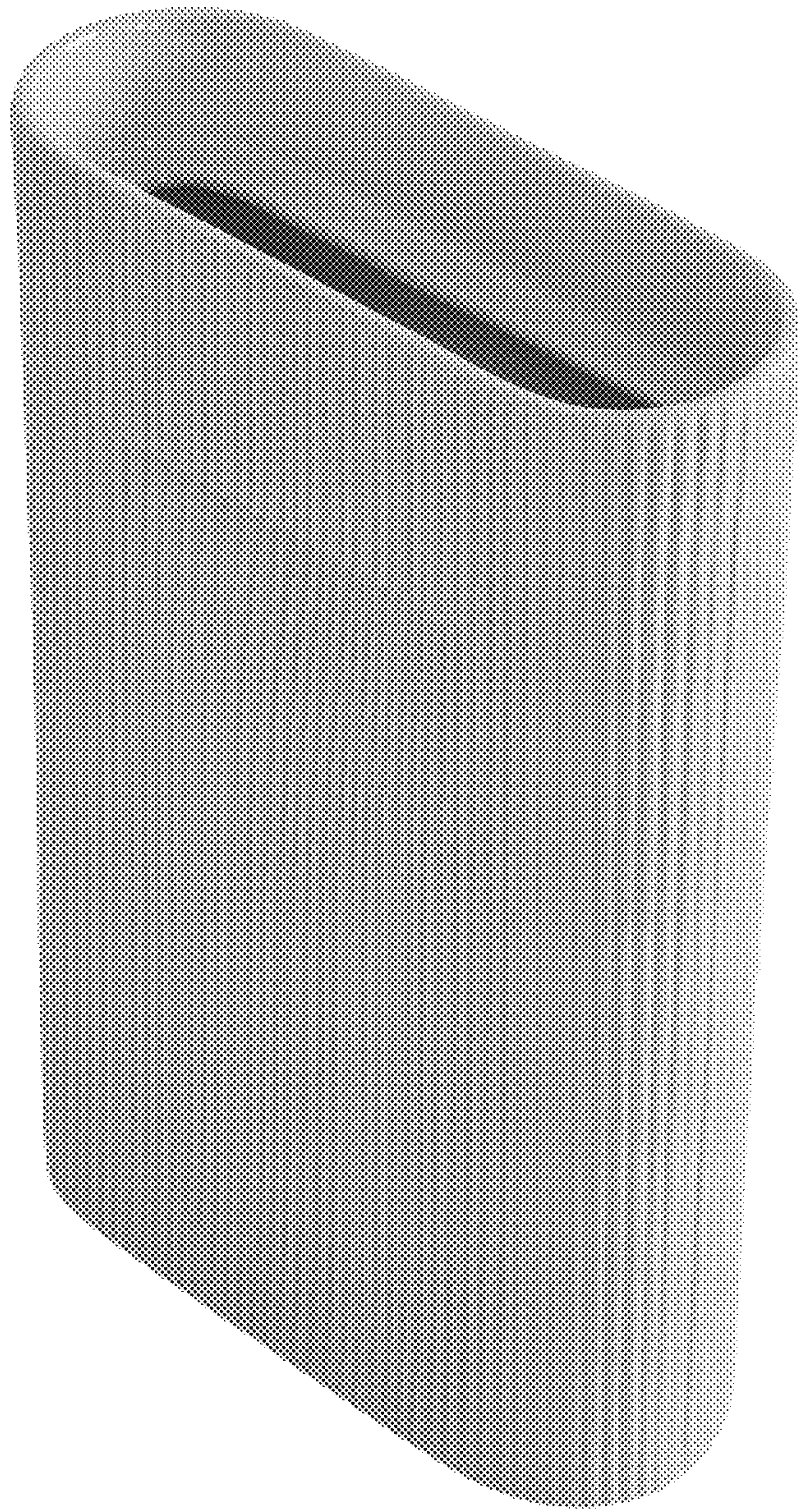

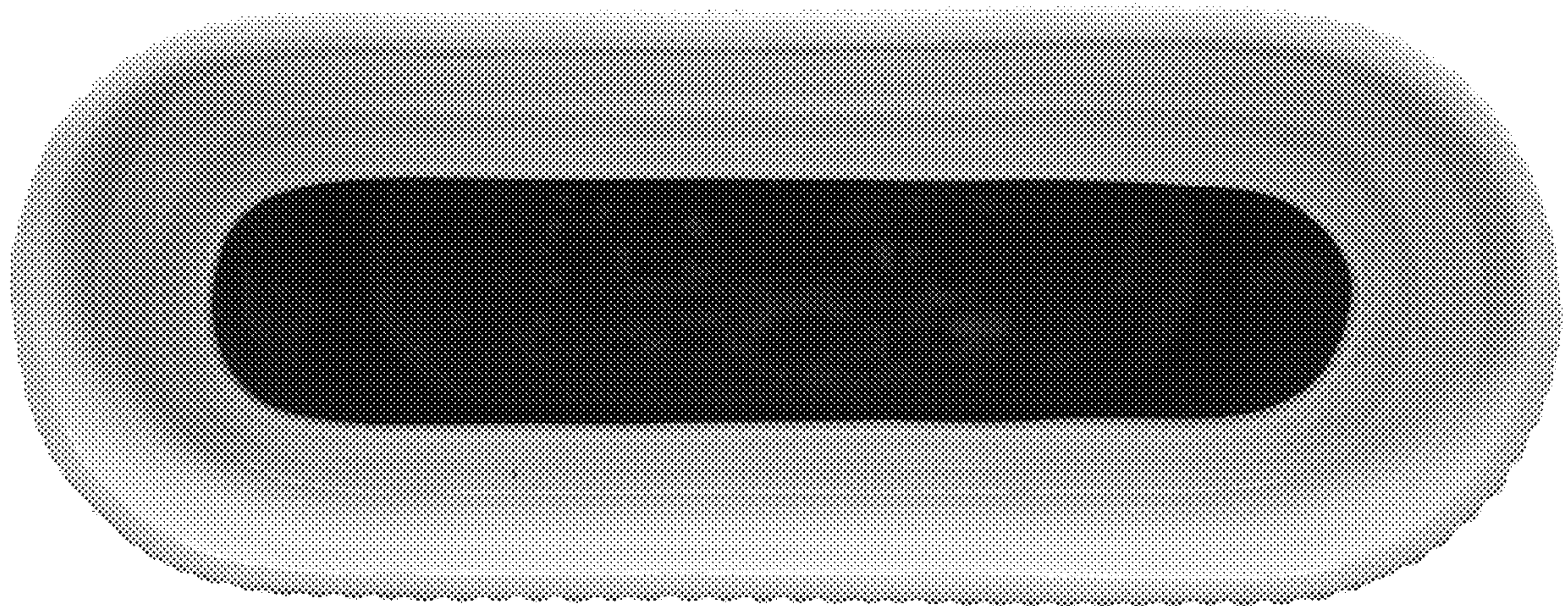

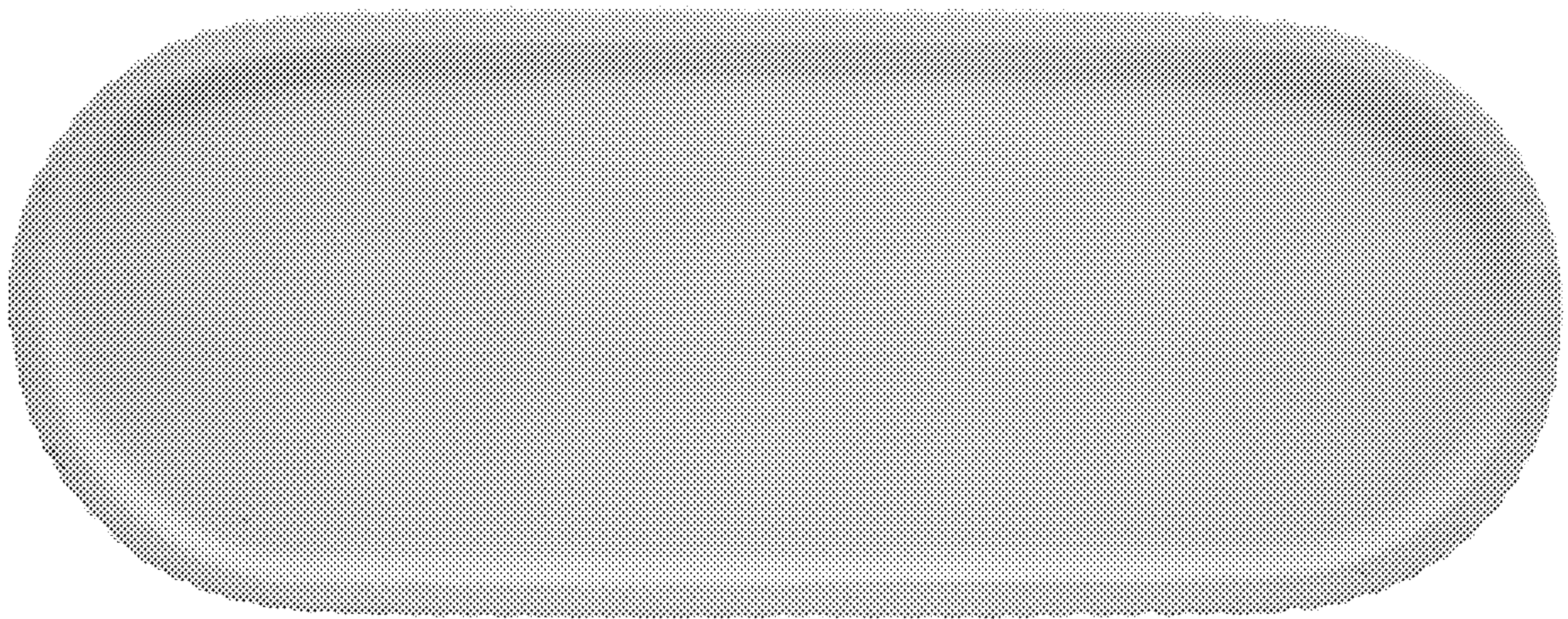

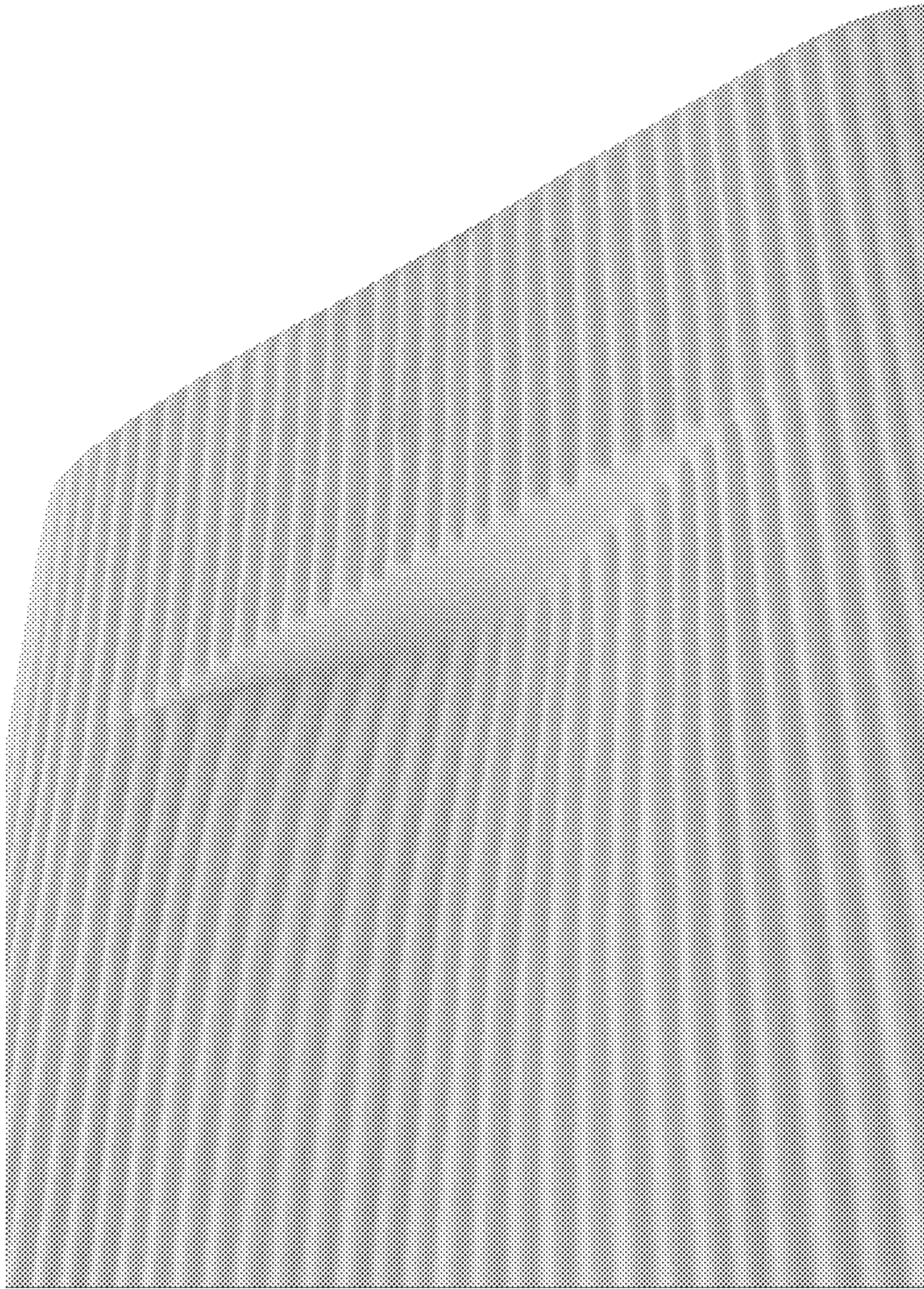
