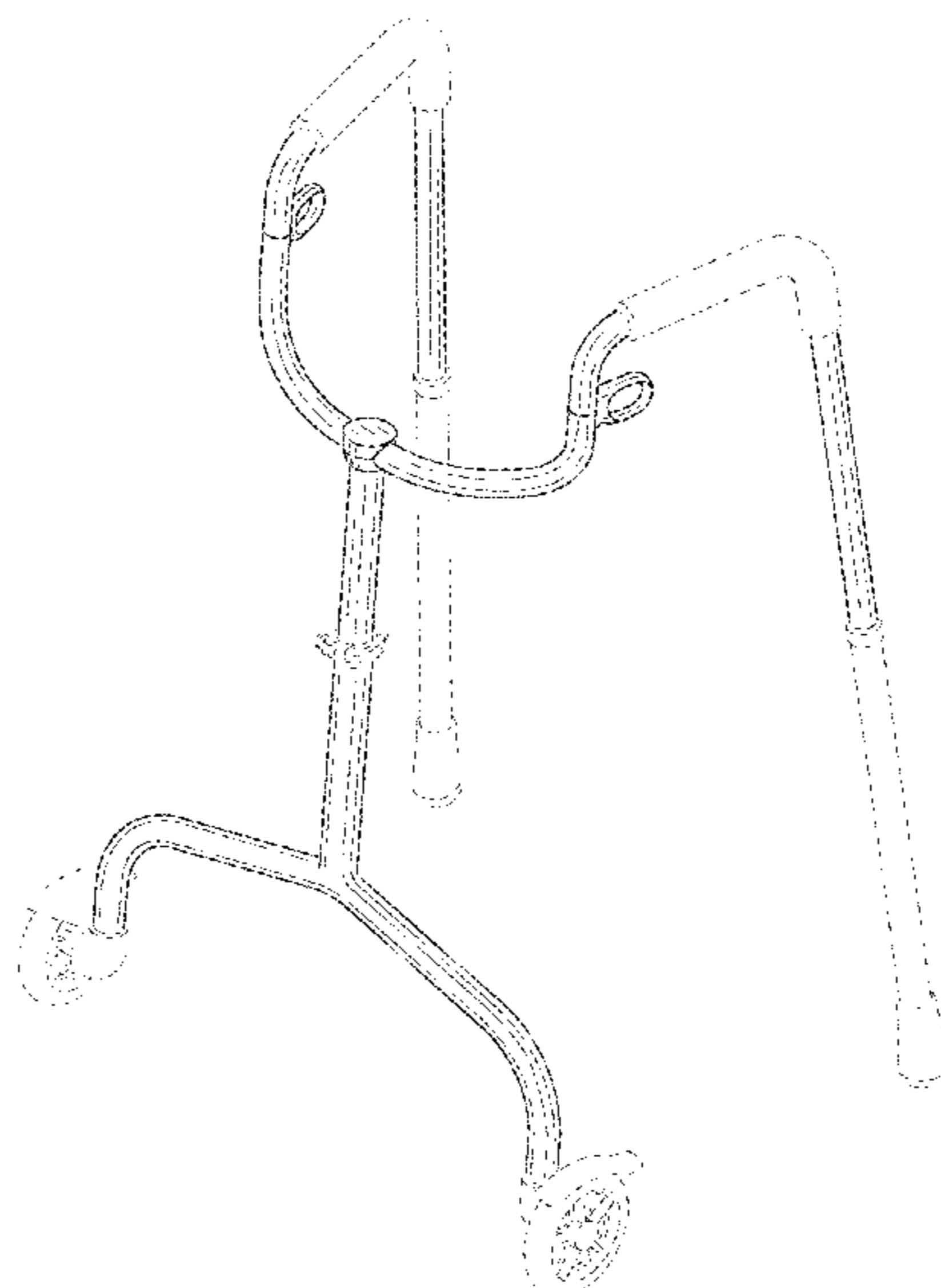
(57) **CLAIM**

We claim the ornamental design for a walking frame, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a walking frame; FIG. 2 is a bottom rear perspective view of the walking frame of FIG. 1; FIG. 3 is a front elevation view of the walking frame of FIG. 1; FIG. 4 is a rear elevation view of the walking frame of FIG. 1; FIG. 5 is a right side elevation view of the walking frame of FIG. 1; FIG. 6 is a left side elevation view of the walking frame of FIG. 1; FIG. 7 is a top plan view of the walking frame of FIG. 1; FIG. 8 is a bottom plan view of the walking frame of FIG. 1; and, FIG. 9 is a top rear perspective view of the walking frame of FIG. 1 in a folded state. The broken lines in the drawings illustrate portions of the walking frame, which form no part of the claimed design.

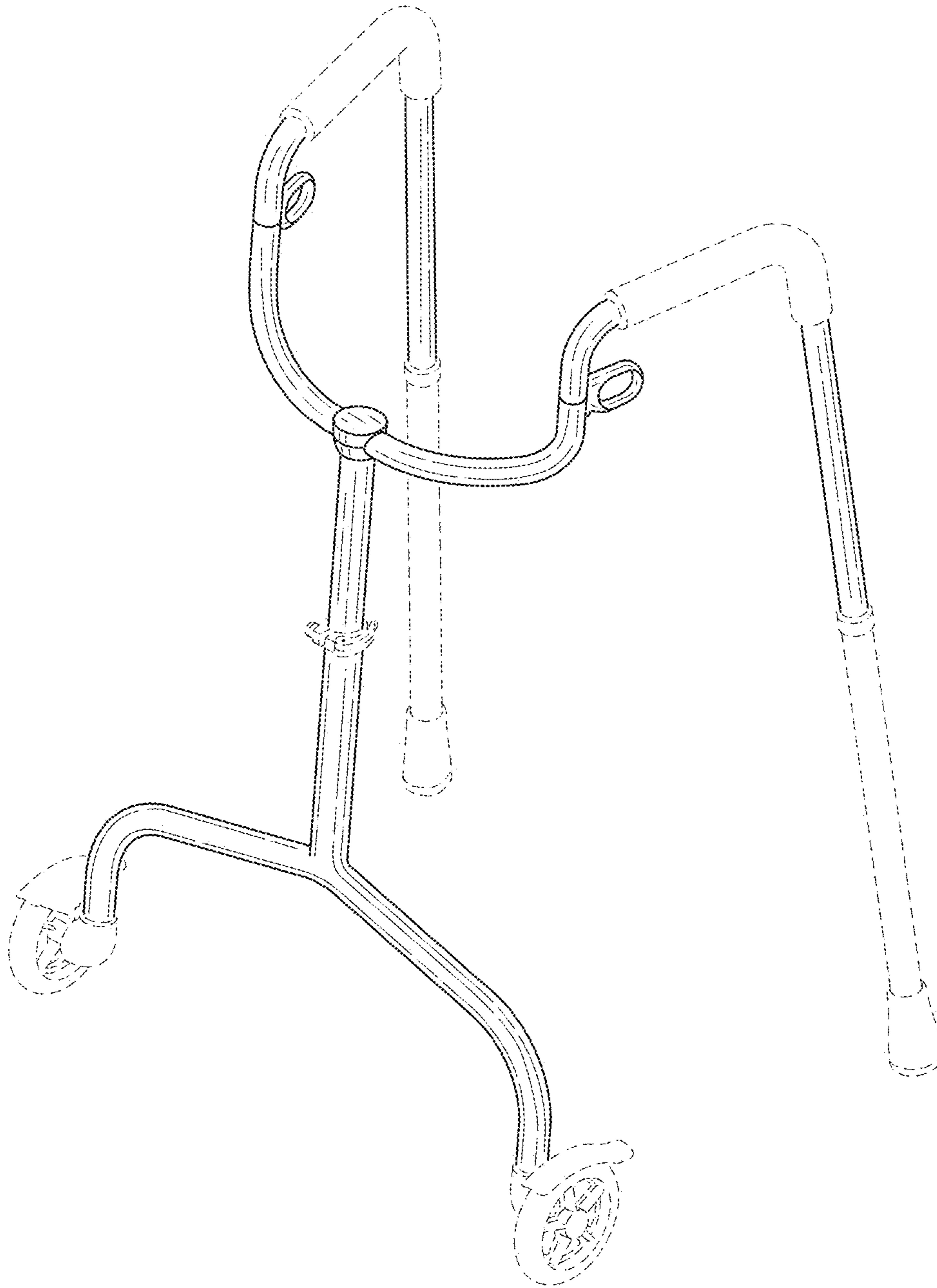

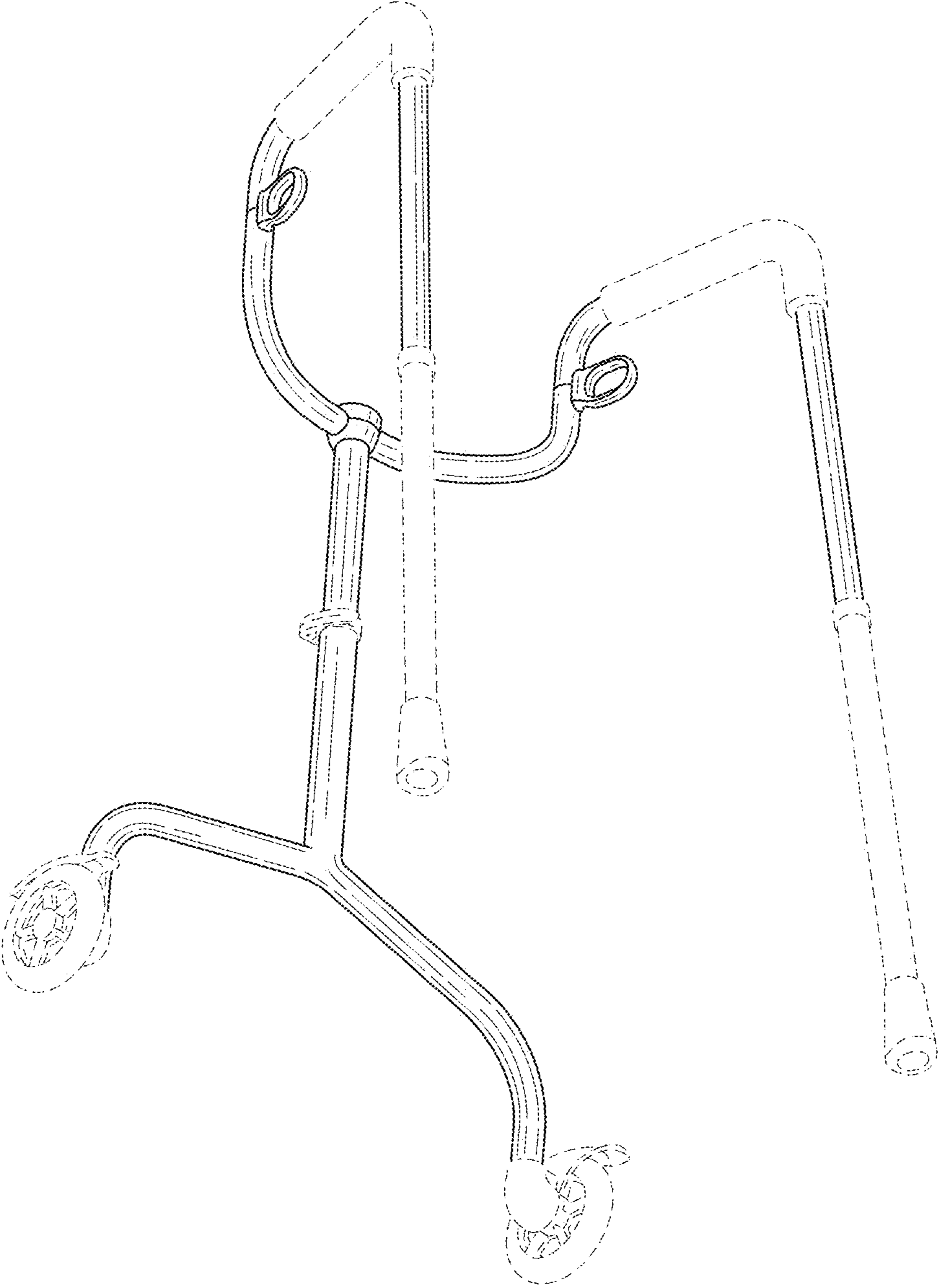

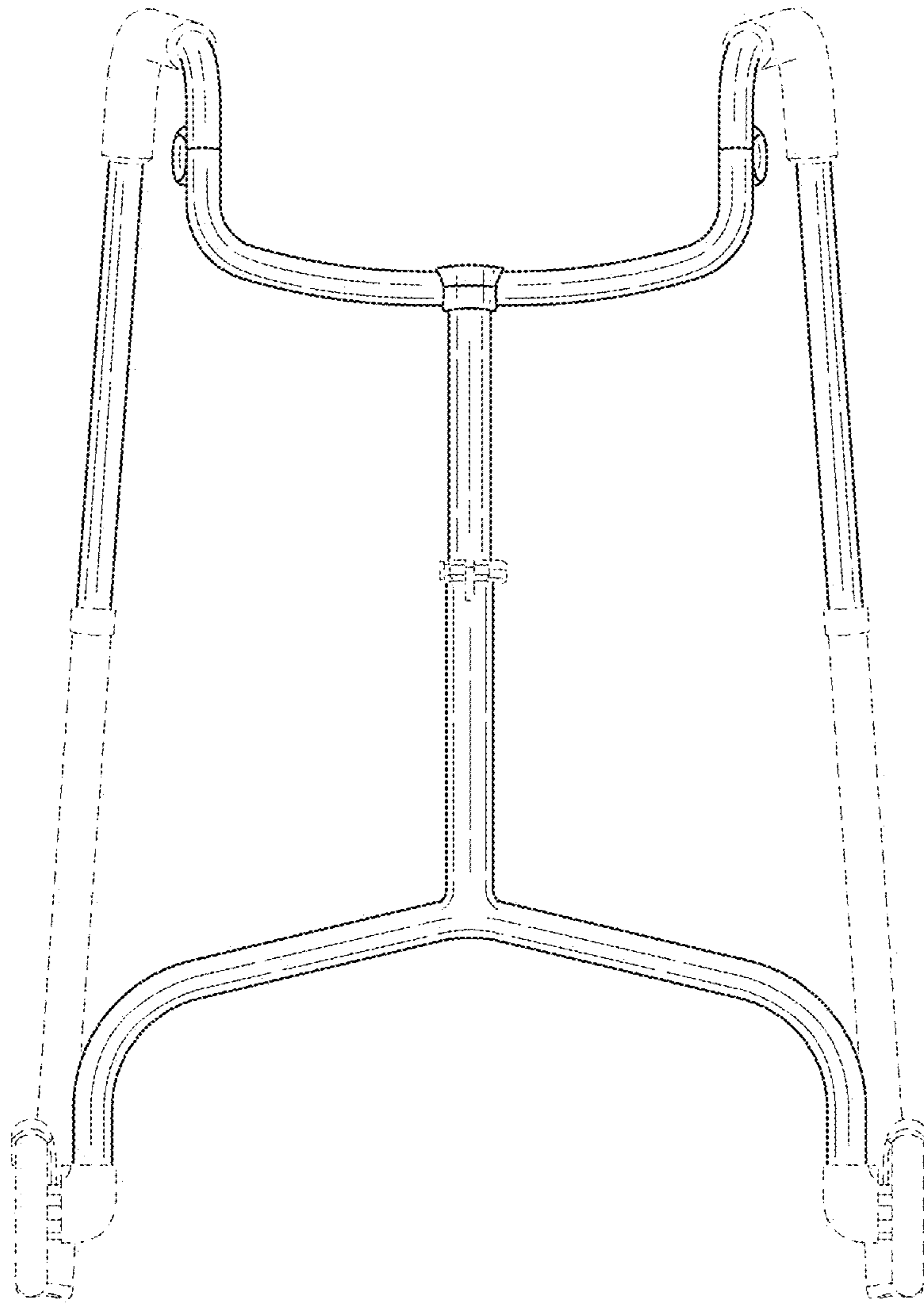

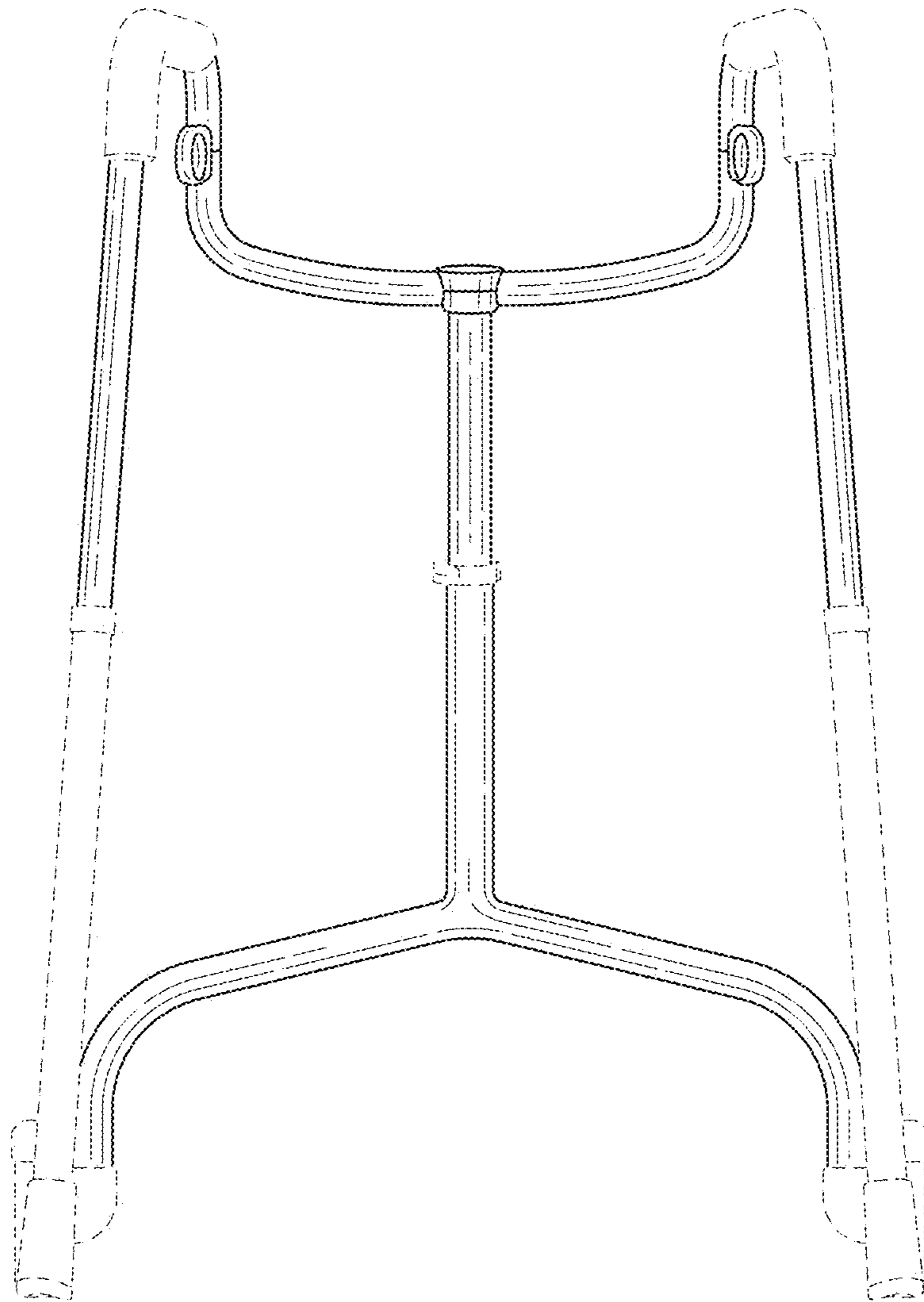

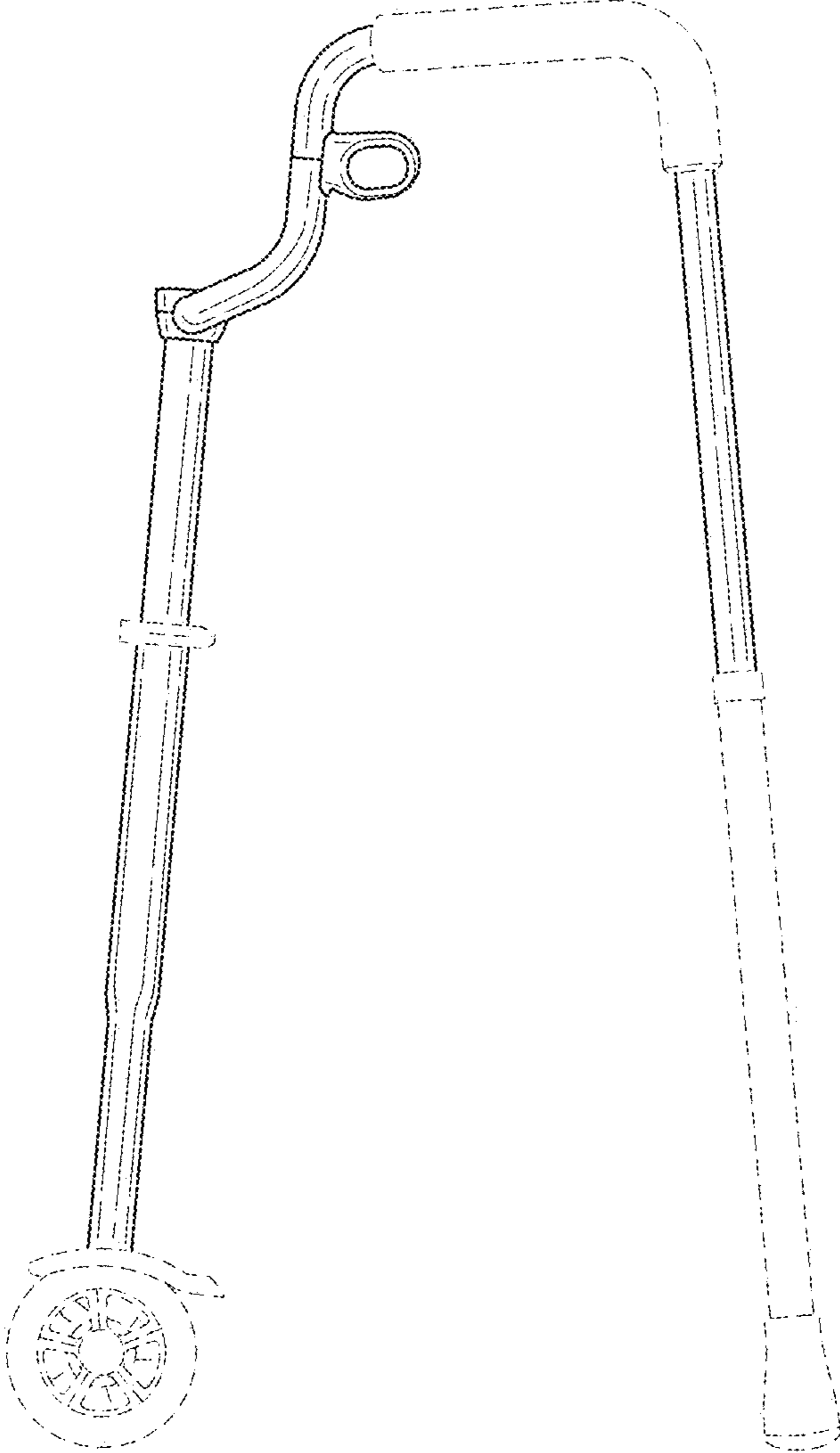

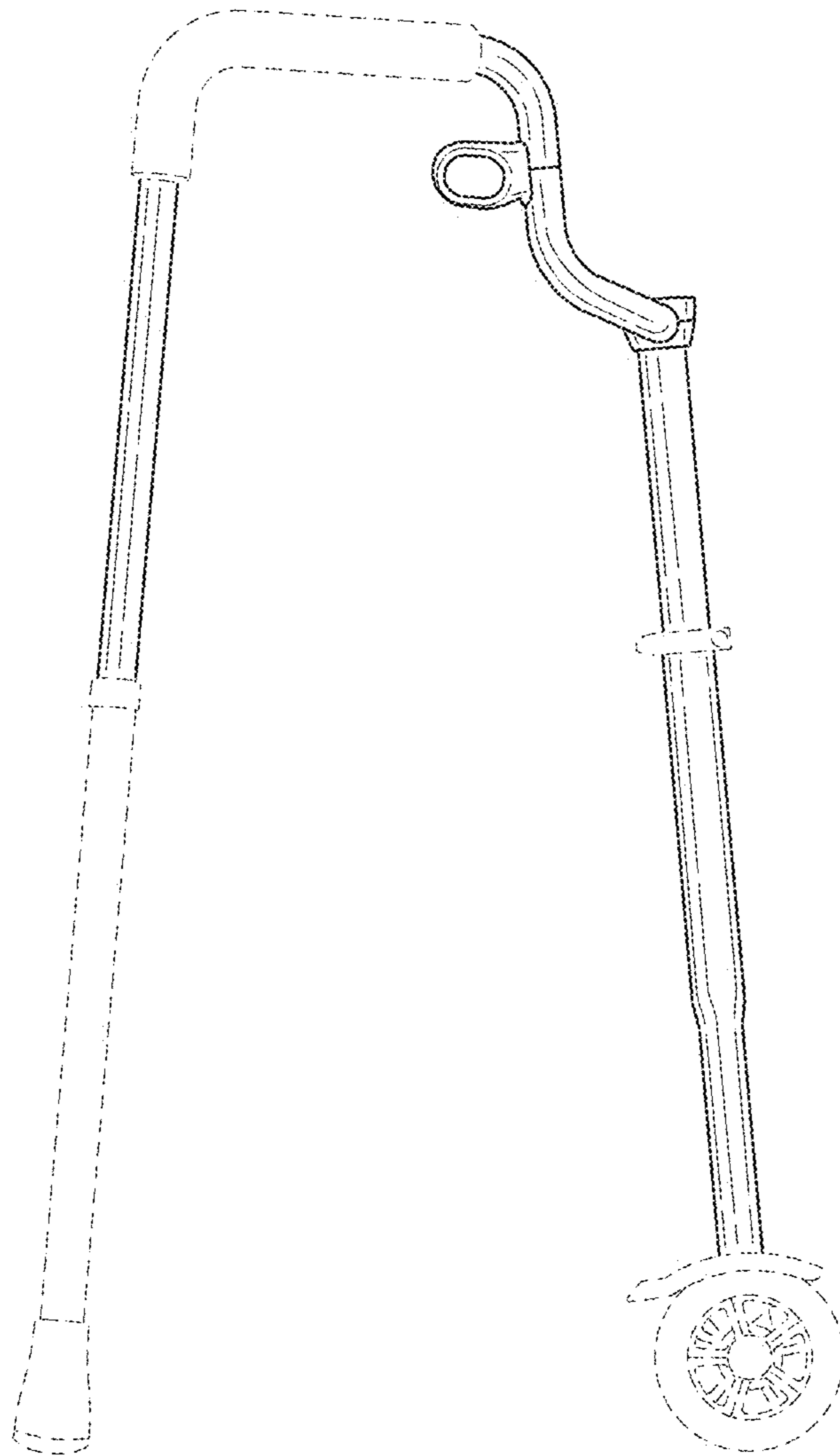

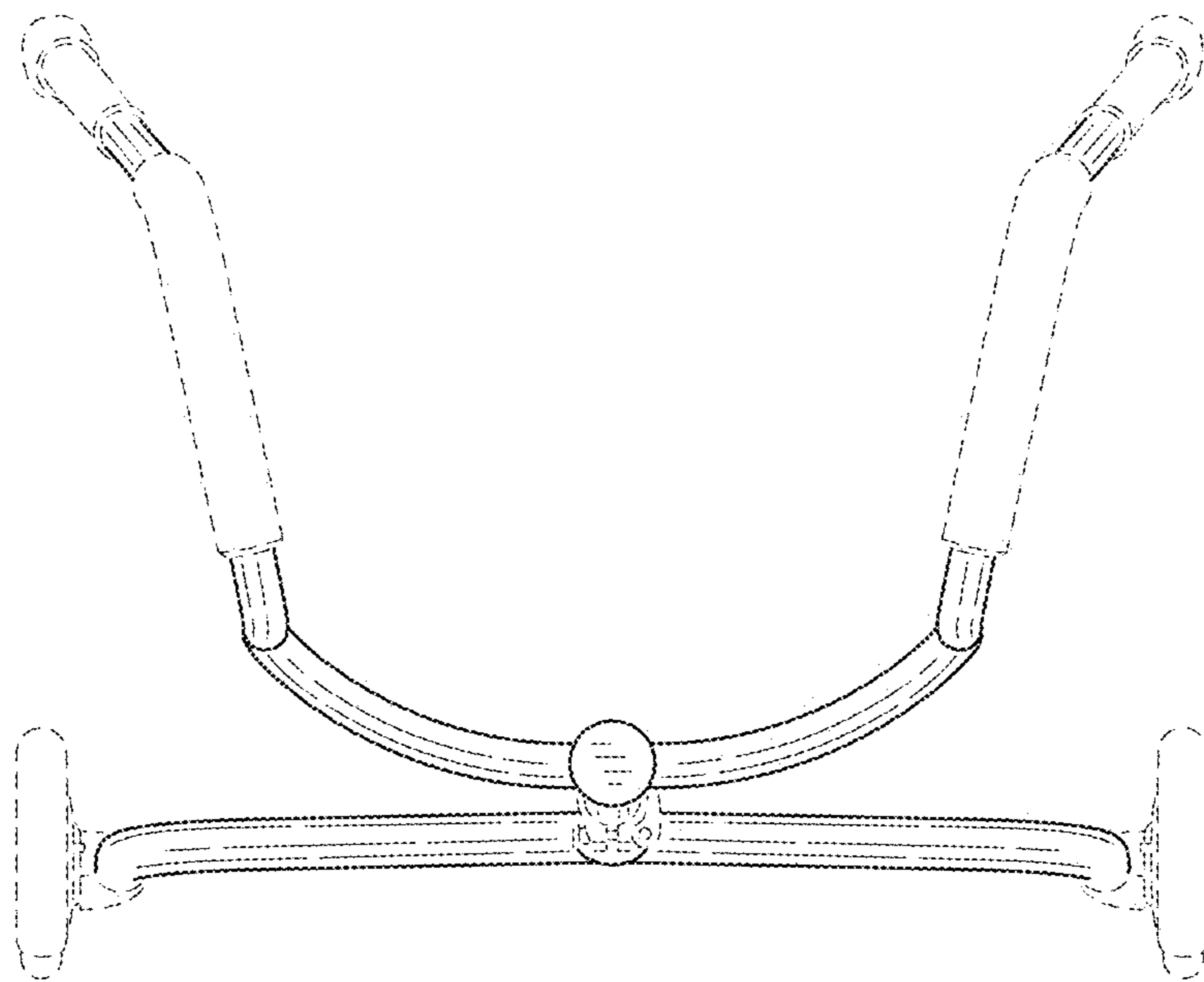

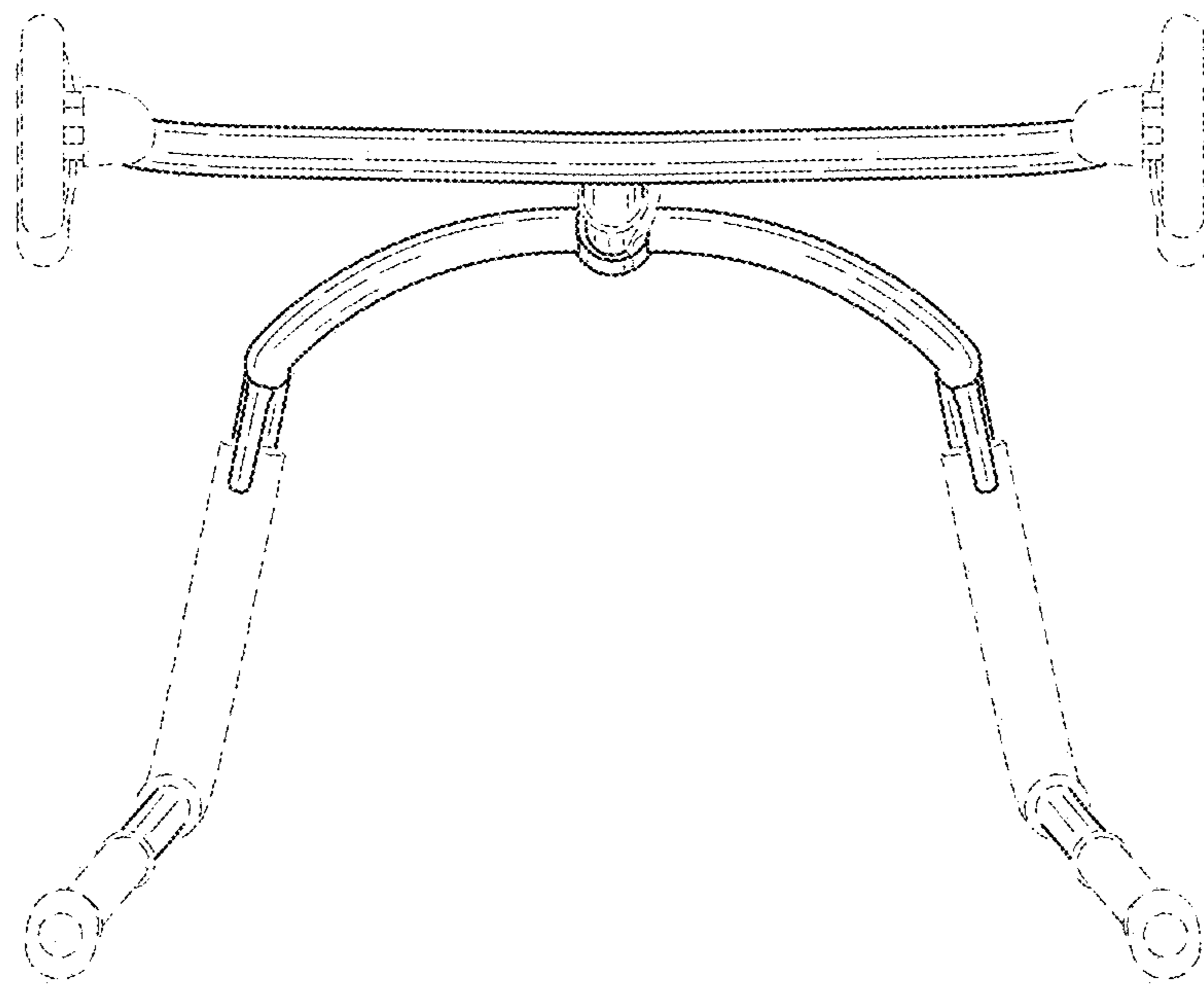

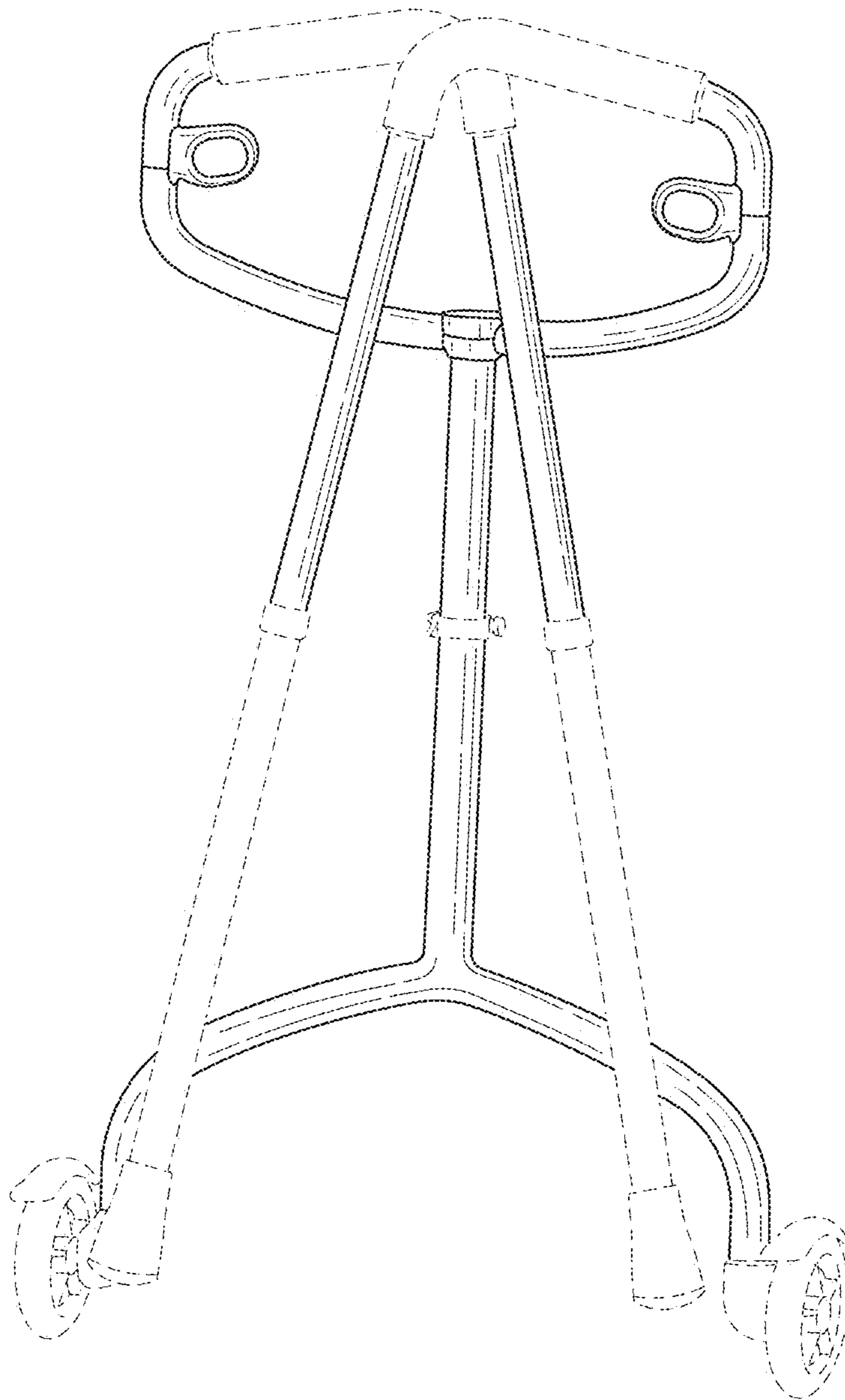
