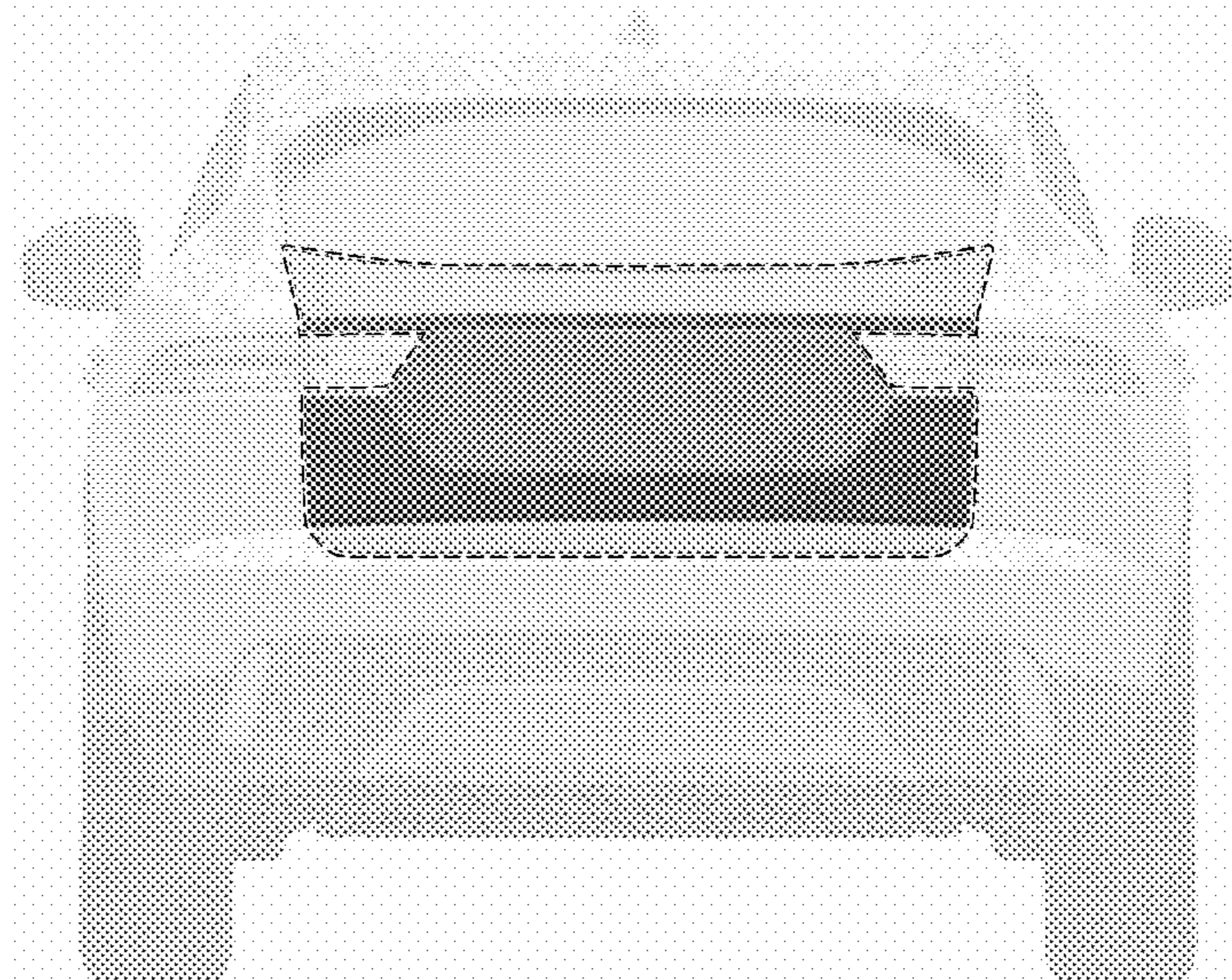

(57) **CLAIM**
The ornamental design for a motor vehicle tailgate, as shown and described.

DESCRIPTION

FIG. 1 is a right, front perspective view of a motor vehicle tailgate showing our new design;
FIG. 2 is a left, front perspective view thereof;
FIG. 3 is a left, rear perspective view thereof;
FIG. 4 is a right, rear perspective view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a left side elevational view thereof;
FIG. 8 is a right side elevational view thereof;
FIG. 9 is a top plan view thereof;
FIG. 10 is a bottom plan view thereof; and,
FIG. 11 is another front elevational view thereof shown mounted on the rear of a motor vehicle.
The rear portion of the motor vehicle shown in a de-emphasized and faded out half tone manner and the broken lines representing a boundary surrounding the claimed design are all for environmental and illustrative purposes and form no part of the claimed design.

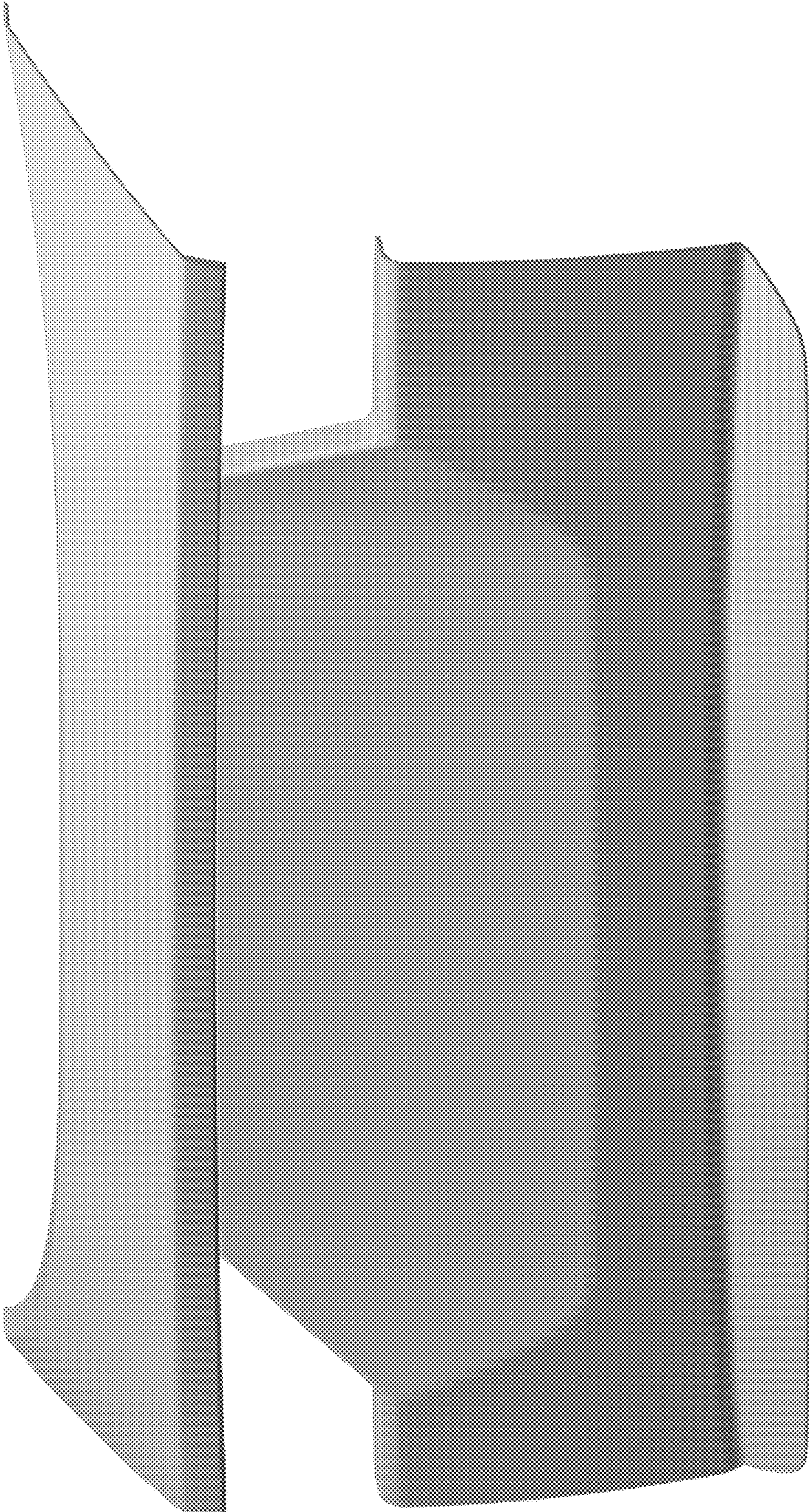

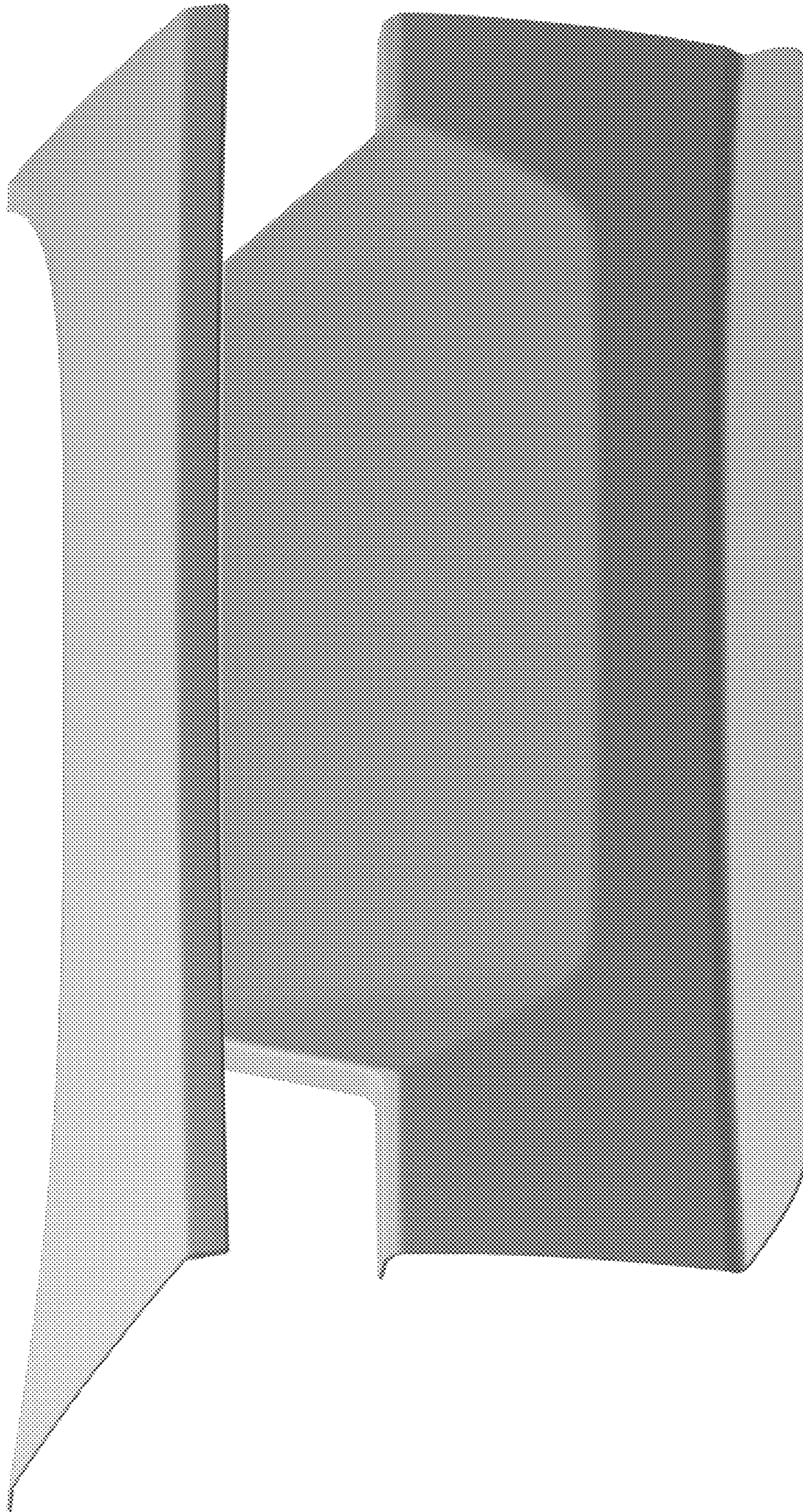

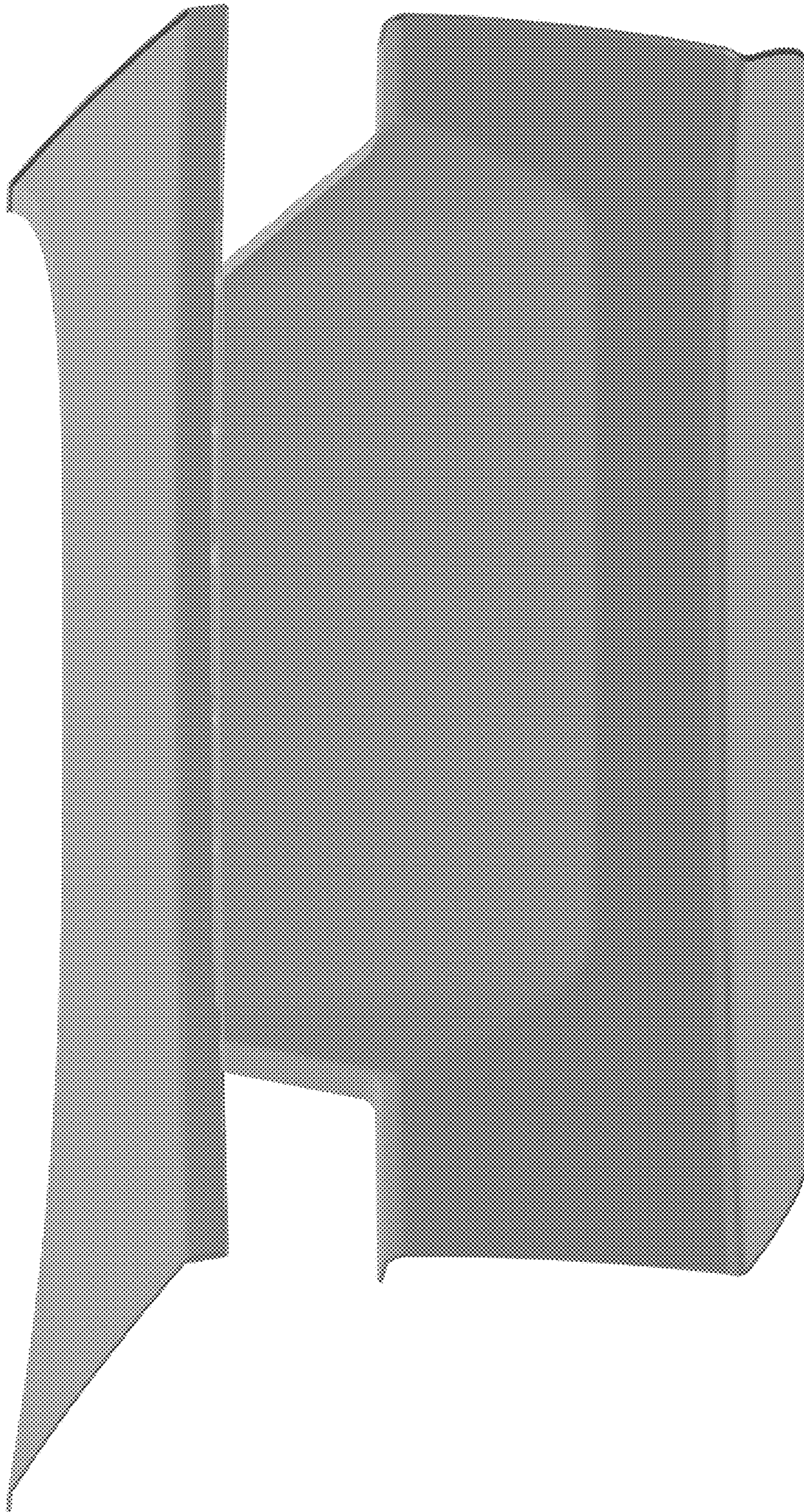

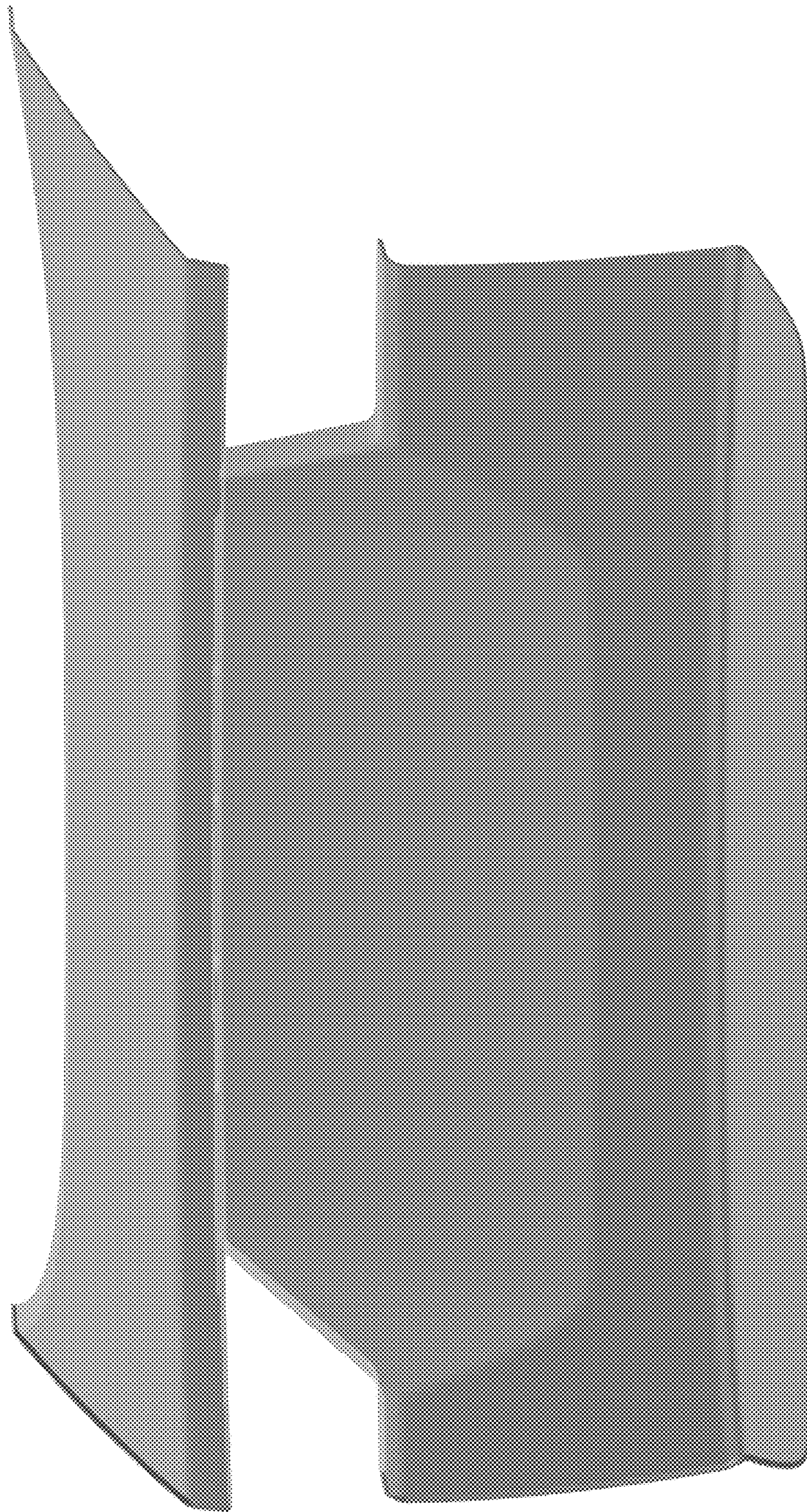

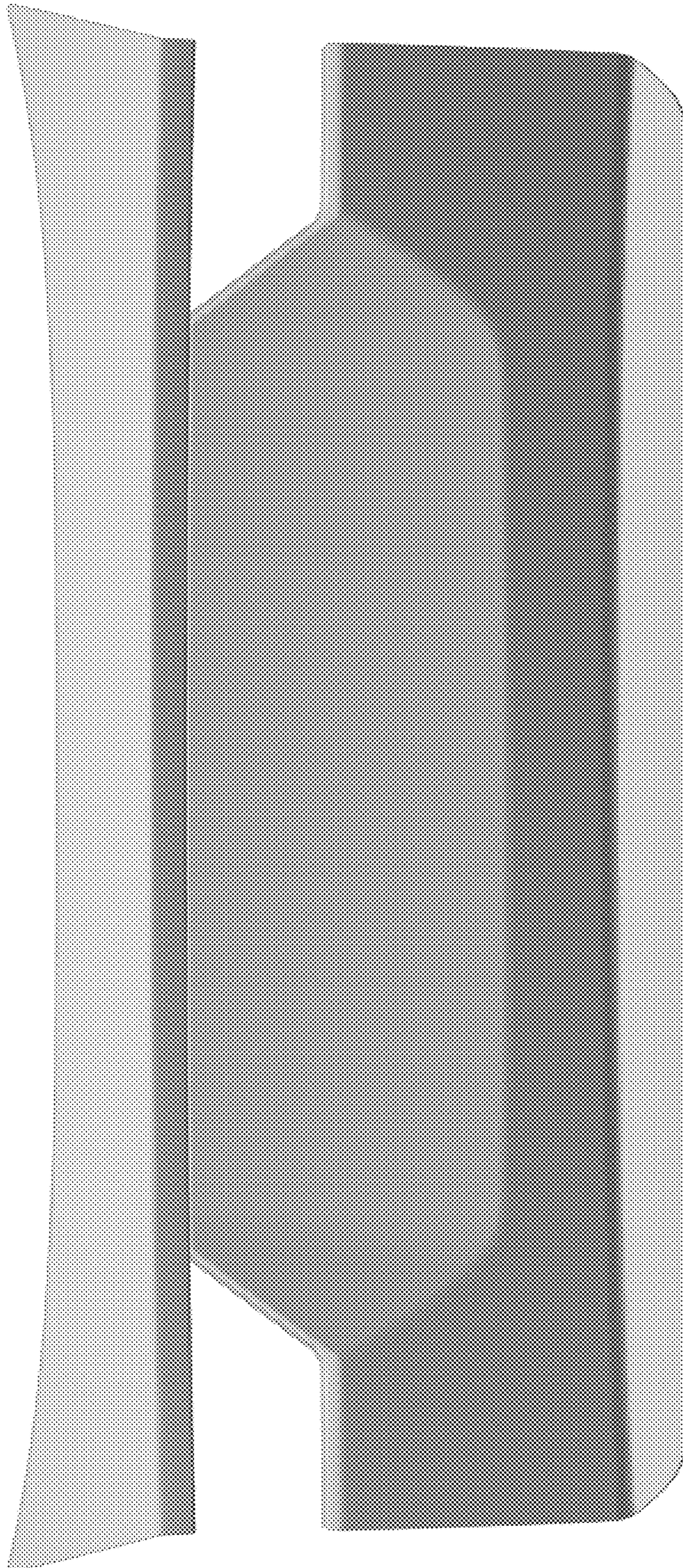

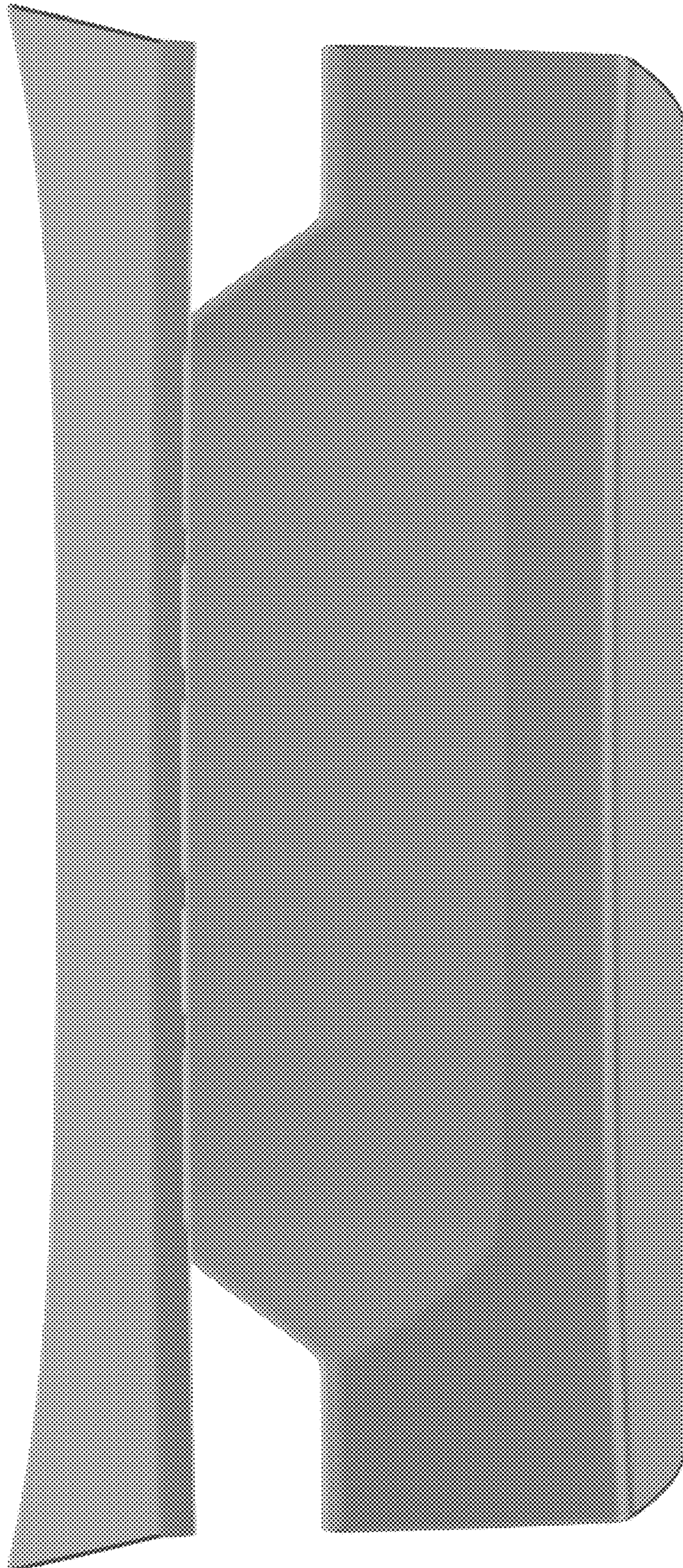

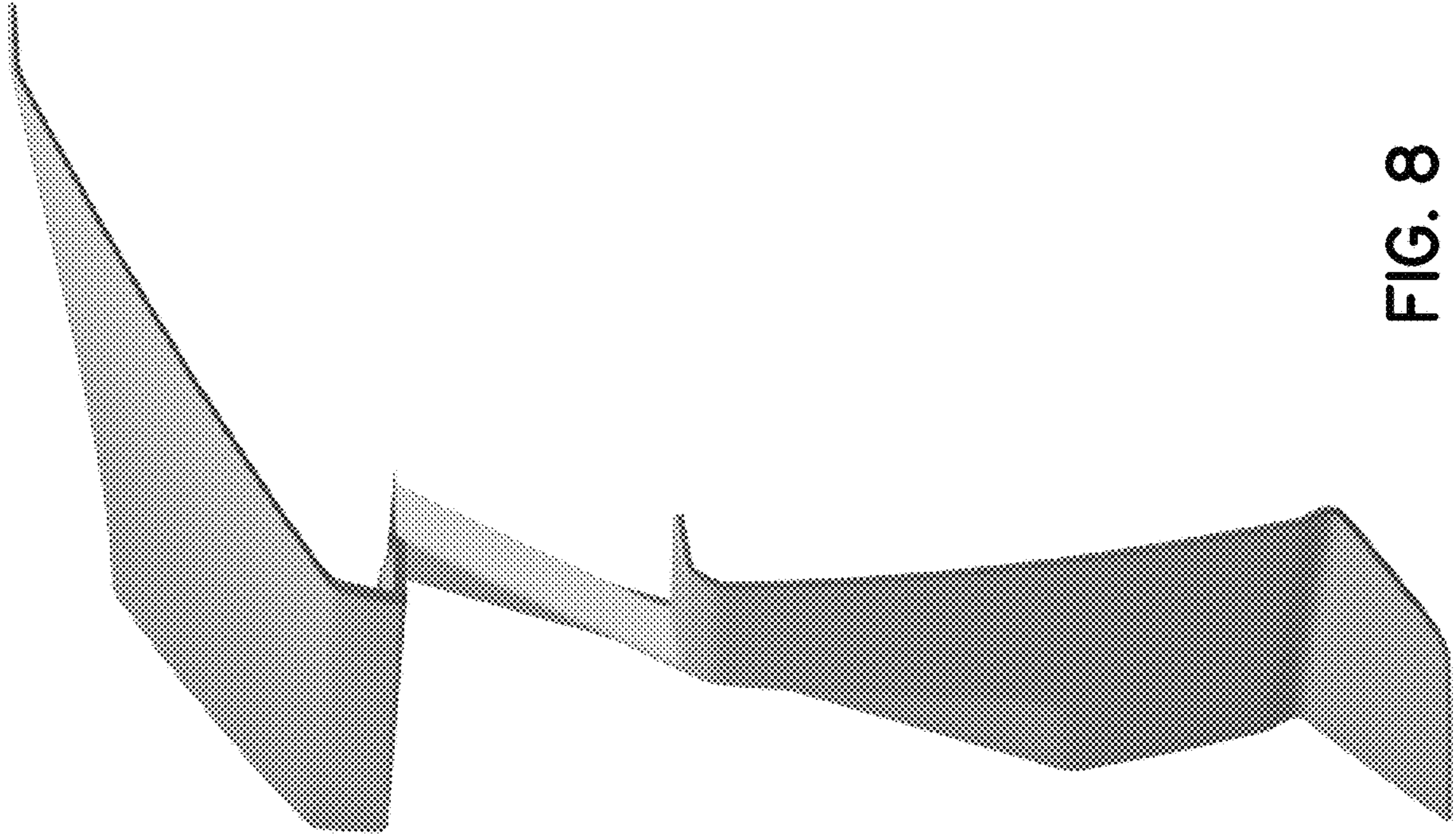

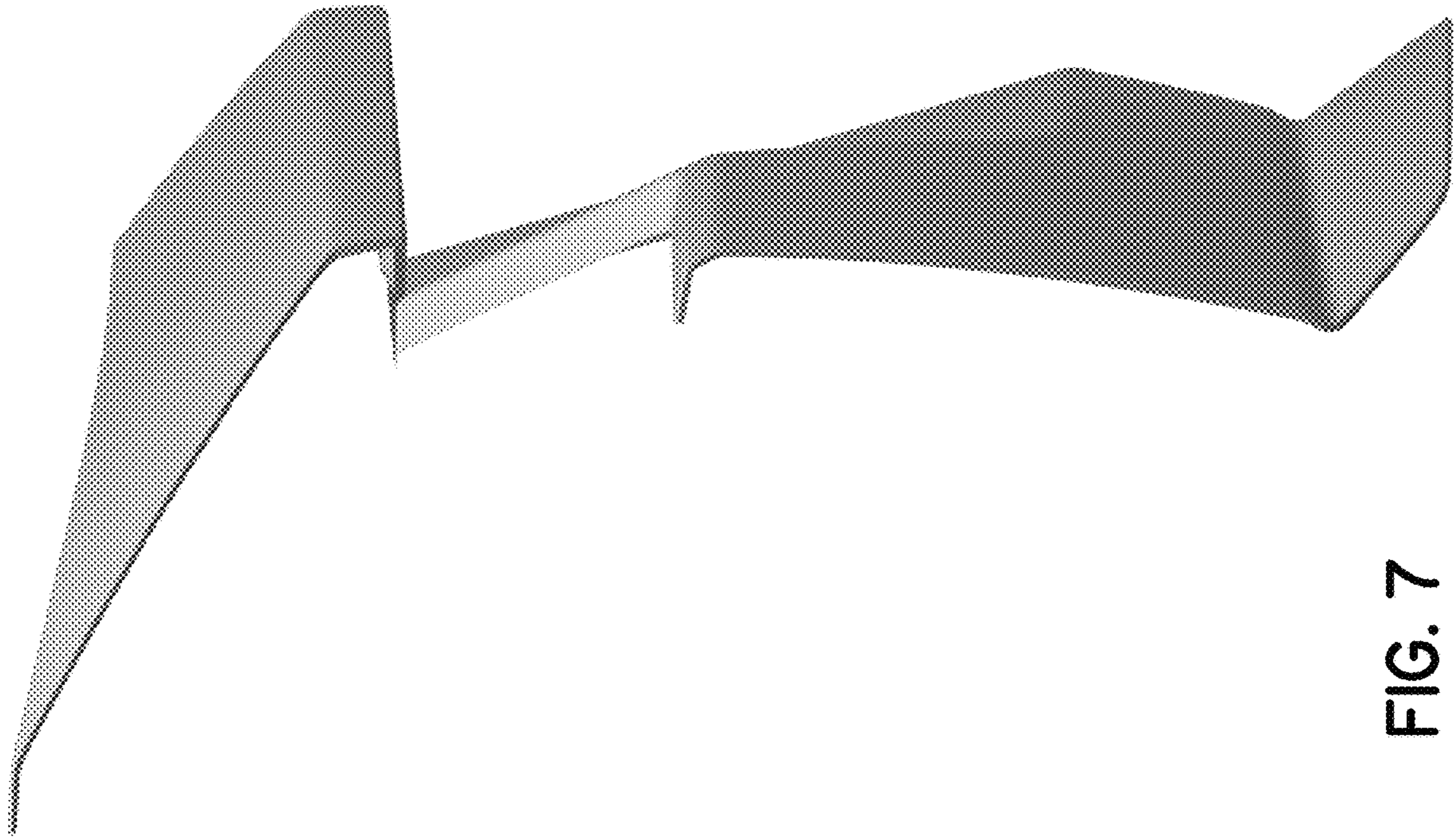

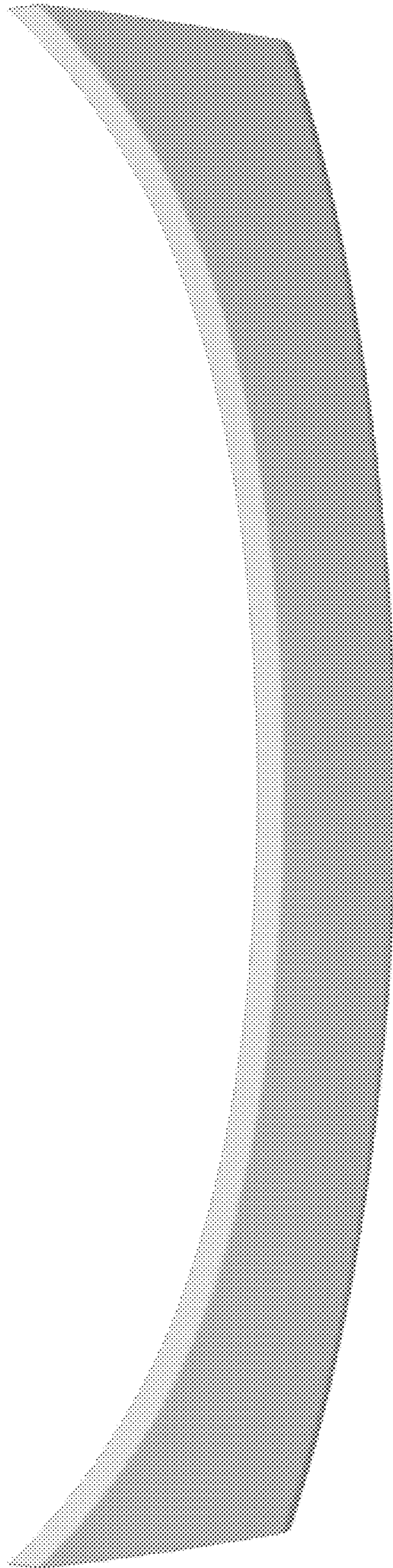

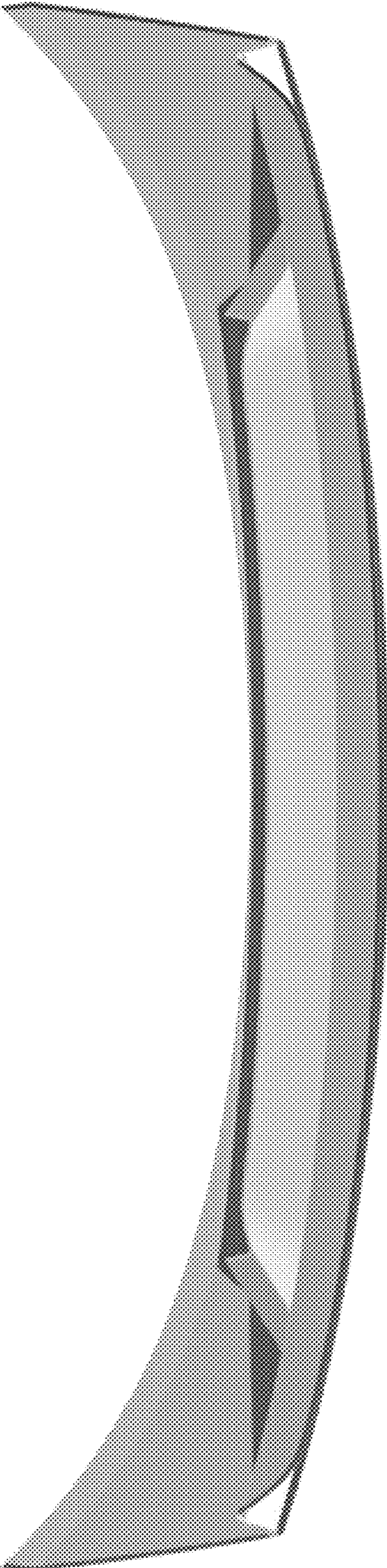

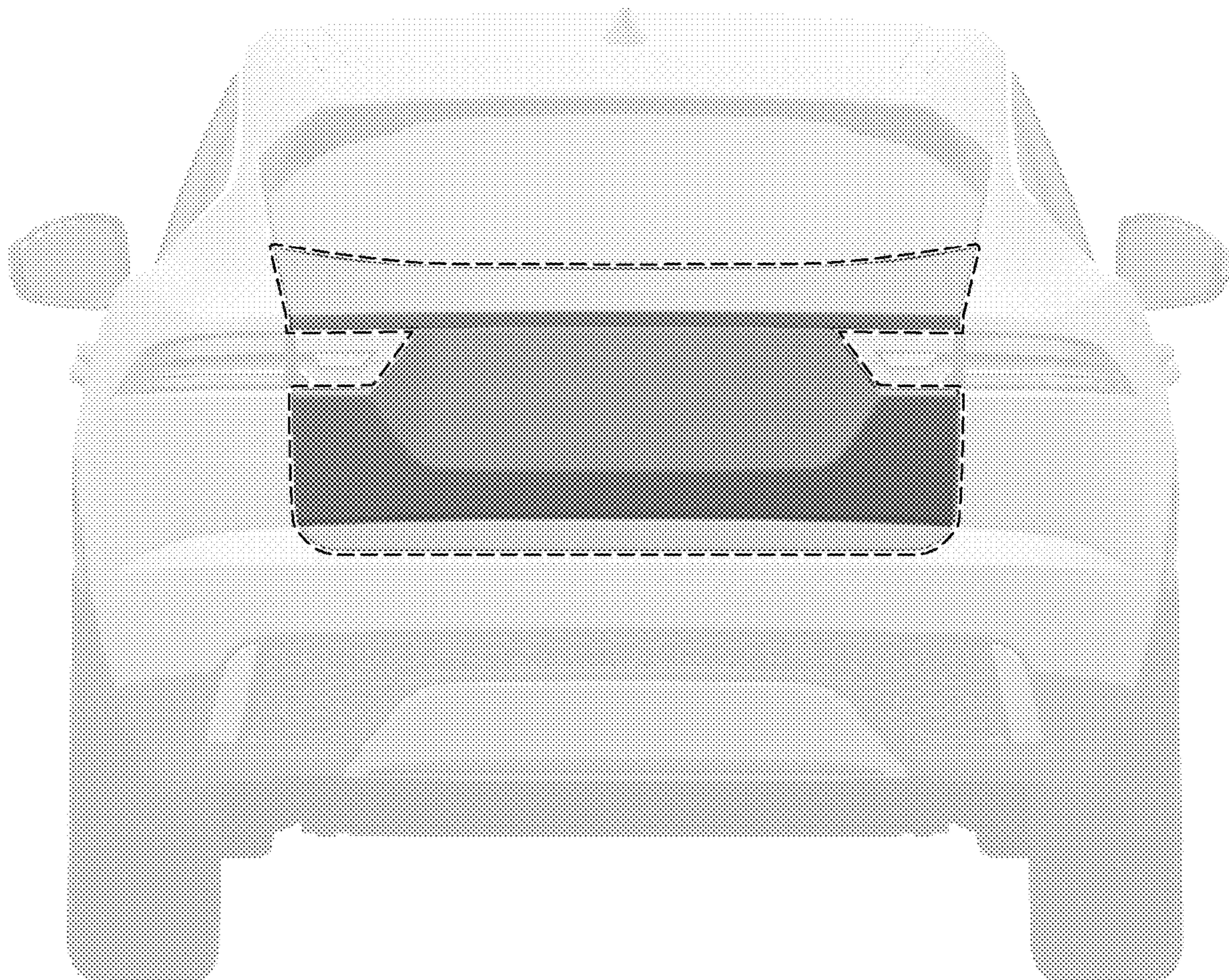
