The ornamental design for a milling machine, as shown and described.

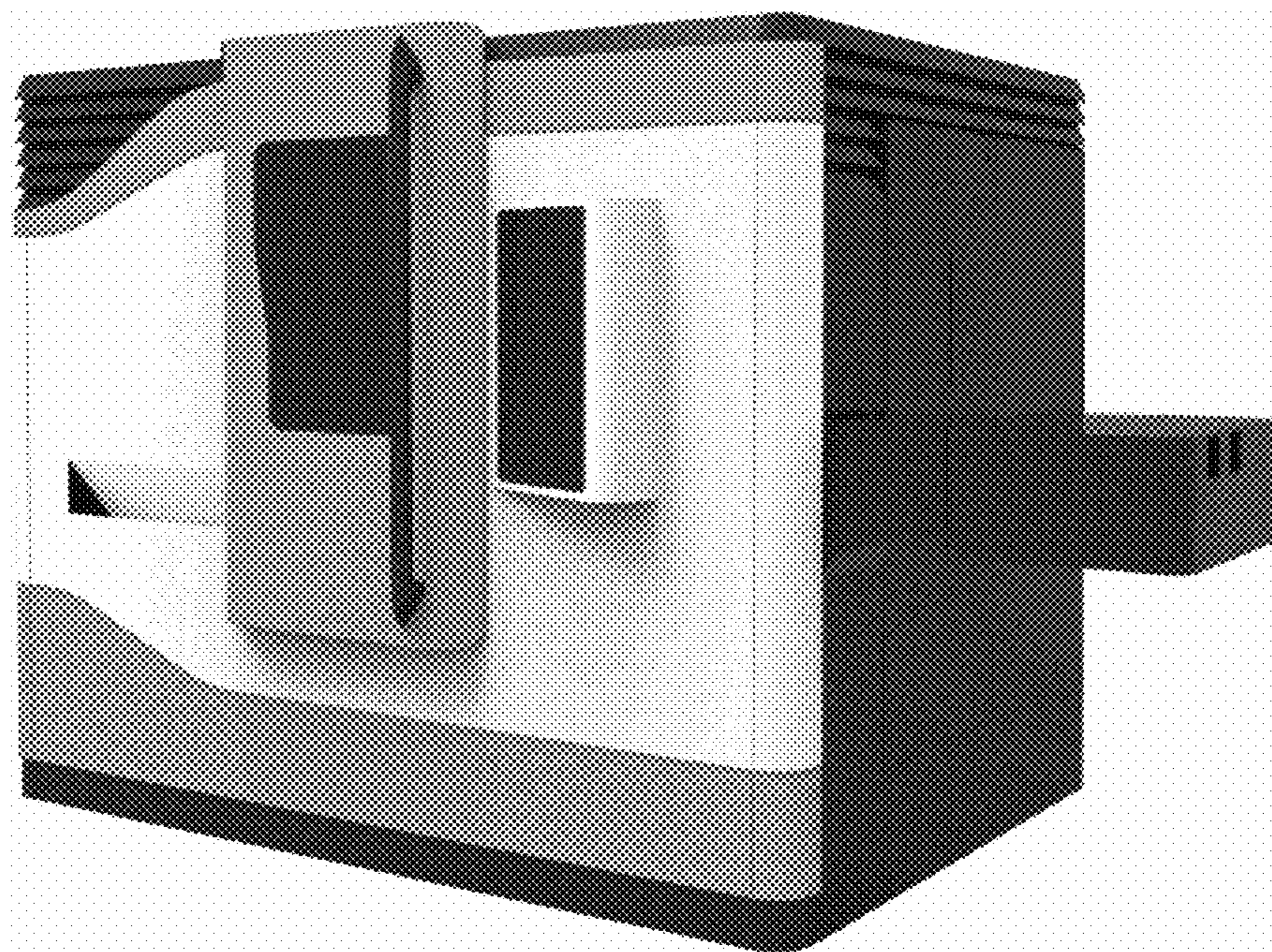

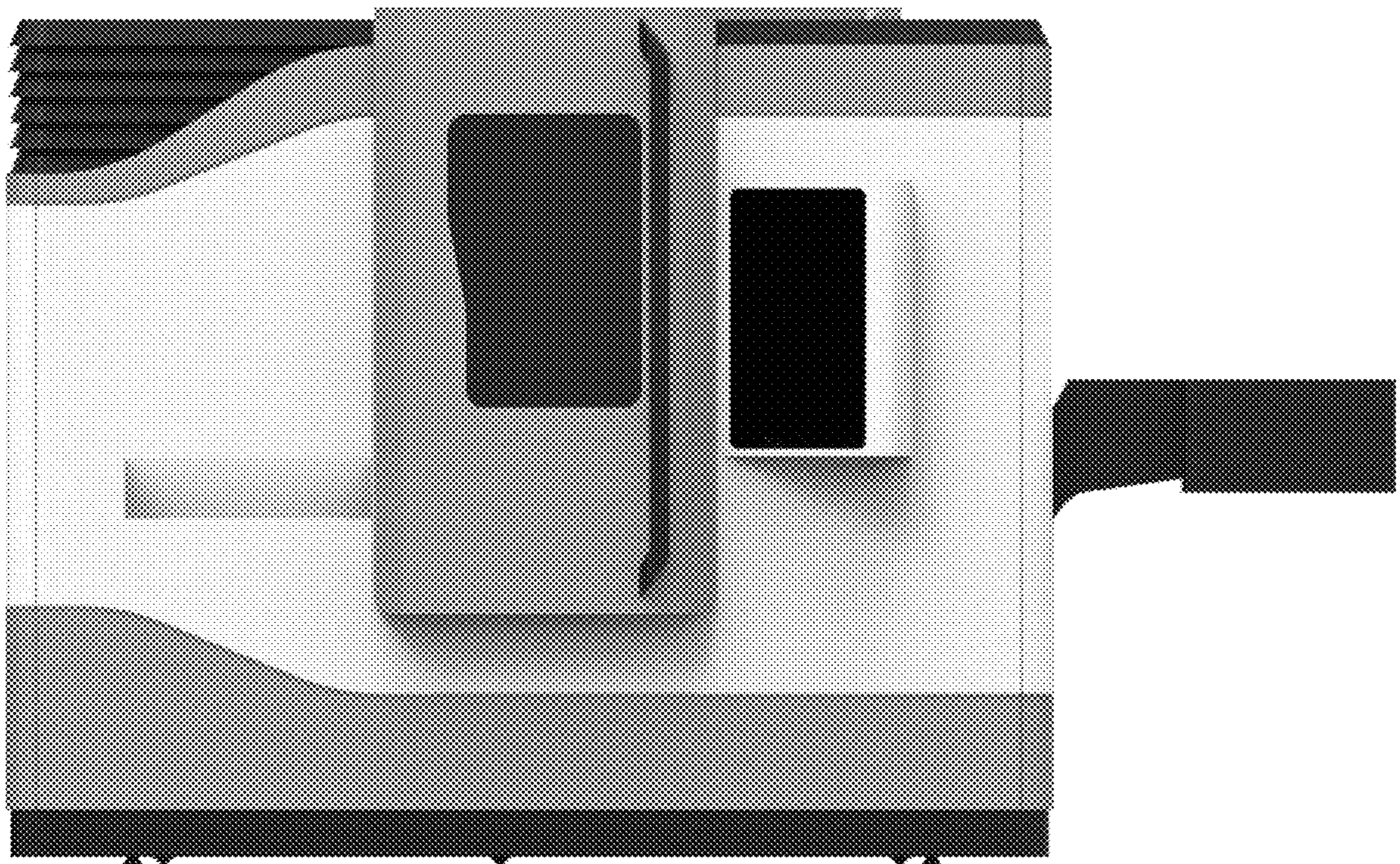

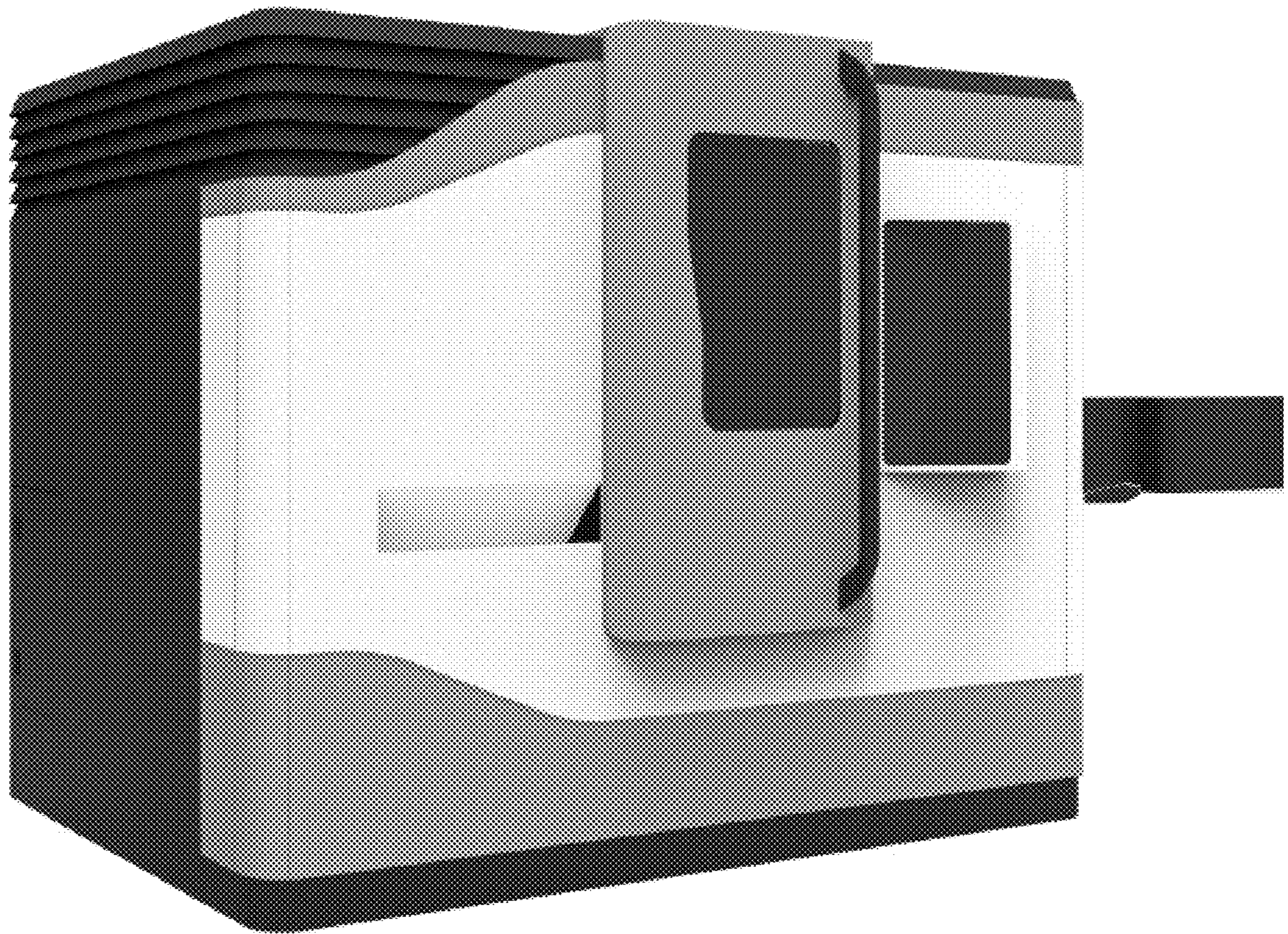

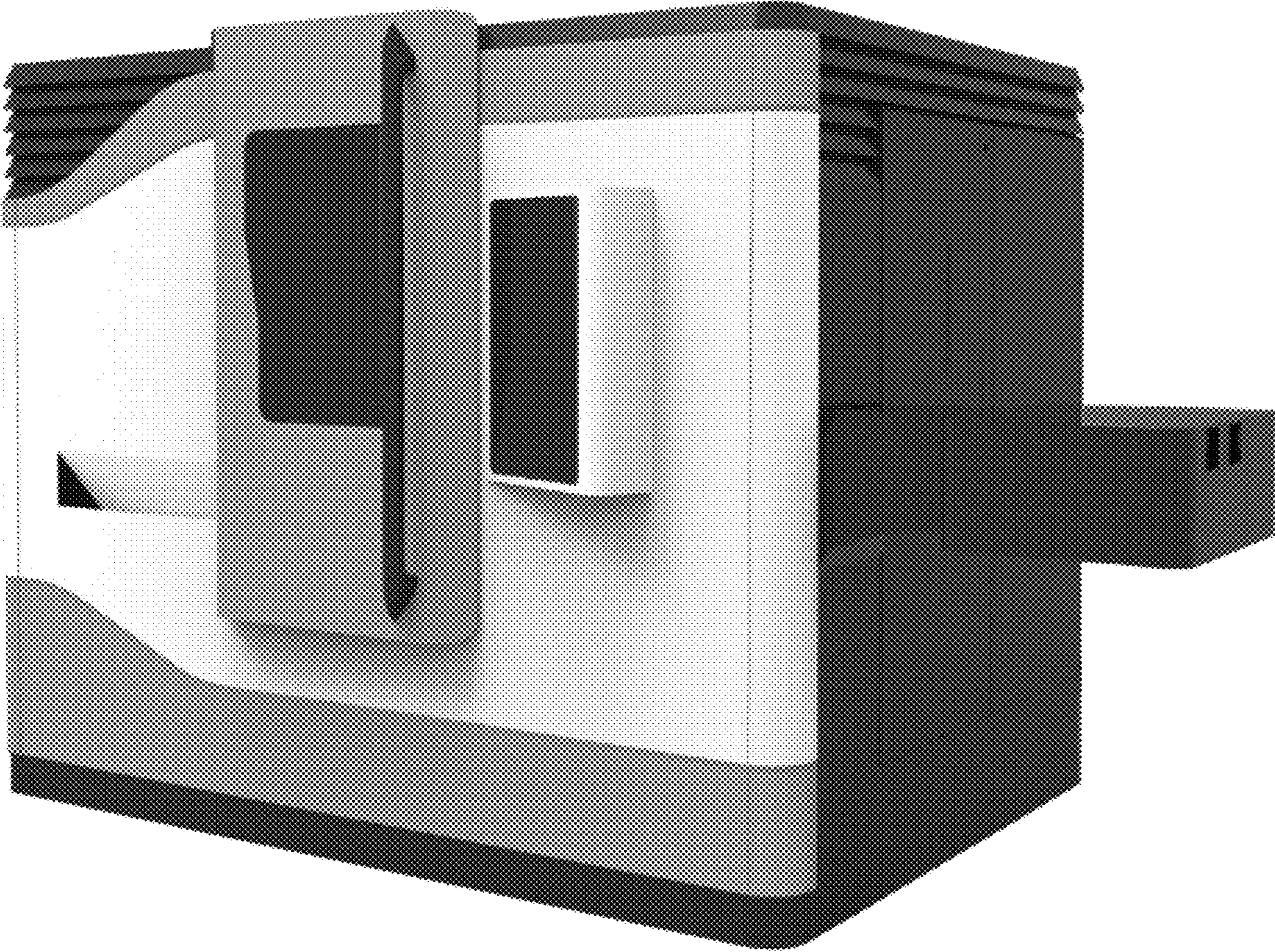

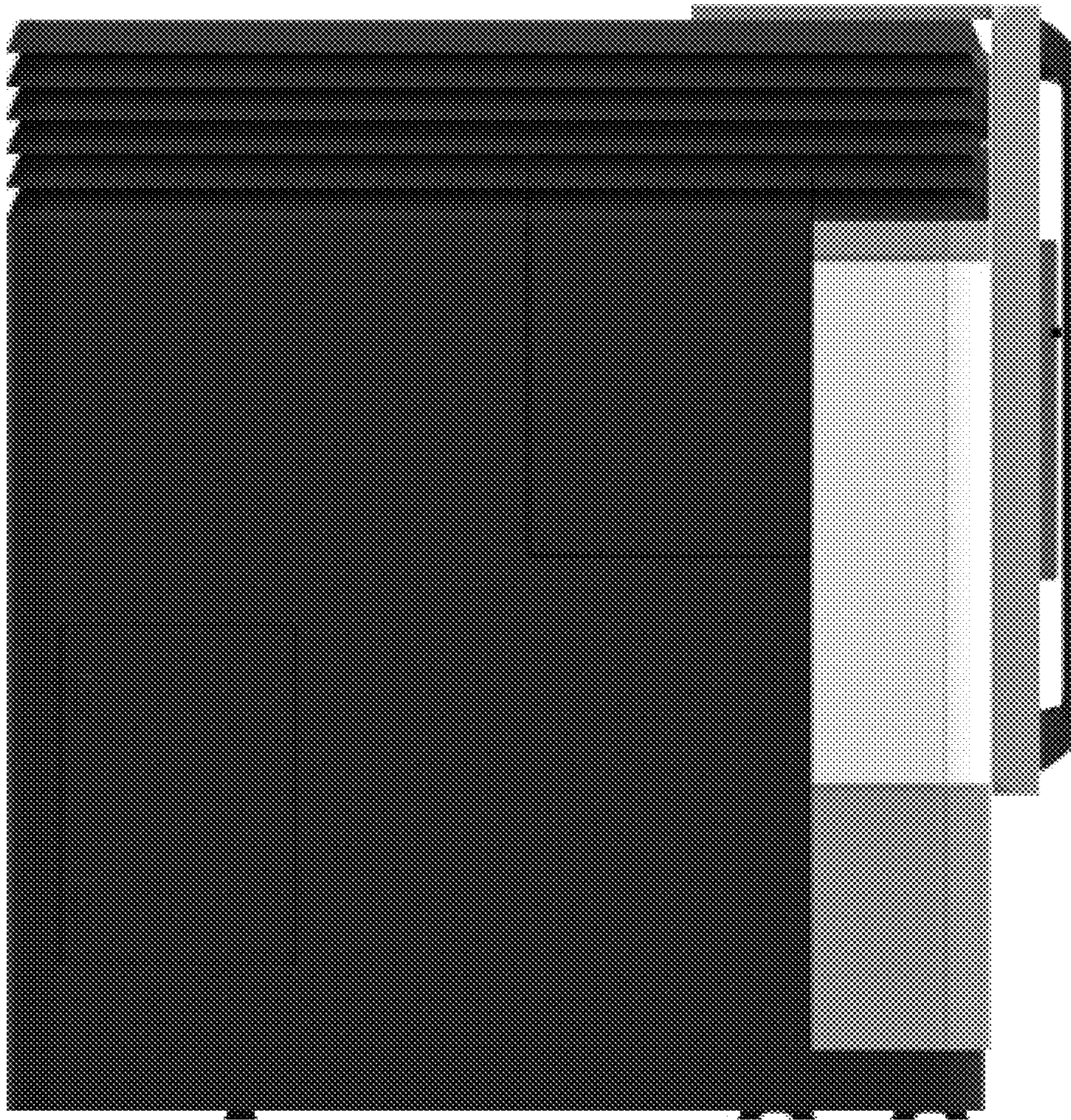

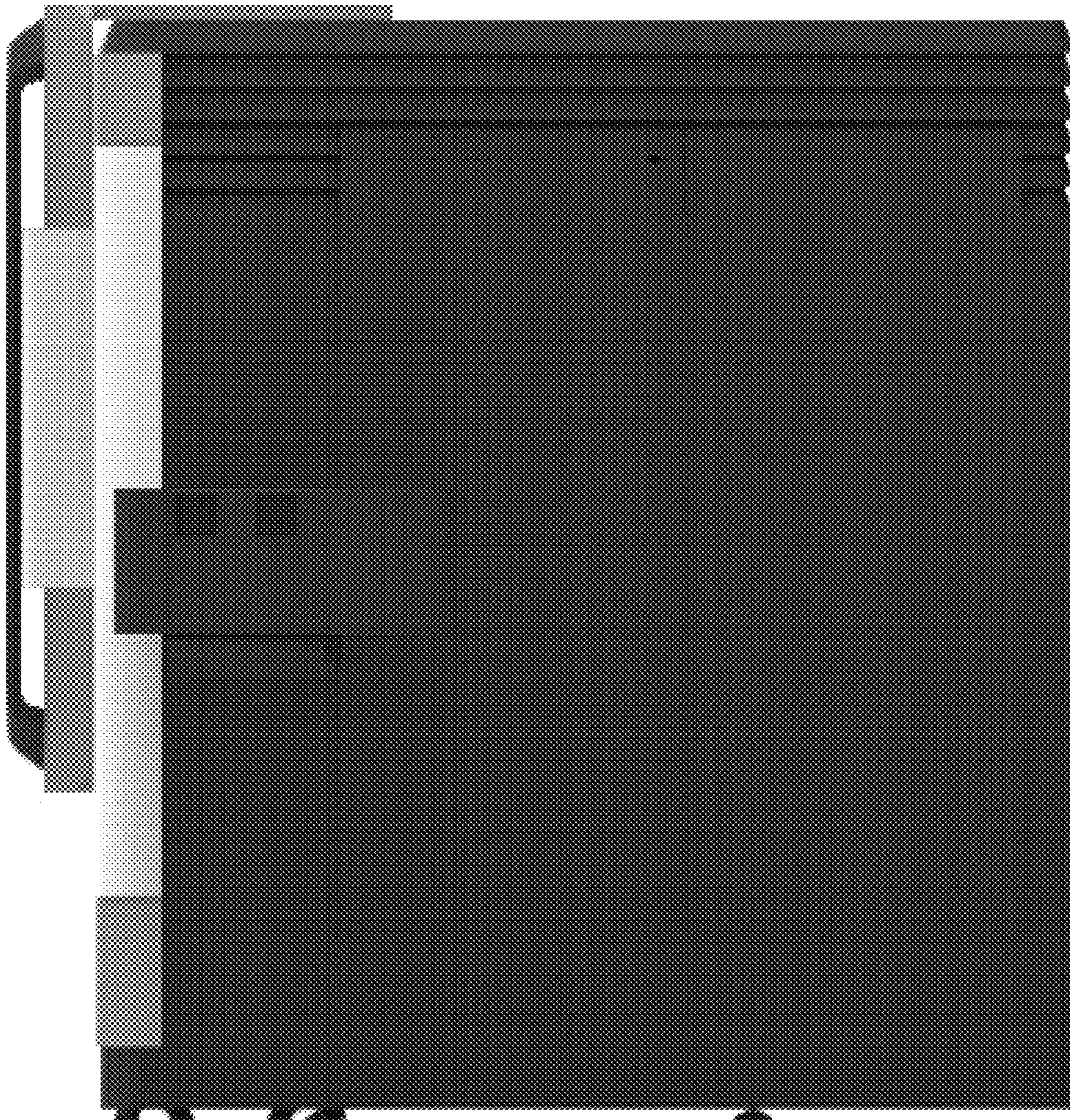
