The ornamental design for a massage device, as shown and described.

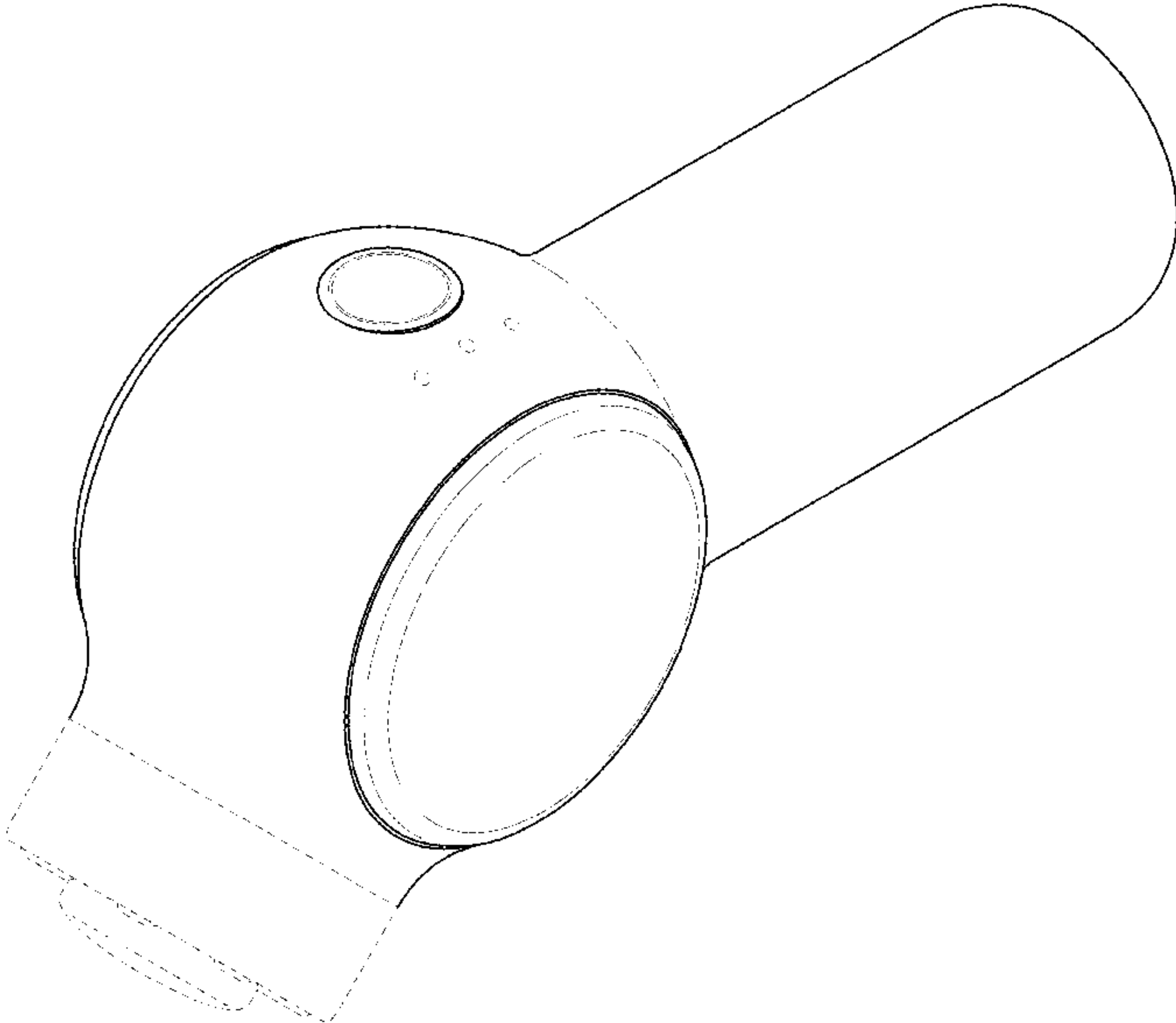
DESCRIPTION

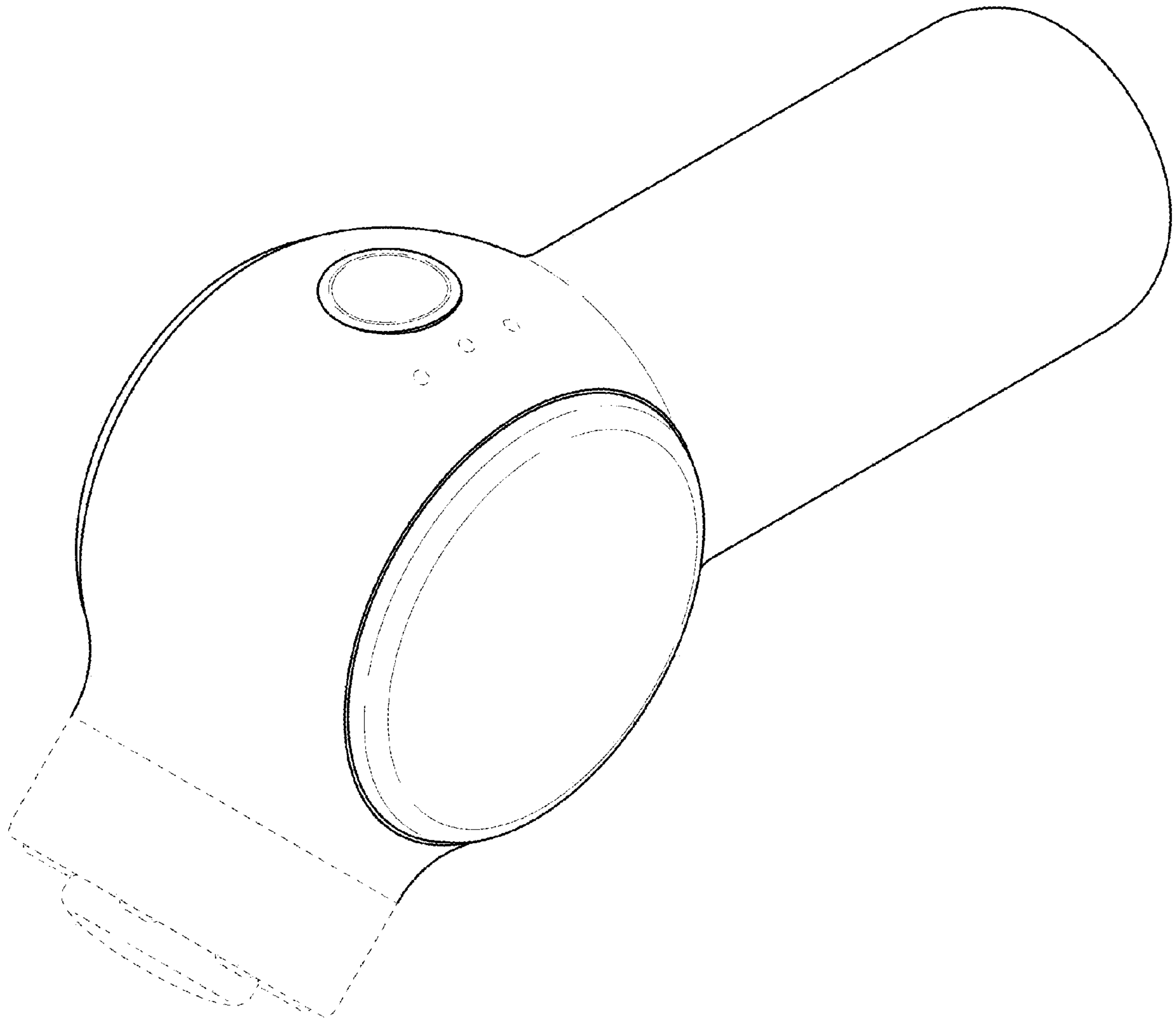

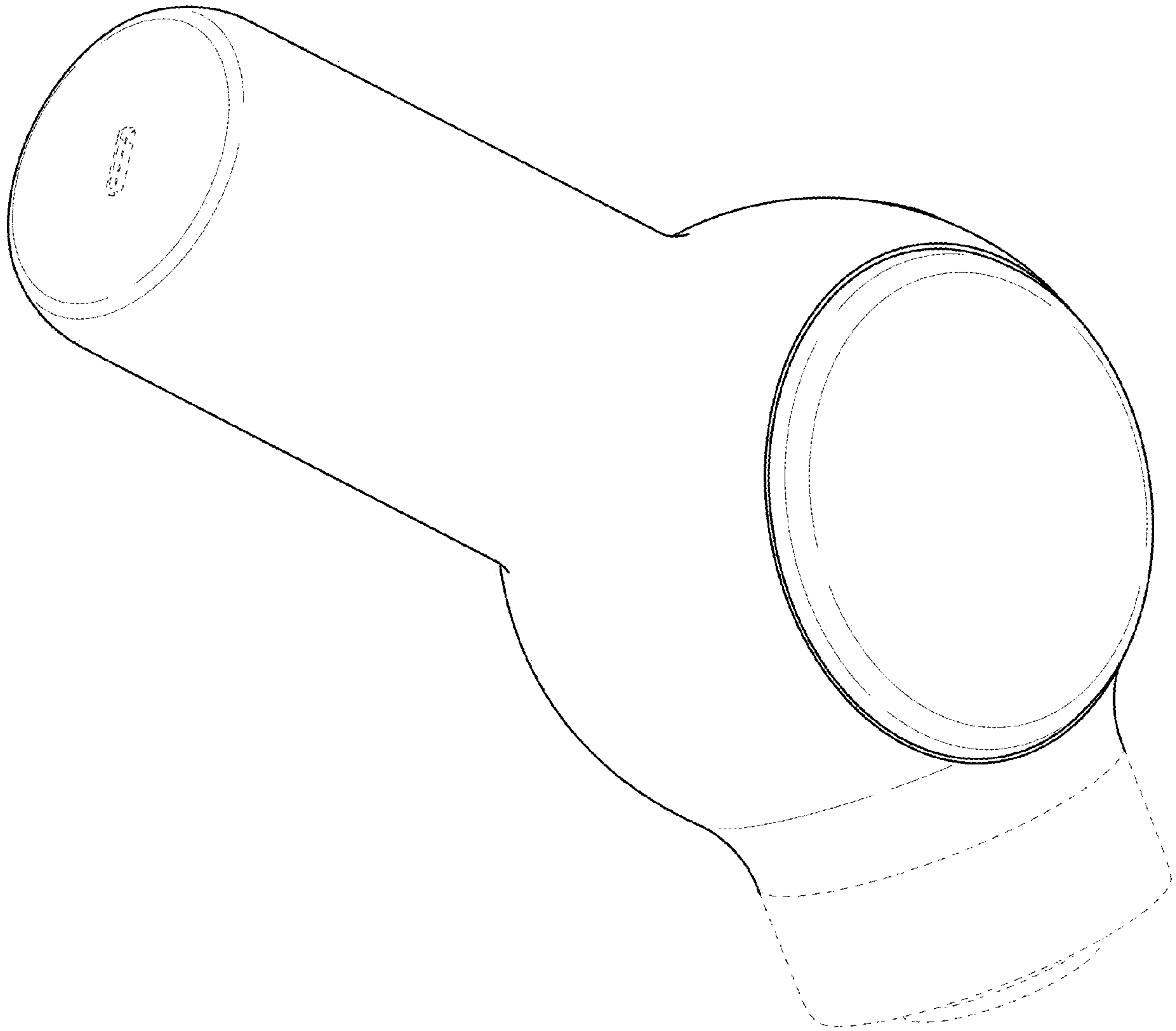

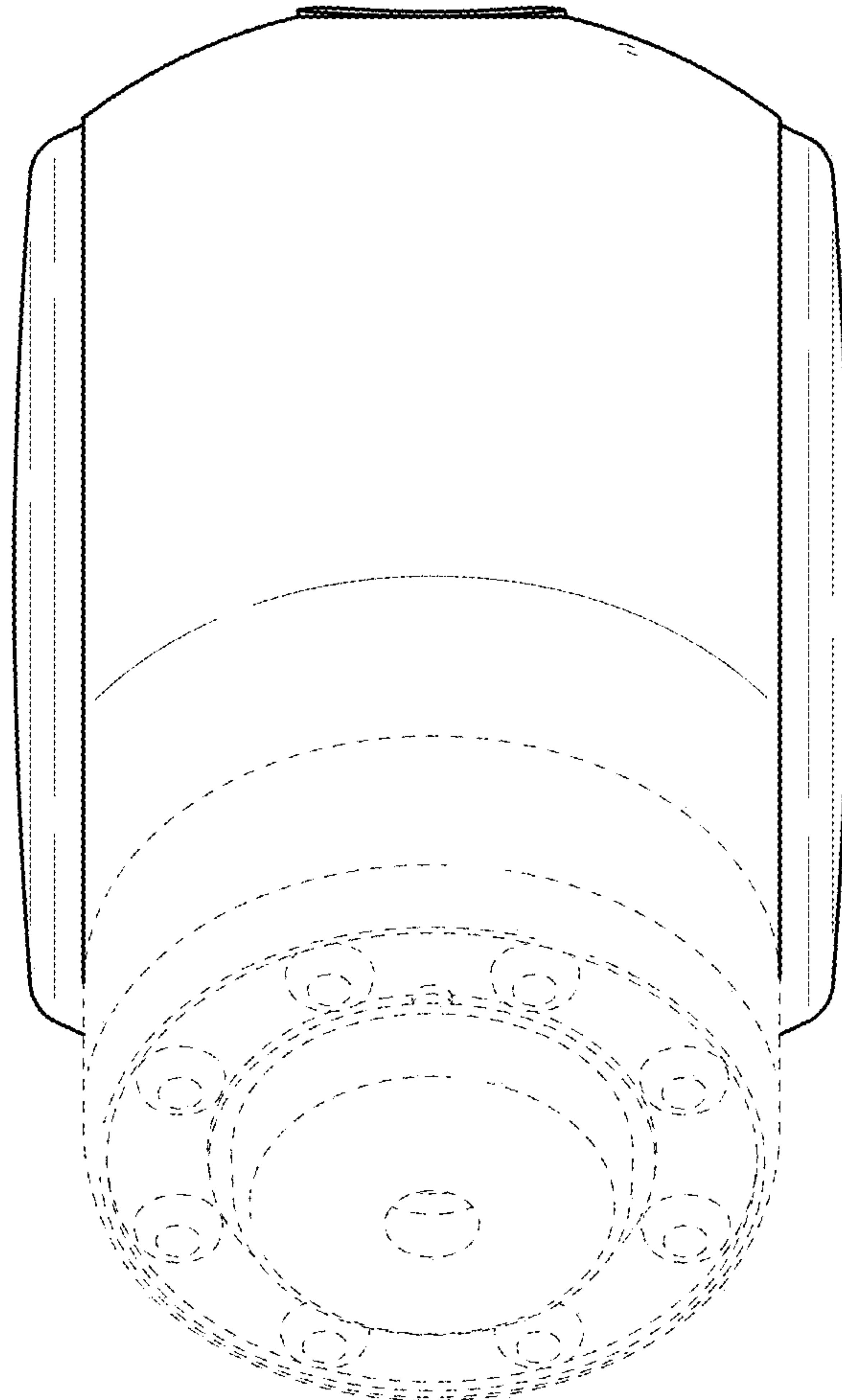

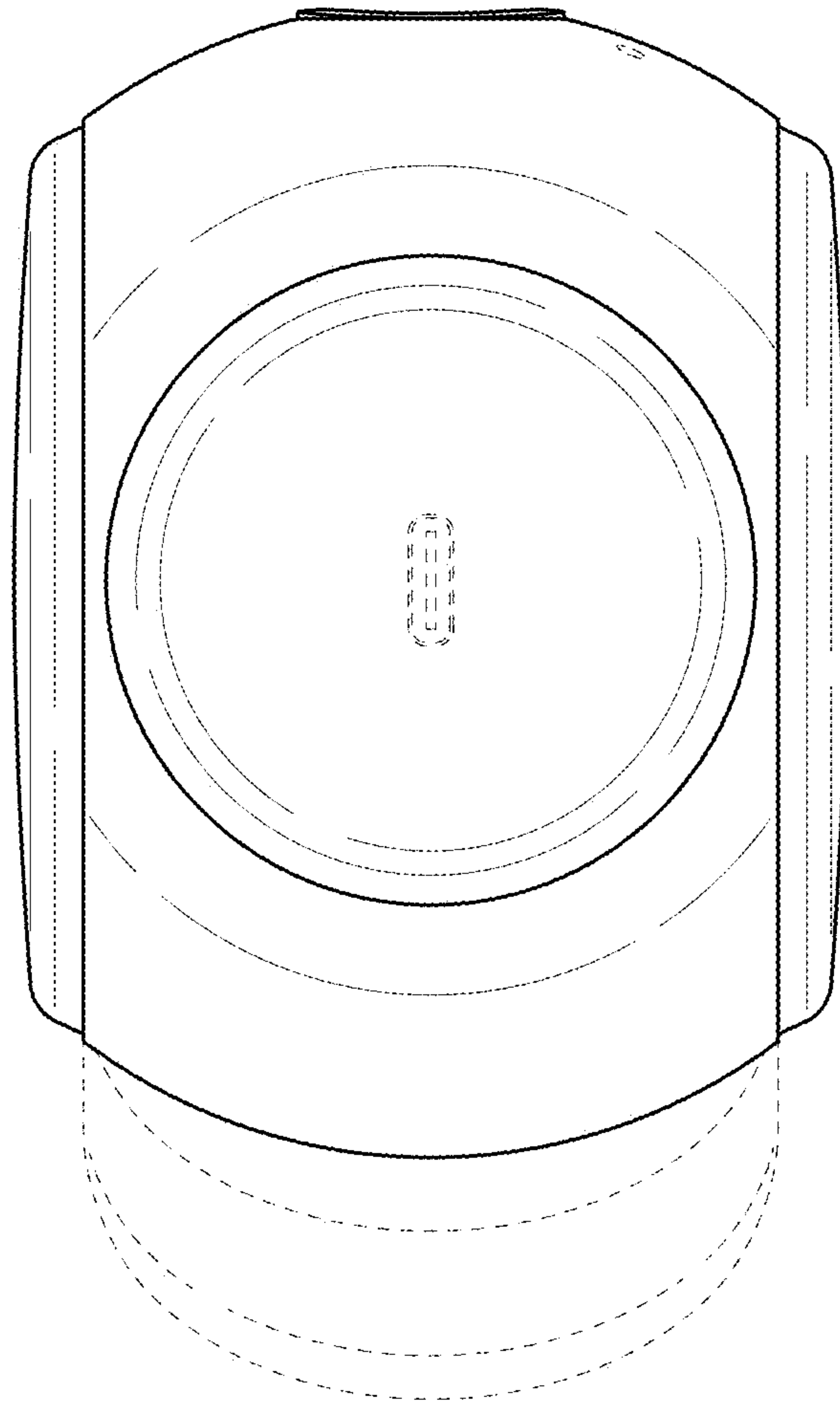

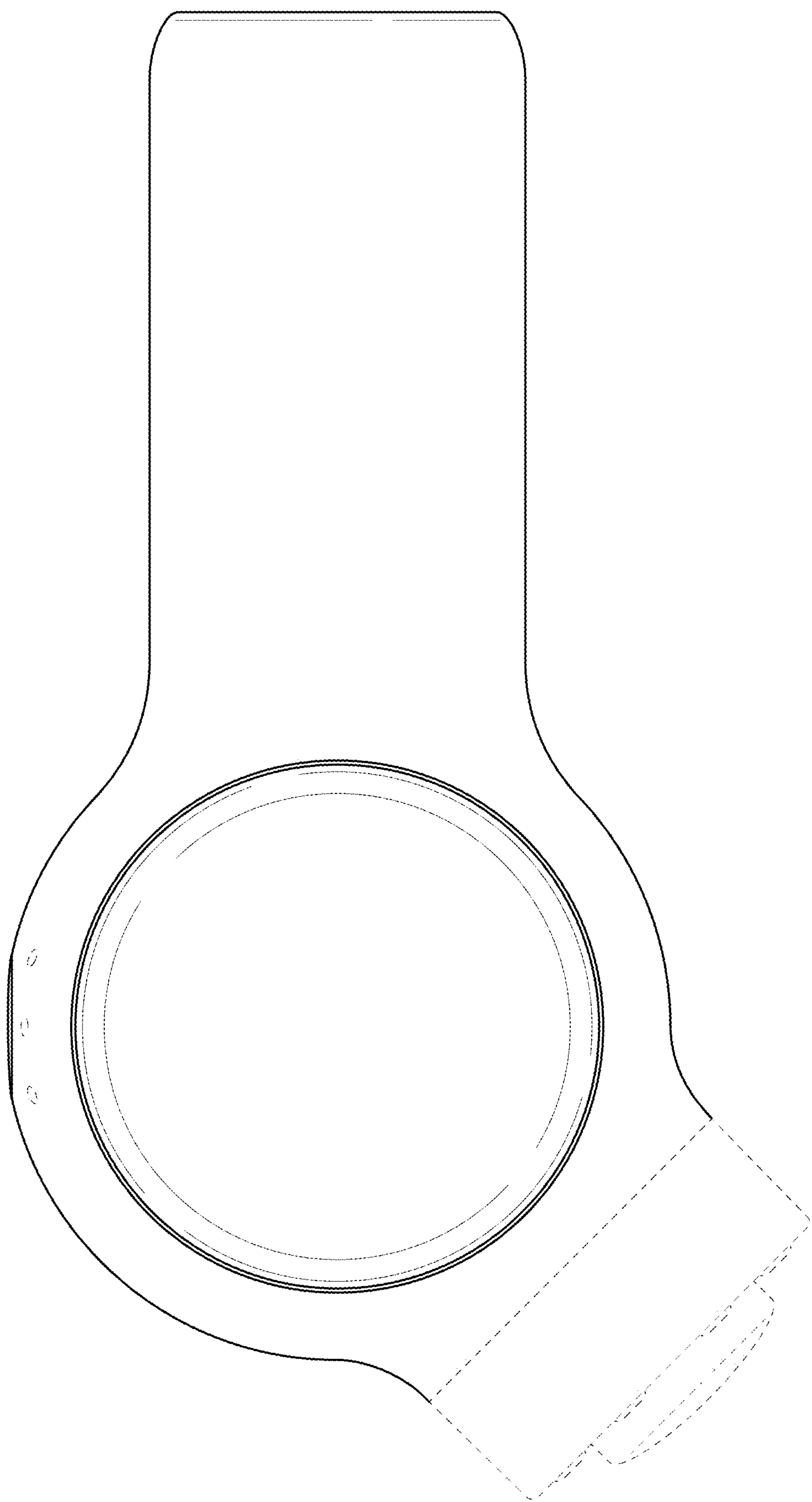

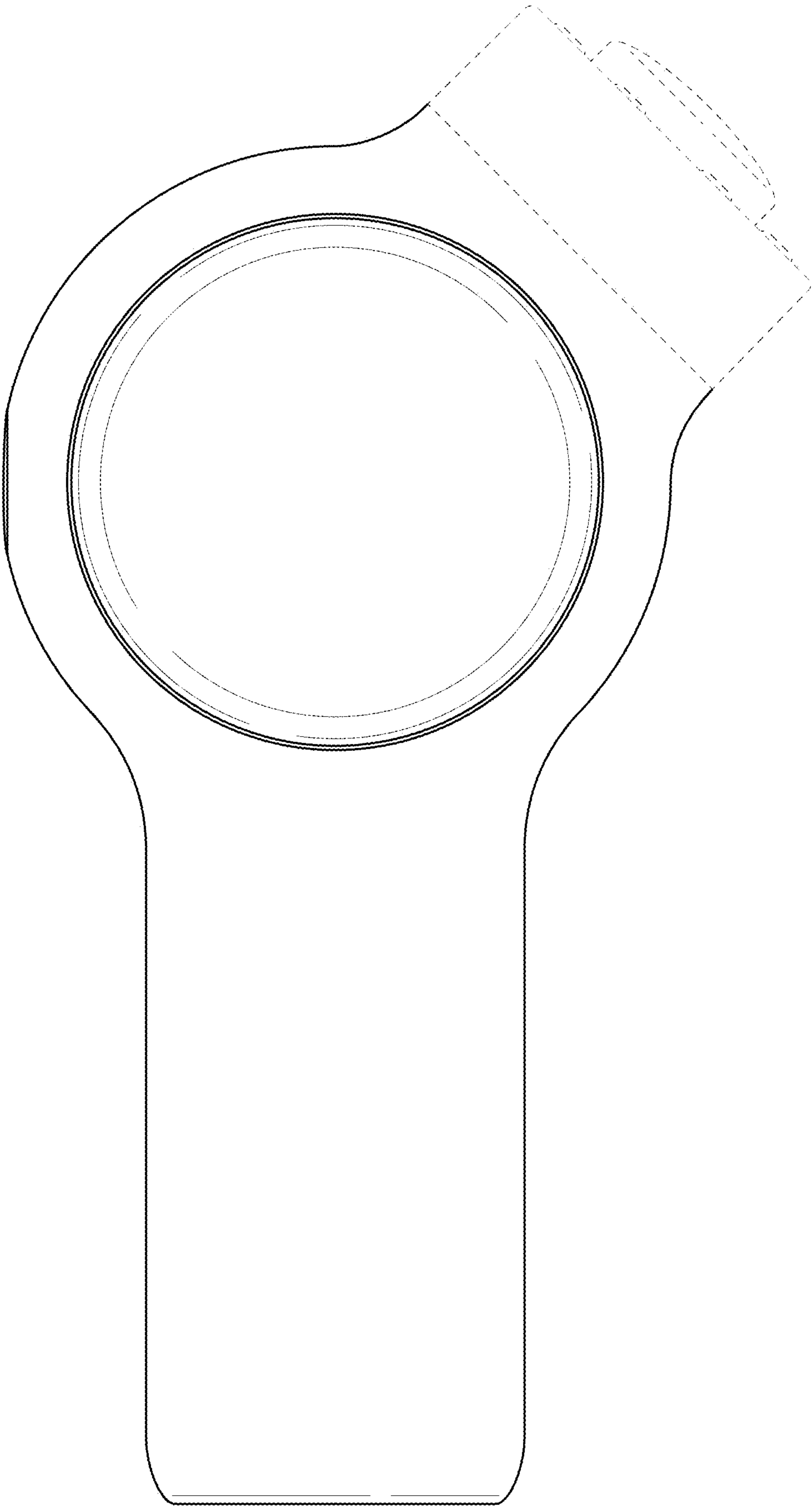

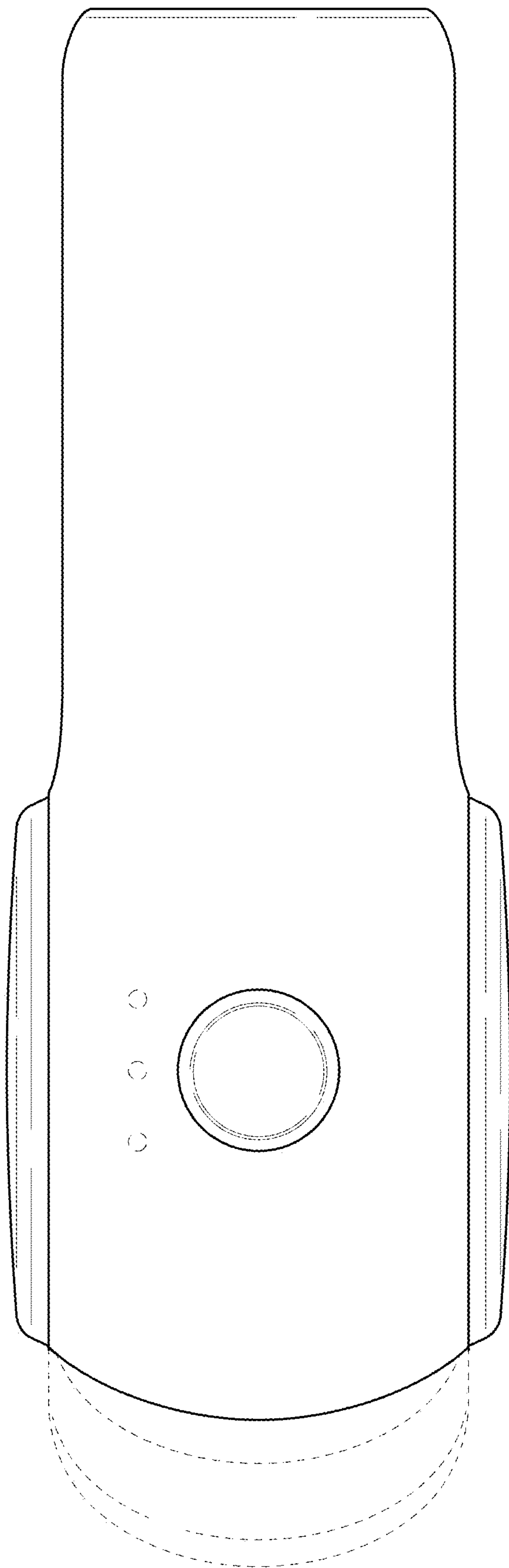

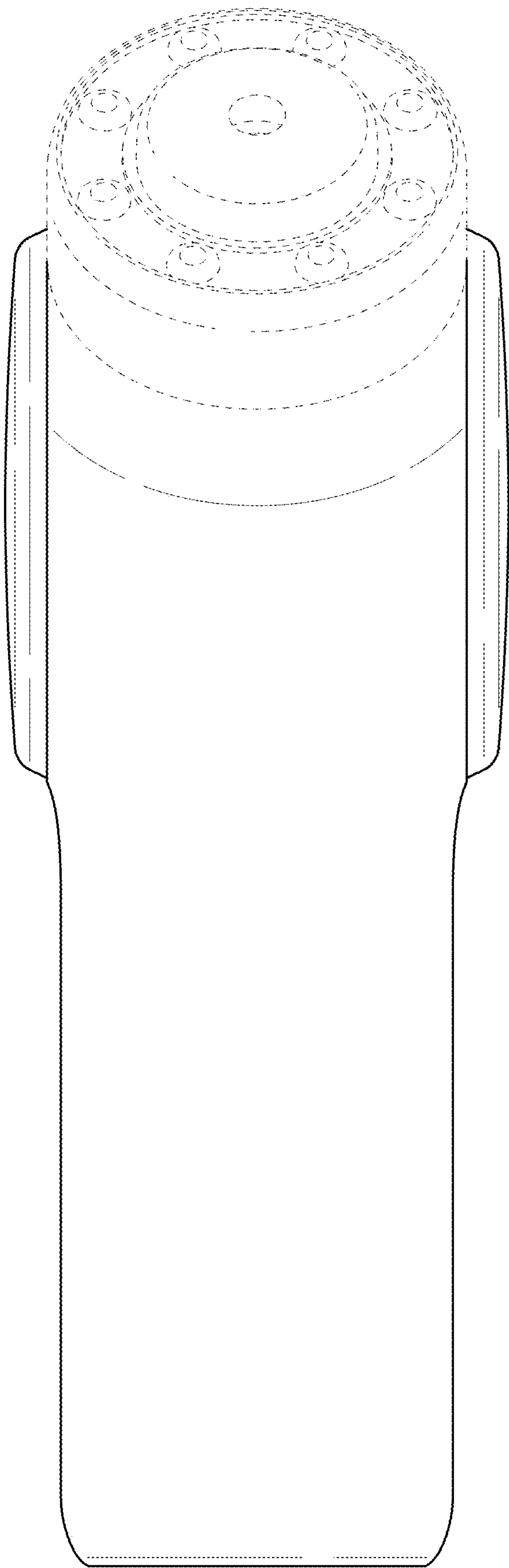
