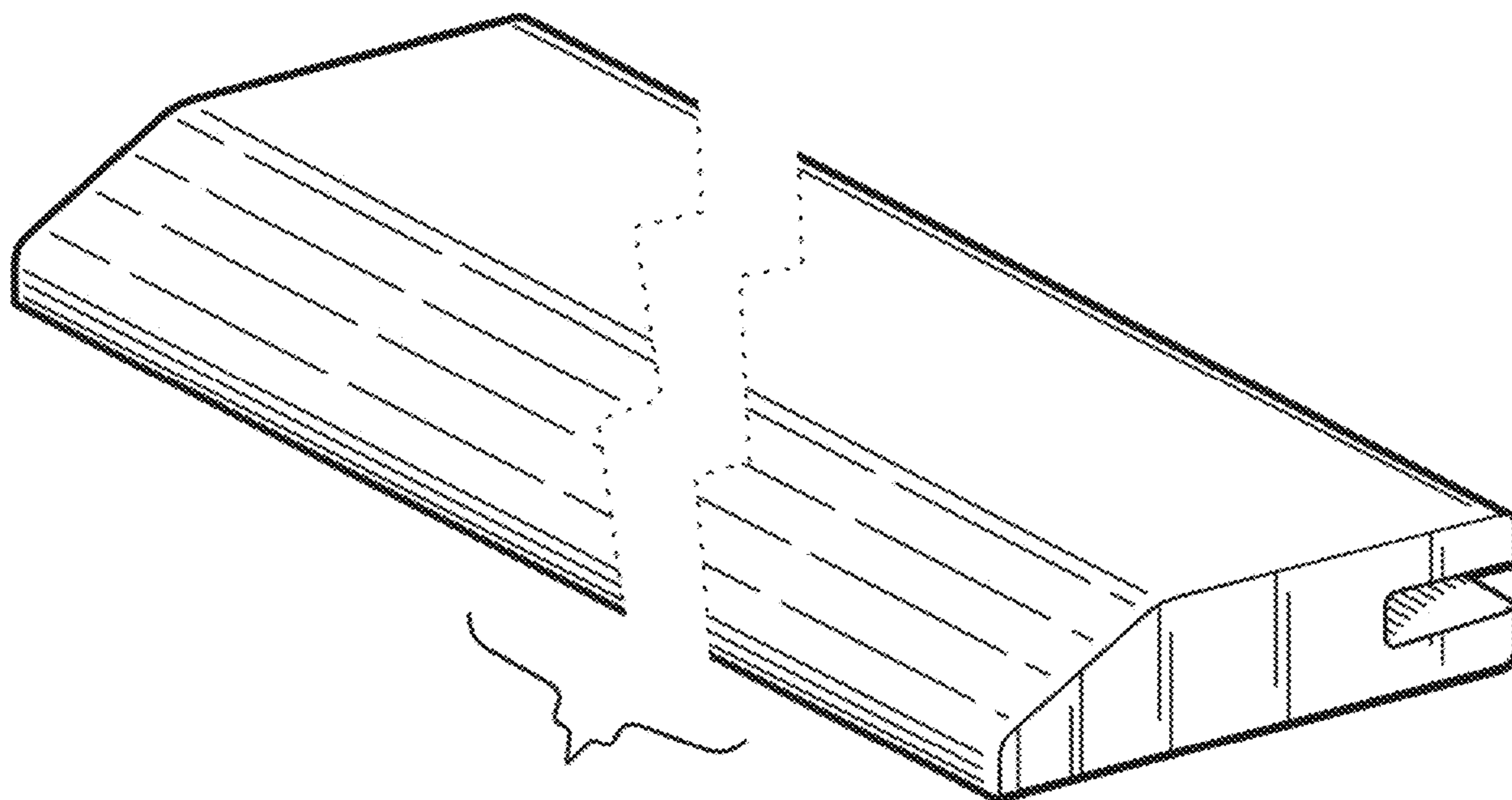
(57) **CLAIM**

The ornamental design for an extrusion for a draft seal, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the extrusion for a draft seal; and,

The dotted broken lines depict a symbolic break. The portion between the break lines forms no part of the claimed design.

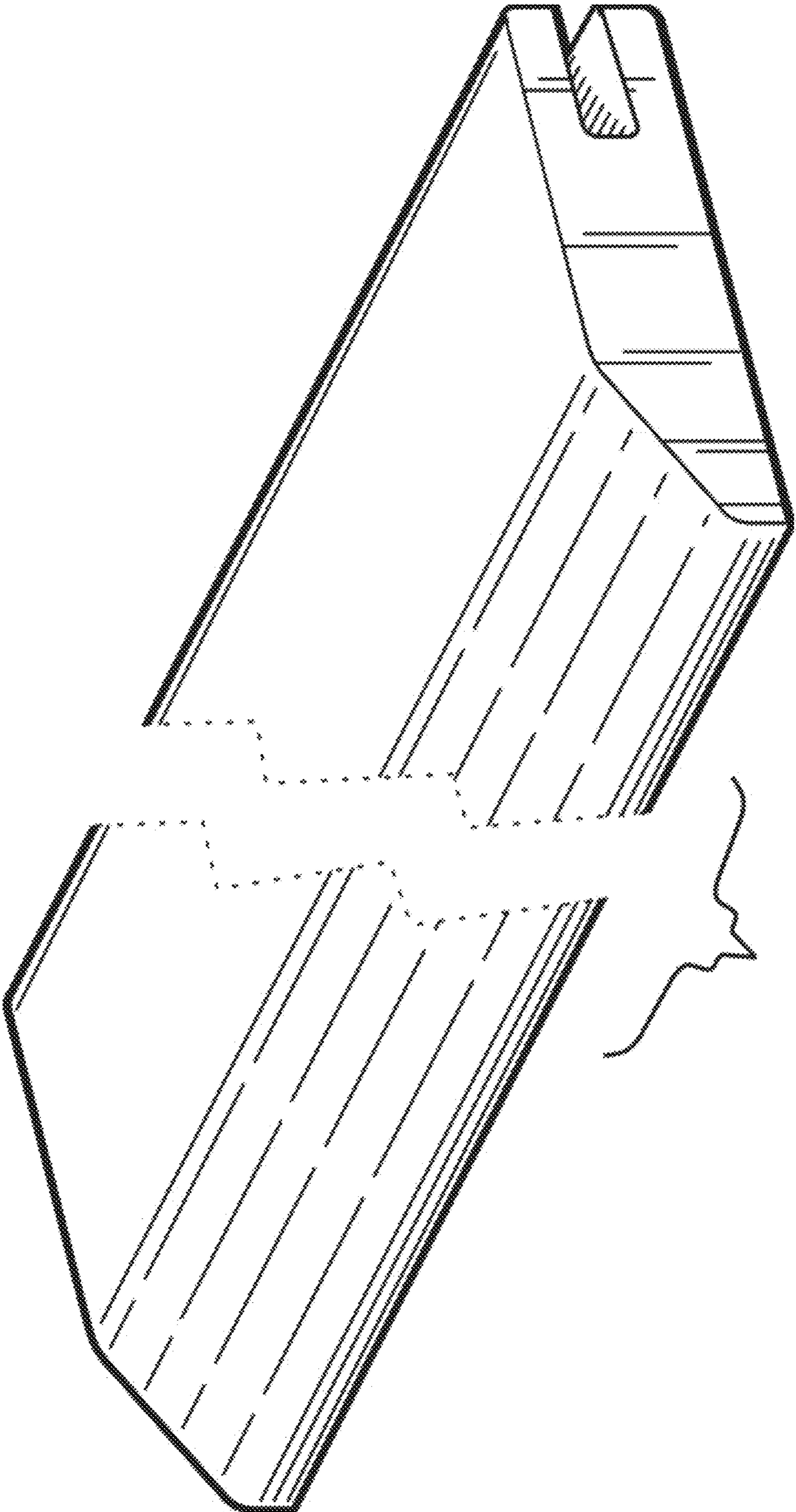

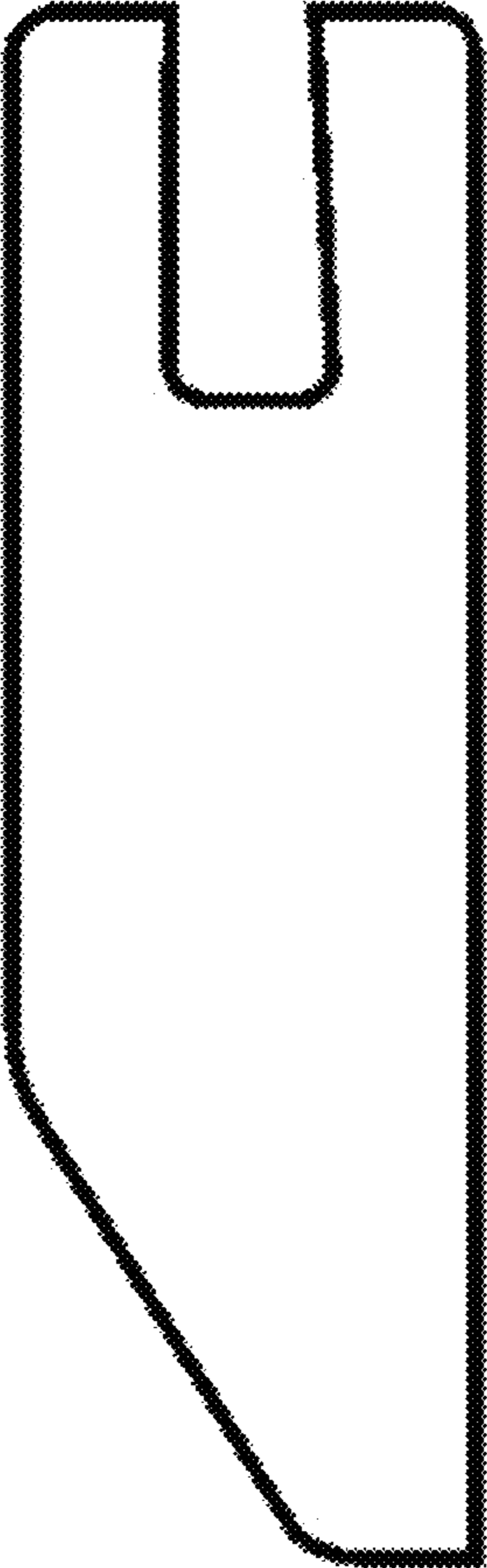
