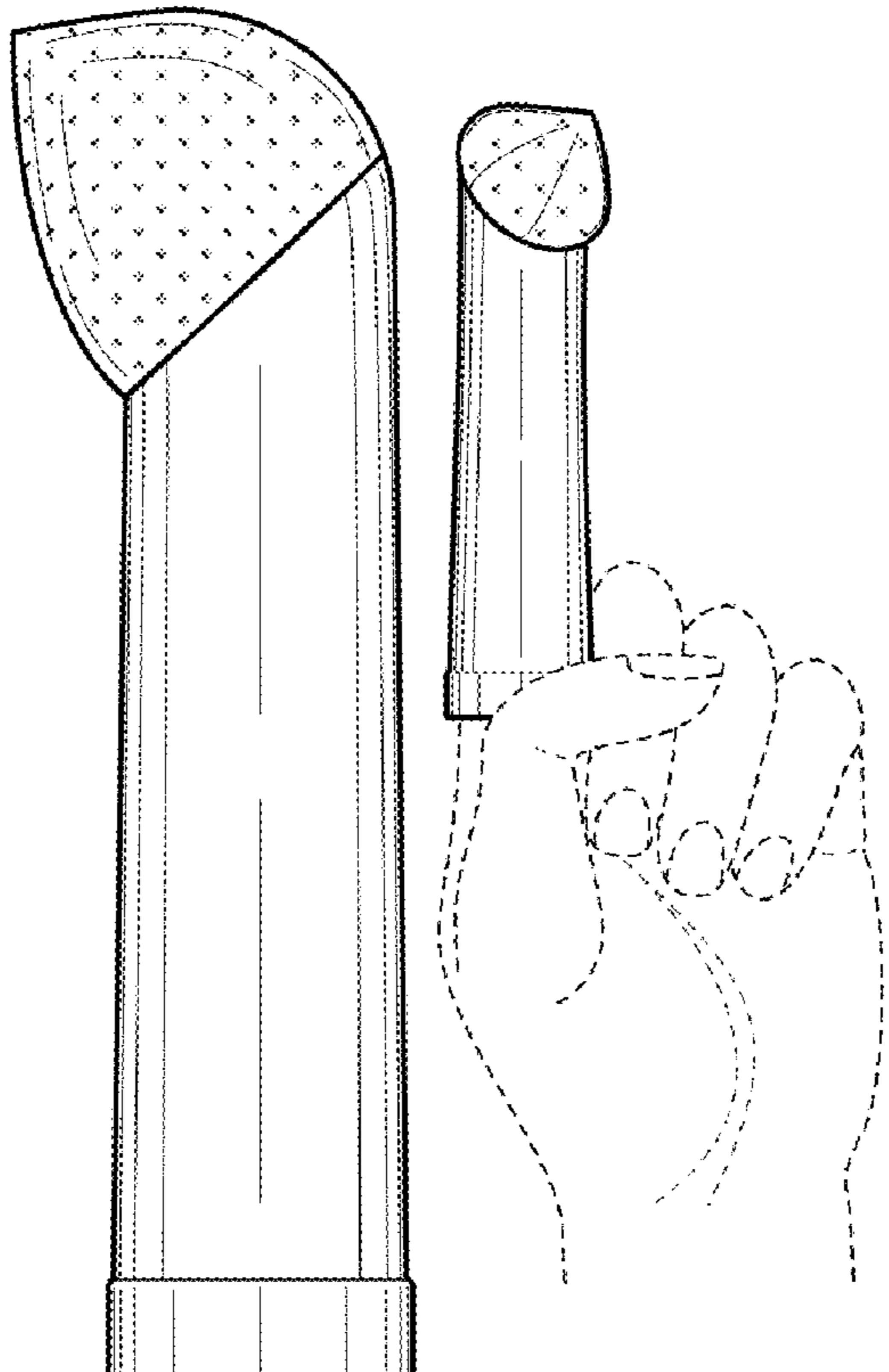

The ornamental design for a makeup applicator, as shown and described.

DESCRIPTION
FIG. 1 is a top plan view of a makeup applicator; FIG. 2 is a front elevational view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is an isometric view thereof; and, FIG. 7 is an isometric view thereof, showing my invention in use.
The broken lines represent environmental structure and form no part of the claimed design.

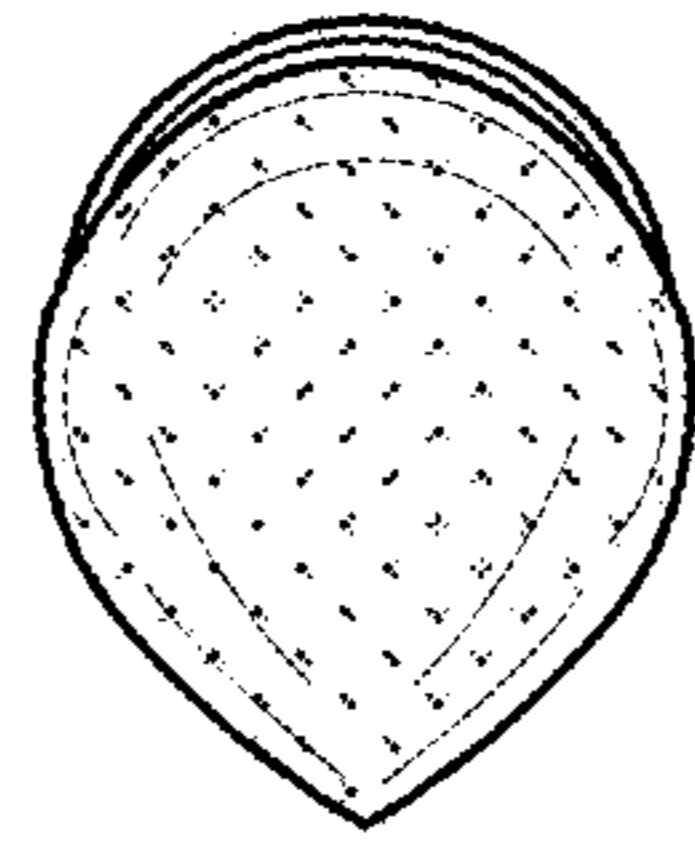

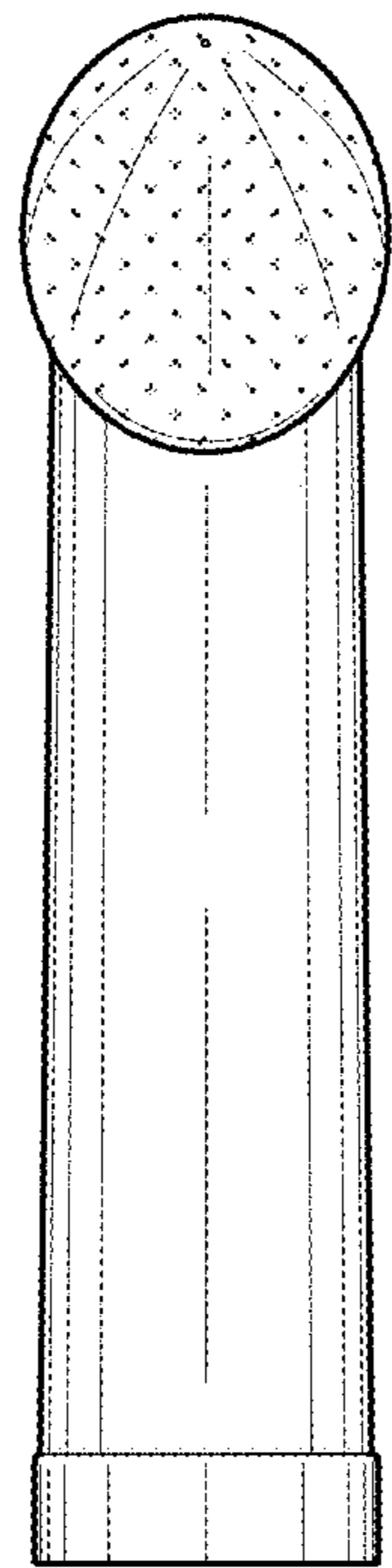

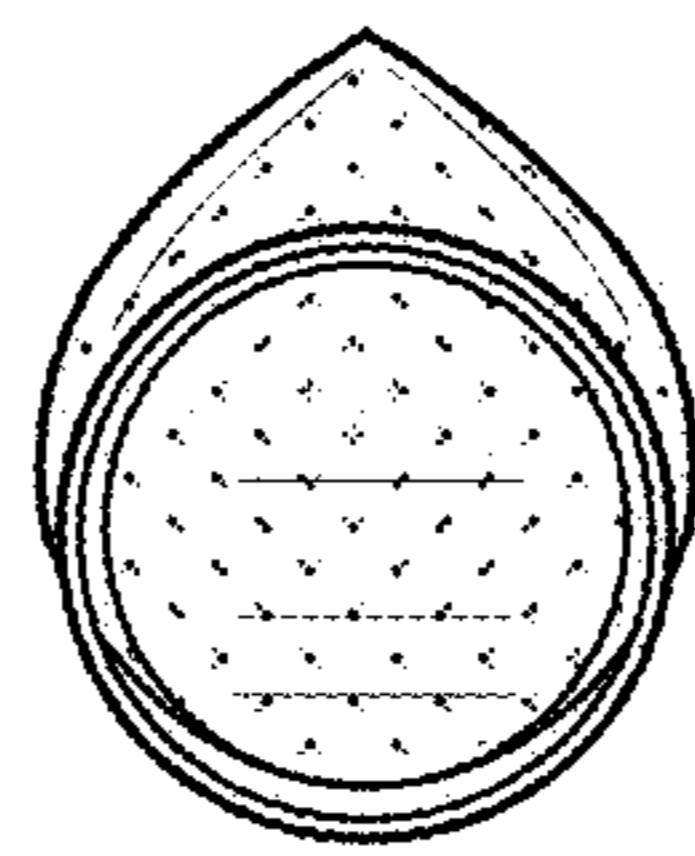

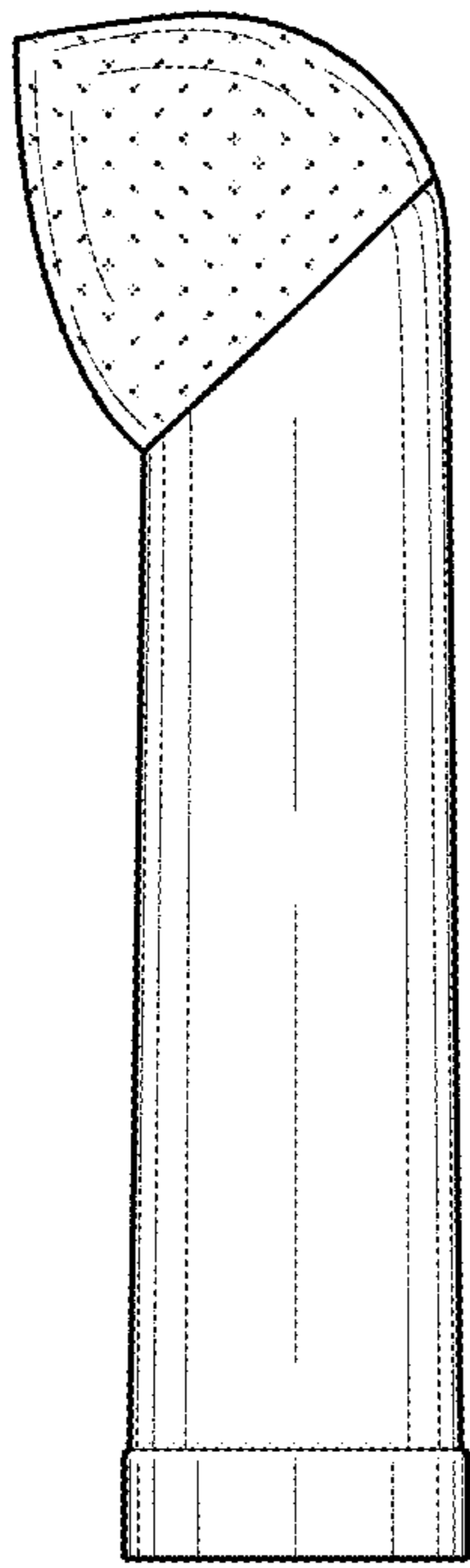

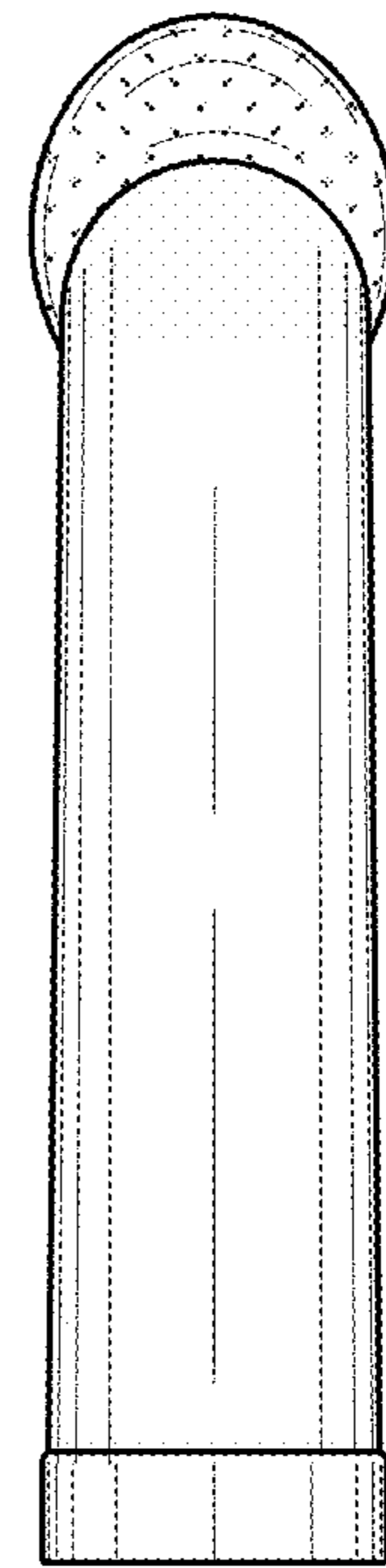

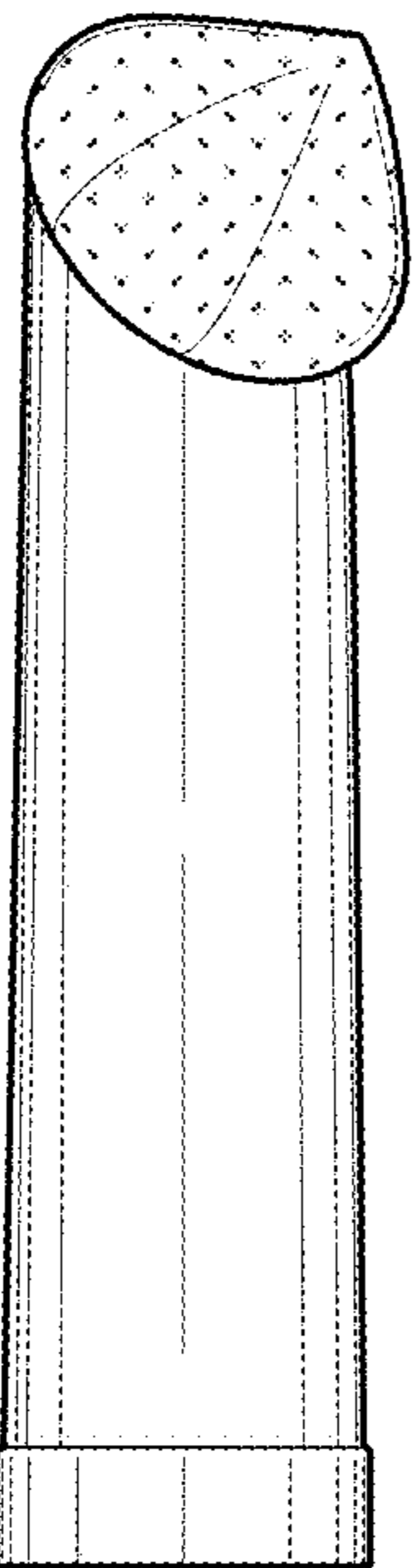

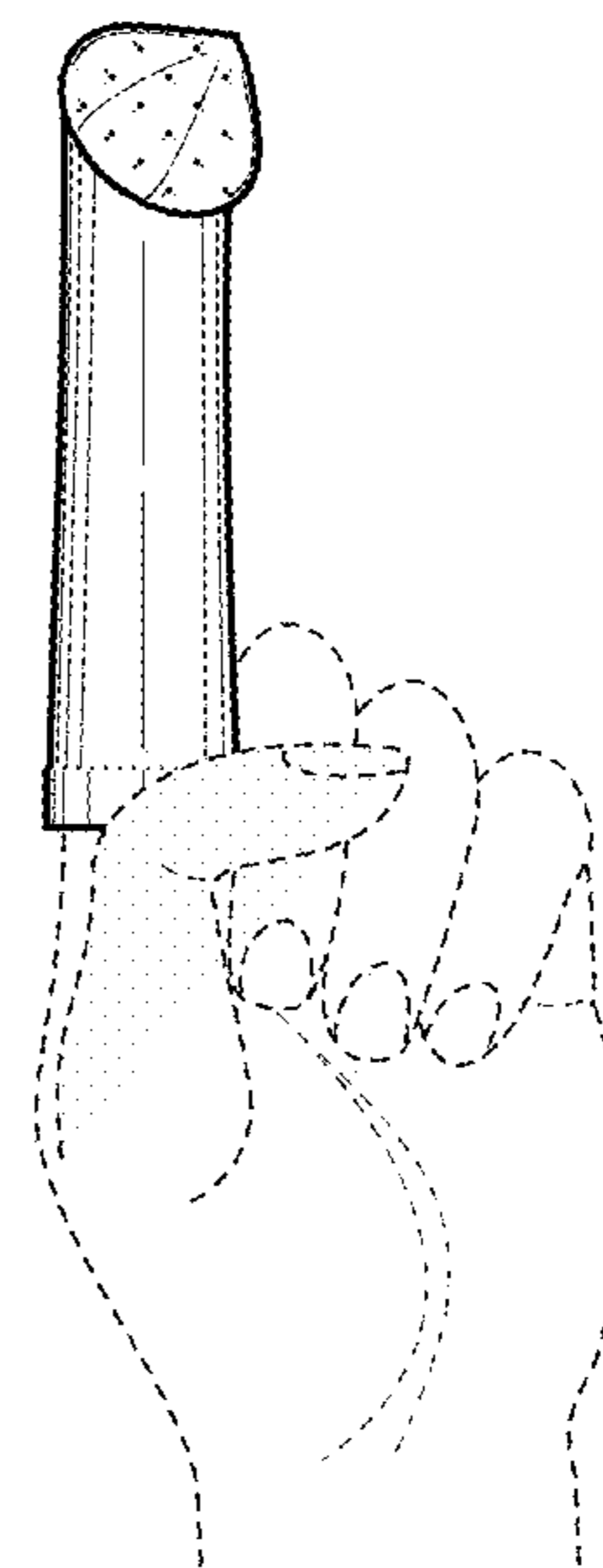
