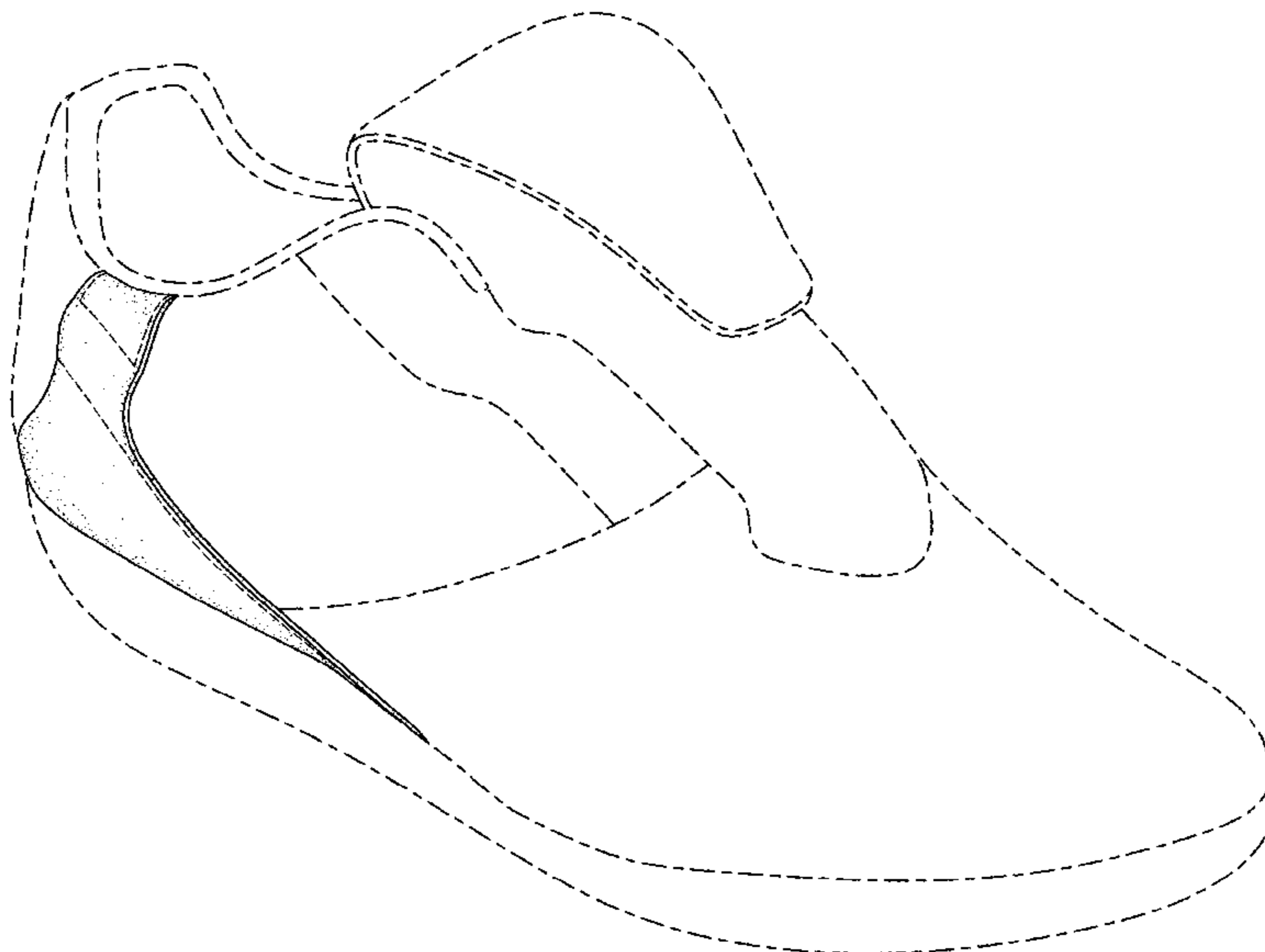
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof; and,

The even-length broken lines represent stitching that forms no part of the claimed design. The uneven-length broken lines depicting the remainder of the shoe form no part of the claimed design.

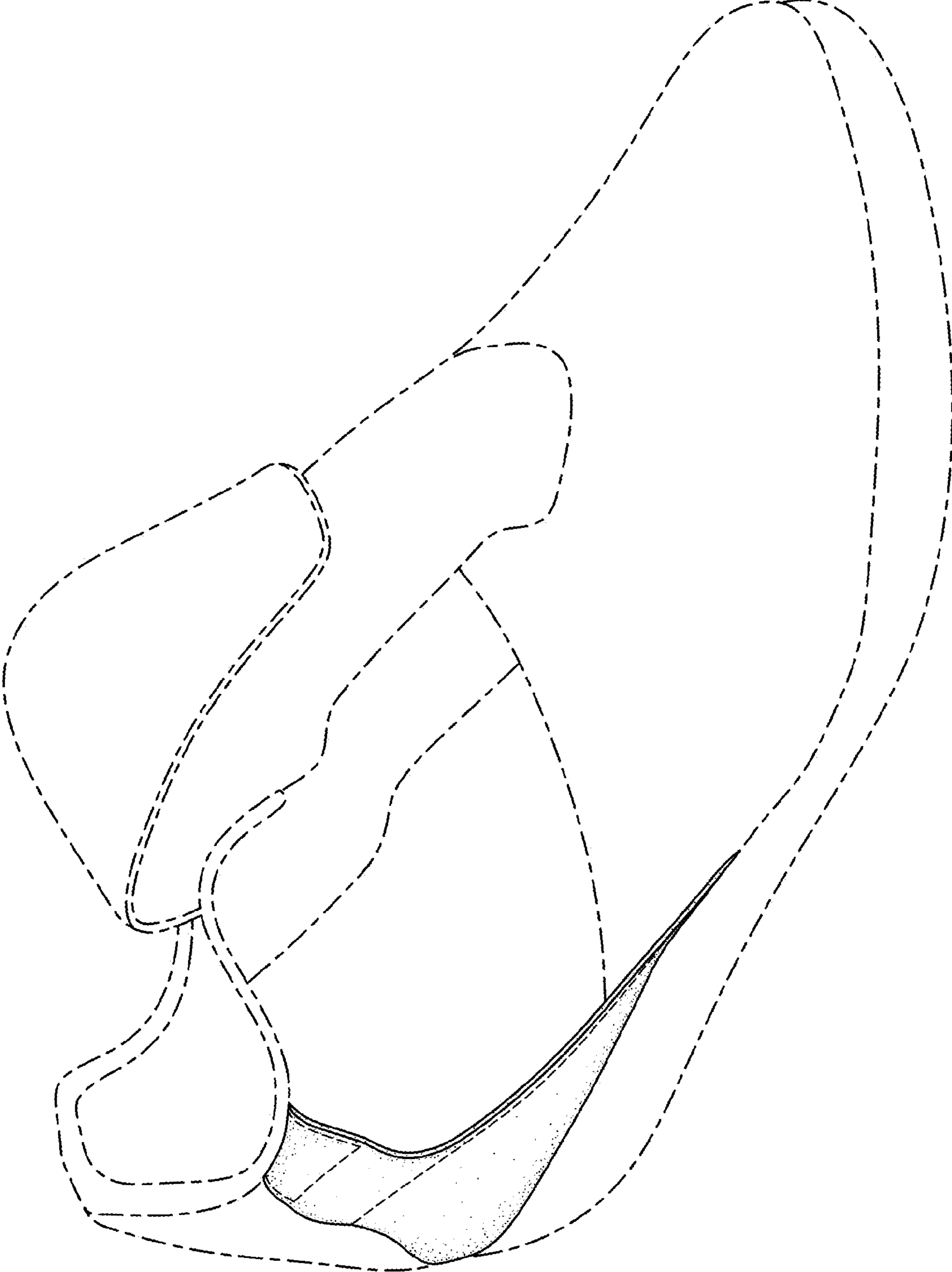

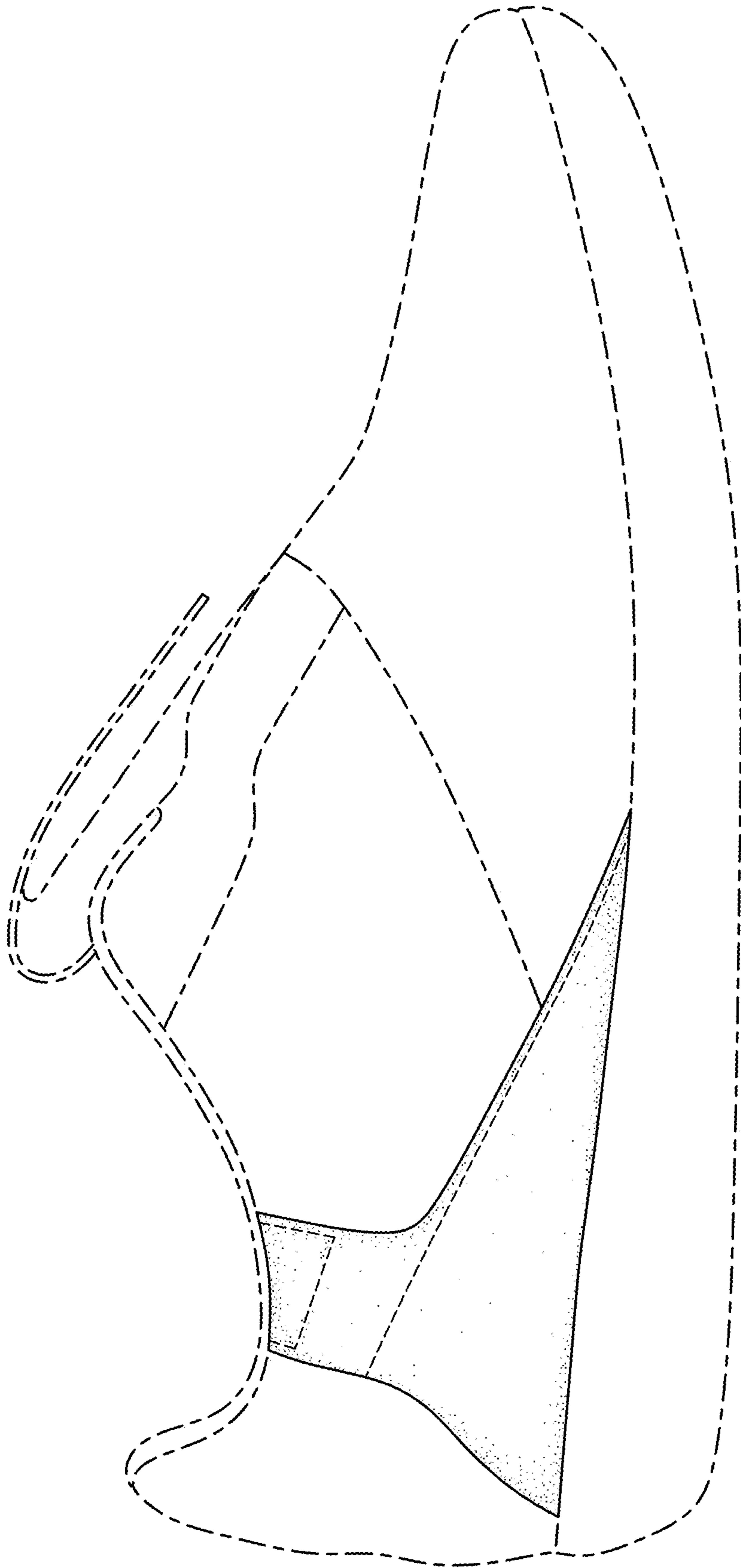

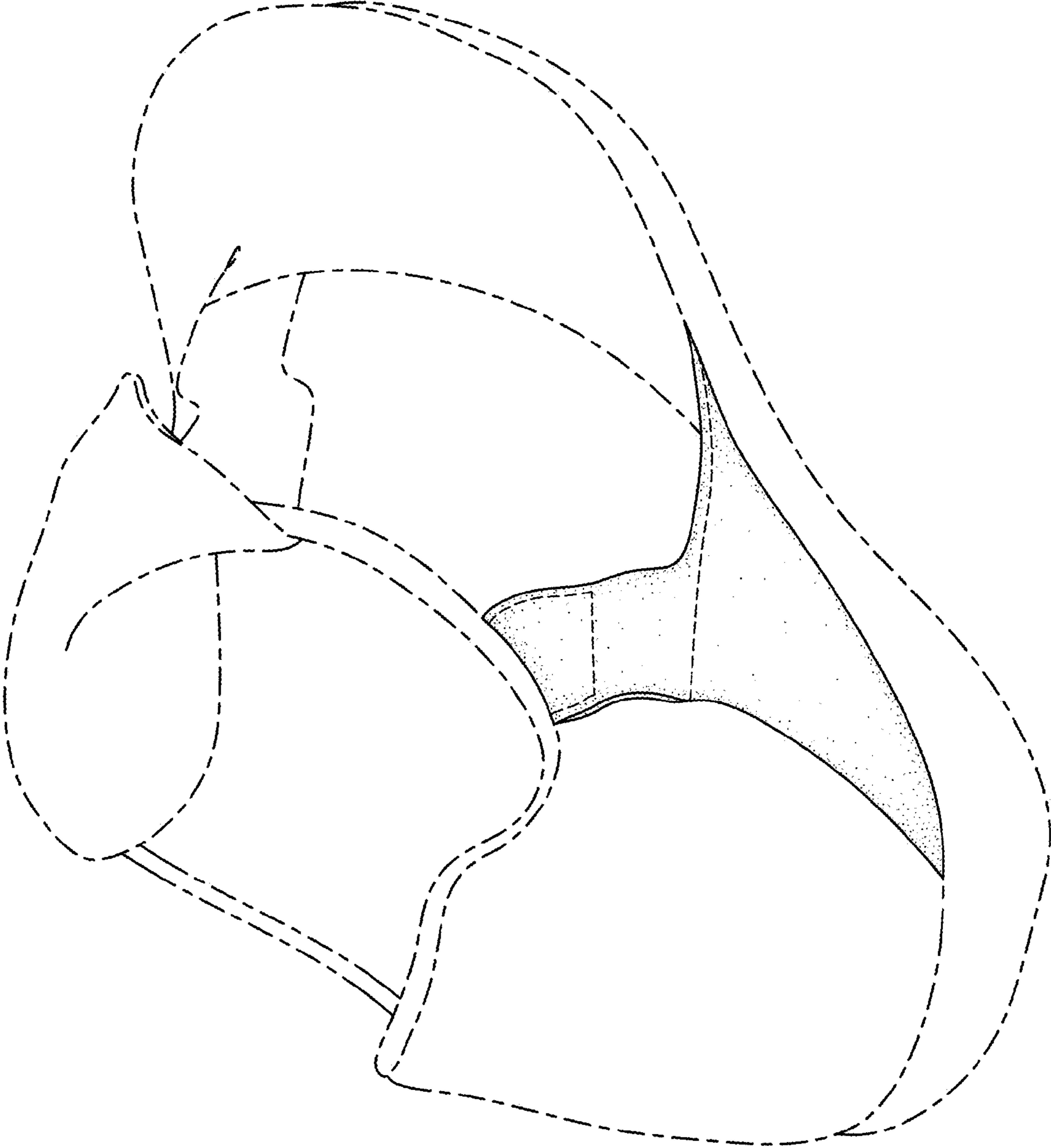
