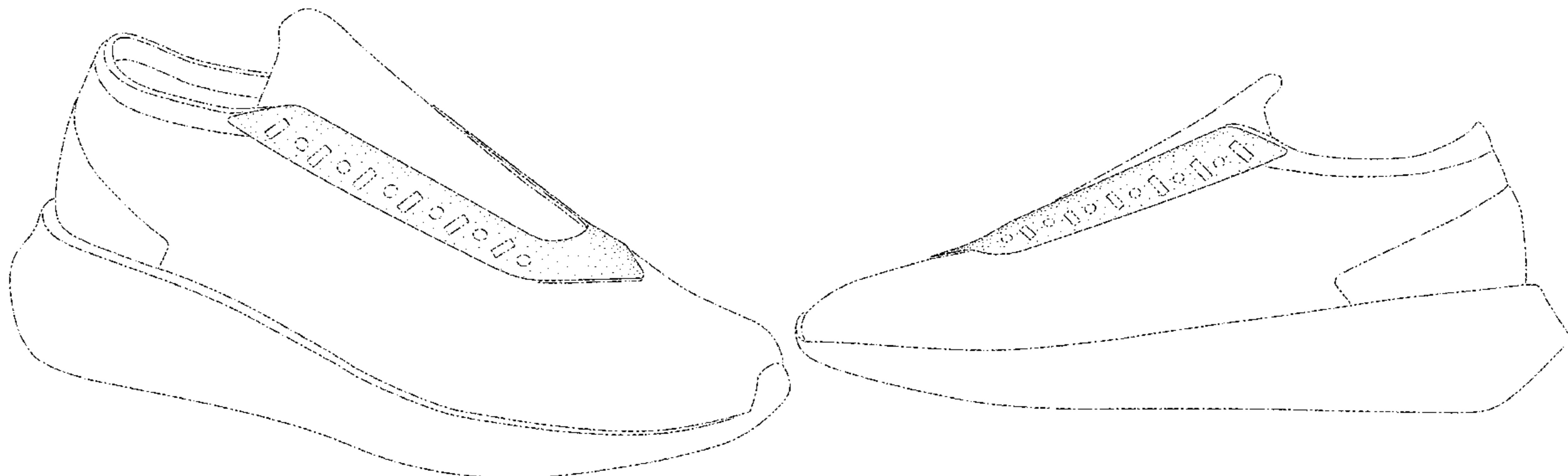
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is an opposite side view thereof; and,
FIG. 4 is an opposite side front perspective view thereof.
The broken line showing of the rectangular and circular shaped elements within the shaded area form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

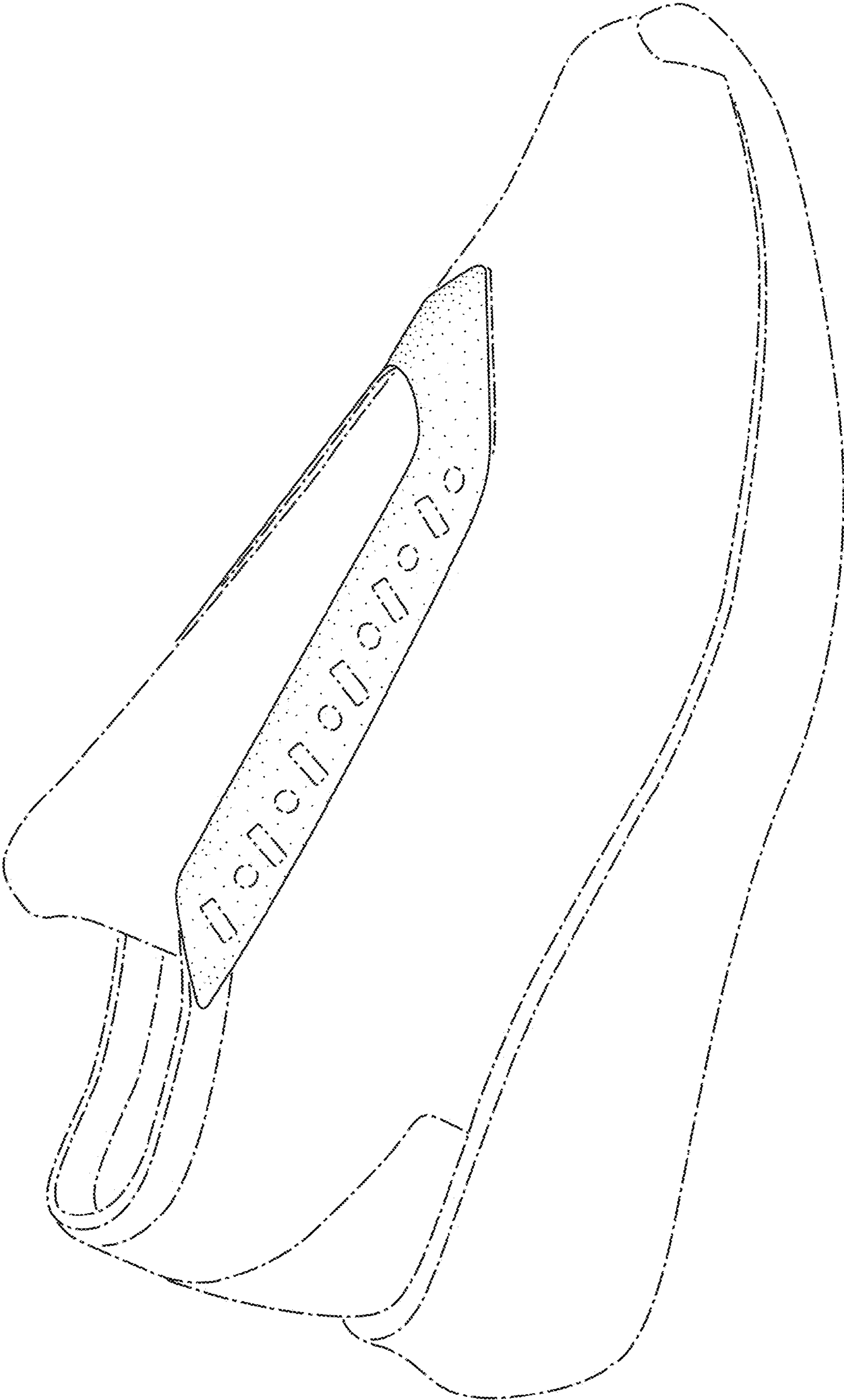

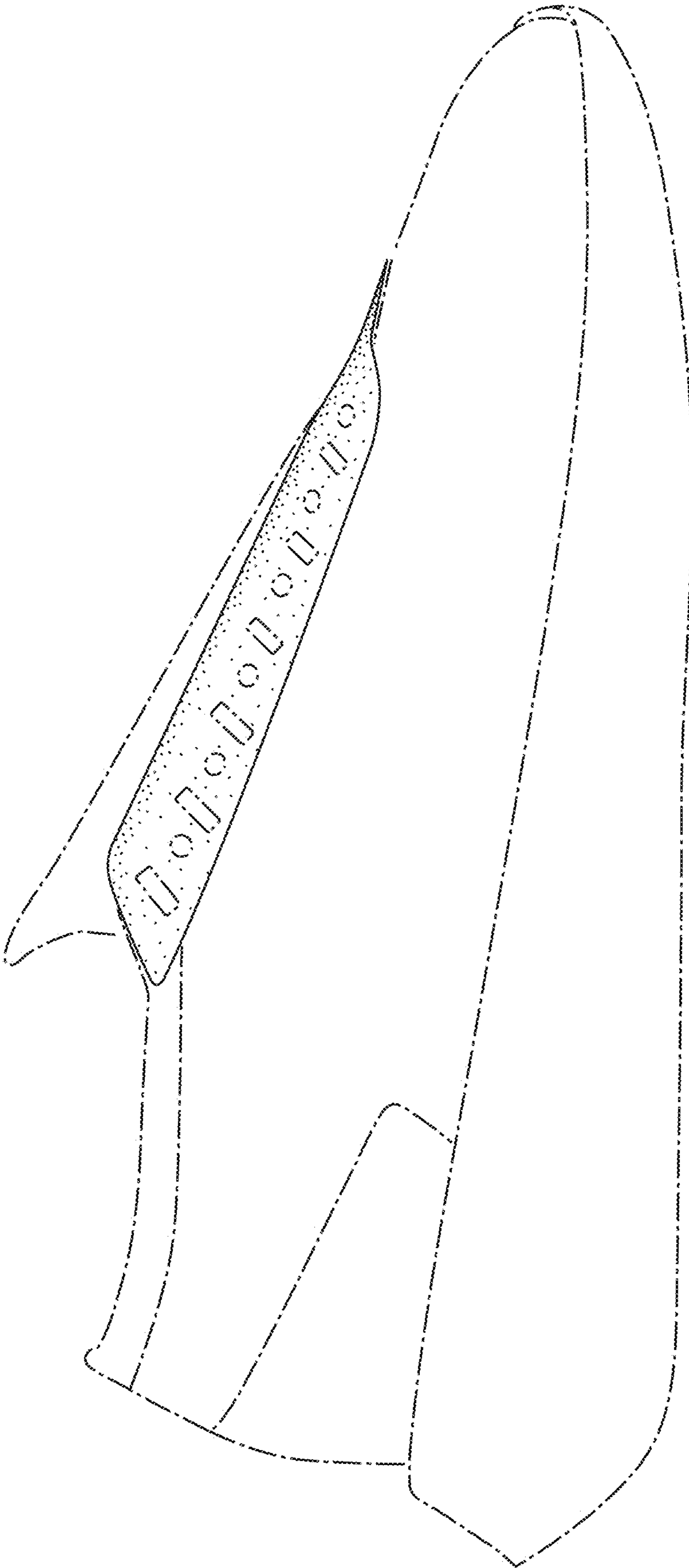

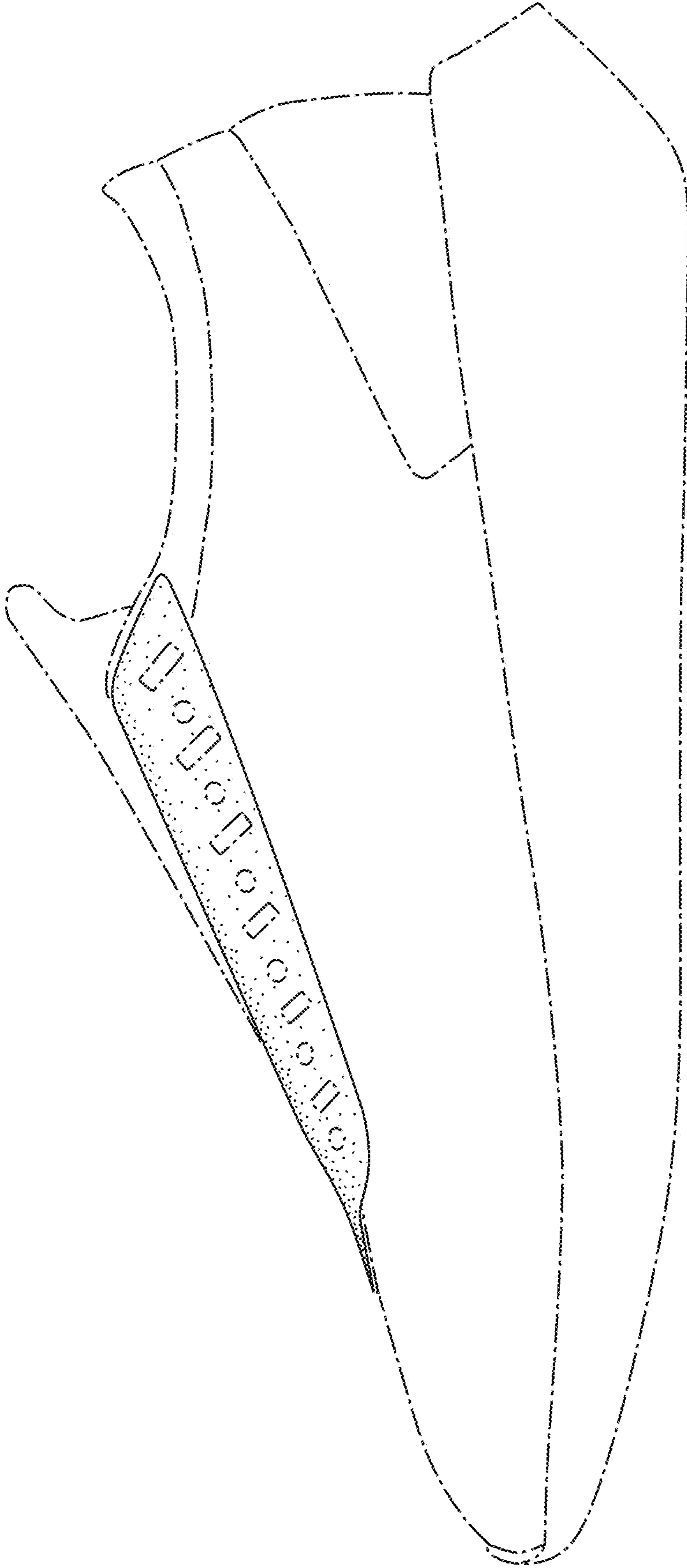

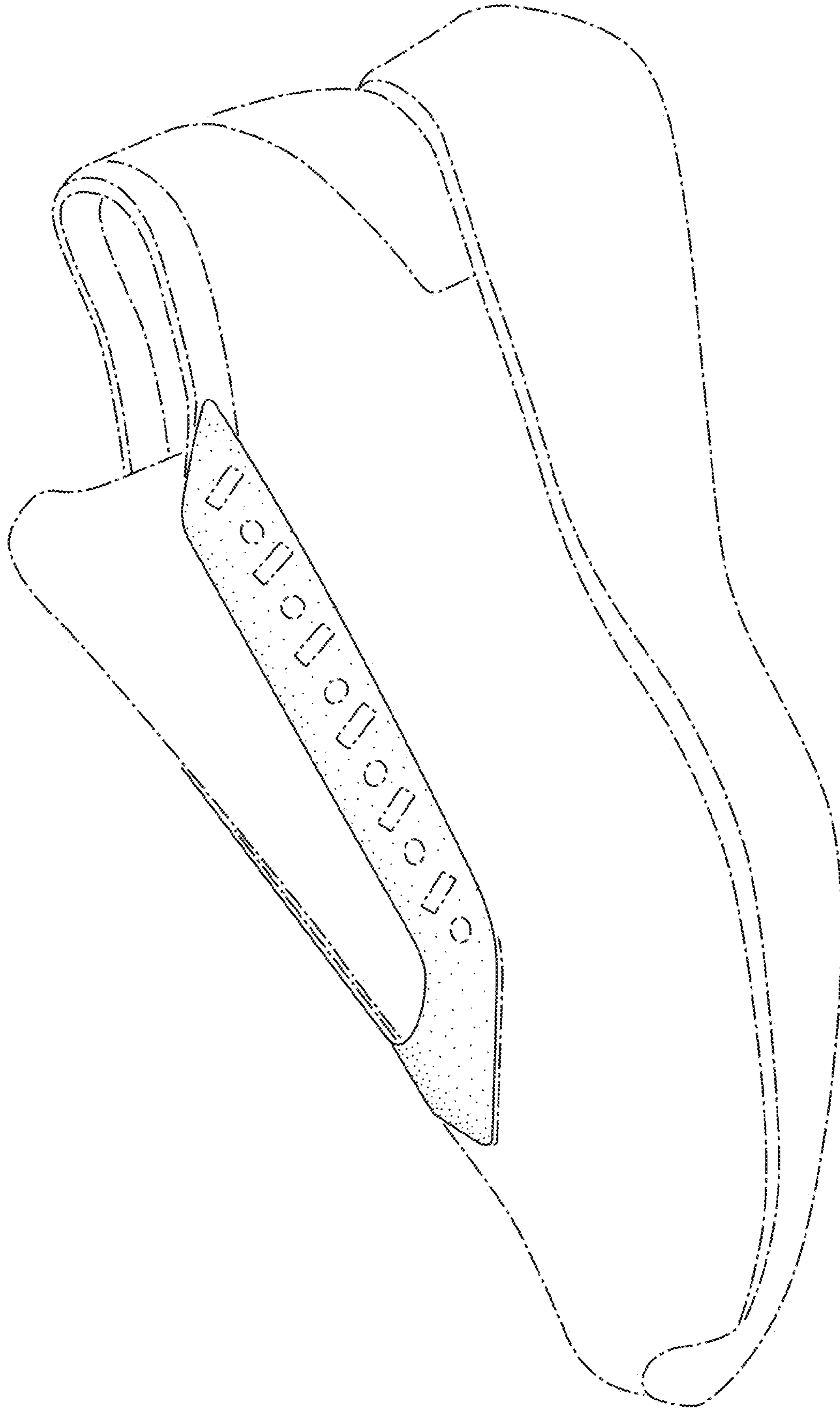
