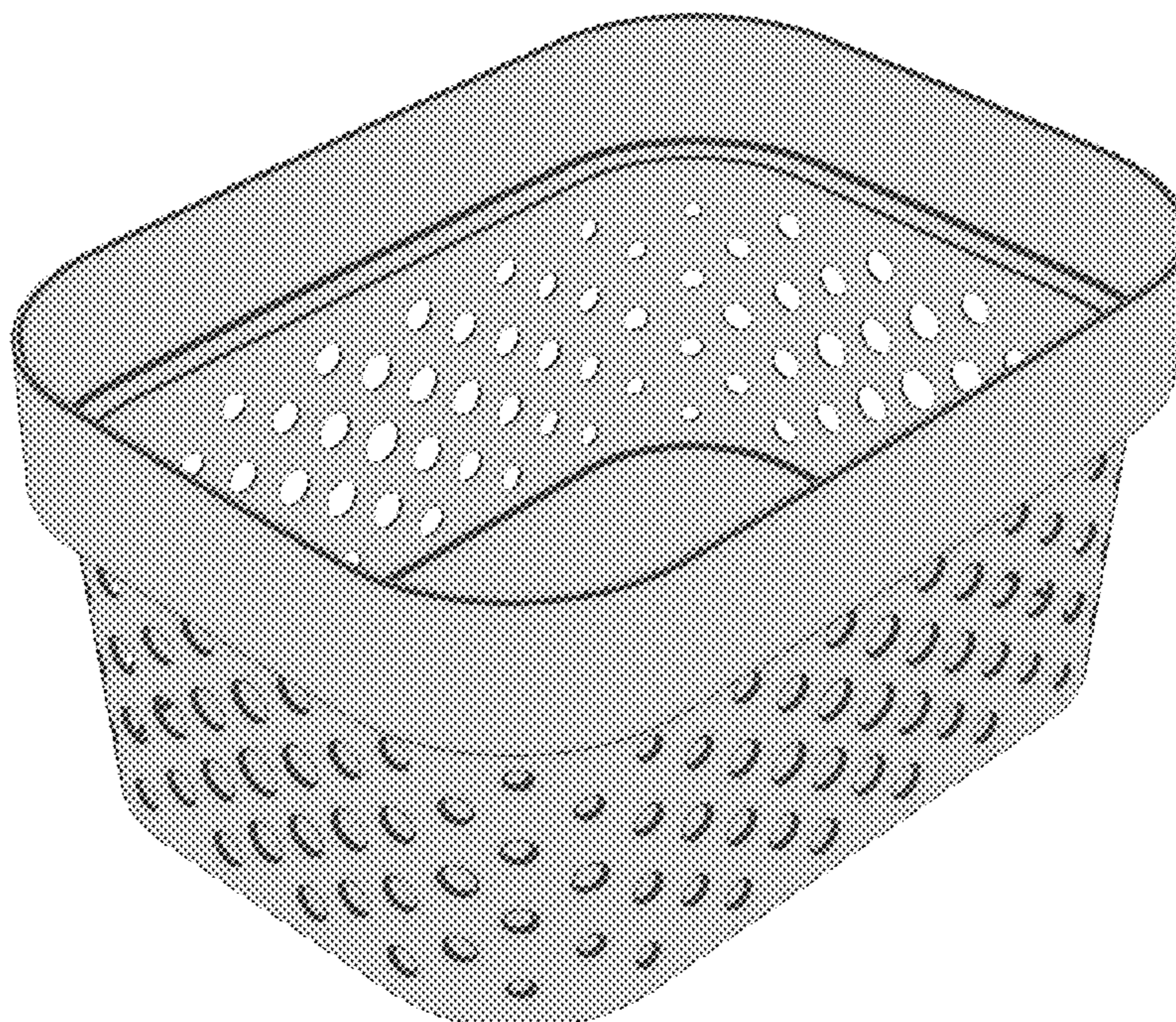
The ornamental design for basket, as shown and described.

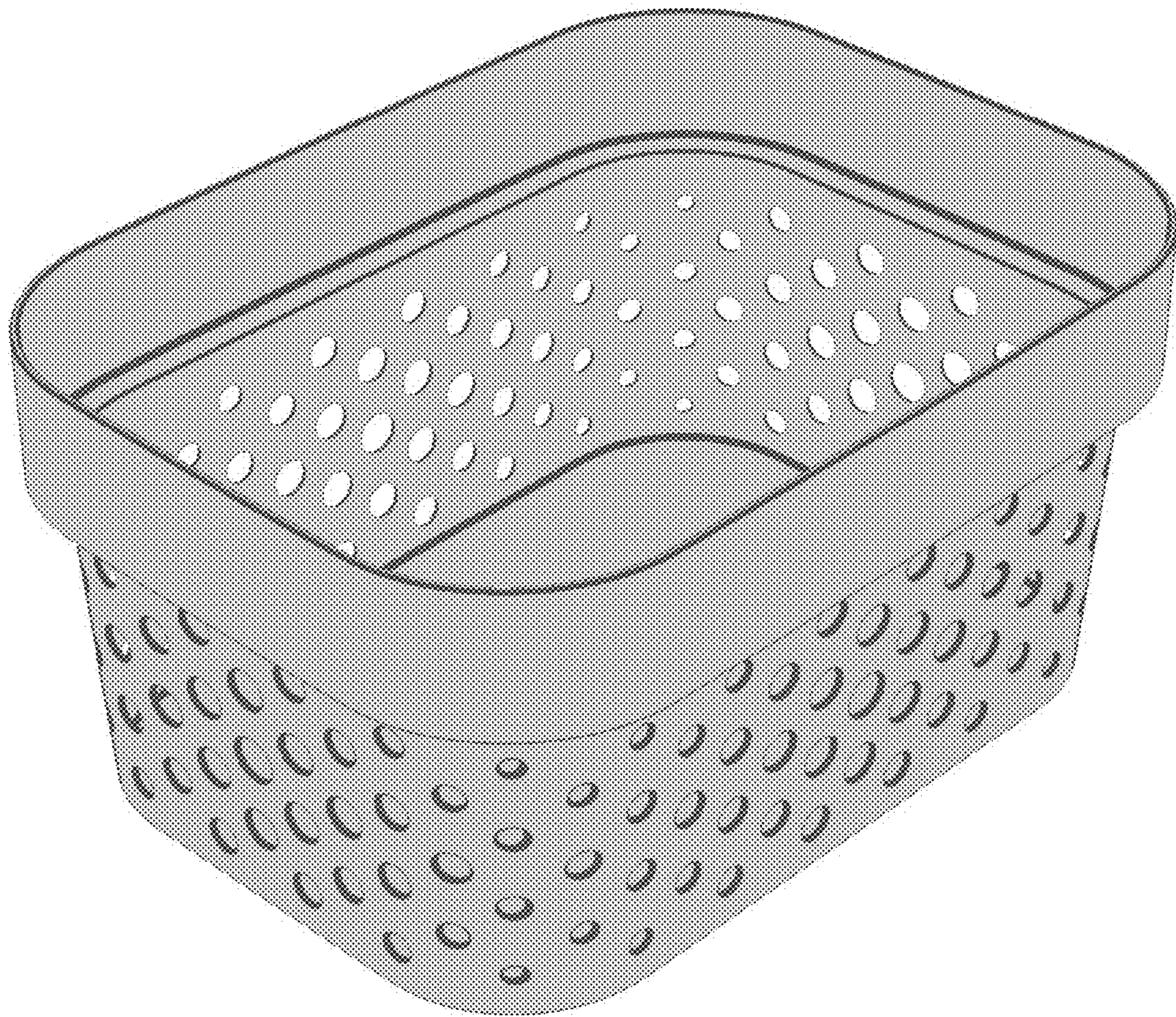

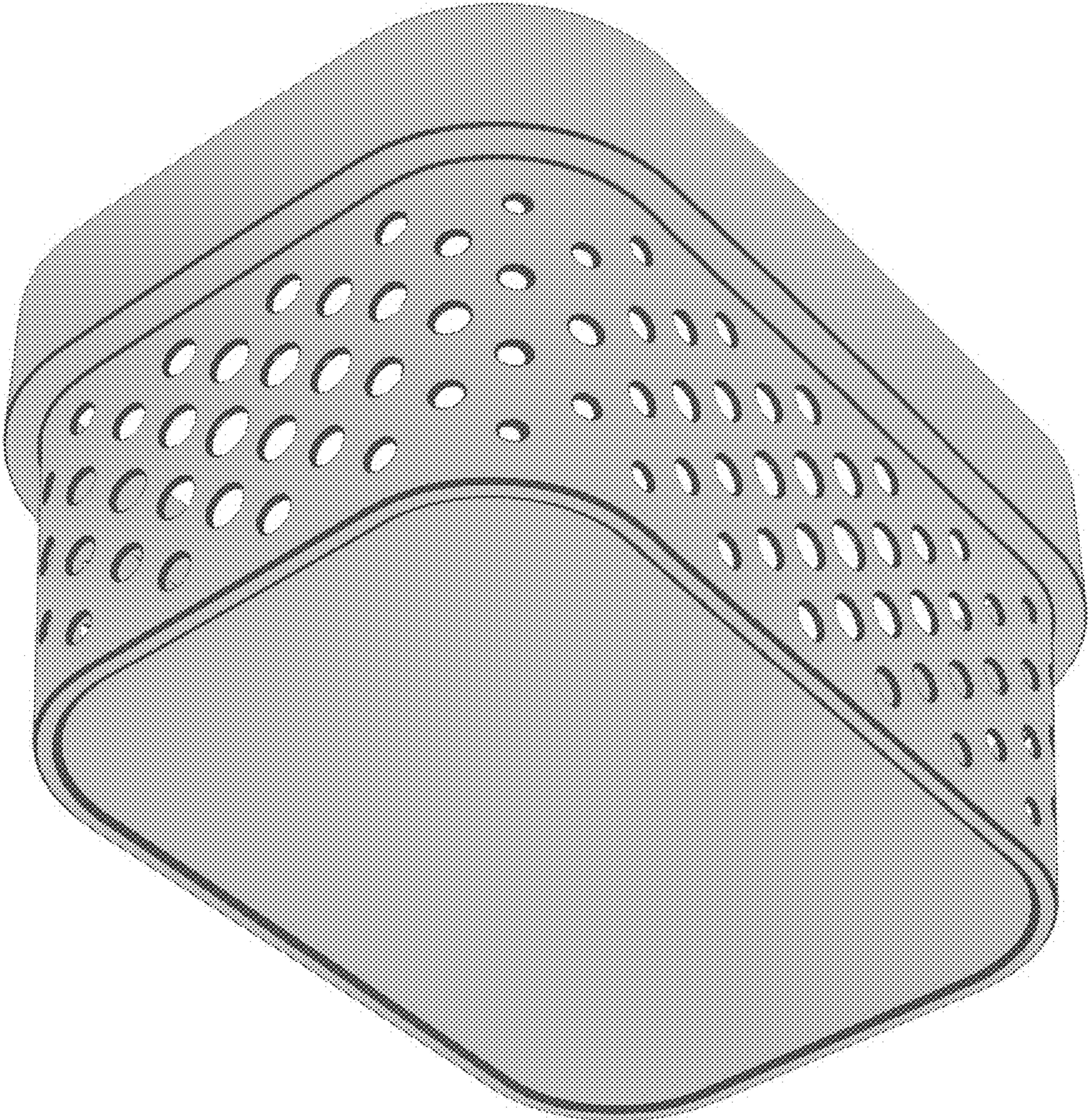

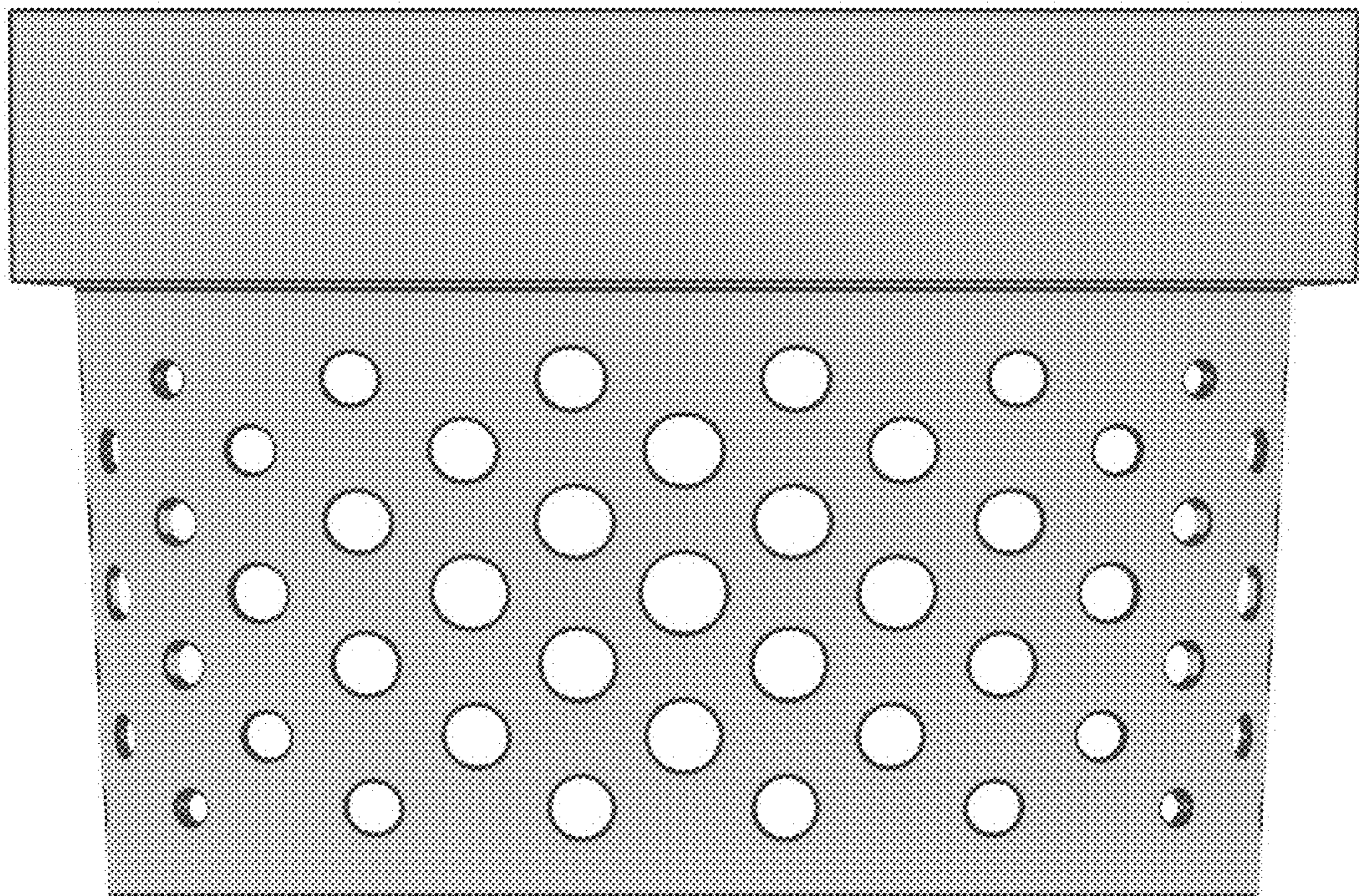

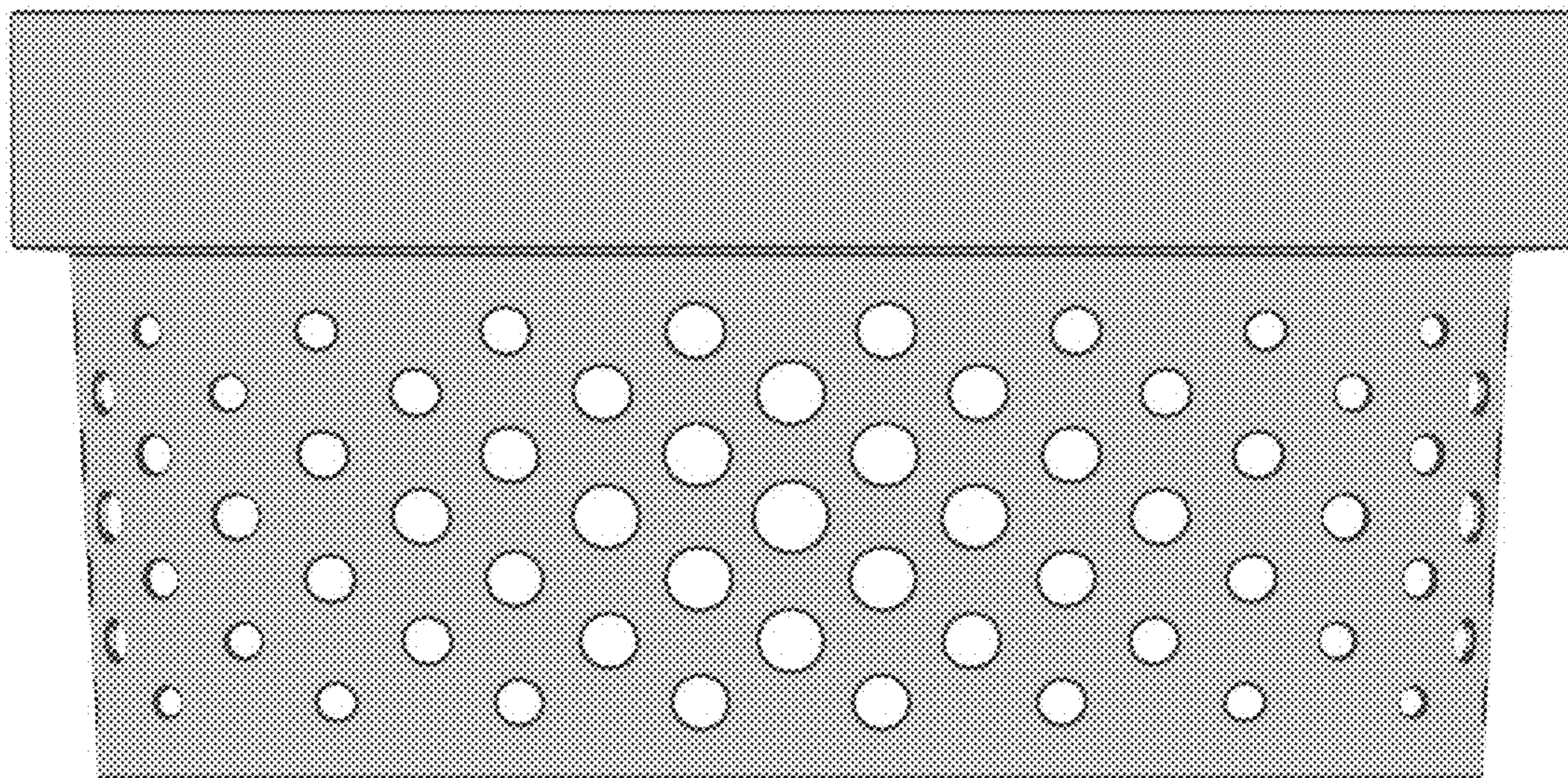

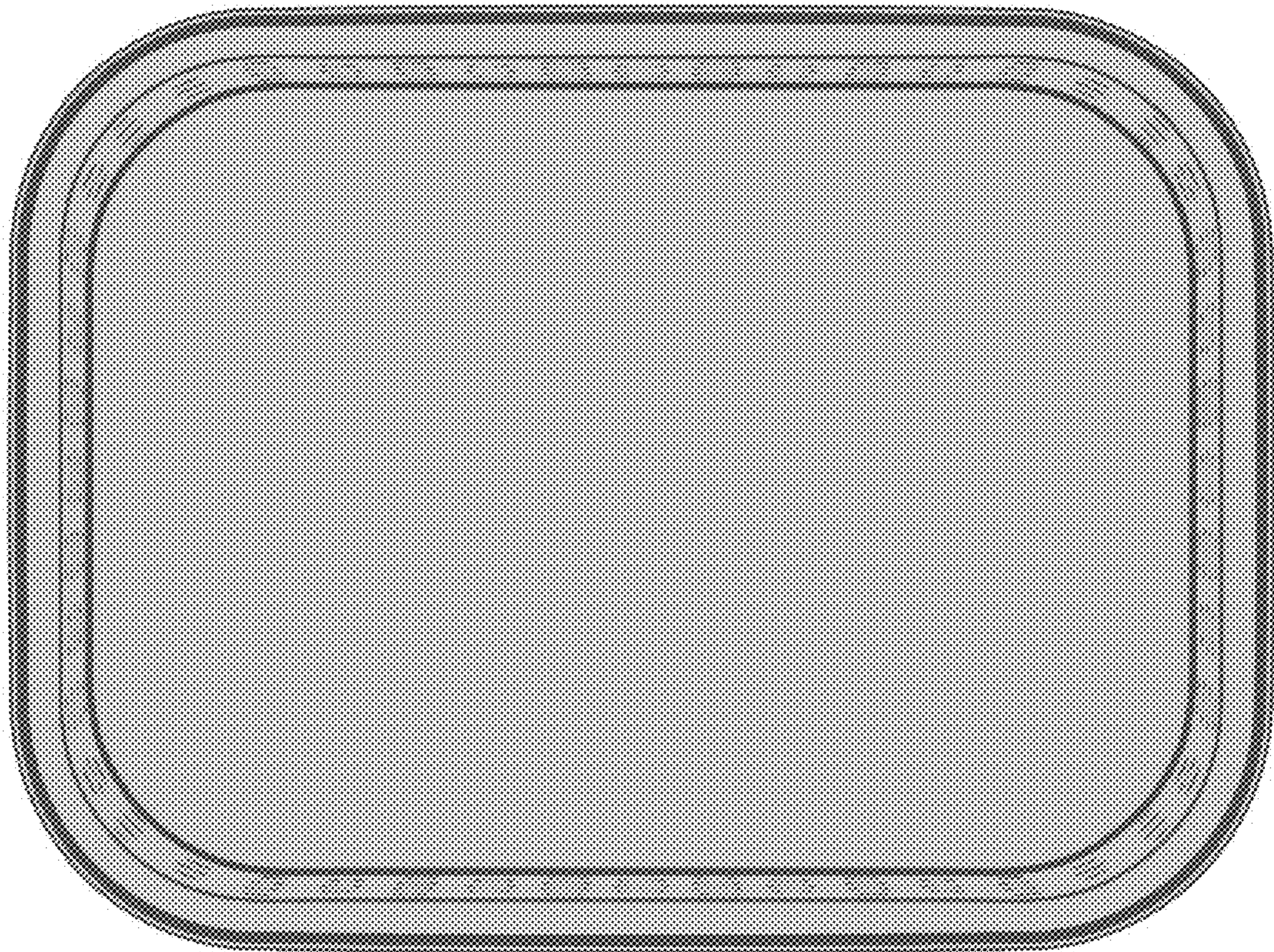
