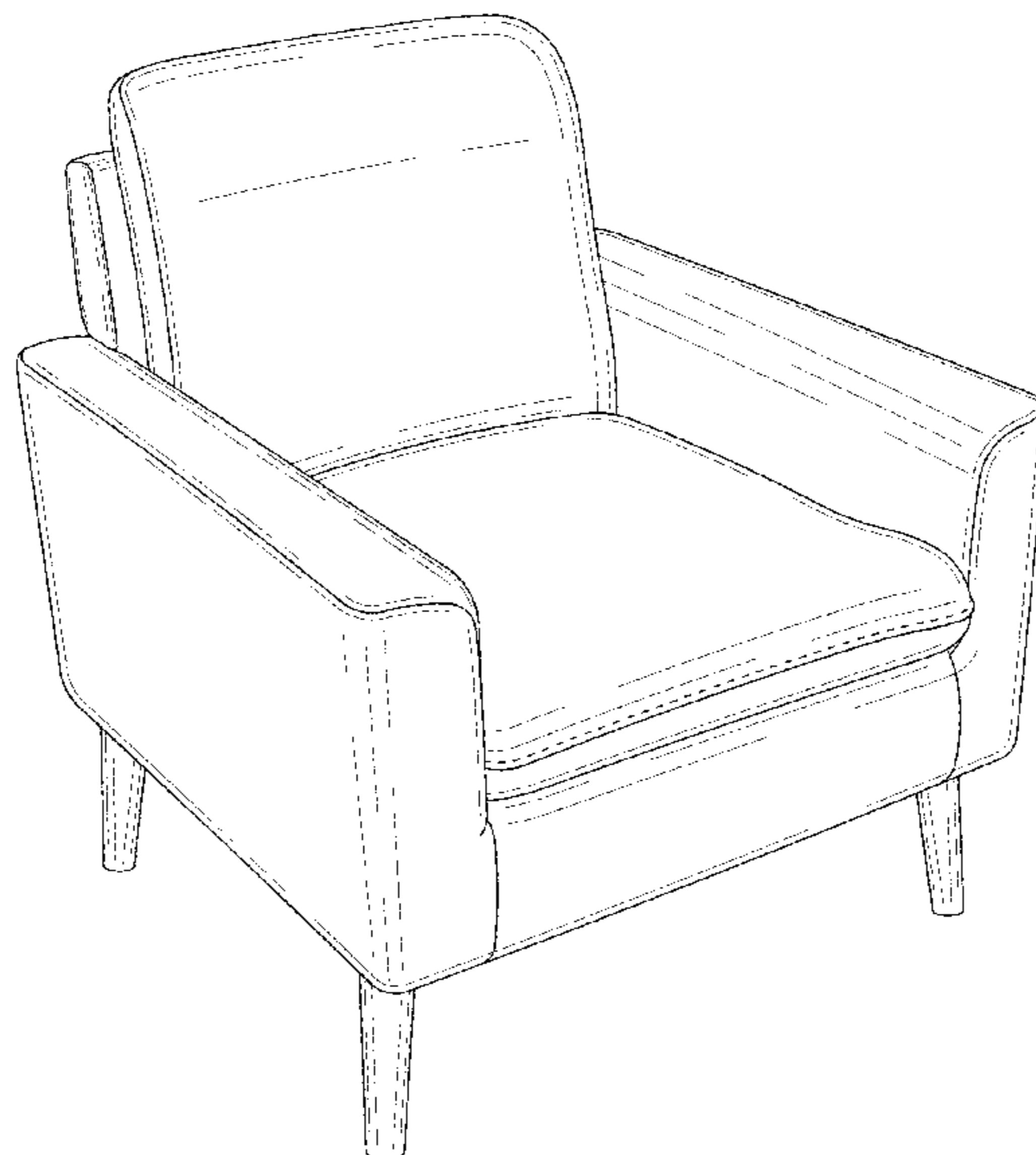
(57) **CLAIM**

The ornamental design for a sofa chair, as shown and described.

DESCRIPTION

FIG. 1 is a front facing perspective view of a sofa chair;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;

image thereof; and,

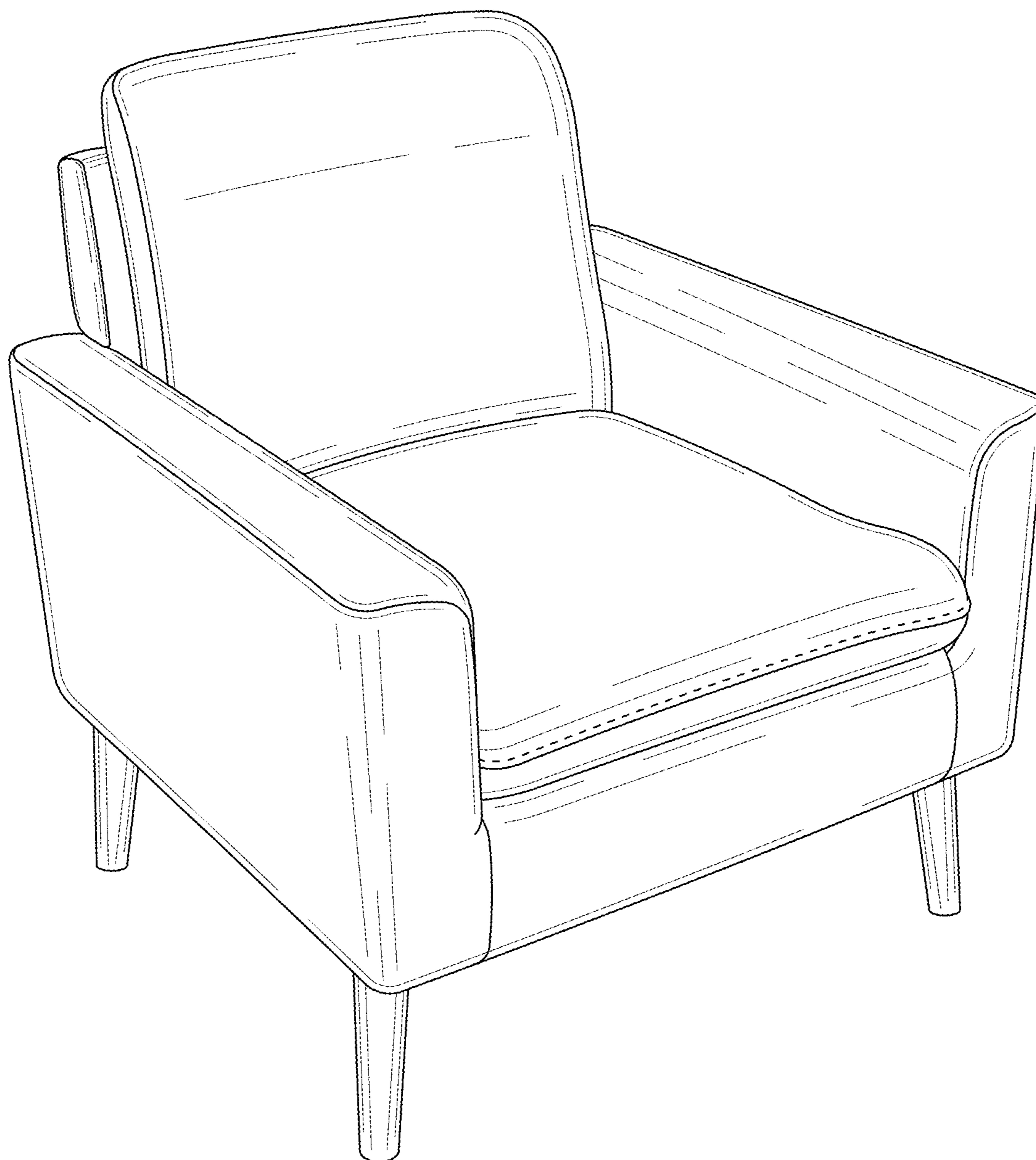

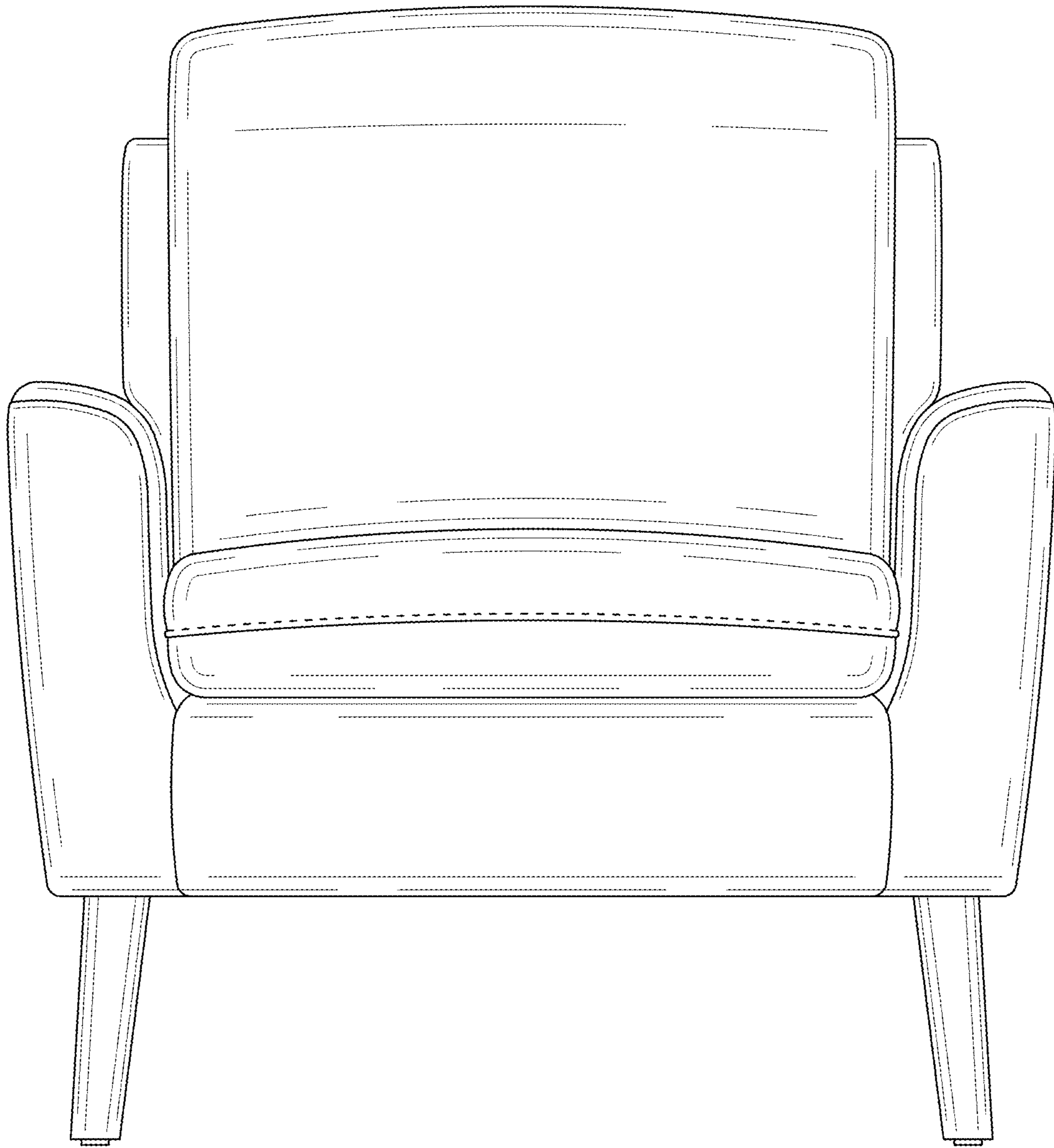

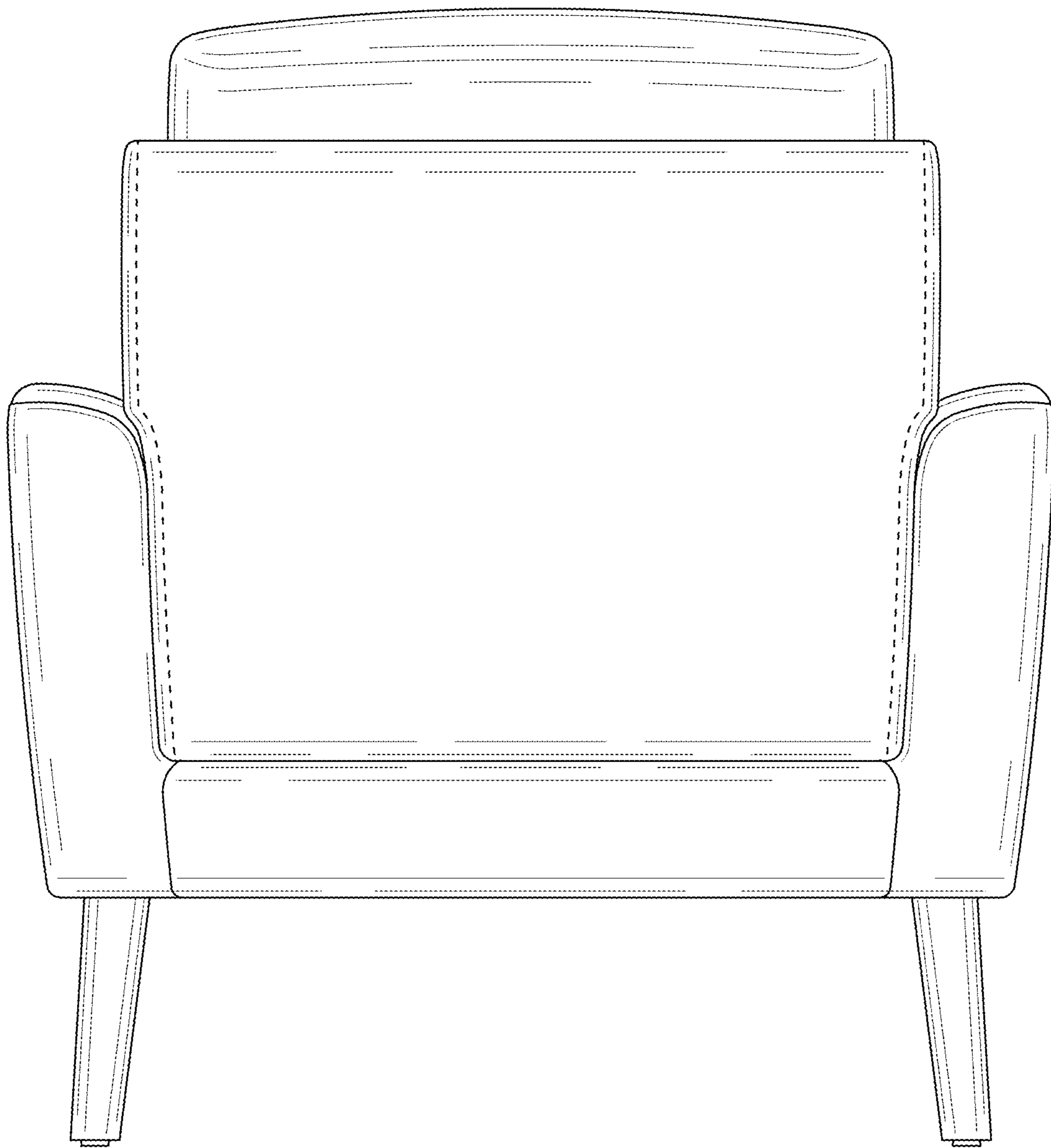

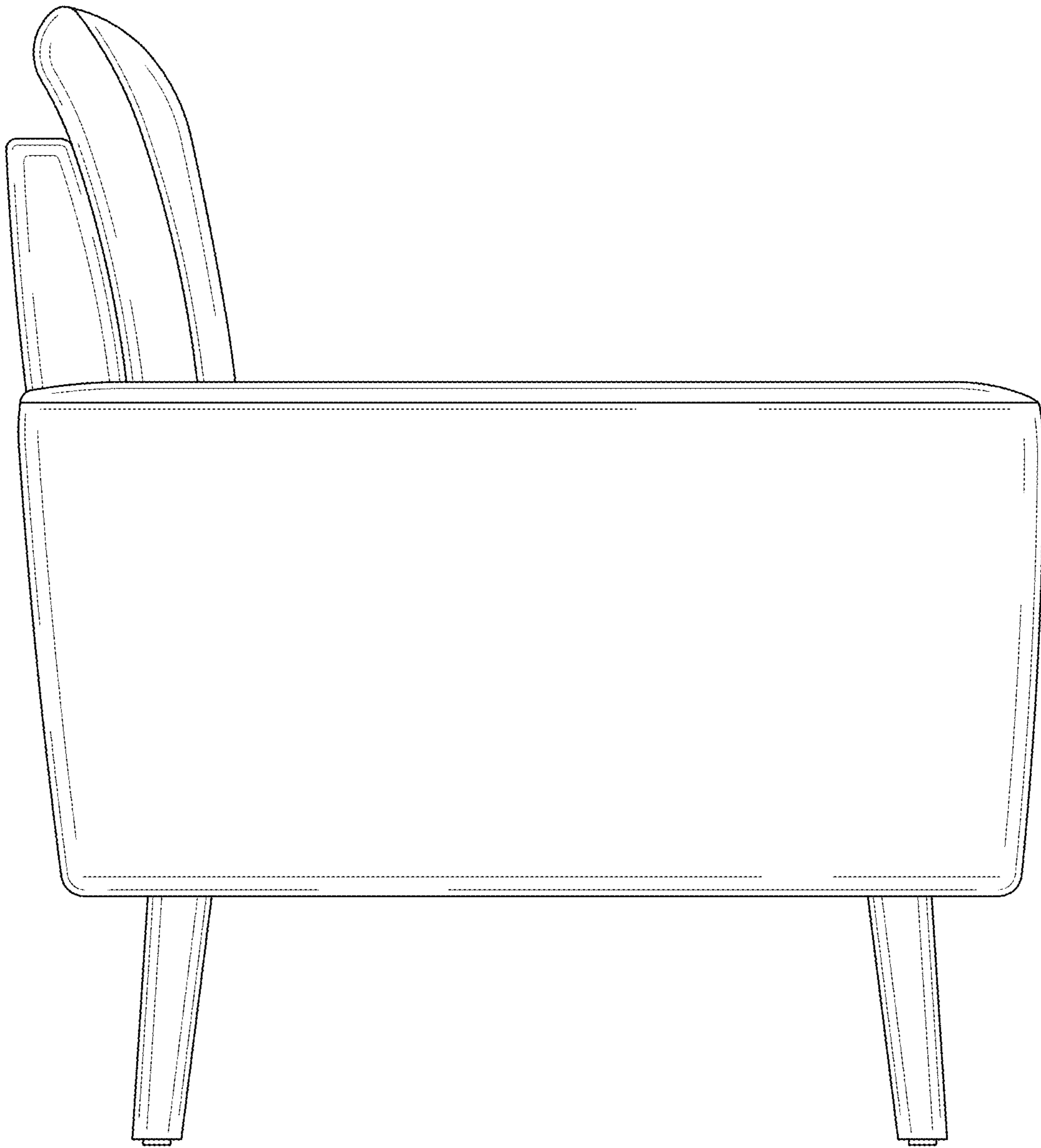

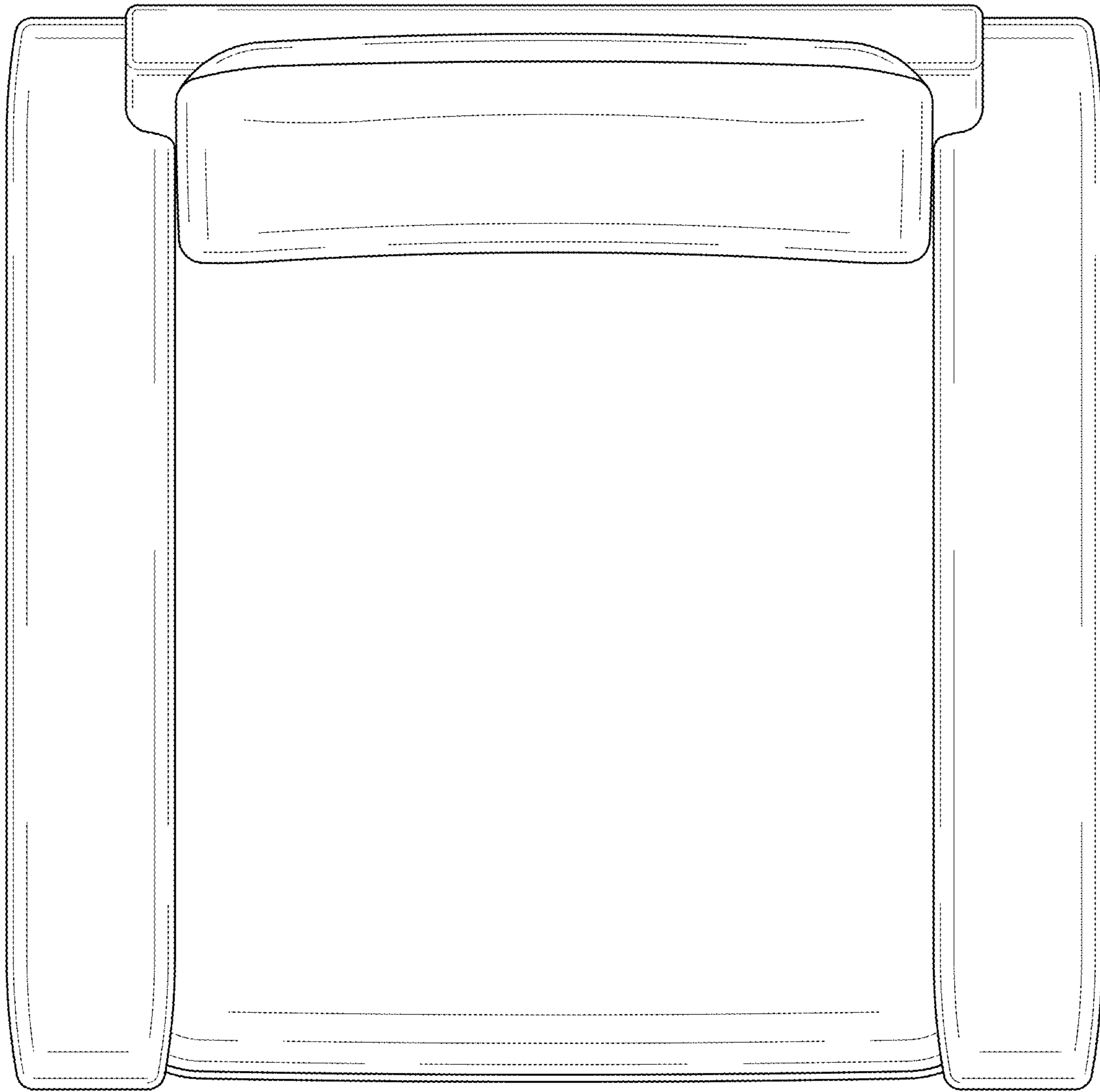
