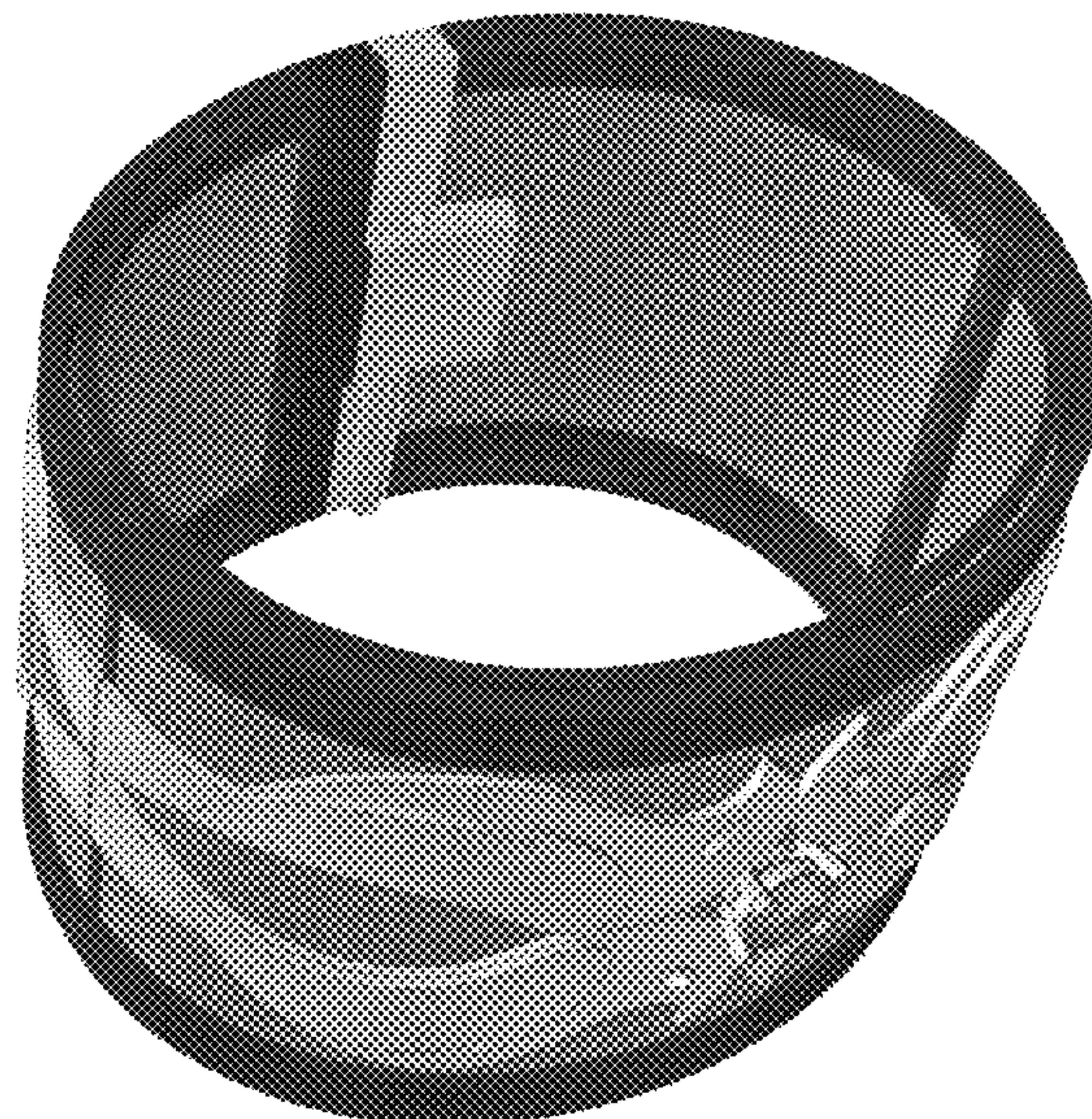
The ornamental design for a bracelet, as shown and described.

The bracelet consists of an oval ring displaying eight birds in relief, in the form of a frieze, four of which hold a precious stone together between their beaks.

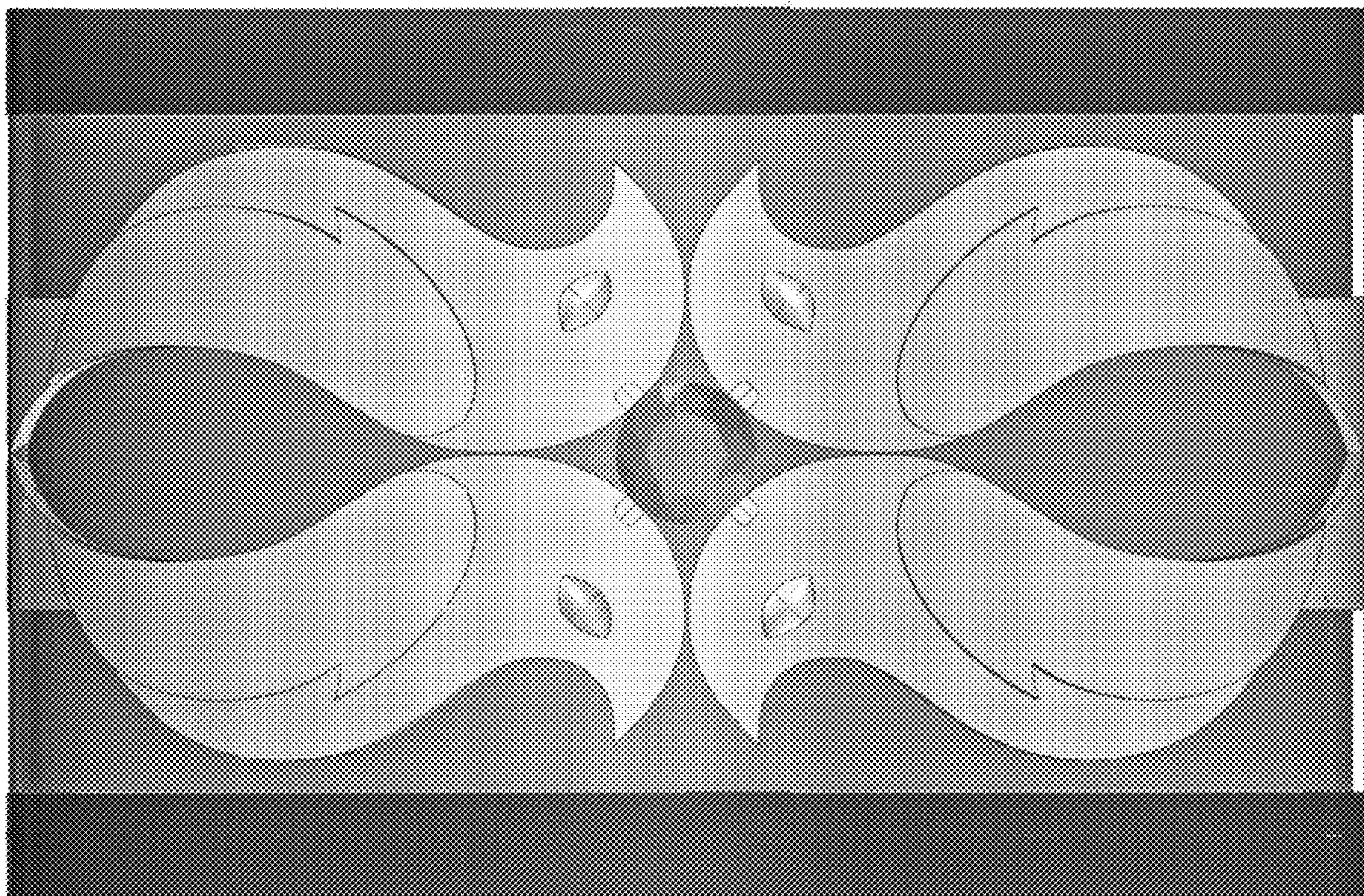

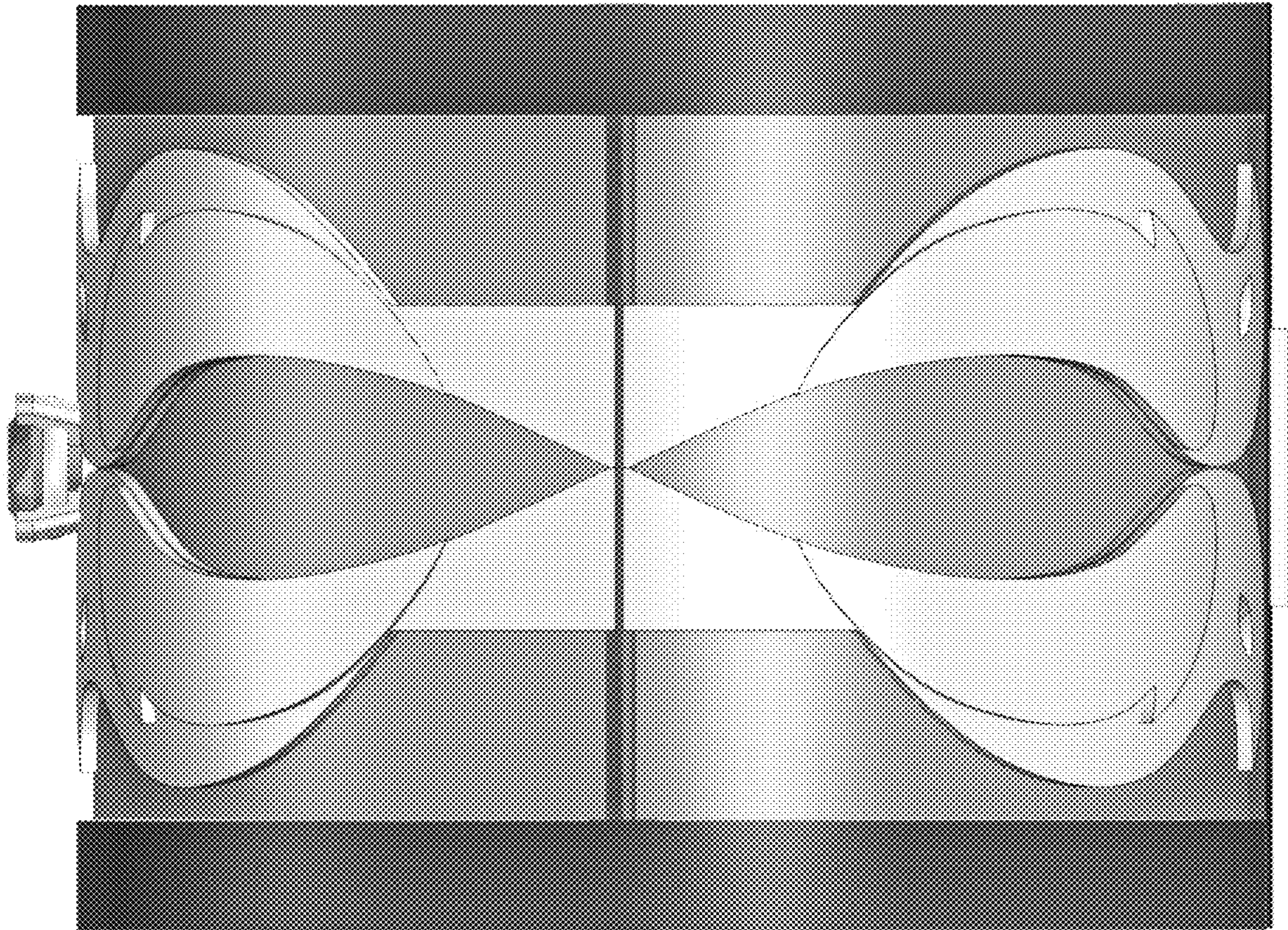
