FIG. 2.4 is a rear view thereof;

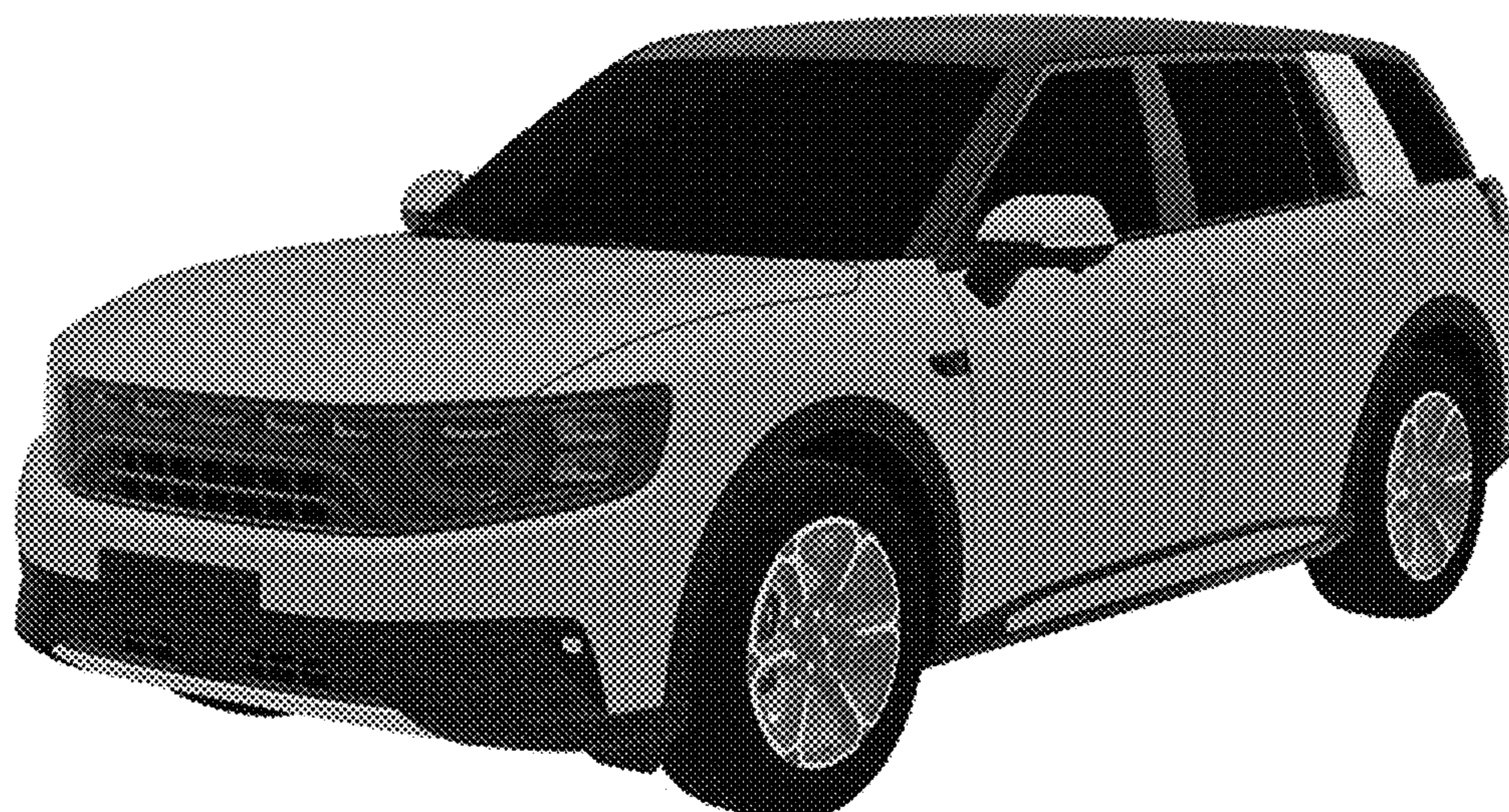
FIG. 2.5 is a left side view thereof;

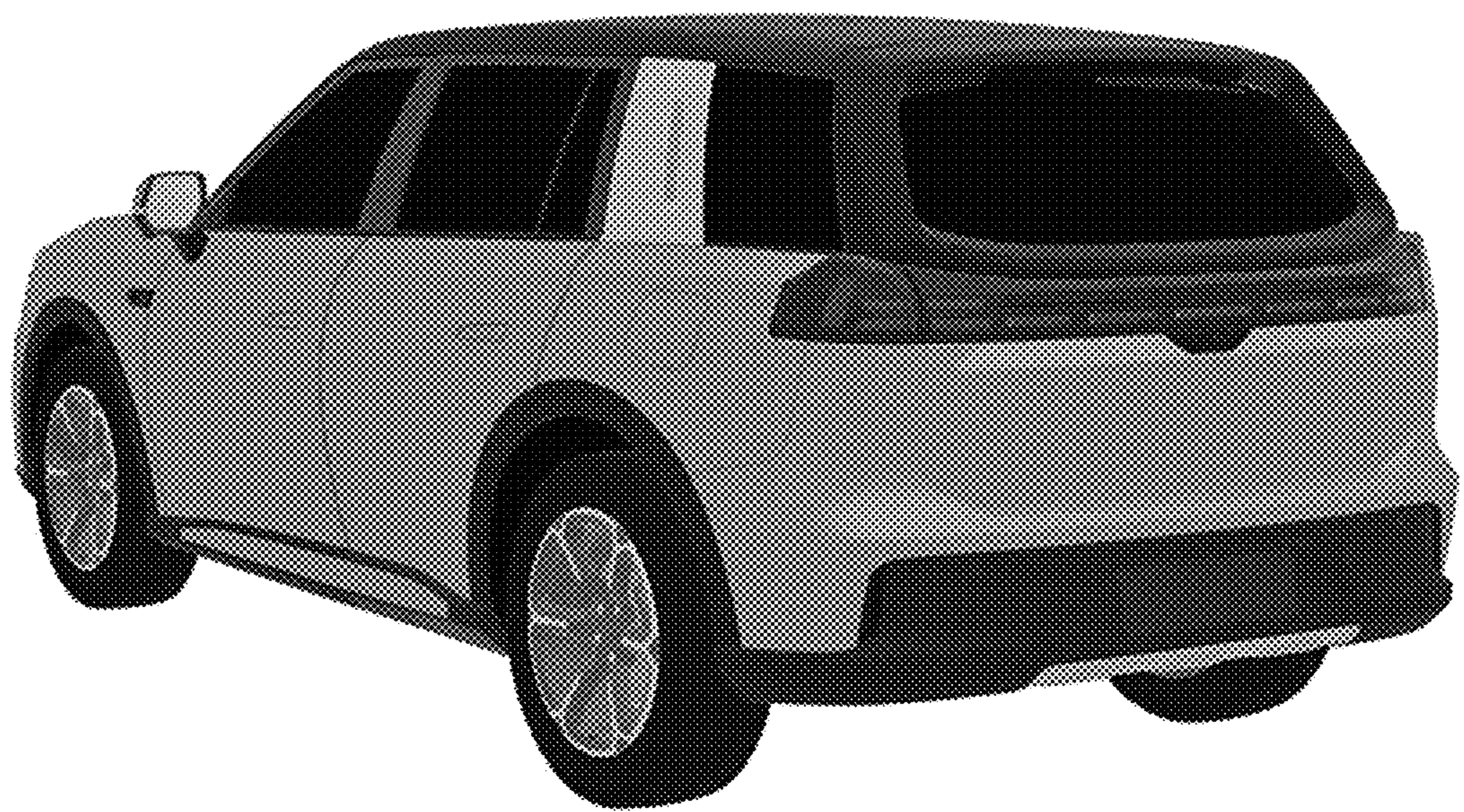




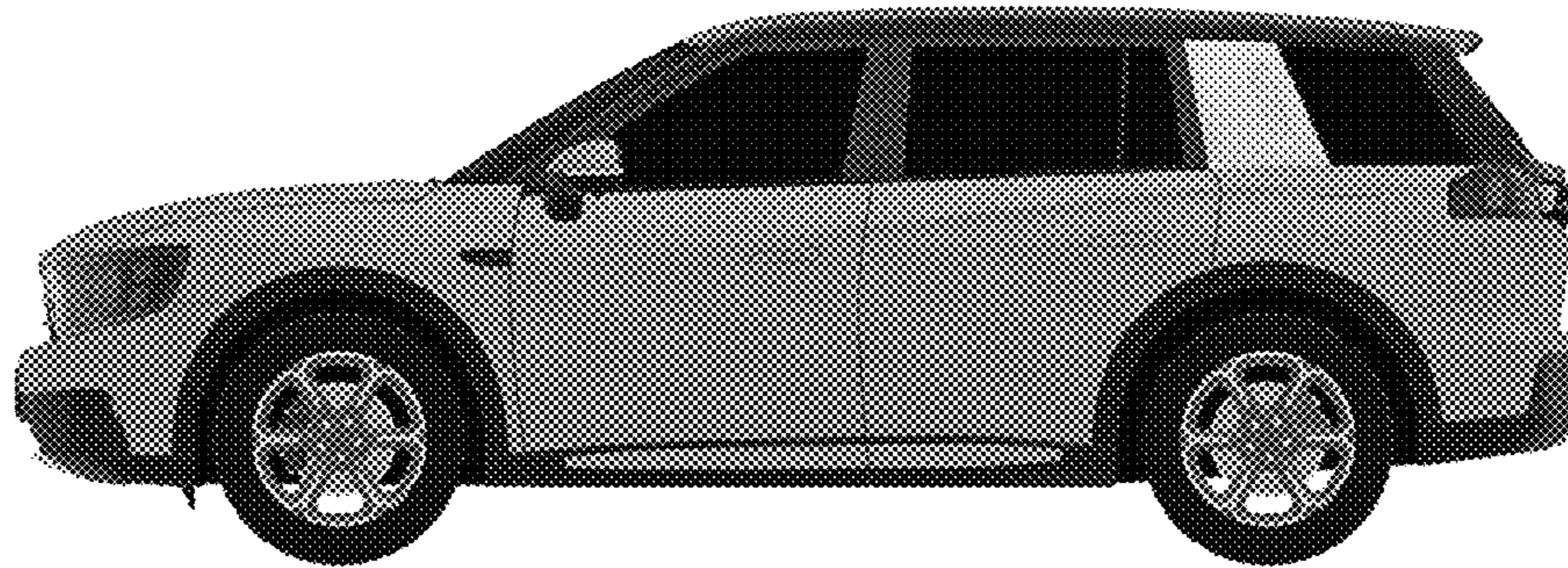

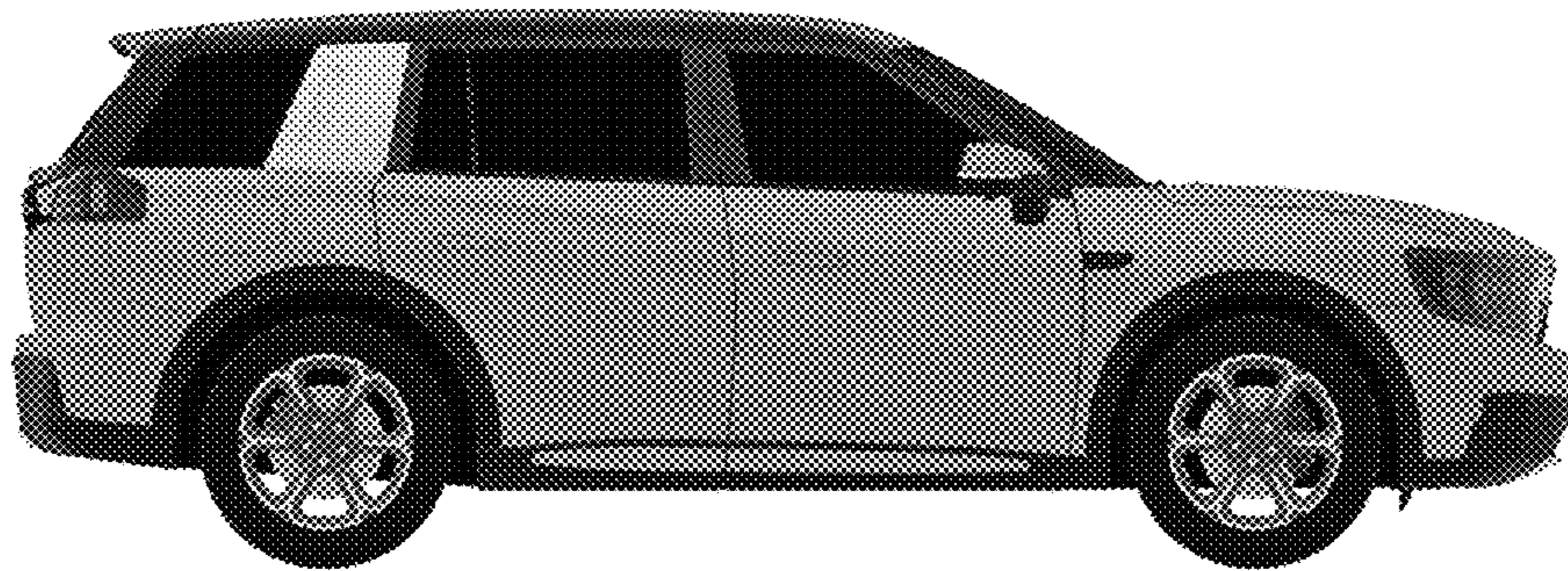

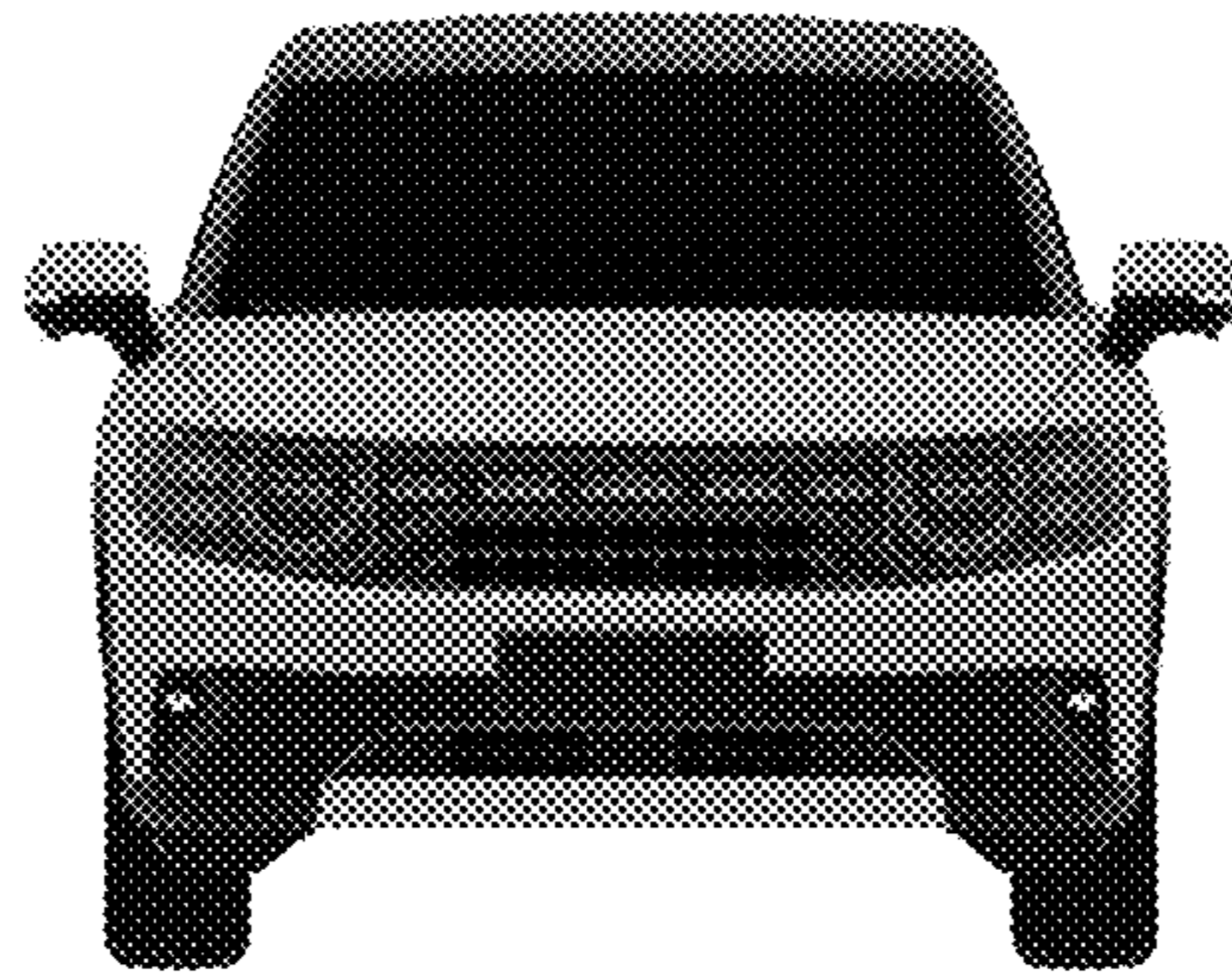




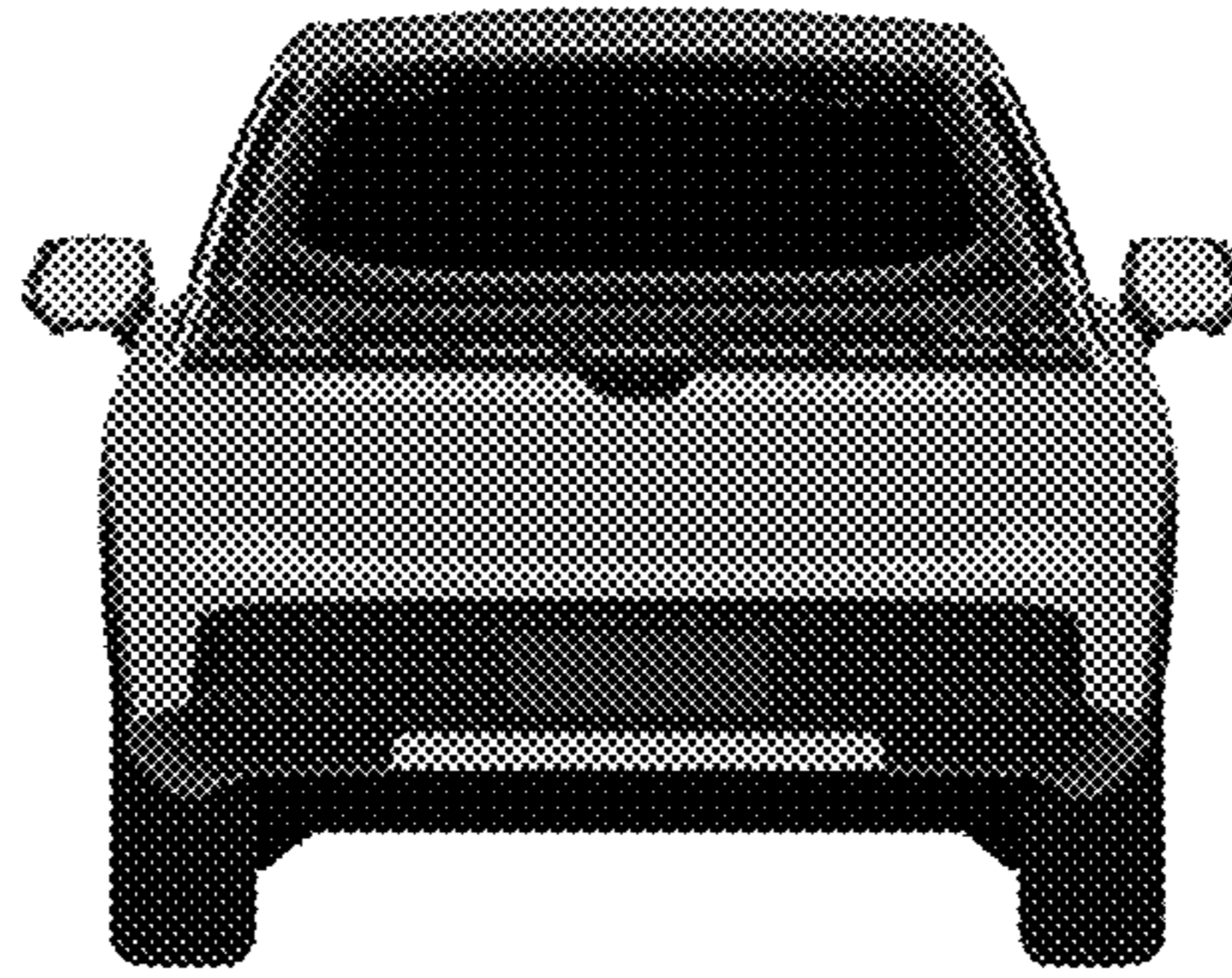

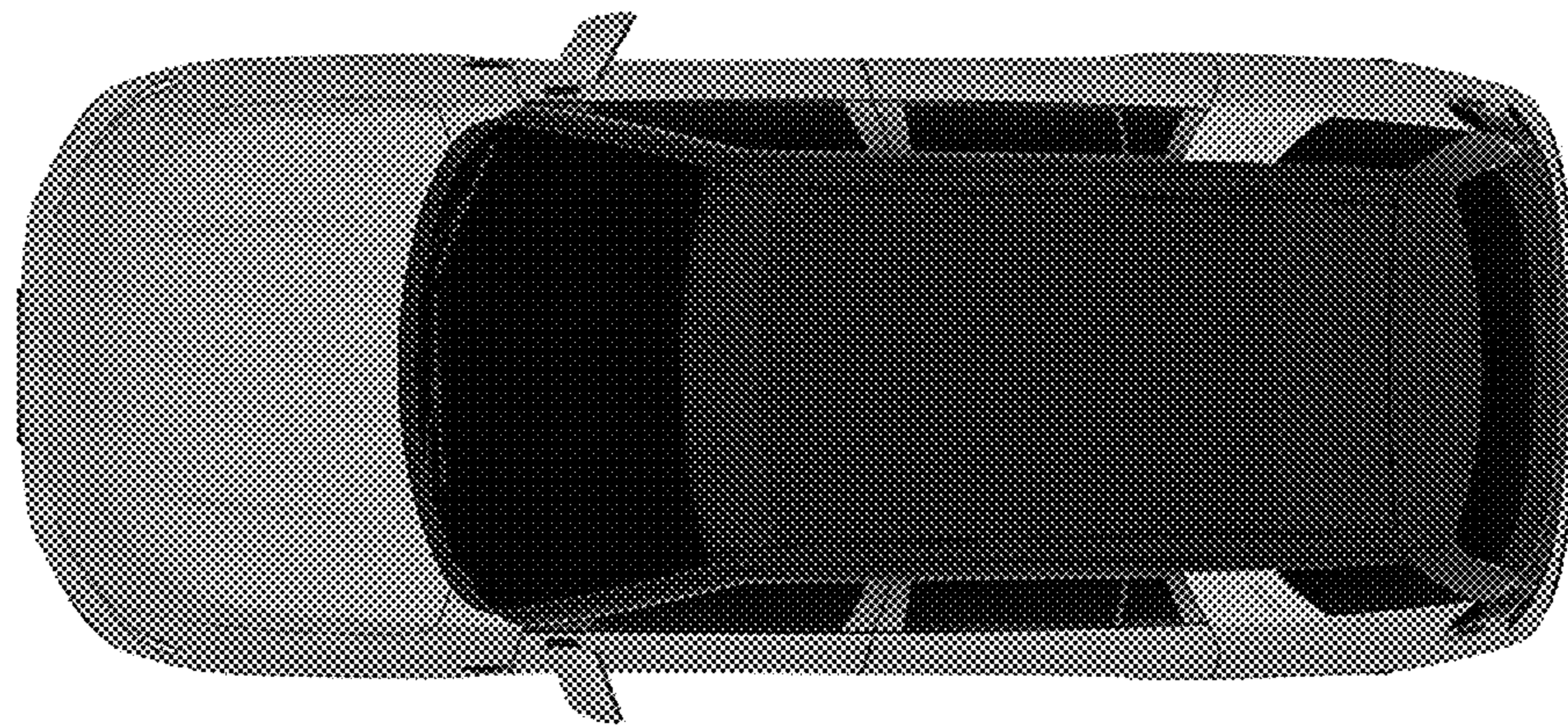

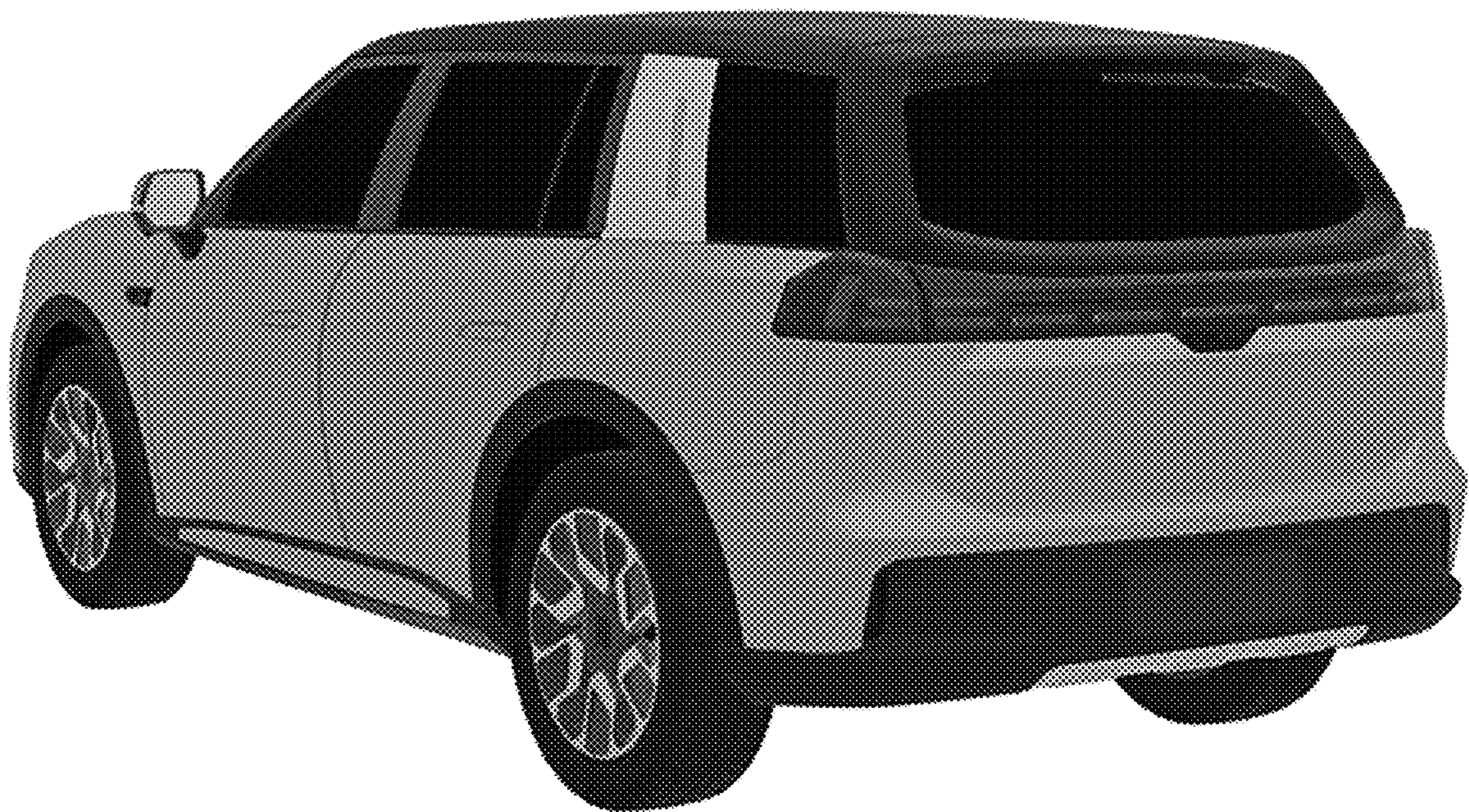

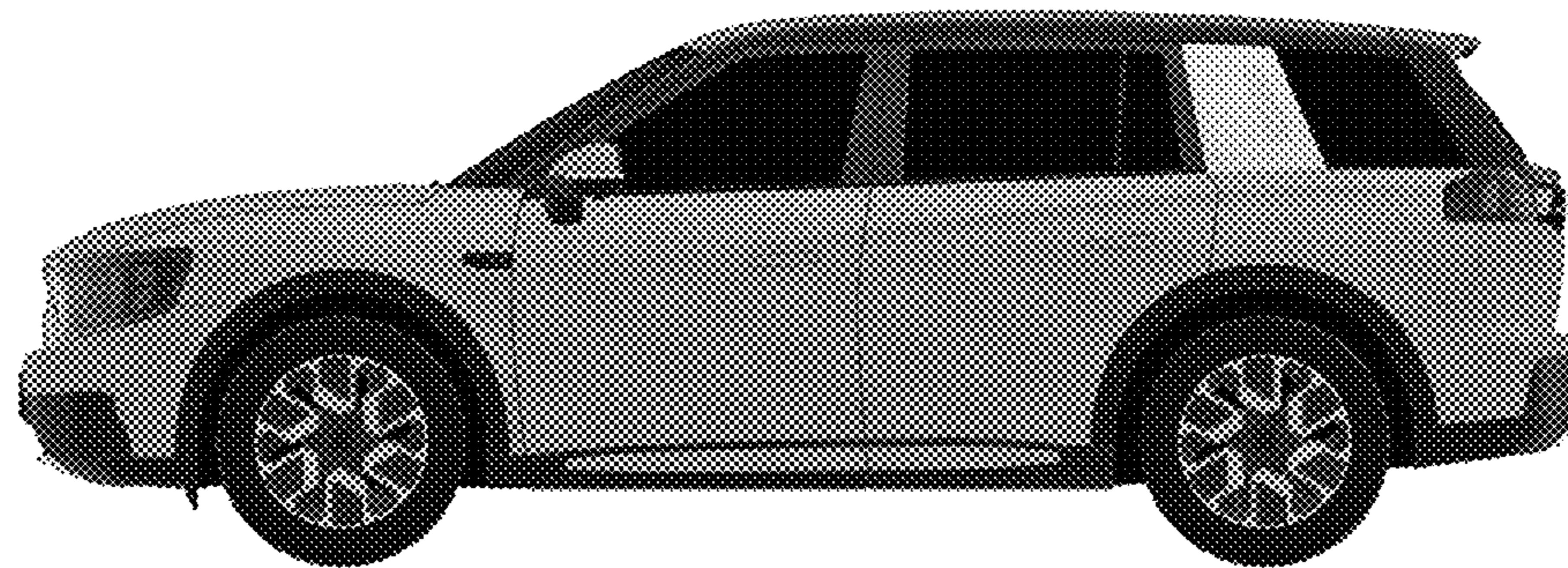

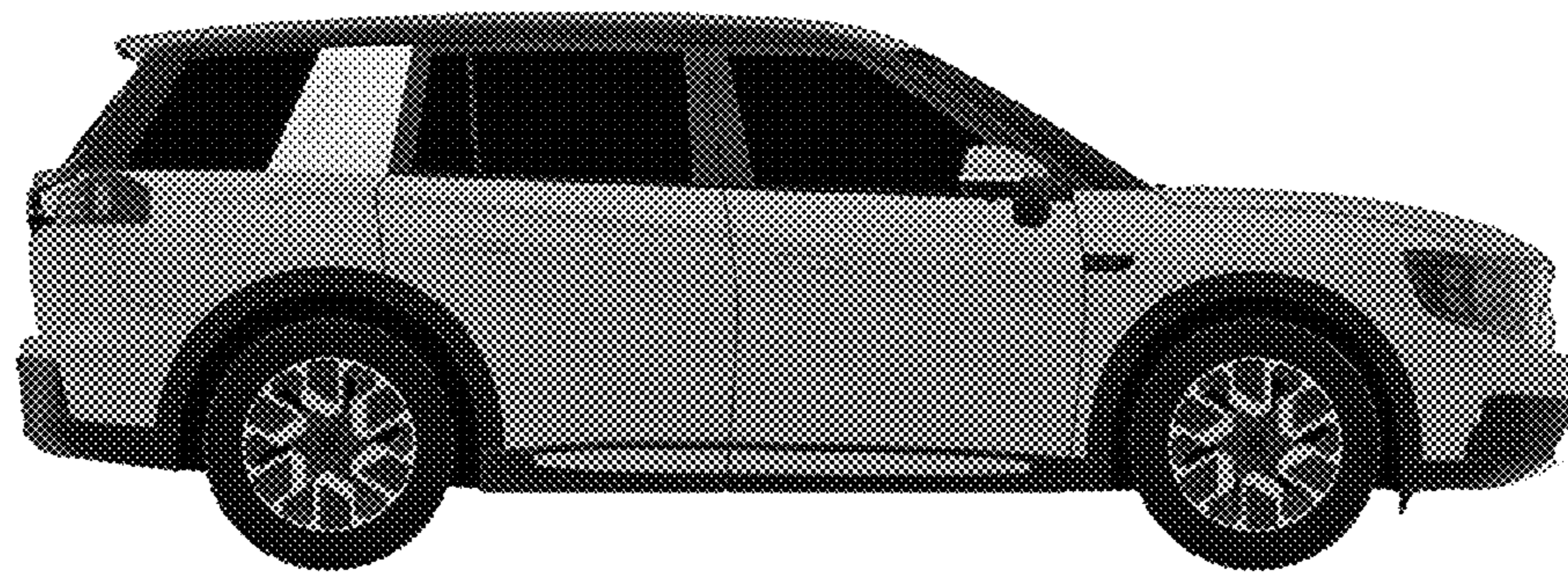

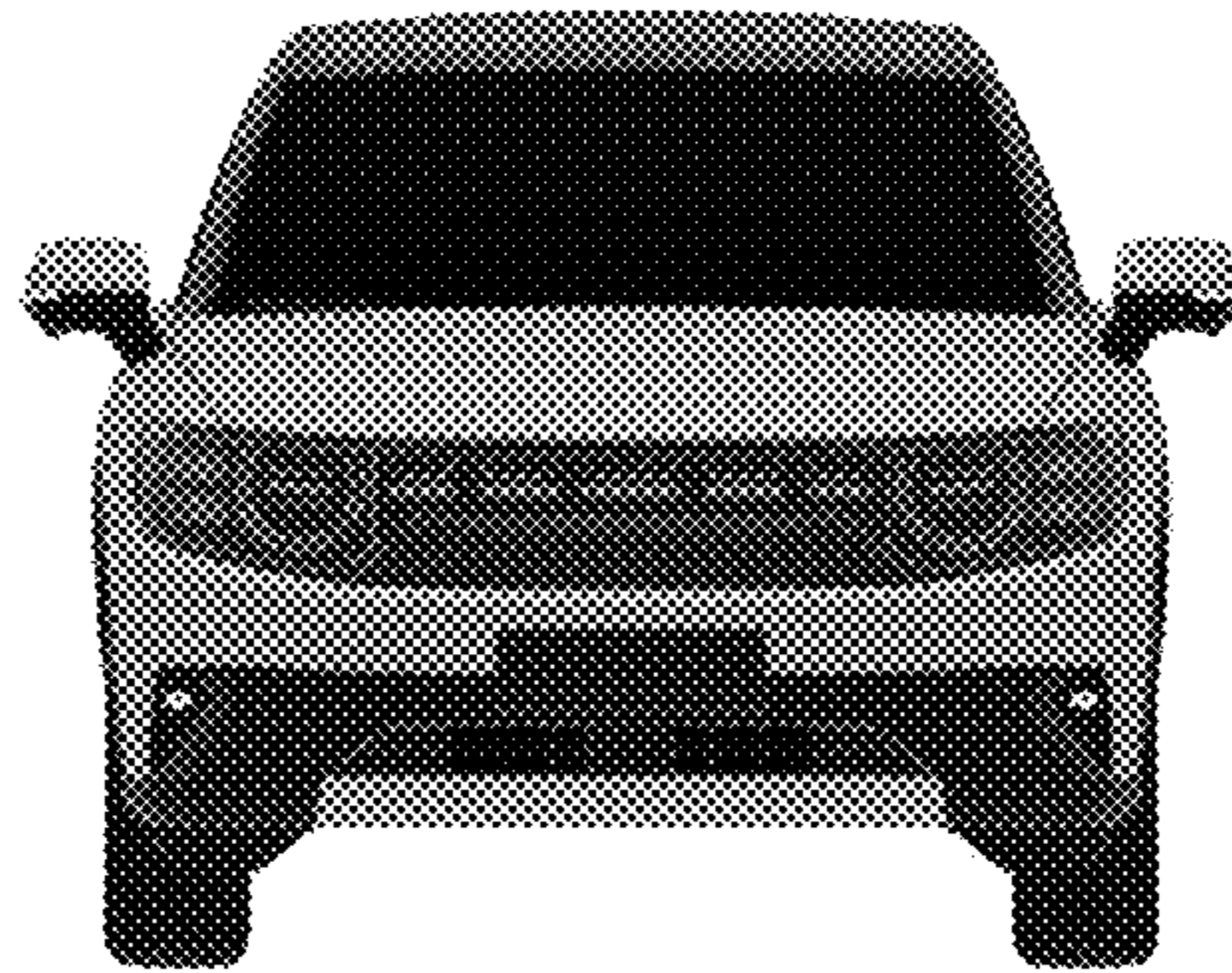




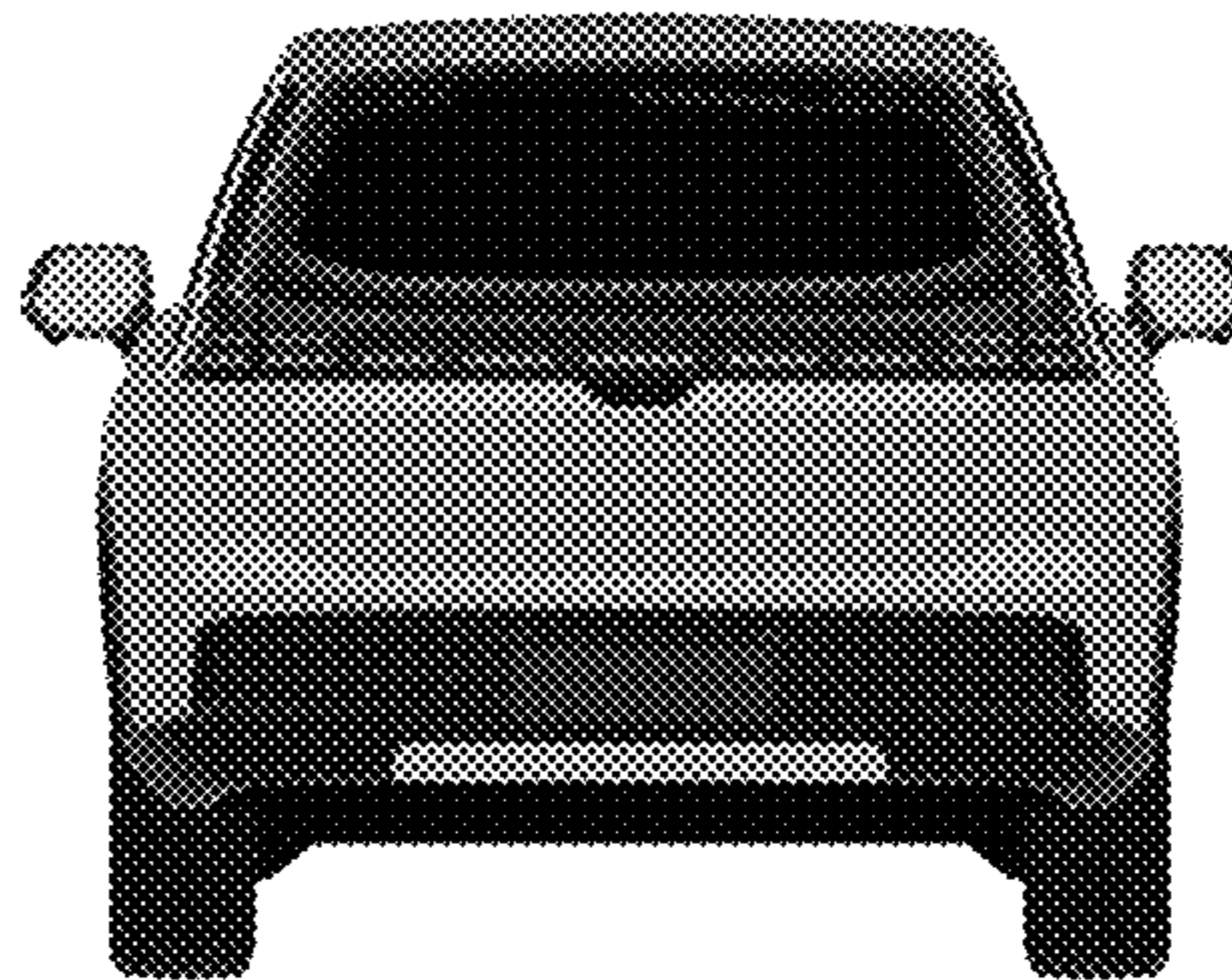
