(57) **CLAIM**

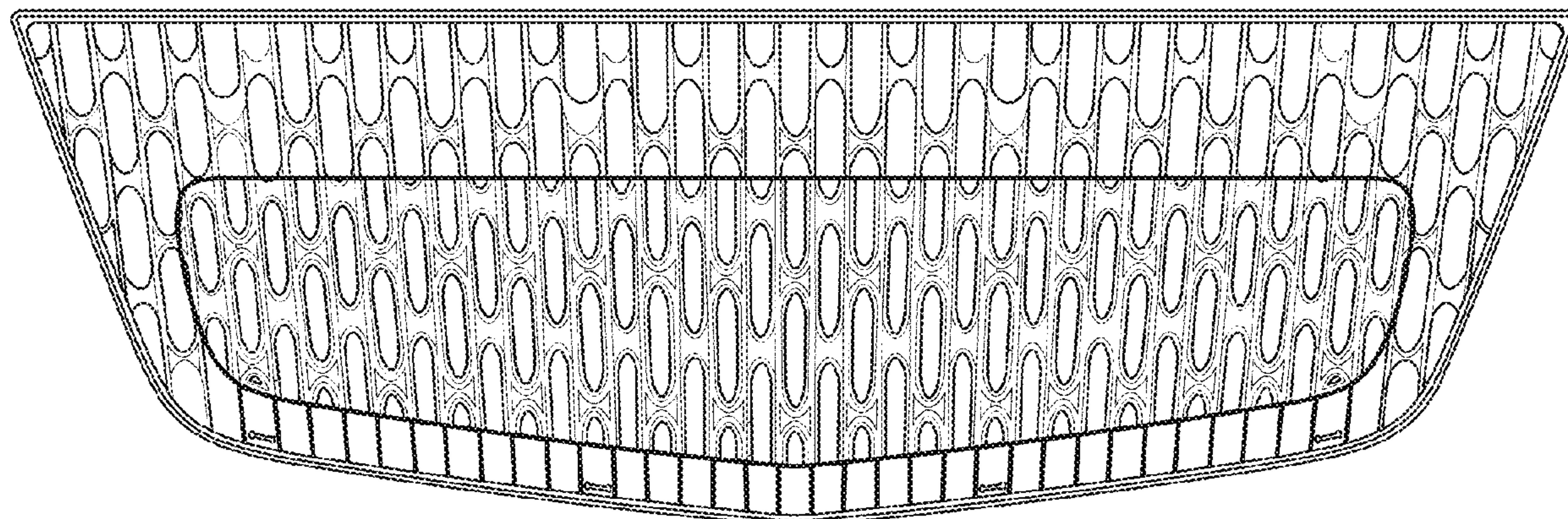
The ornamental design for a grille for a truck, as shown and described.

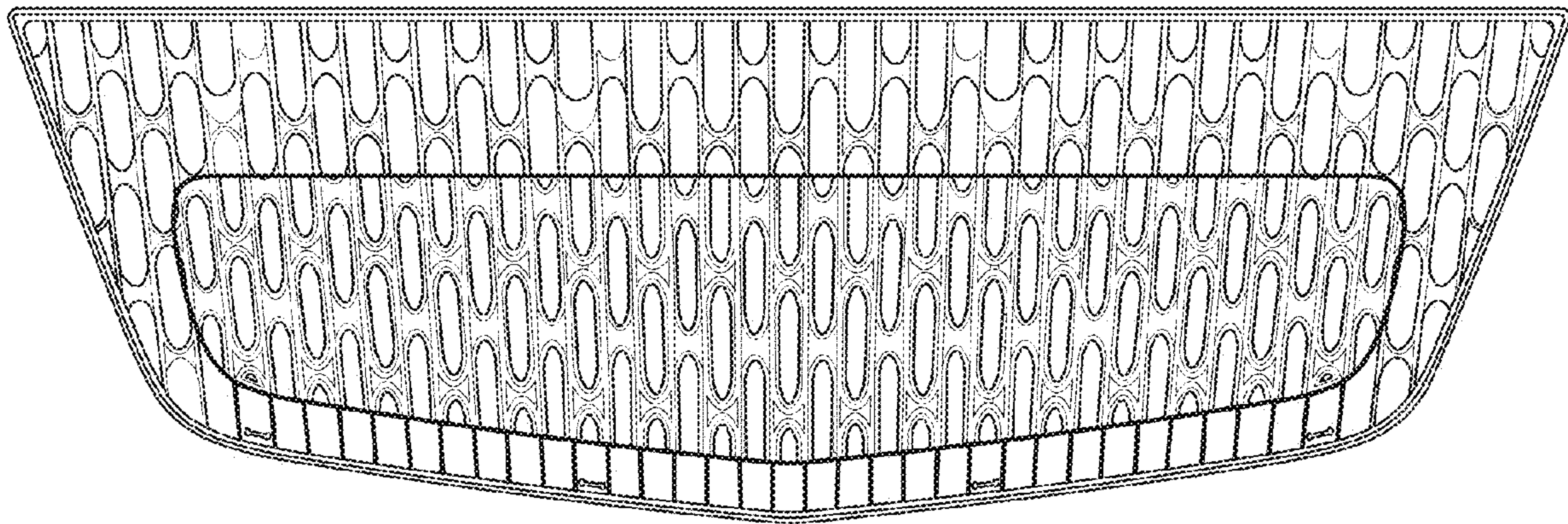

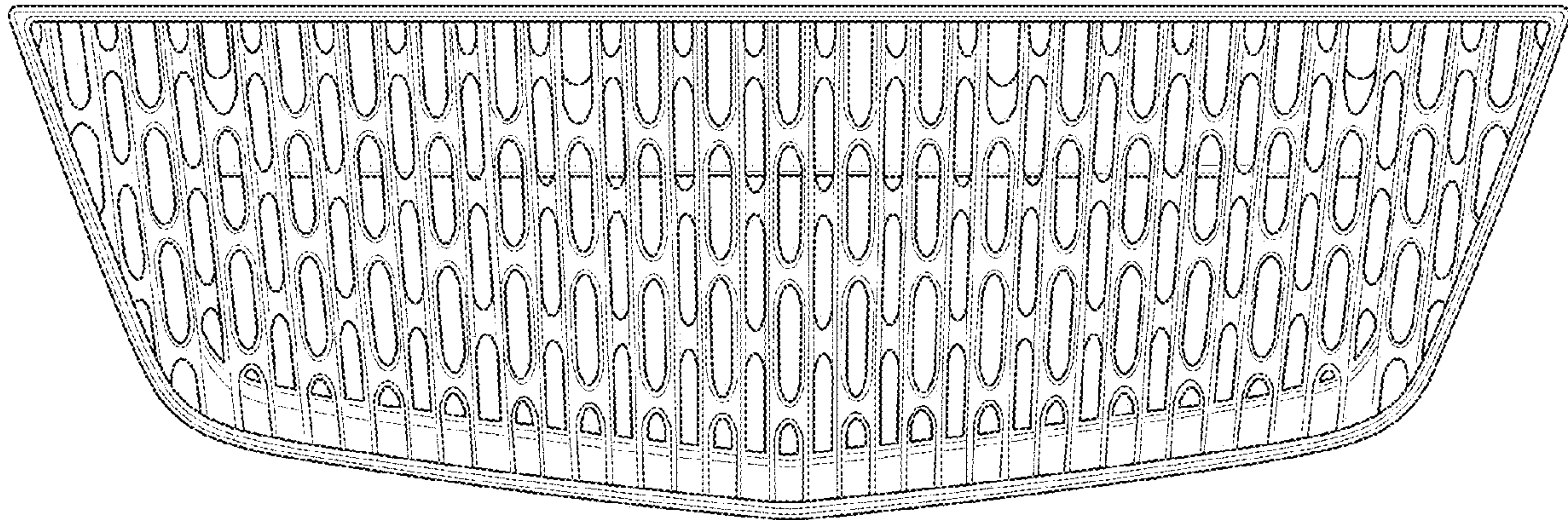

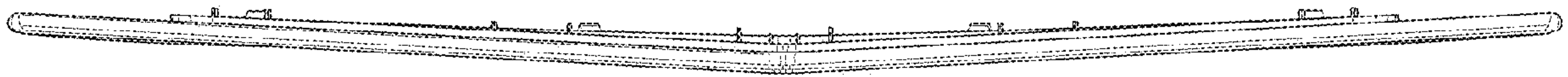

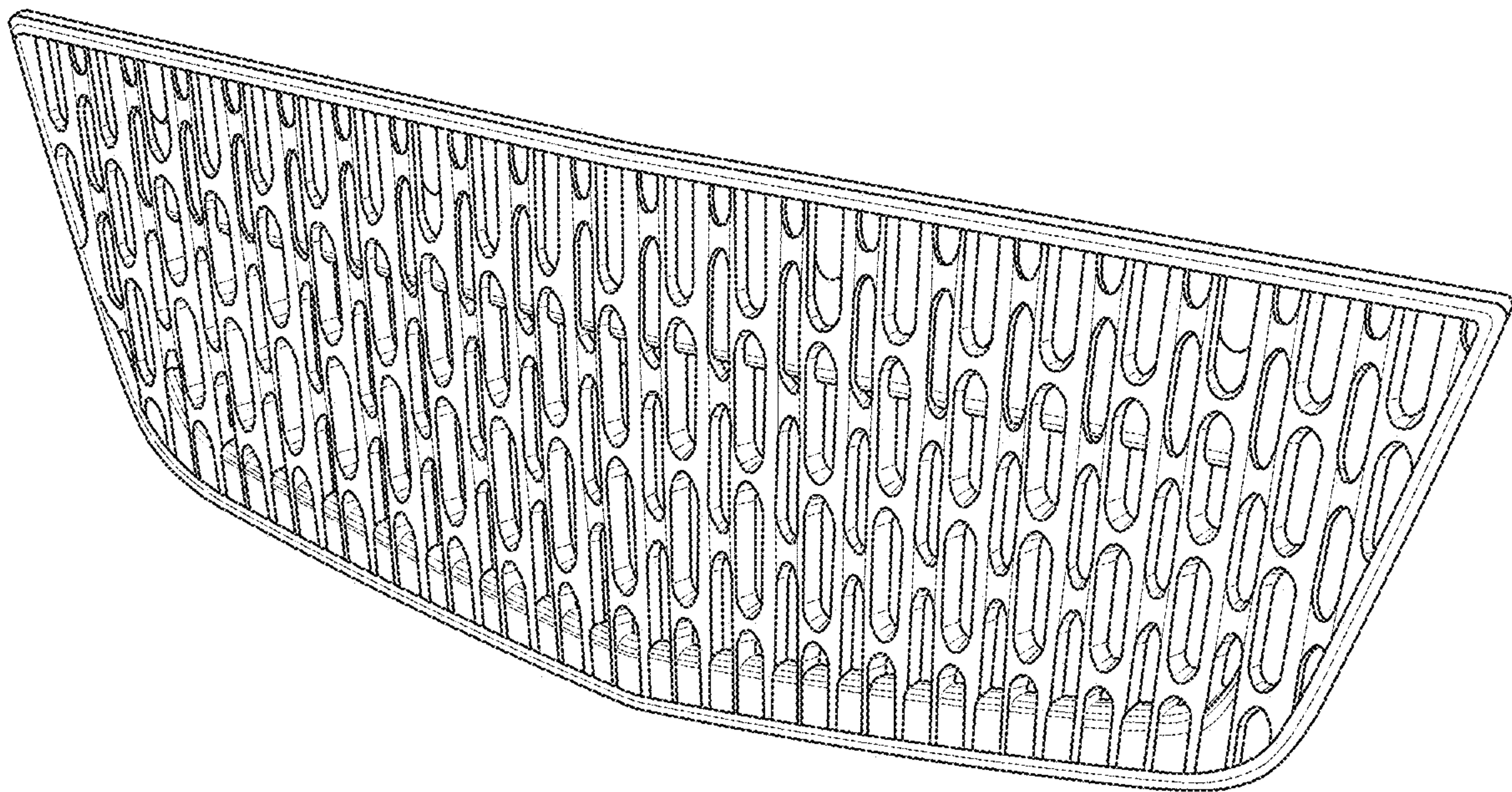
