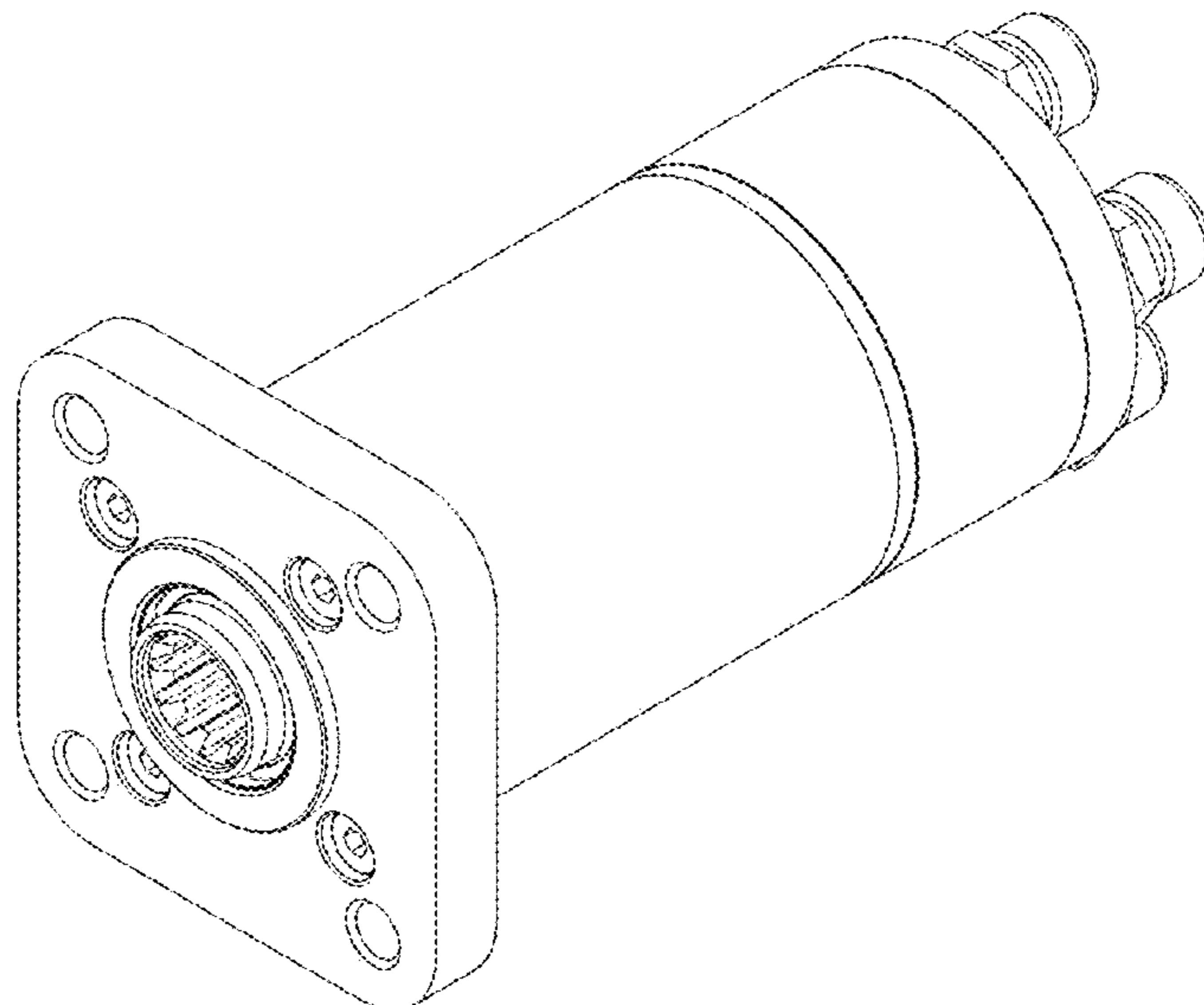
(57) **CLAIM**

The ornamental design for a hydraulic steering unit, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a hydraulic steering unit embodying our new design;

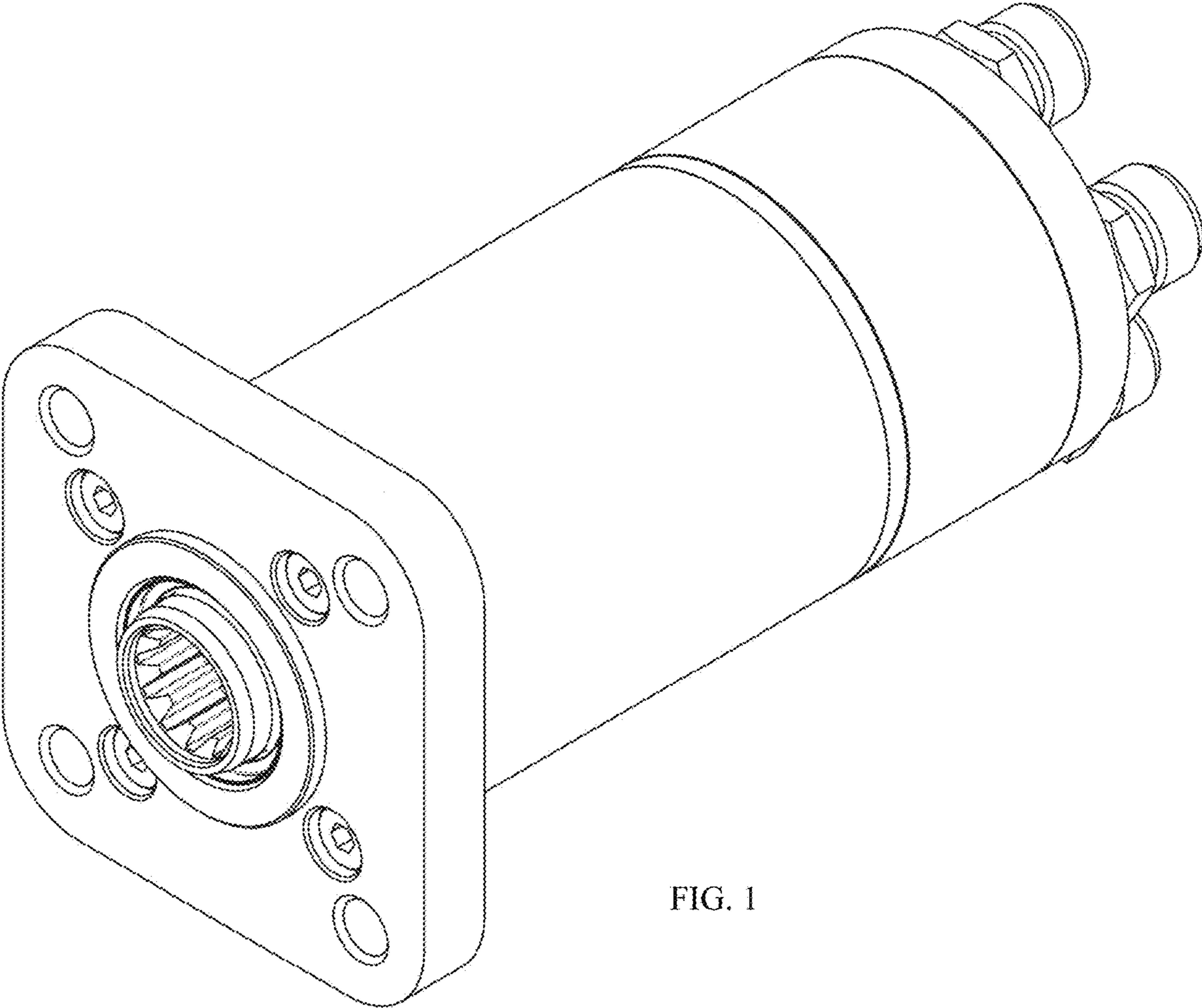

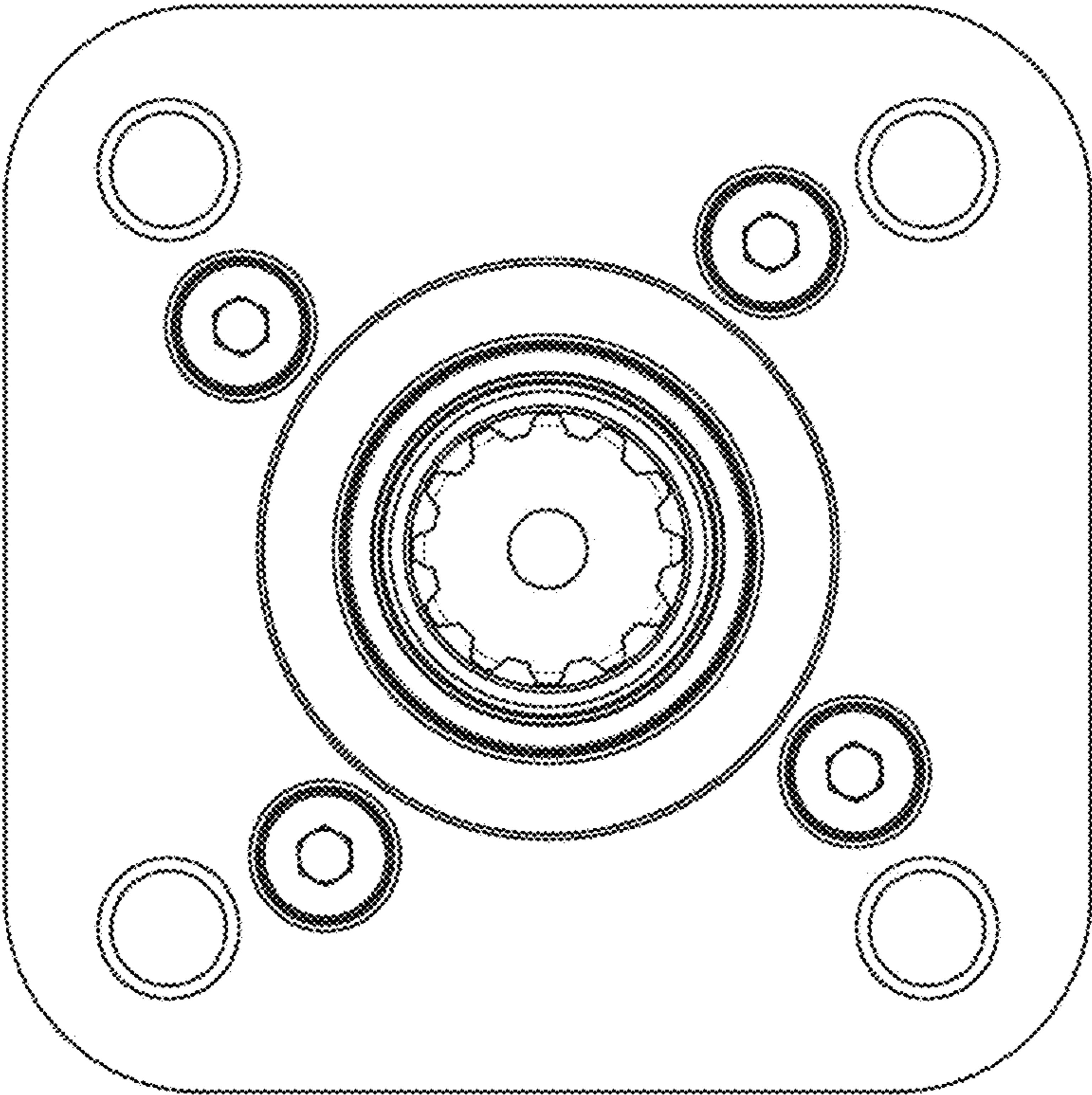

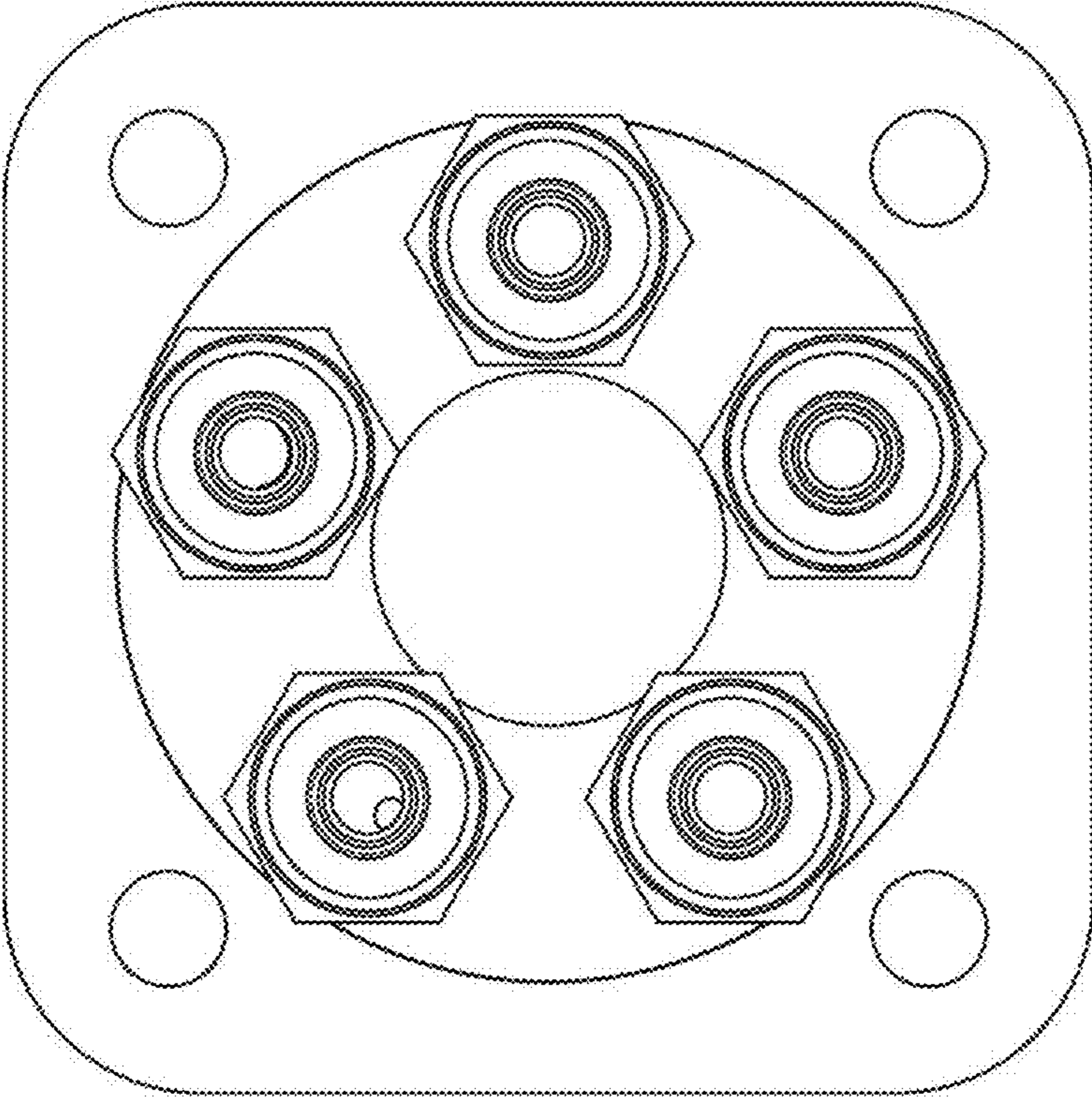

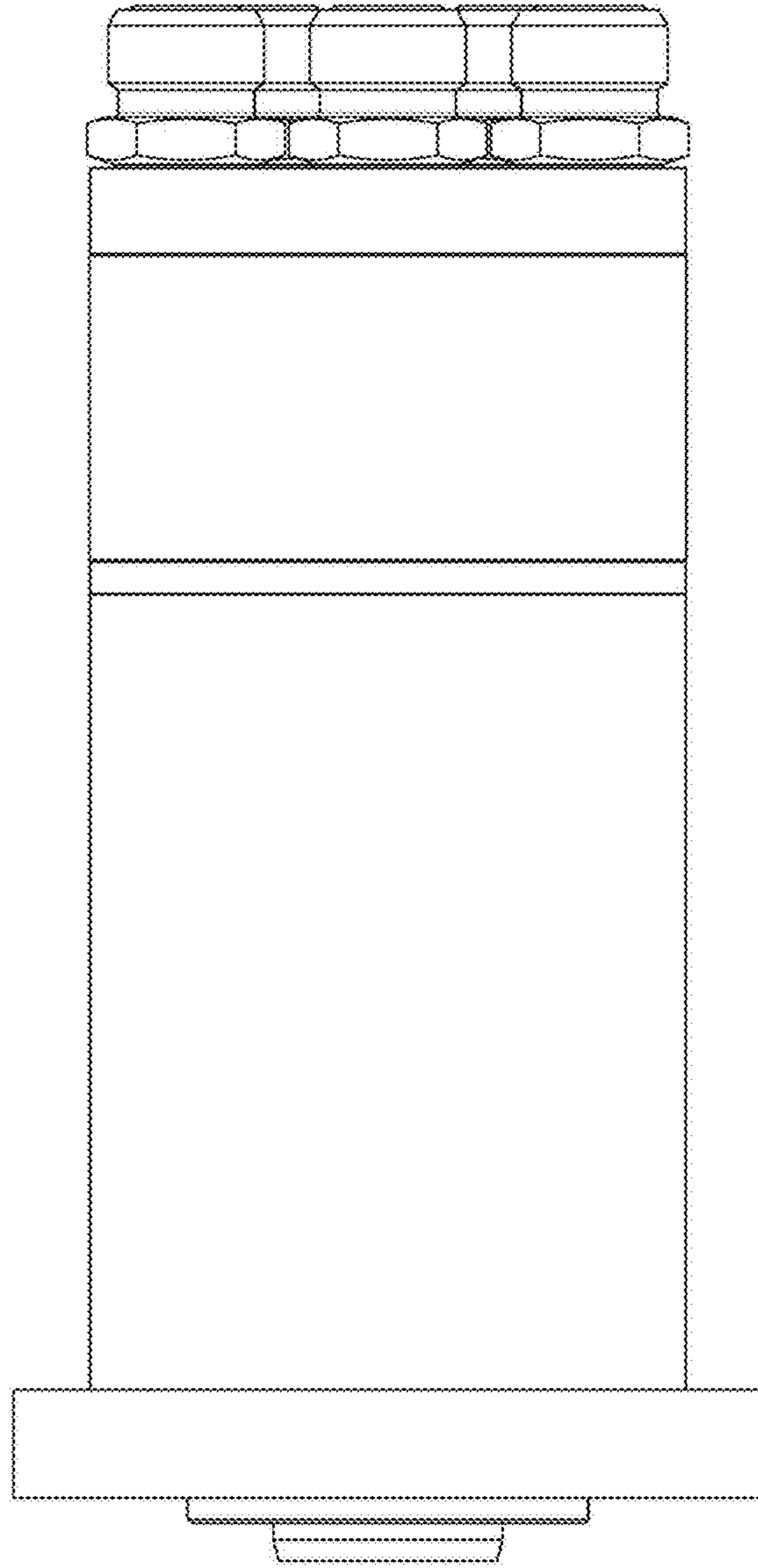

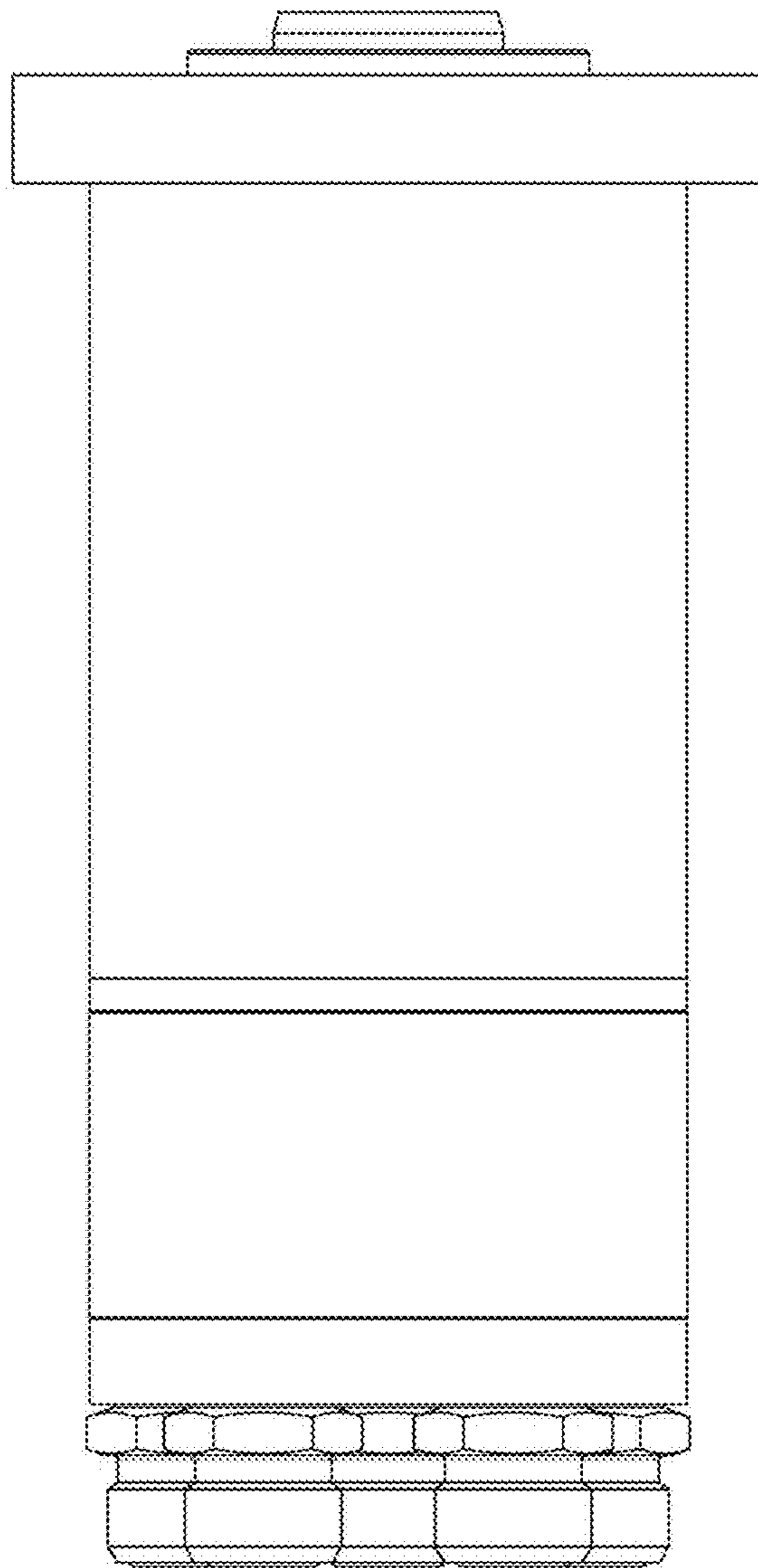

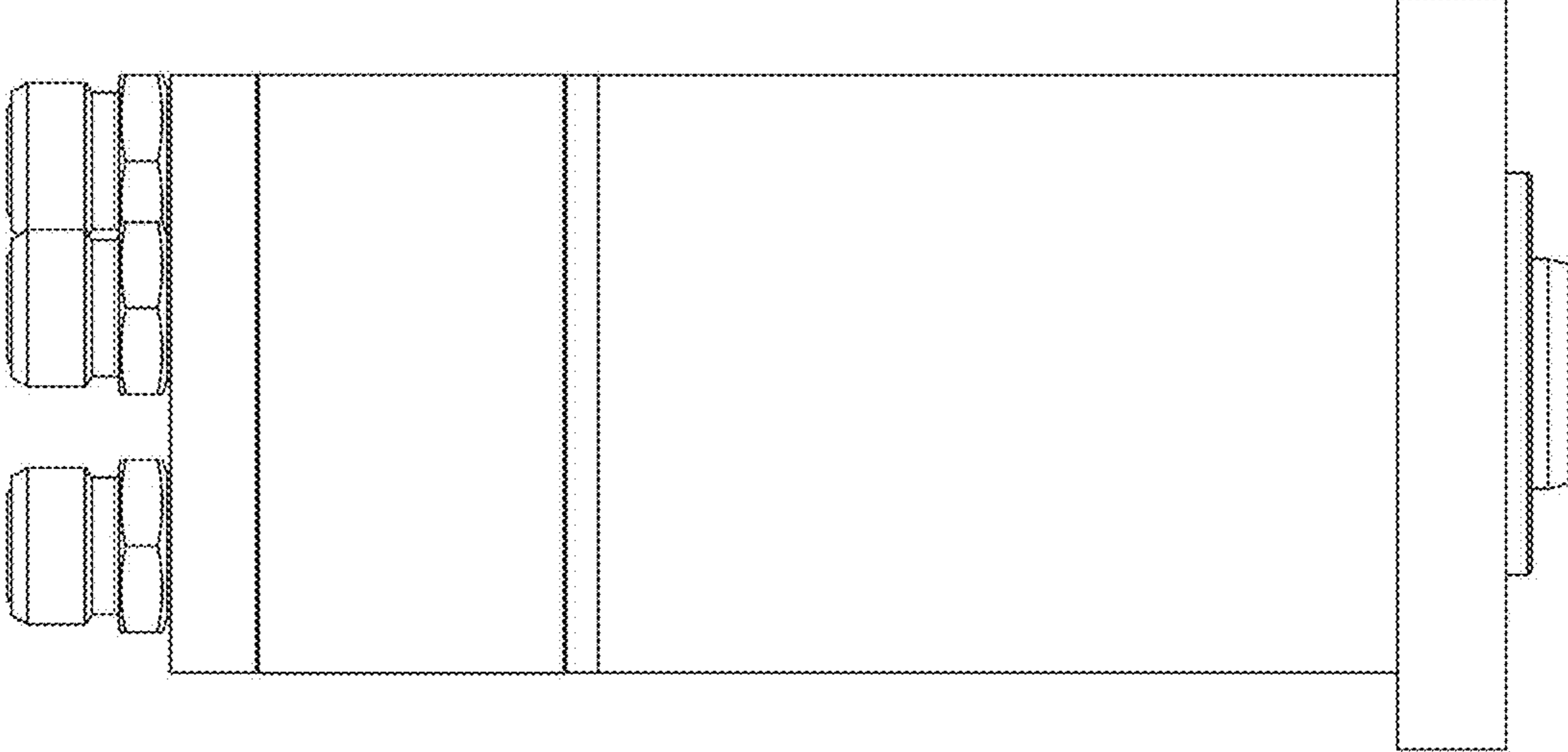

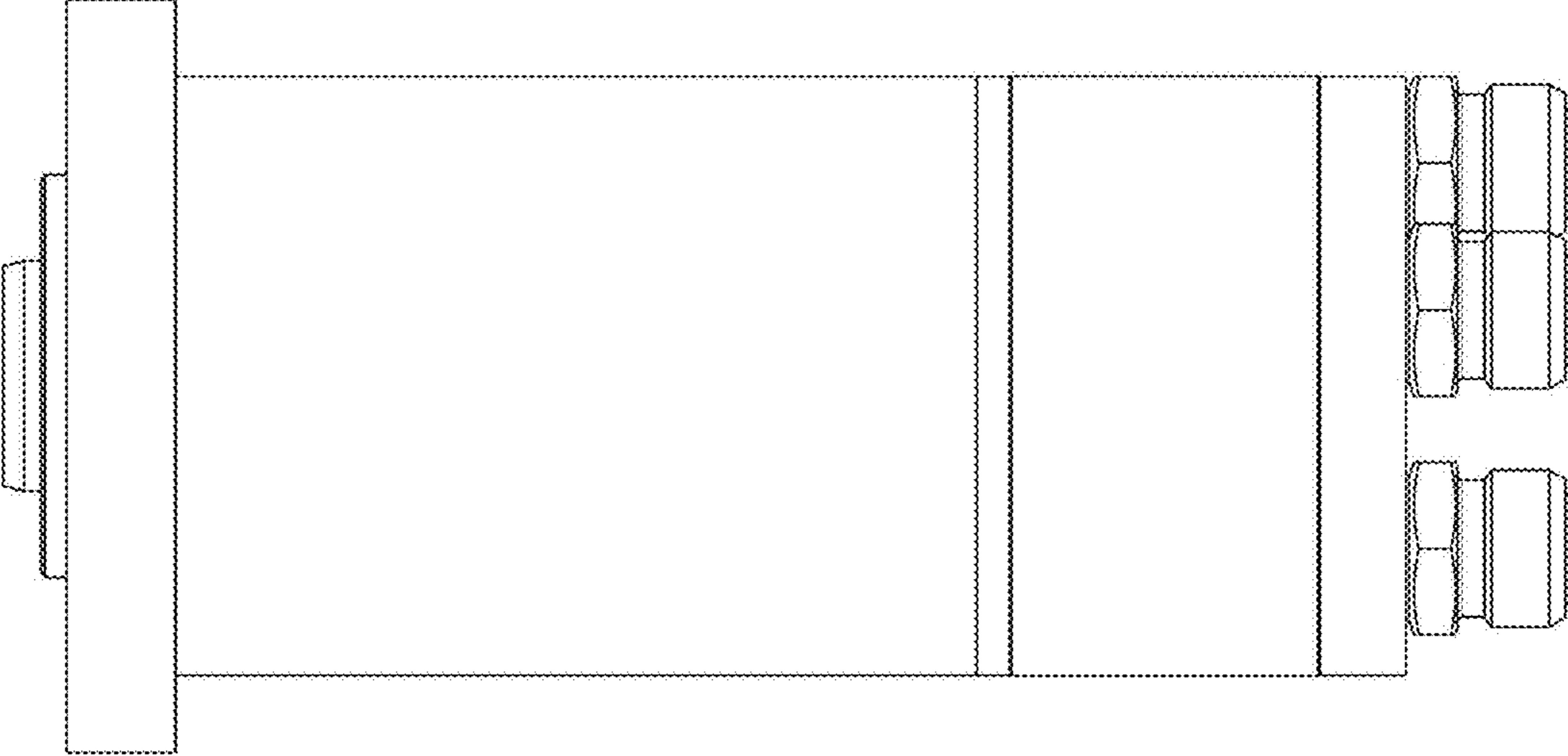
