**DESCRIPTION**

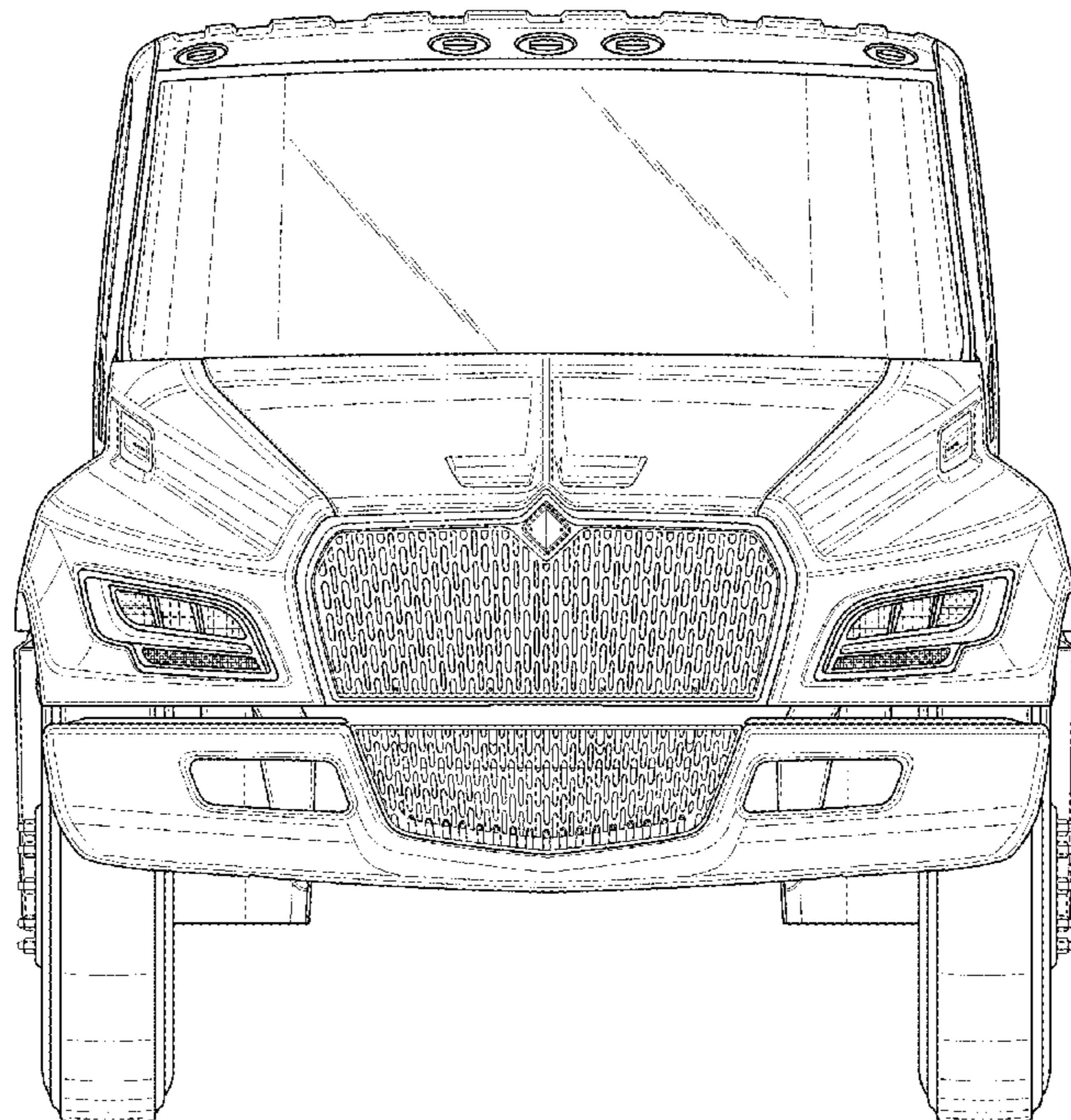
FIG. 1 is a front view of the truck;

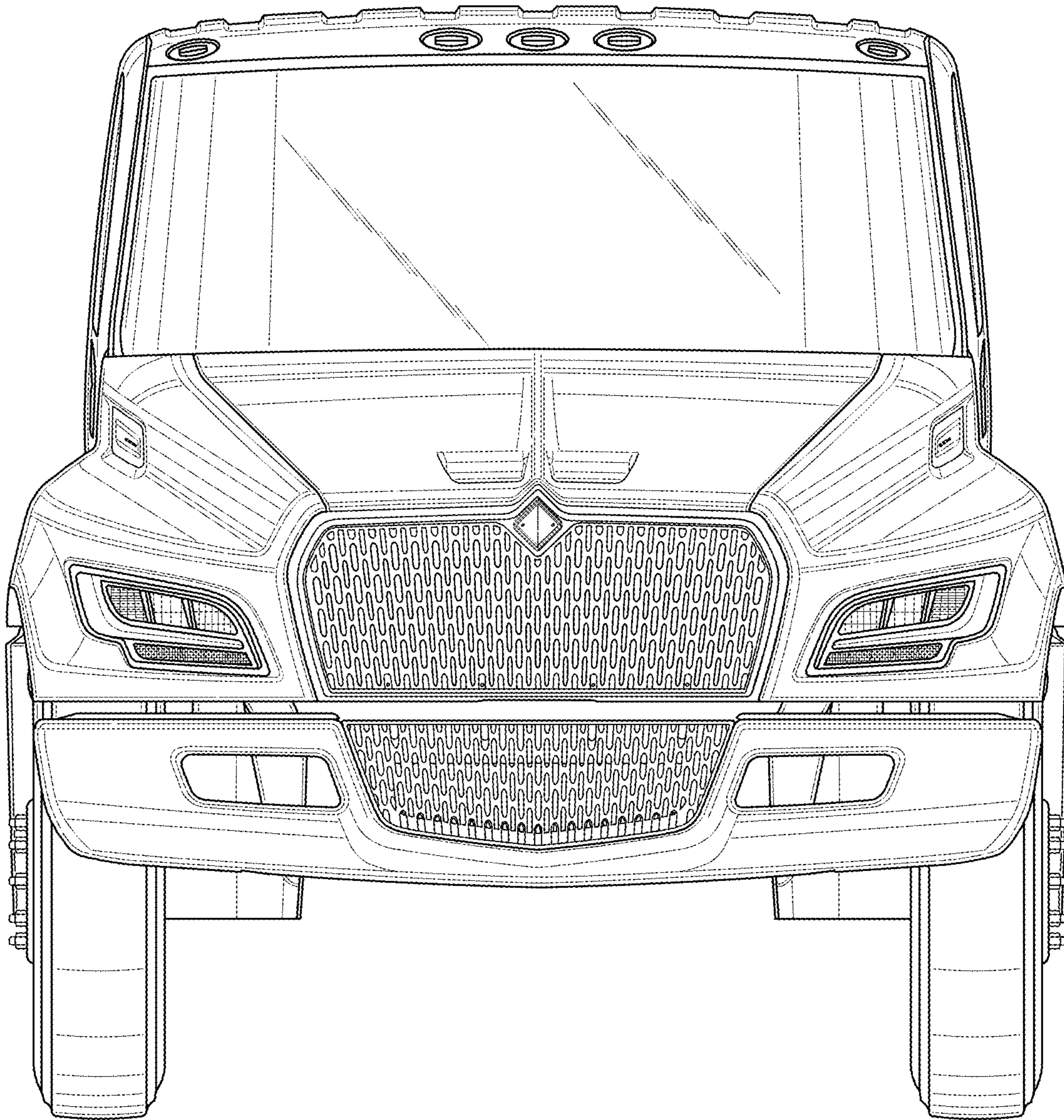

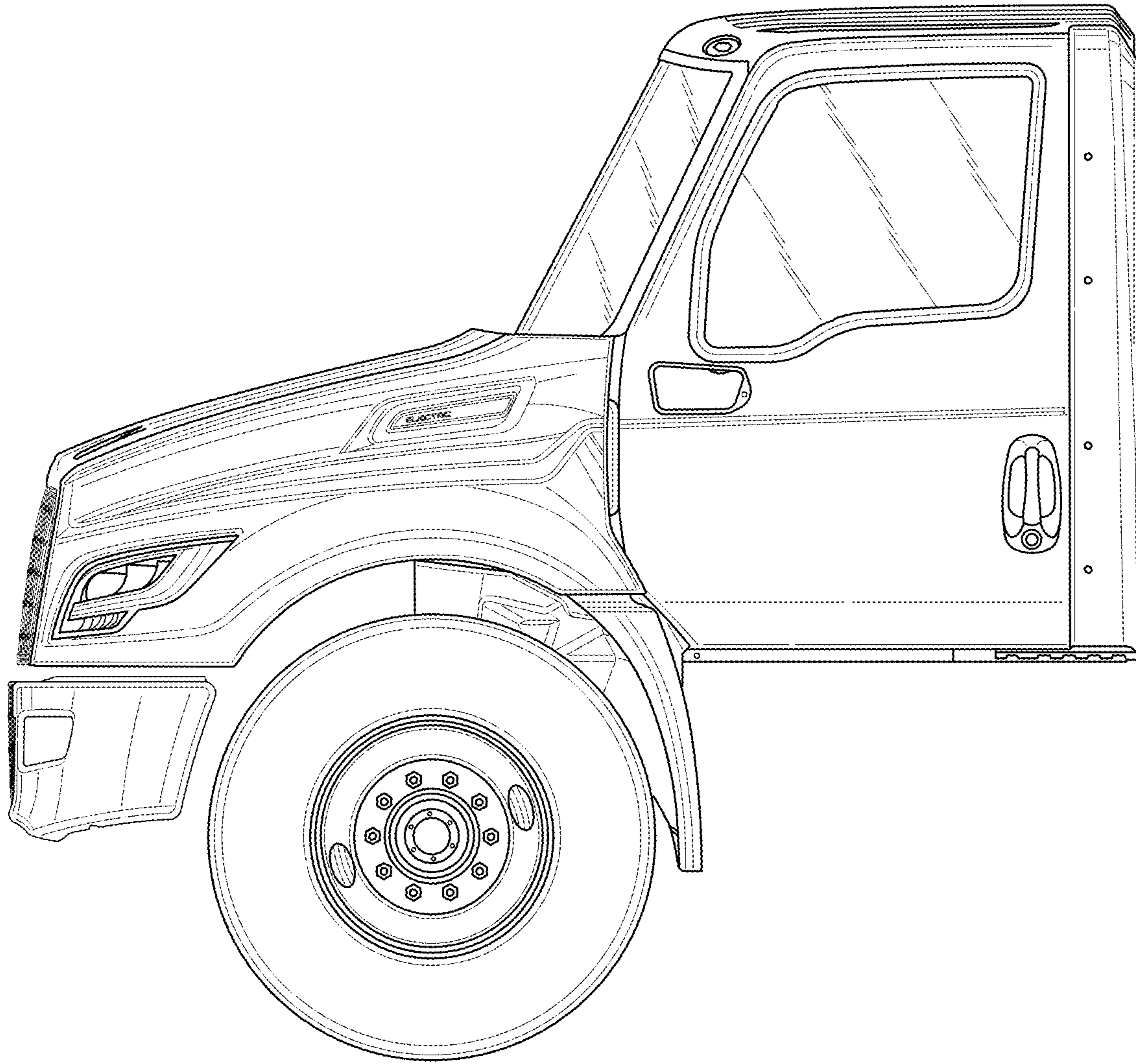

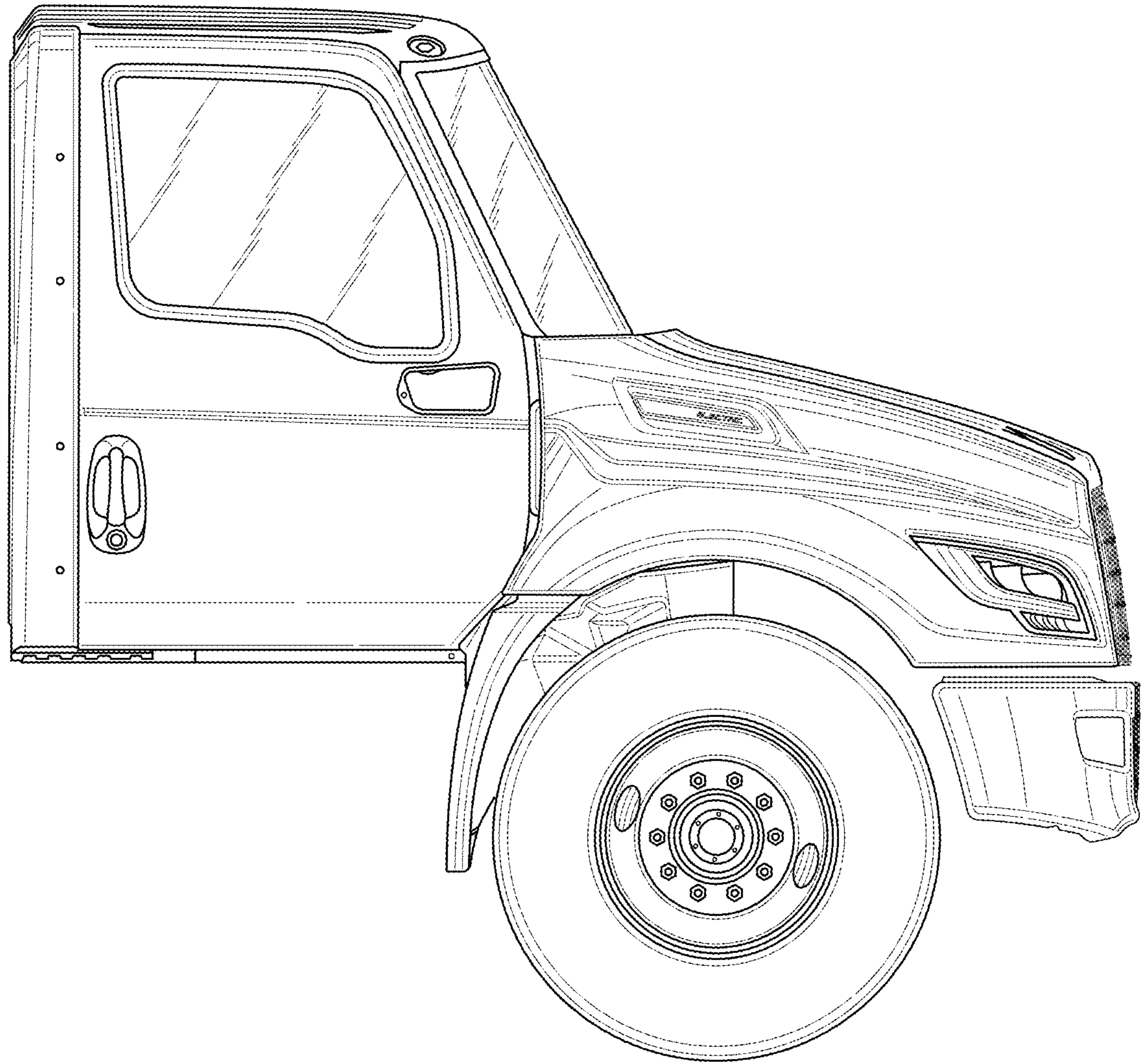

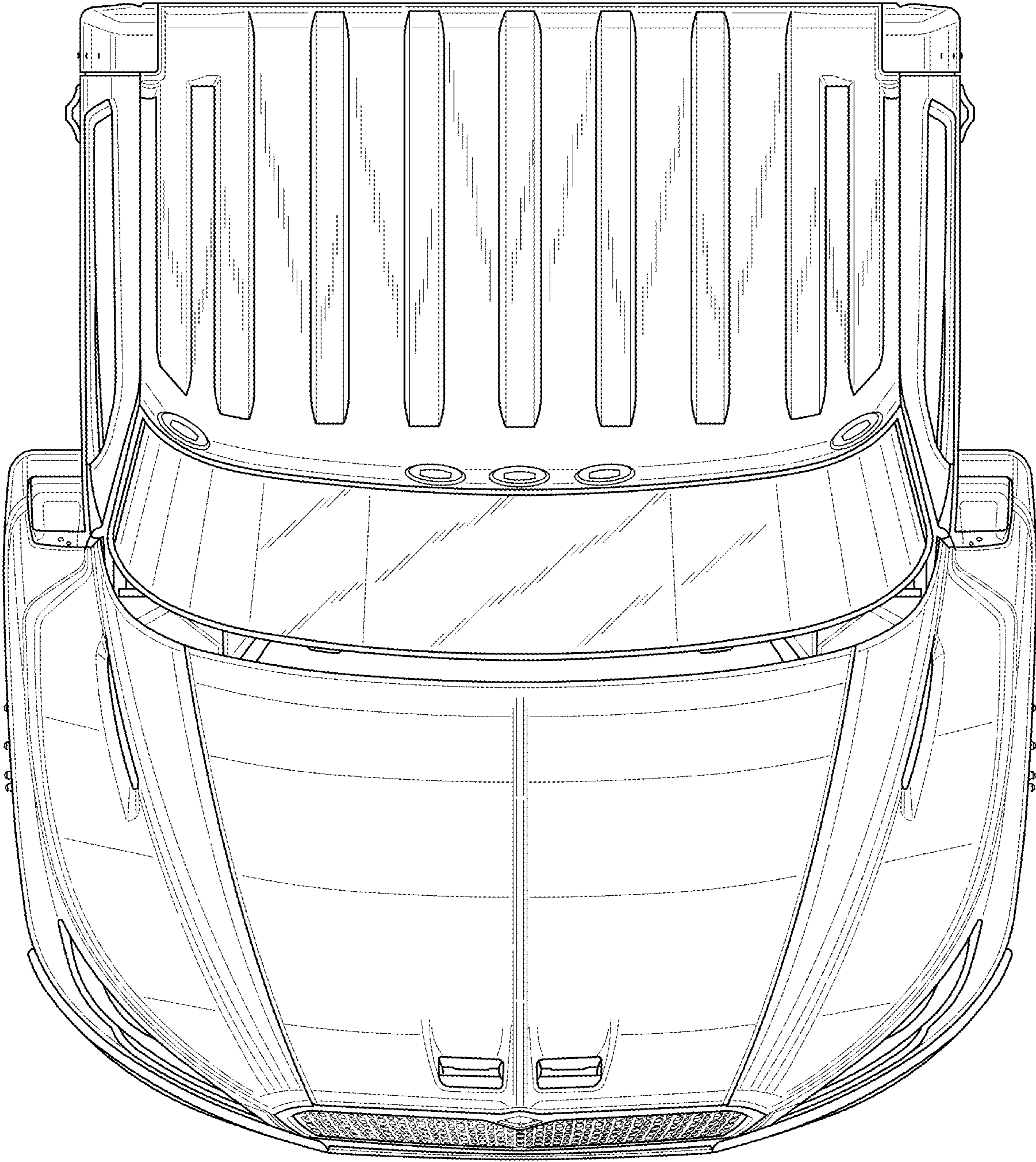

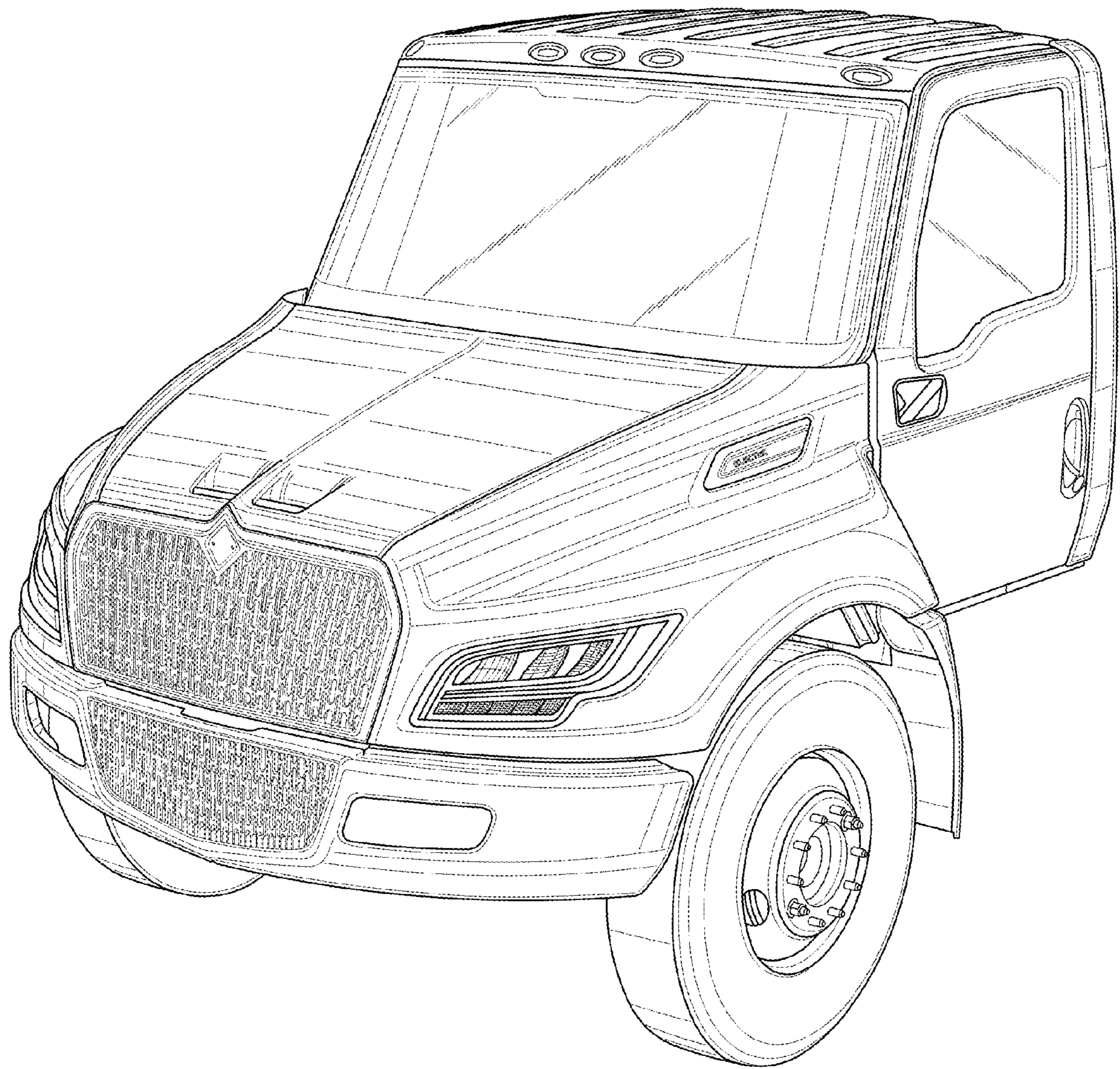
