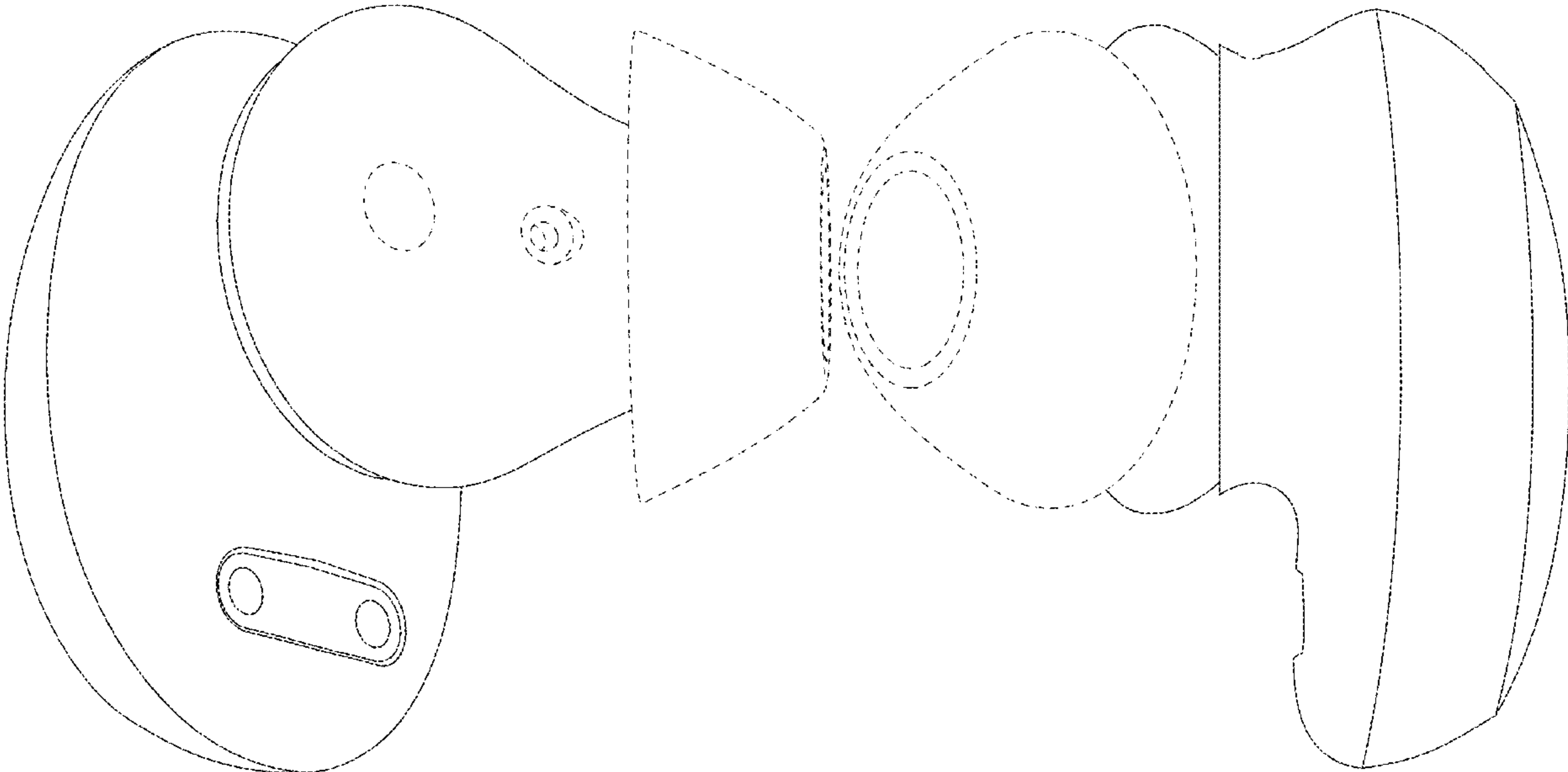
(57) CLAIM

I claim the ornamental design for a earphone, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of an earphone showing my new design;
FIG. 2 is a rear and right side perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left elevation view thereof;
FIG. 6 is a right elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

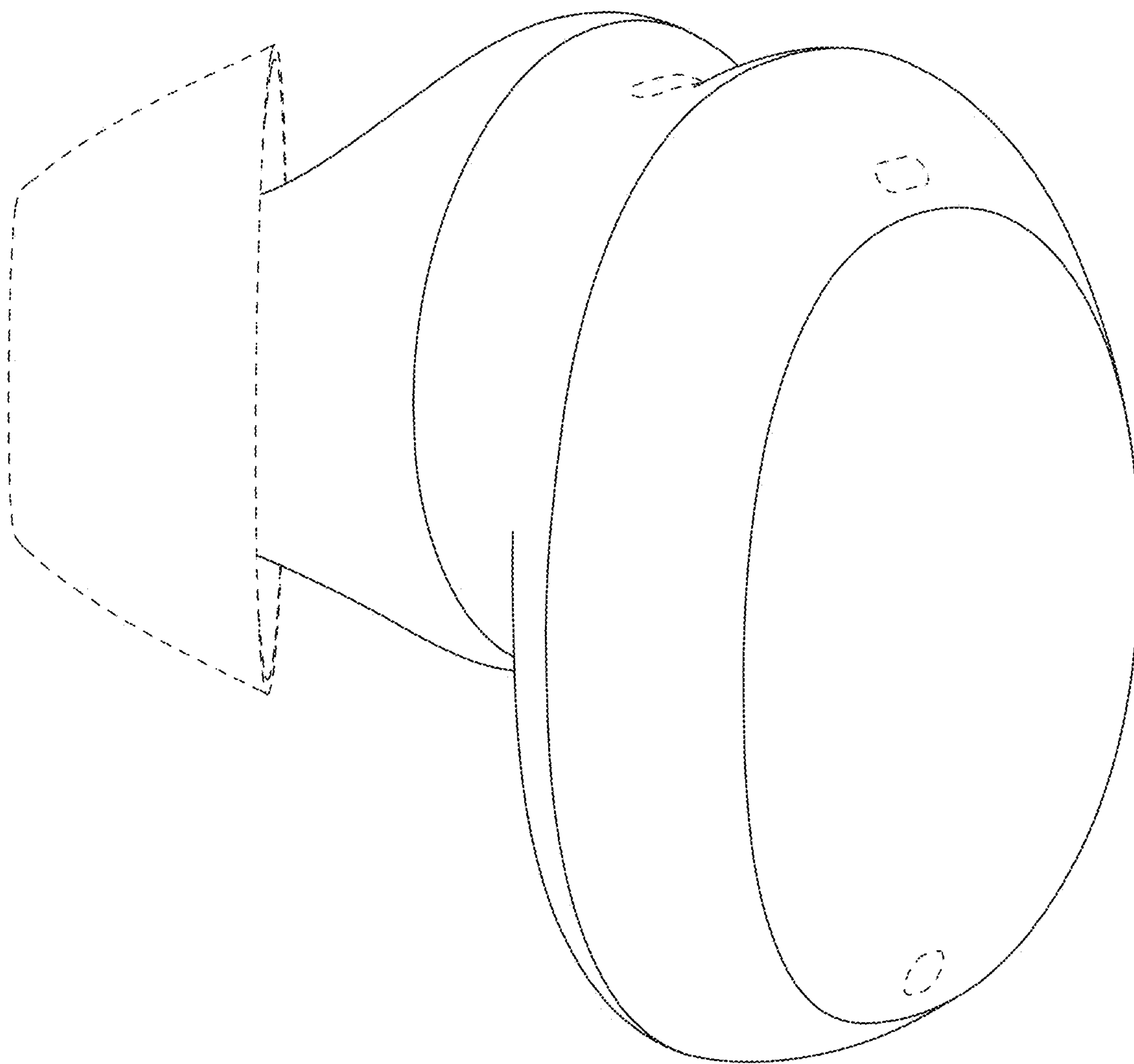

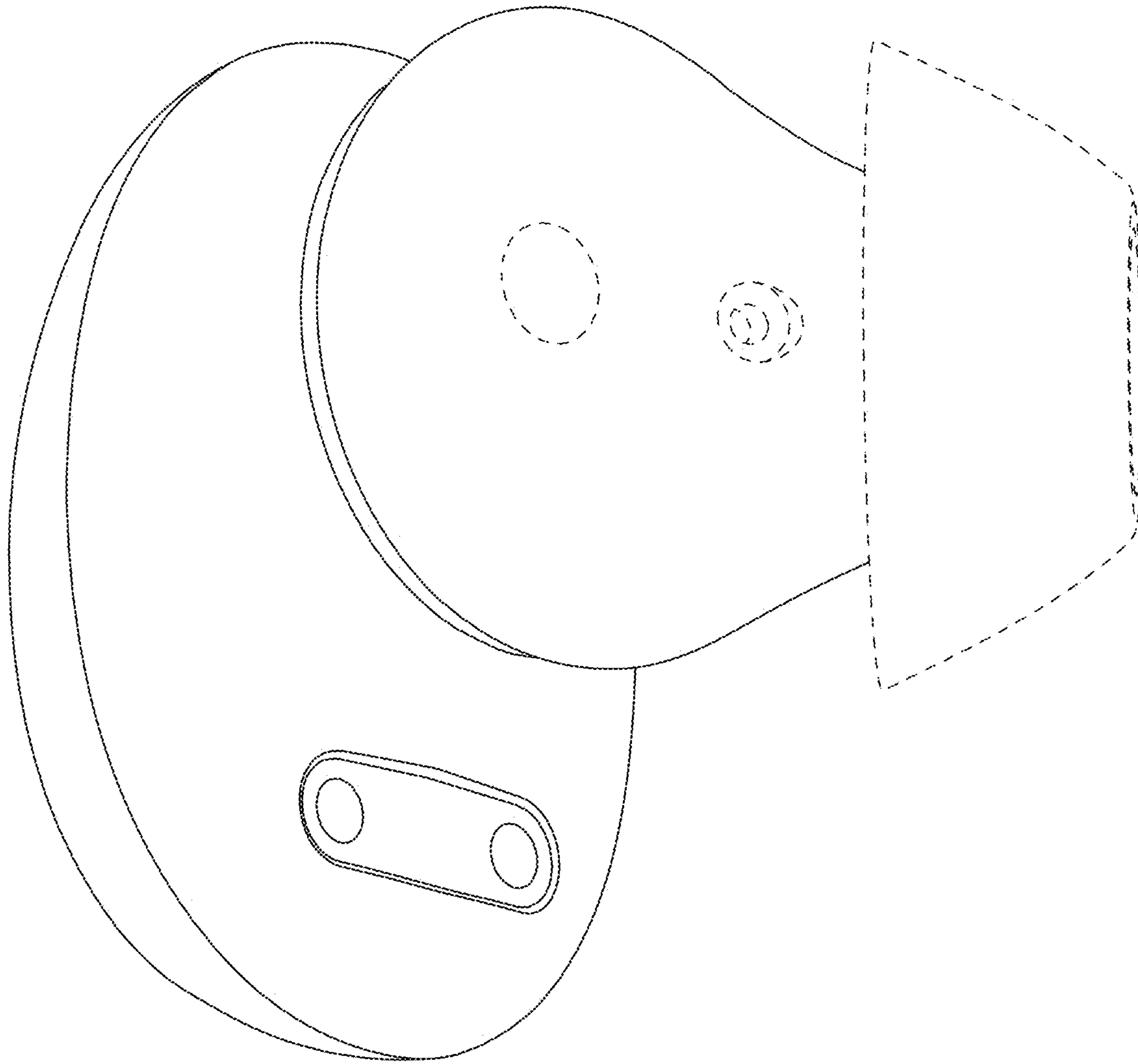

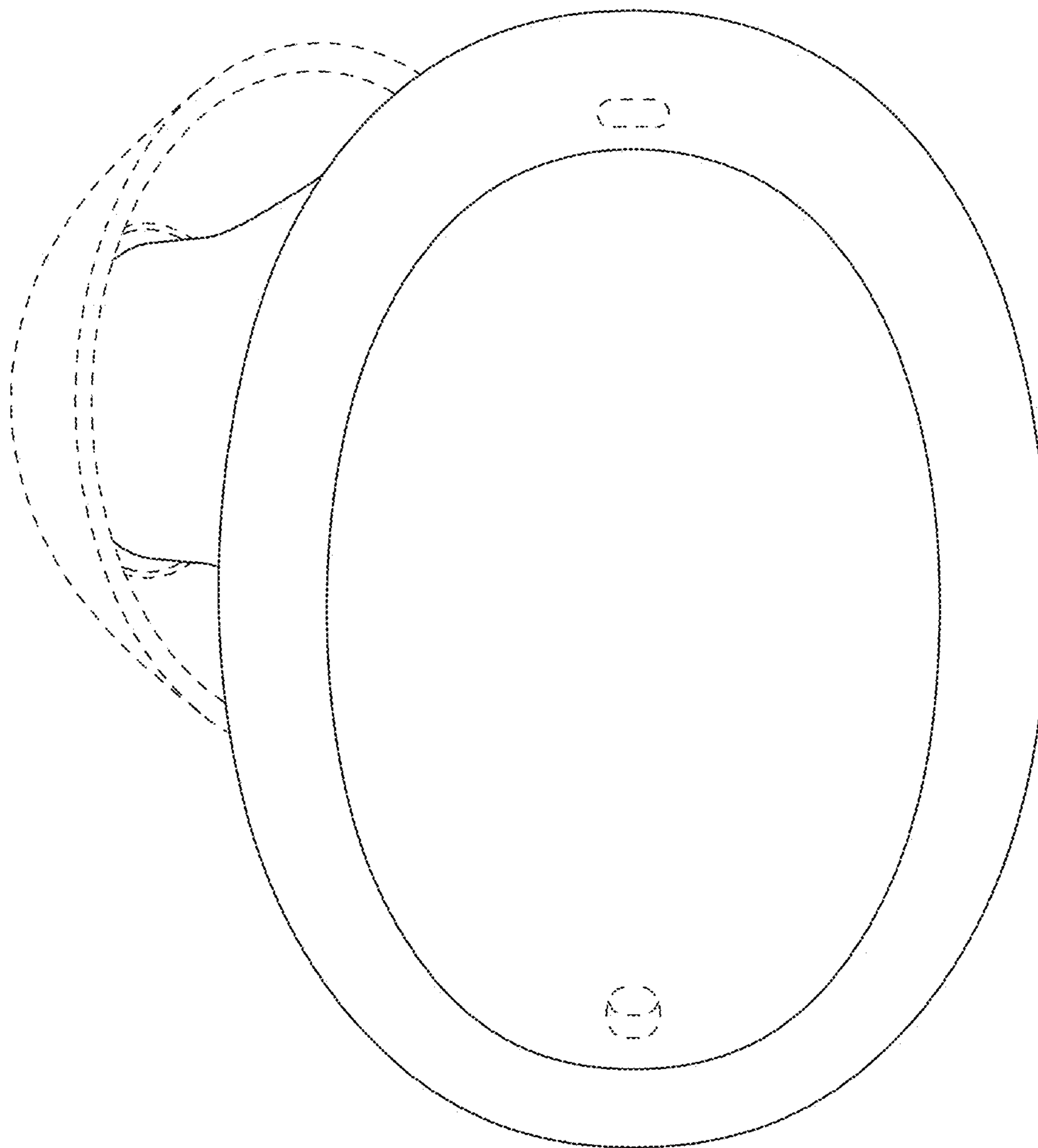

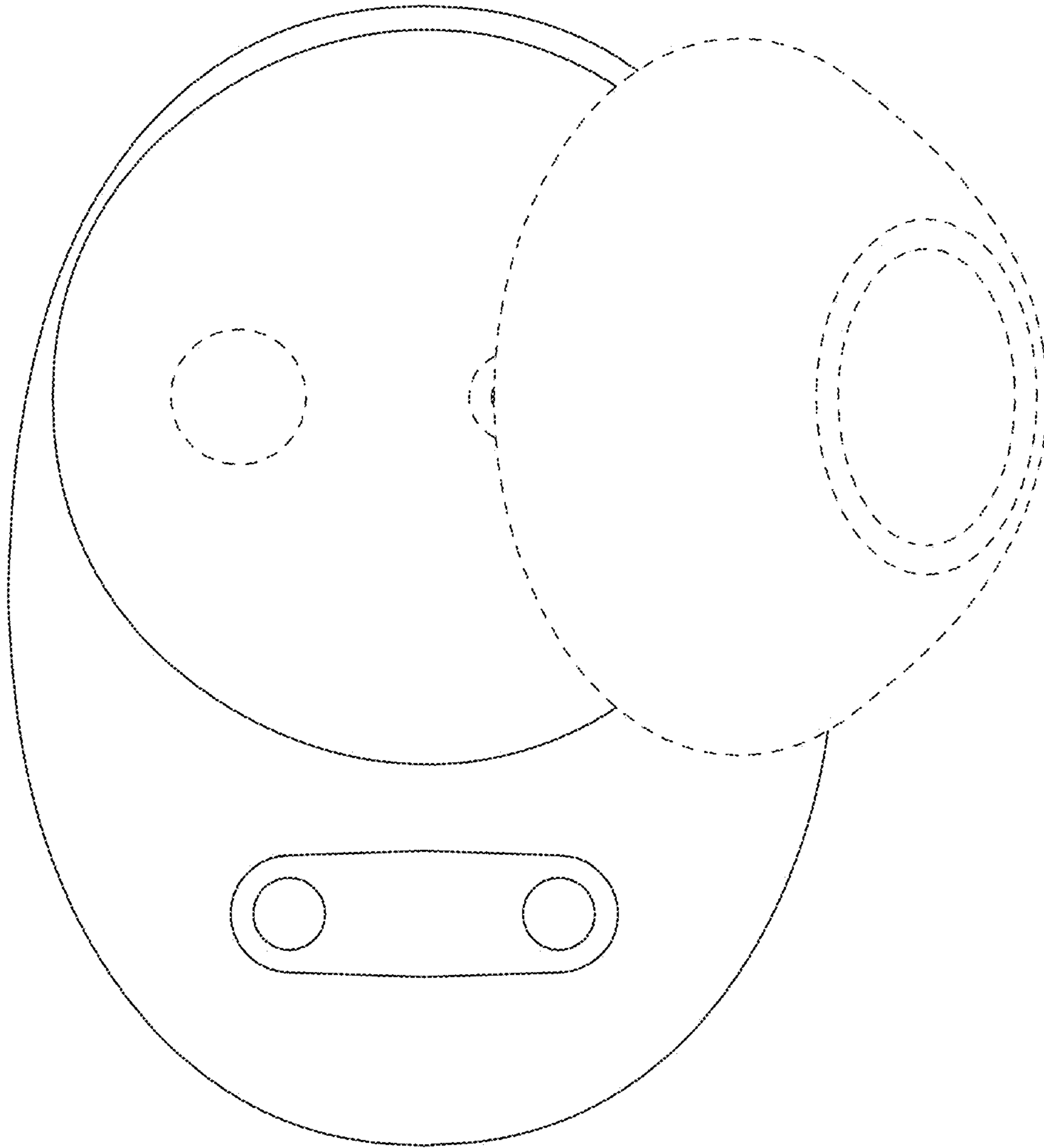

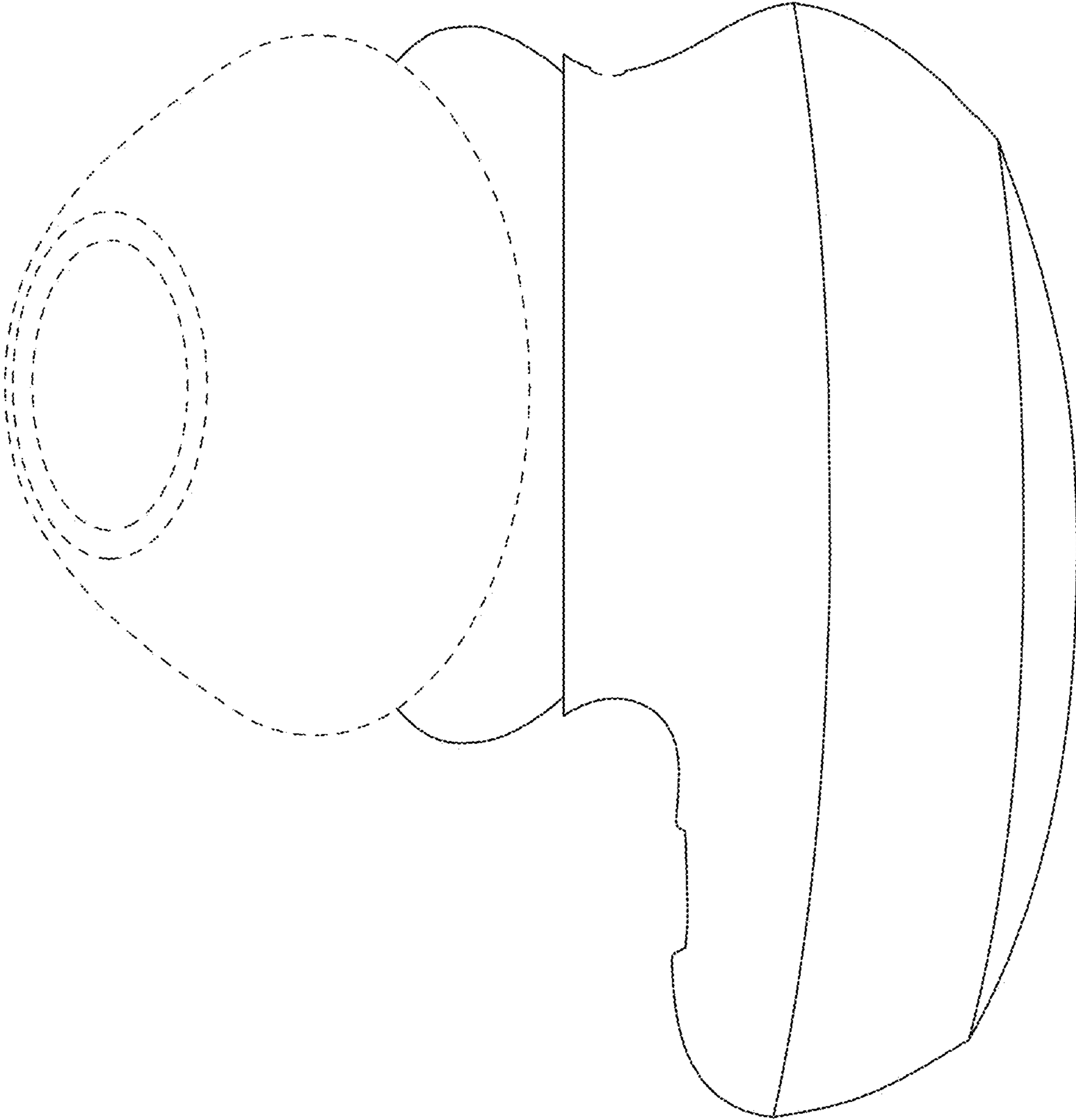

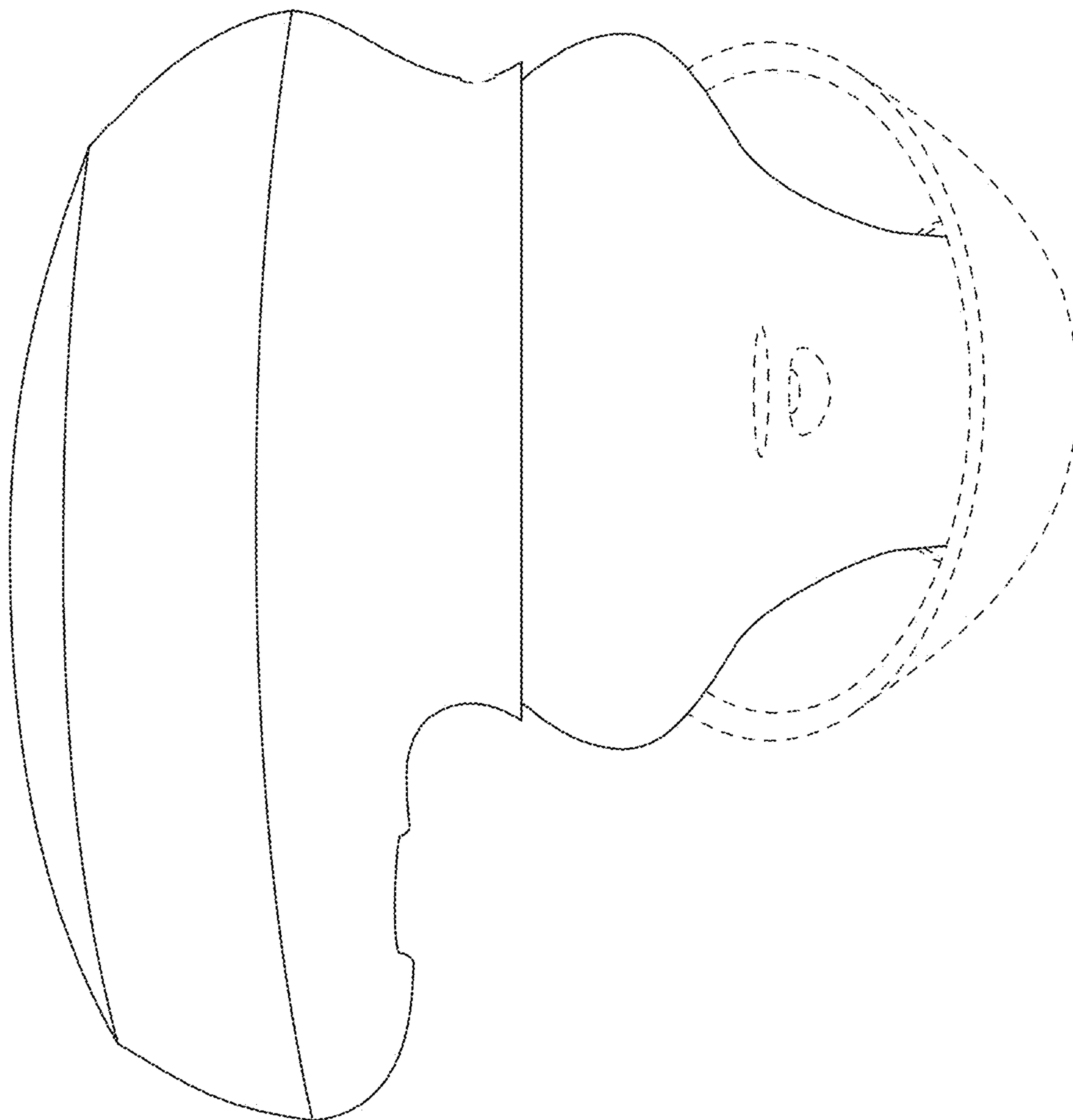

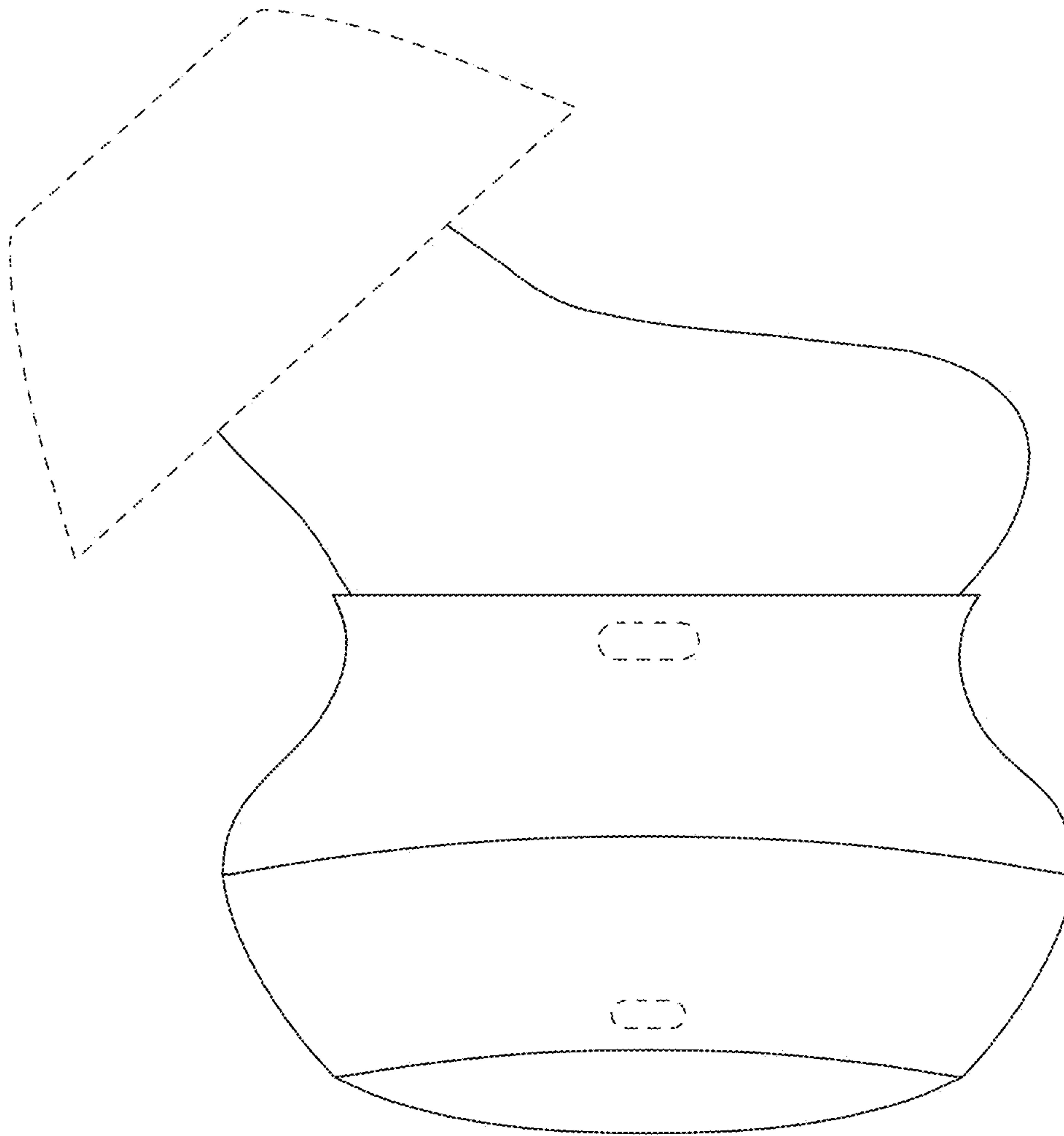

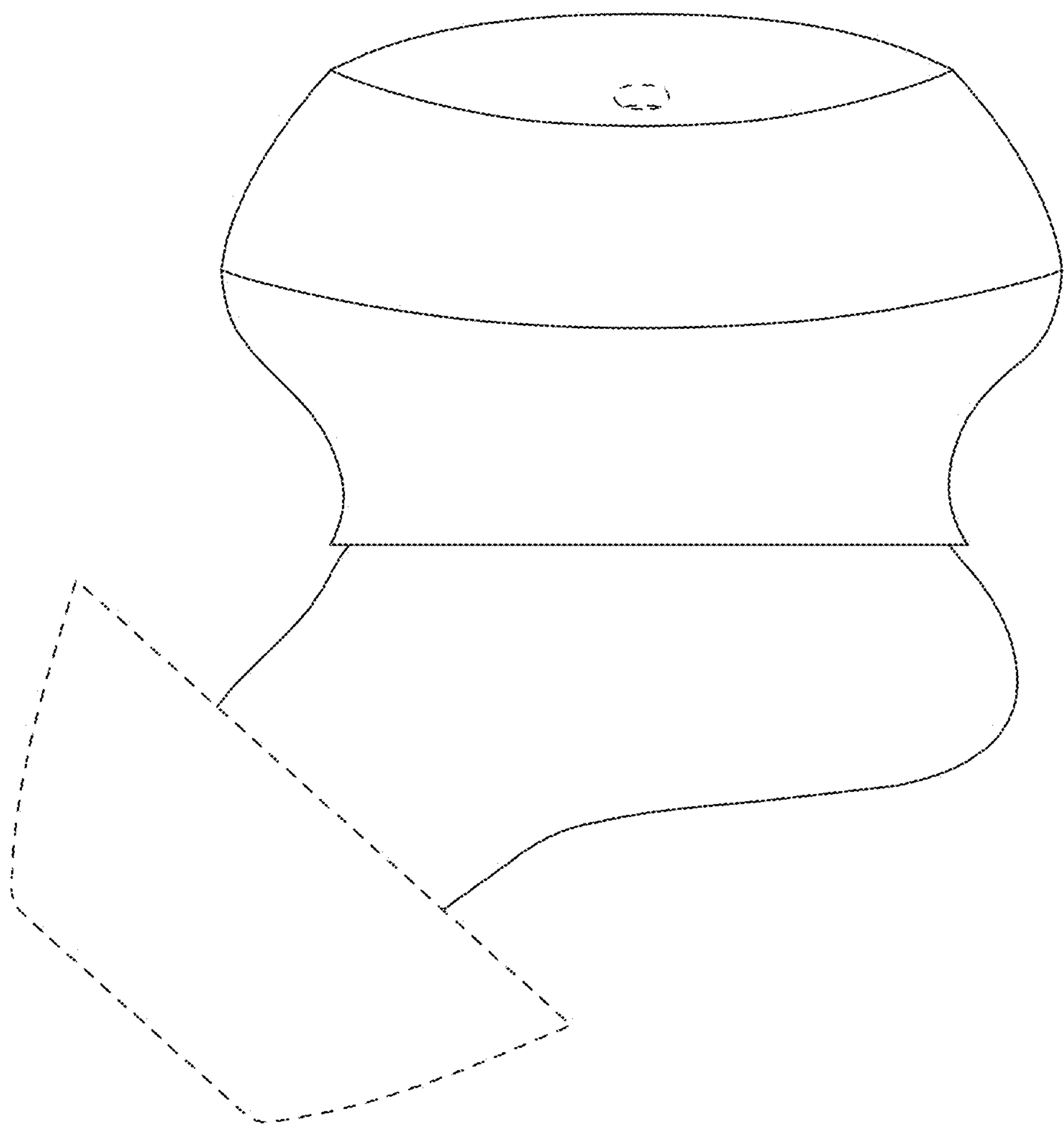
