**DESCRIPTION**

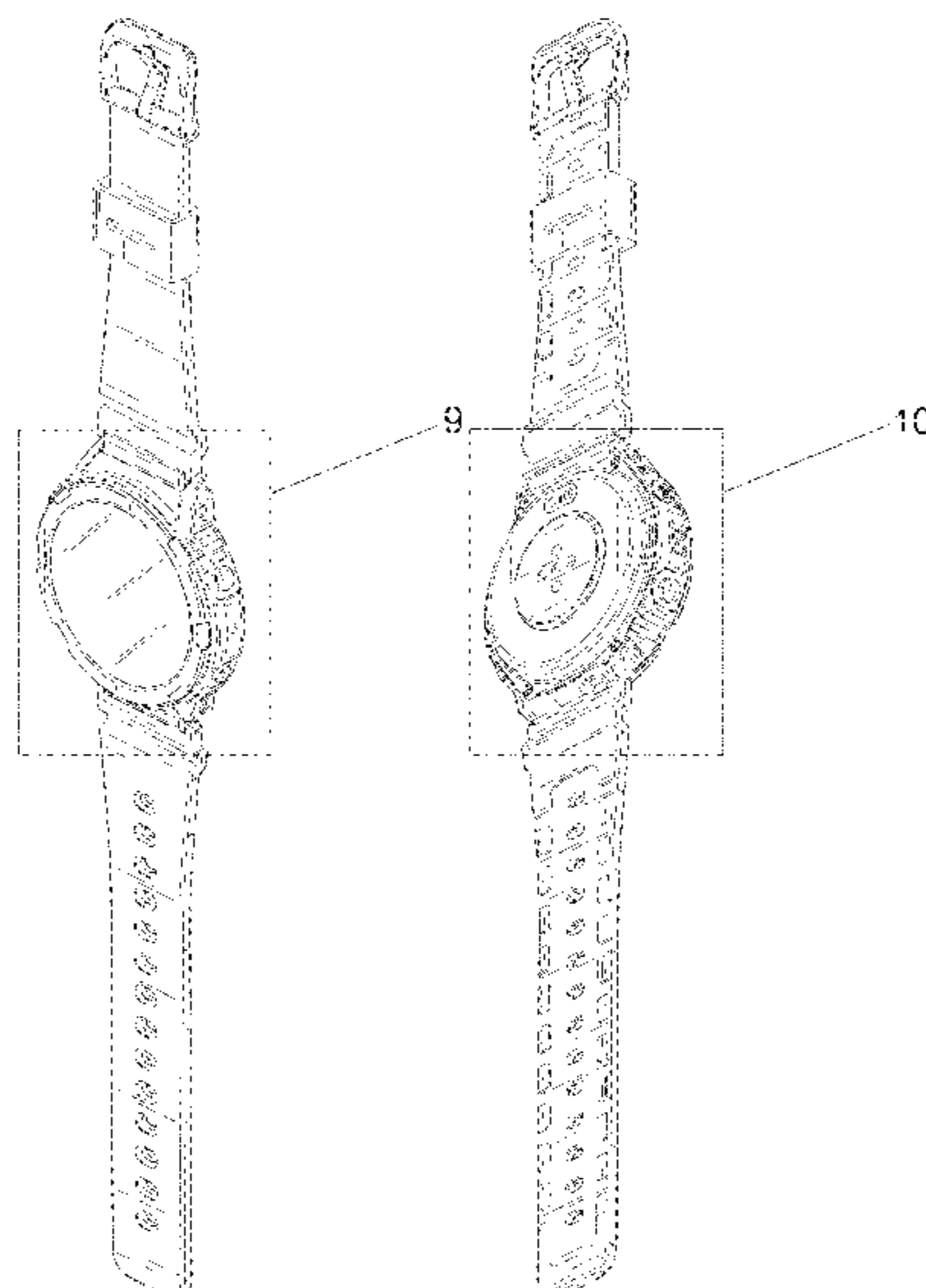
FIG. 1 is a front, right and top perspective view of a smart watch, showing my new design;

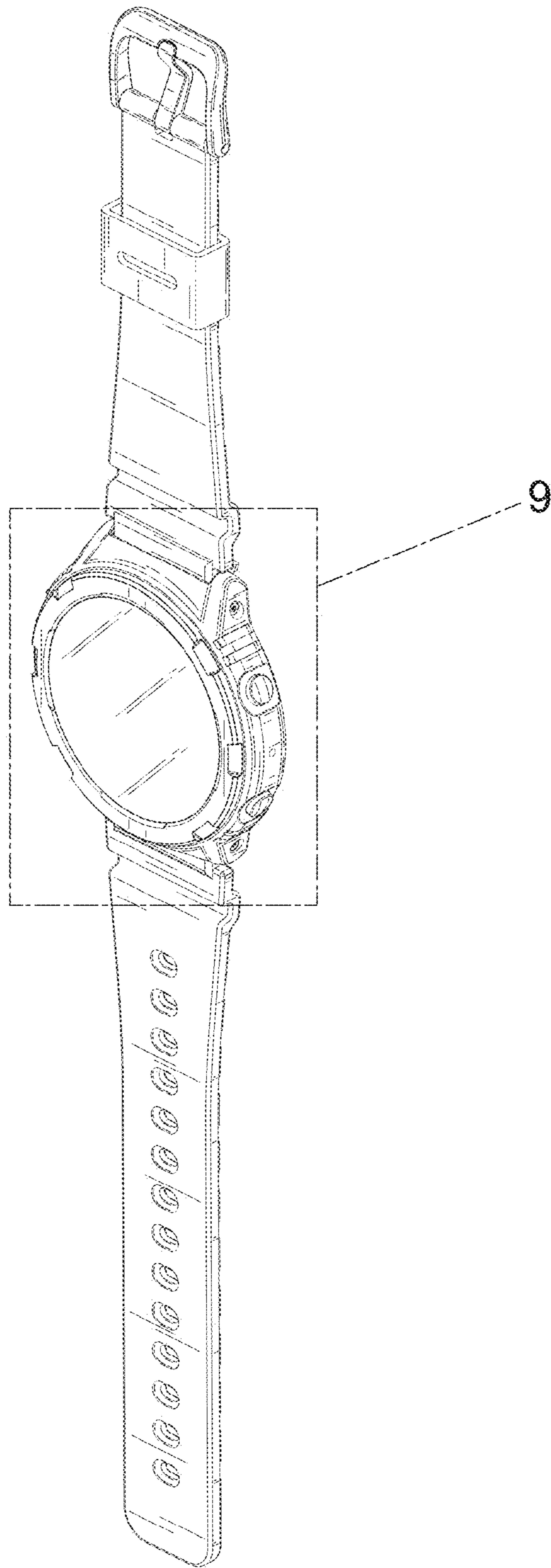

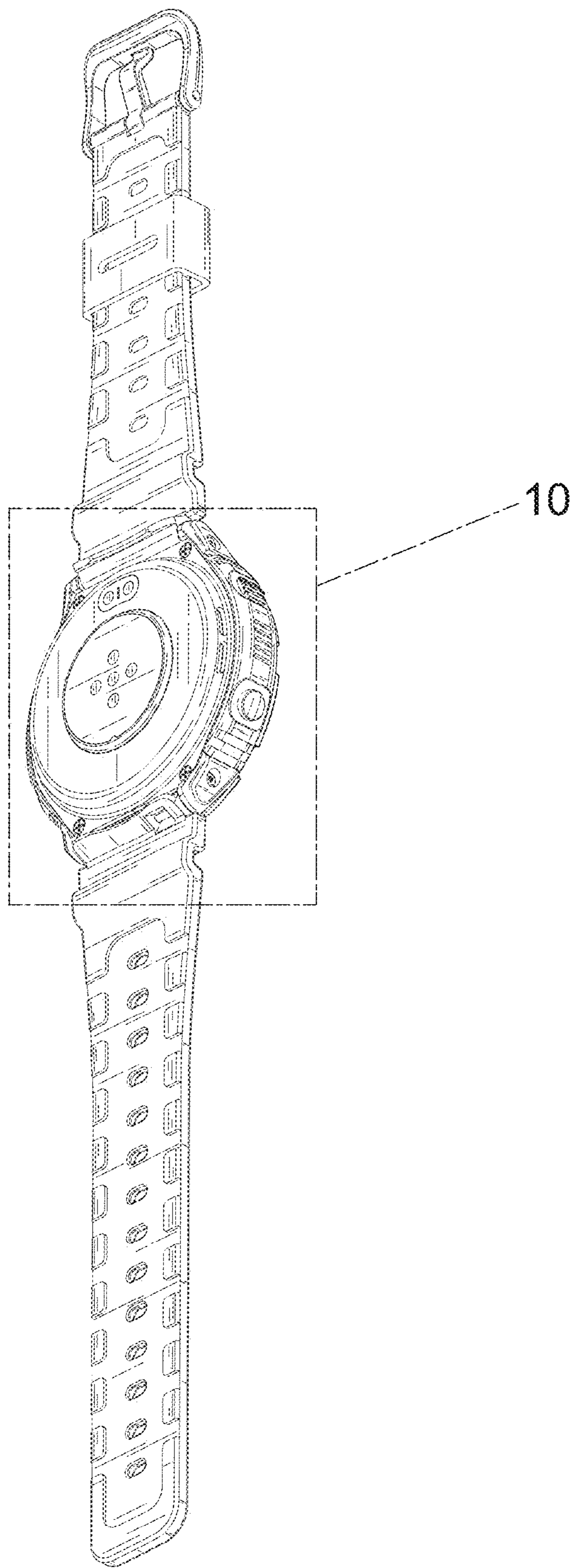

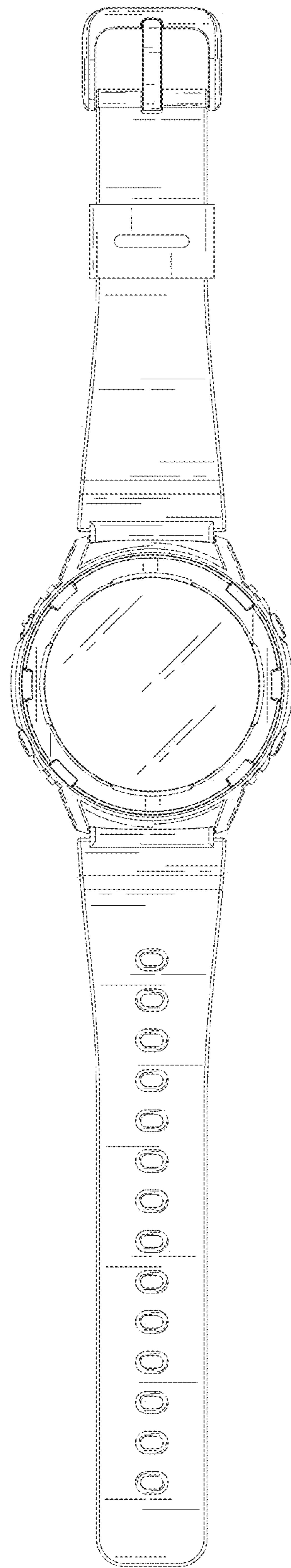

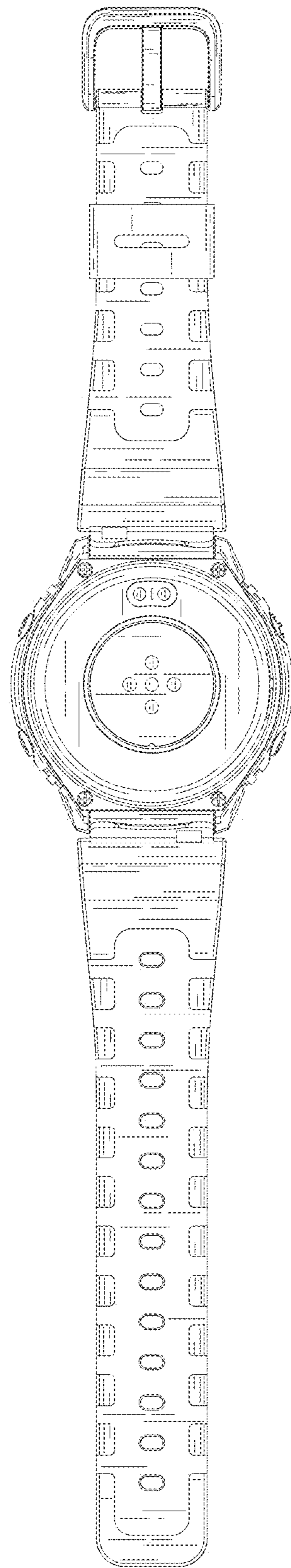

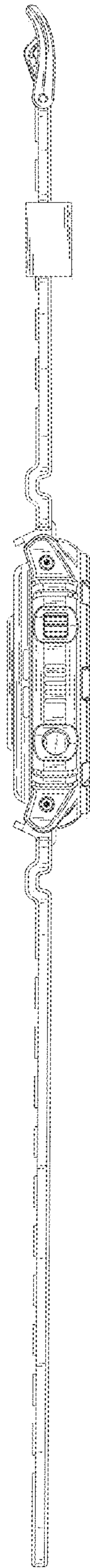

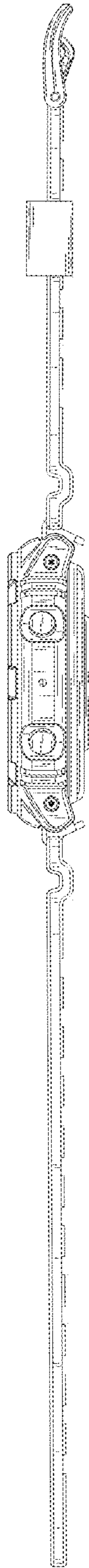

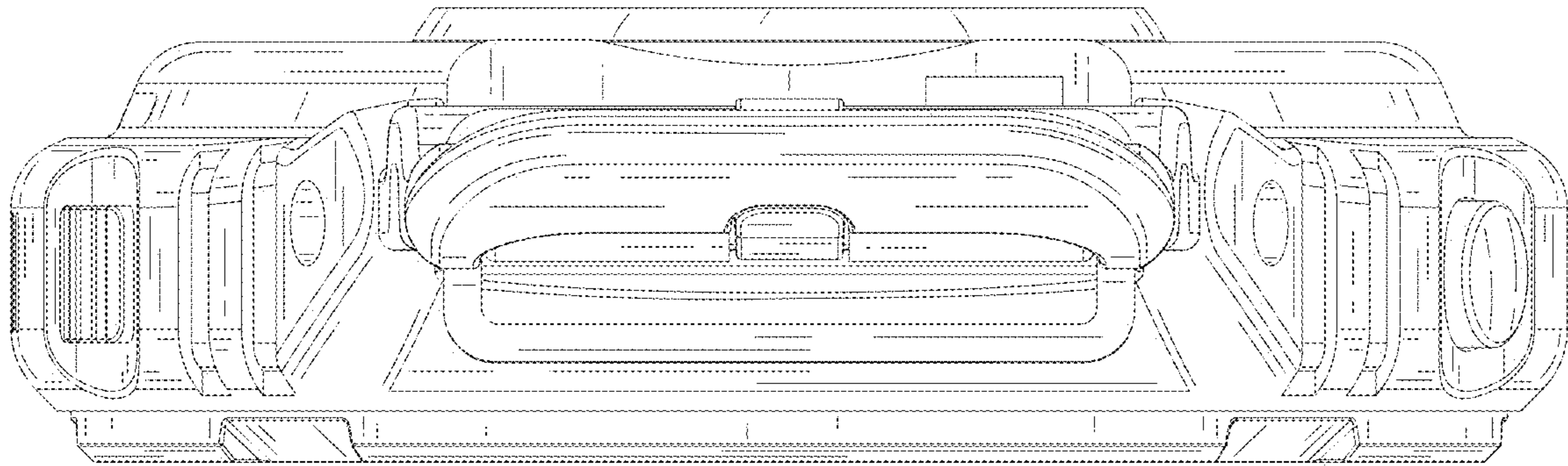

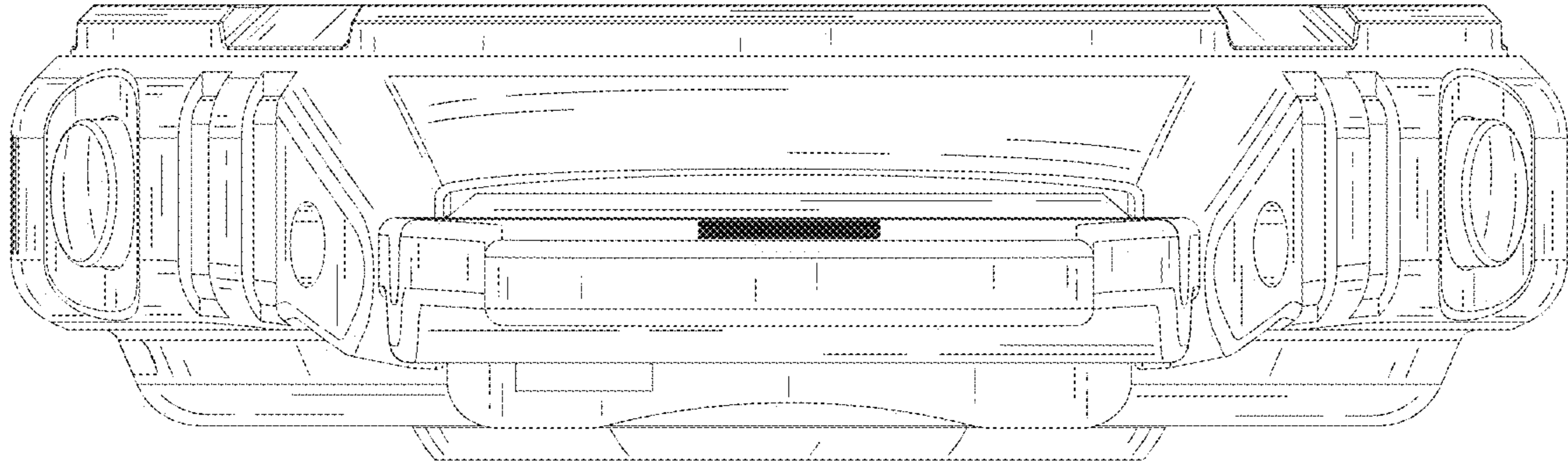

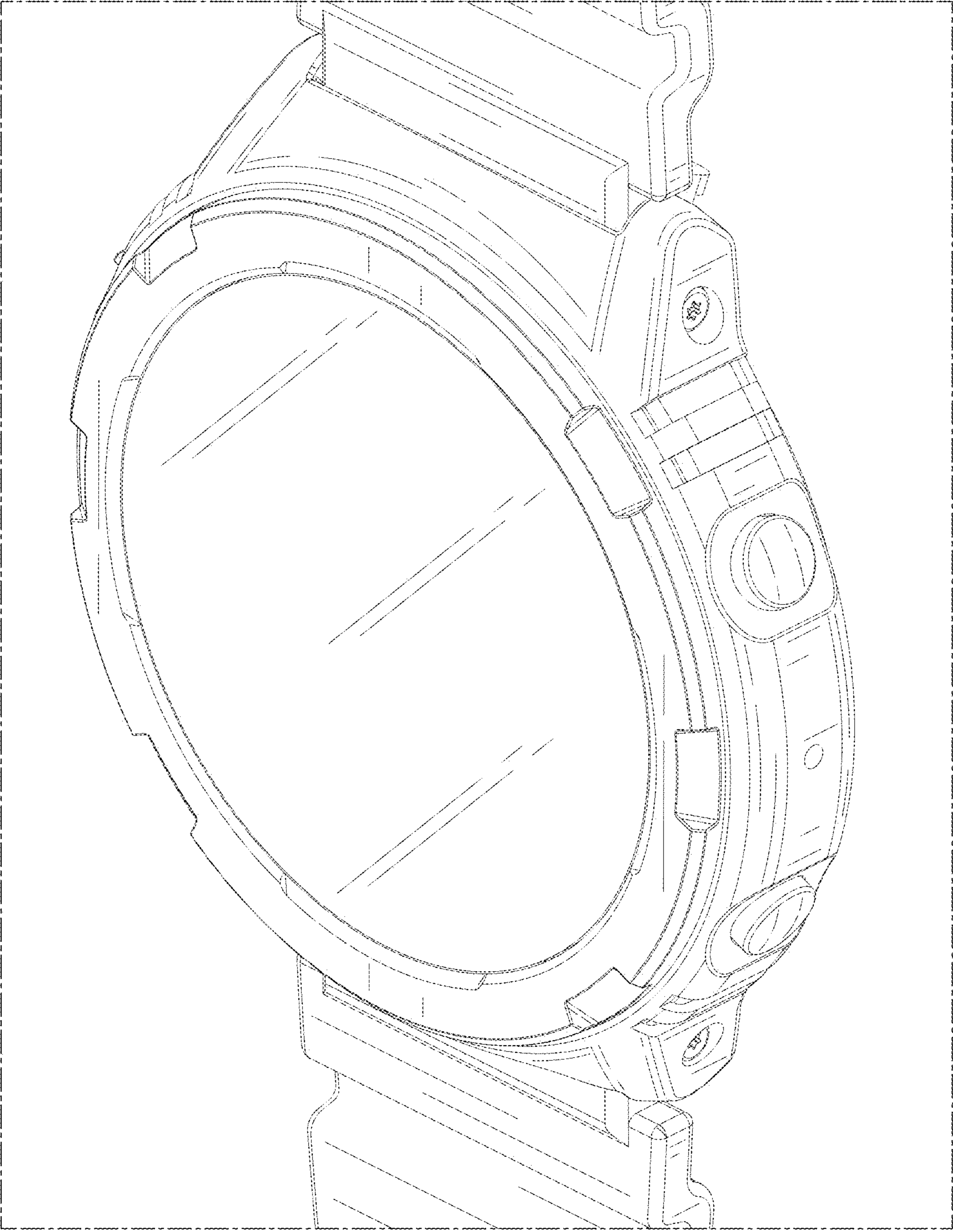

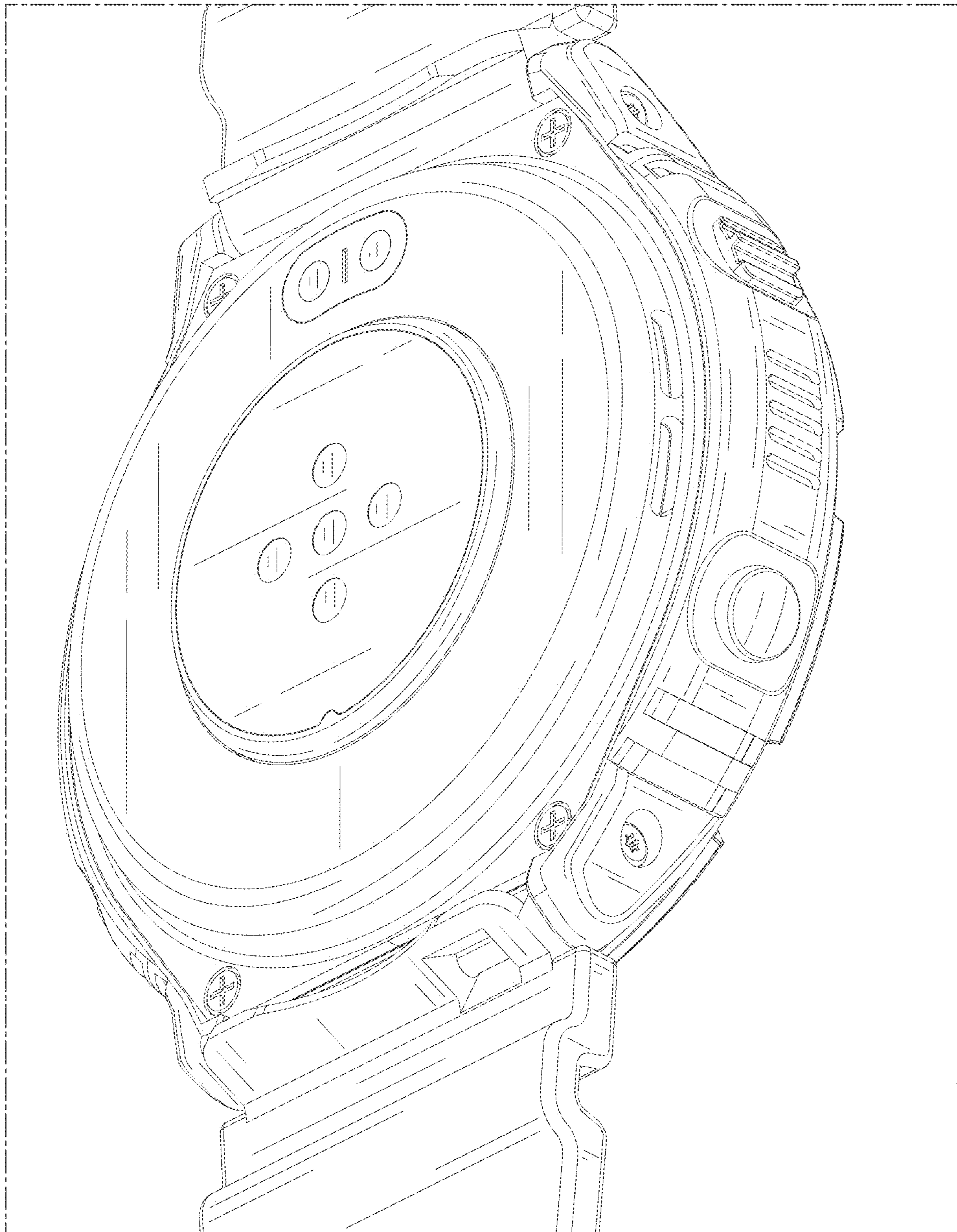
