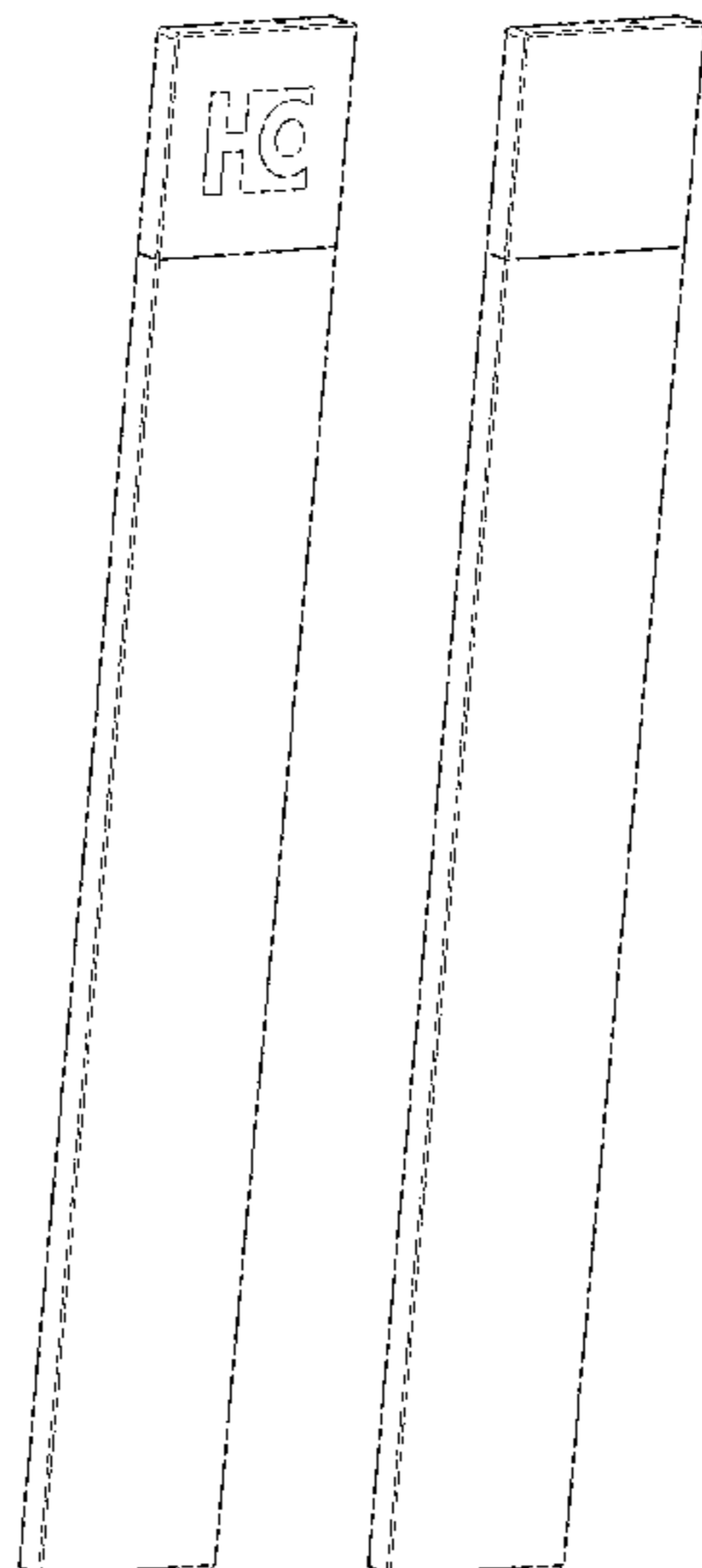
(57) **CLAIM**

The ornamental design for a machine part for a woodworking machine, as shown and described.

**DESCRIPTION**

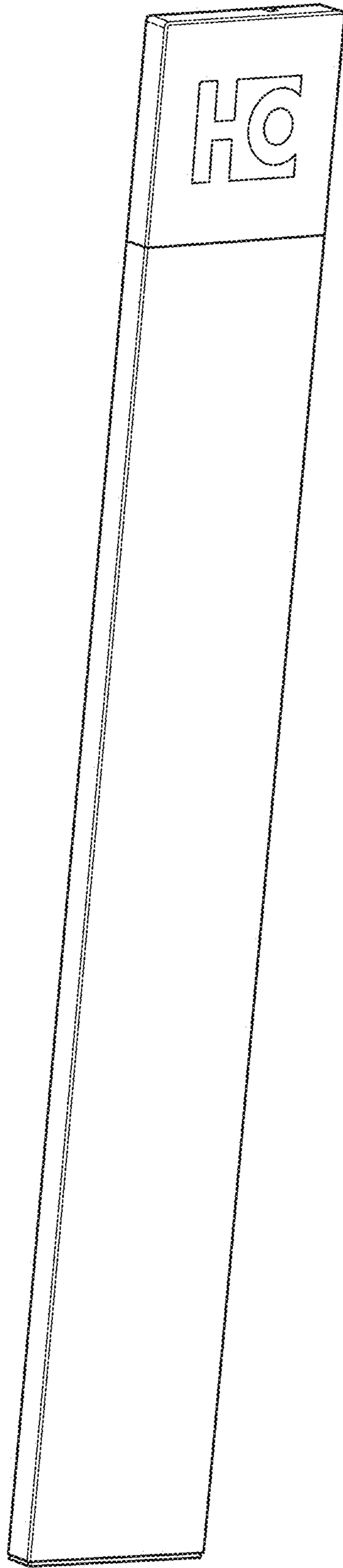

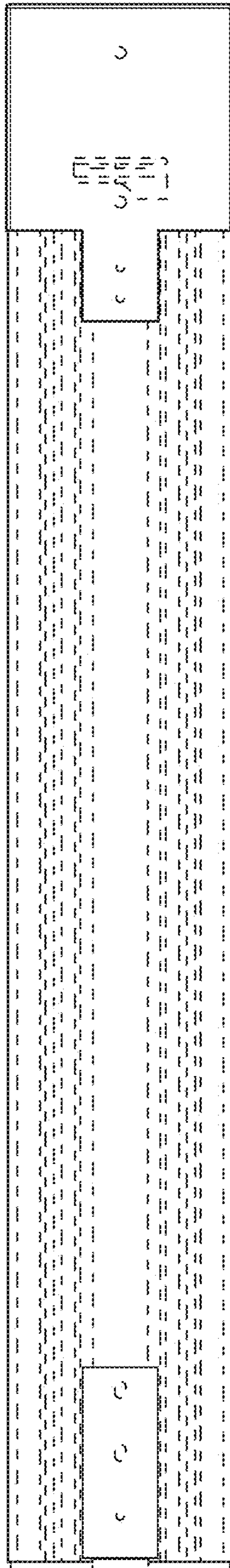

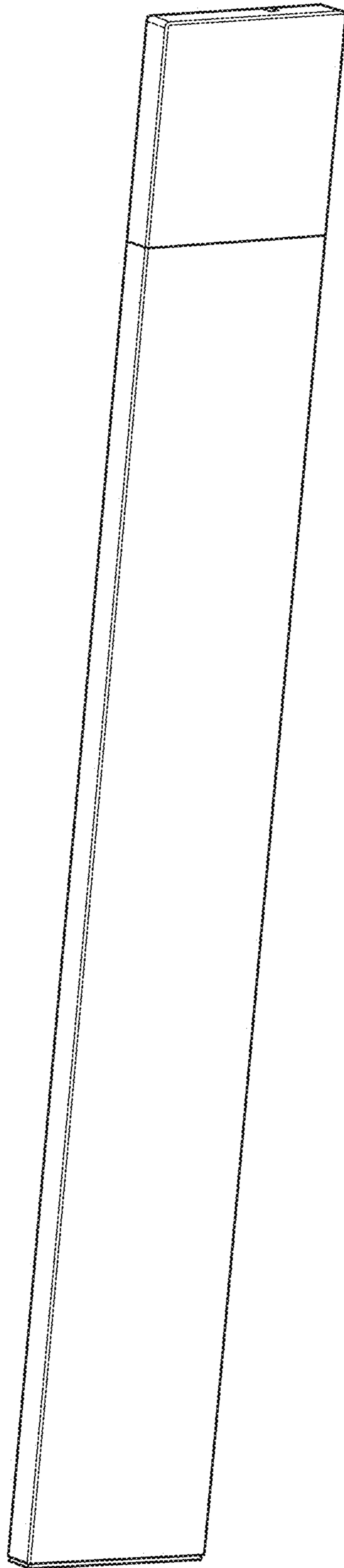

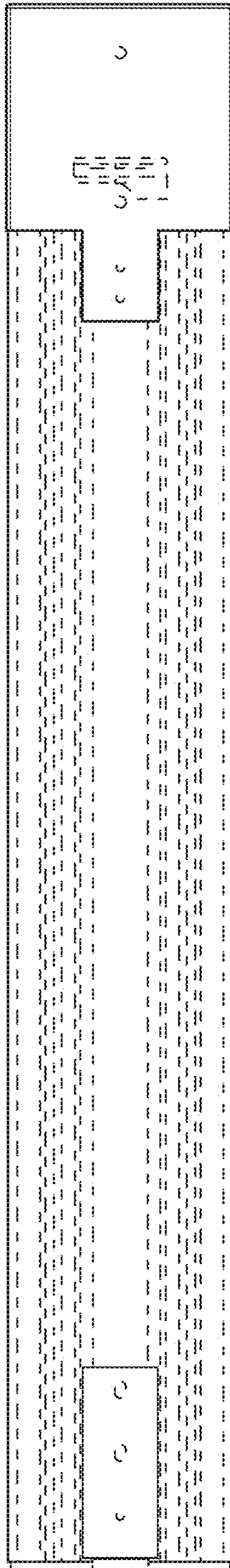
