**DESCRIPTION**

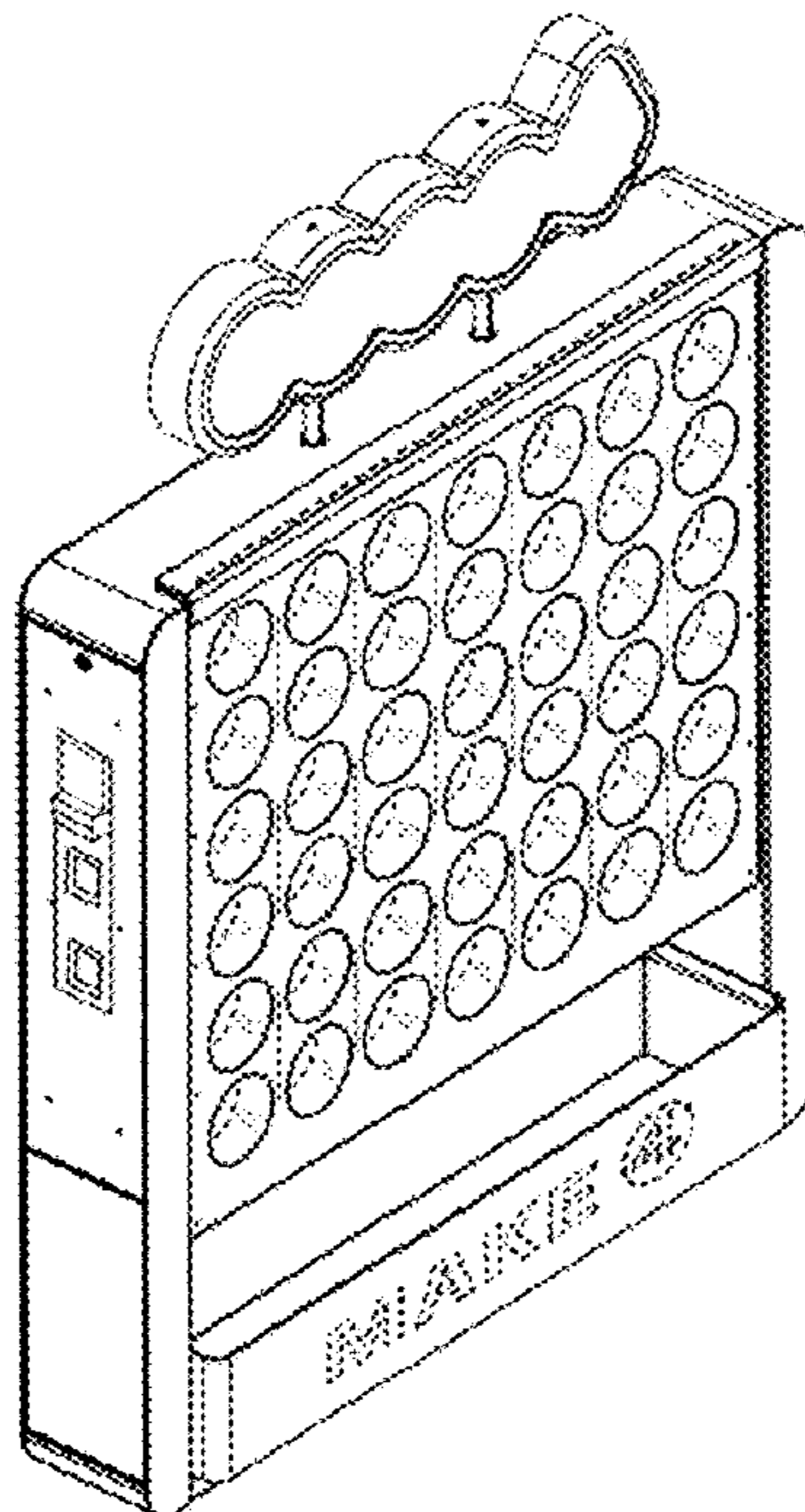
FIG. 1 is a top left front perspective view of a game board showing my new design;

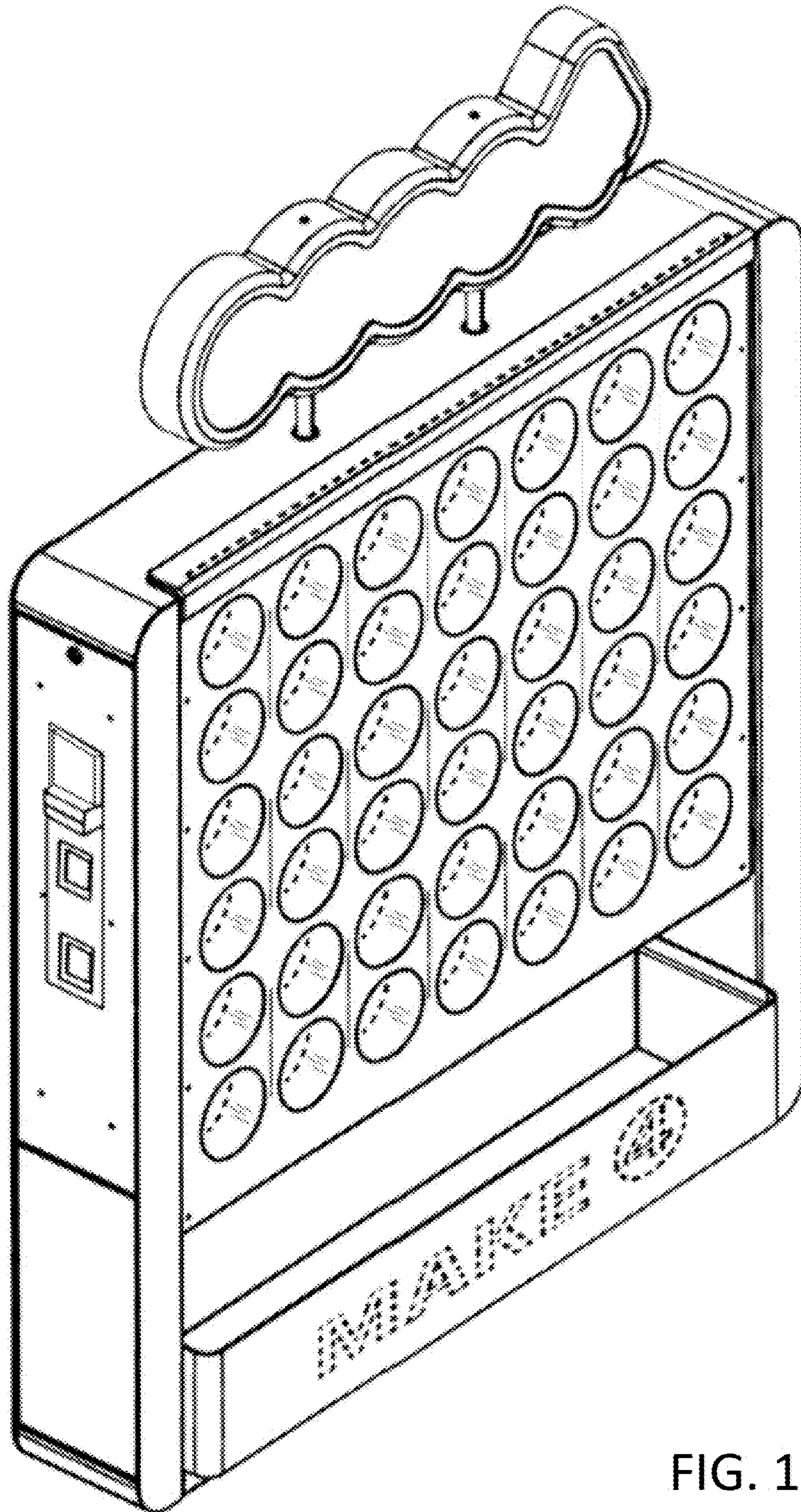

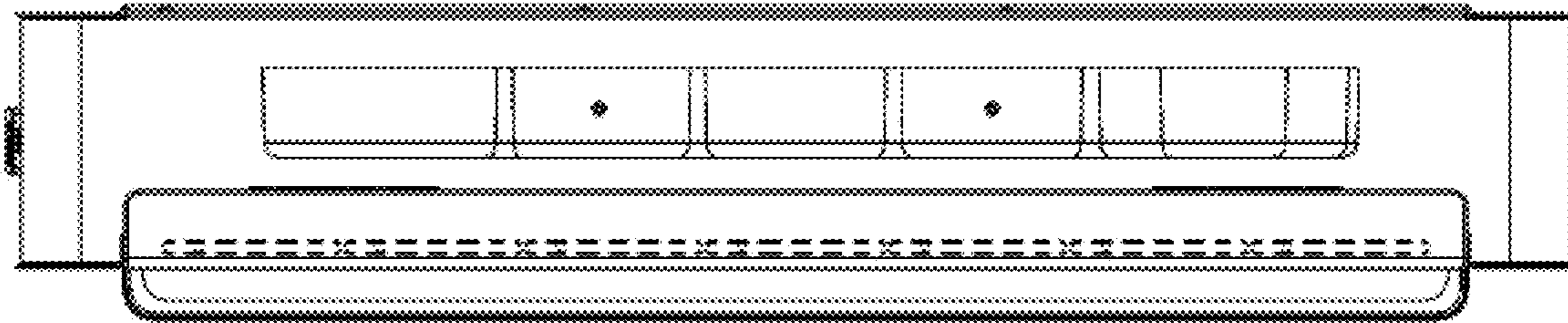

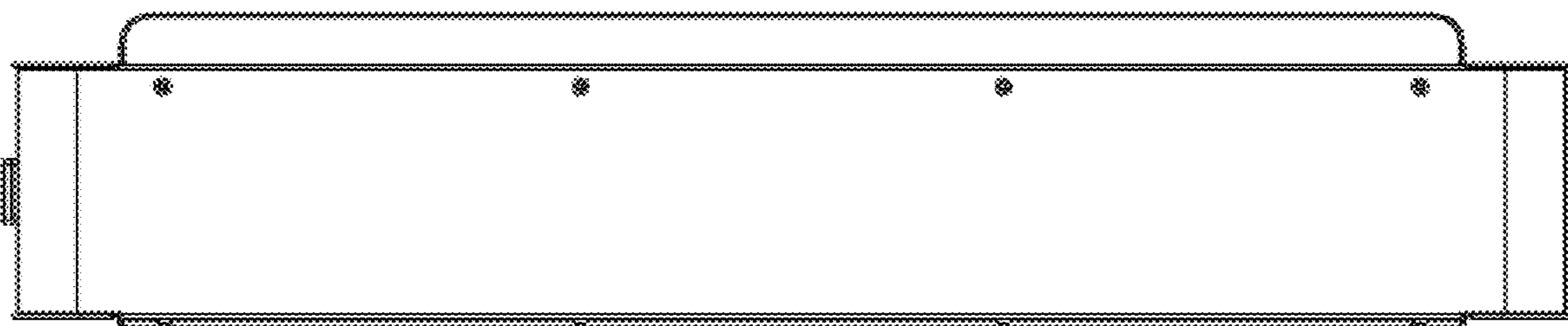

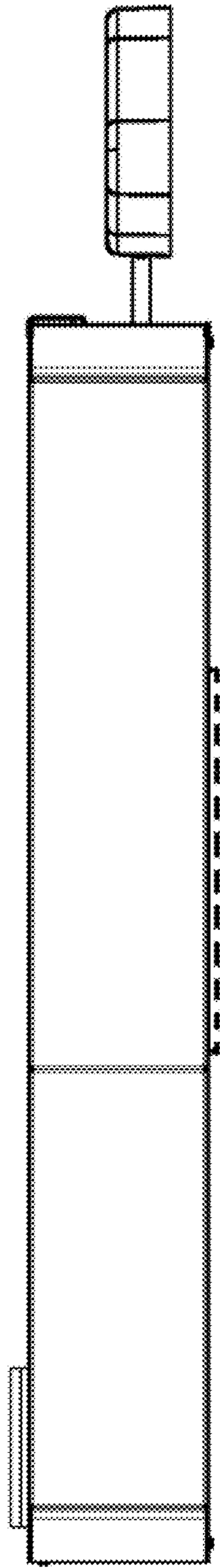

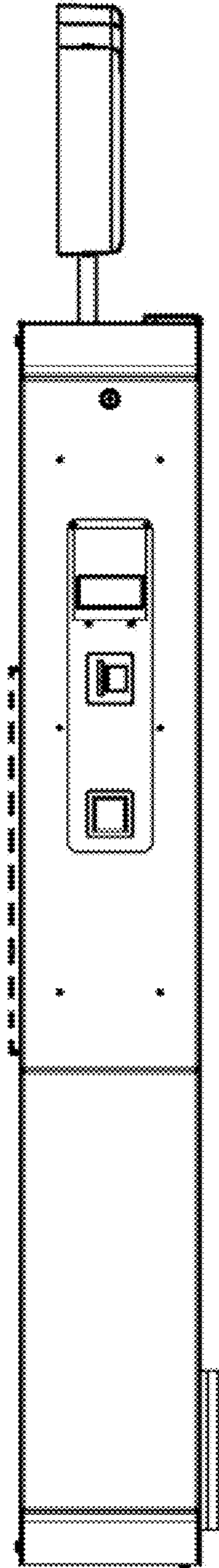

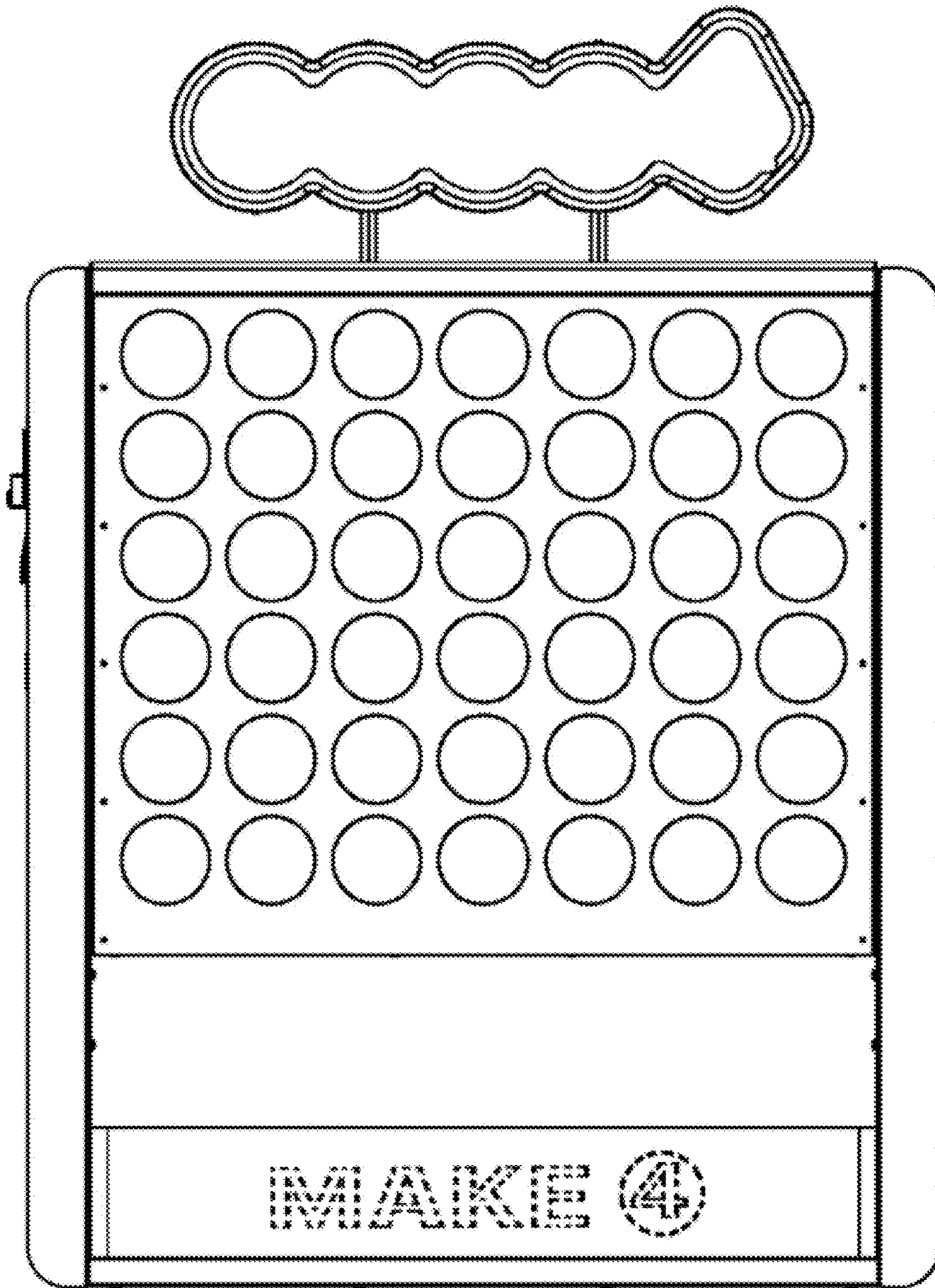

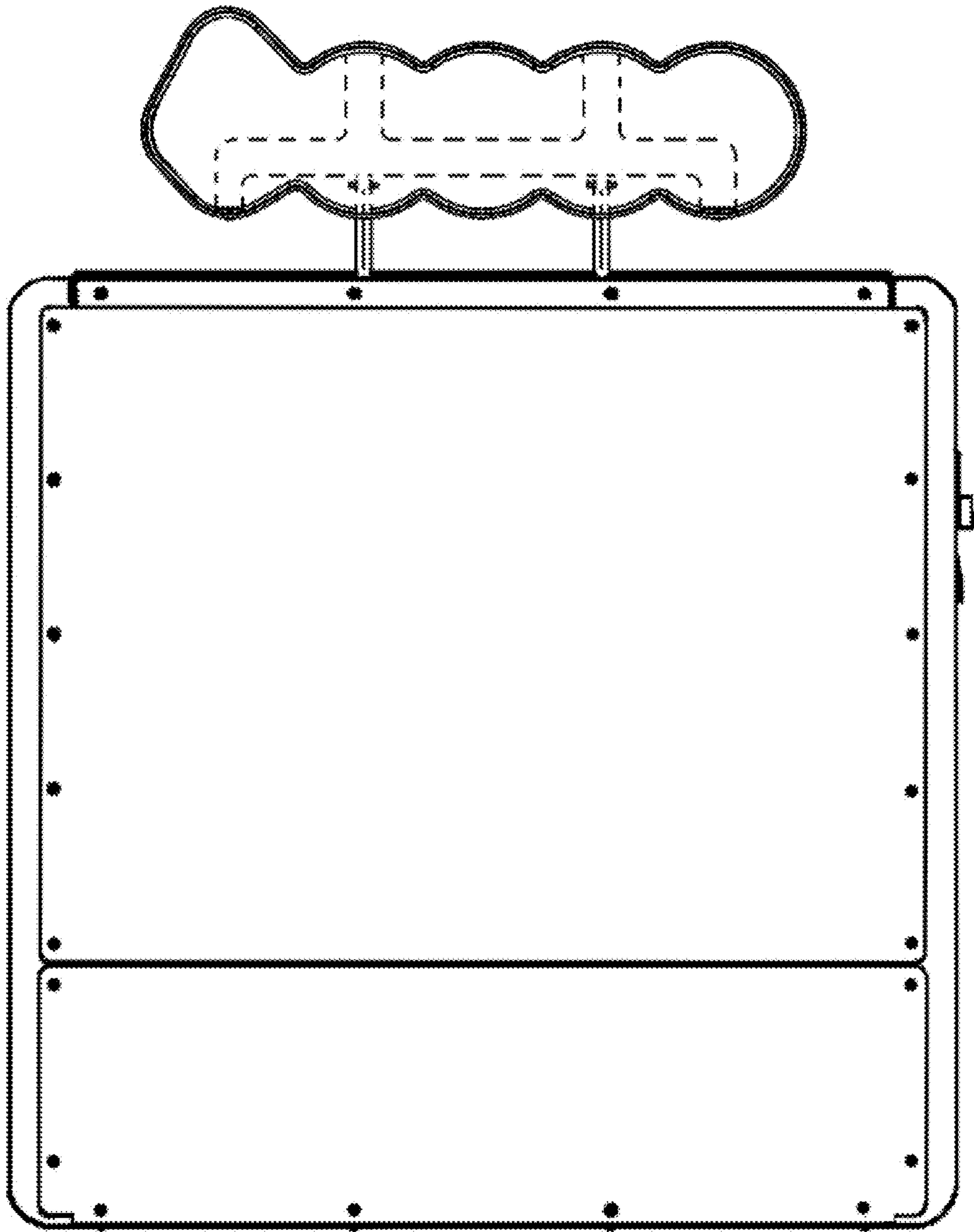
