(57) **CLAIM**

We claim the ornamental design for a gaming machine, as shown and described.

**DESCRIPTION**

FIG. 3 is a back view of the gaming machine shown in FIG. 1;

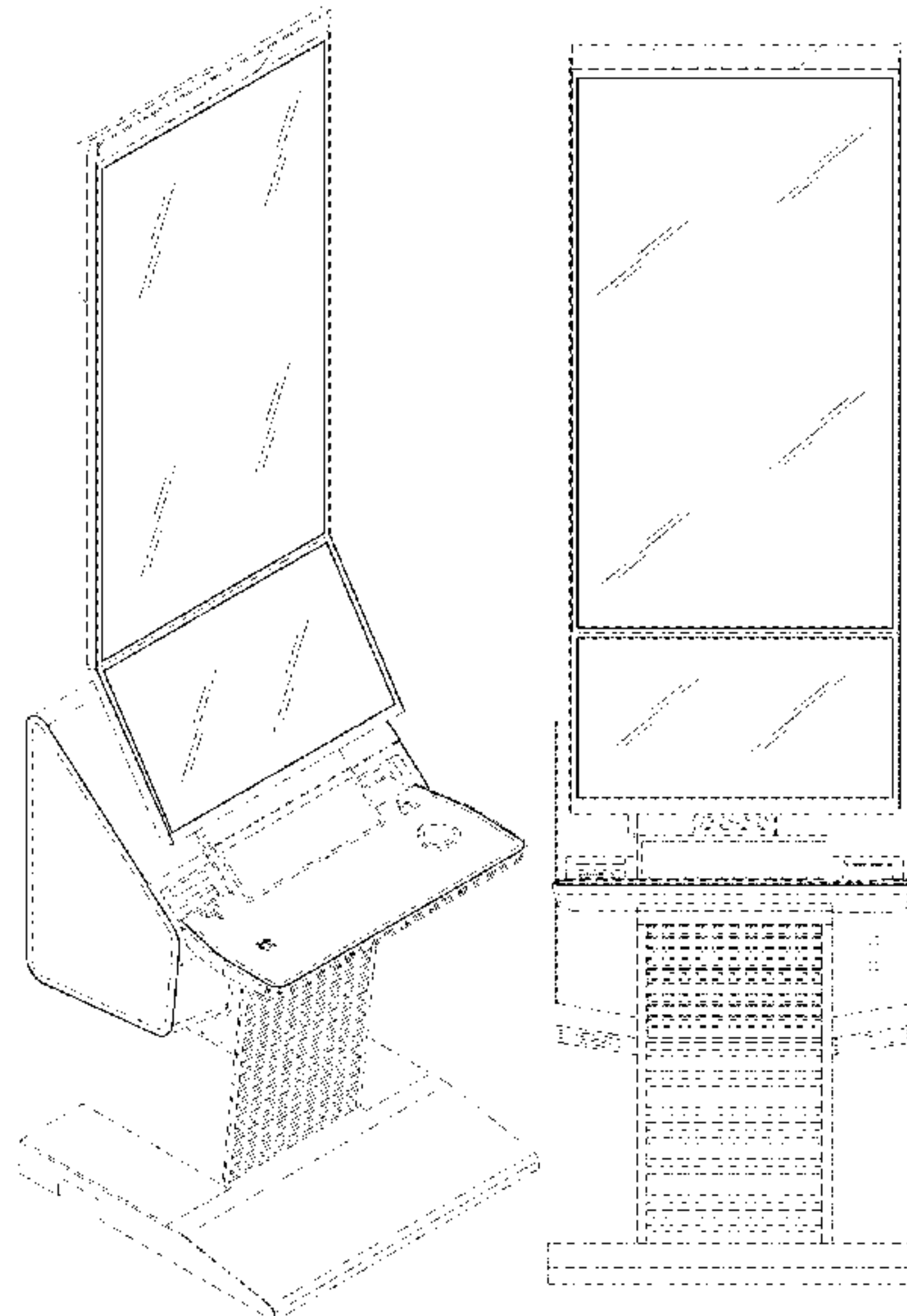
FIG. 4 is a right side view of the gaming machine shown in FIG. 1;

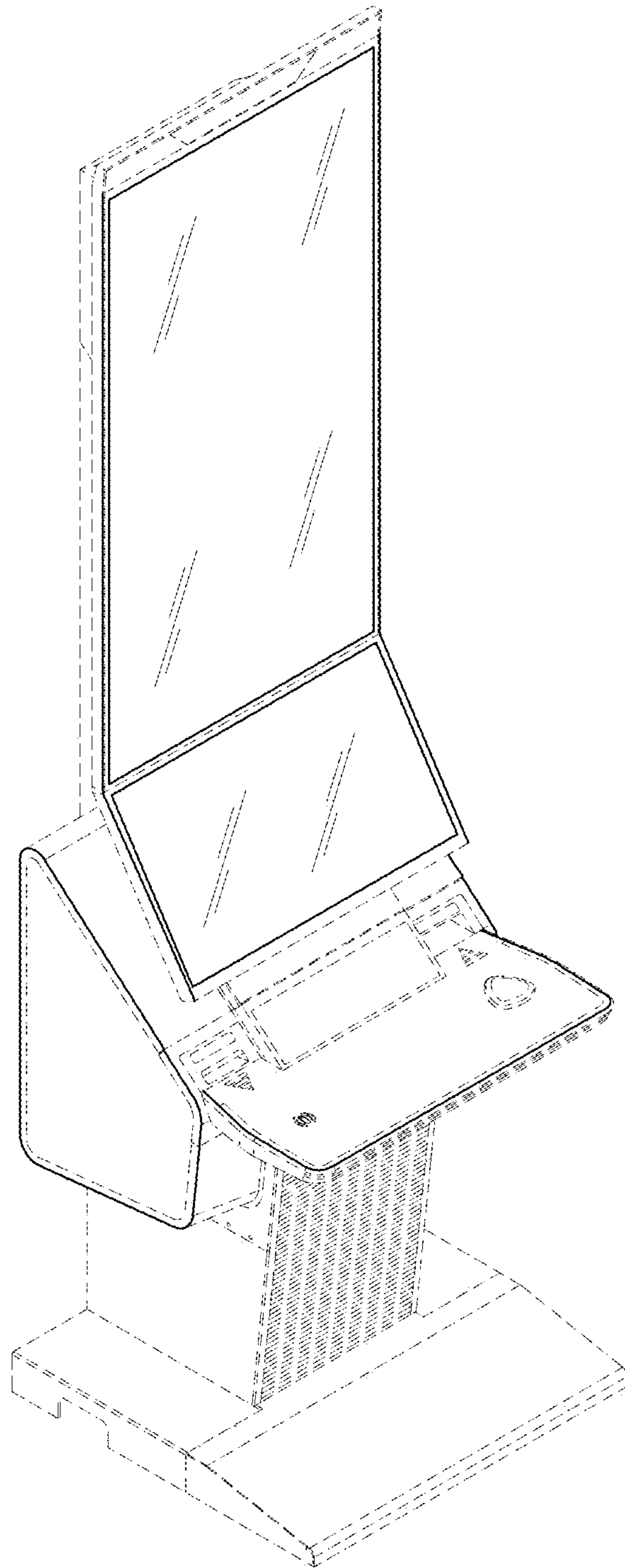

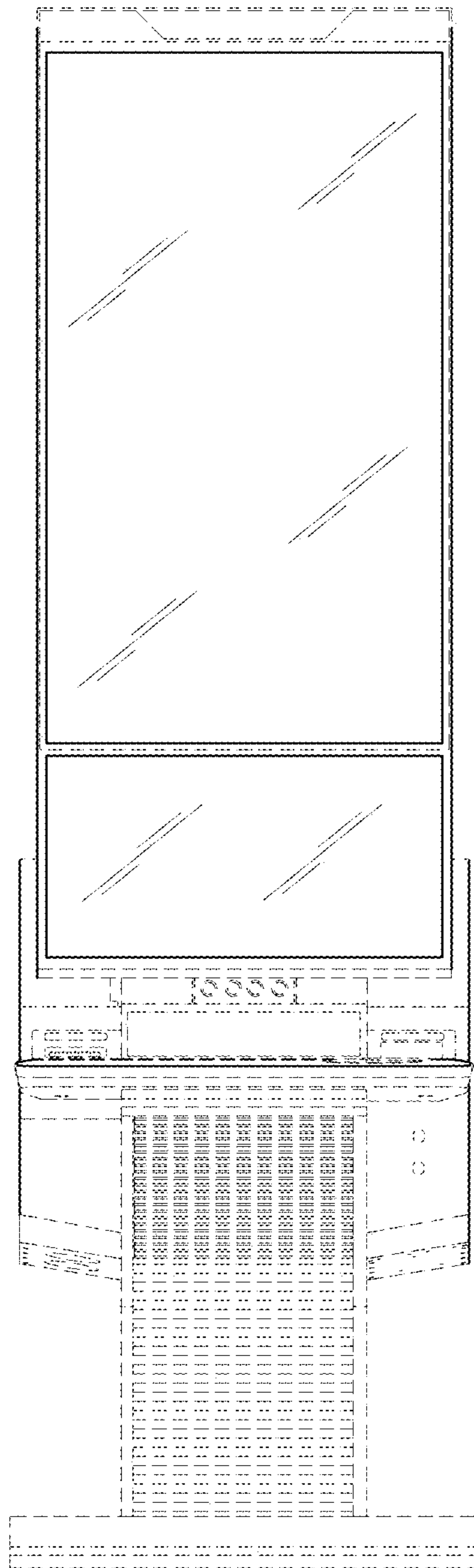

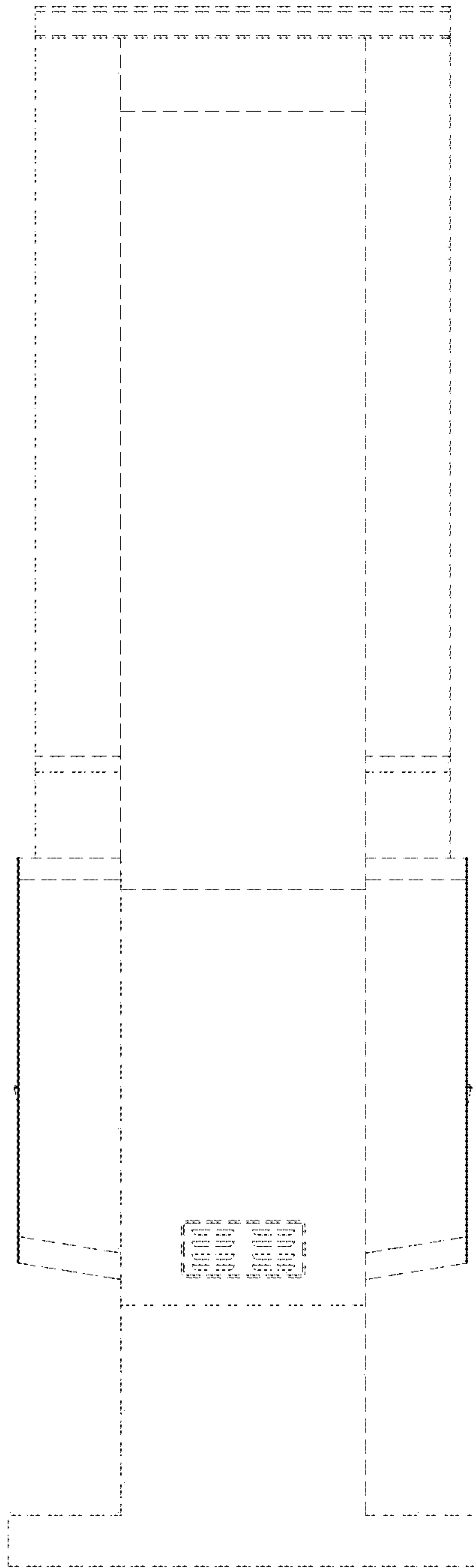

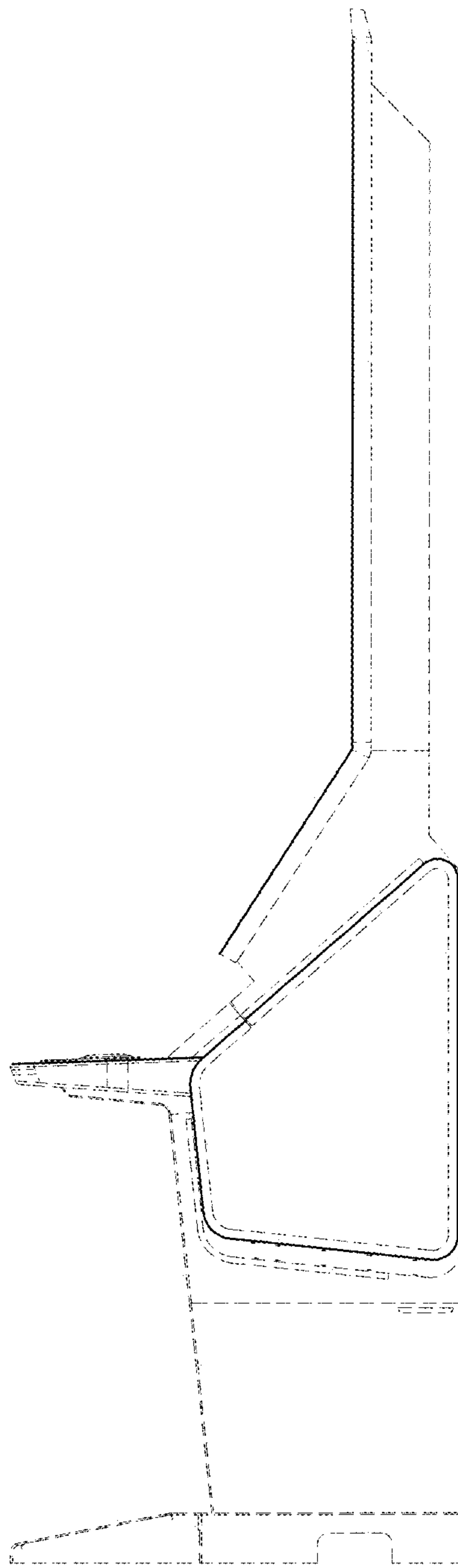

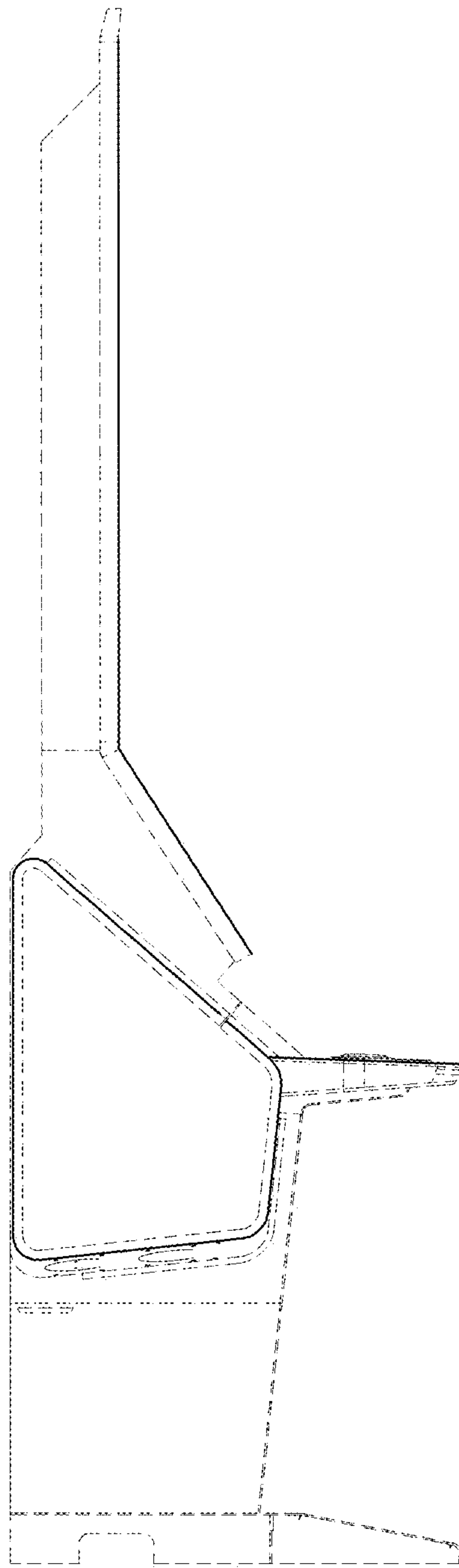

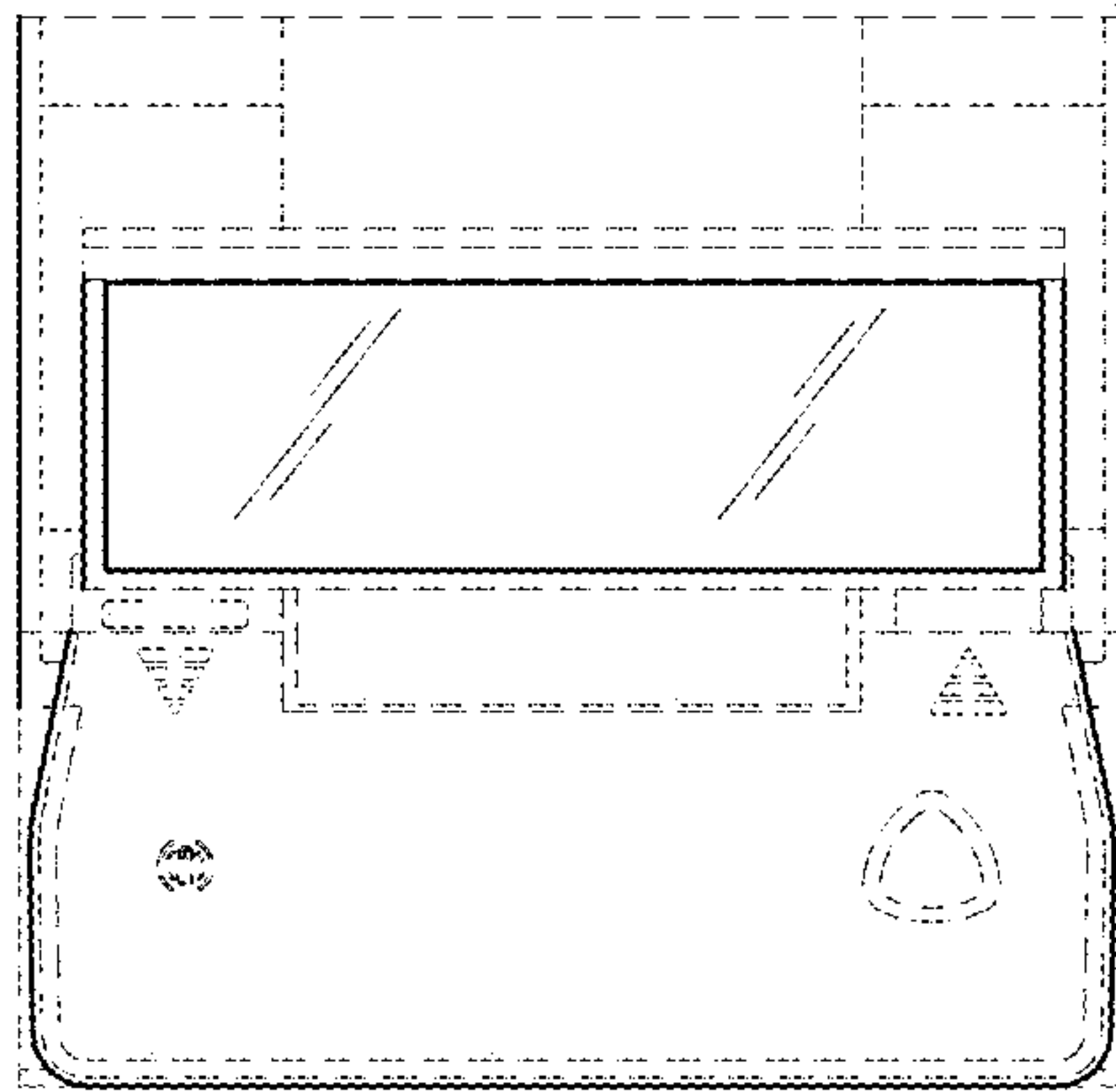
