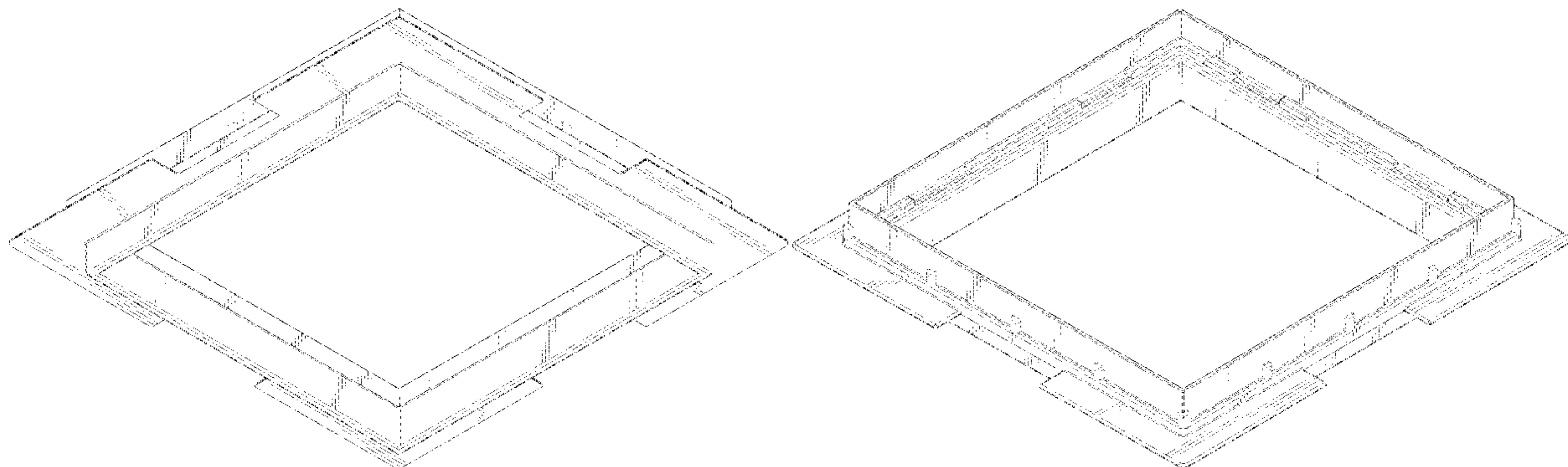
(57) **CLAIM**

The ornamental design for a square drain extension, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a square drain extension, showing our new design;
FIG. 2 is a back side elevation view thereof; the front, right and left sides being an identical image;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom perspective view thereof; and,
FIG. 5 is a top perspective view thereof.

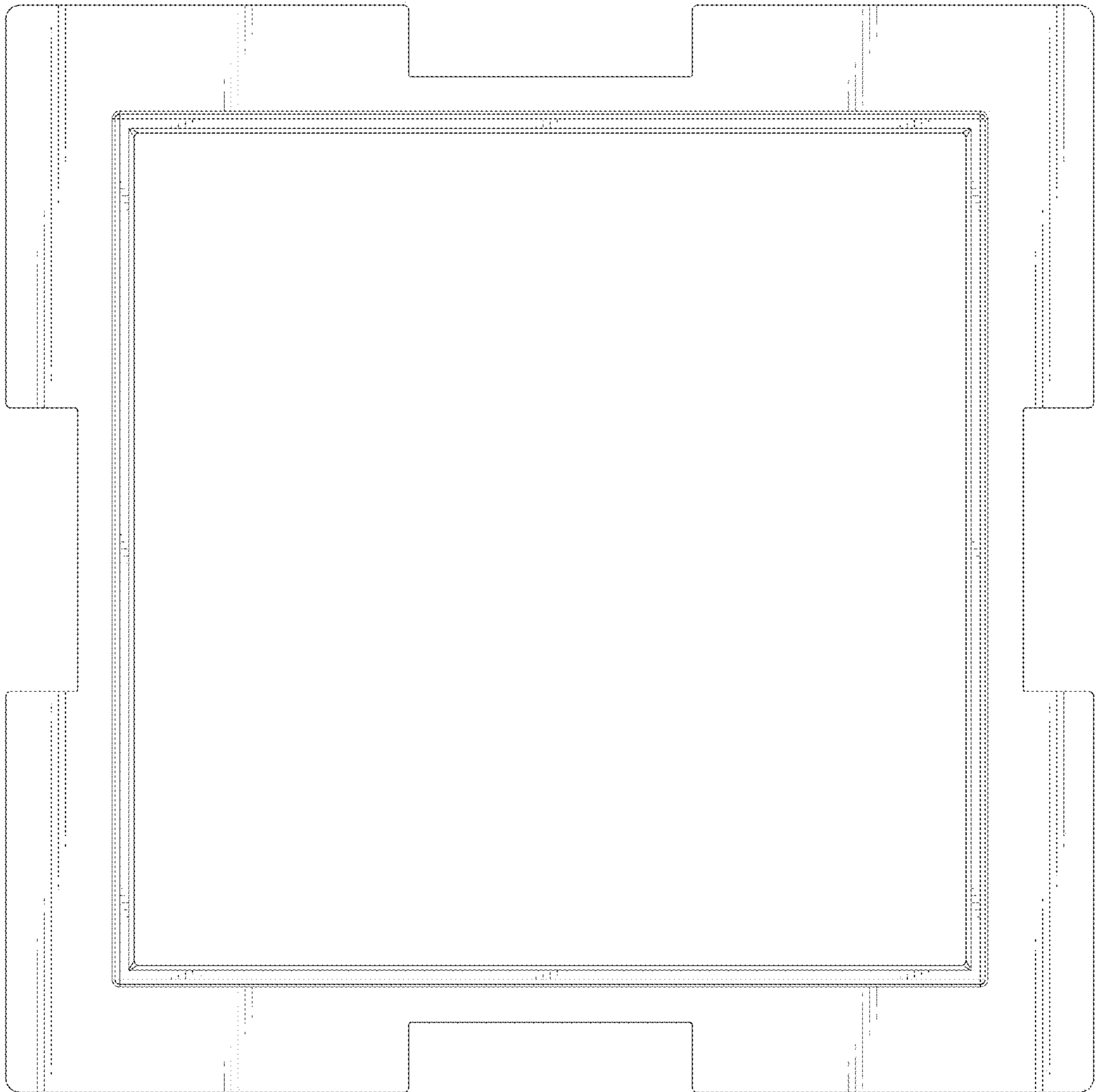

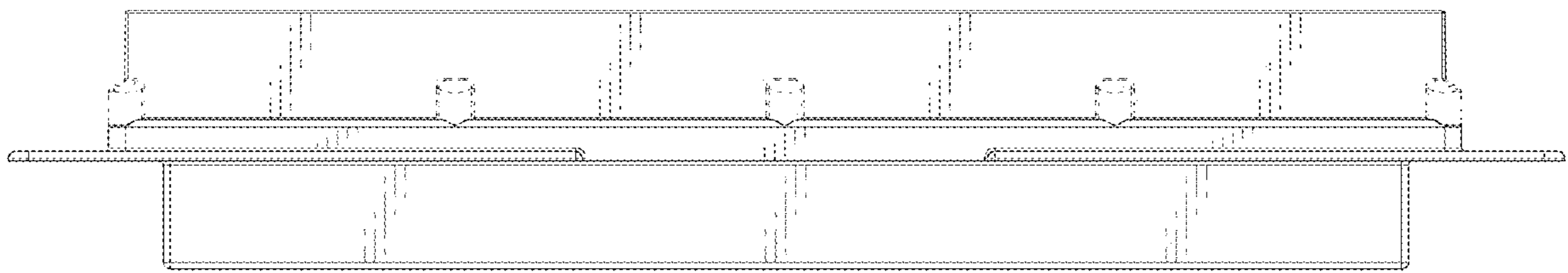

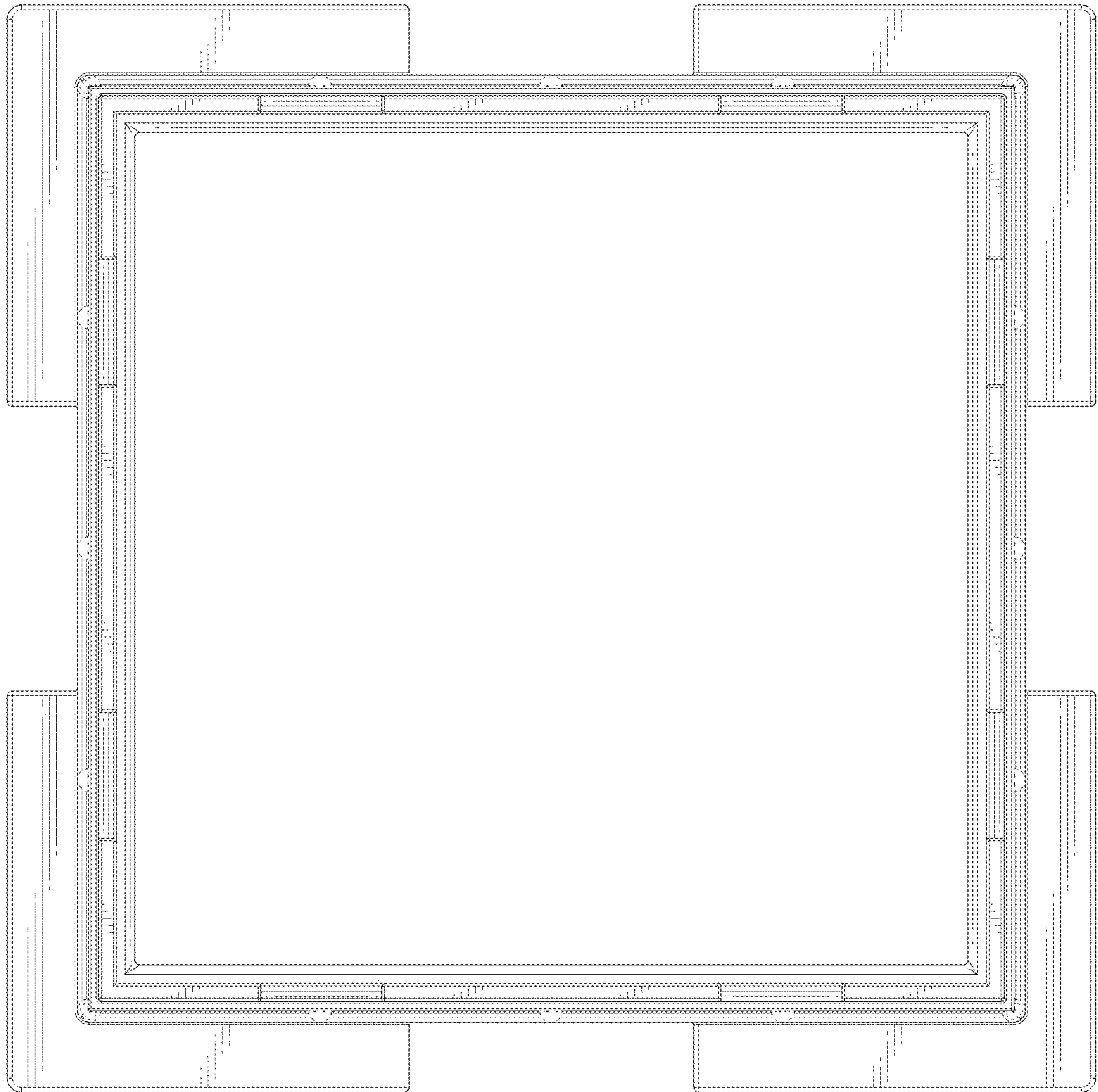

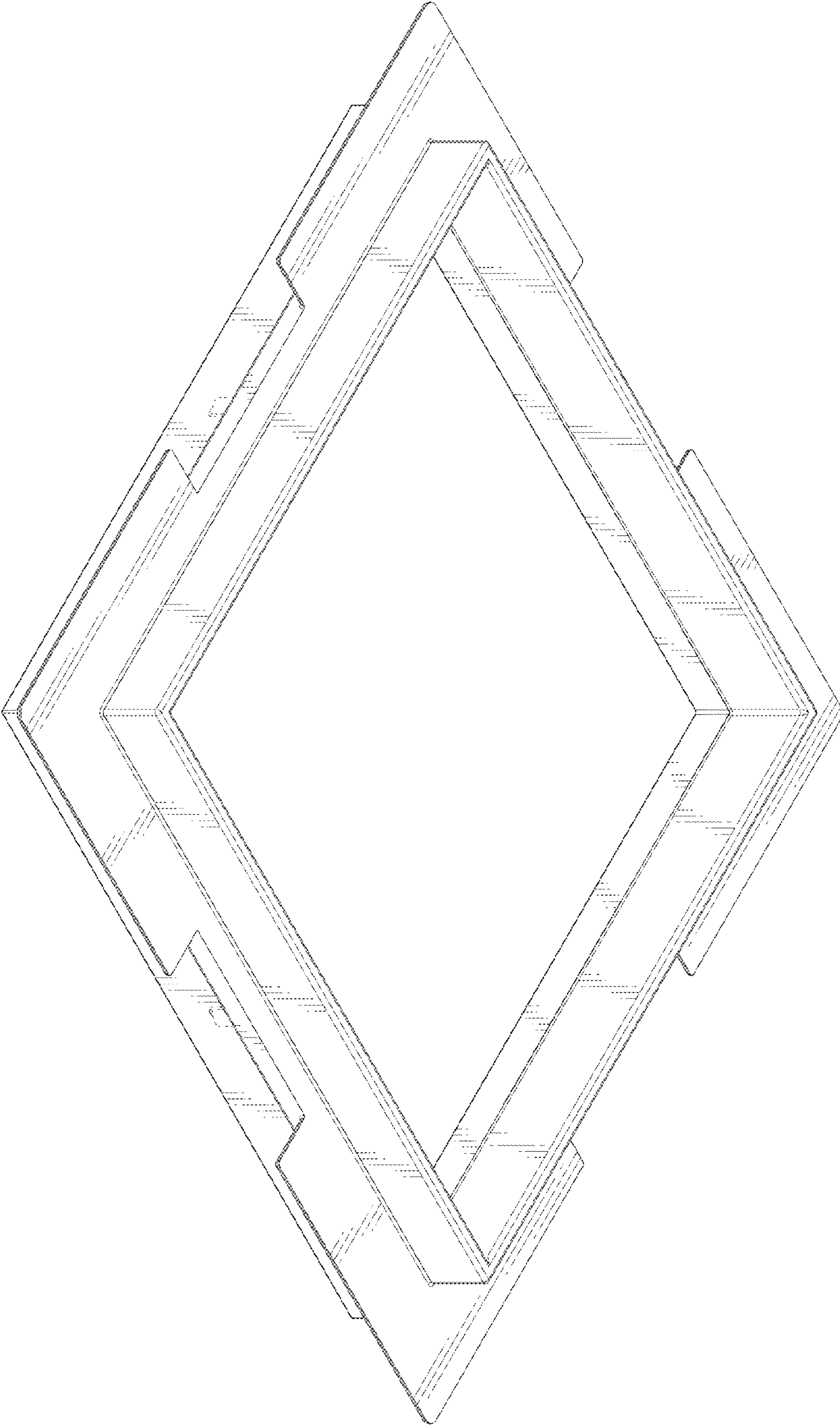

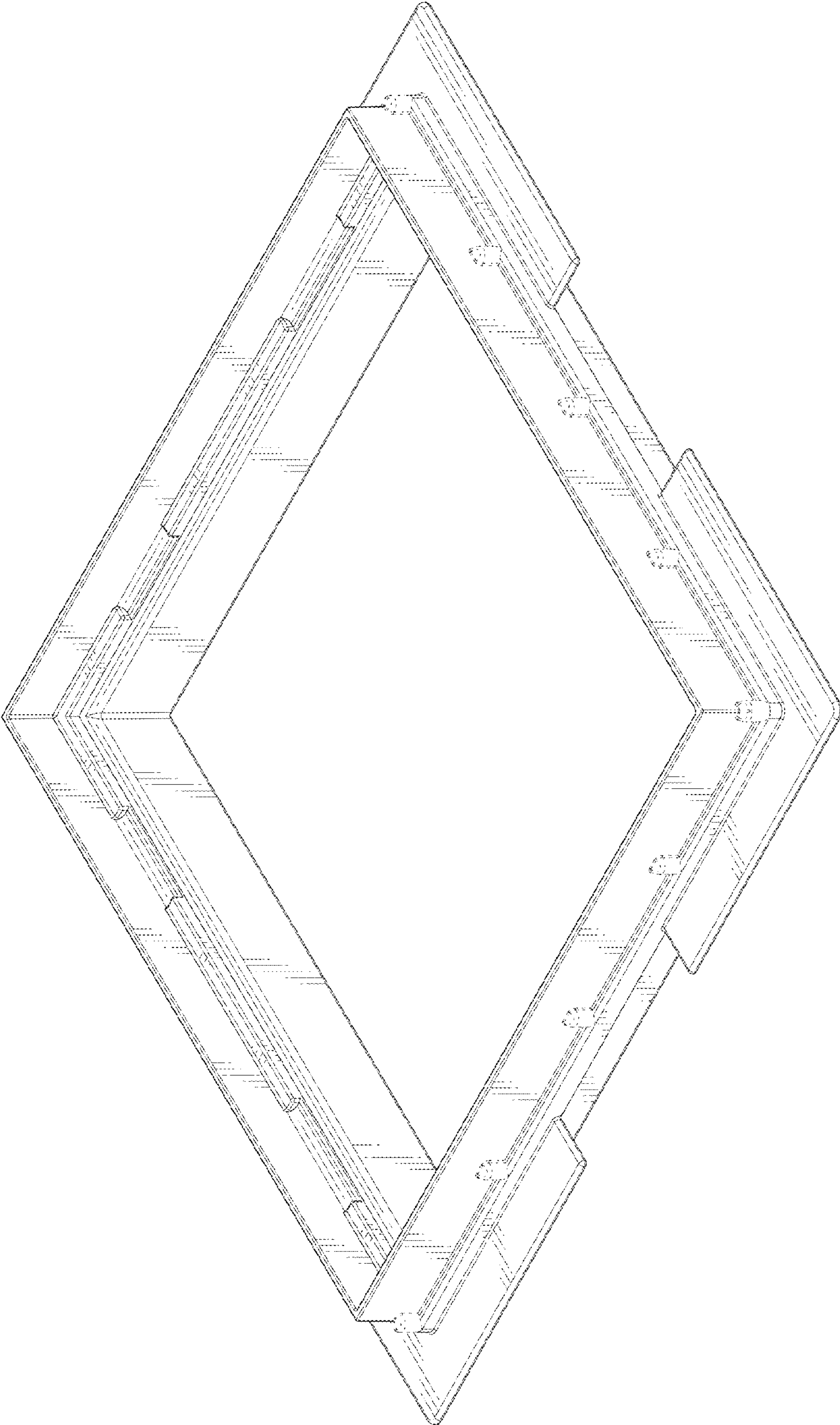
