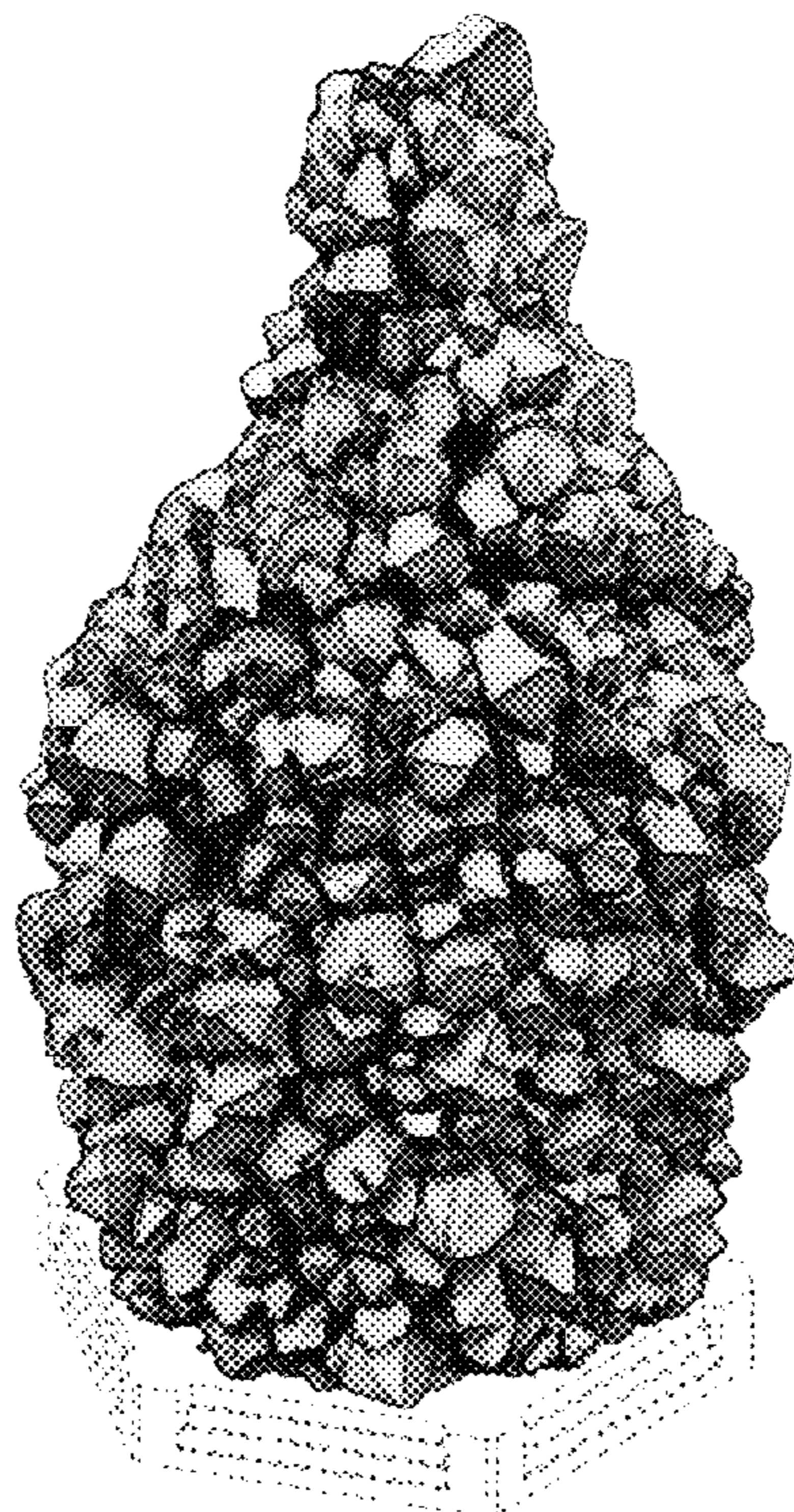
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the diffuser topper;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a third perspective view thereof;
FIG. 4 is a fourth perspective view thereof;
FIG. 5 is a perspective view similar to FIG. 1, without a
diffuser base;
FIG. 6 is a perspective view similar to FIG. 2, without the

diffuser base; and,
FIG. 8 is a perspective view similar to FIG. 4, without the
diffuser base.

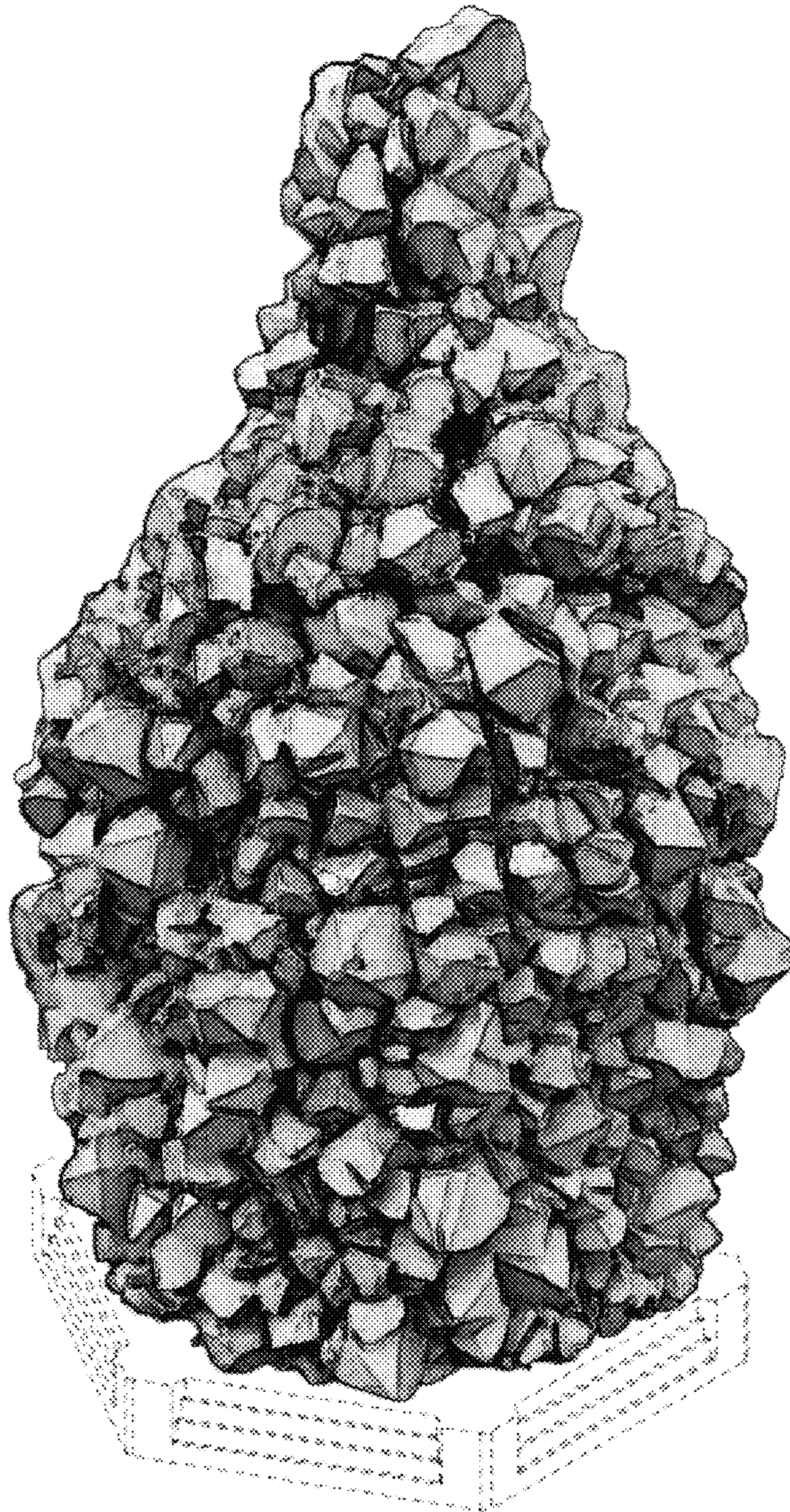

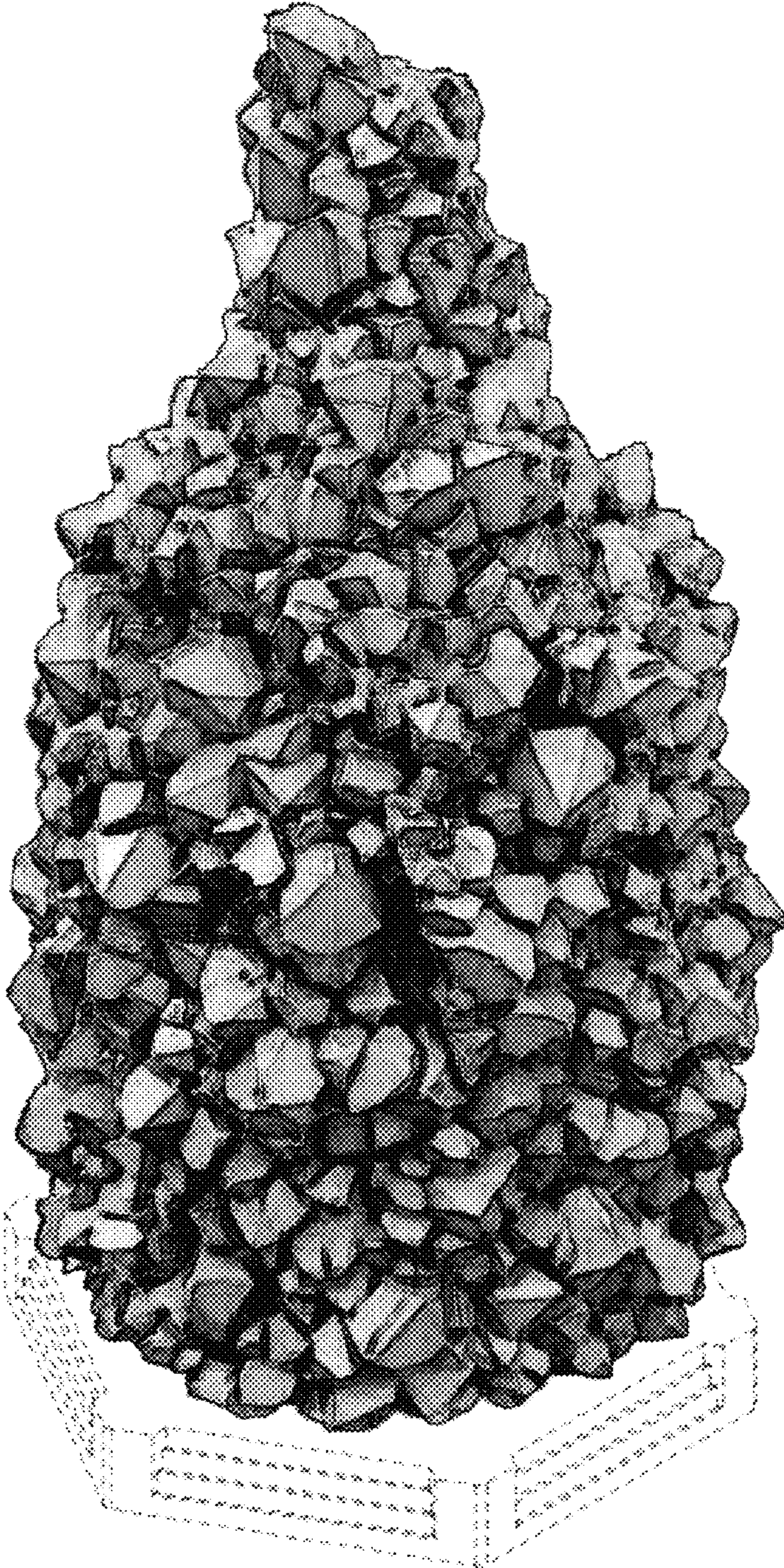

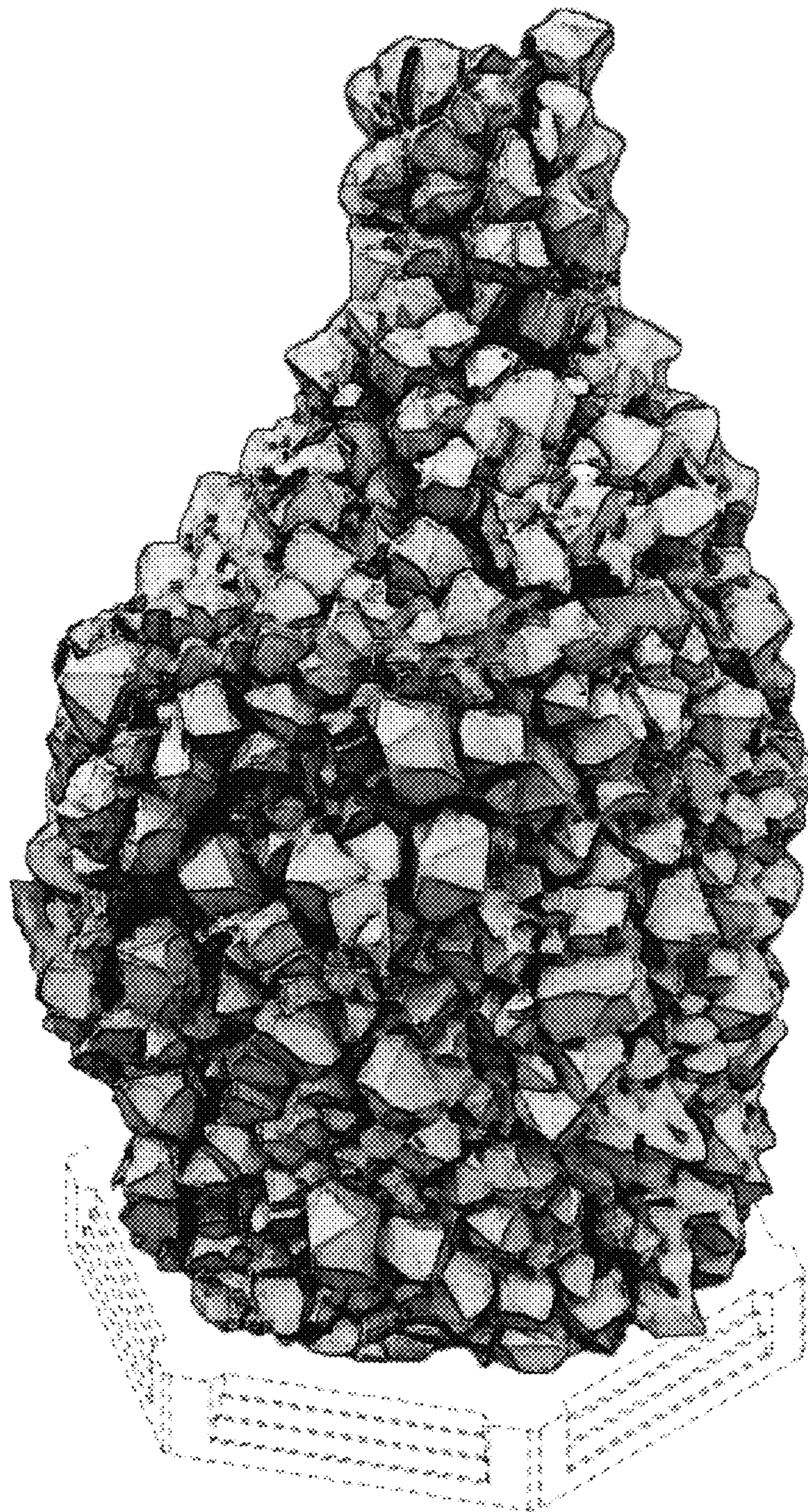

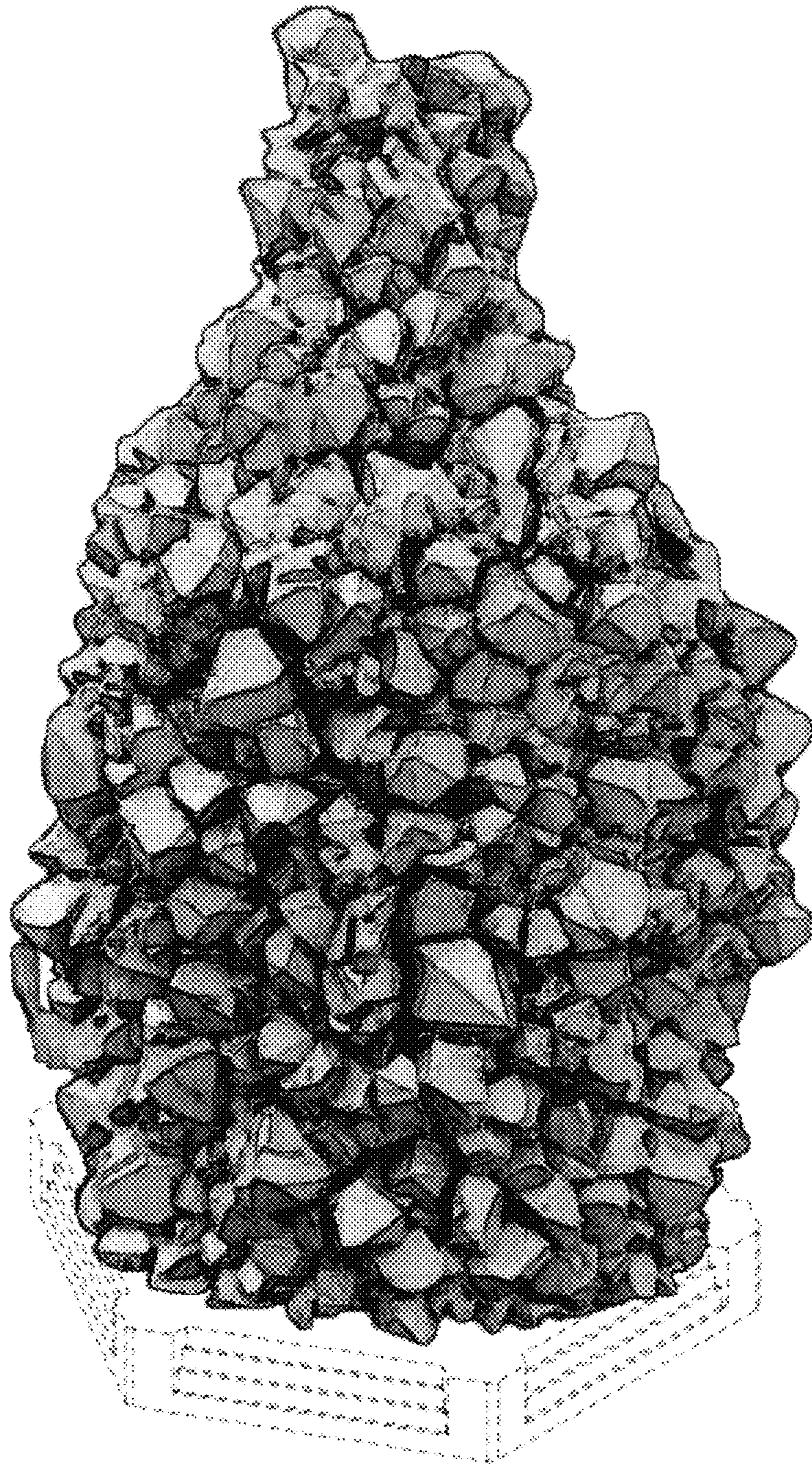

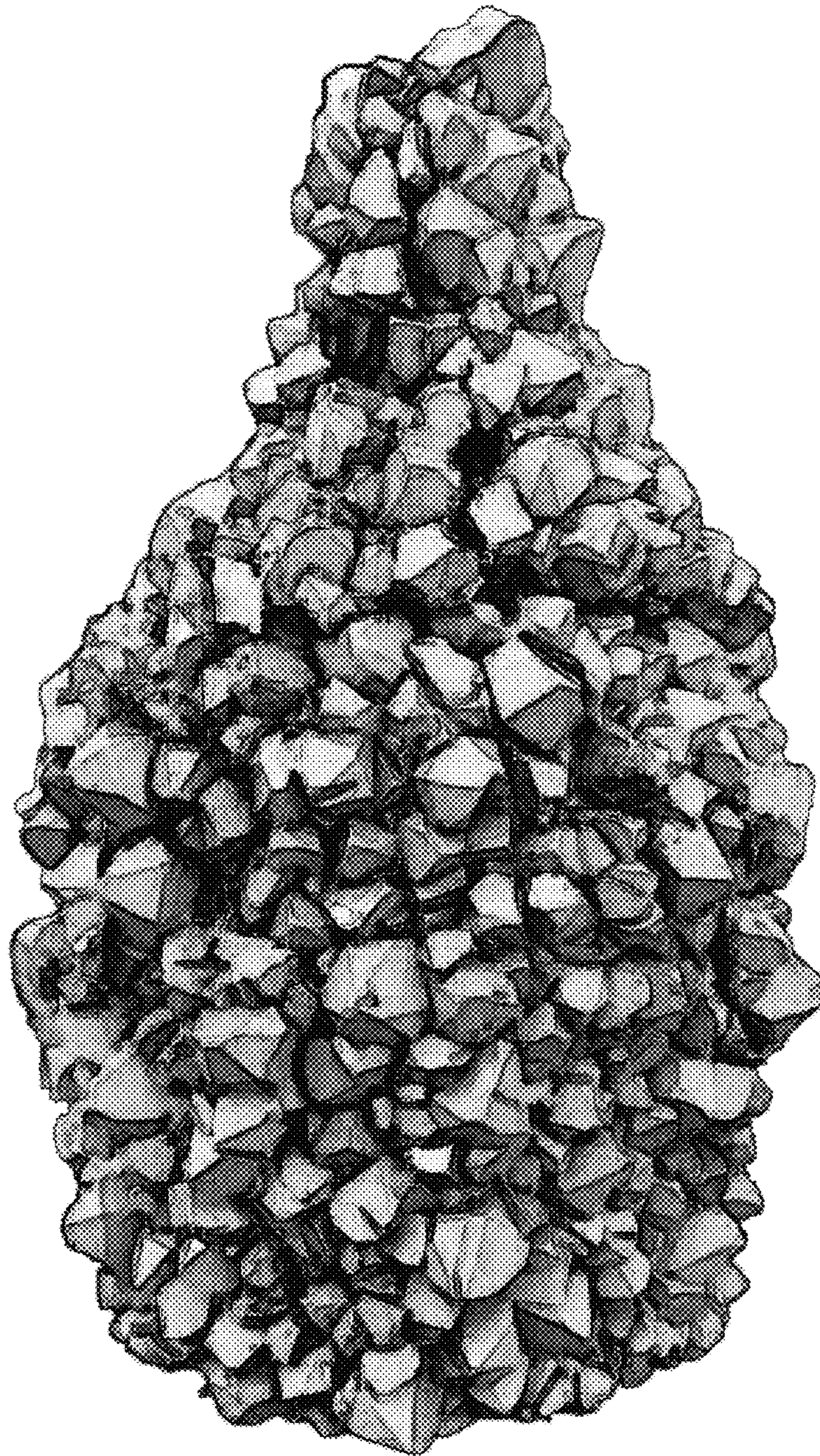

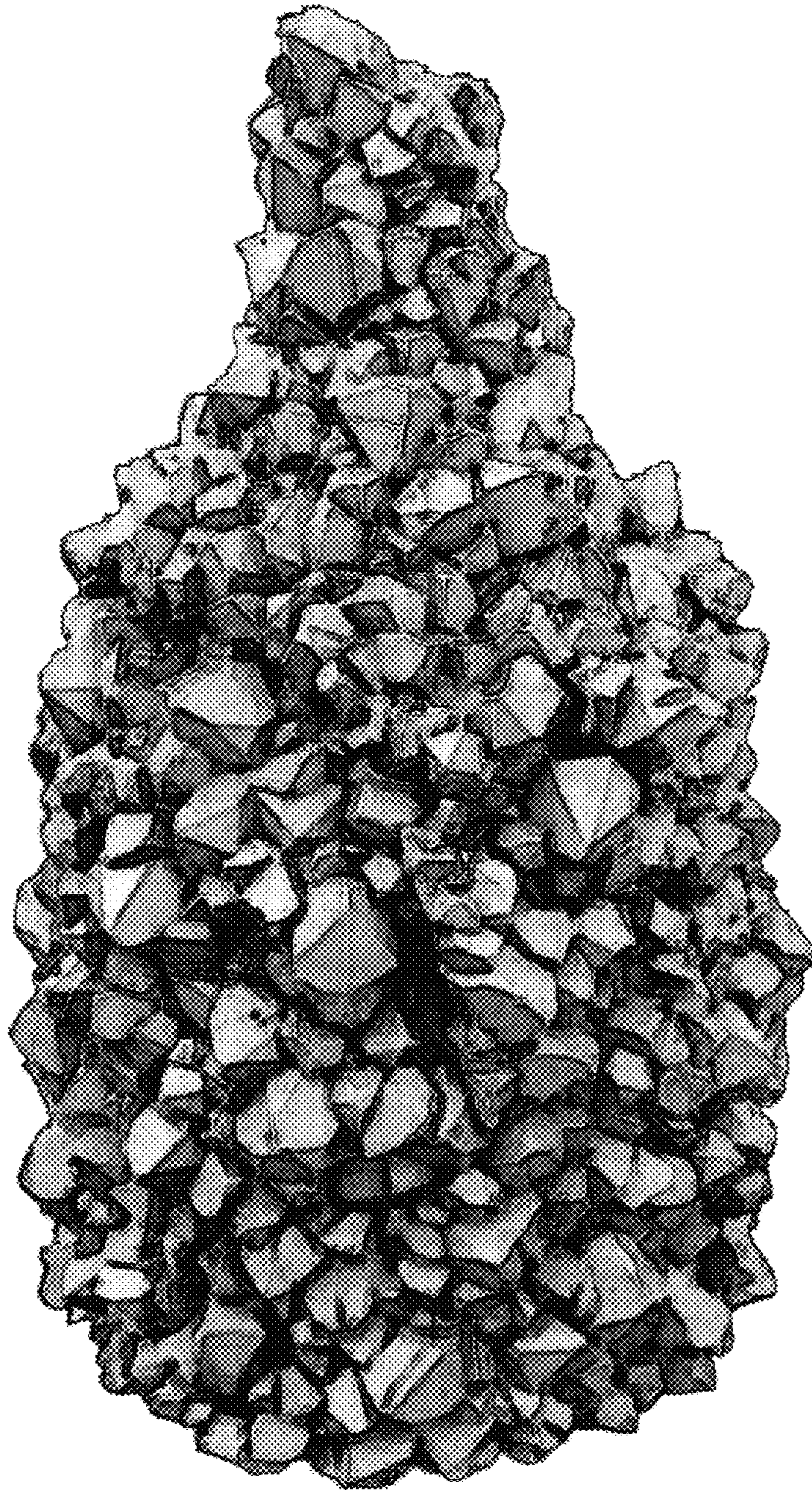

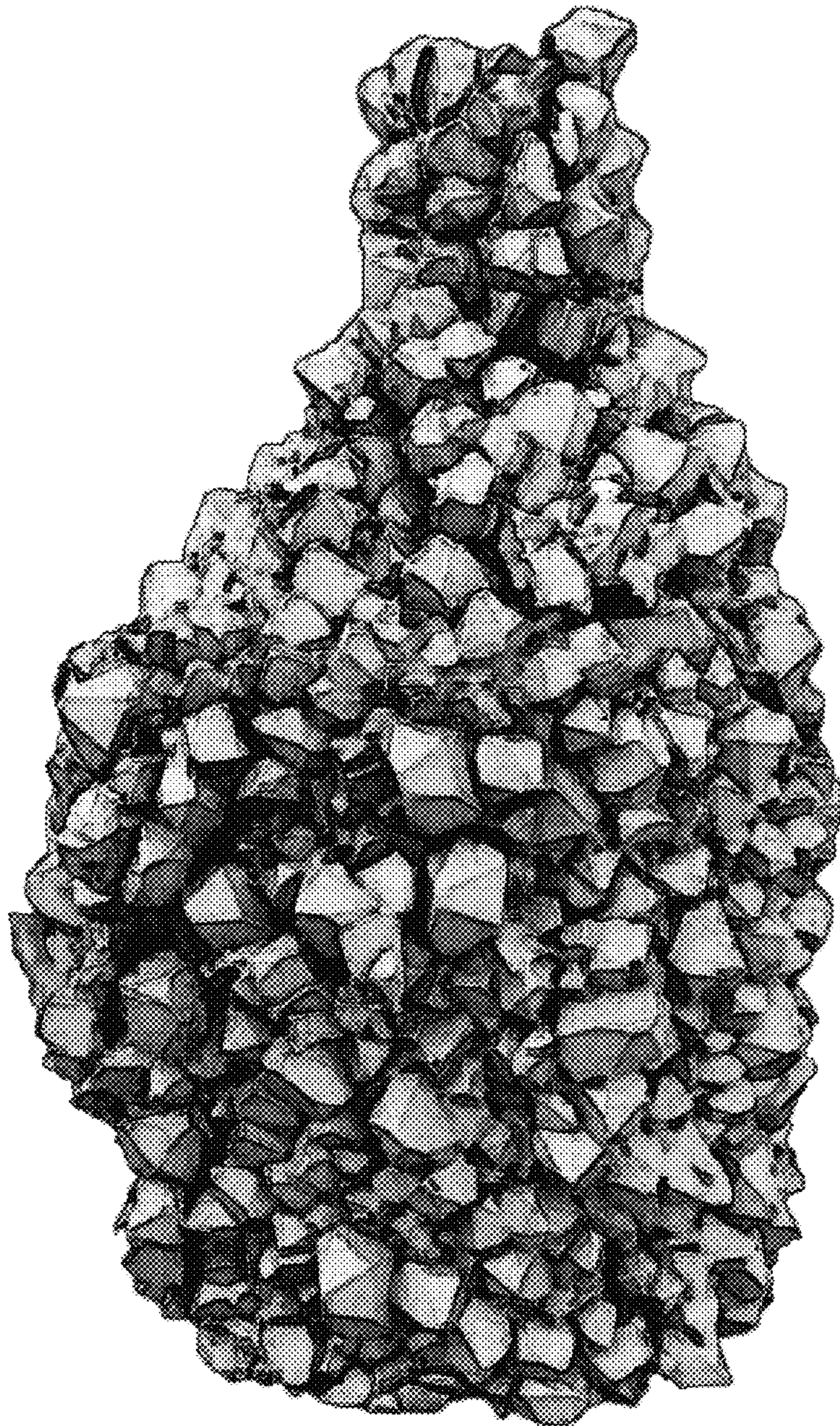

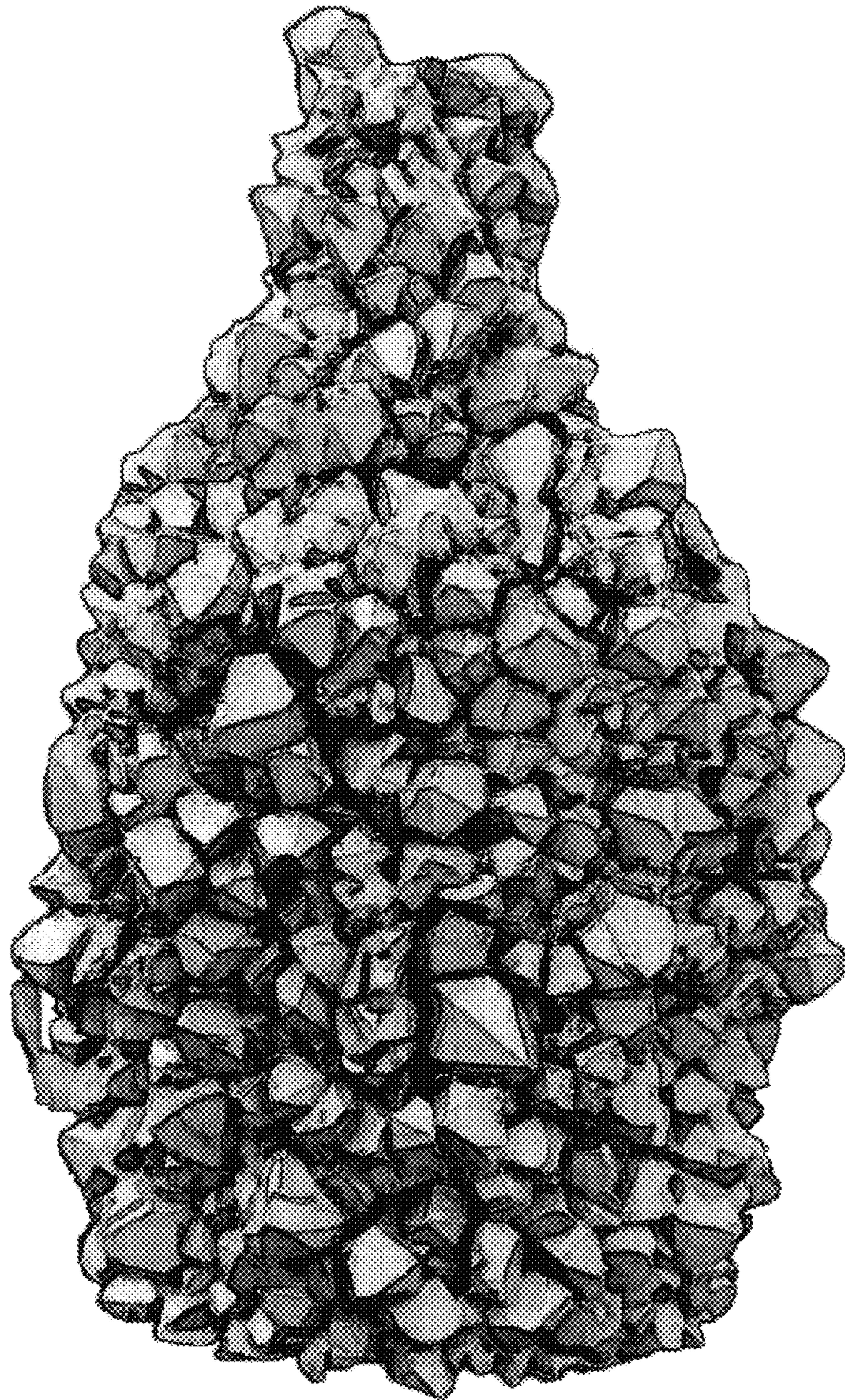
