DESCRIPTION

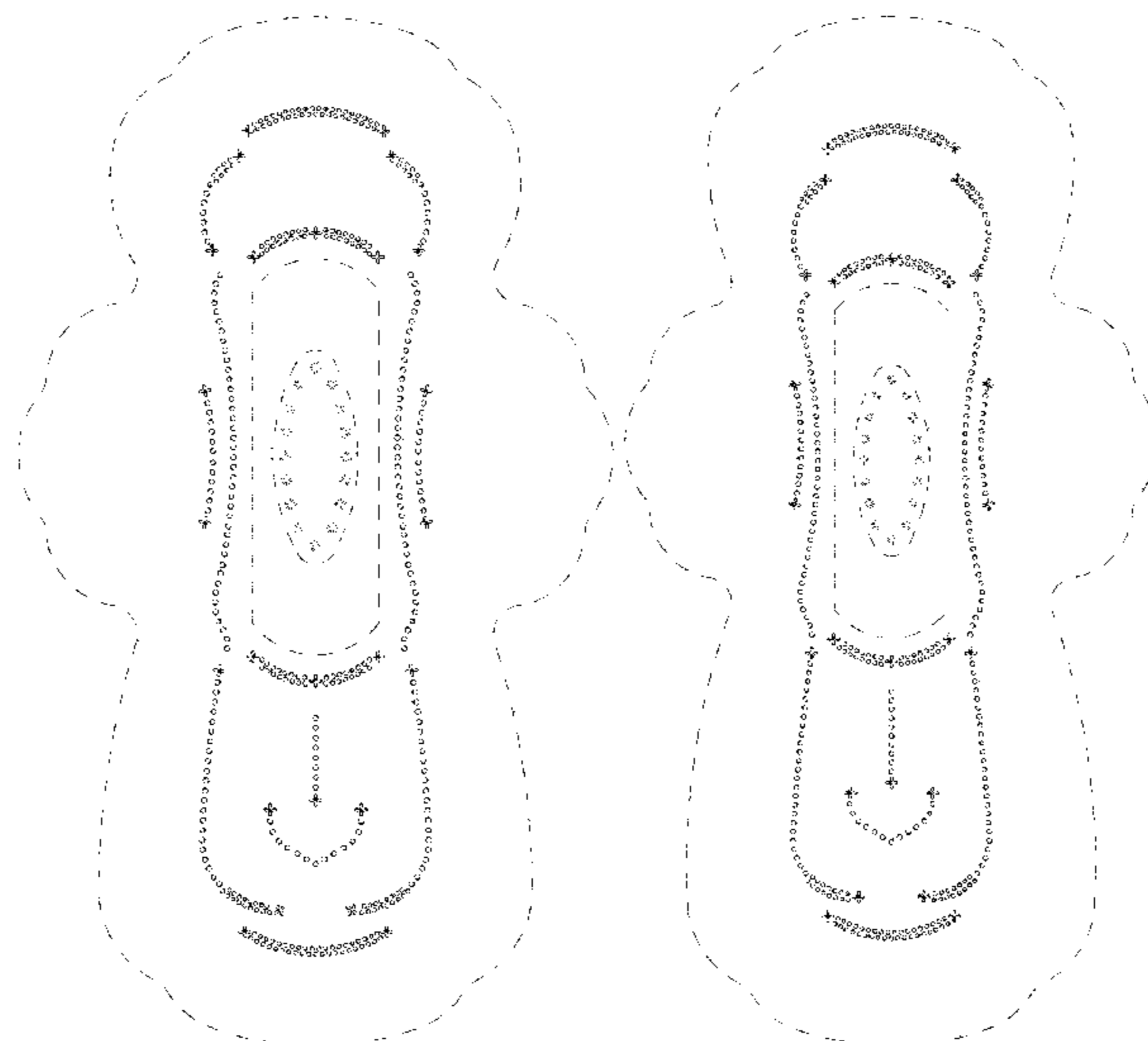
FIG. 1 is a plan view of a feminine pad showing our new design;

The solid lines are claimed. The unshaded regions within or otherwise adjacent to the solid lines form no part of the claimed design. The broken lines depicting the remainder of the feminine pad show features that form no part of the claimed design.

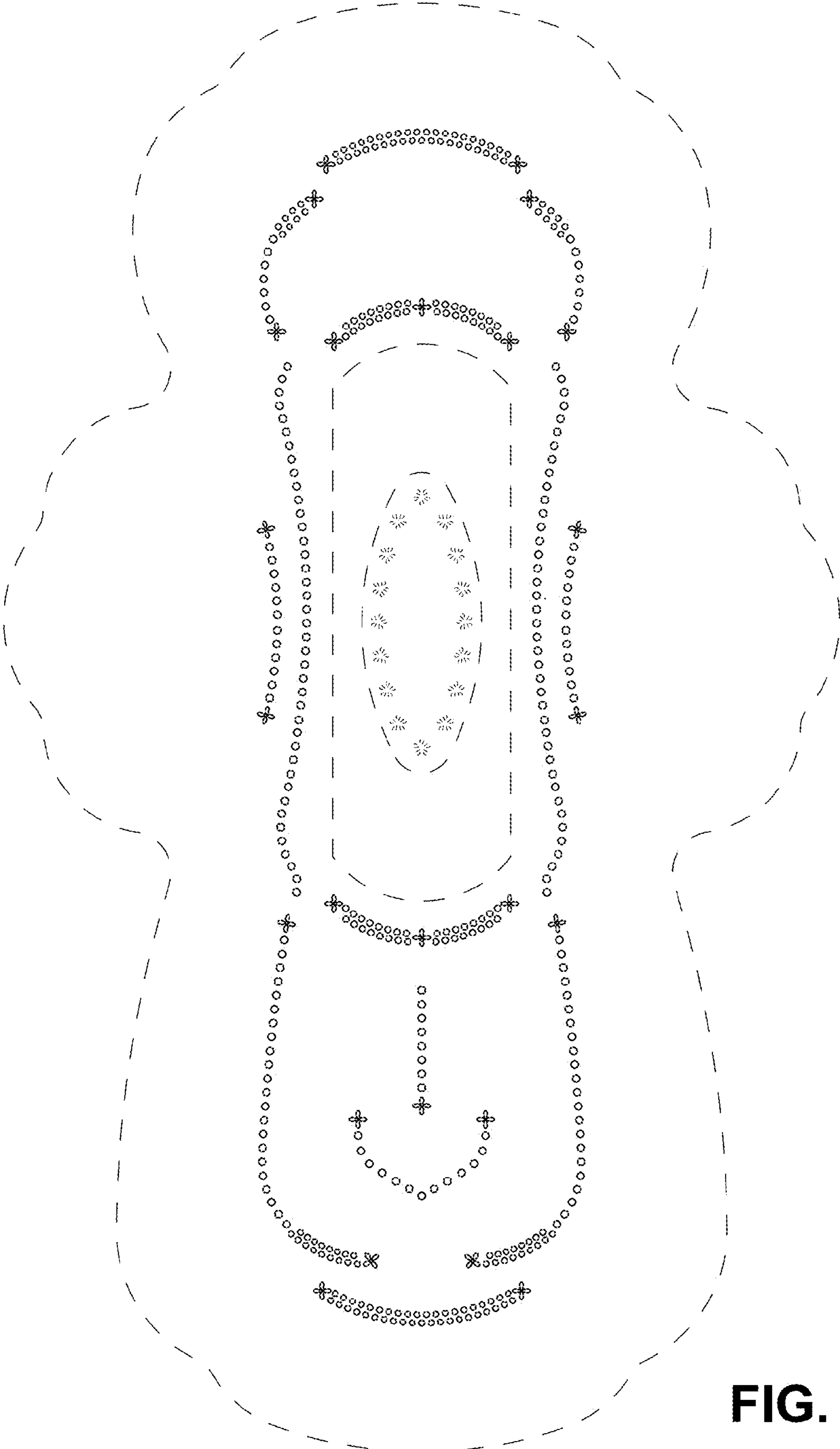

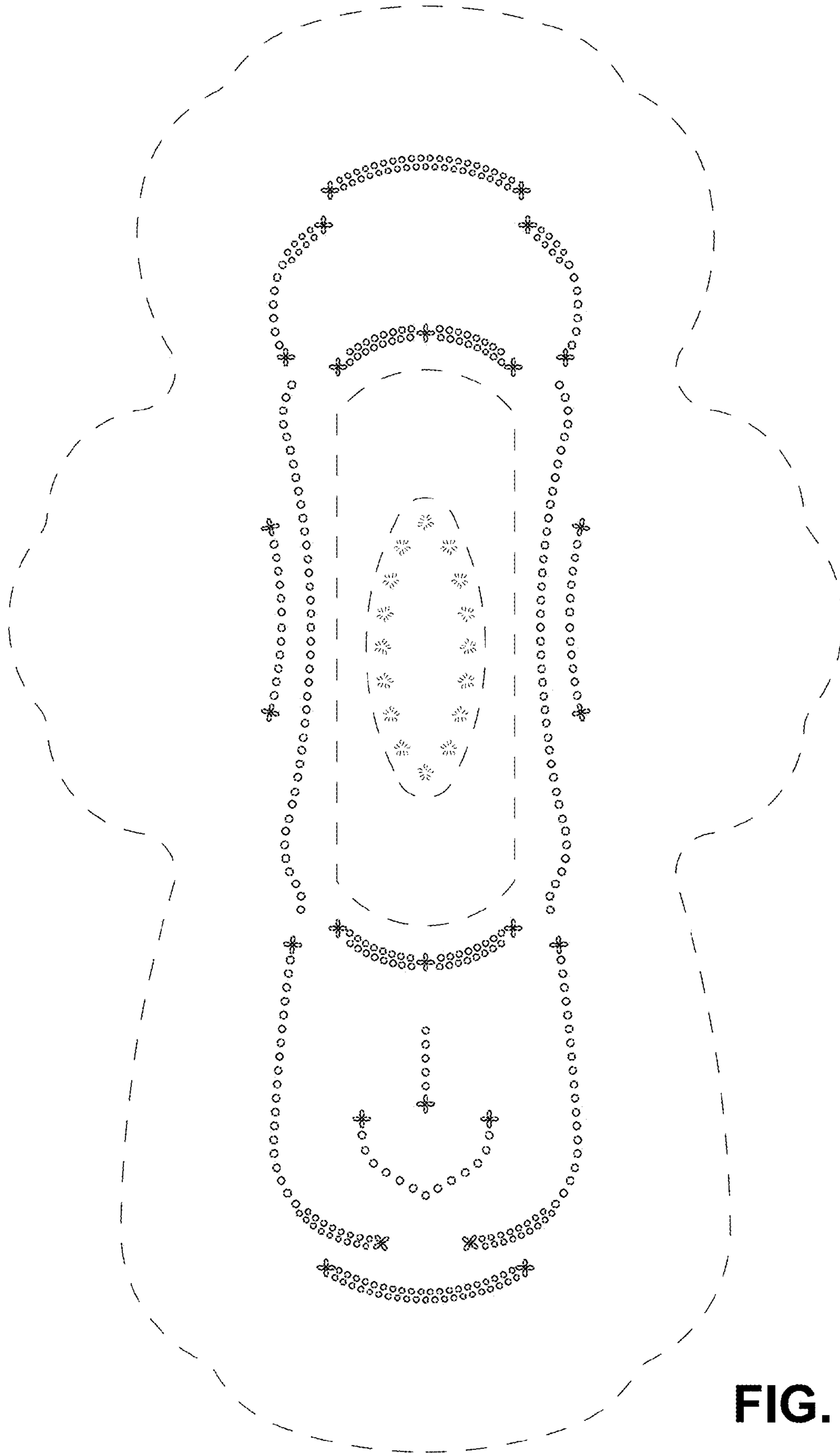

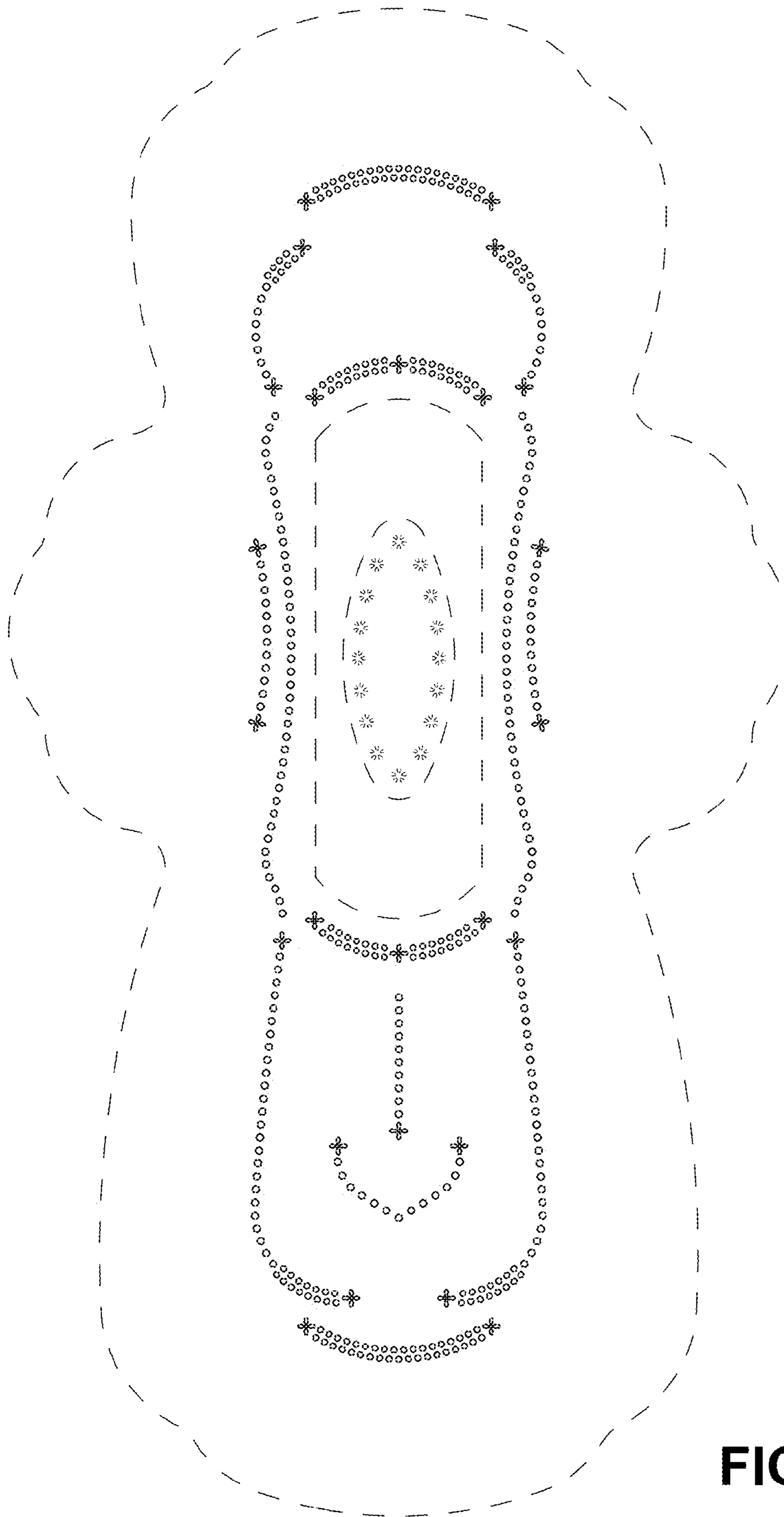
