(57) **CLAIM**

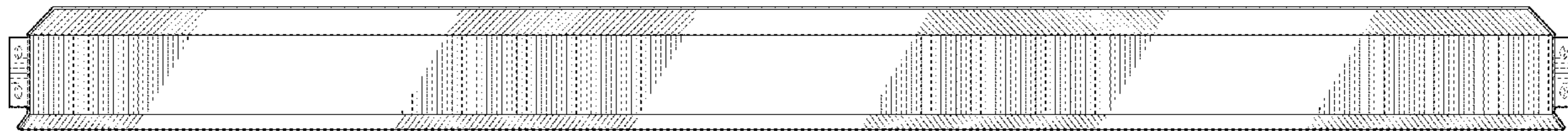
The ornamental design for a drip edge for a roof of a shelter structure, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a drip edge for a roof of a shelter structure in an installed environment; FIG. 2 is a perspective view of the drip edge of FIG. 1; FIG. 3 is a front view of the drip edge of FIG. 1; FIG. 4 is a rear view of the drip edge of FIG. 1; FIG. 5 is a left-side view of the drip edge of FIG. 1; FIG. 6 is a right-side view of the drip edge of FIG. 1; FIG. 7 is a top view of the drip edge of FIG. 1; and, FIG. 8 is a bottom view of the drip edge of FIG. 1. The broken lines represent structure or features of the drip edge for a roof of a shelter structure that form no part of the claimed design.

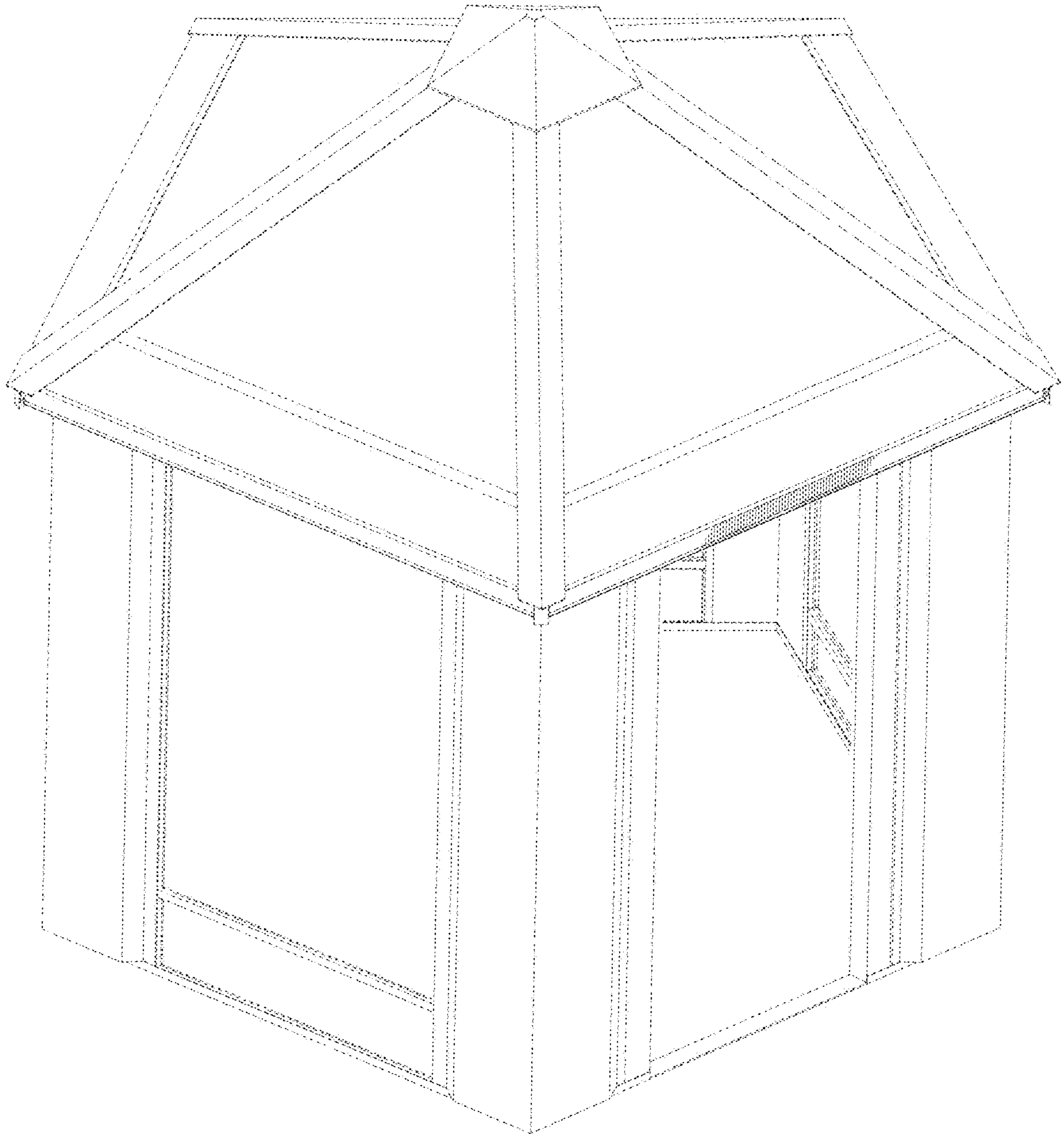

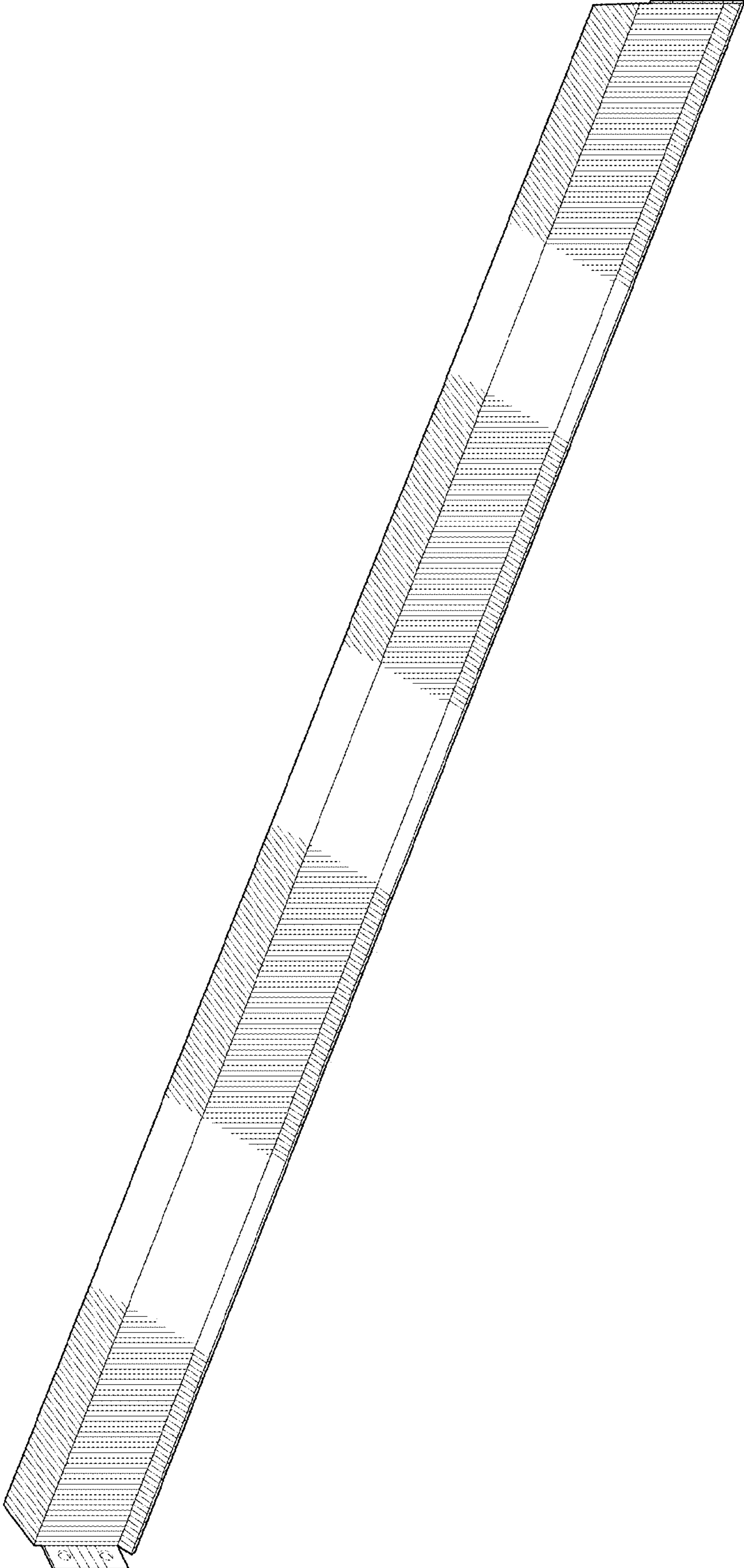

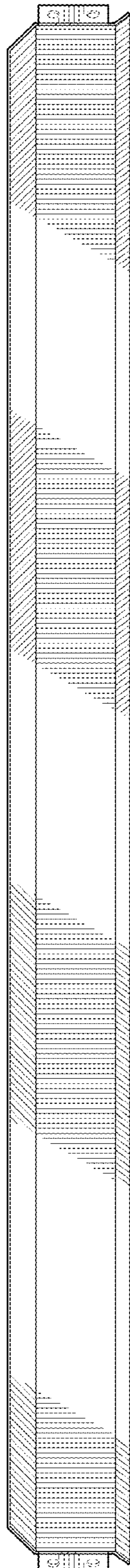

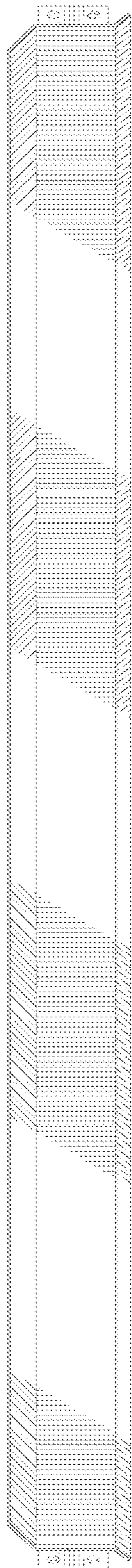
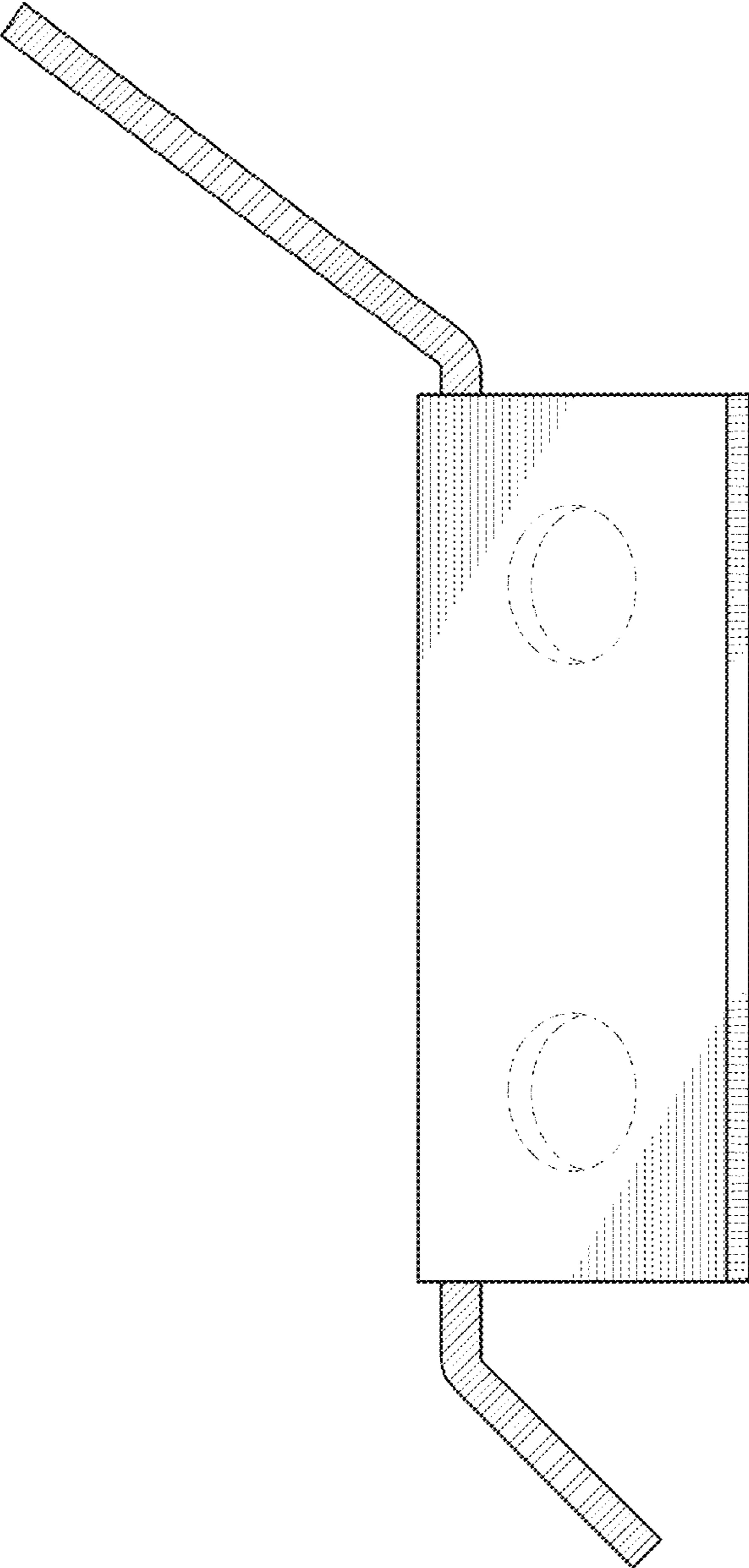
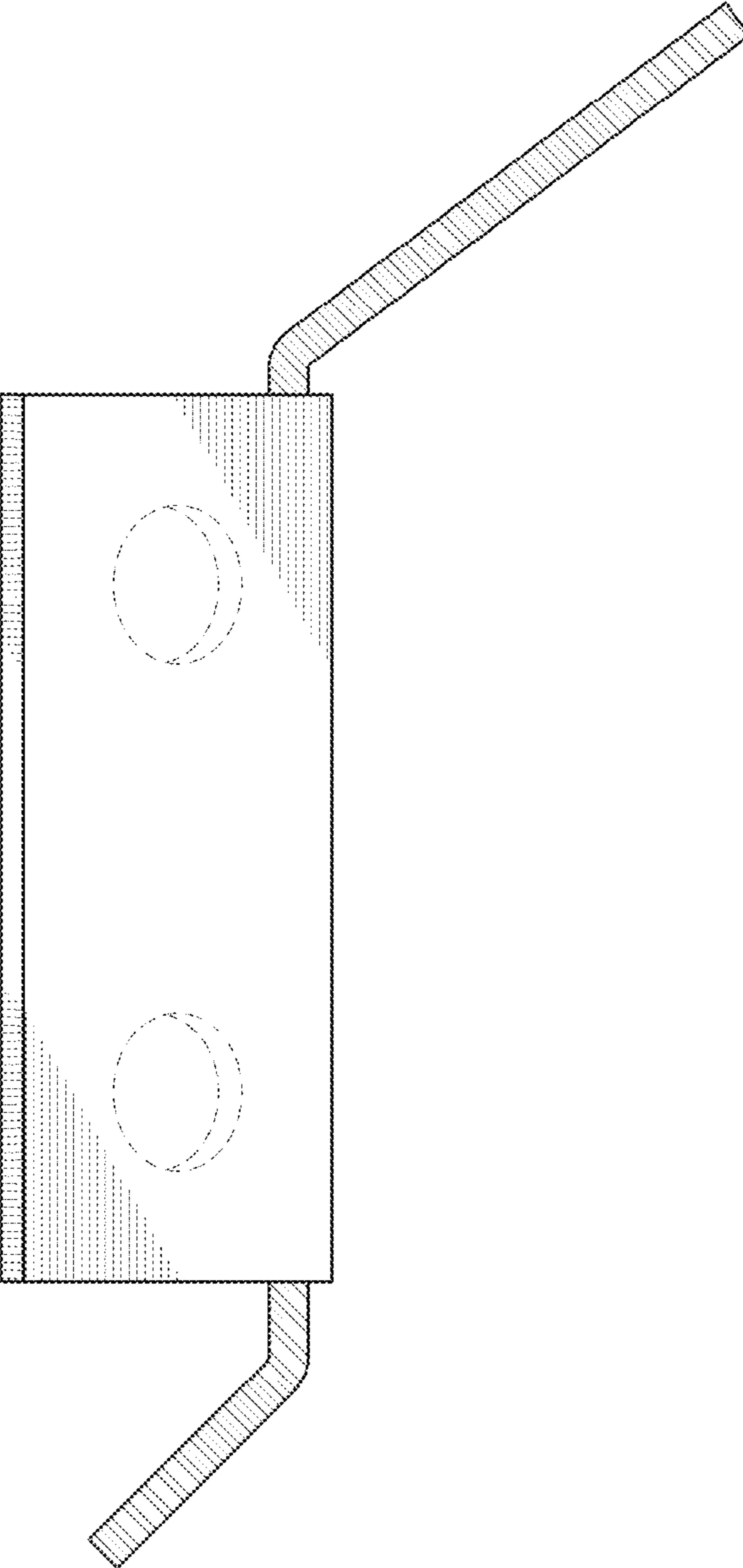

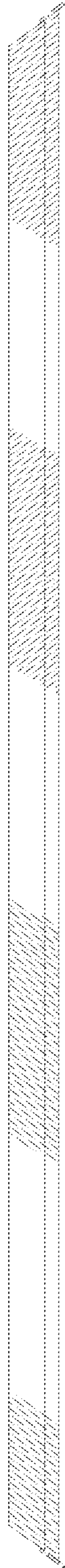

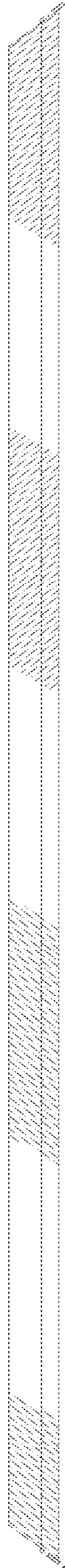
