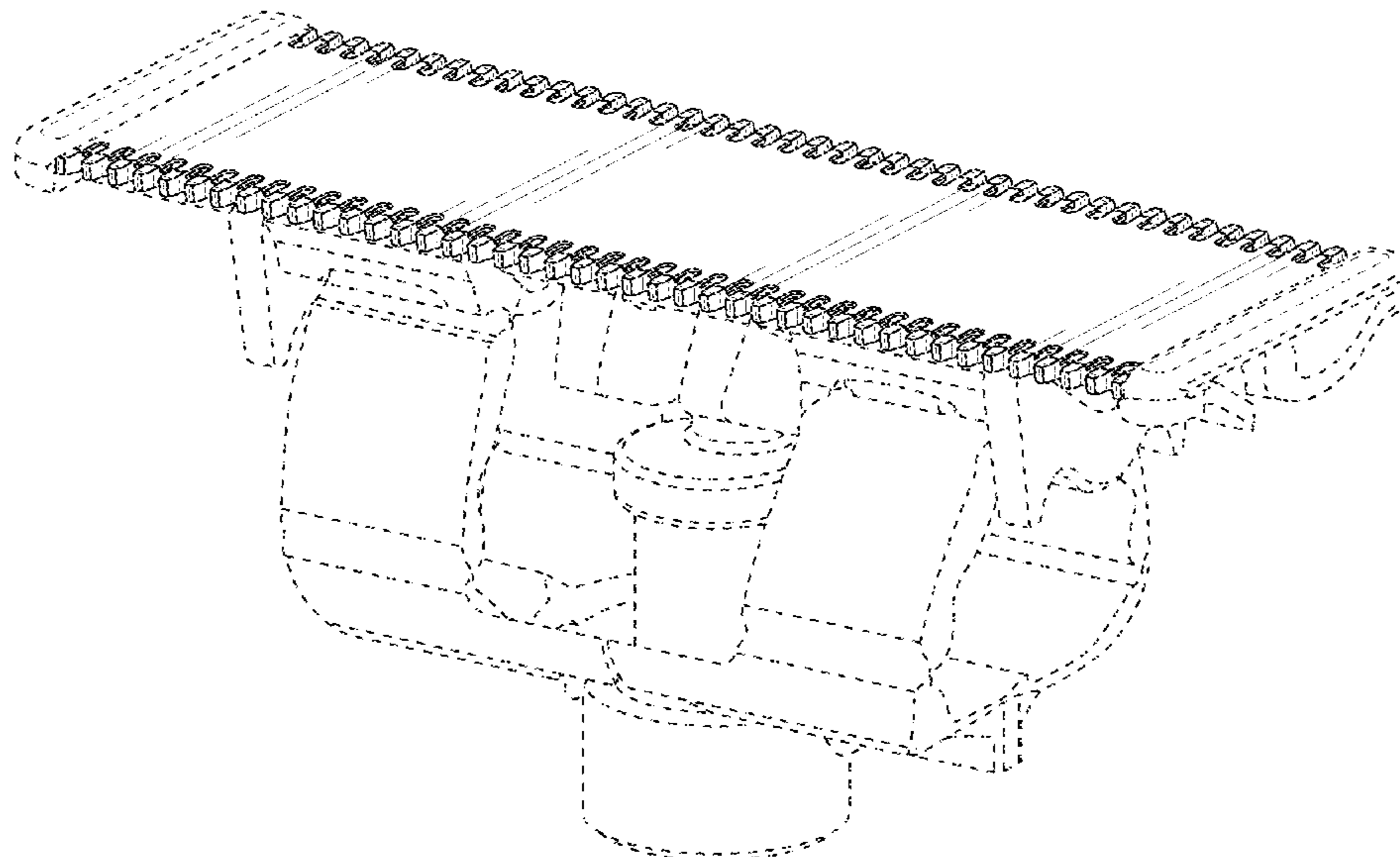
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a blade set,
showing our new design;
FIG. 2 is a bottom, rear, left perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a left side elevation view thereof;
FIG. 7 is a rear elevation view thereof; and,
FIG. 8 is a front elevation view thereof.
The broken lines of even length illustrate portions of the
blade set that form no part of the claimed design. The broken
lines of uneven length illustrate the boundary of the claimed
design and form no part thereof.

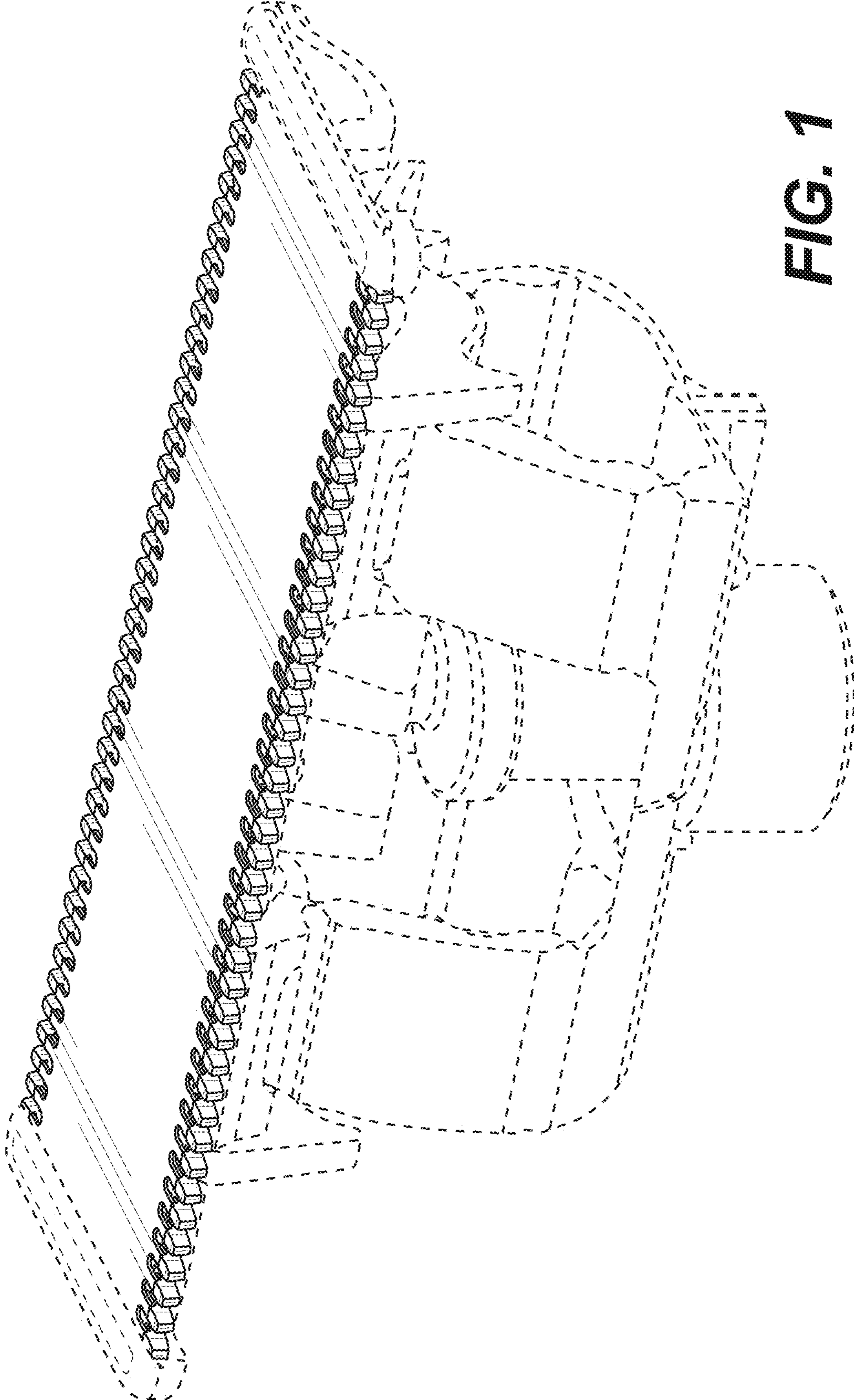

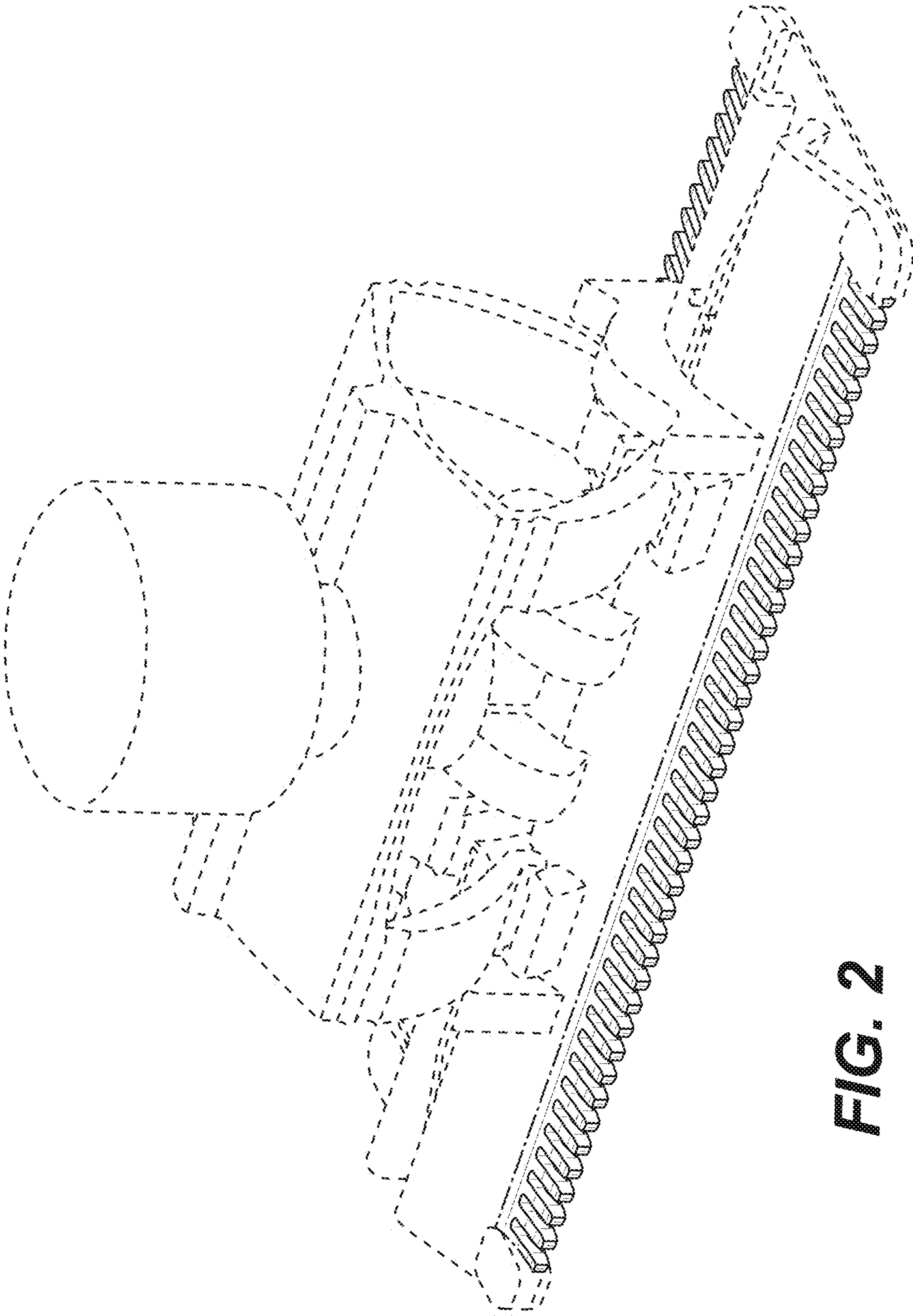

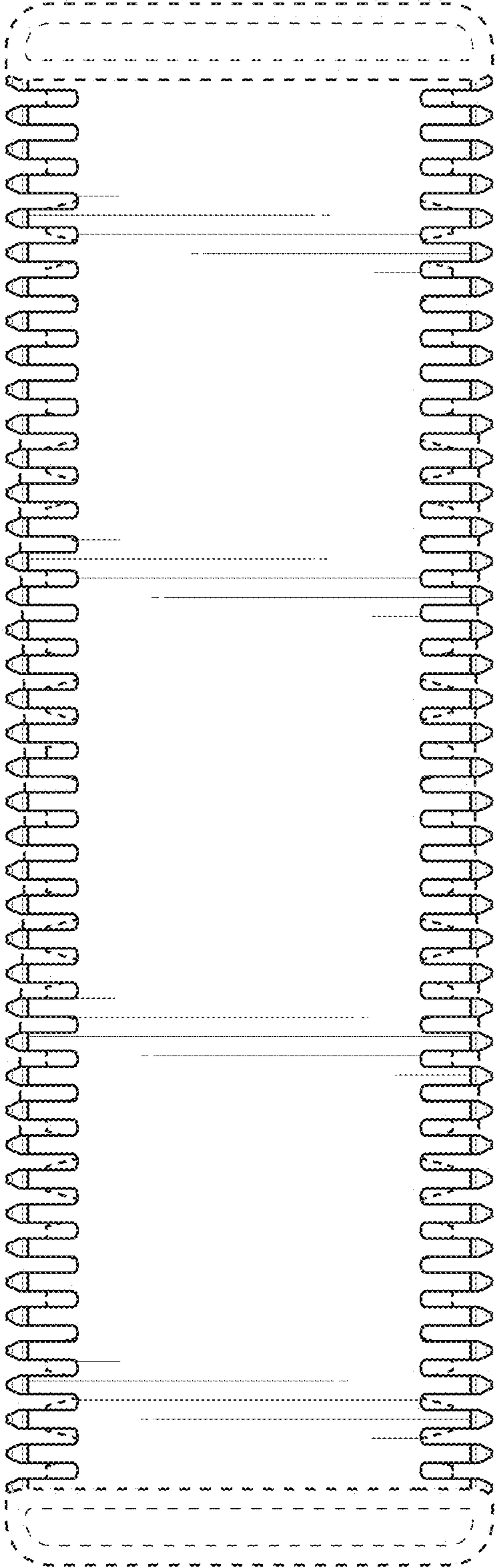

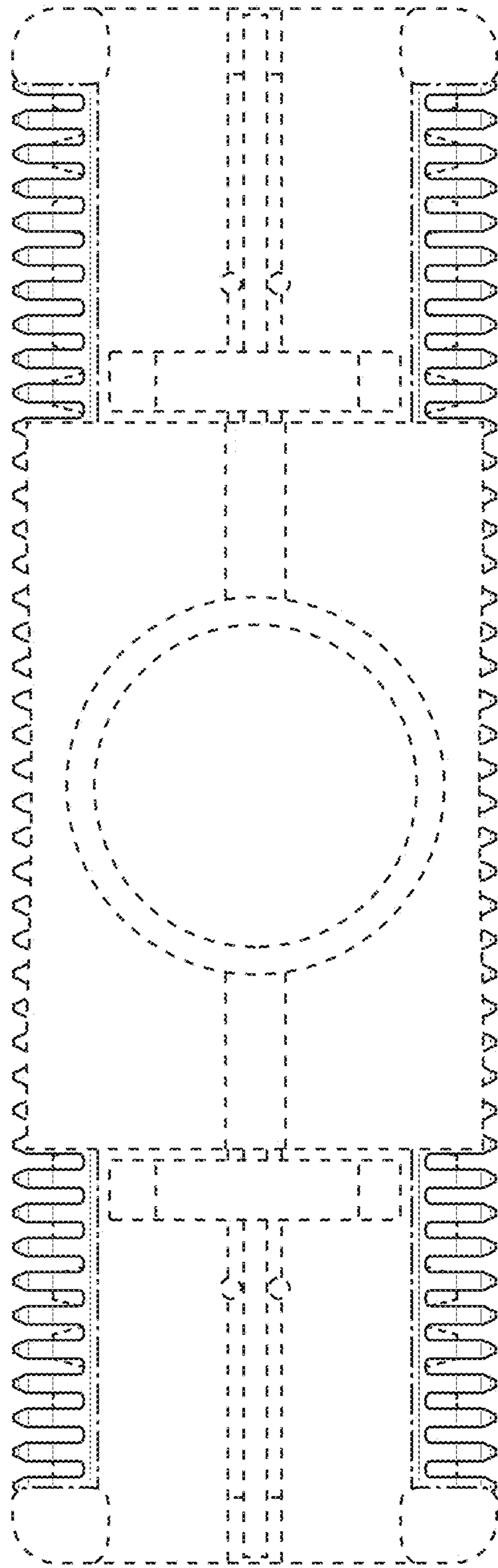

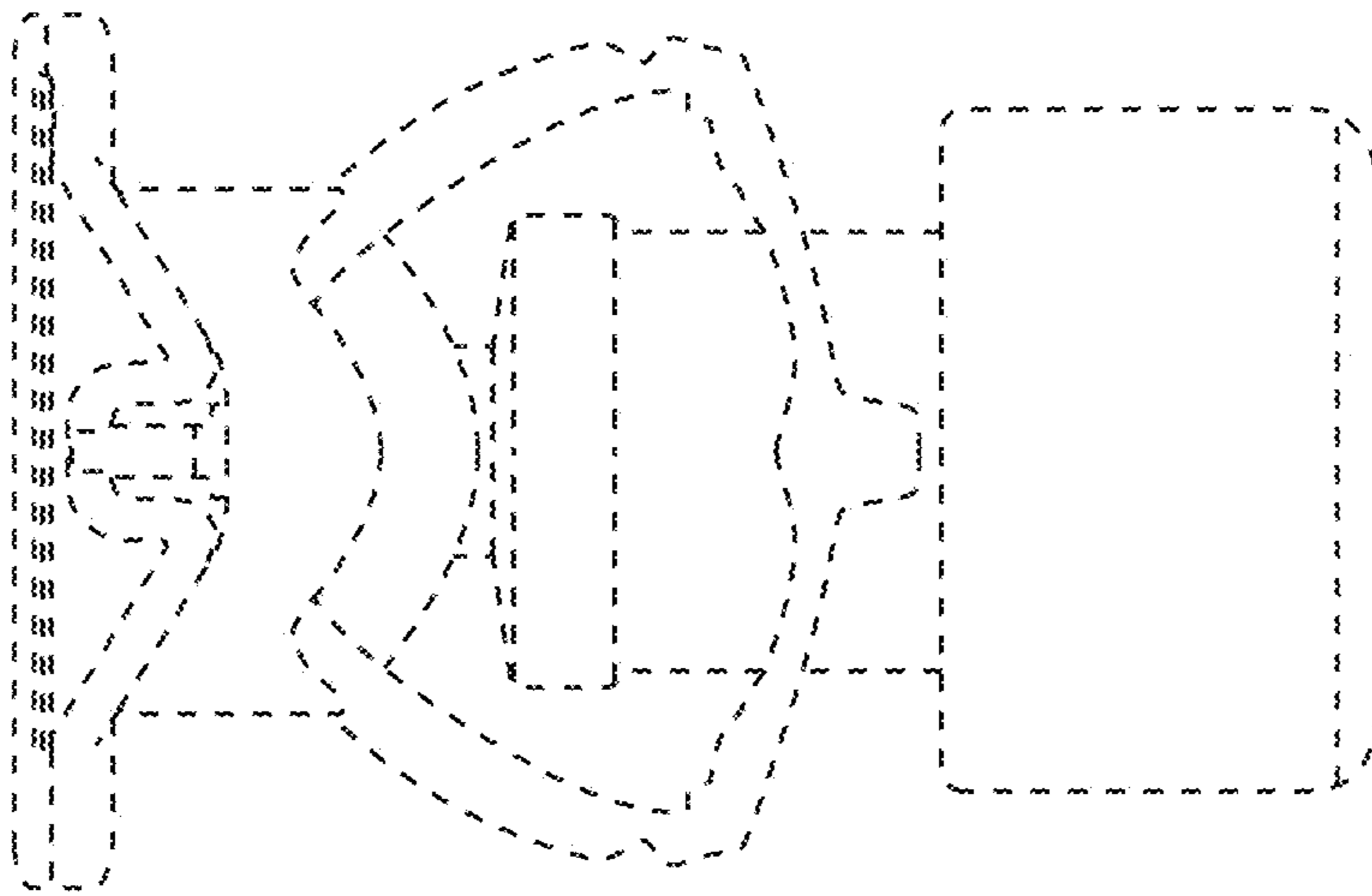

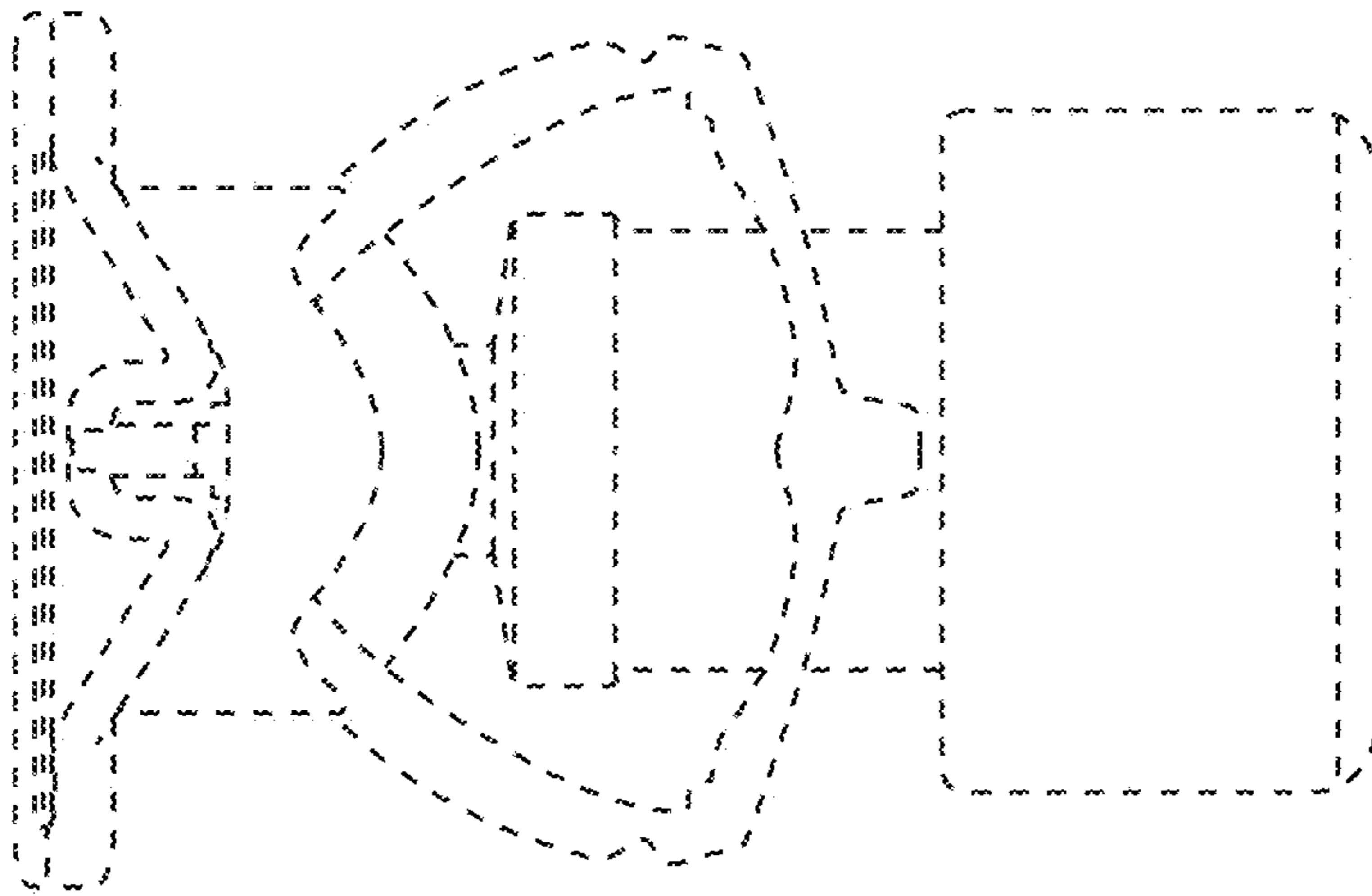

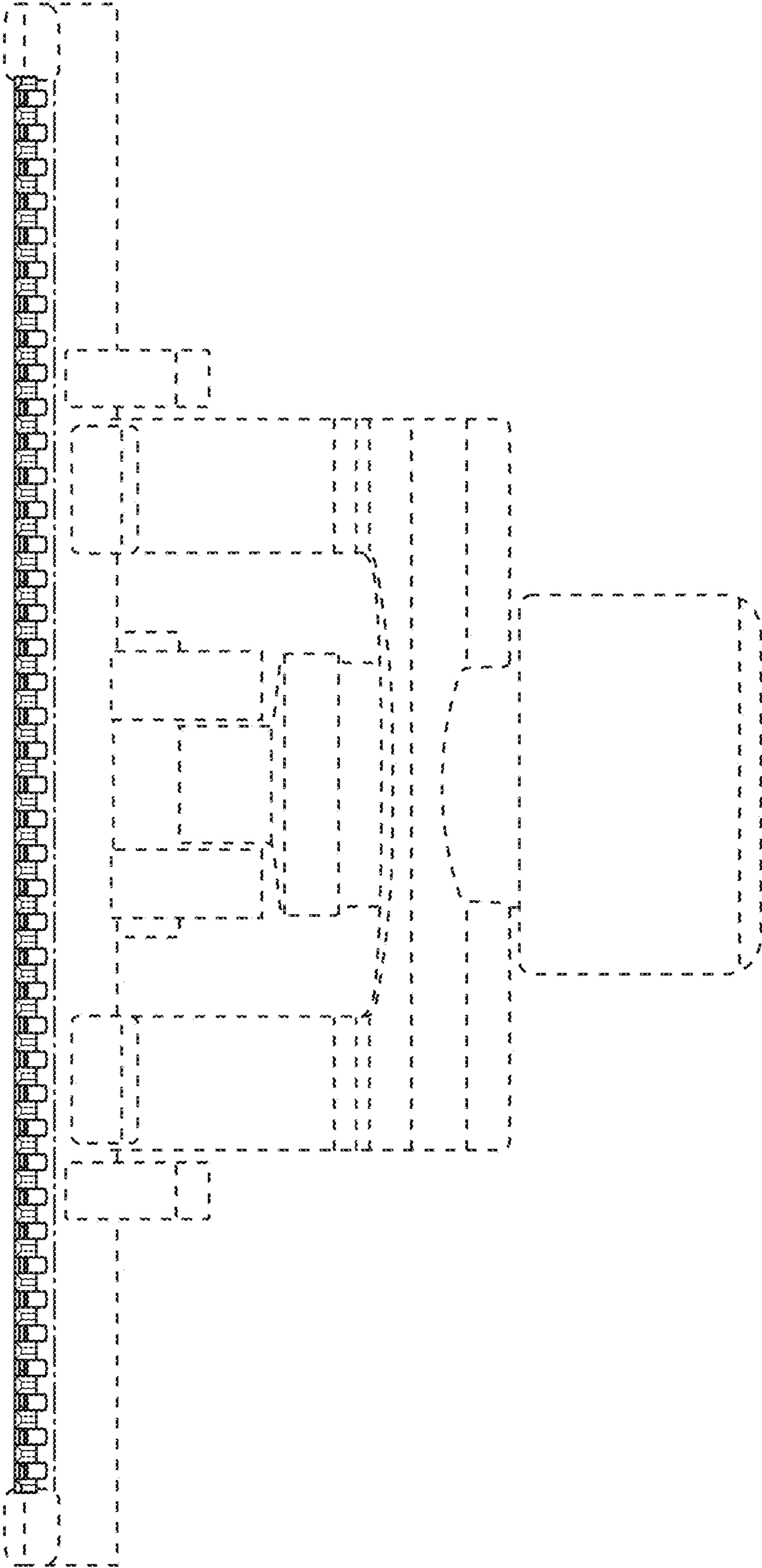

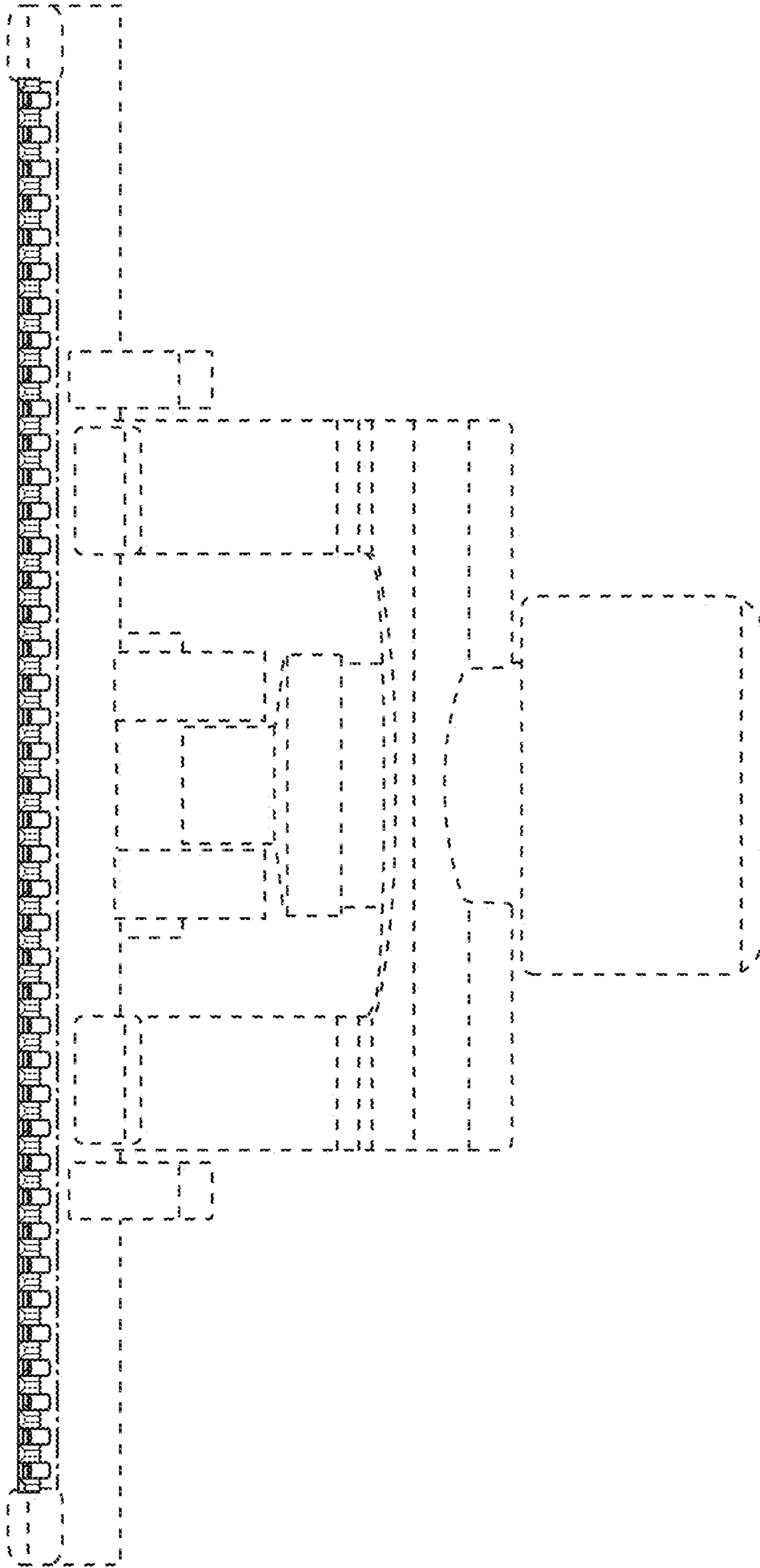
