(57) **CLAIM**

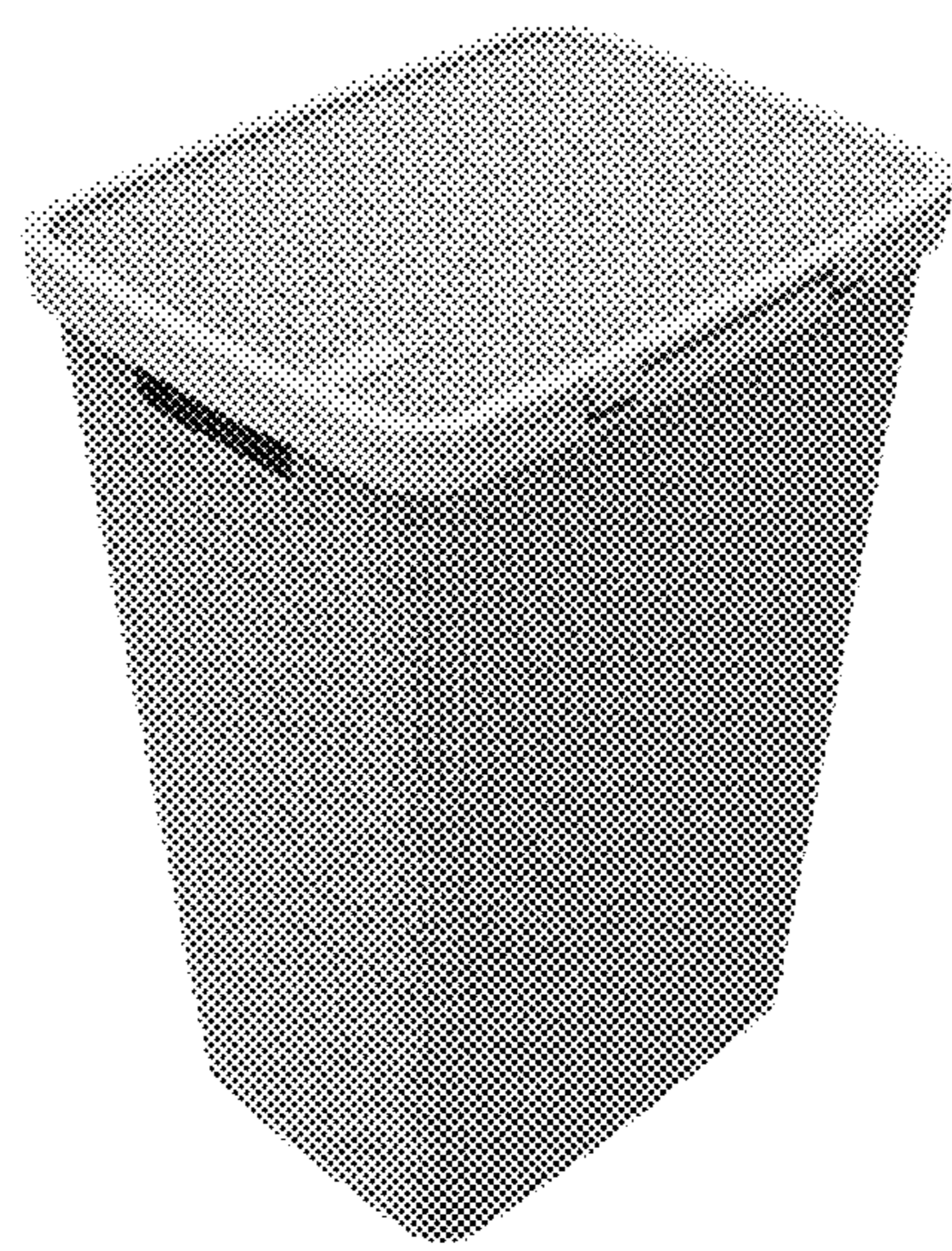
The ornamental design for a laundry basket, as shown and described.

DESCRIPTION

FIG. 1 is a top and rear perspective view of the new design for a laundry basket;

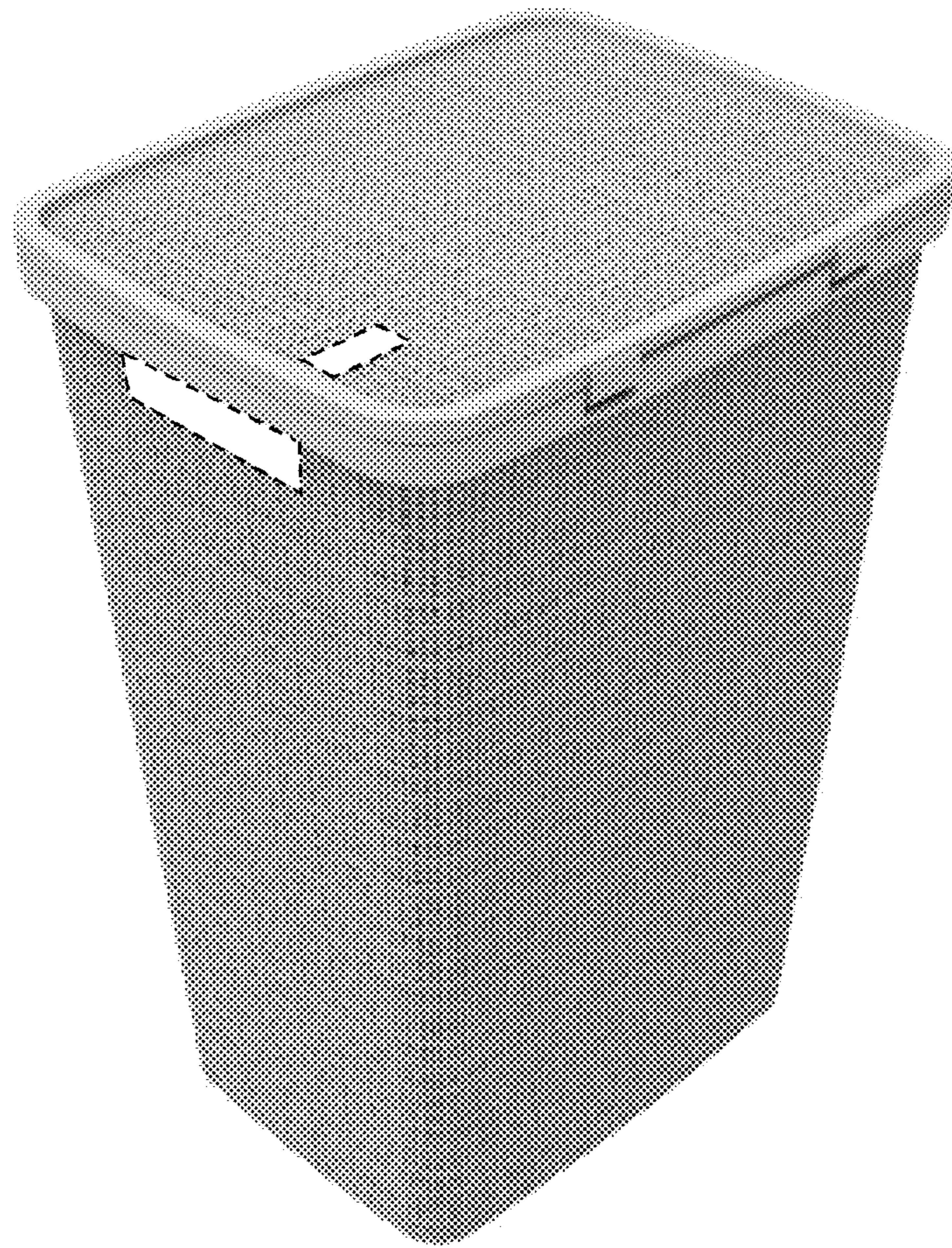

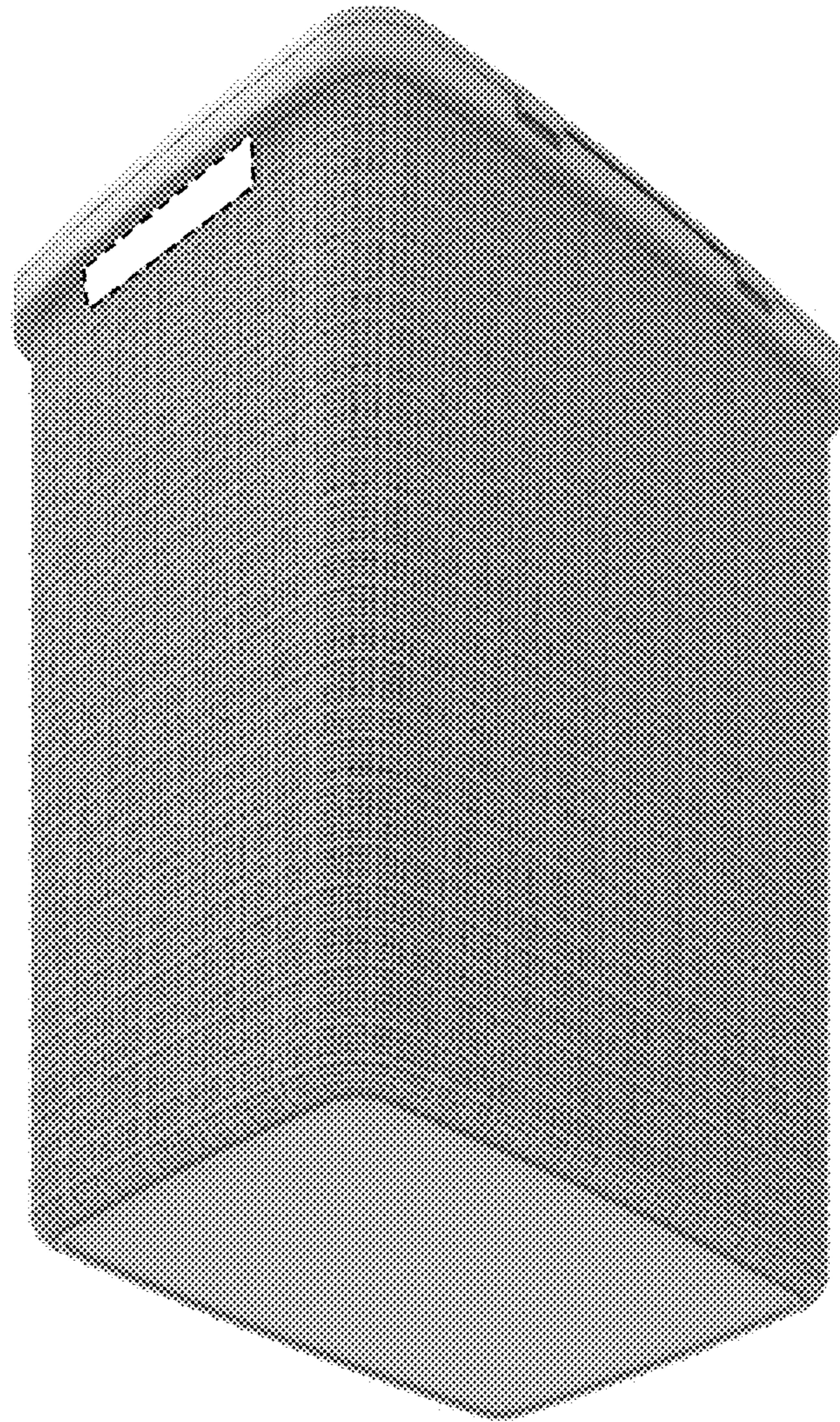

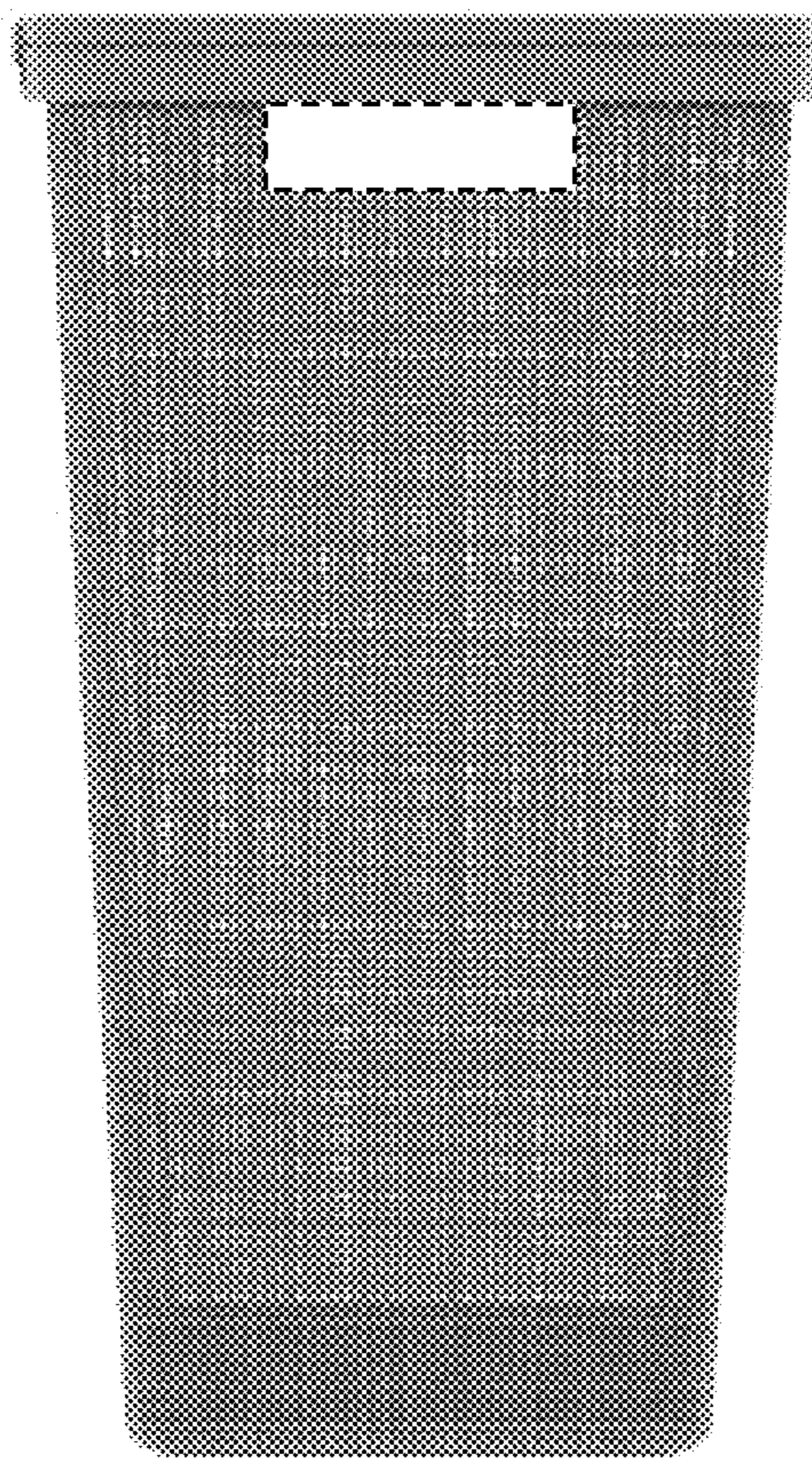

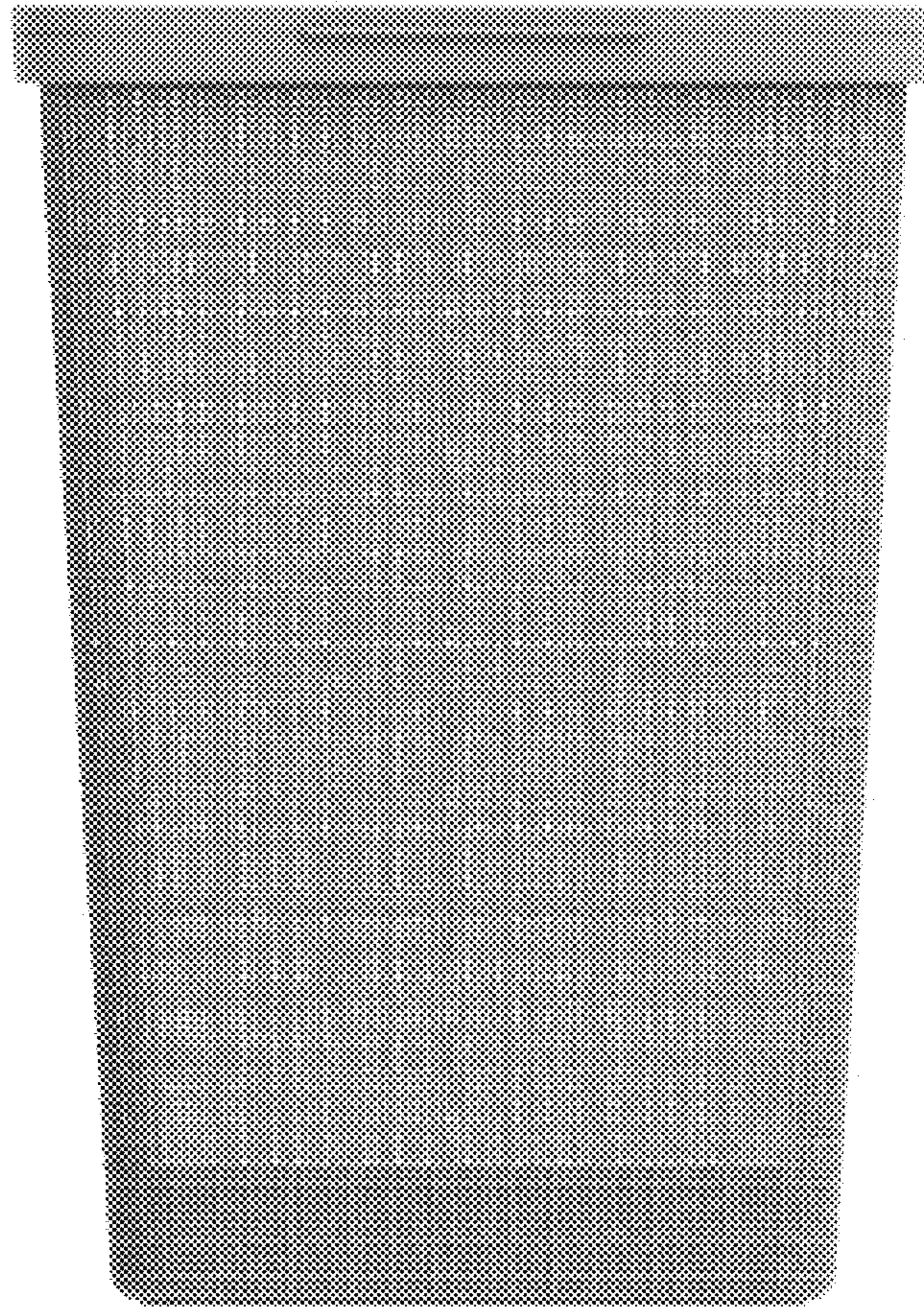

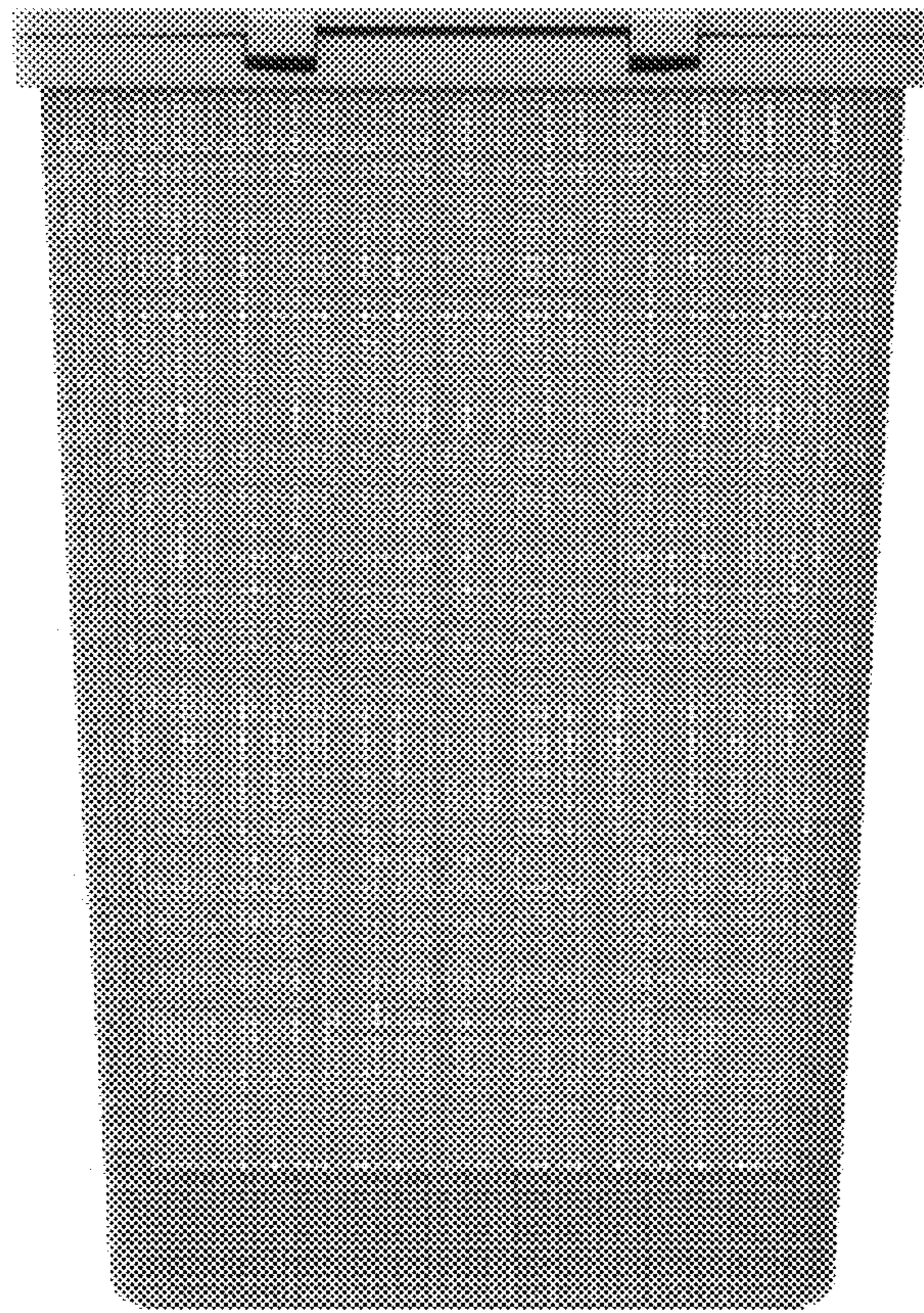

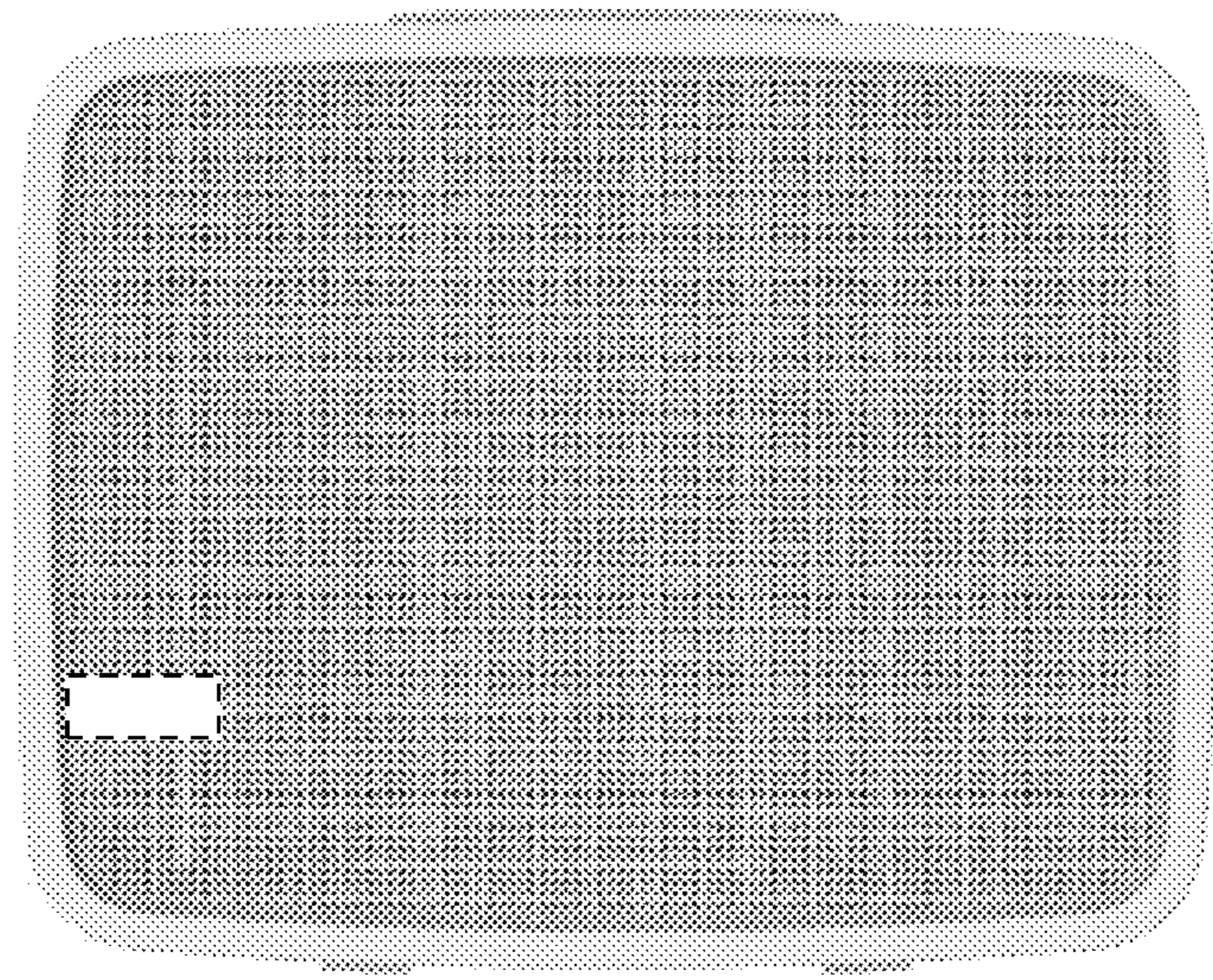

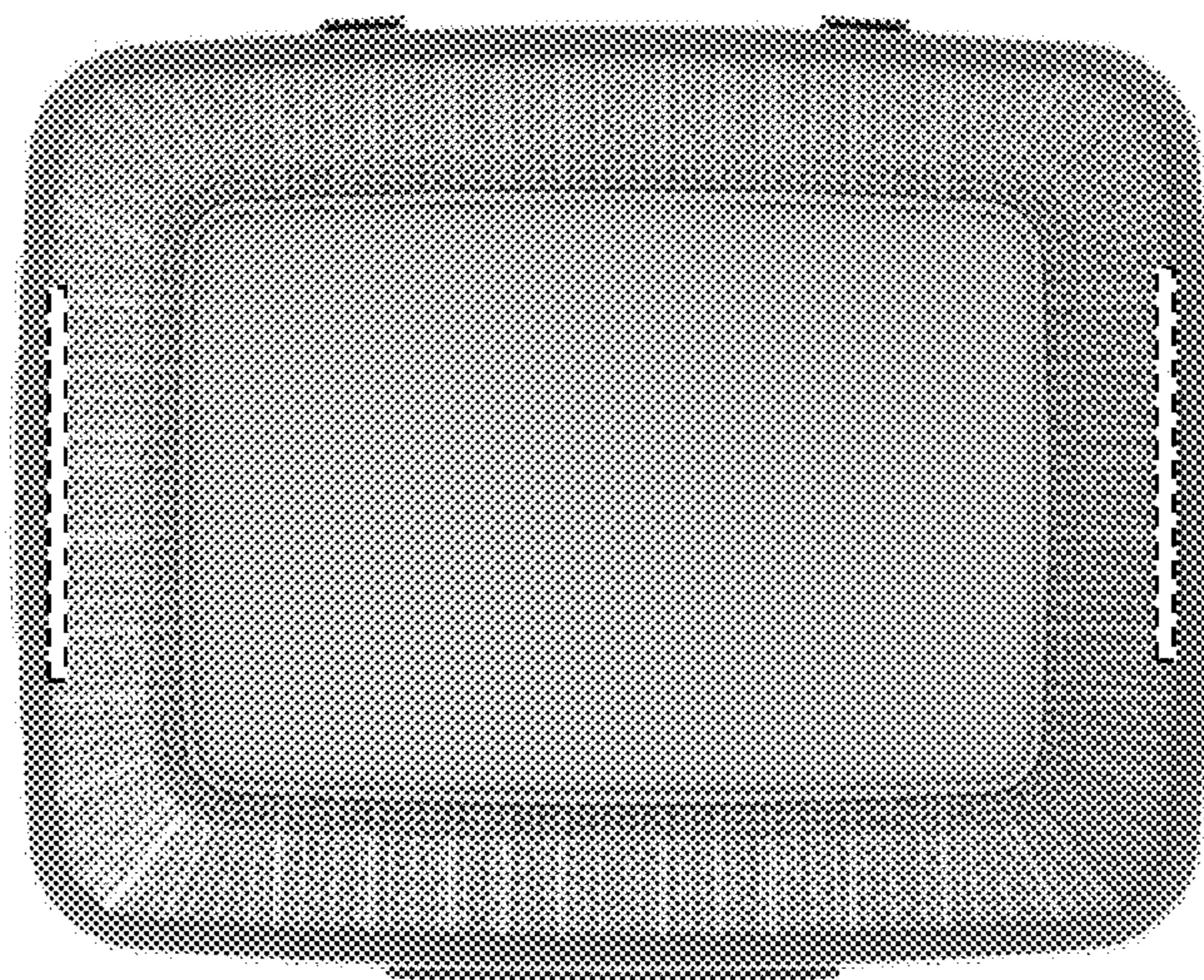

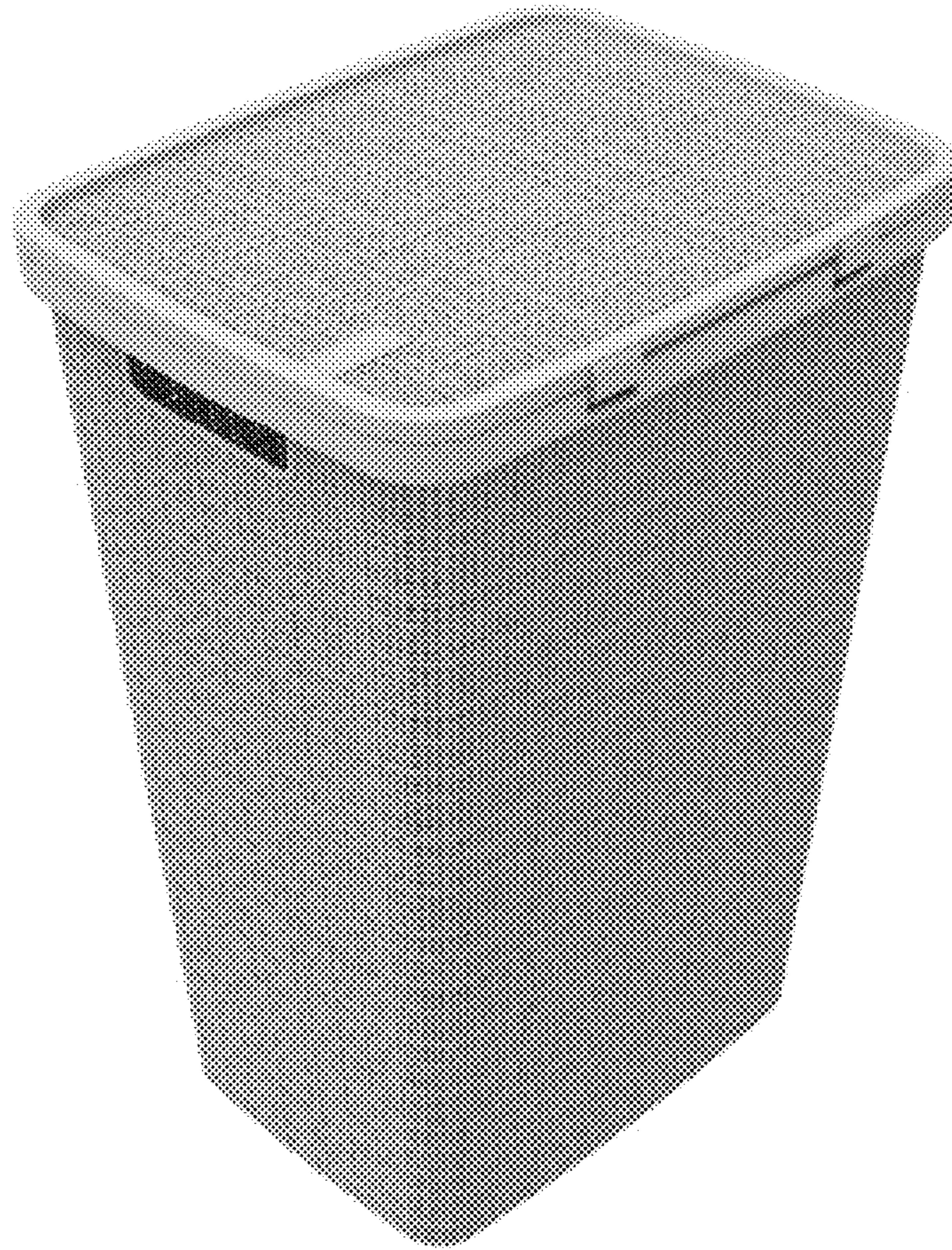

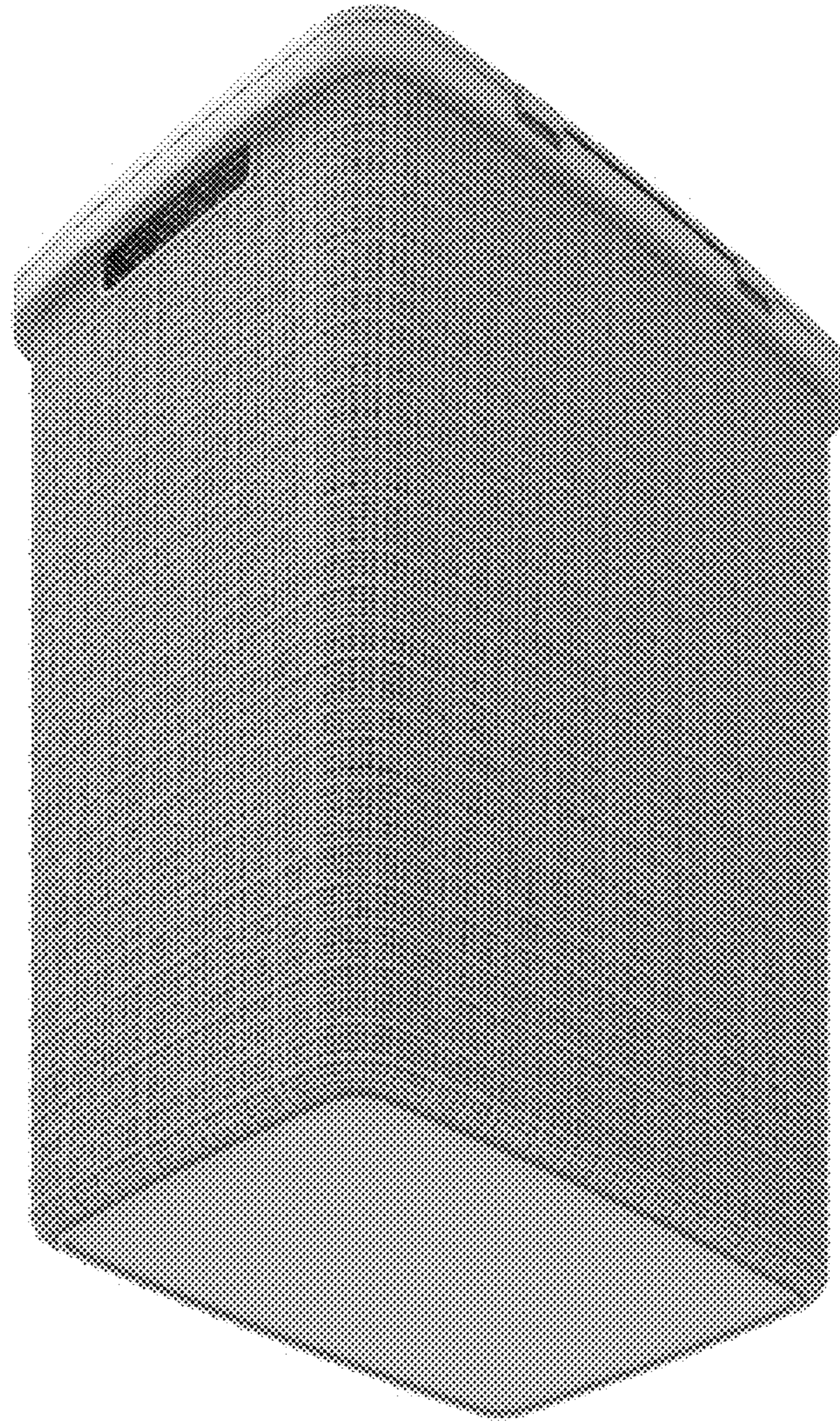

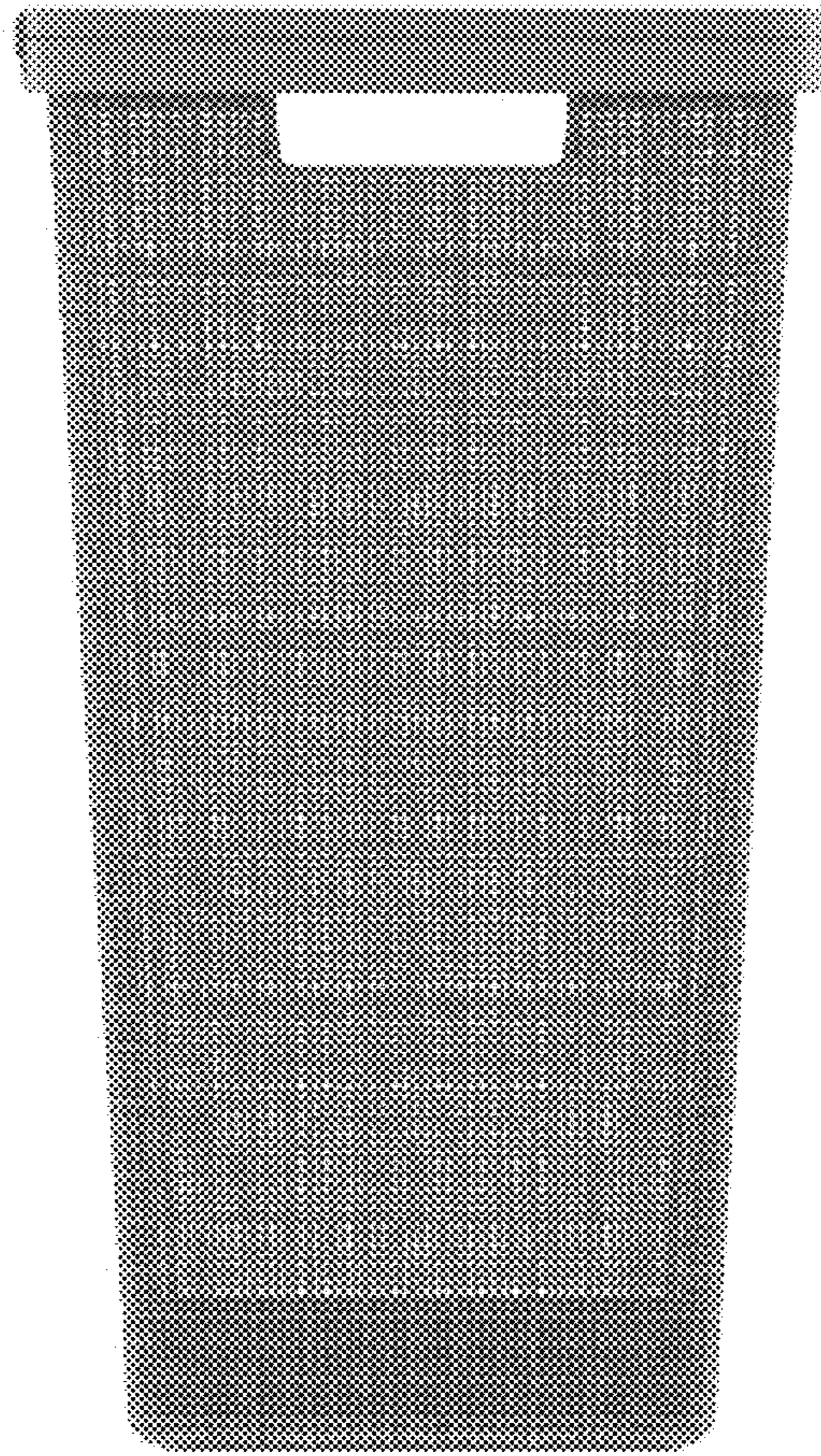

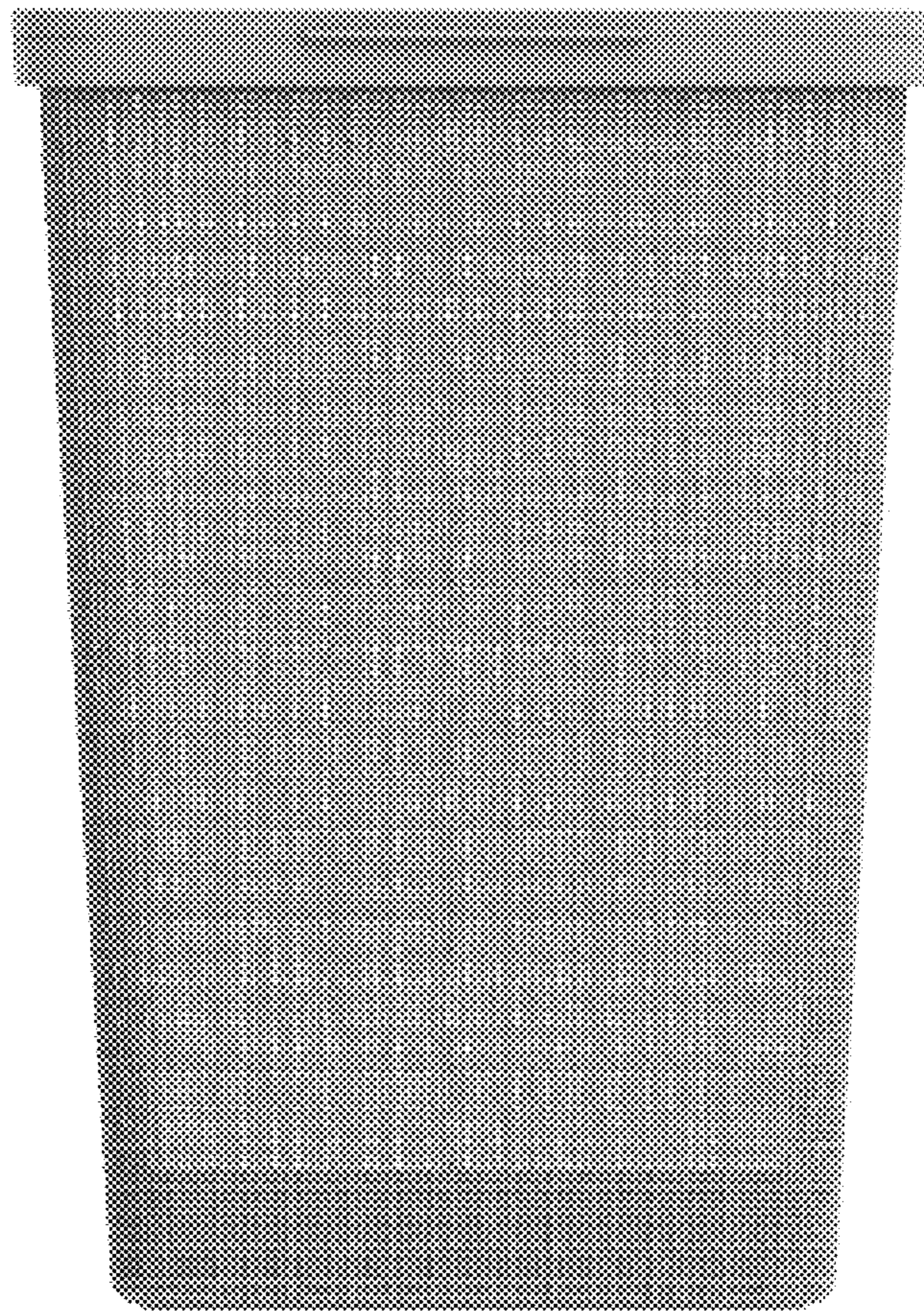

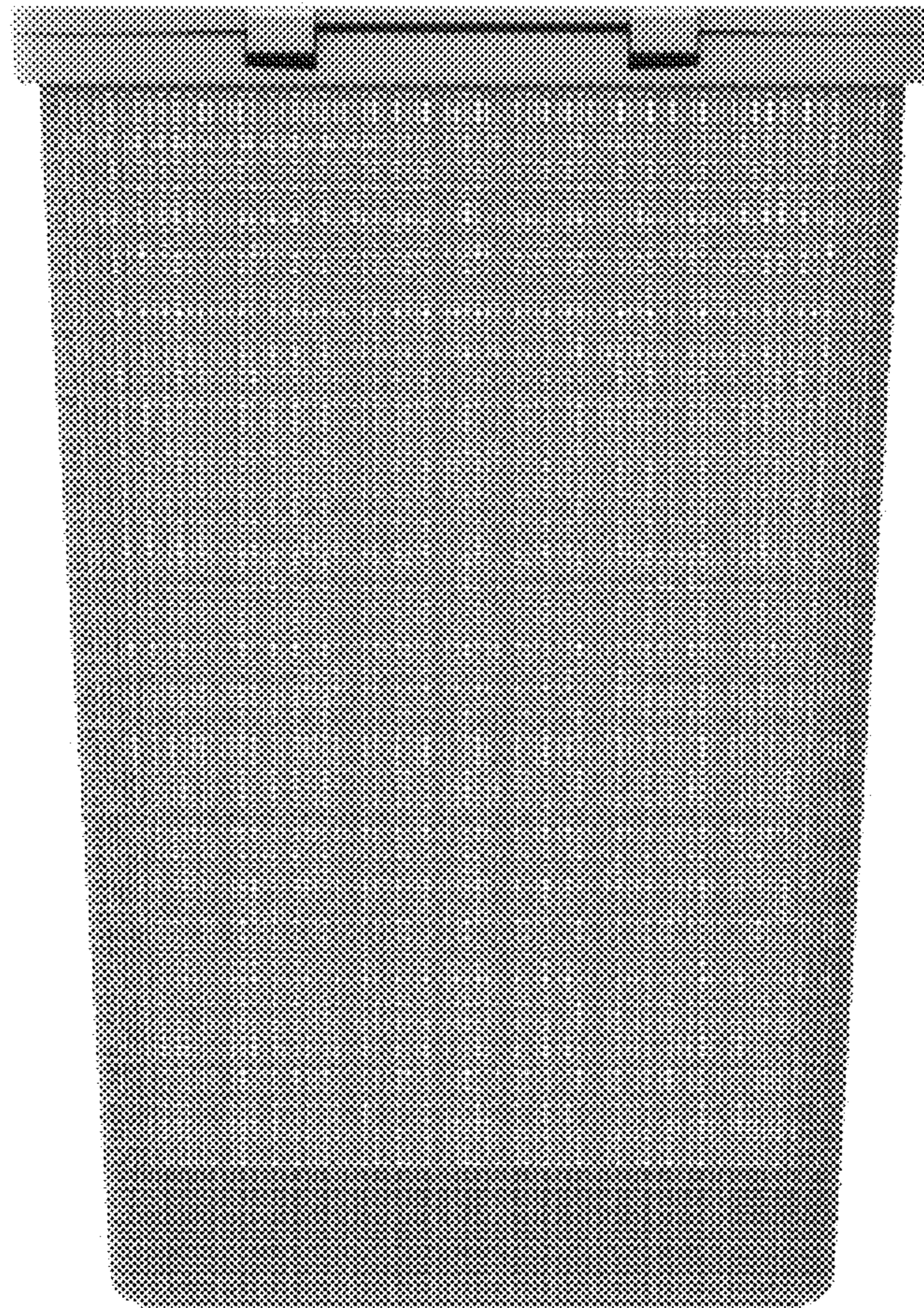

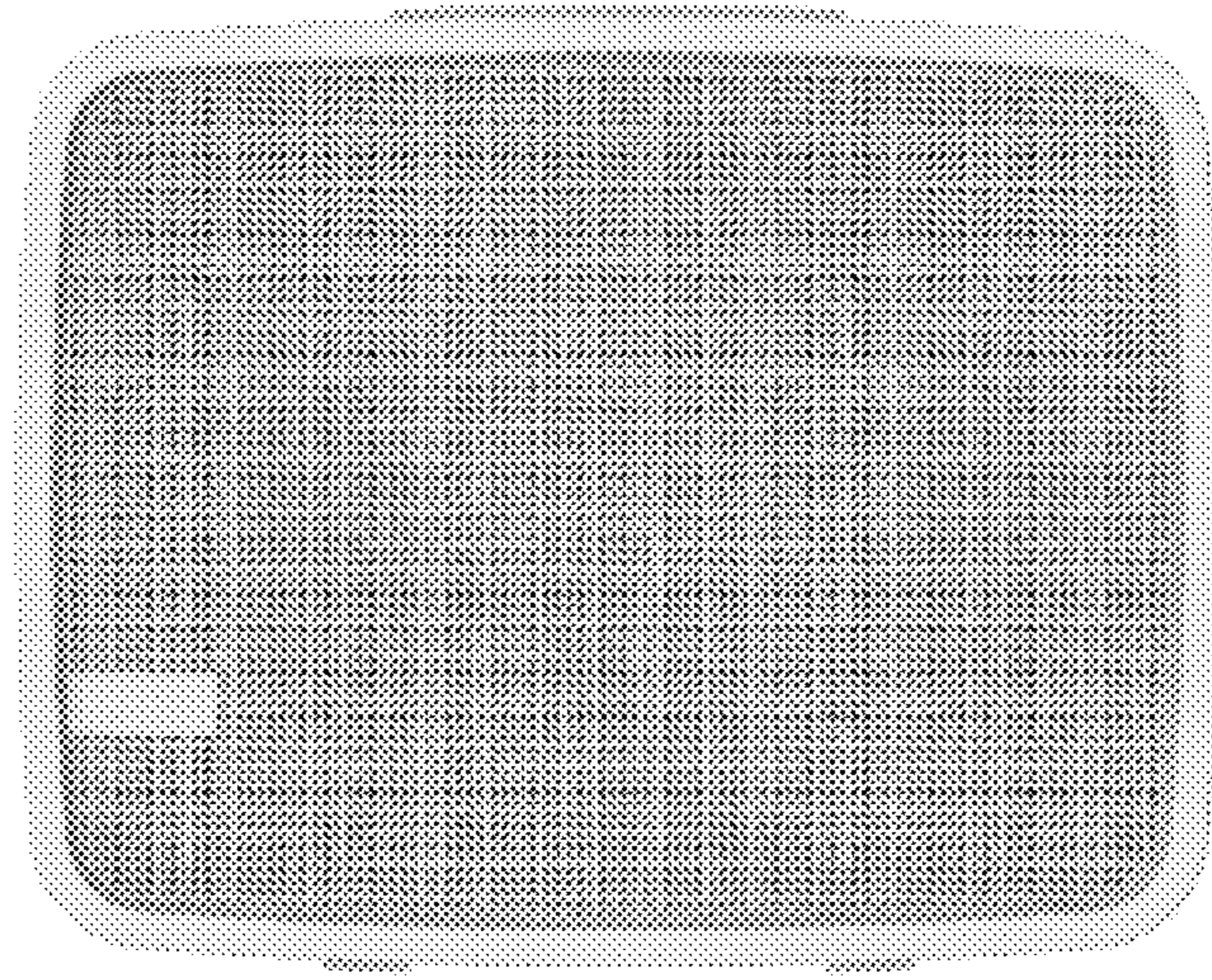

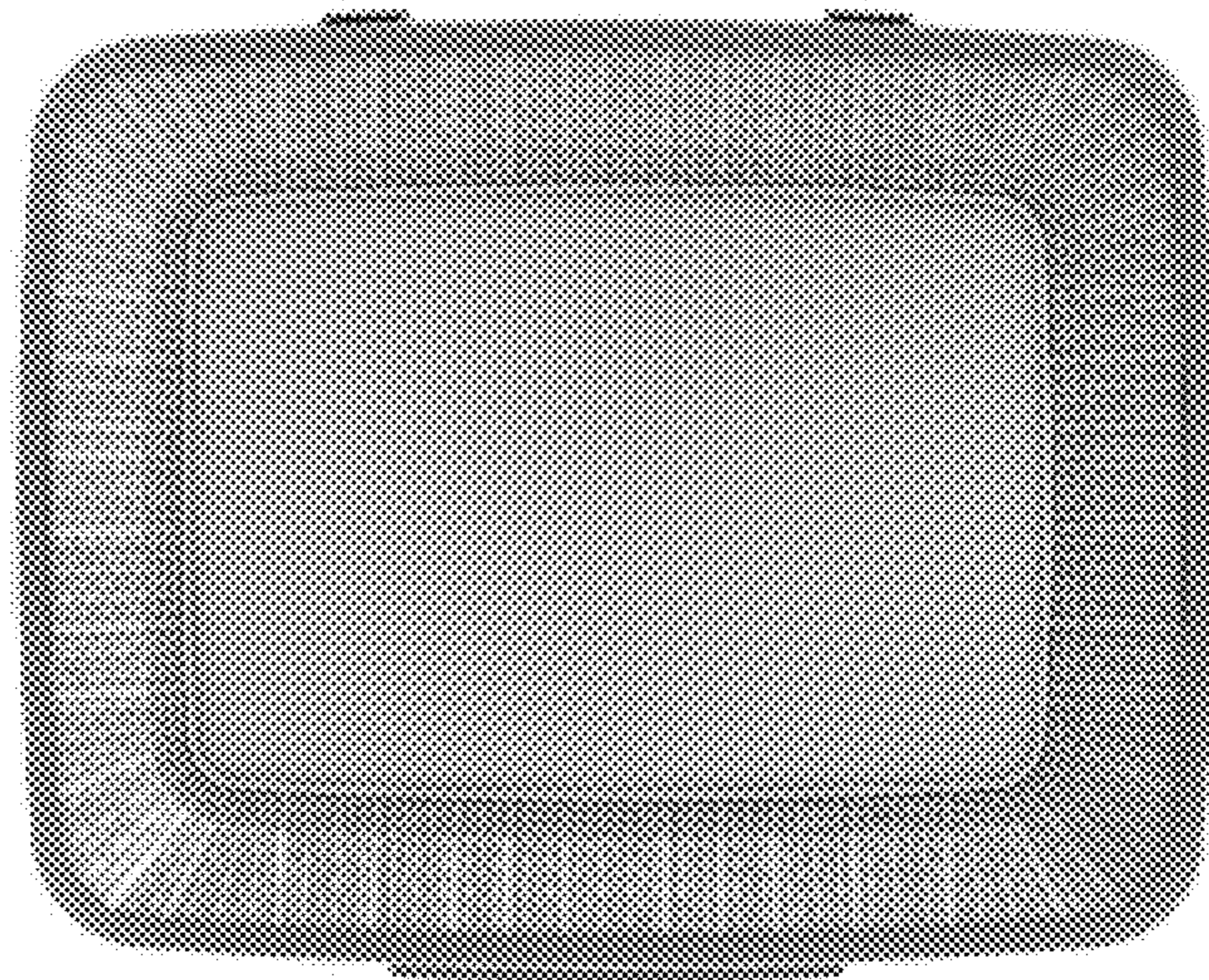
