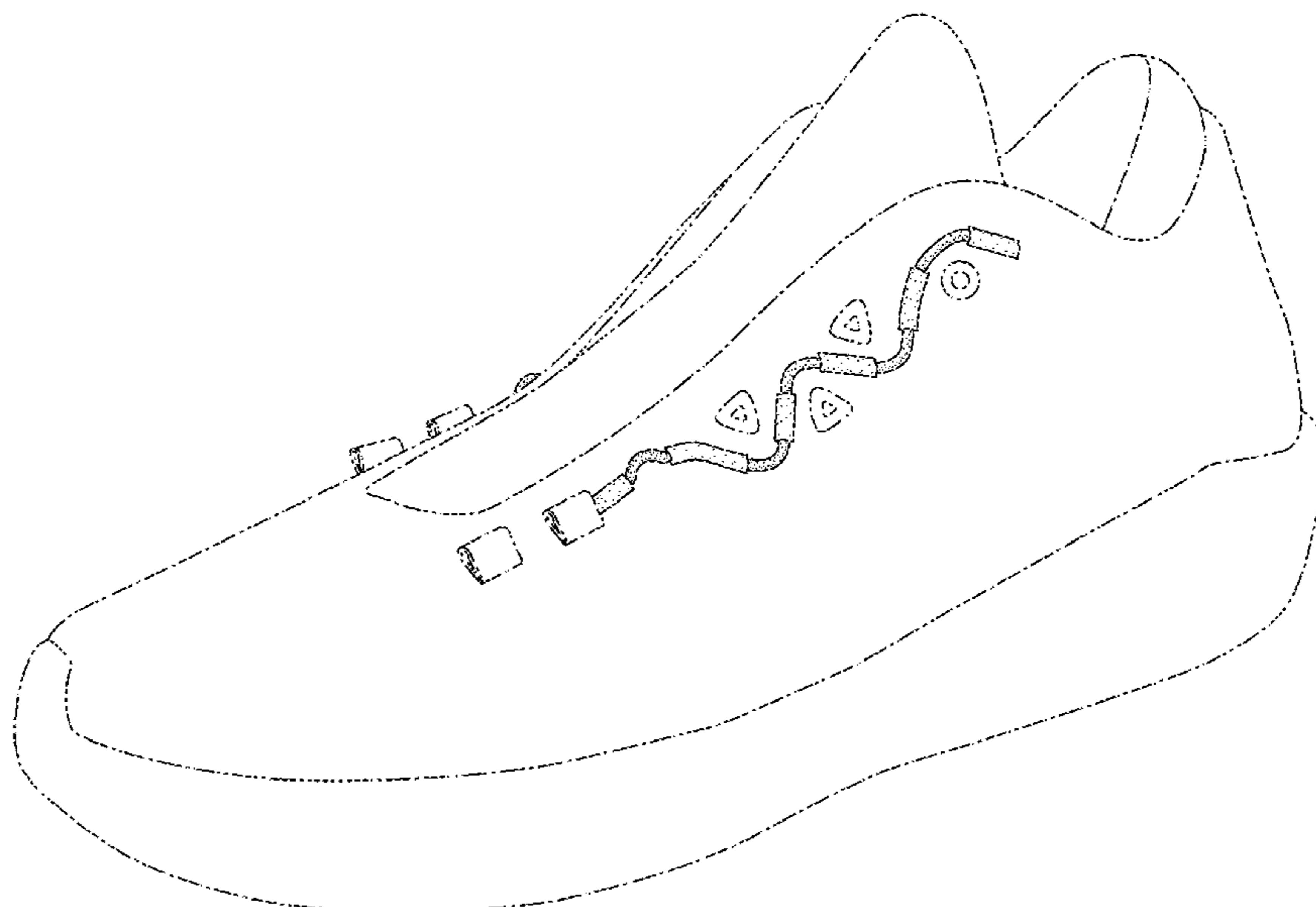
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
FIG. 2 is a side view thereof;

FIG. 5 is an opposite side view thereof; and,

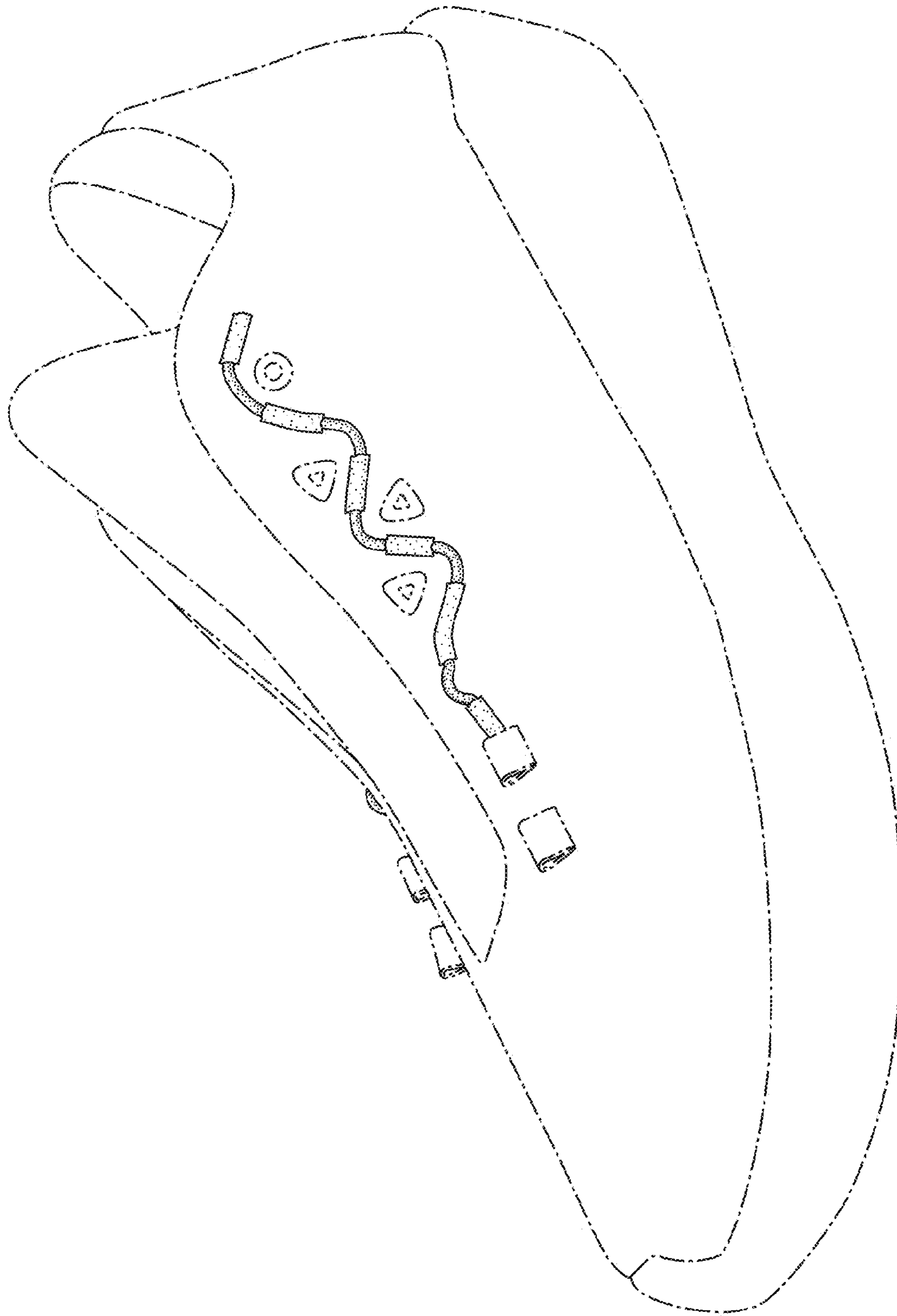

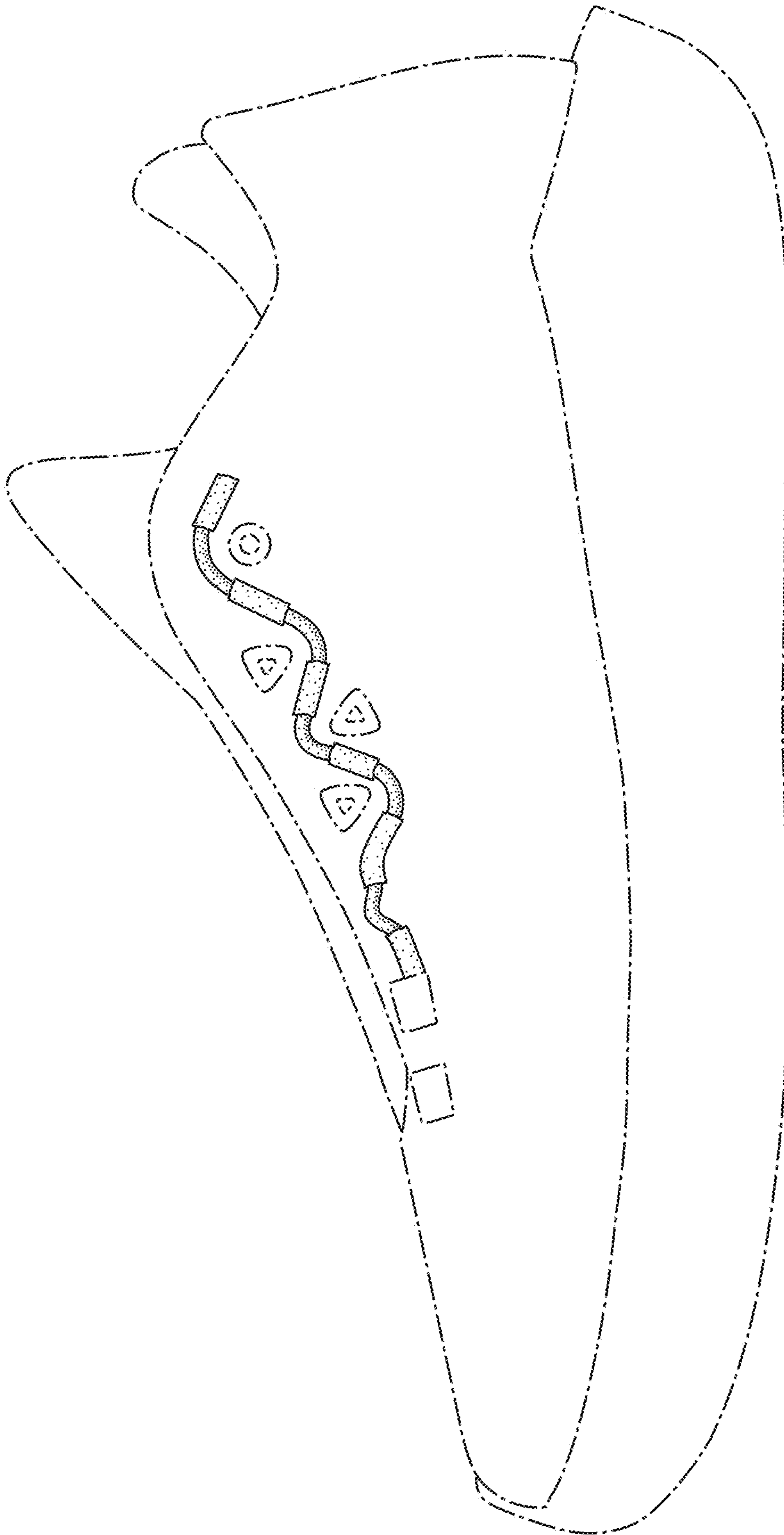

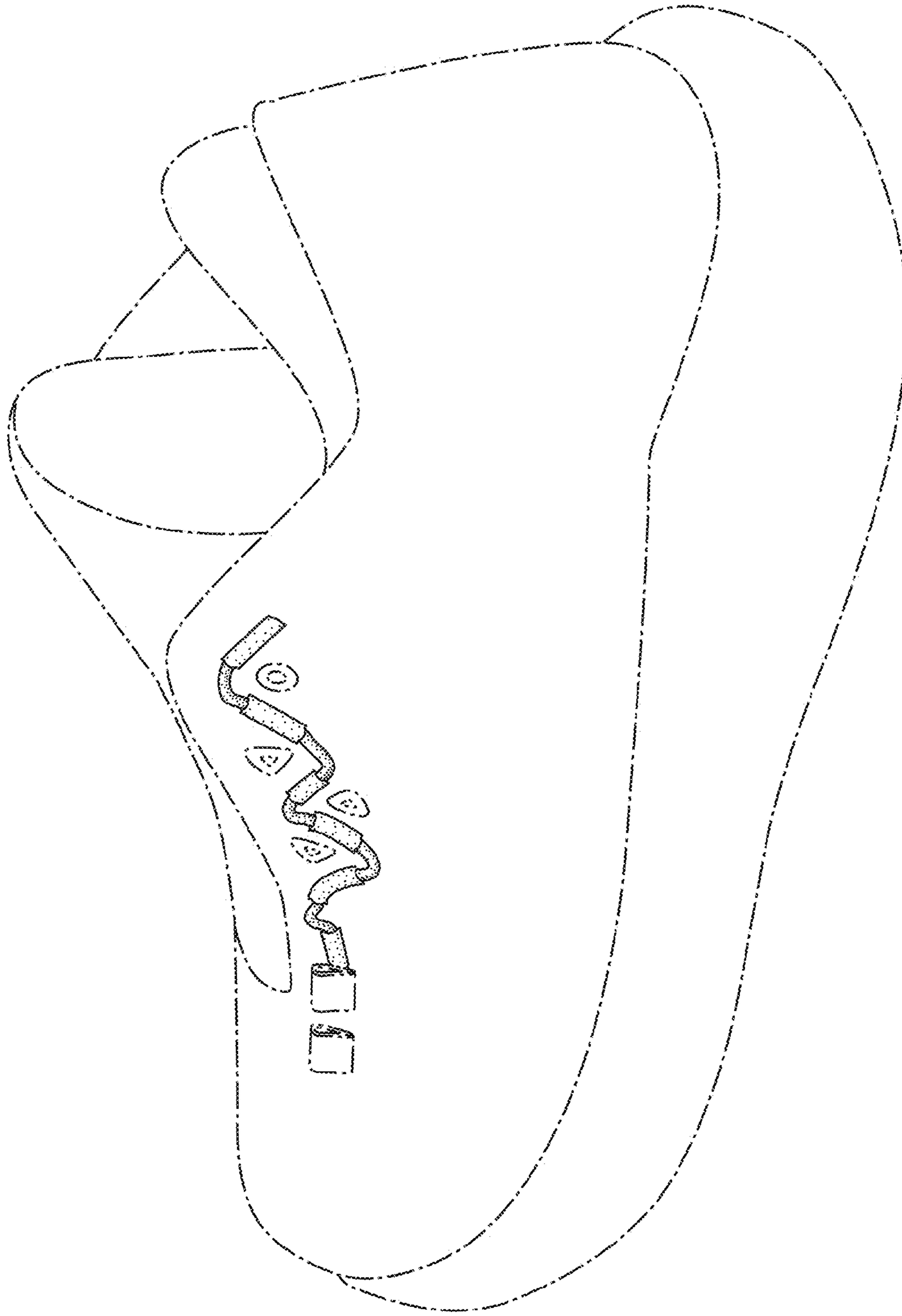

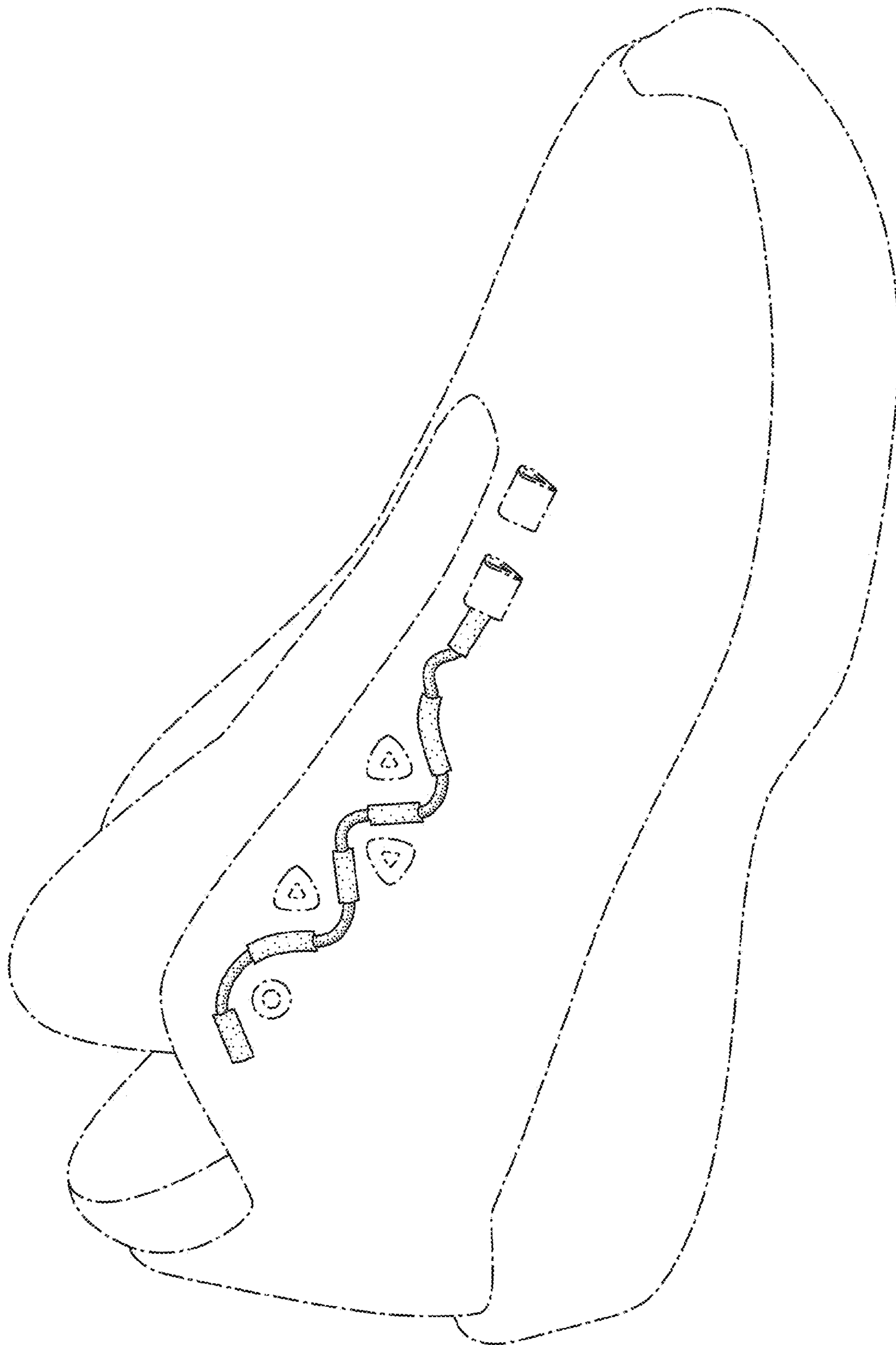

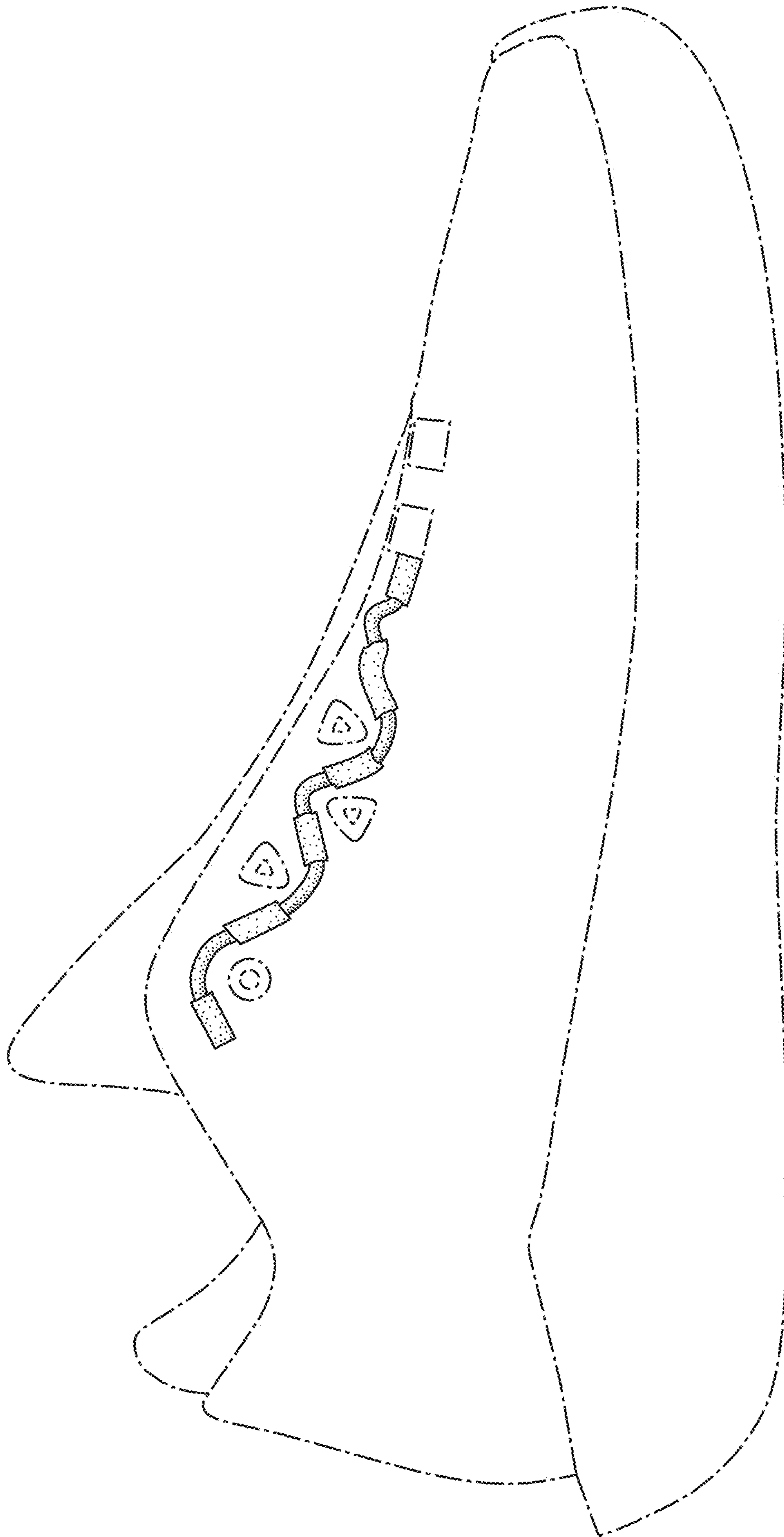

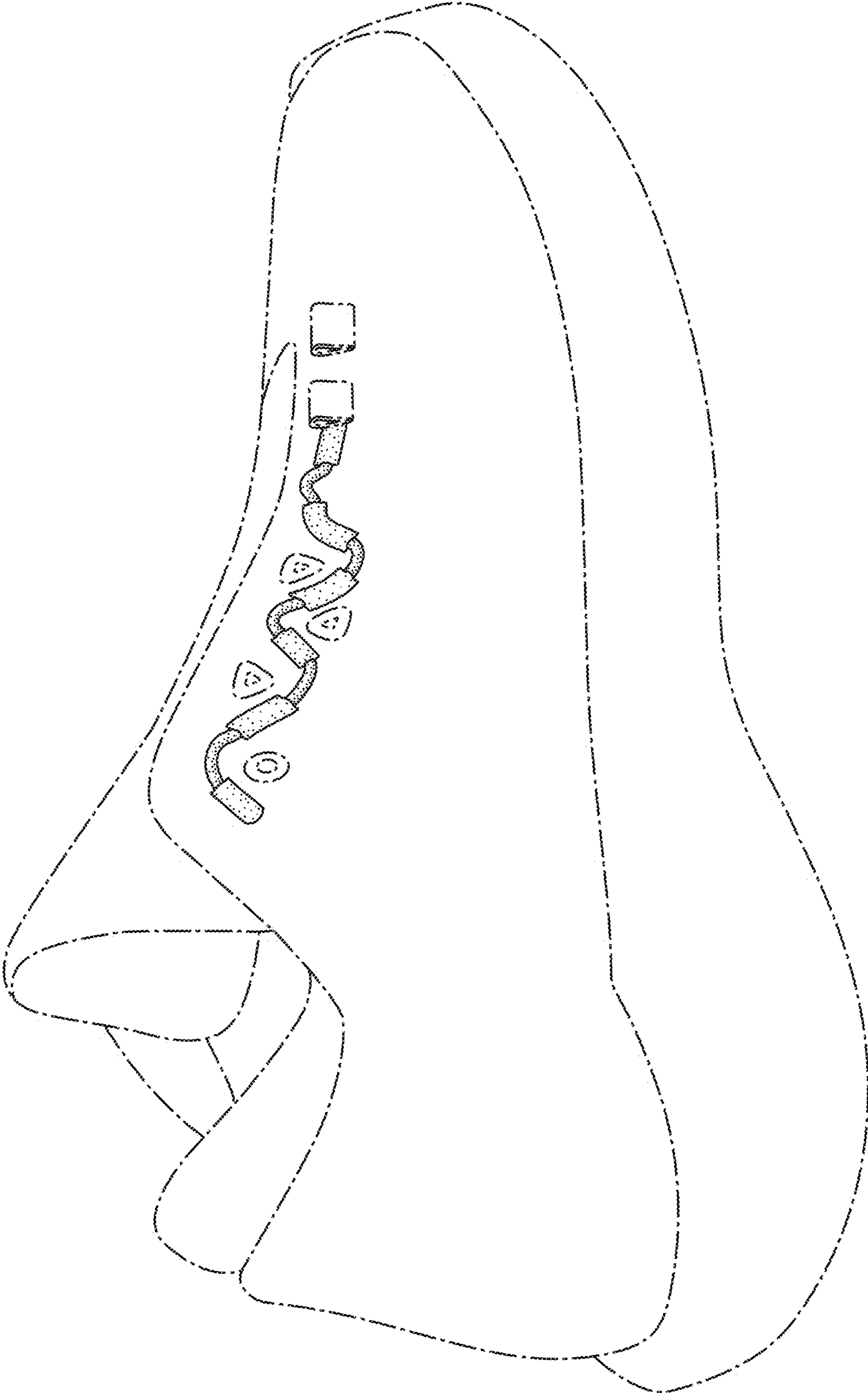
