(57) **CLAIM**

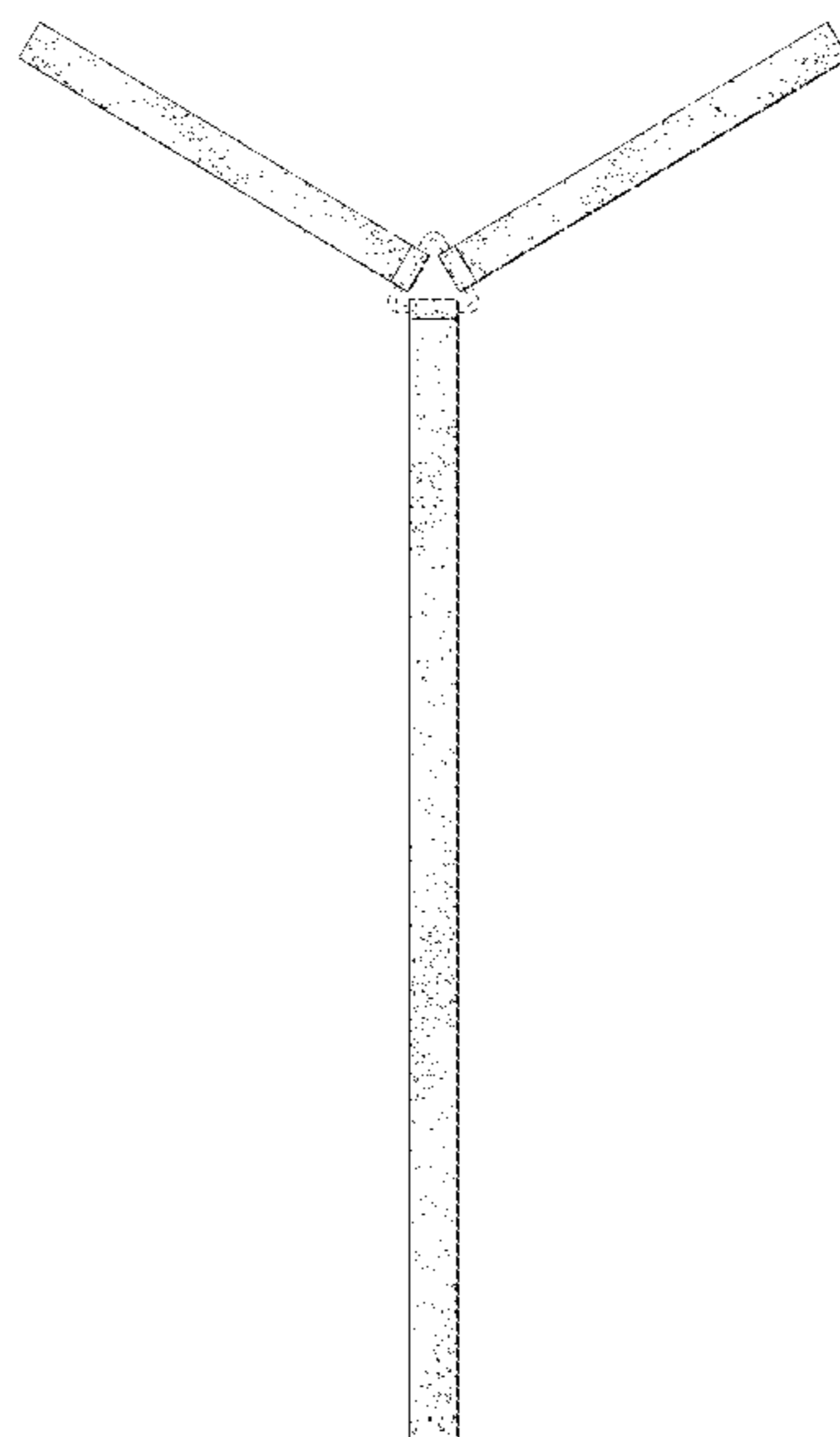
The ornamental design of a container securing device, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a container securing device illustrating the new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a top elevational view thereof;
FIG. 4 is a bottom side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof; and,
FIG. 7 is a front view thereof showing the straps of the container securing device in a bent position.
The broken lines in the drawings are included for the purpose of illustrating portions of the container securing device that form no part of the claimed design.

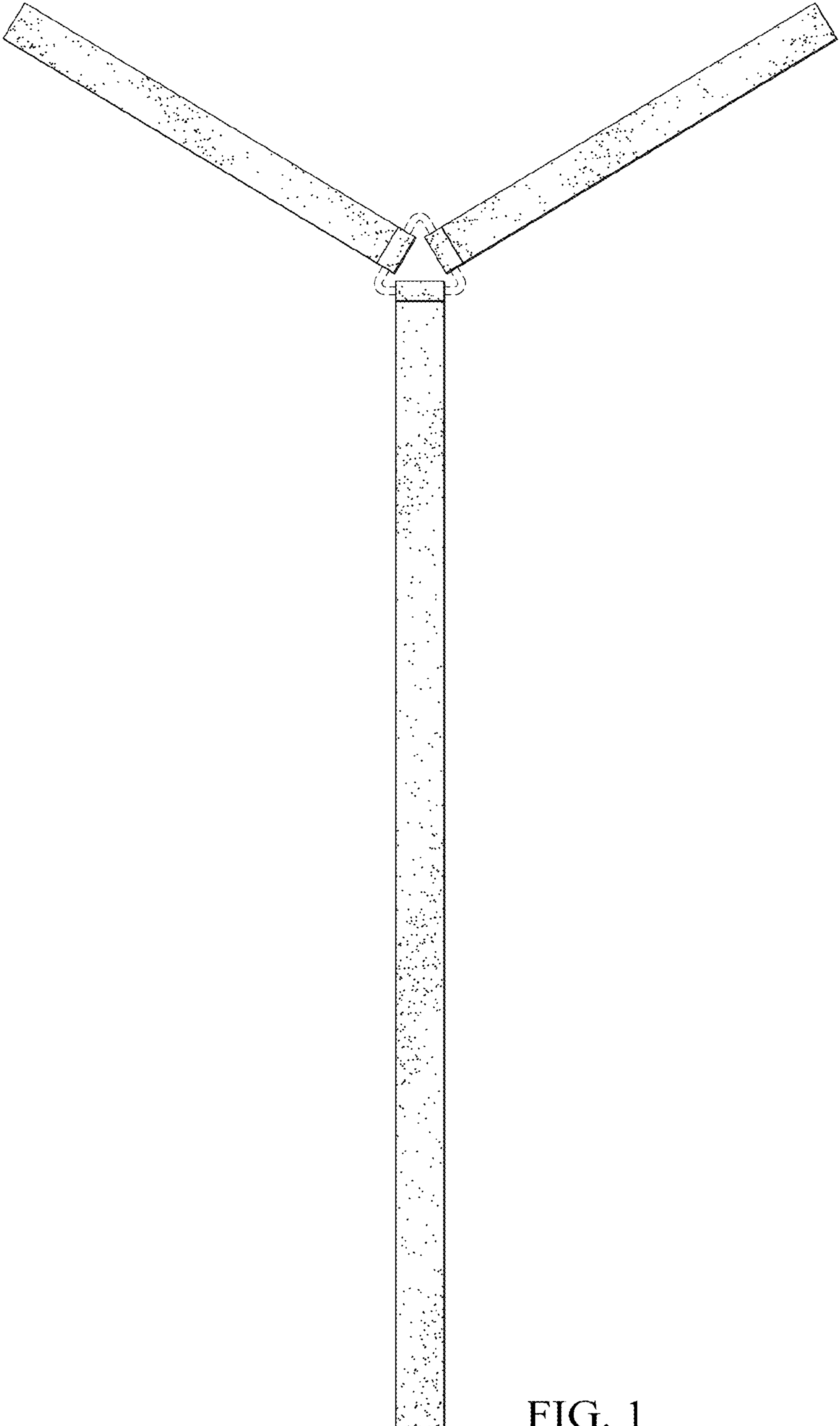

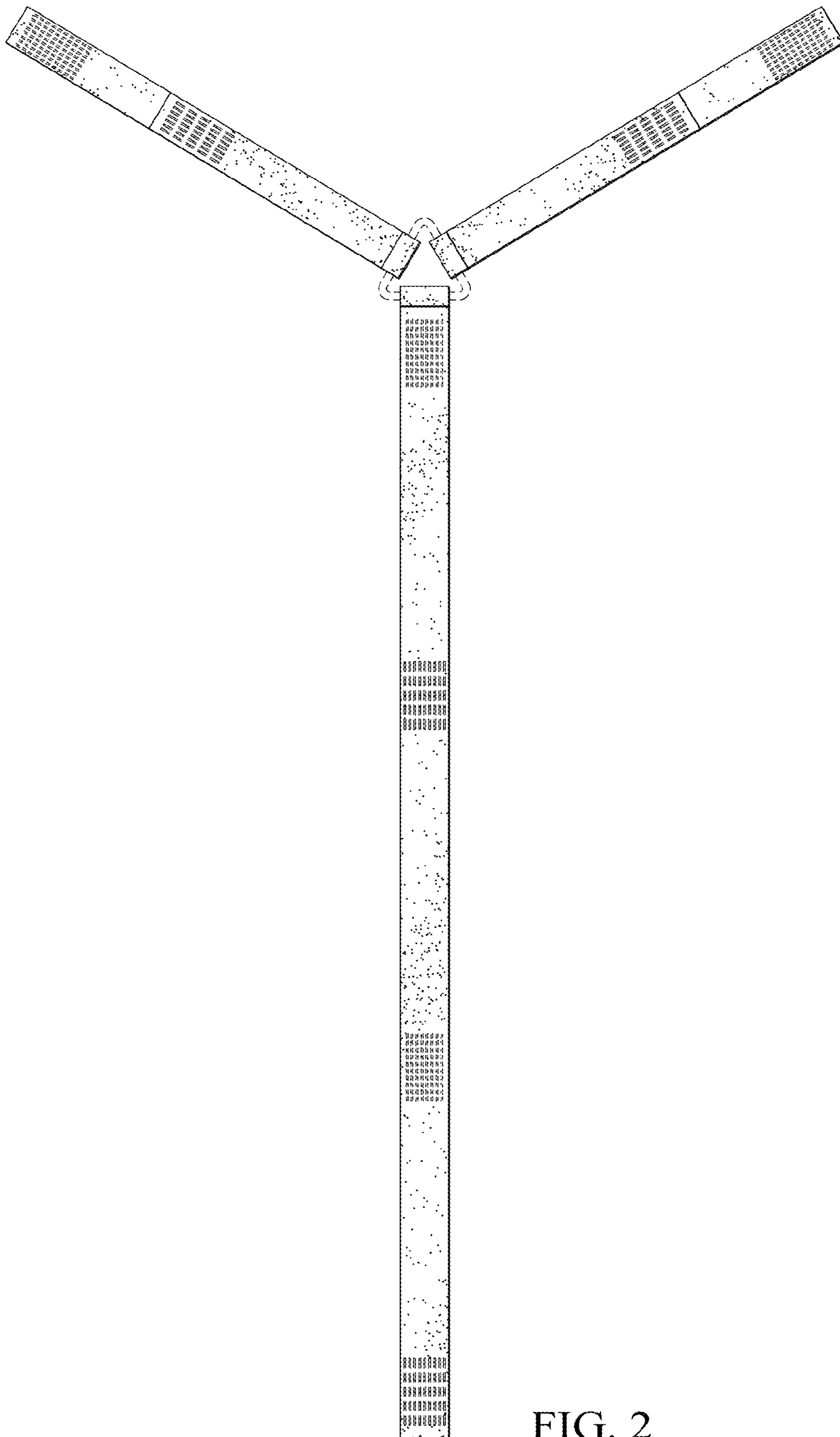

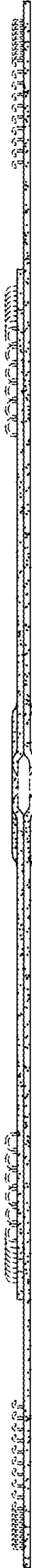

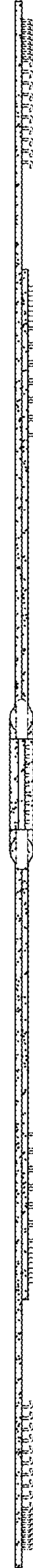

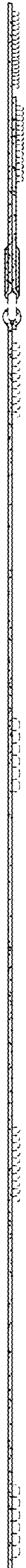

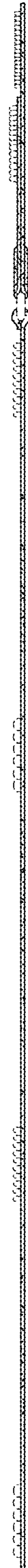

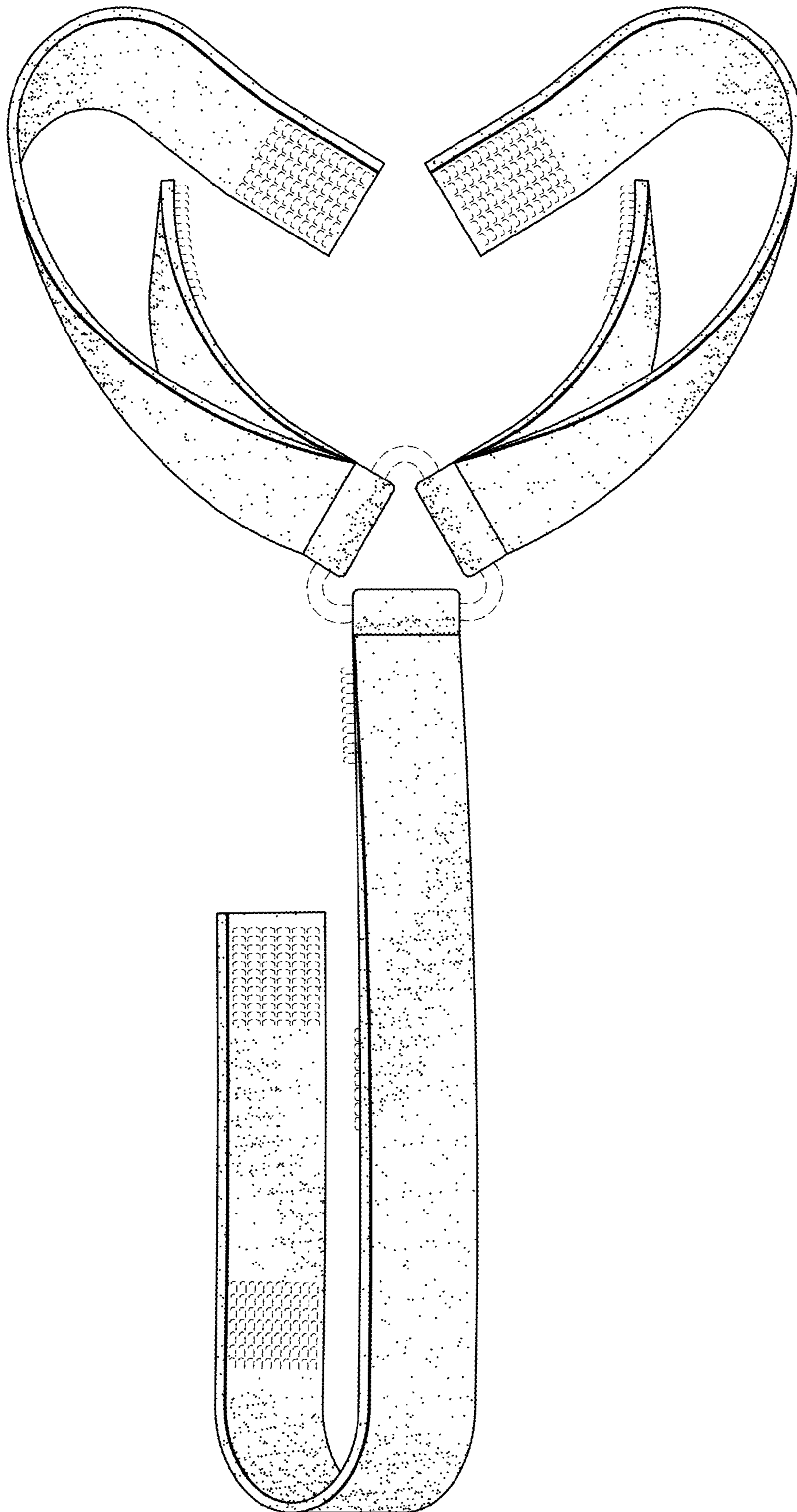
