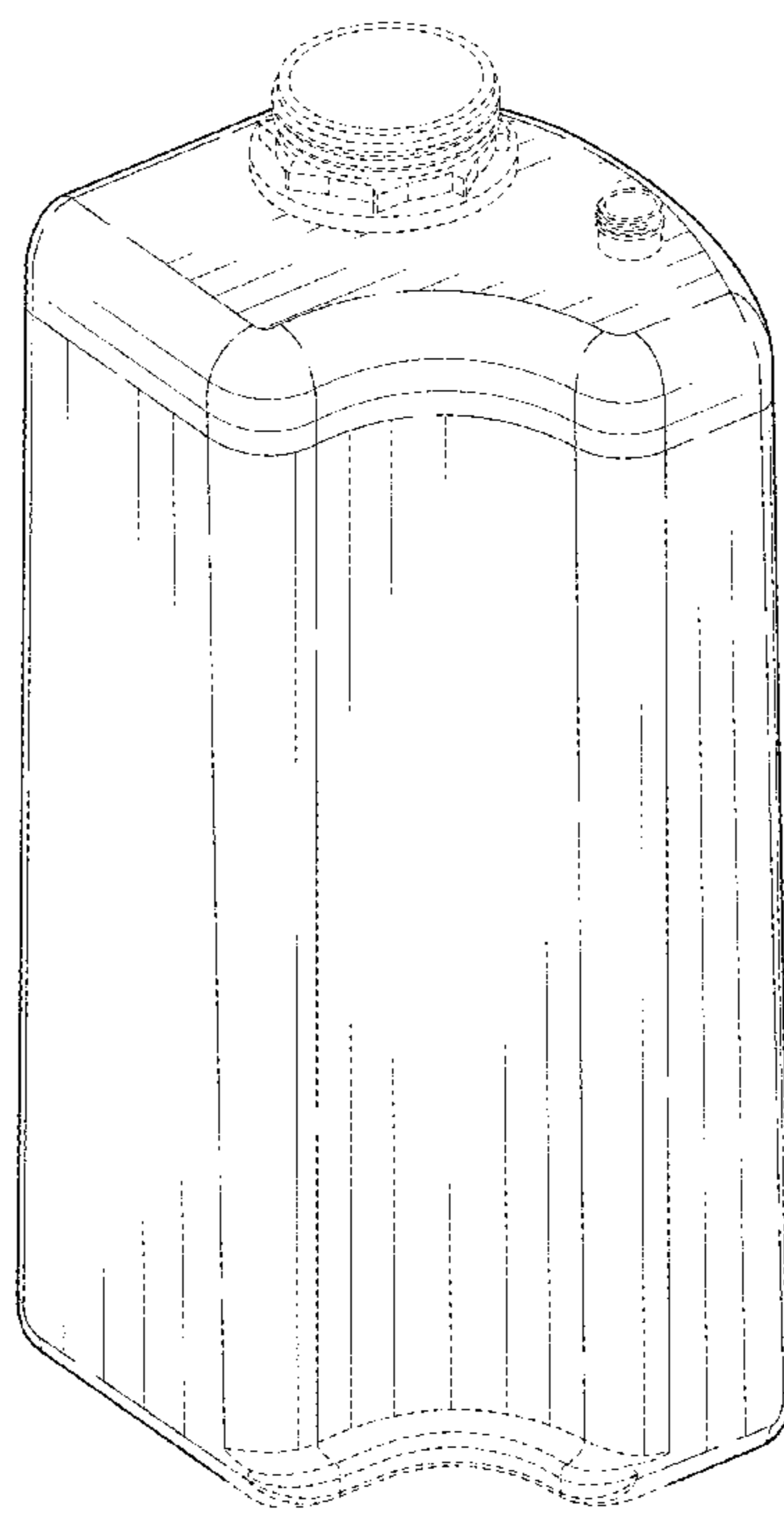

DESCRIPTION

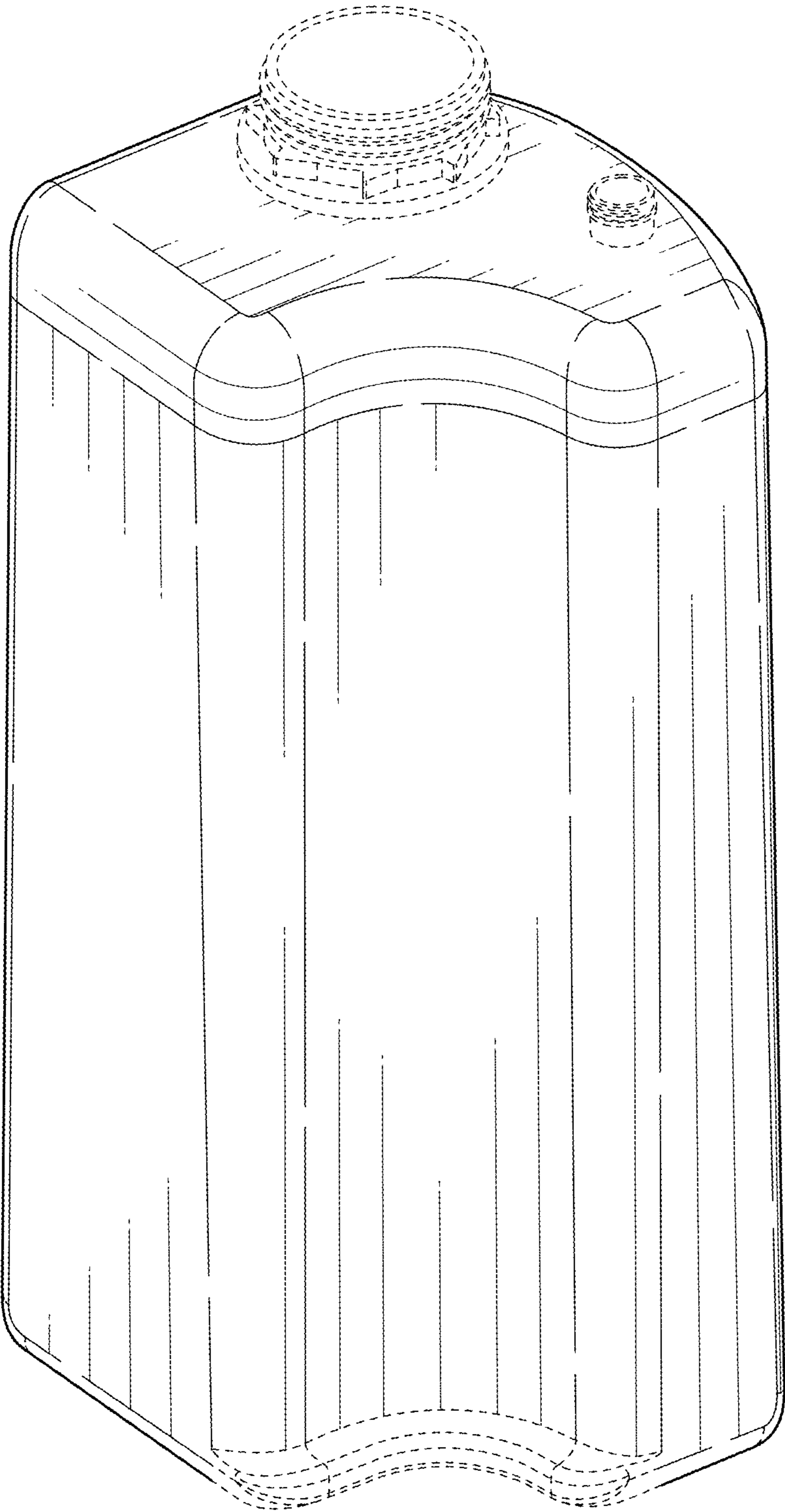

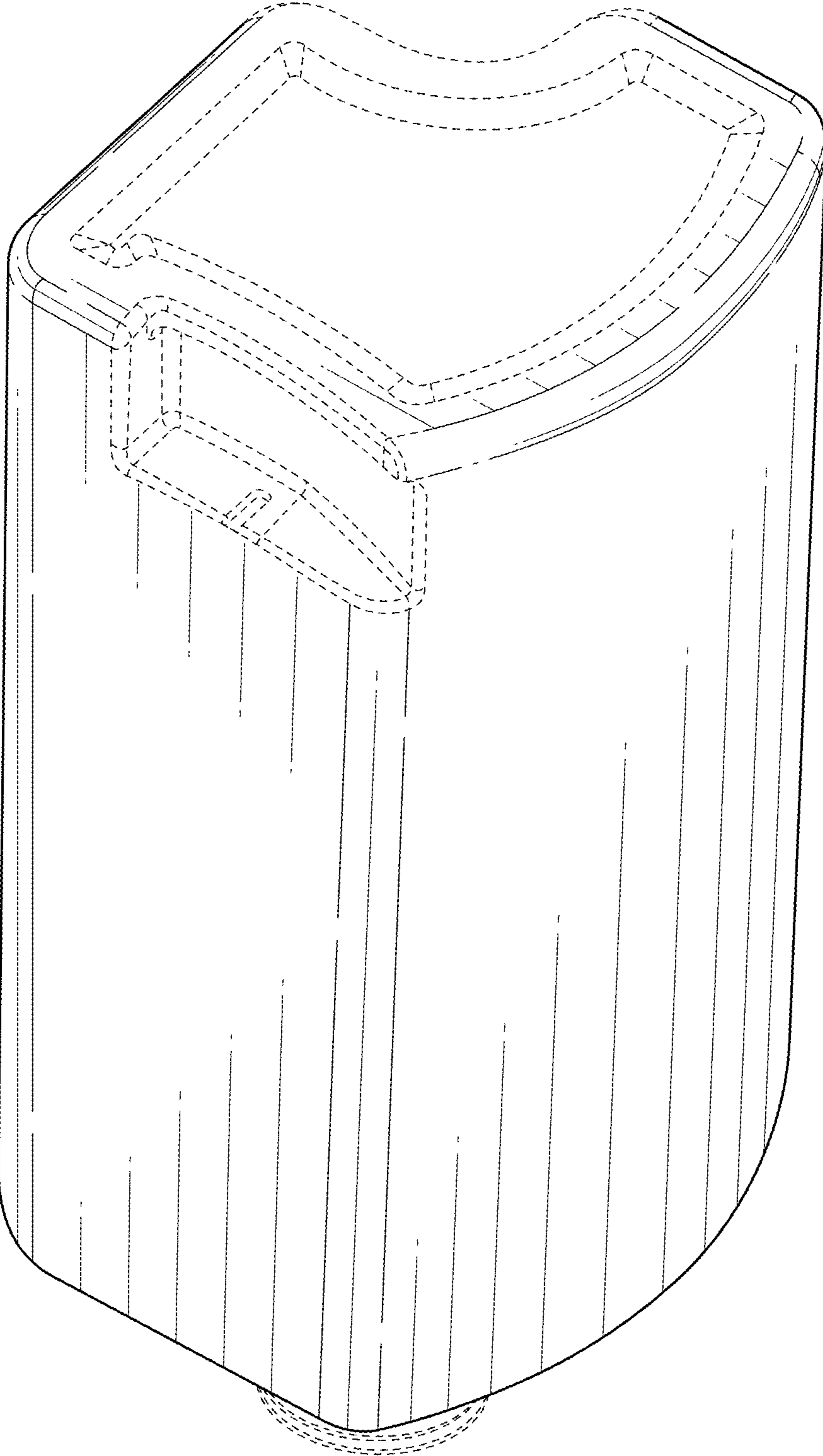

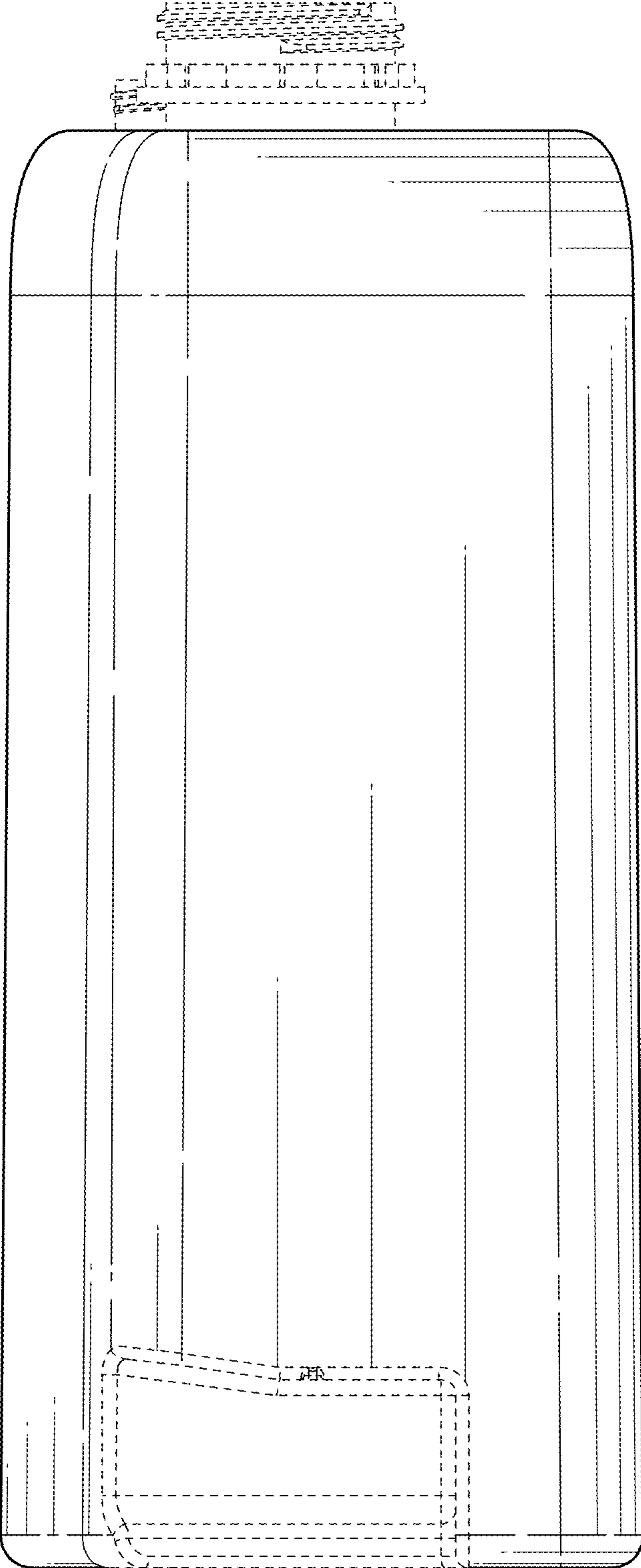

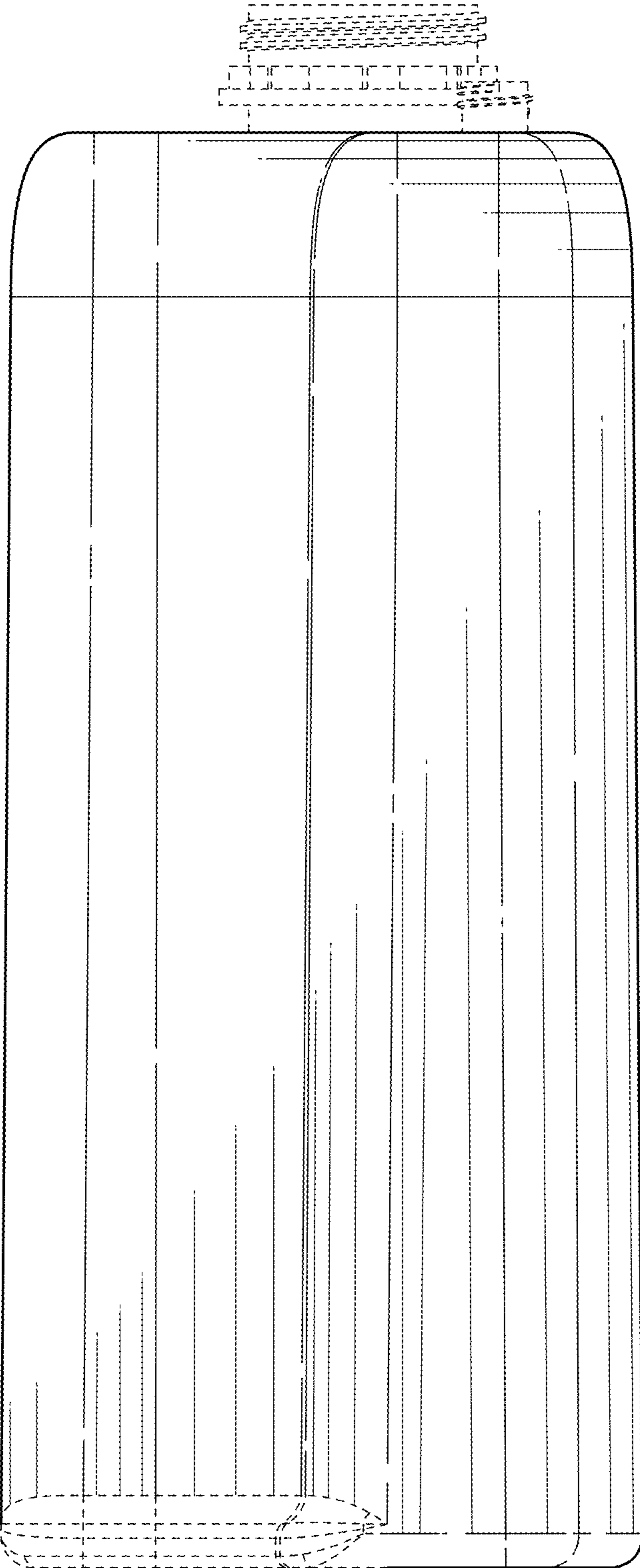

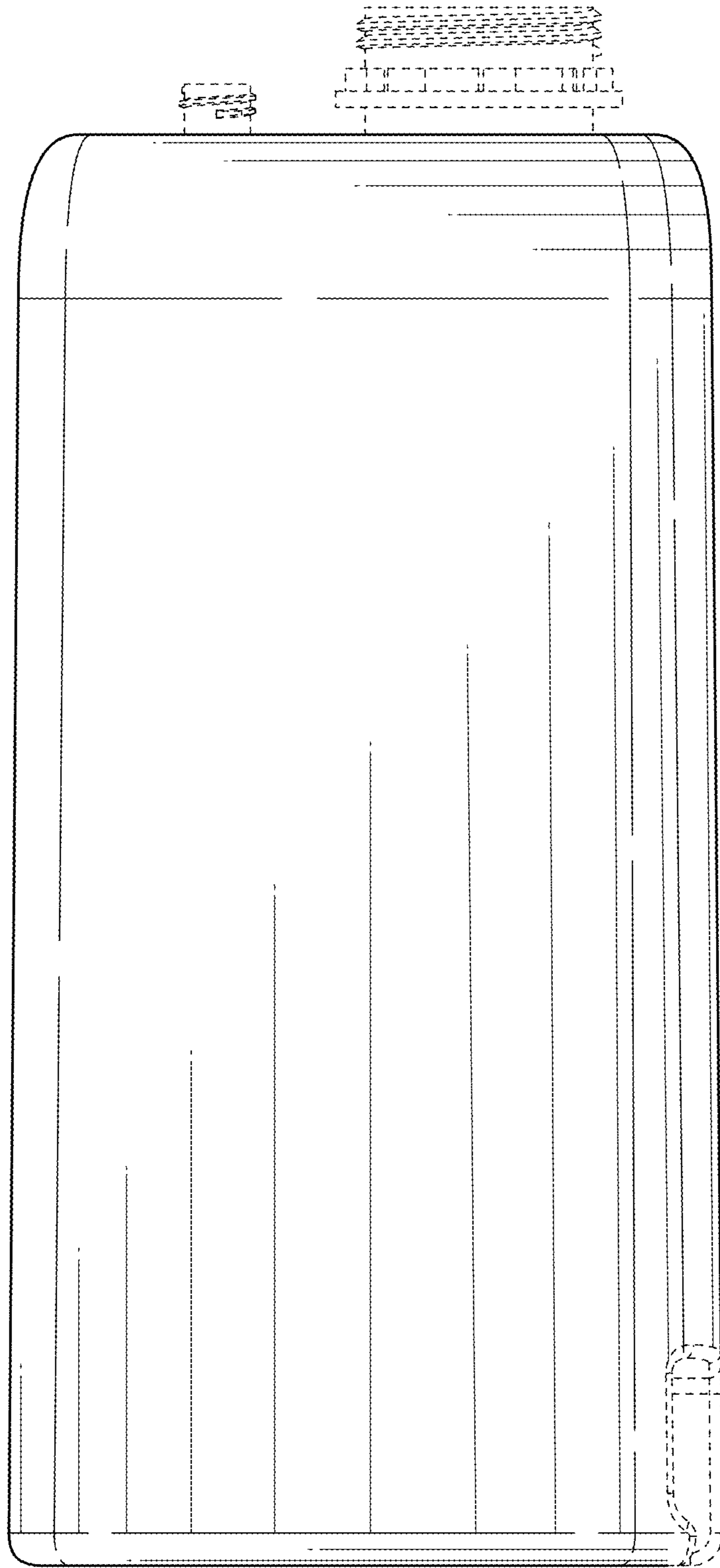

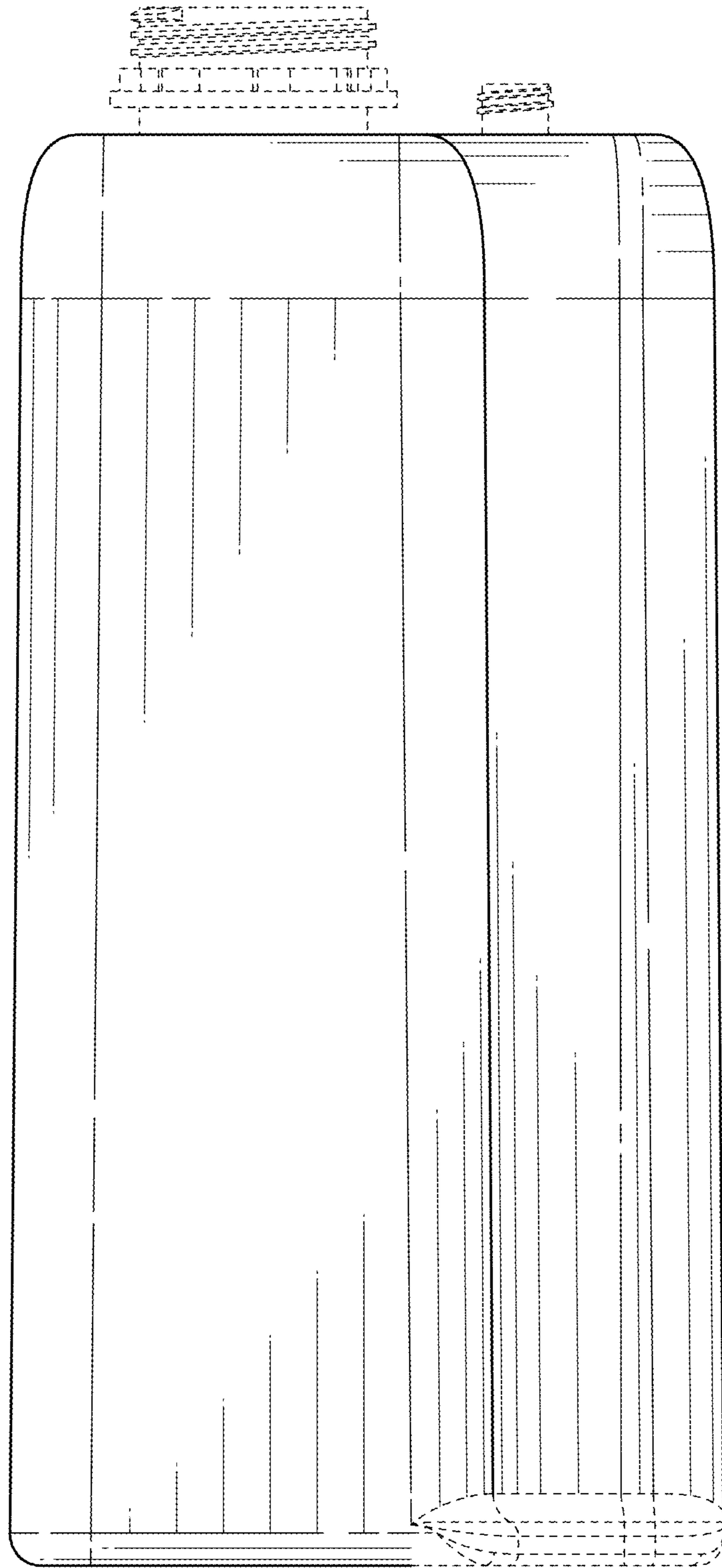

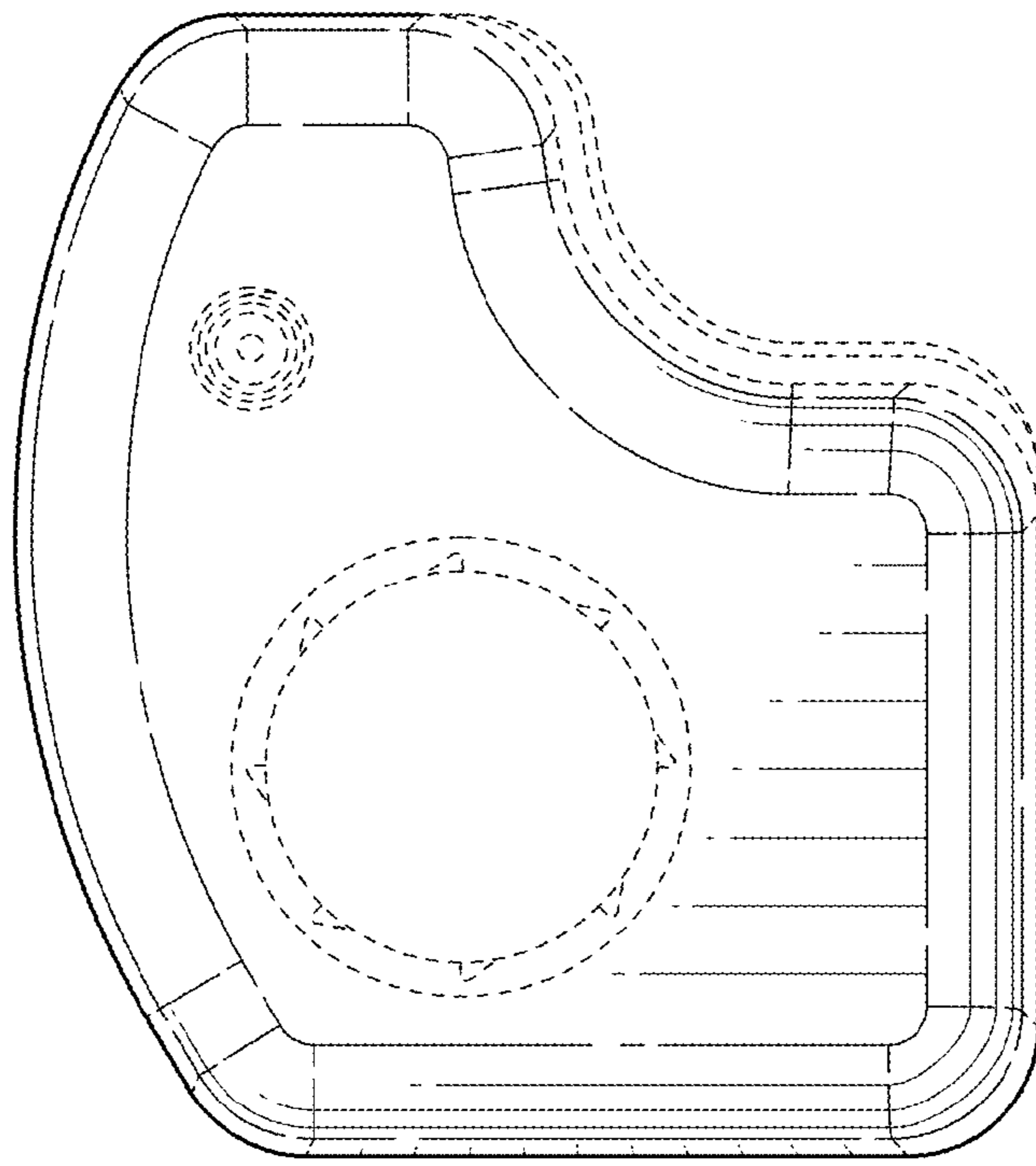

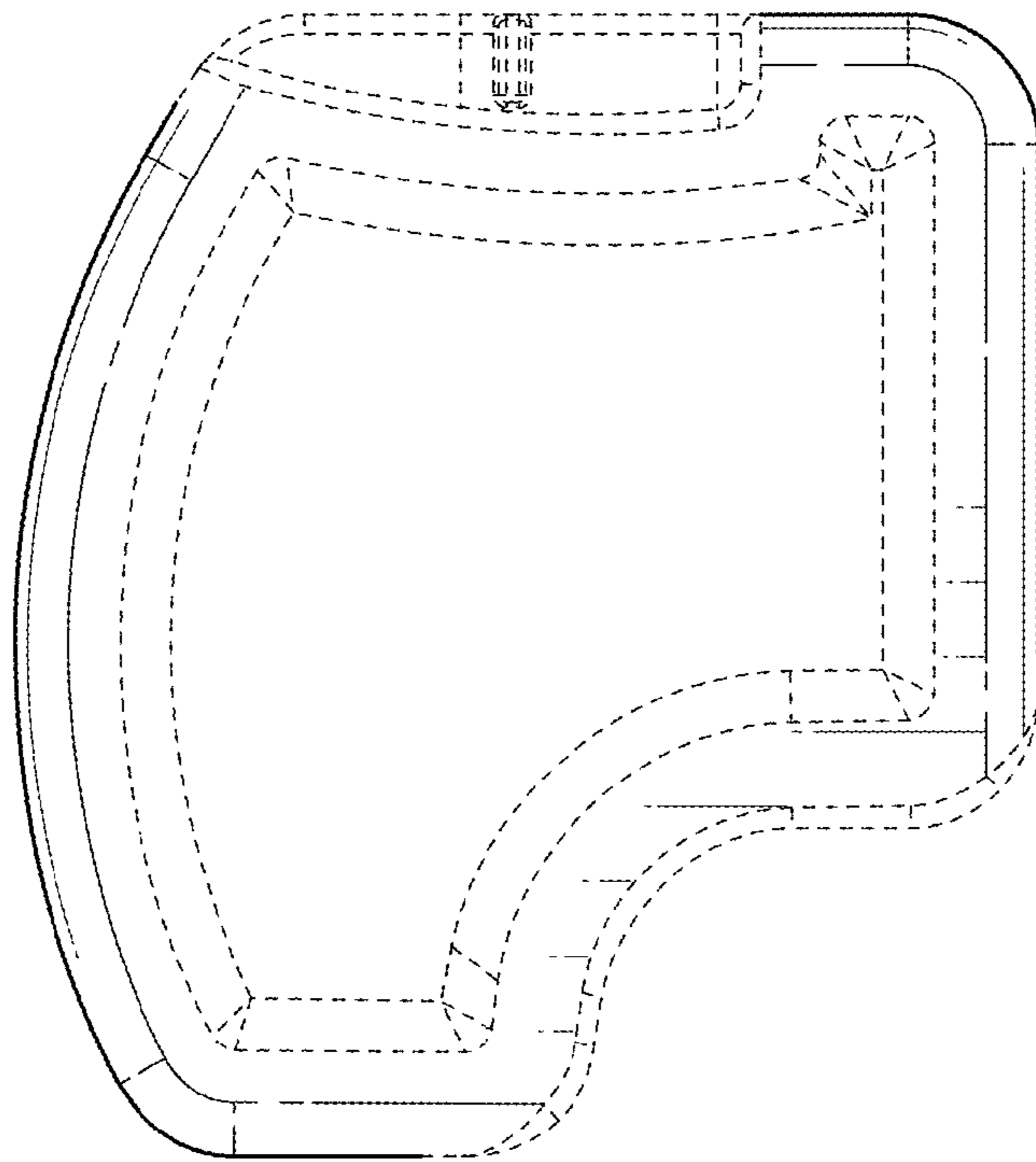
