(57) **CLAIM**

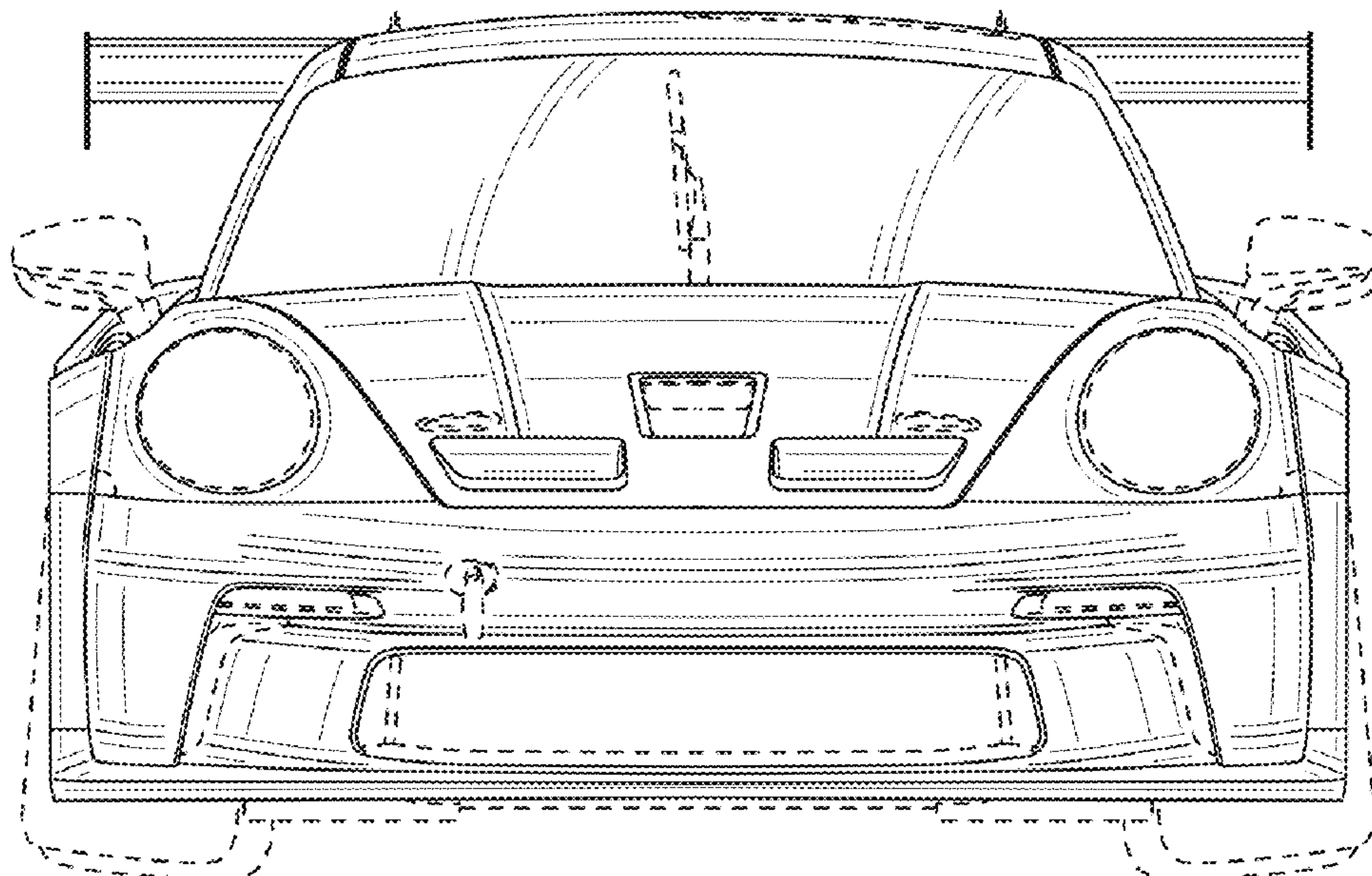
The ornamental design for a motor vehicle body, toy vehicle body replica and/or other replica, as shown and described.

**DESCRIPTION**

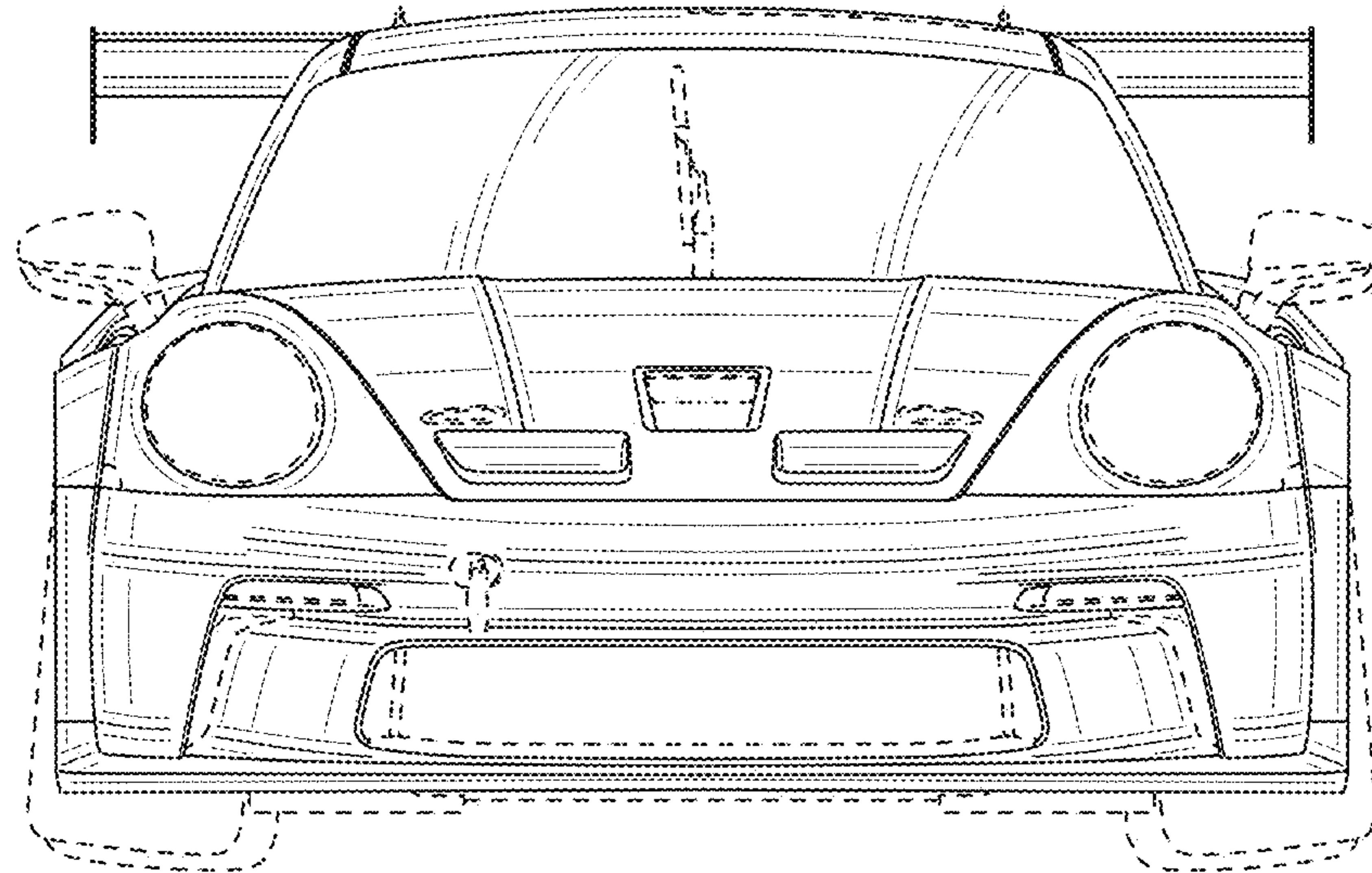

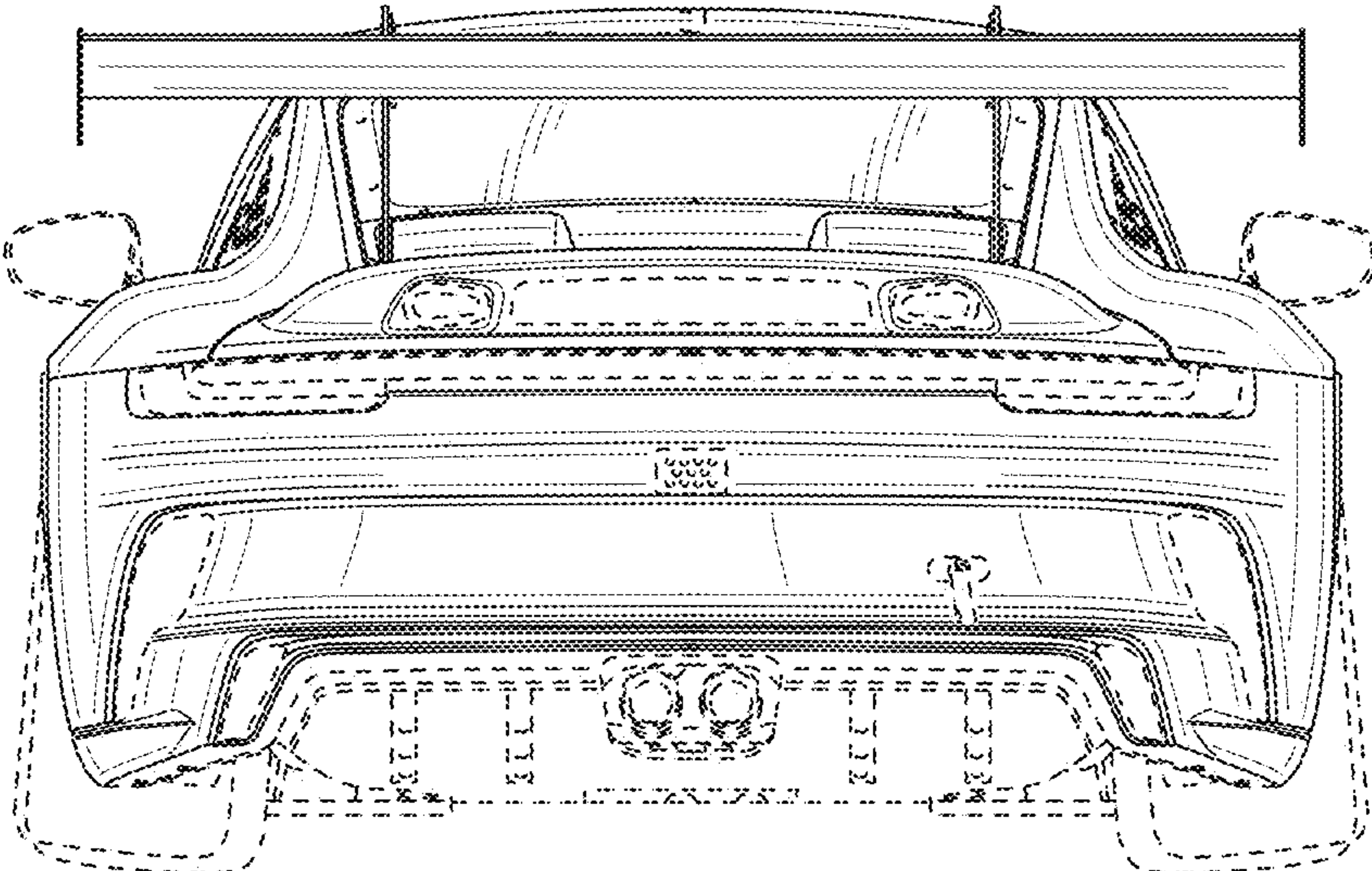

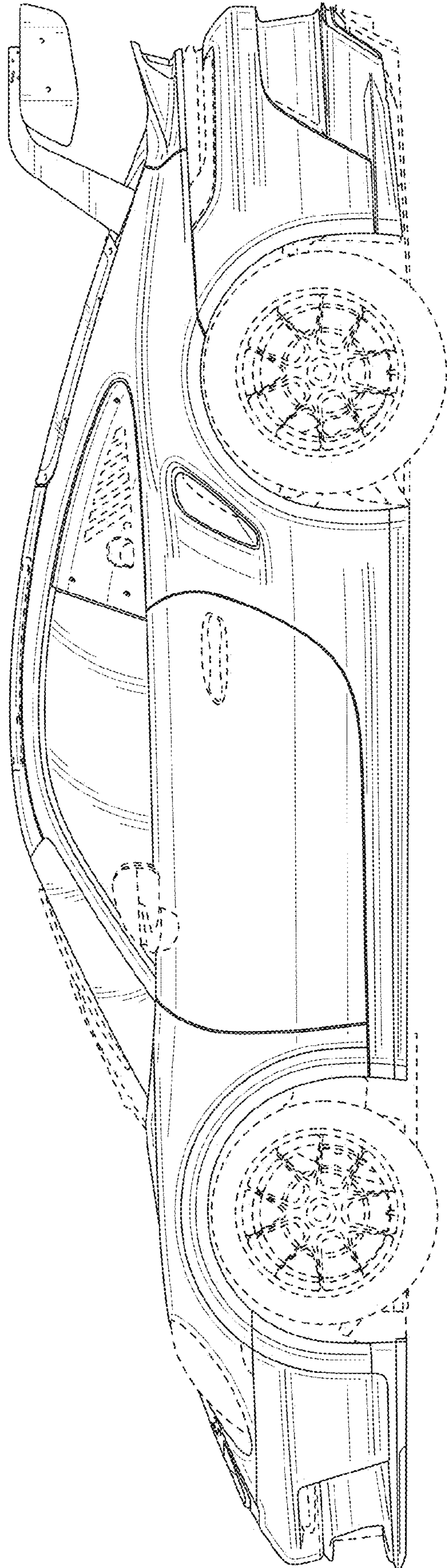
