**DESCRIPTION**


FIG. 1 is a front view of a vehicle grille with repeating mesh pattern;


FIG. 2 is an enlarged view taken at the broken line boundary in FIG. 1;

FIG. 3 is a perspective view thereof; and,


FIG. 4 is an enlarged view taken at the broken line boundary in FIG. 3.

The broken lines in the drawings represent the boundaries of the claimed design and form no part thereof. The claimed design is indicated in FIGS. 1 and 3 by the relatively darker portions of the vehicle grille with repeating mesh pattern, while the relatively lighter portions form no part of the claimed design.




