DESCRIPTION

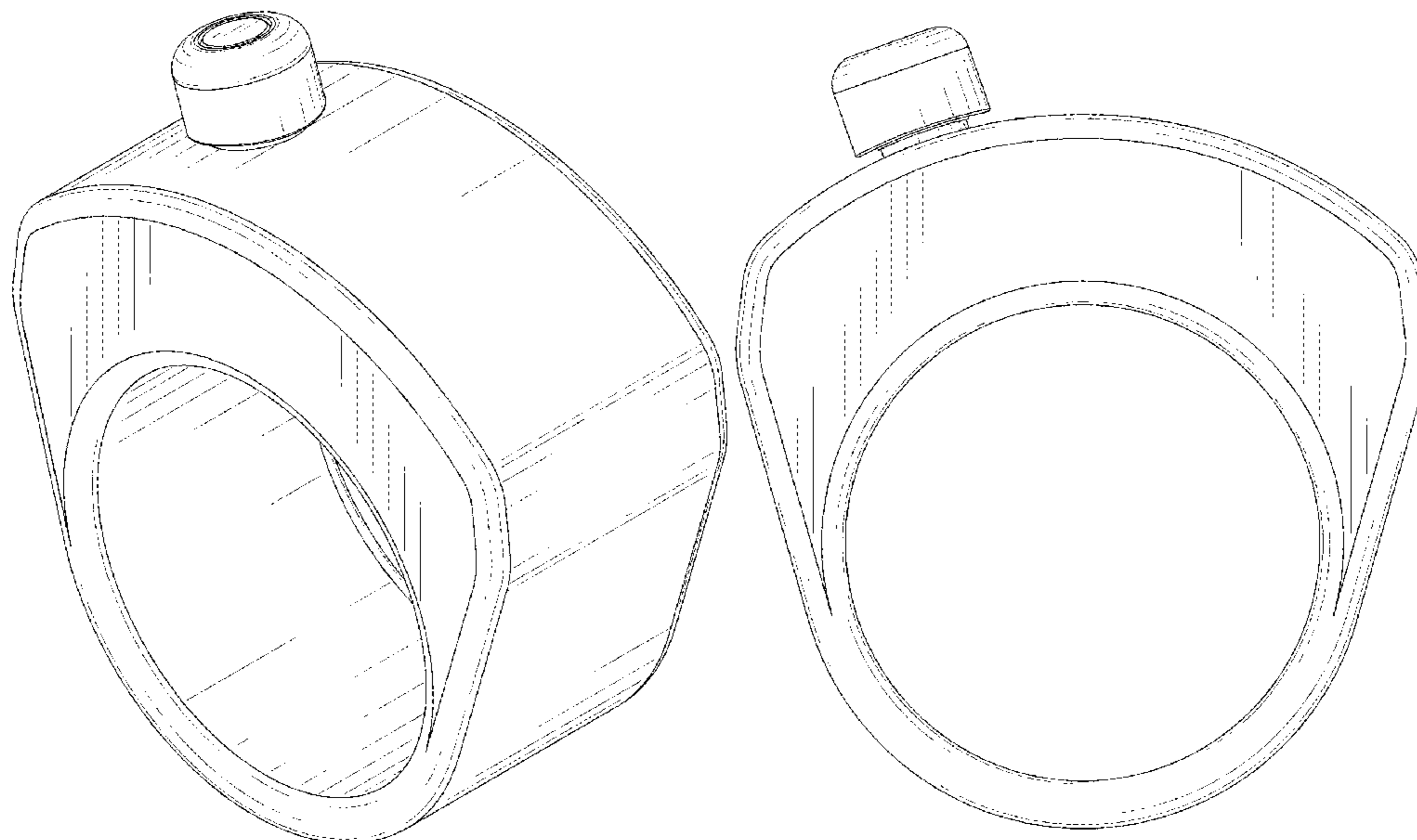
FIG. 1 is a front-top-right perspective view of a wireless controller showing my new design;

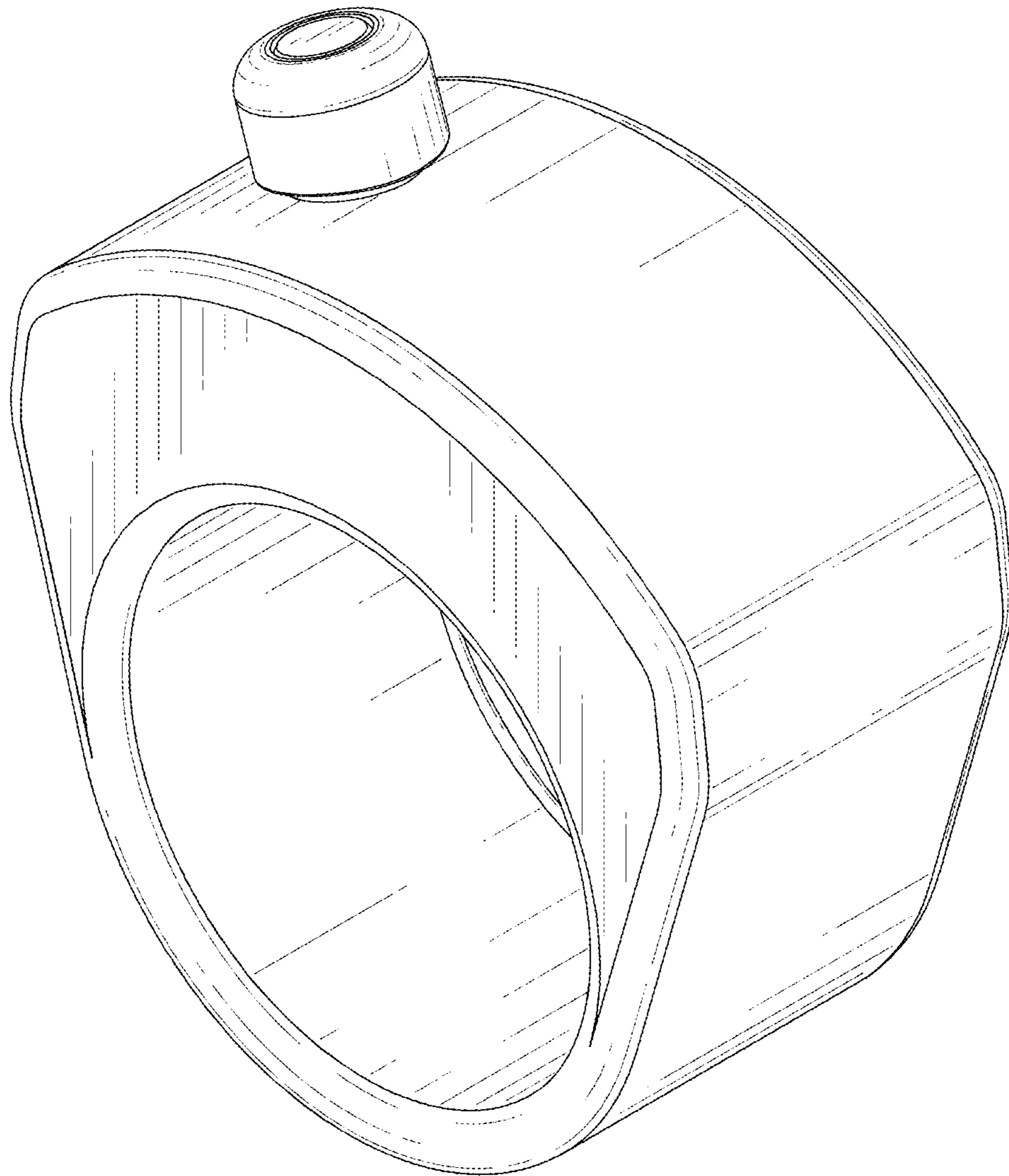

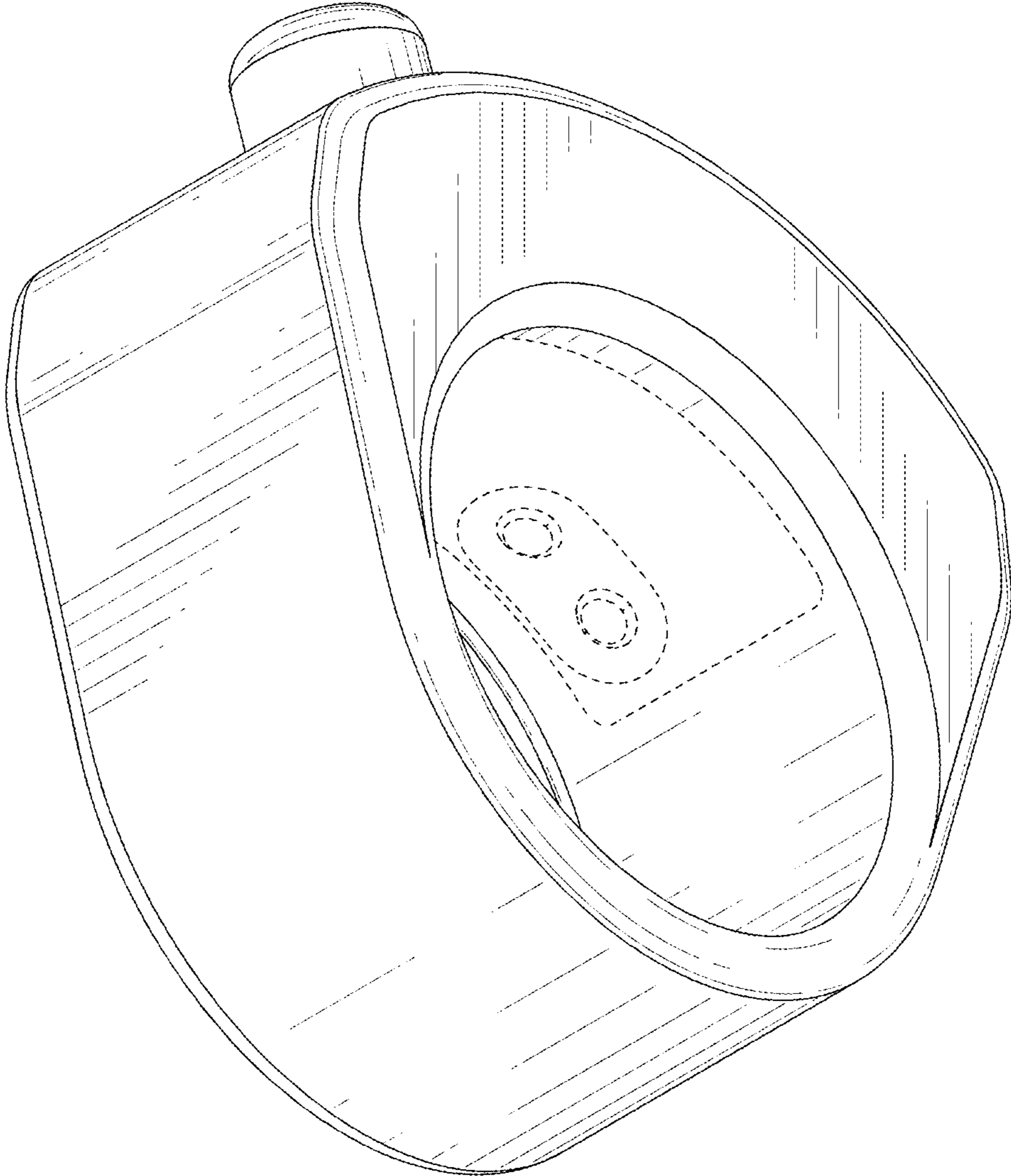

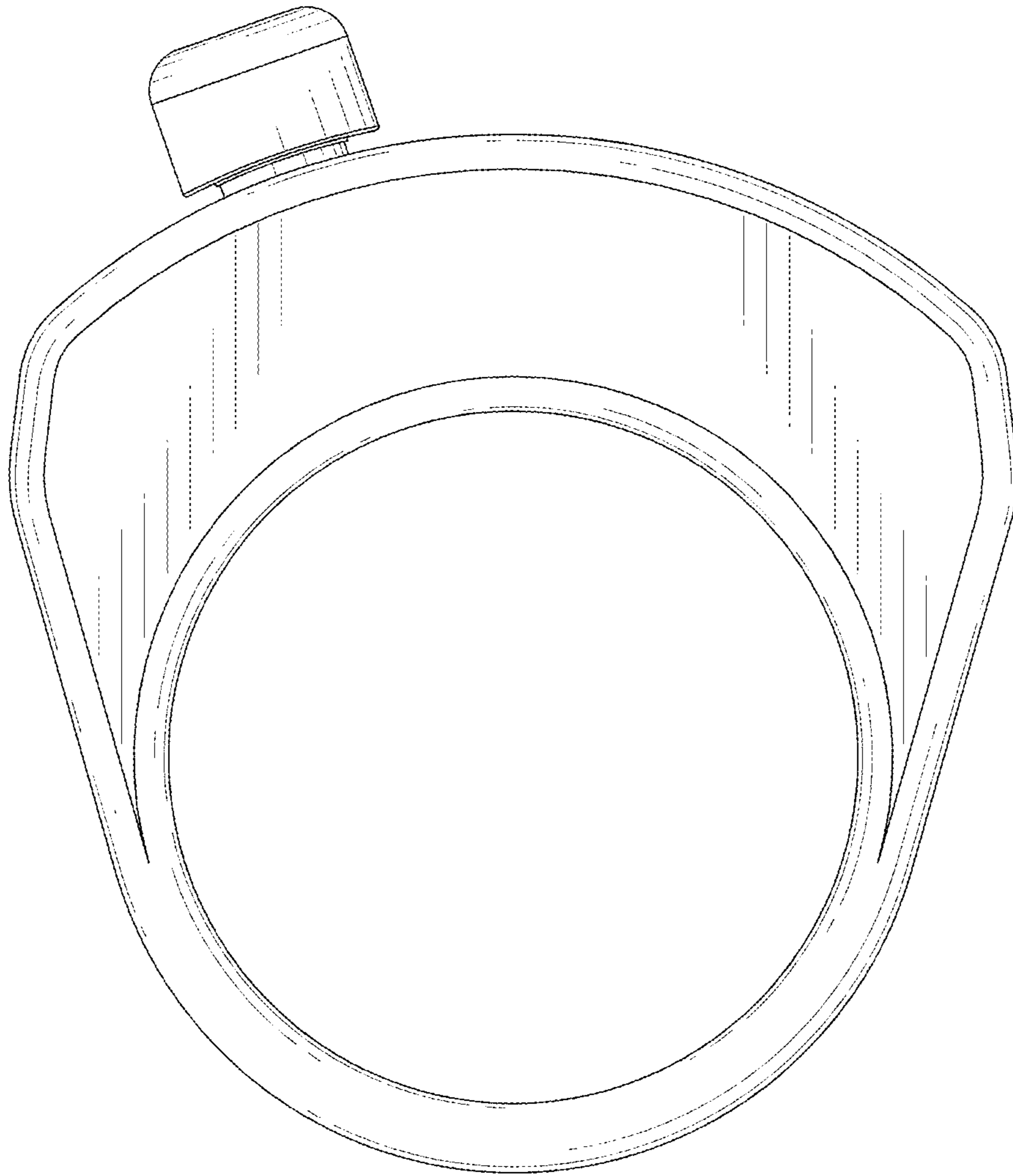

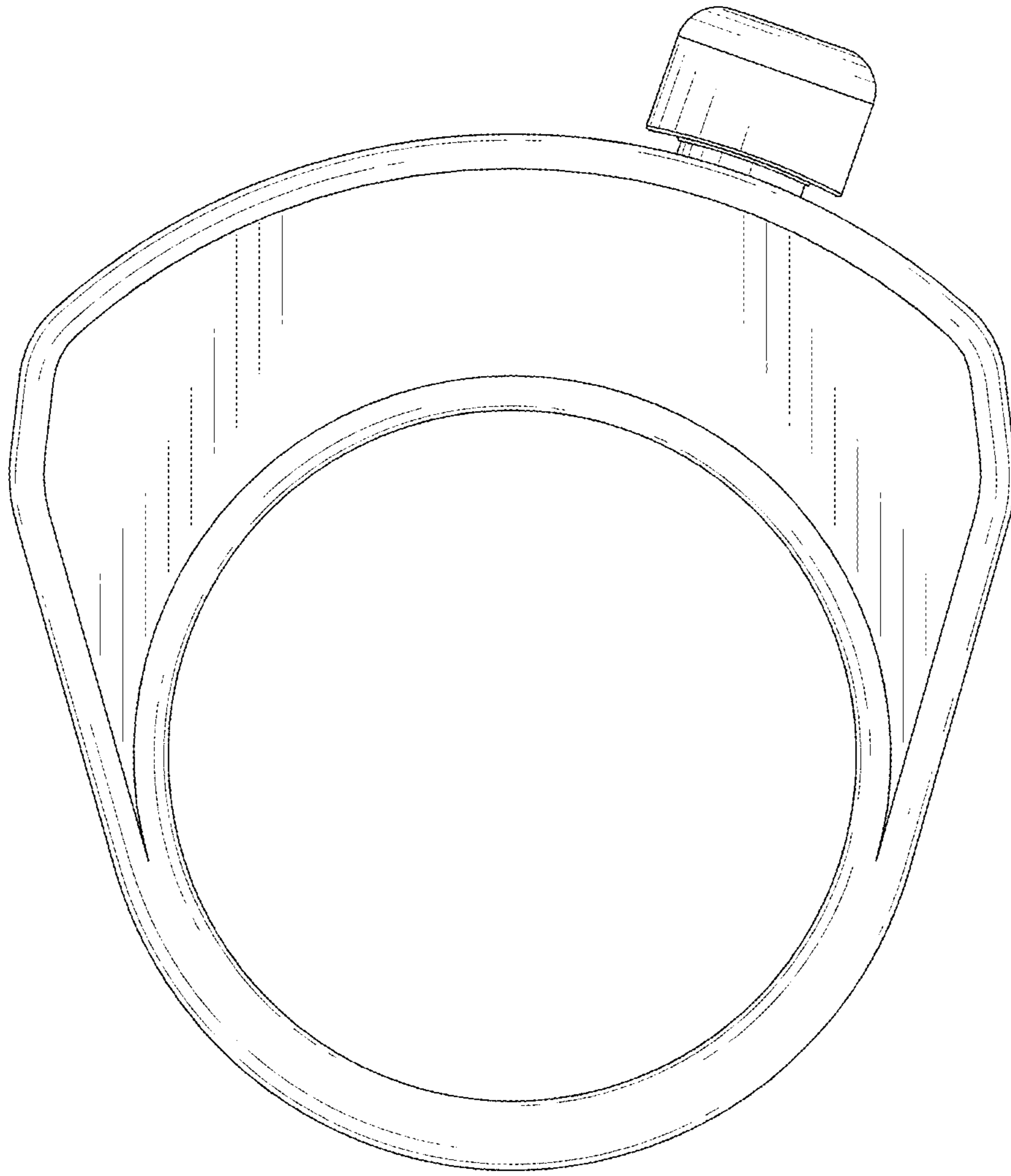

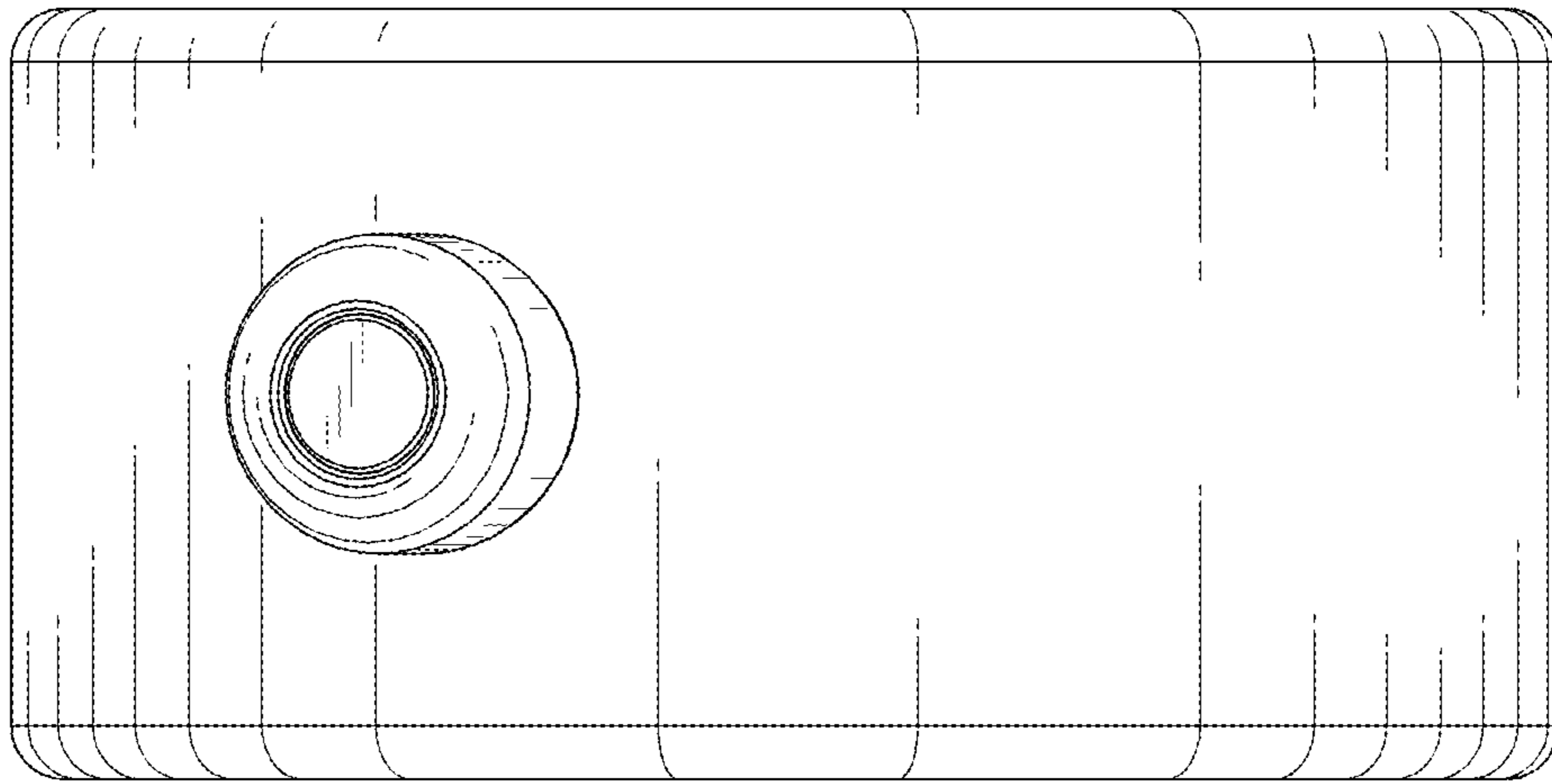

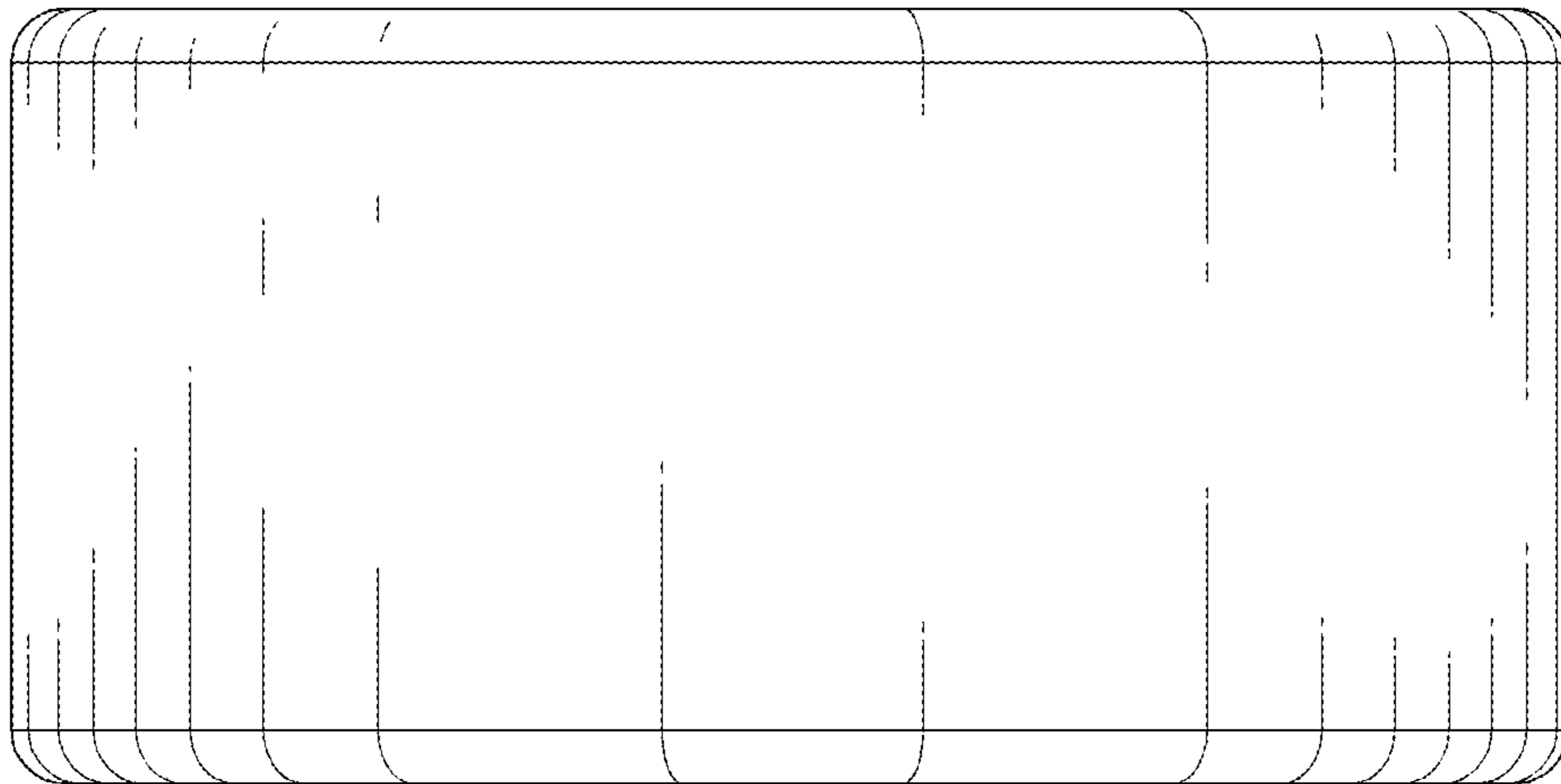

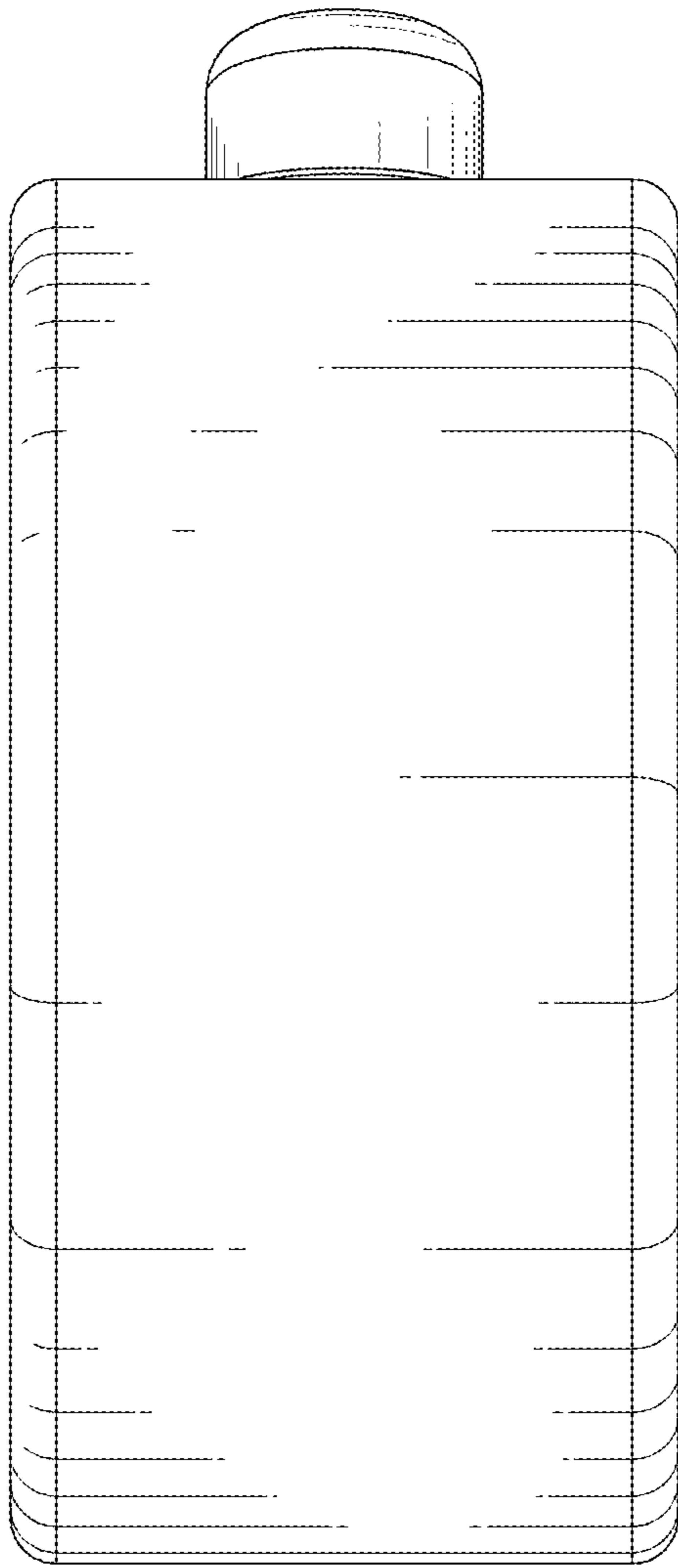

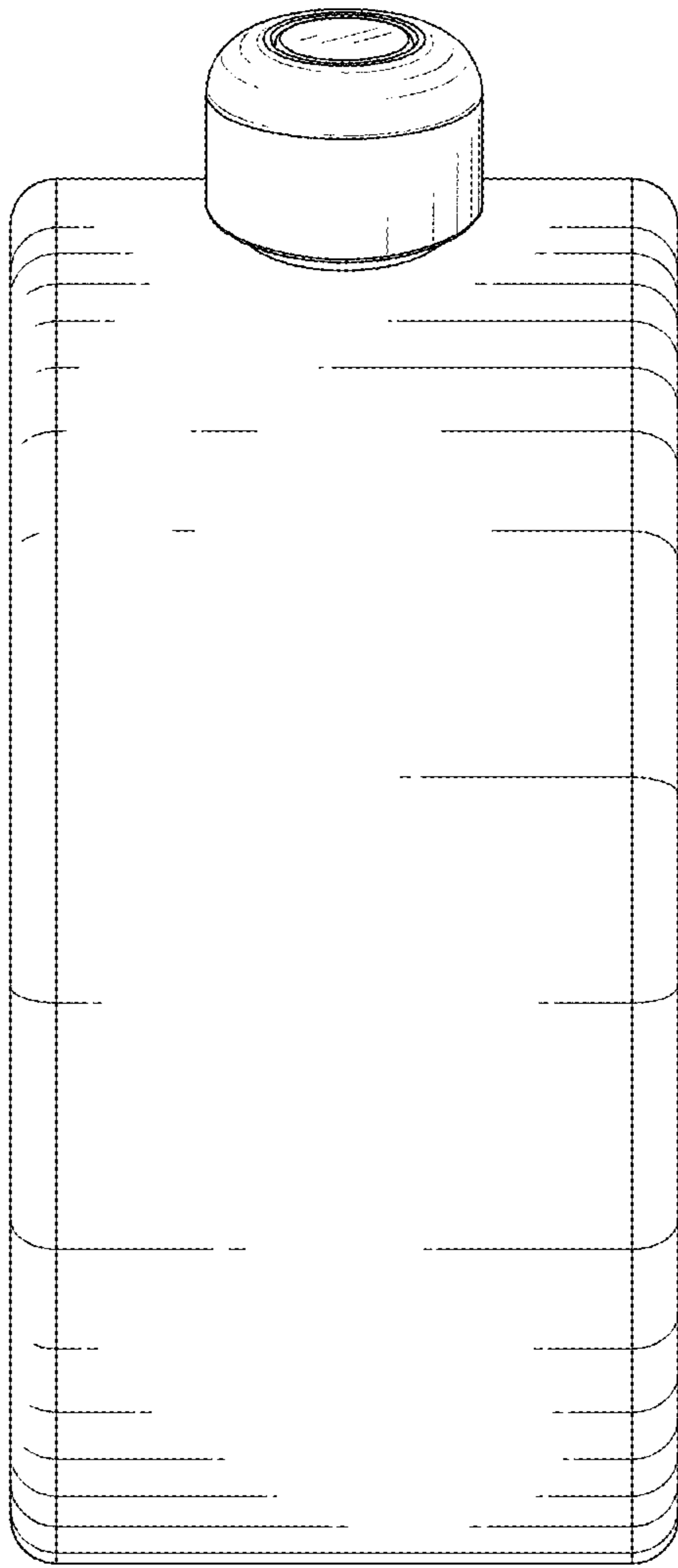
