The ornamental design for a smartphone holder for vehicles, as shown and described.

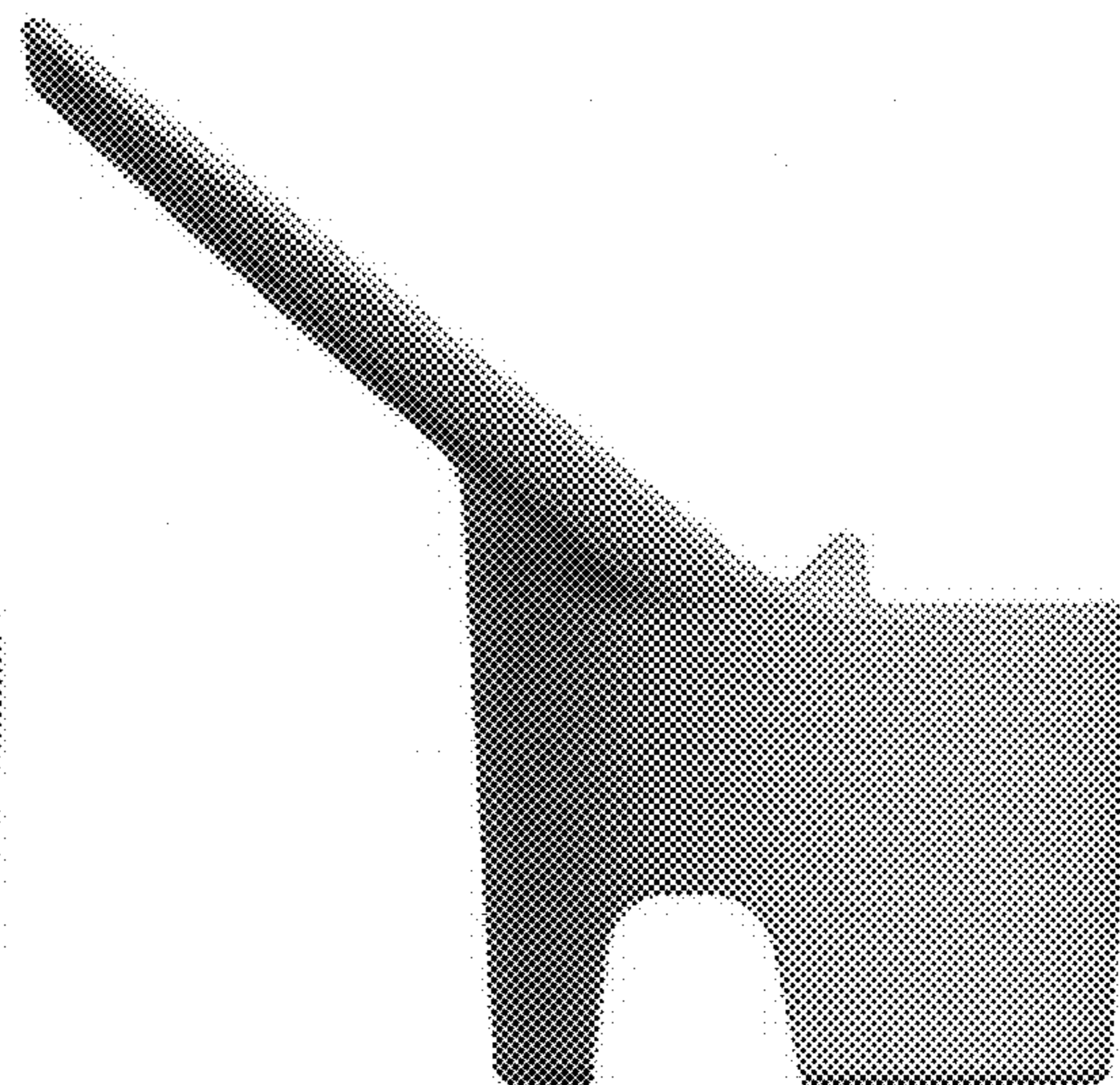
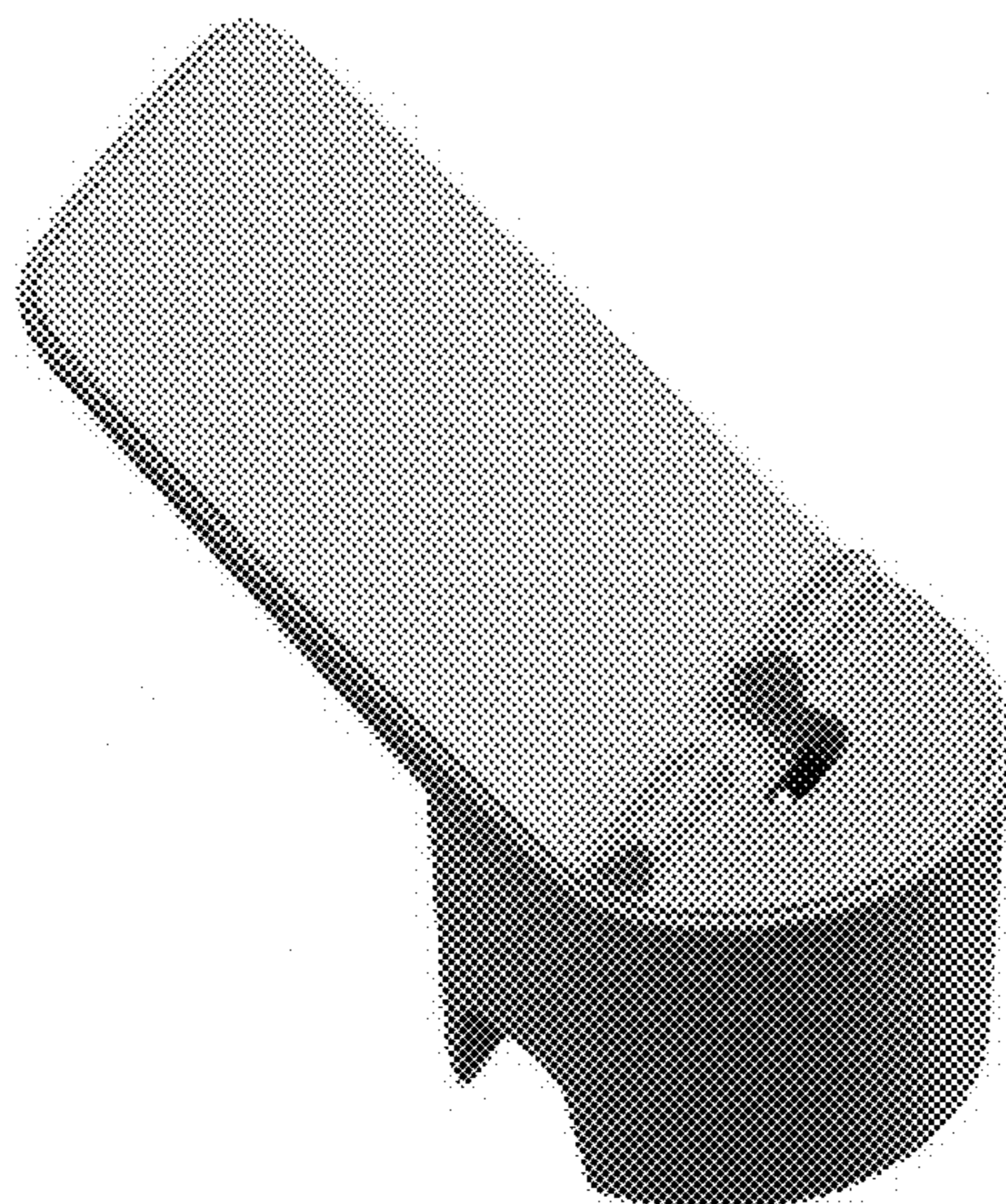
**DESCRIPTION**

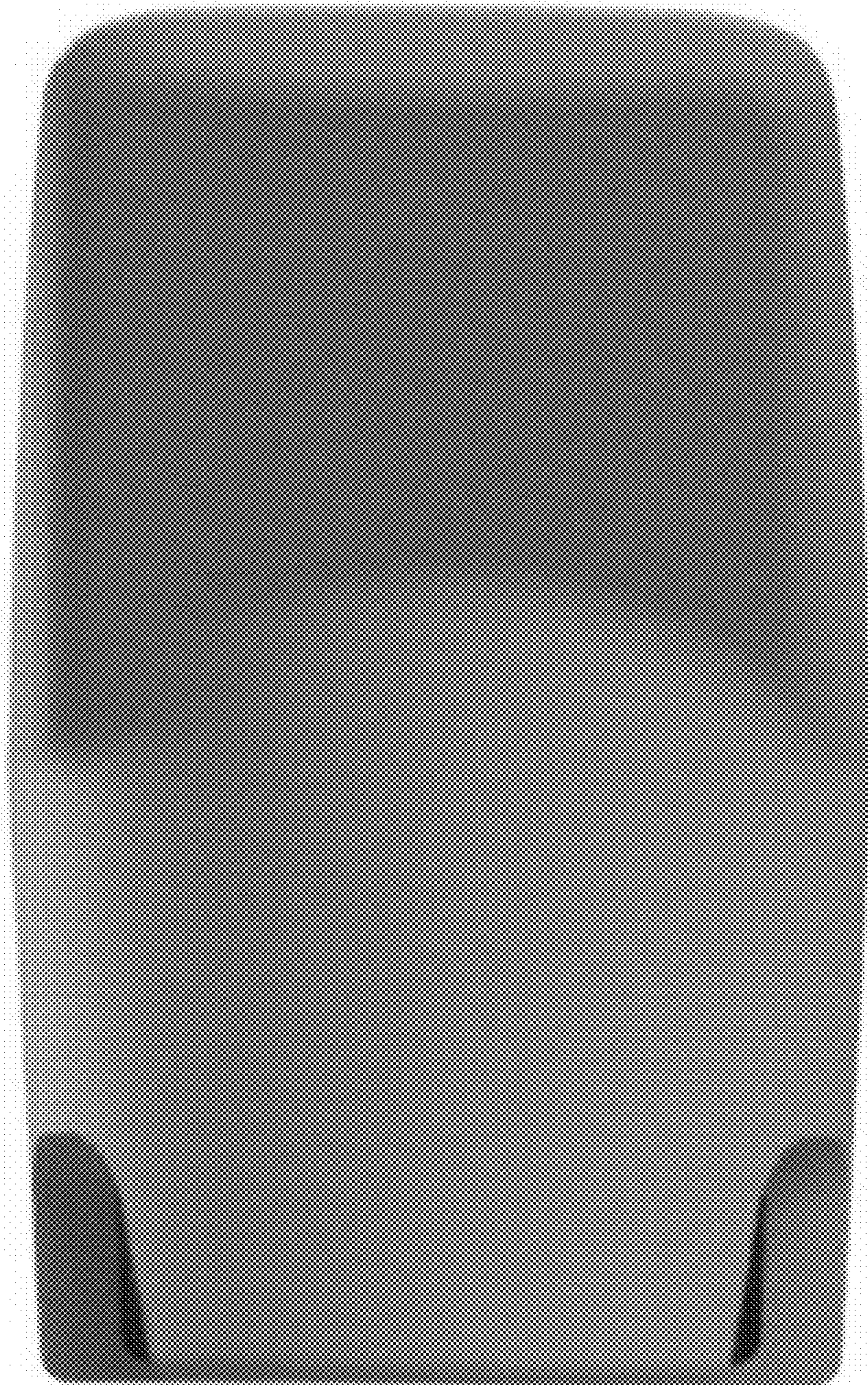

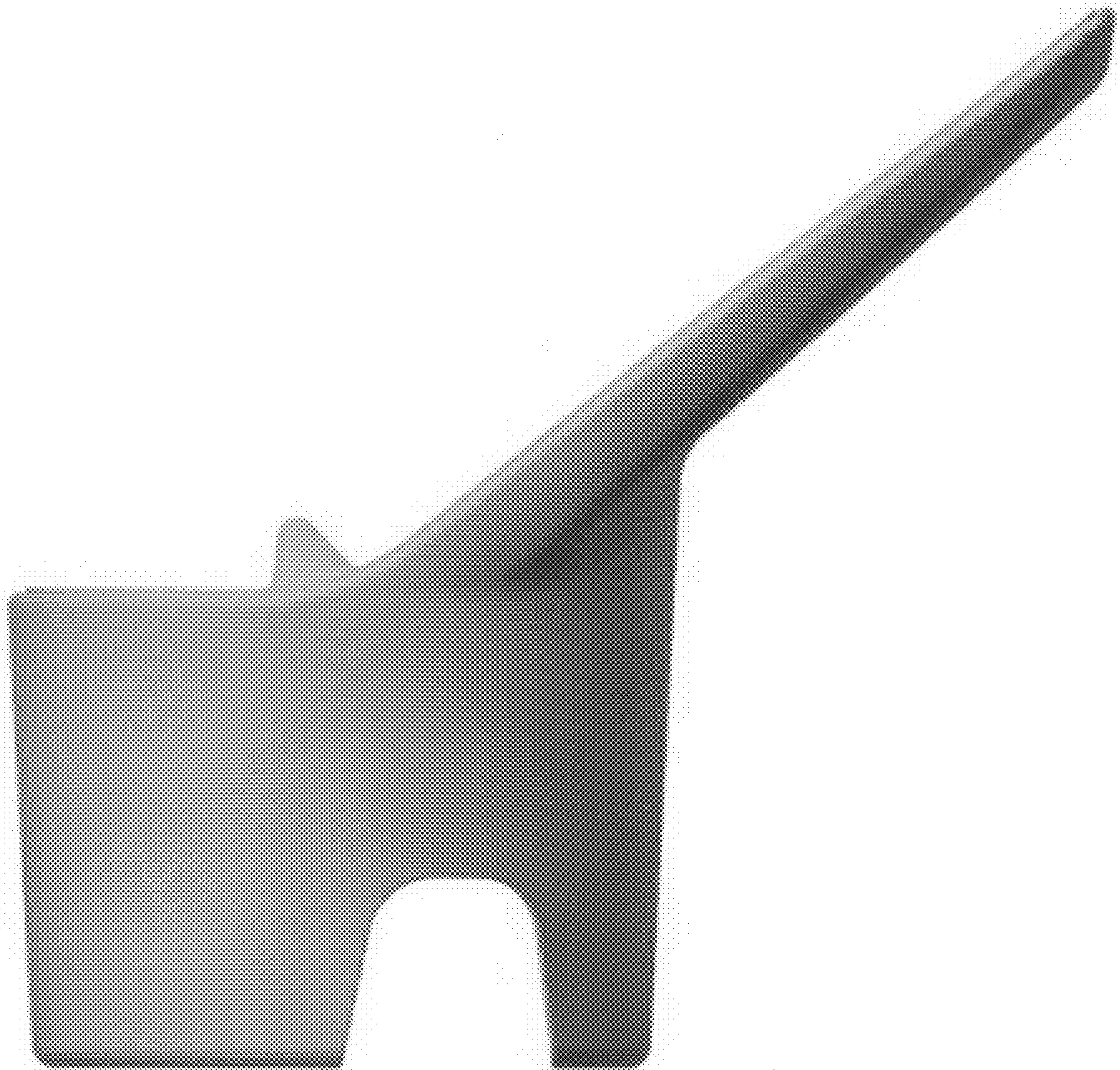

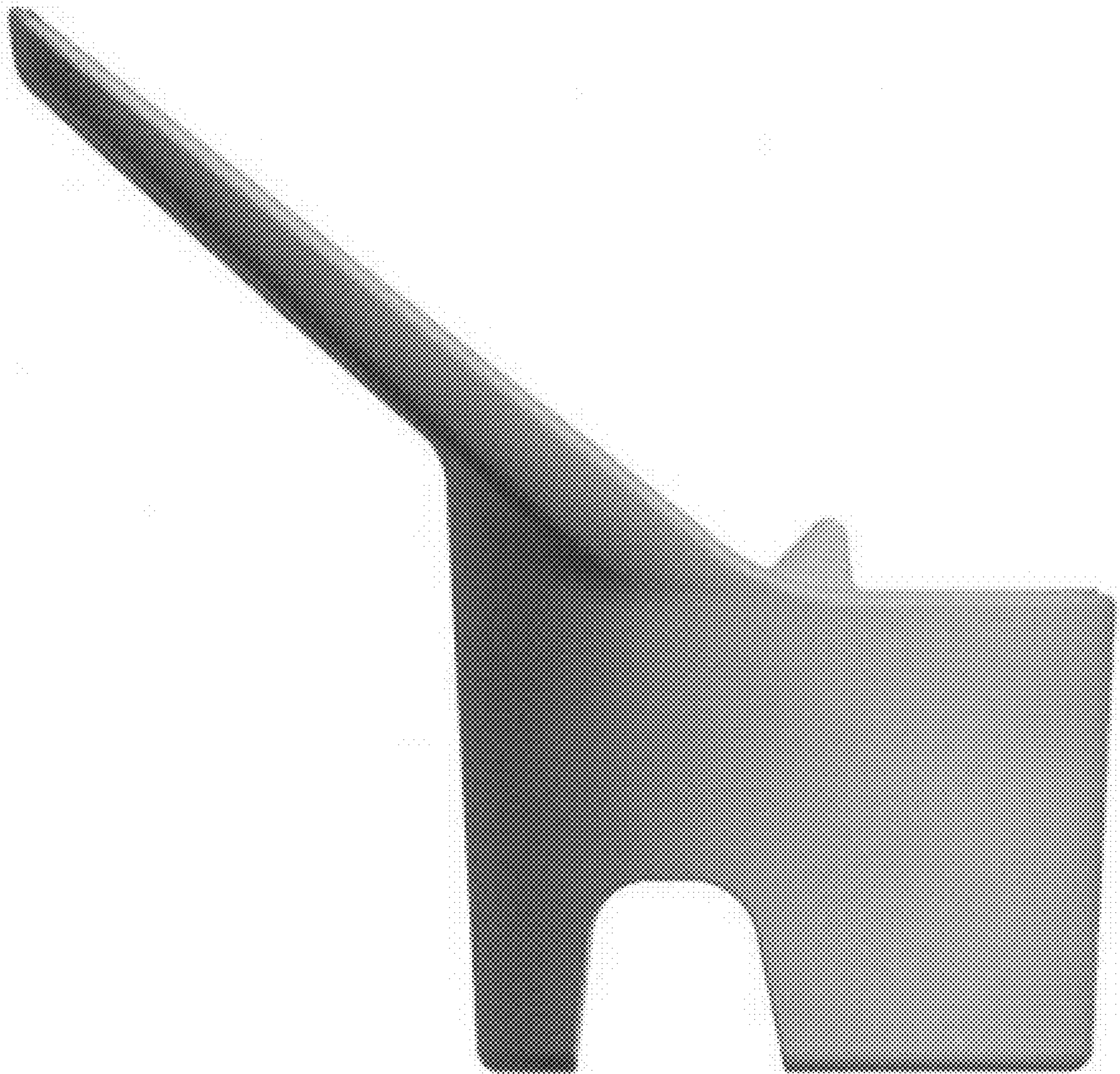

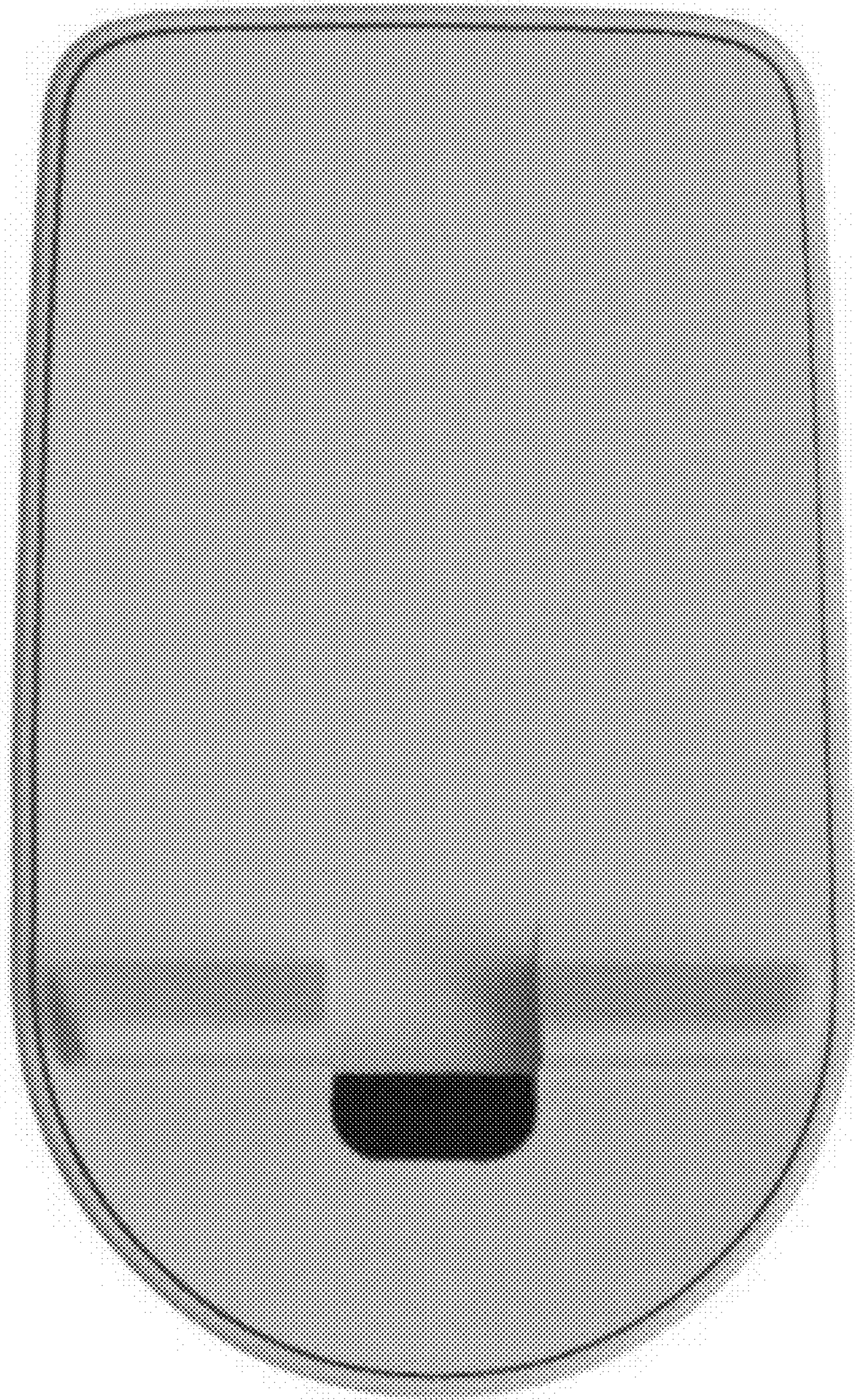
