(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

FIG. 2 is a second image thereof; and,

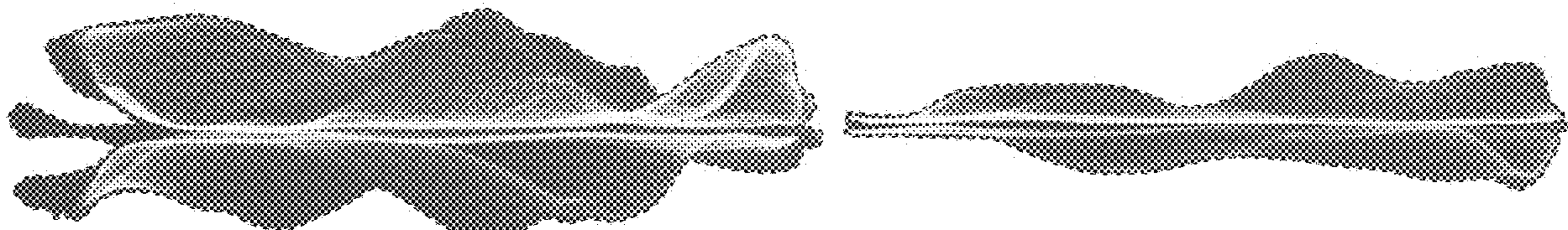
FIG. 3 is a third image thereof.

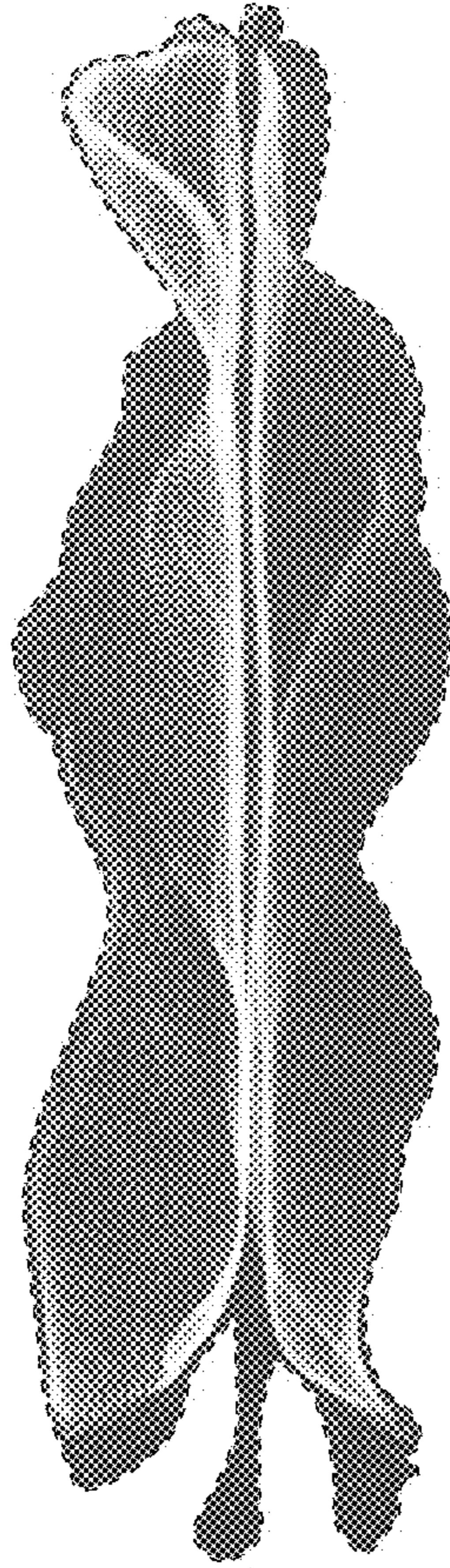

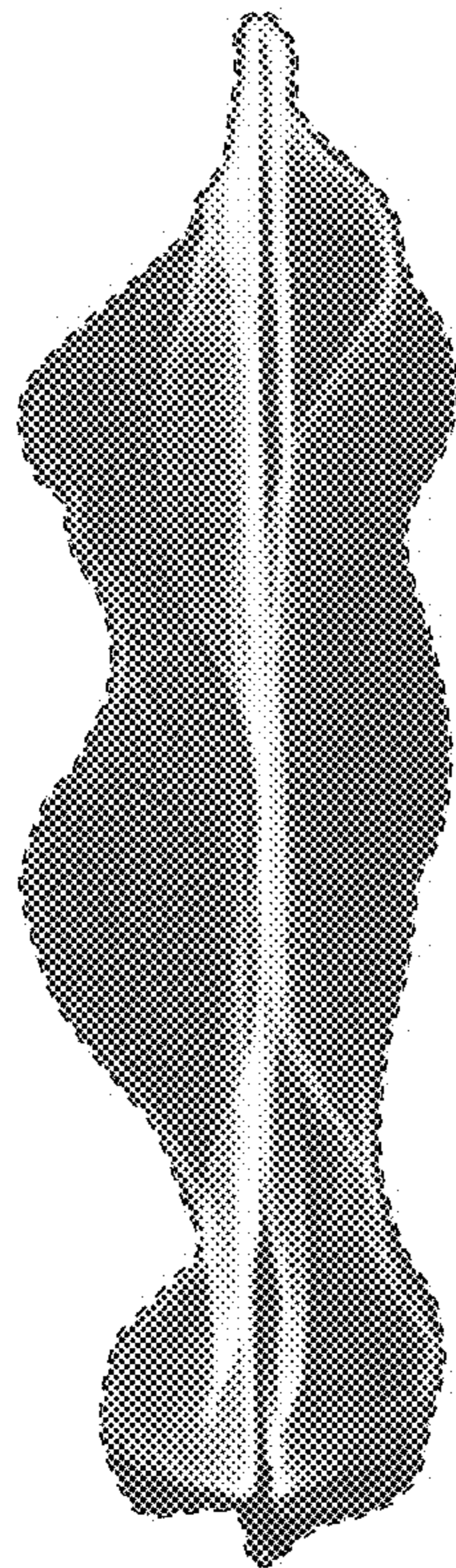

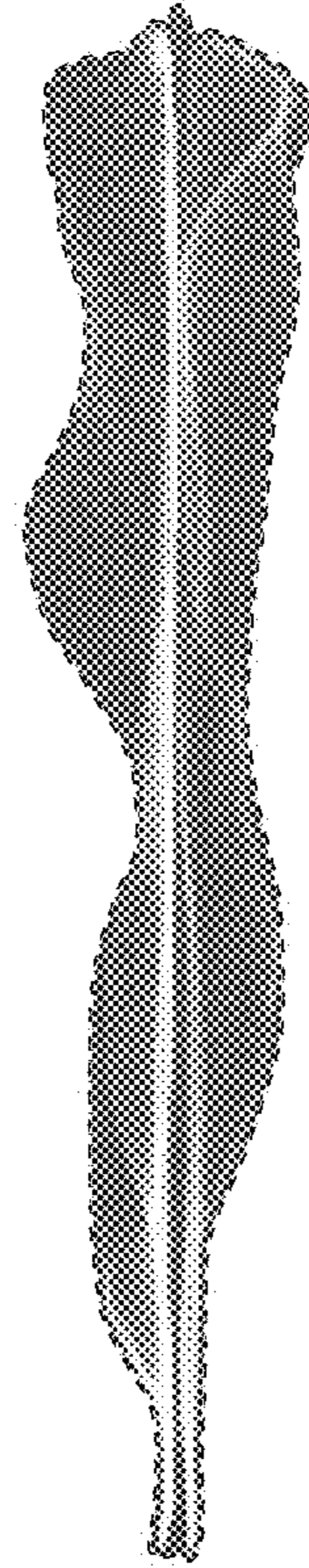
