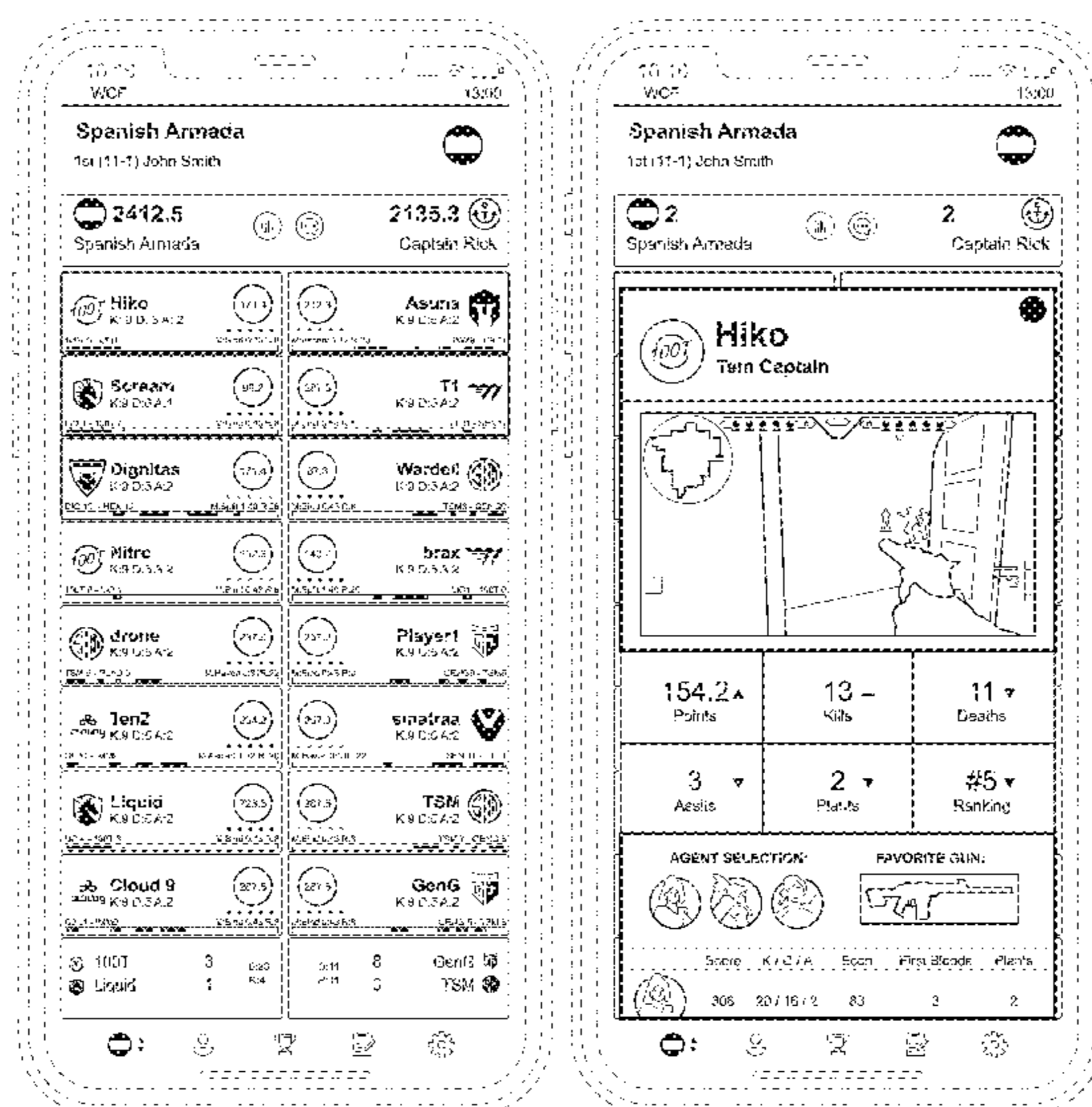
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface displaying fantasy sports player pop out, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface displaying fantasy sports player pop out in an initial state;
FIG. 2 shows a first transition state thereof;
FIG. 3 shows a second transition state thereof; and,
FIG. 4 shows a display screen with graphical user interface displaying fantasy sports player pop out in a final state.
FIGS. 1-4 show a sequence of images that feature a transition from the state shown in FIG. 1 to the state shown in FIG. 4. The process or period in which one image transitions to another image forms no part of the claimed design. The dashed broken lines showing of a mobile device illustrates the environment of the claimed design and forms no part thereof. The remaining dashed broken lines show a display screen and portions of the graphical user interface that forms no part of the claimed design. The dotted lines beneath the circles in FIGS. 1 and 2 and heavy weight dots and dashes in FIGS. 2-4 form no part of the claimed design.

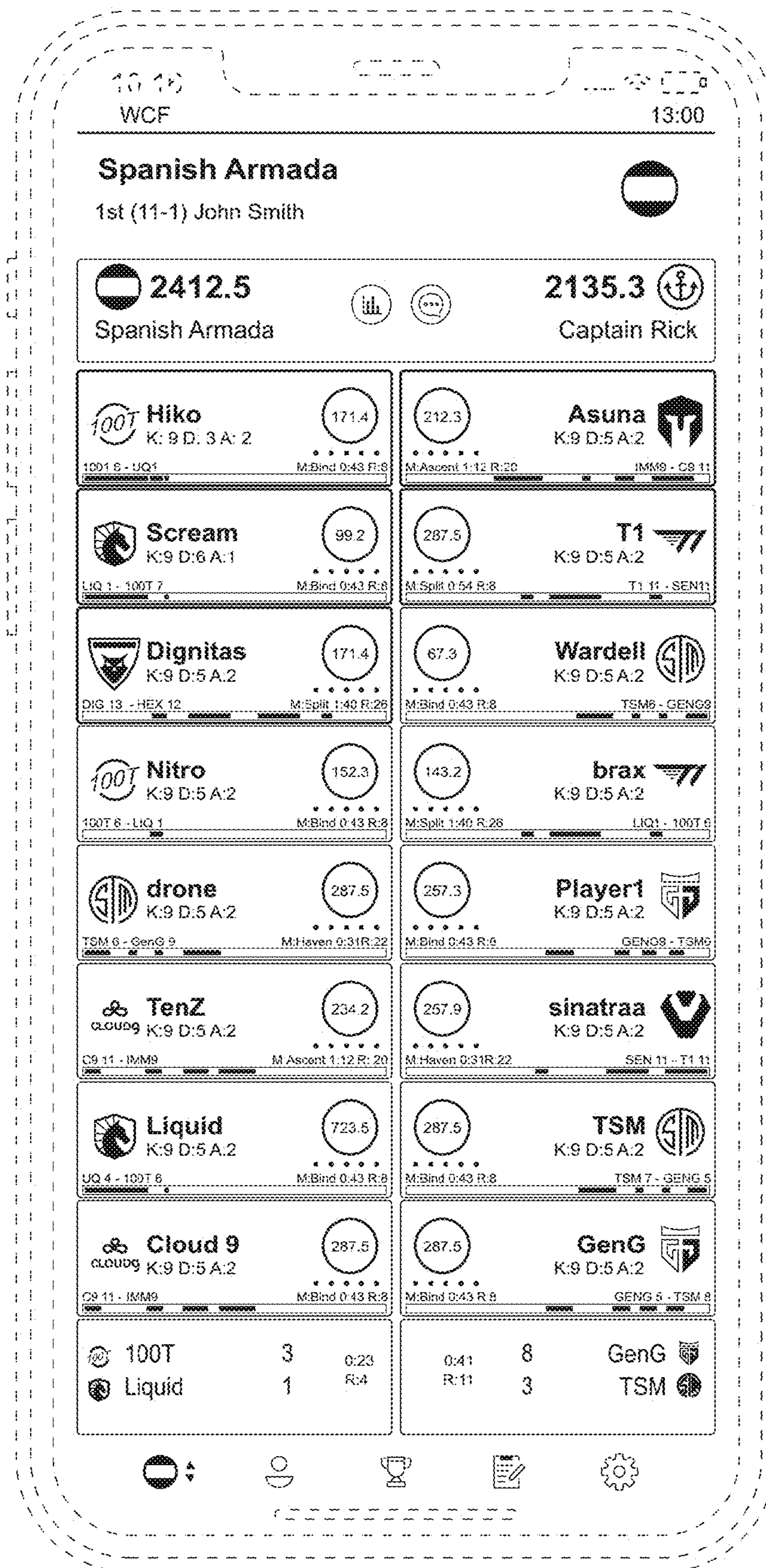

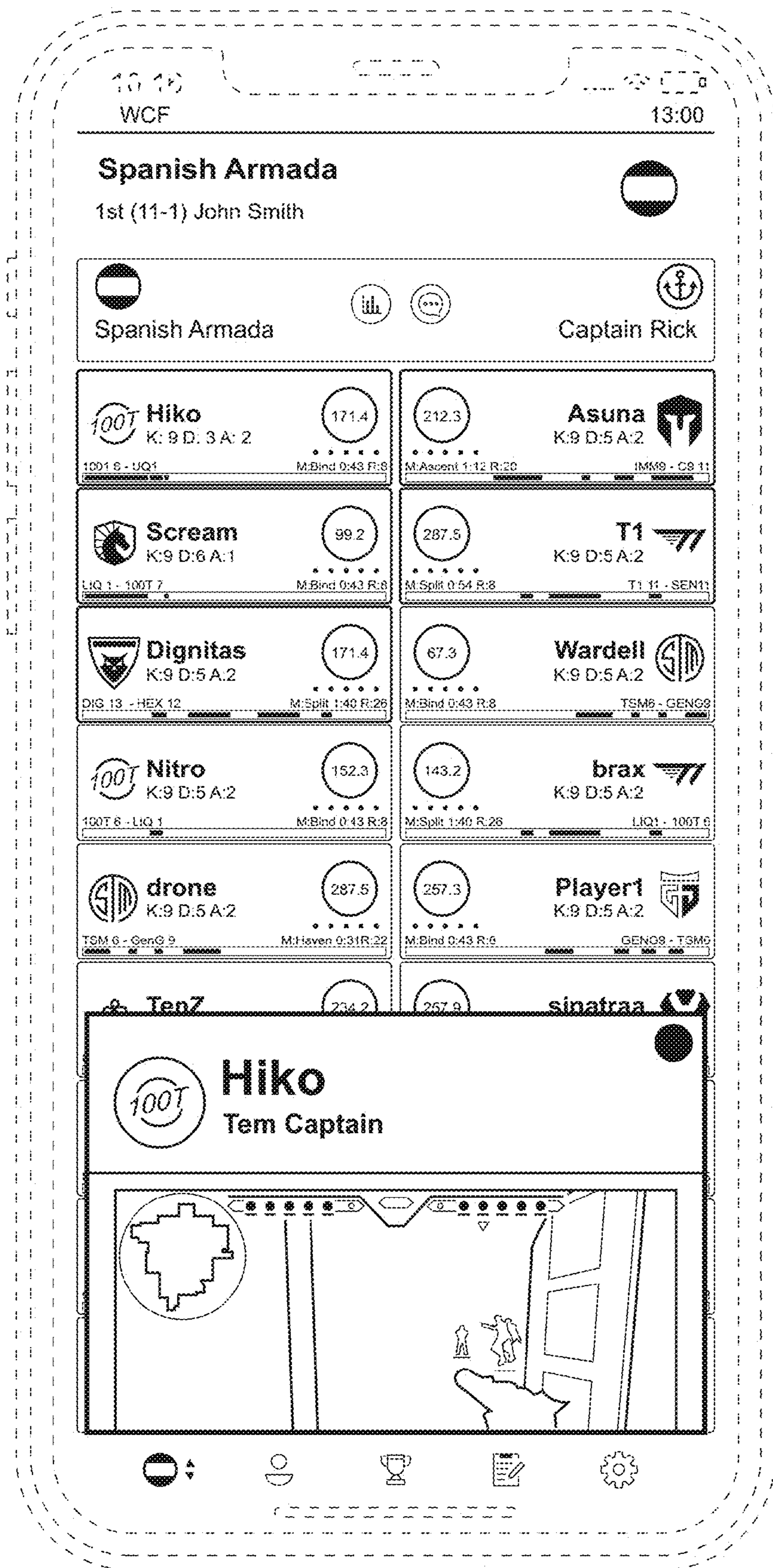

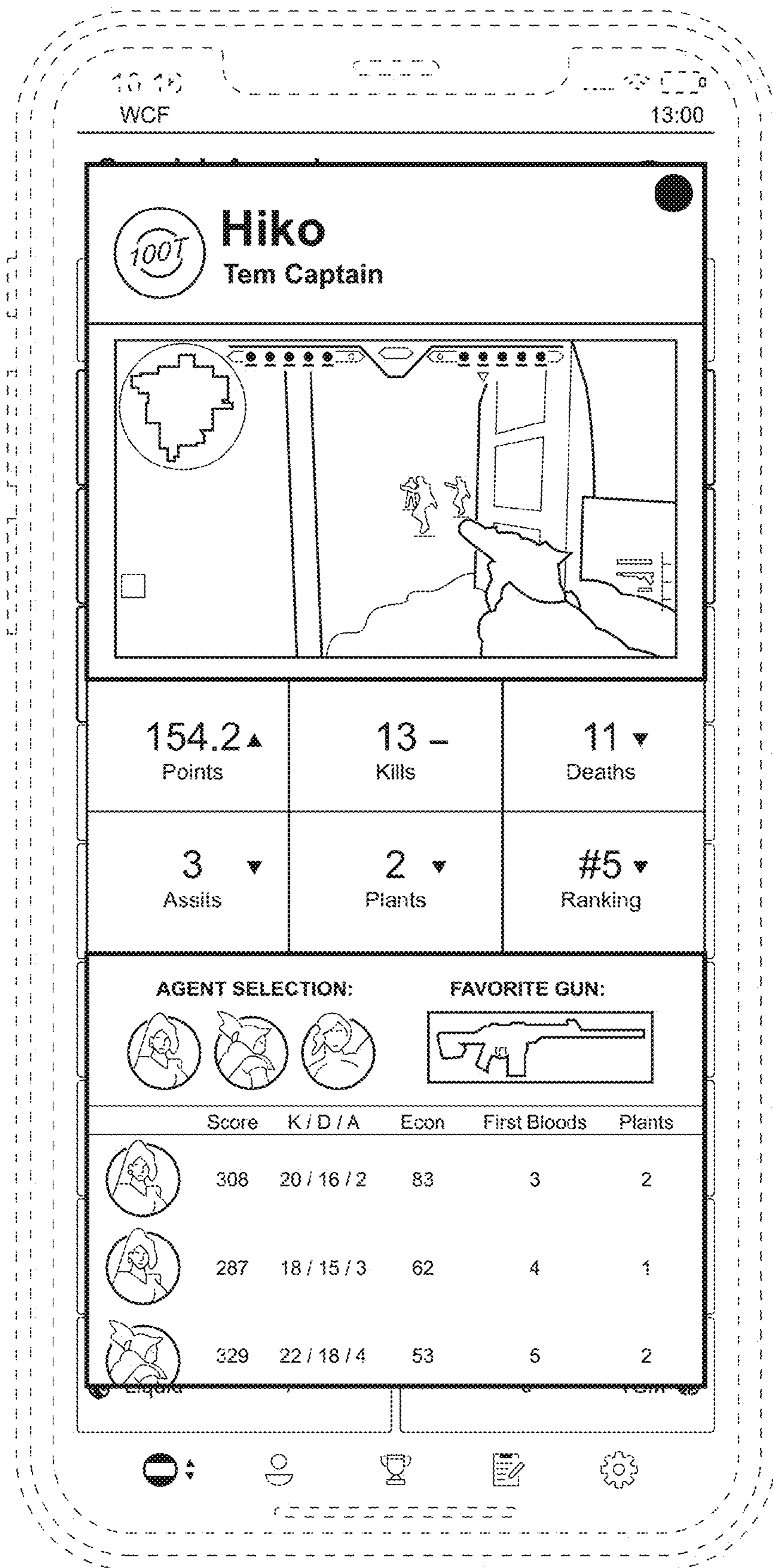
