(57) **CLAIM**

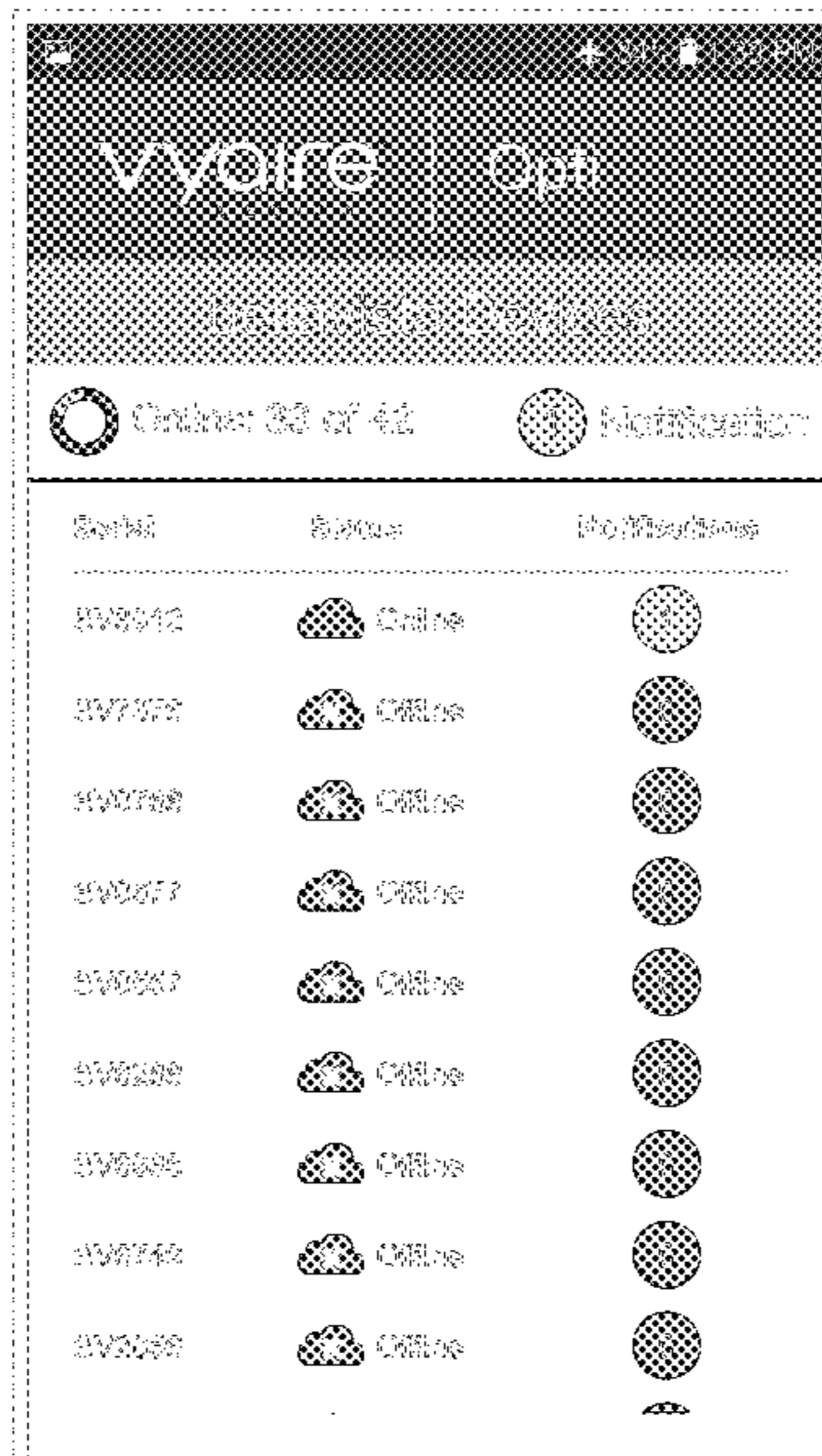
The ornamental design for a display screen with graphical user interface for communicating health-related messages regarding ventilated patients, as shown and described.
