(57) **CLAIM**

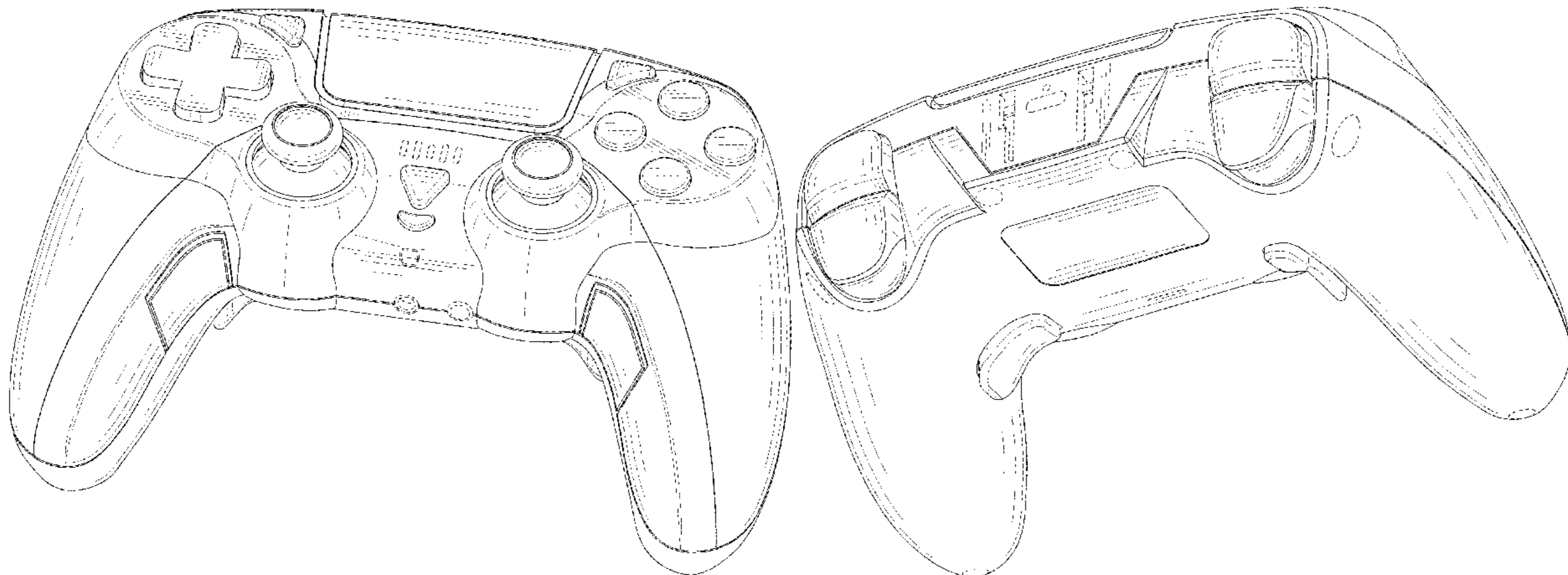
The ornamental design for a game controller, as shown and described.

DESCRIPTION

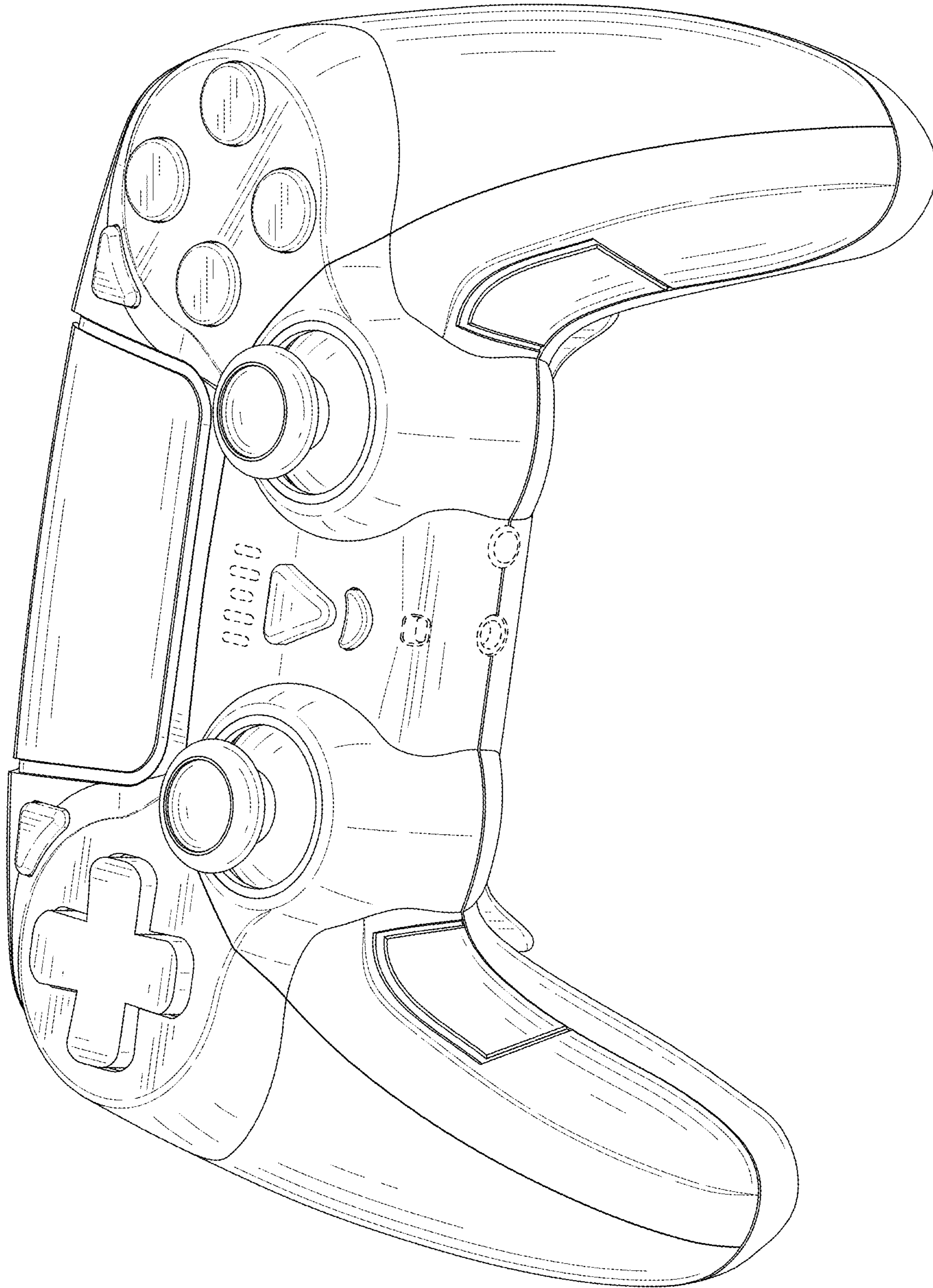

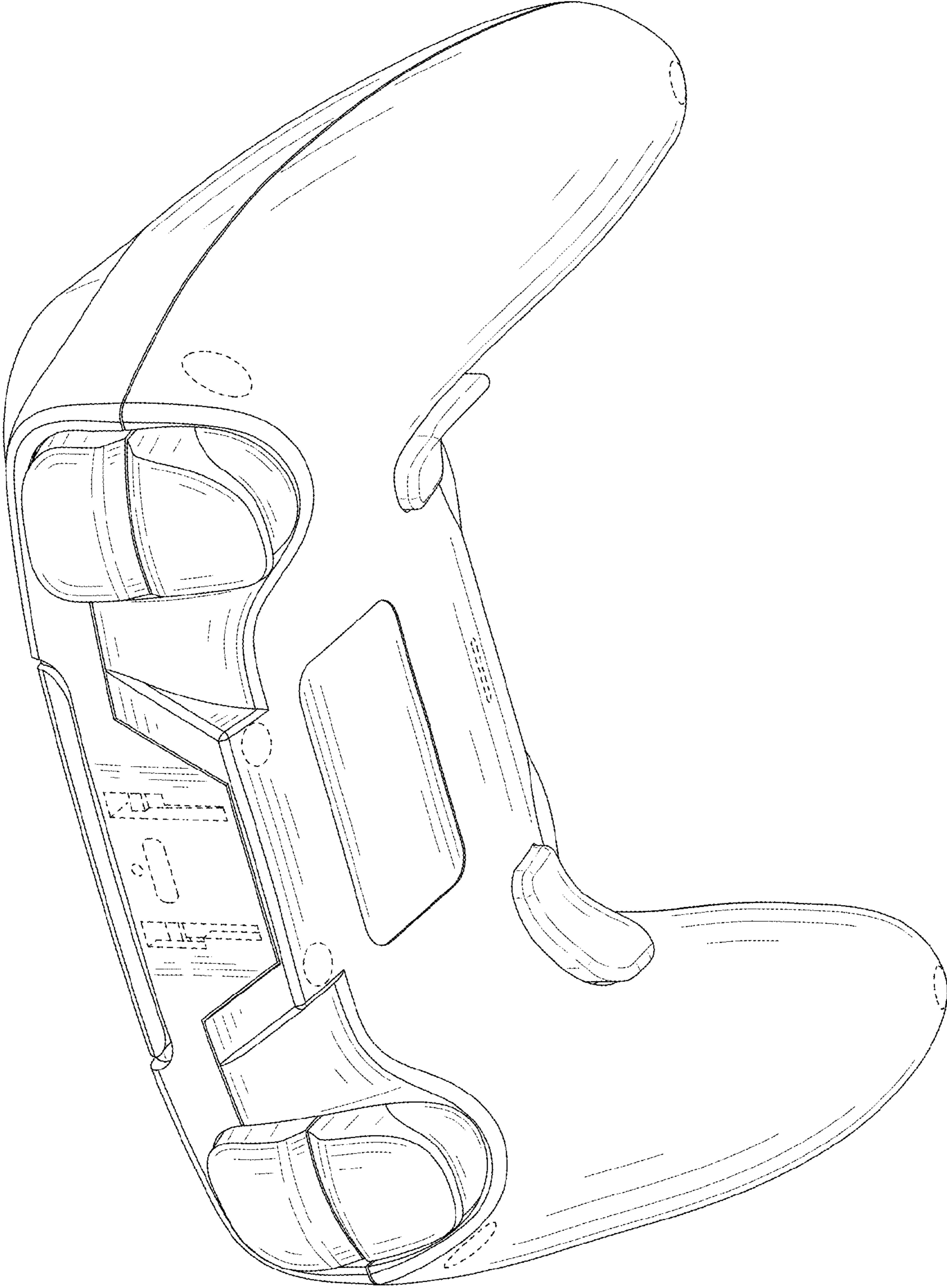

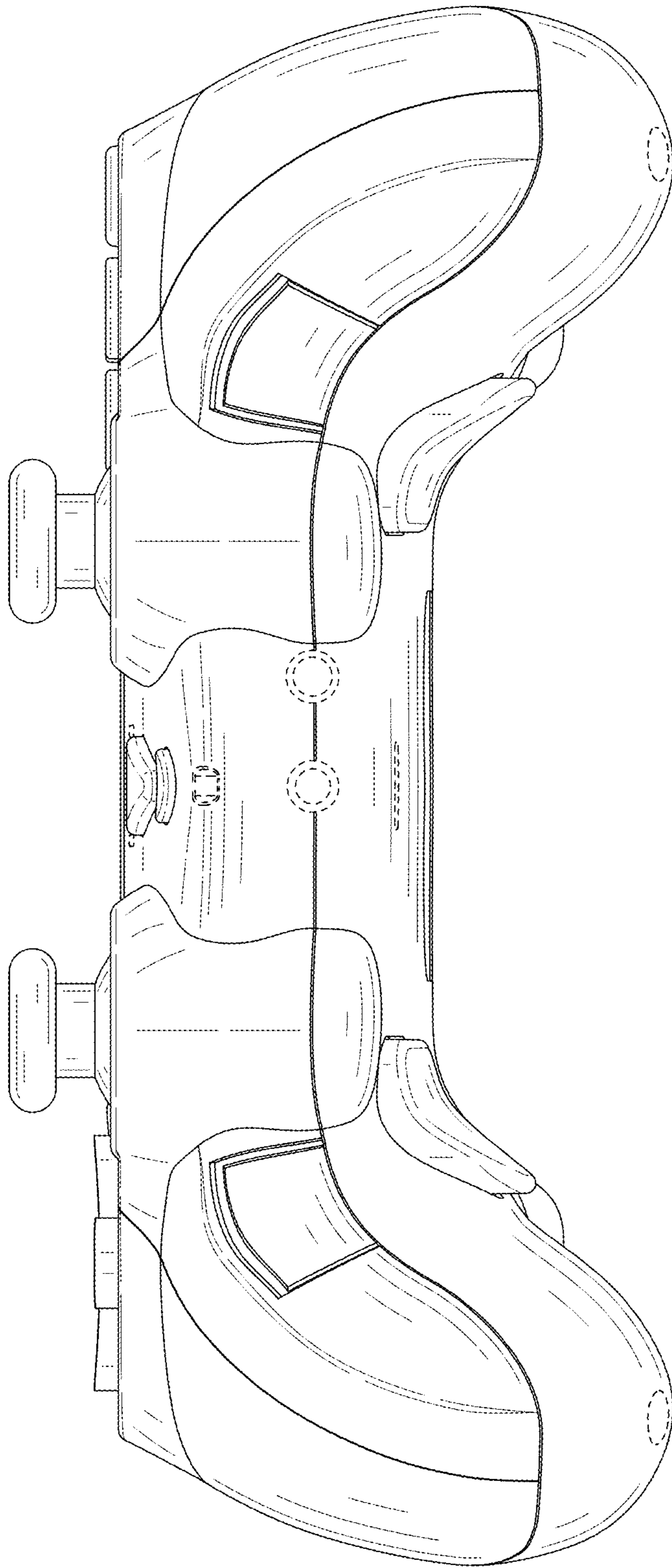

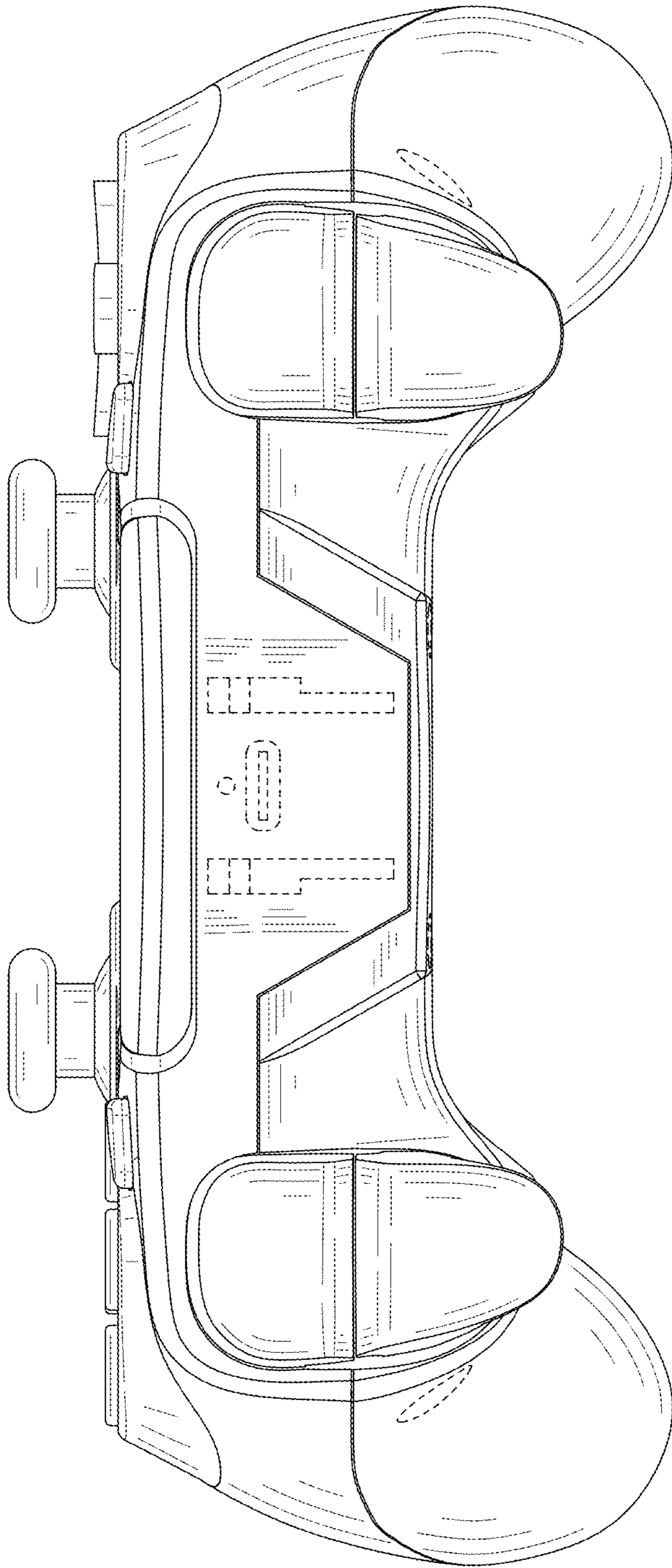

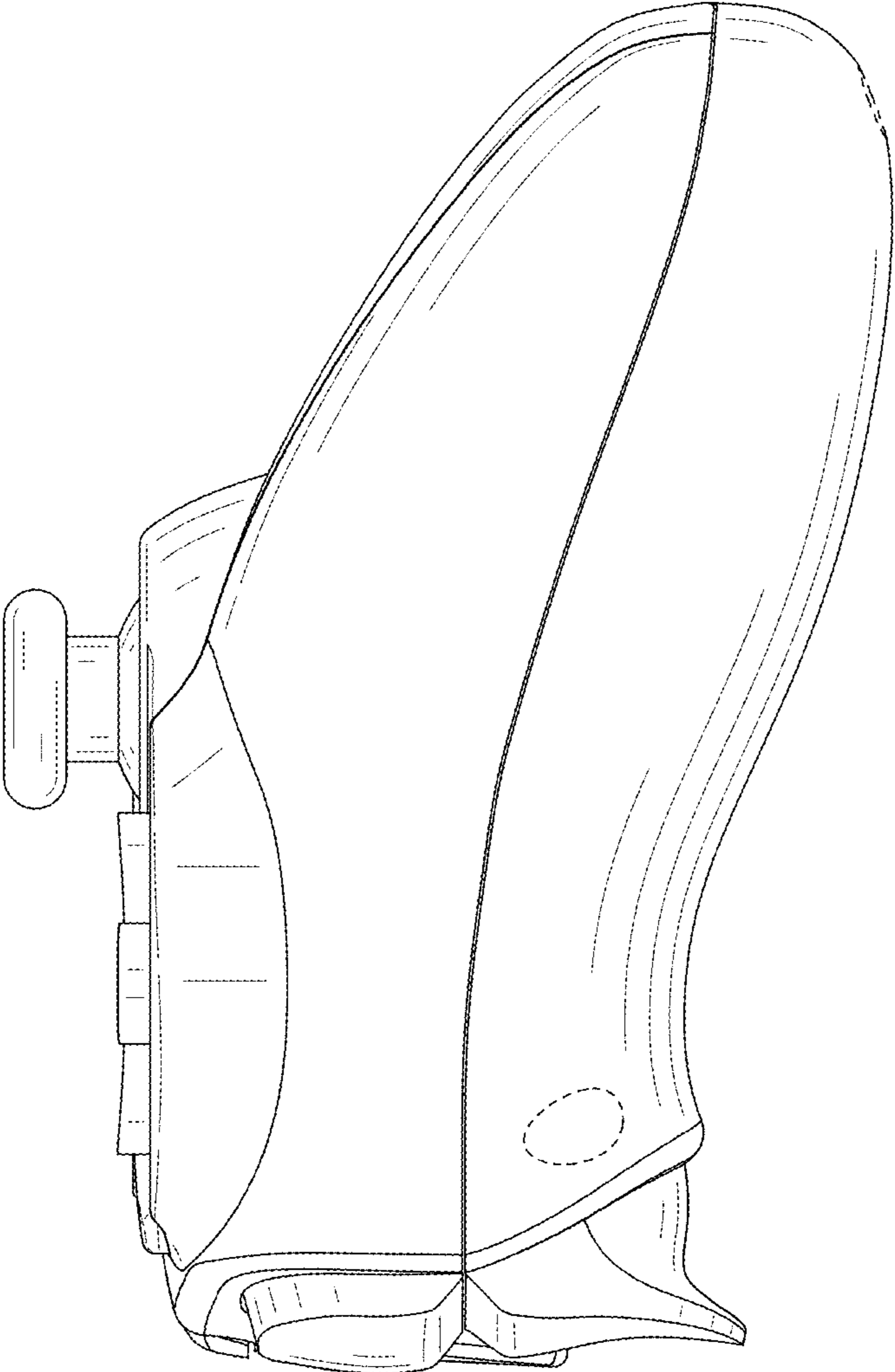

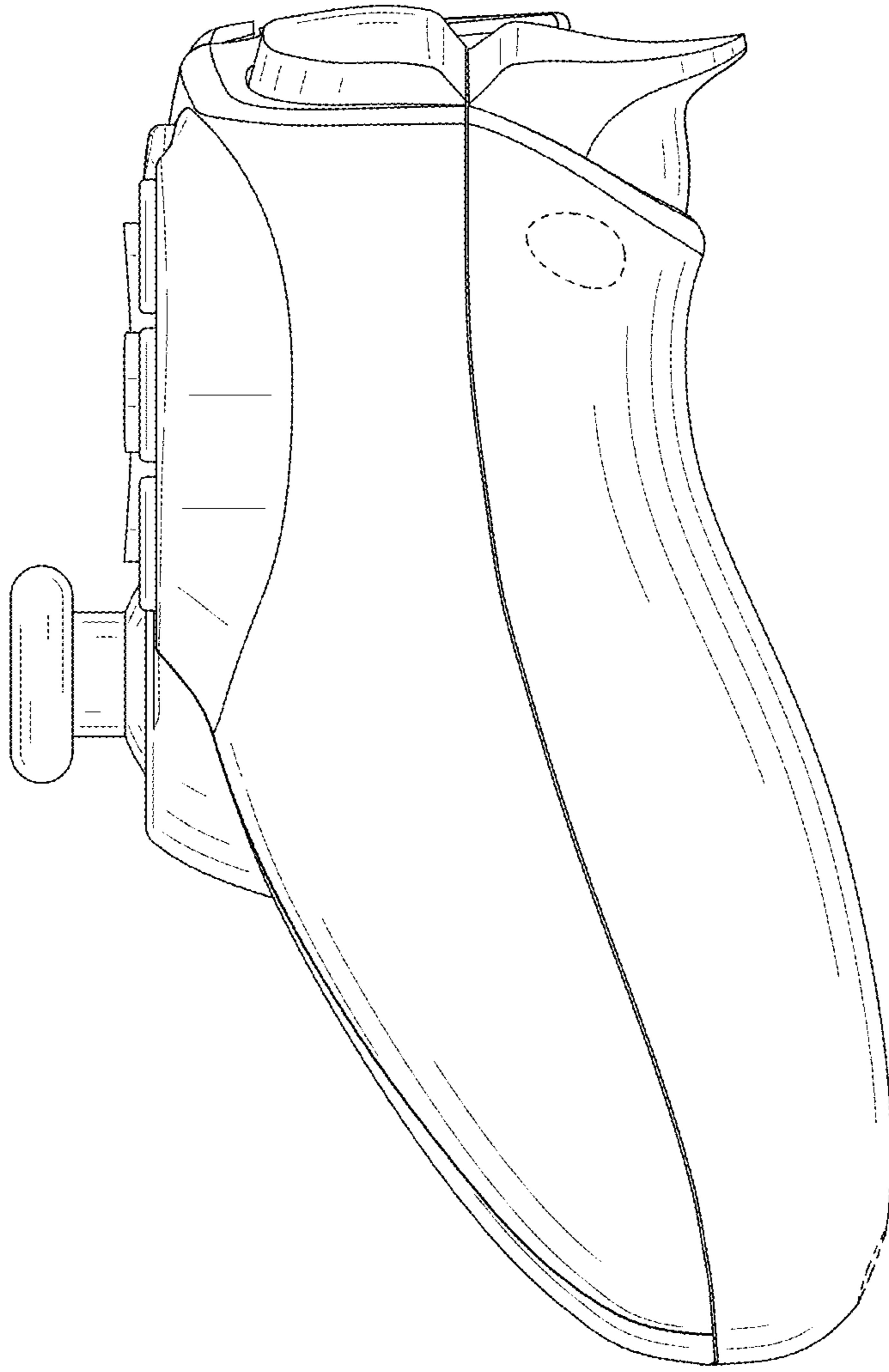

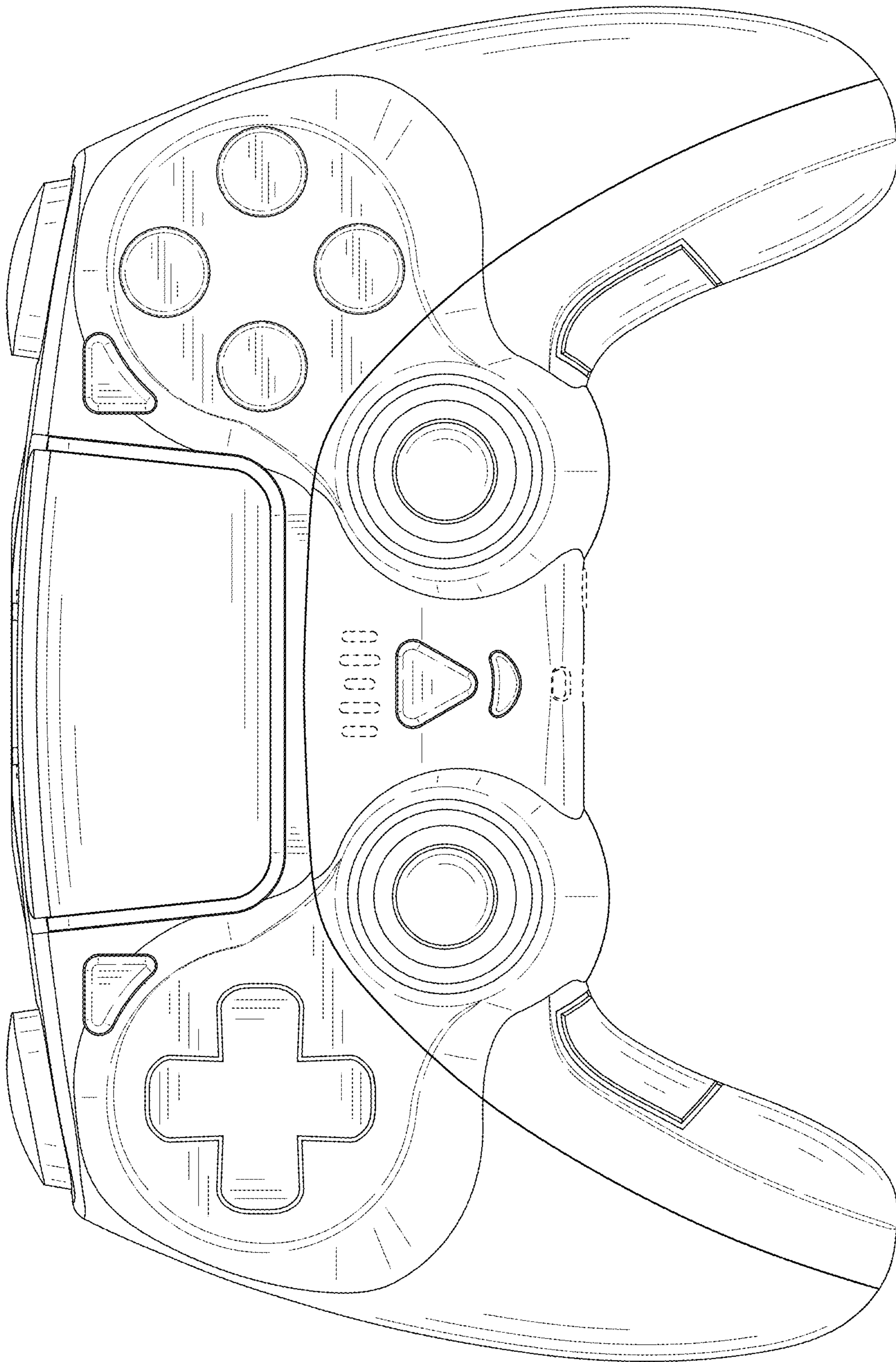

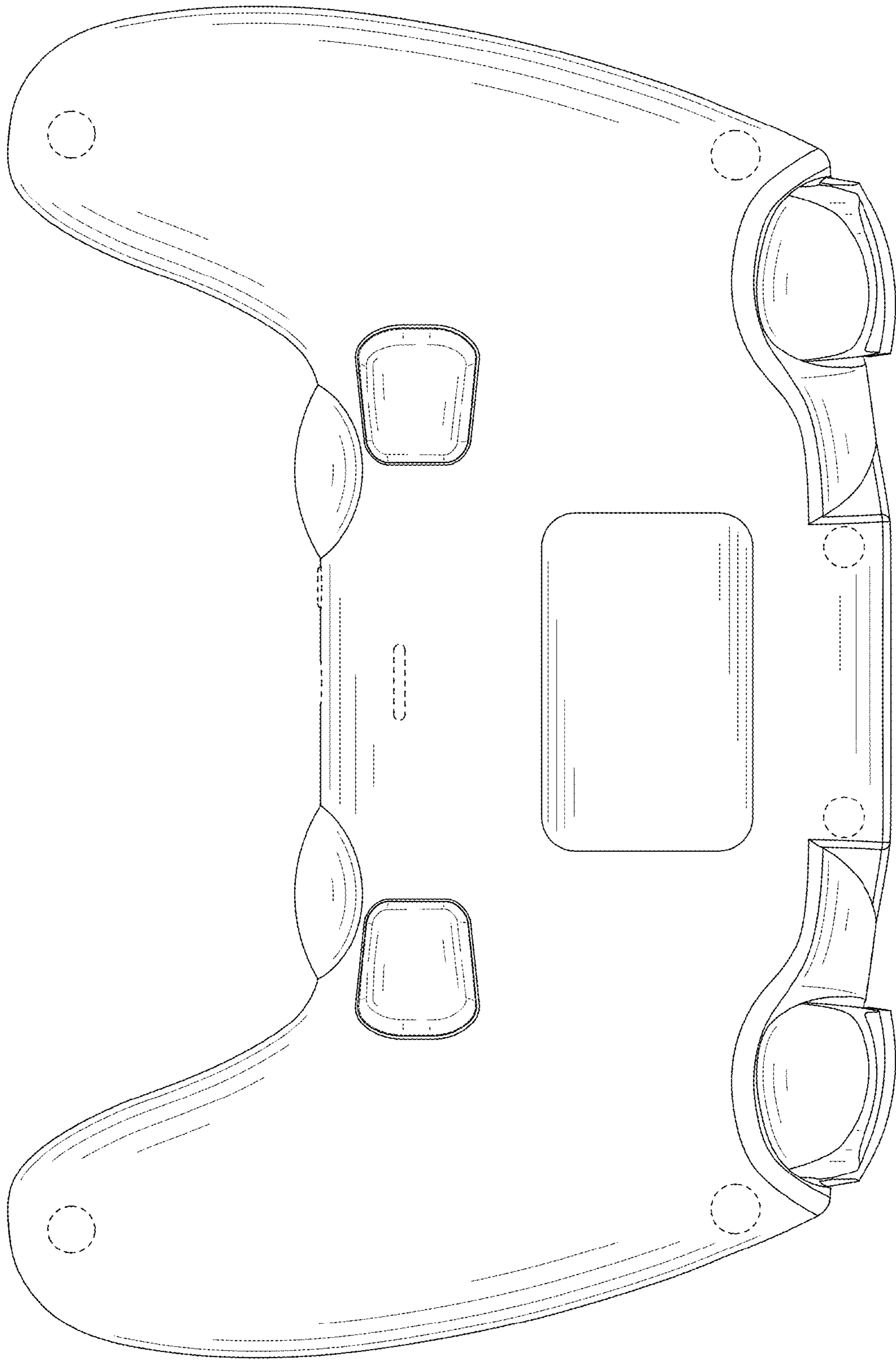
