FIG. 5 is a back elevation view of the construction toy piece.

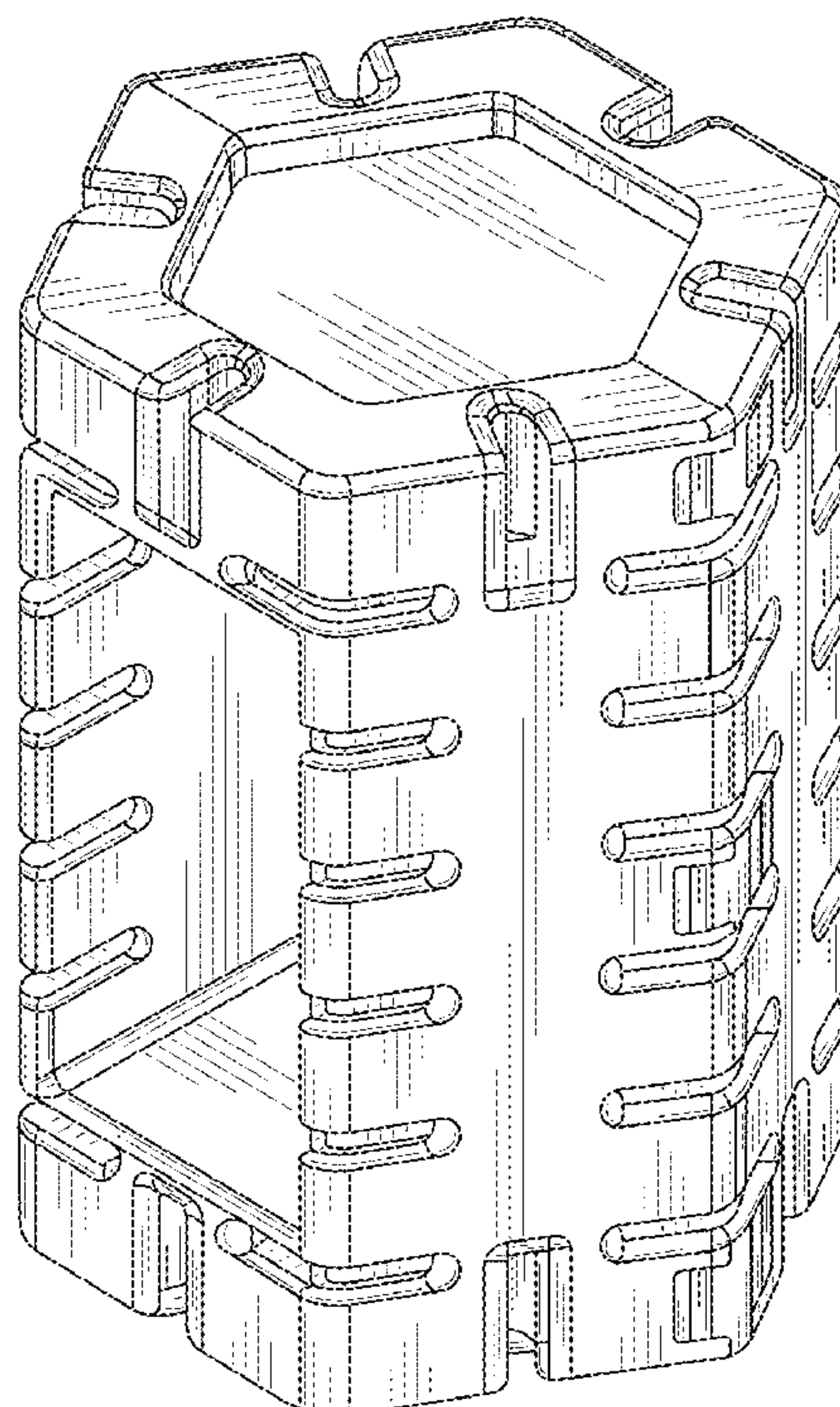
FIG. 6 is a top elevation view of the construction toy piece;

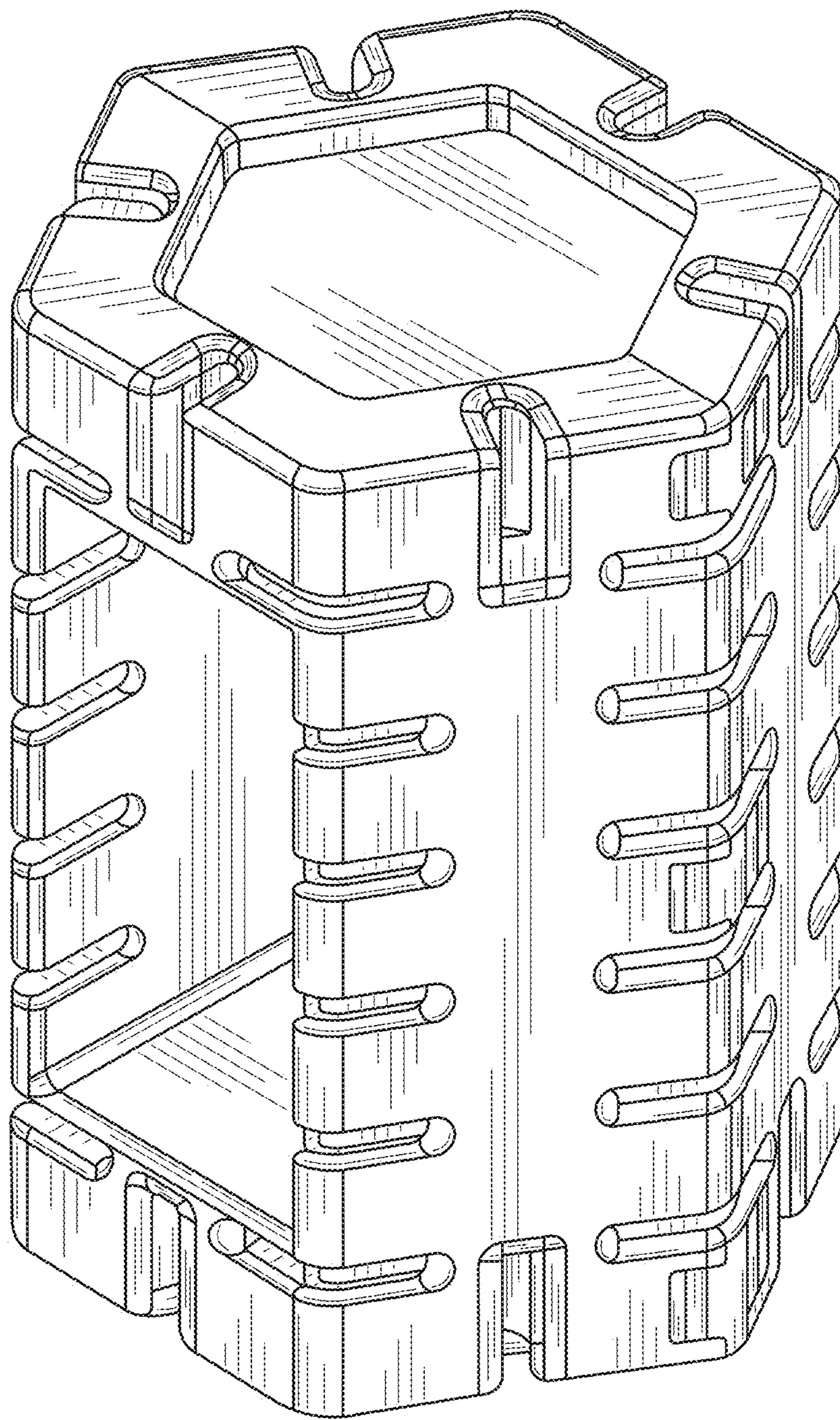

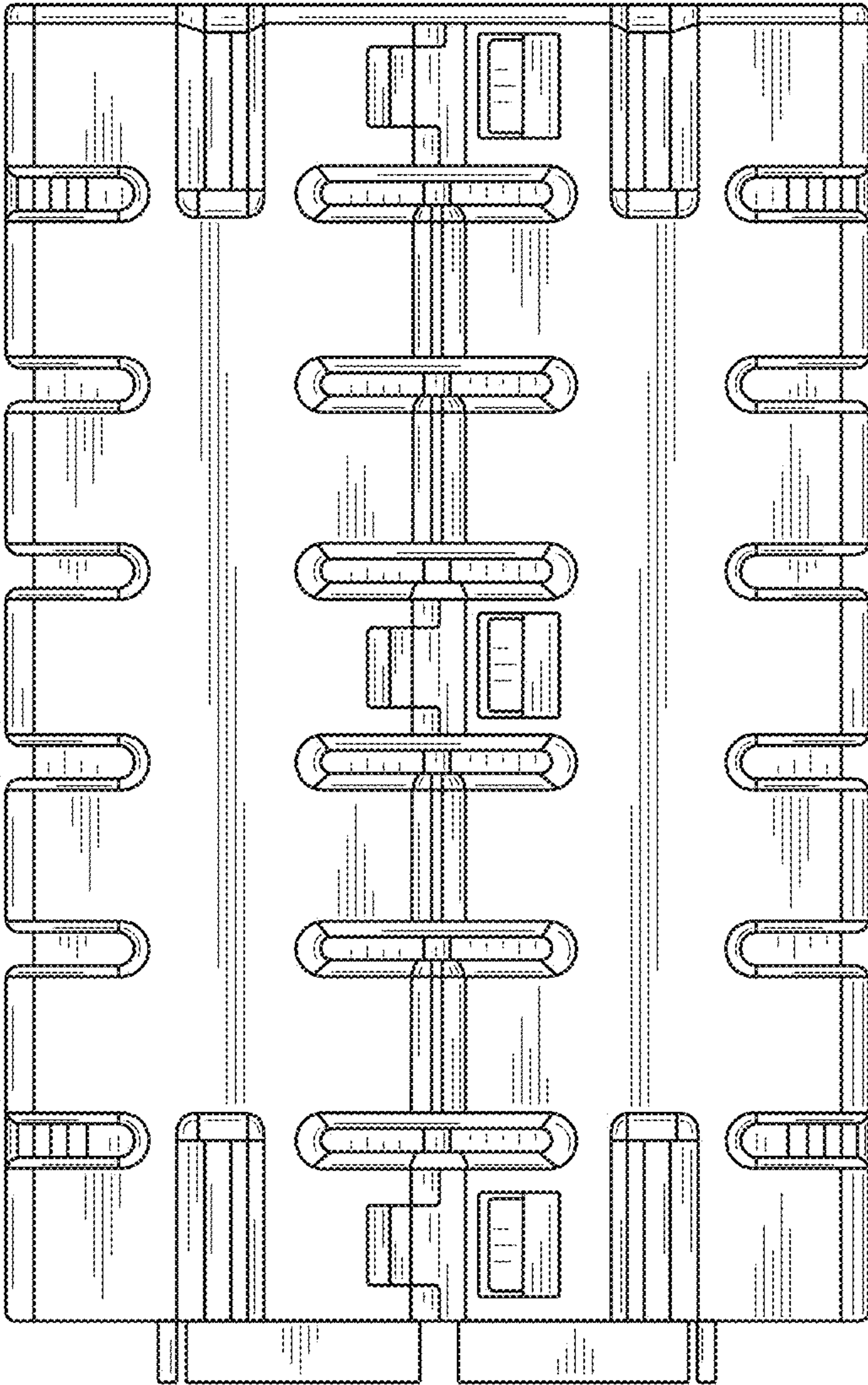

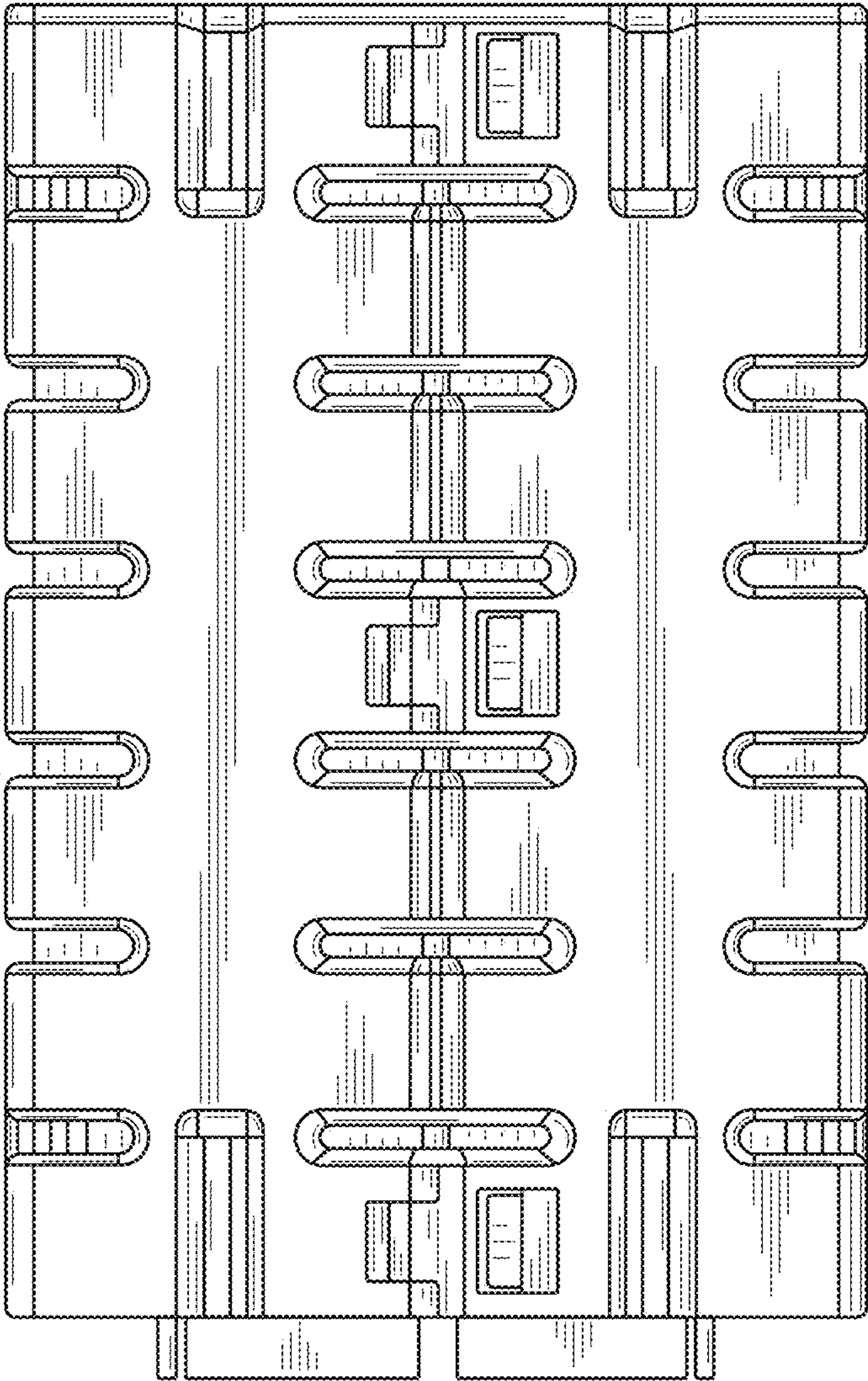

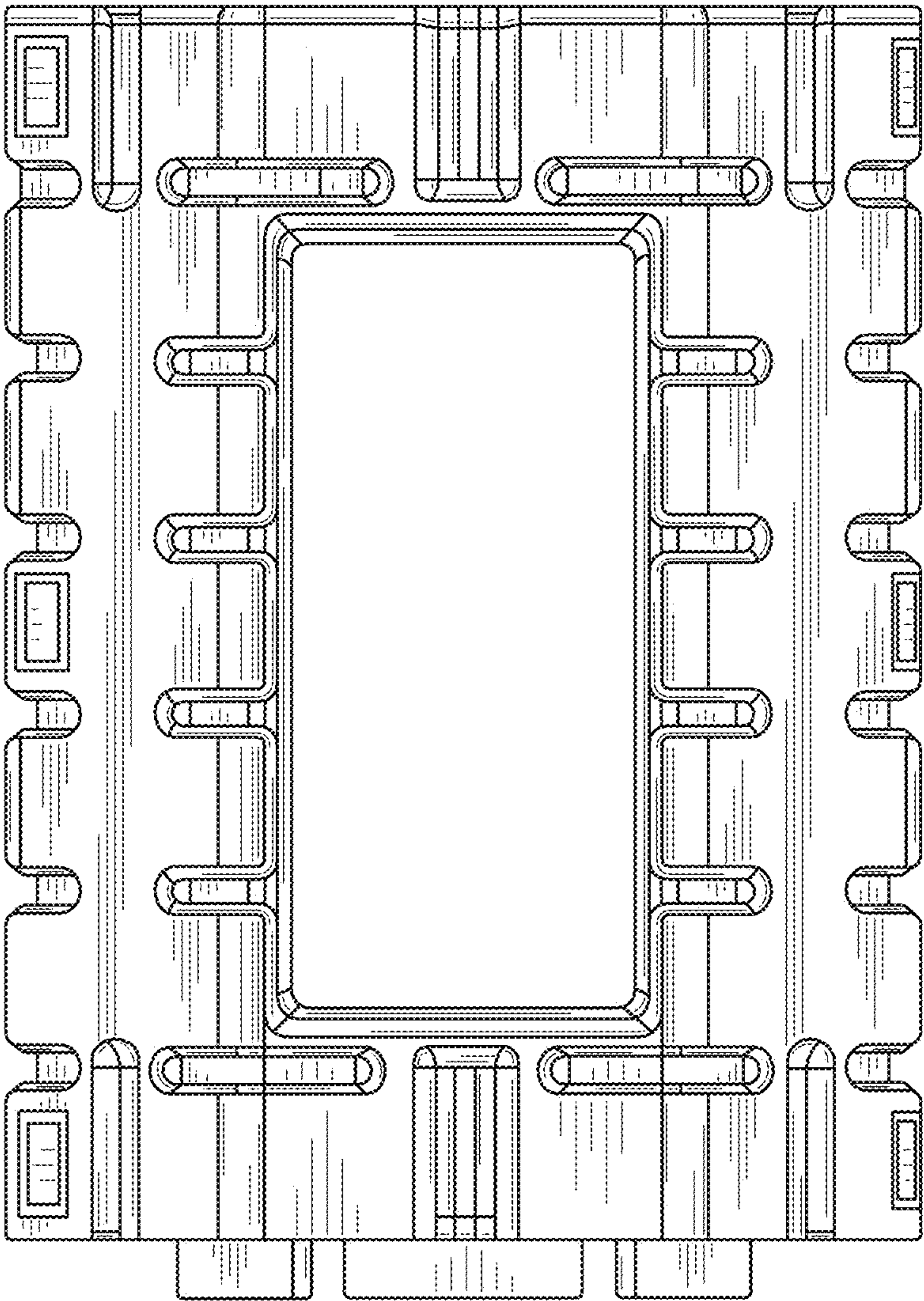

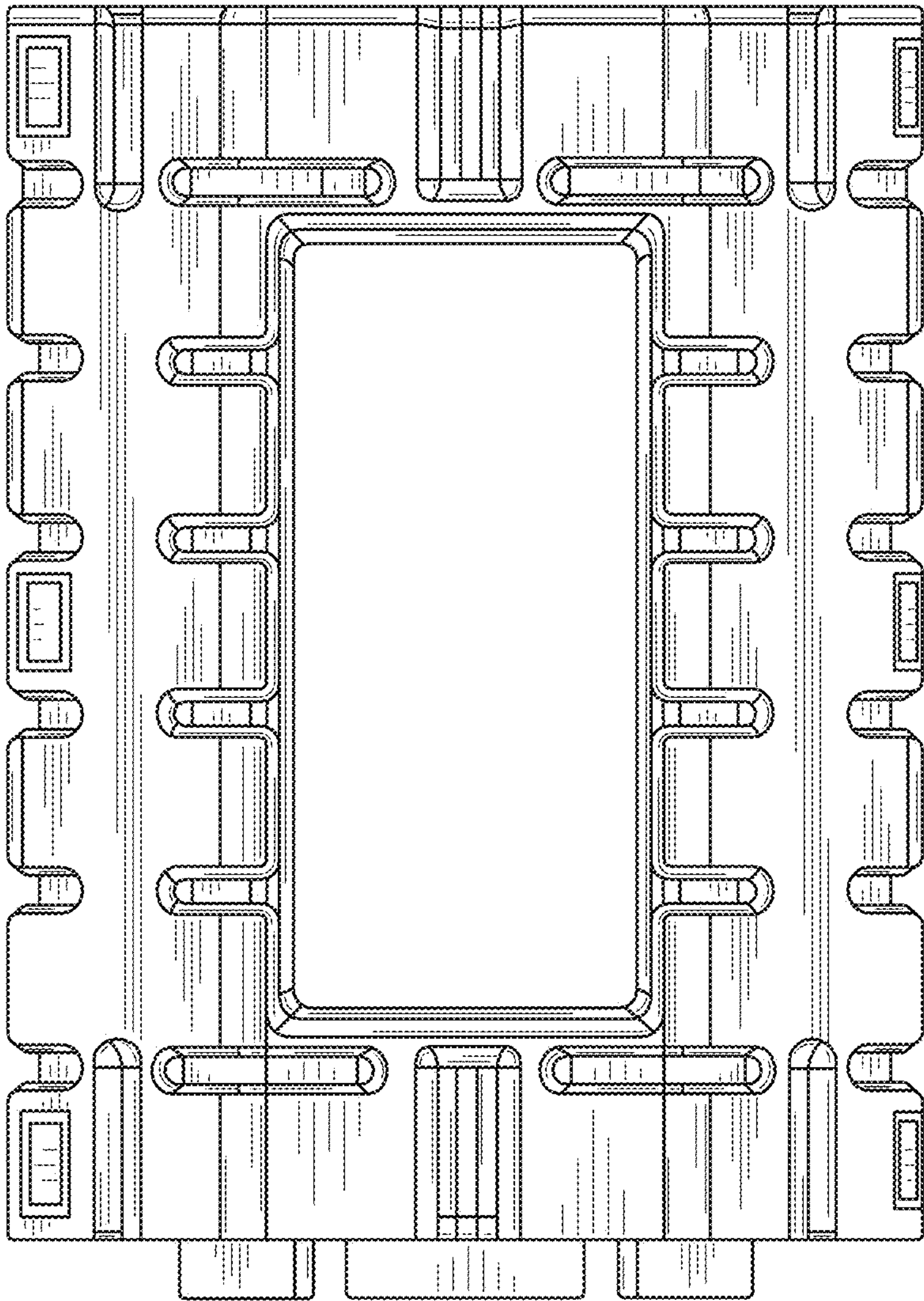

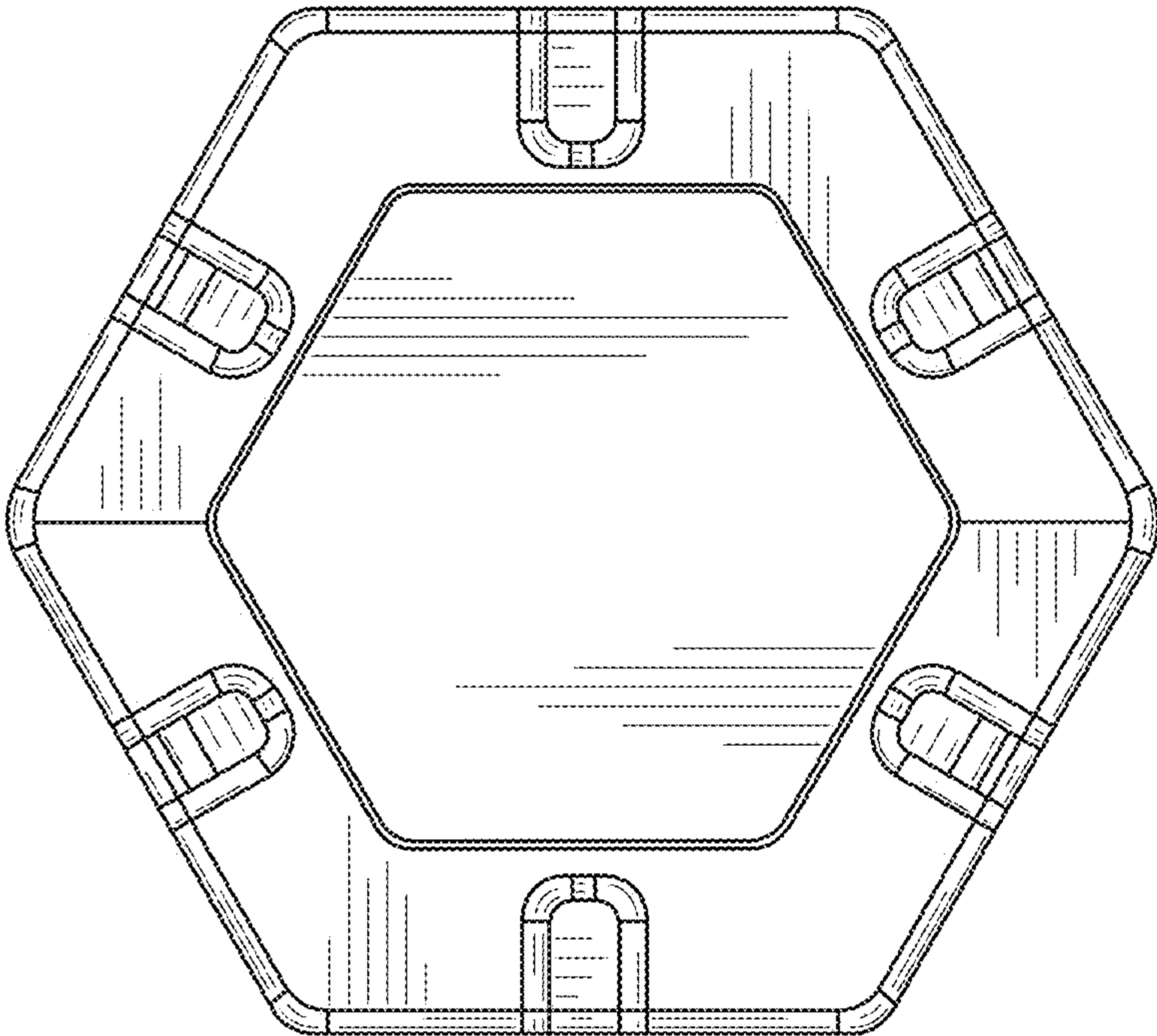

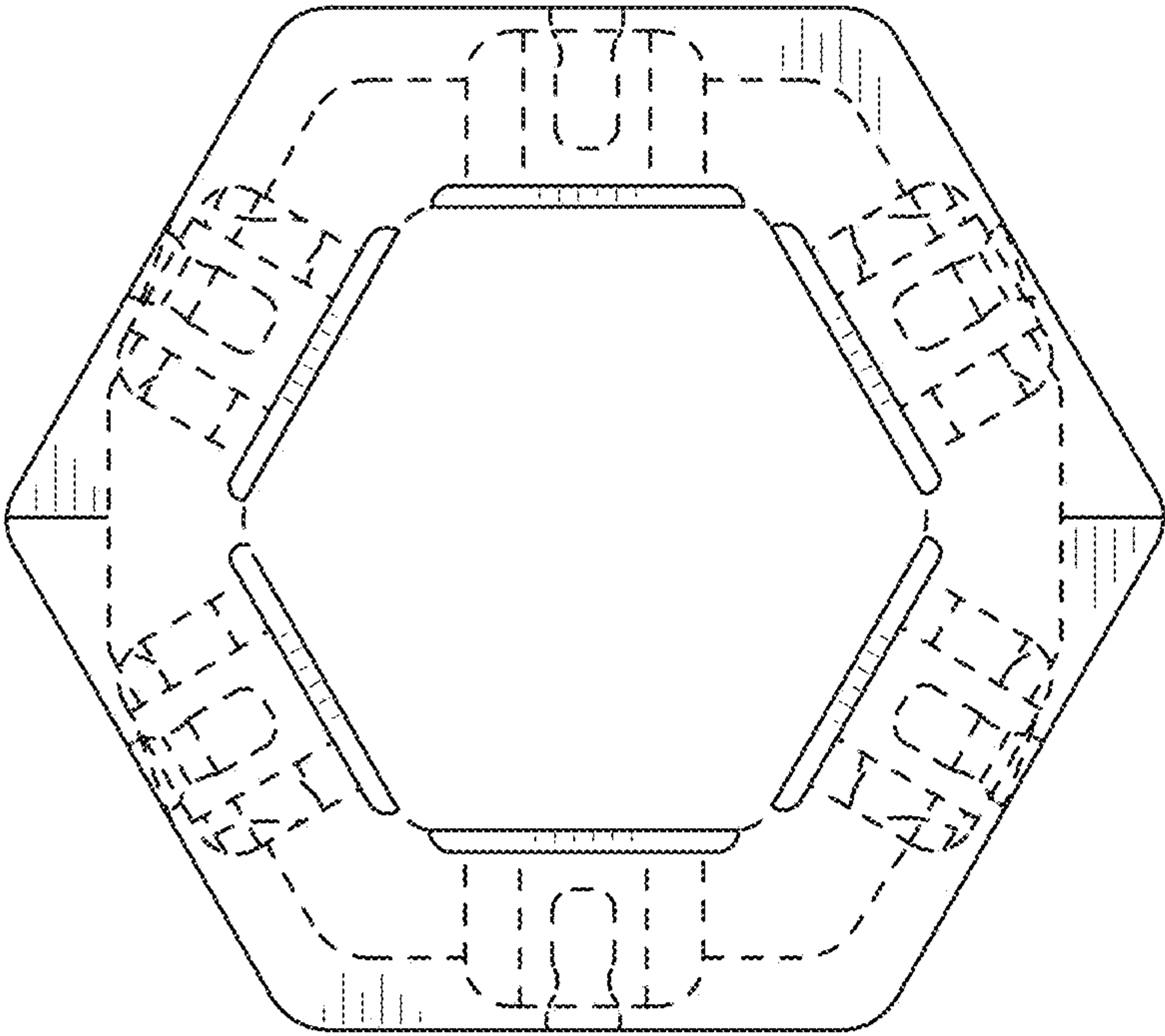
