**DESCRIPTION**

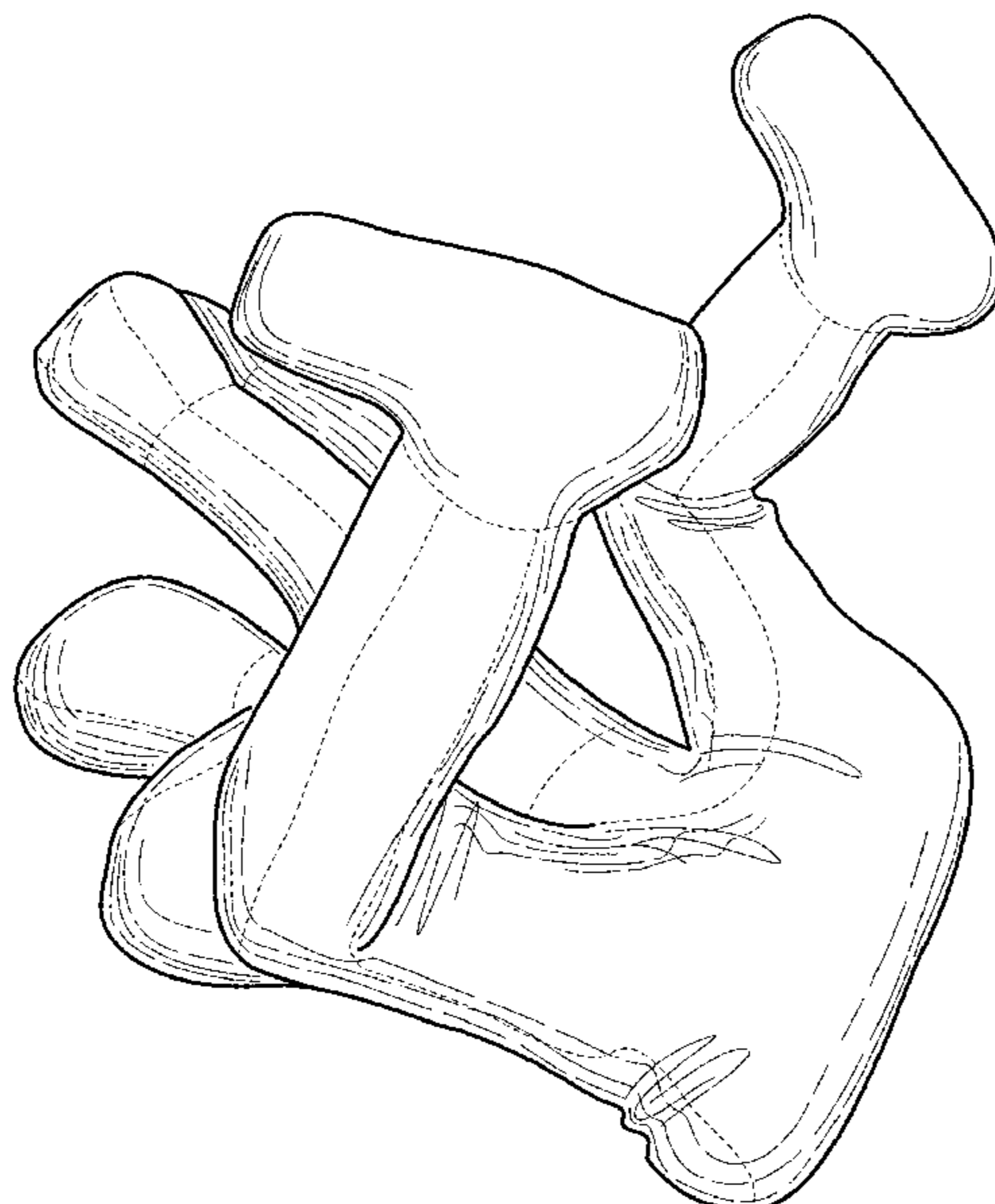
FIG. 1 shows a perspective view of a grappling dummy in a supine position.

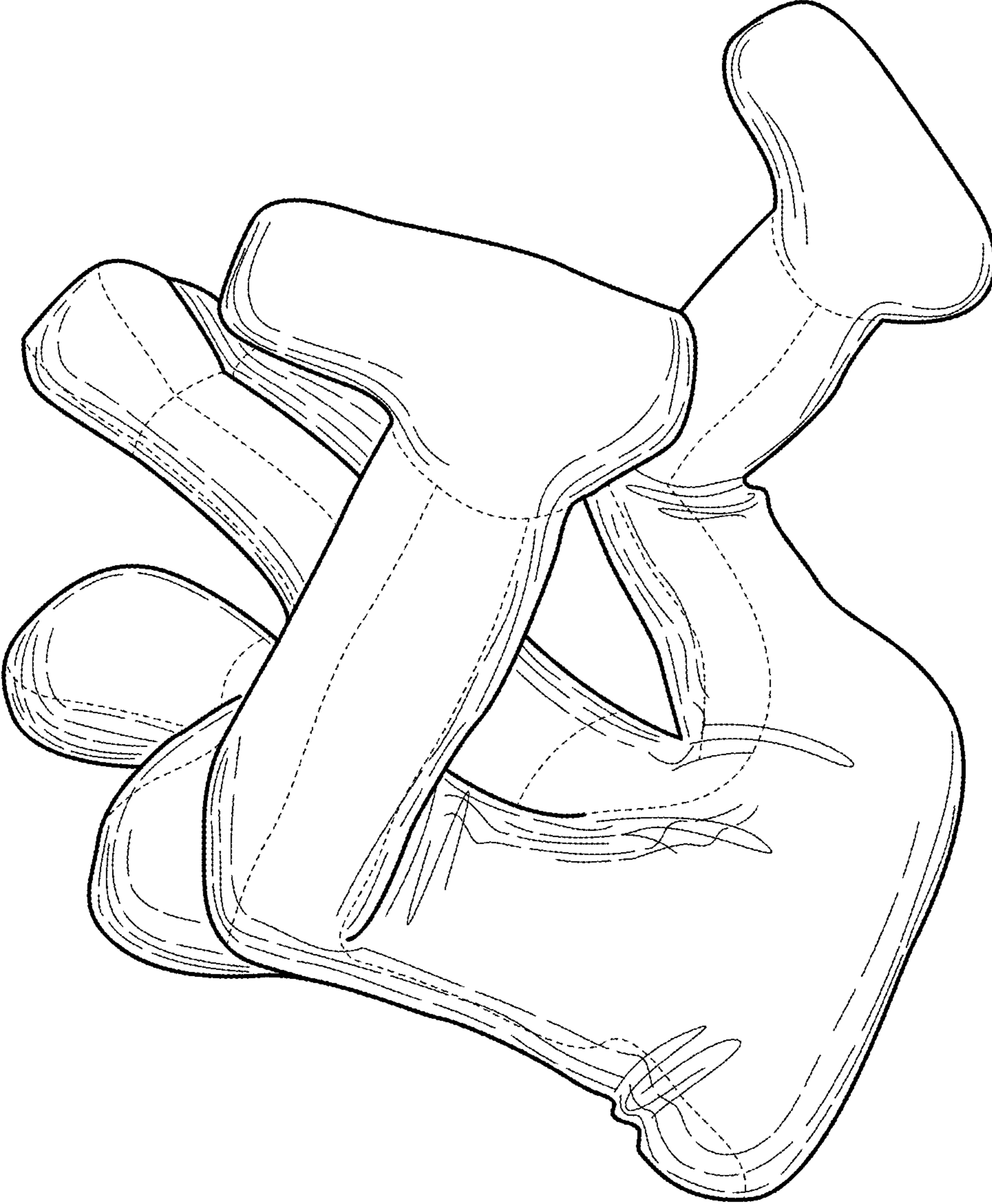

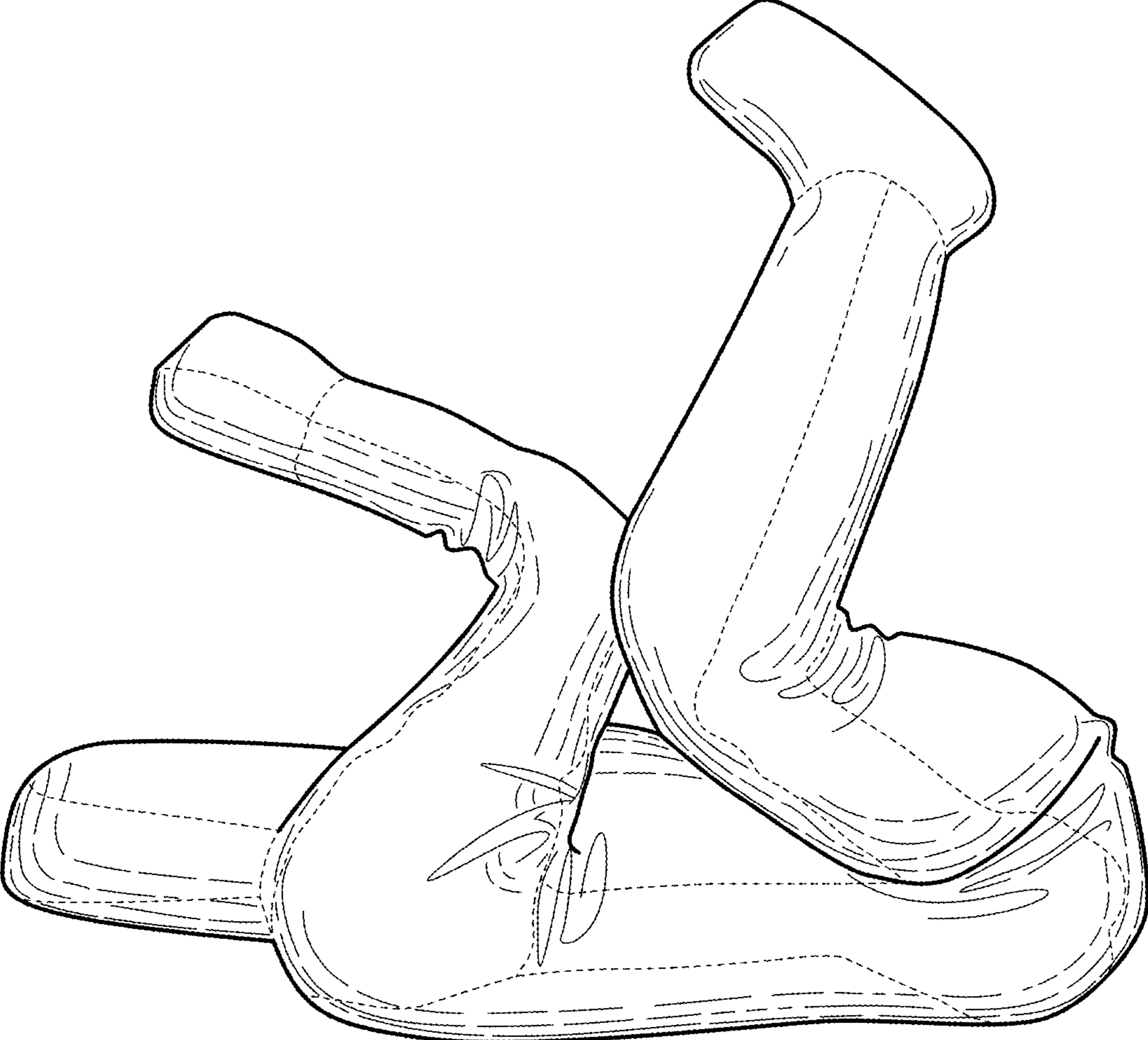

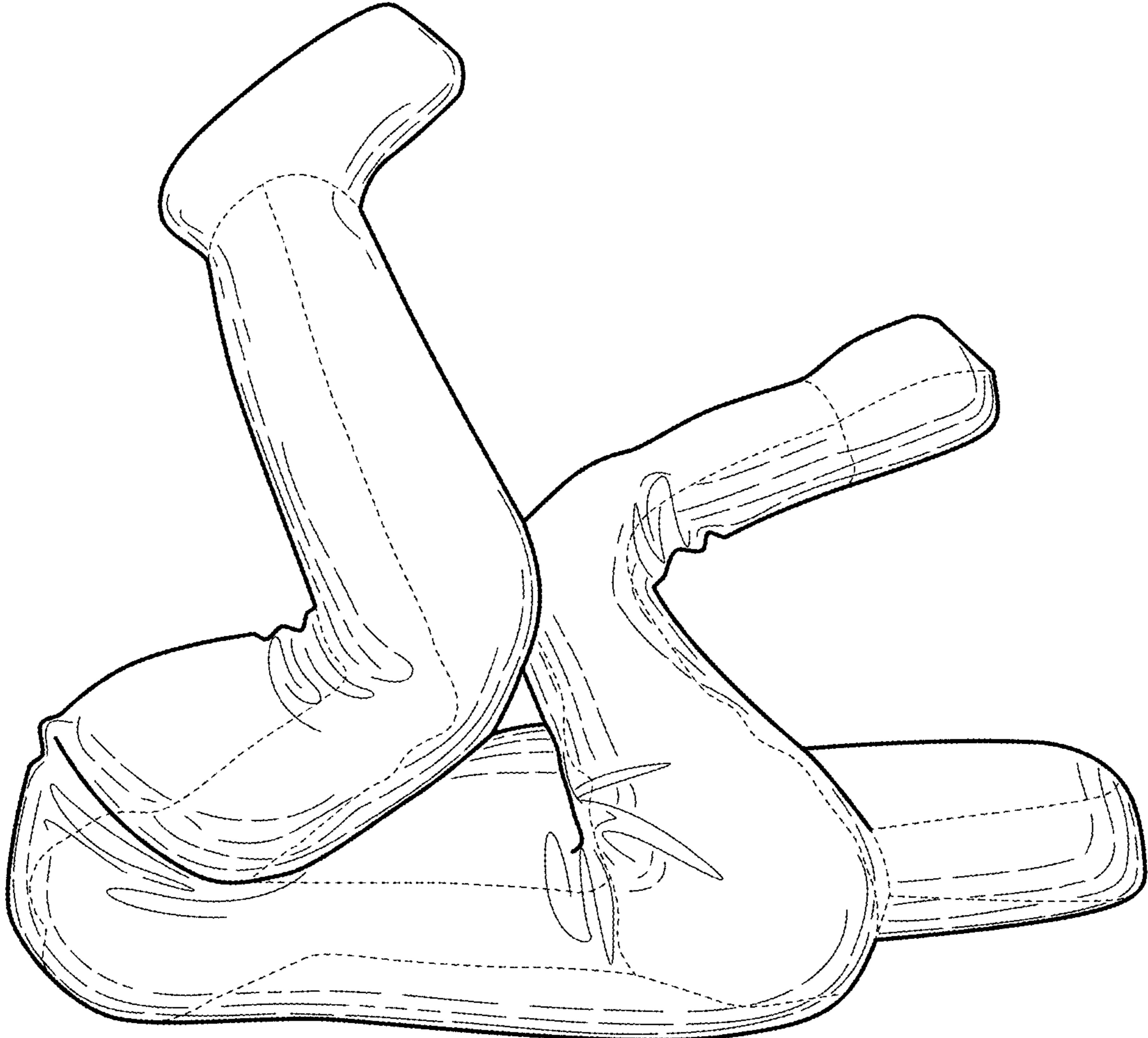

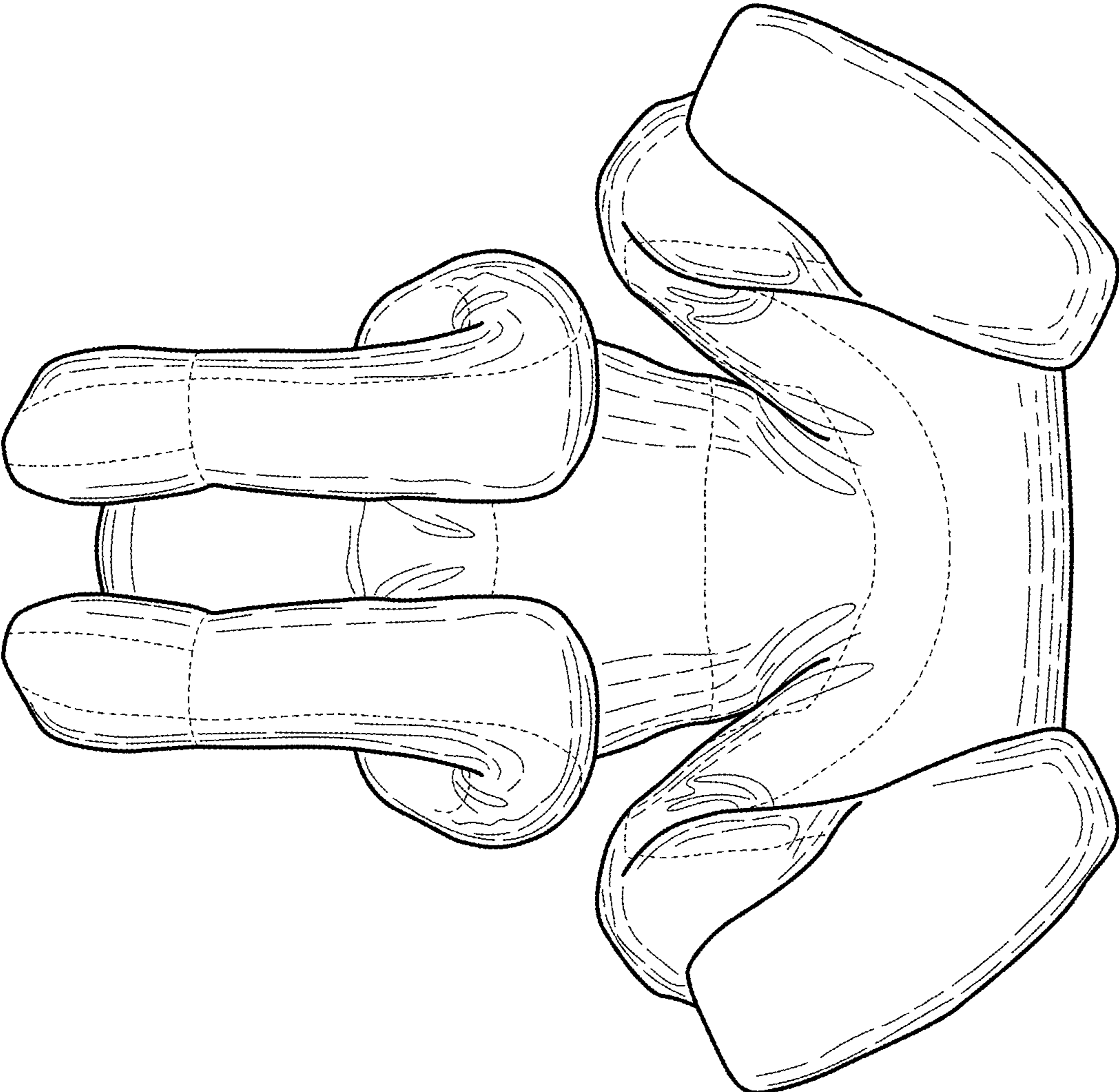

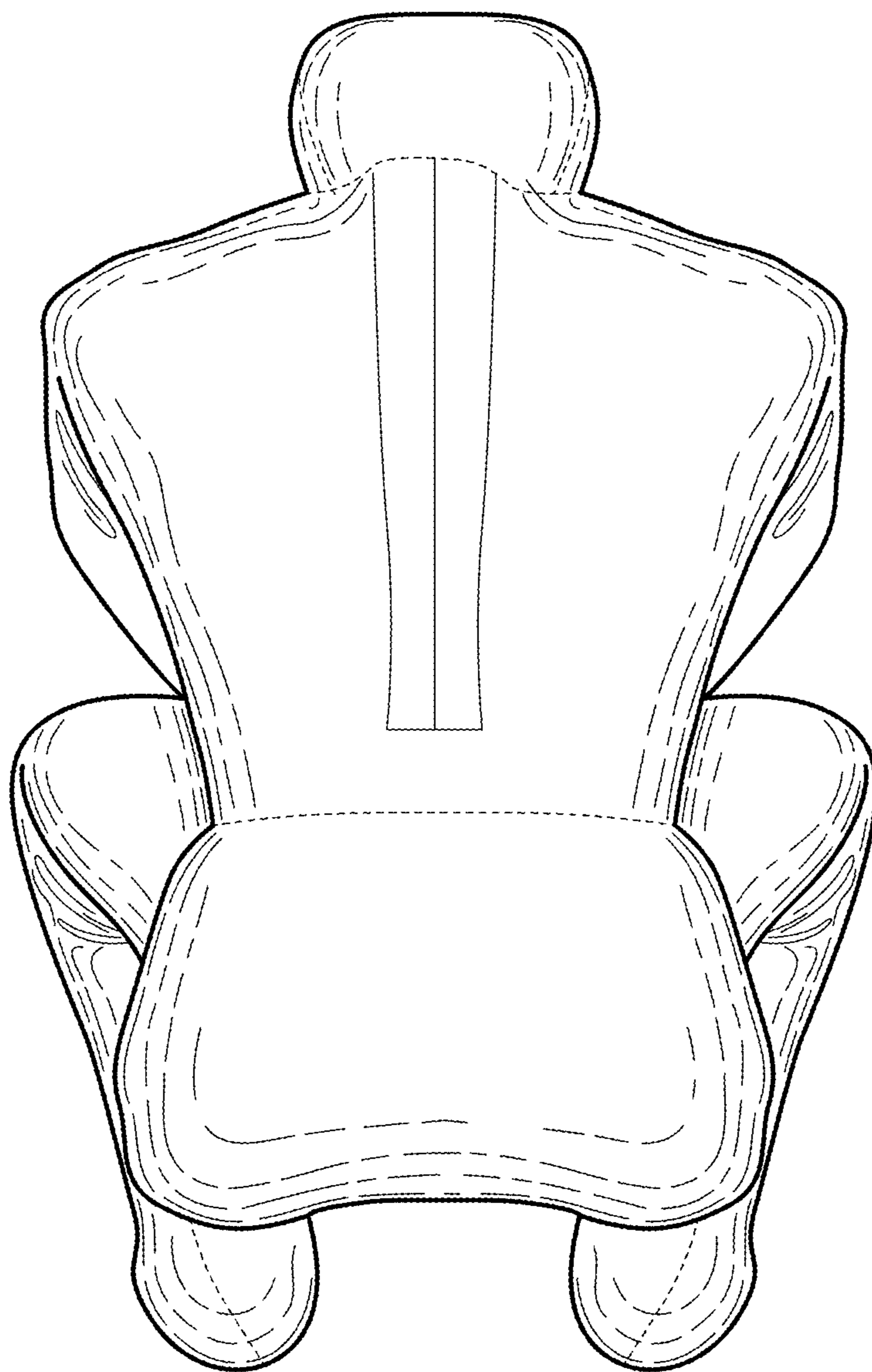

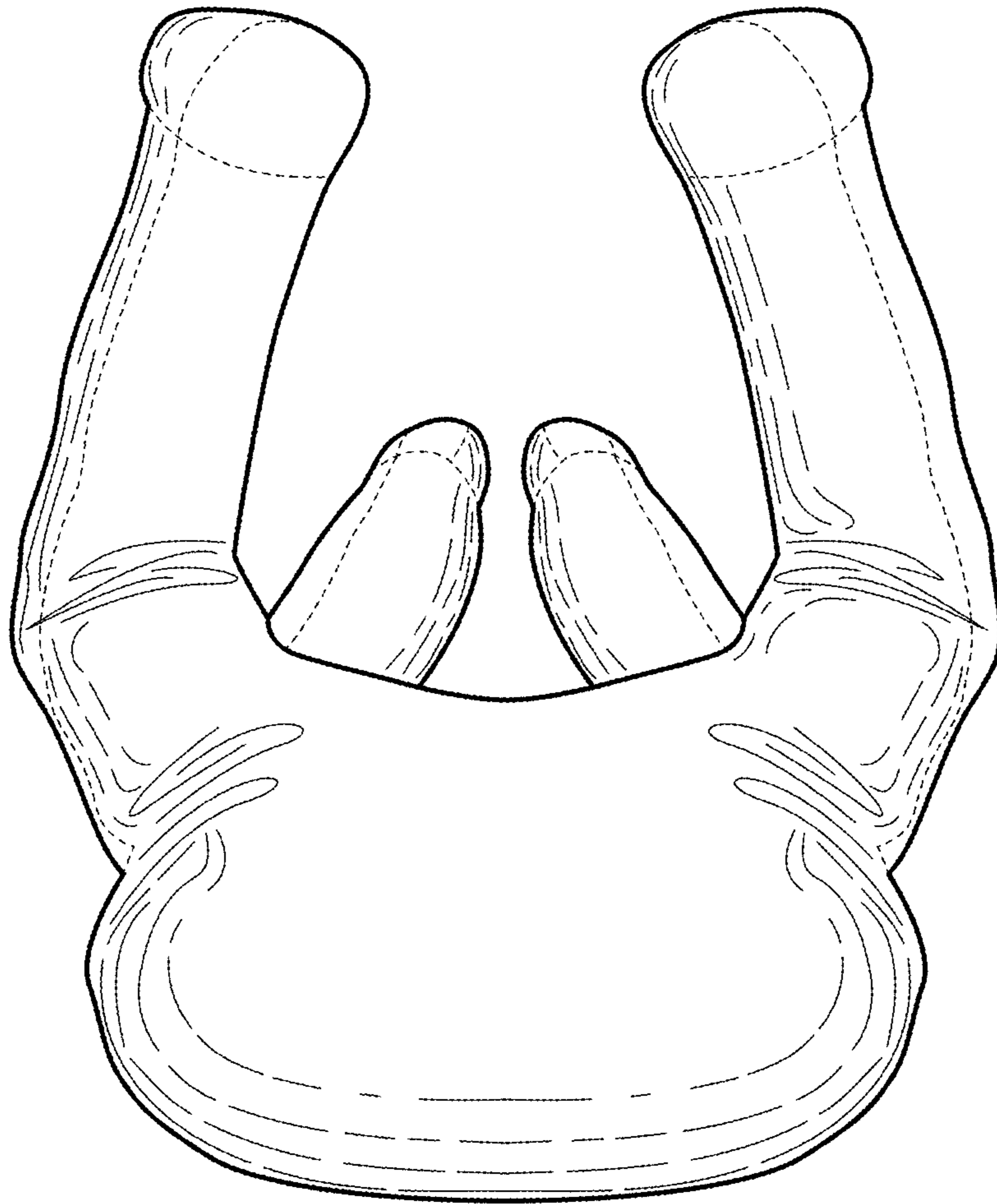

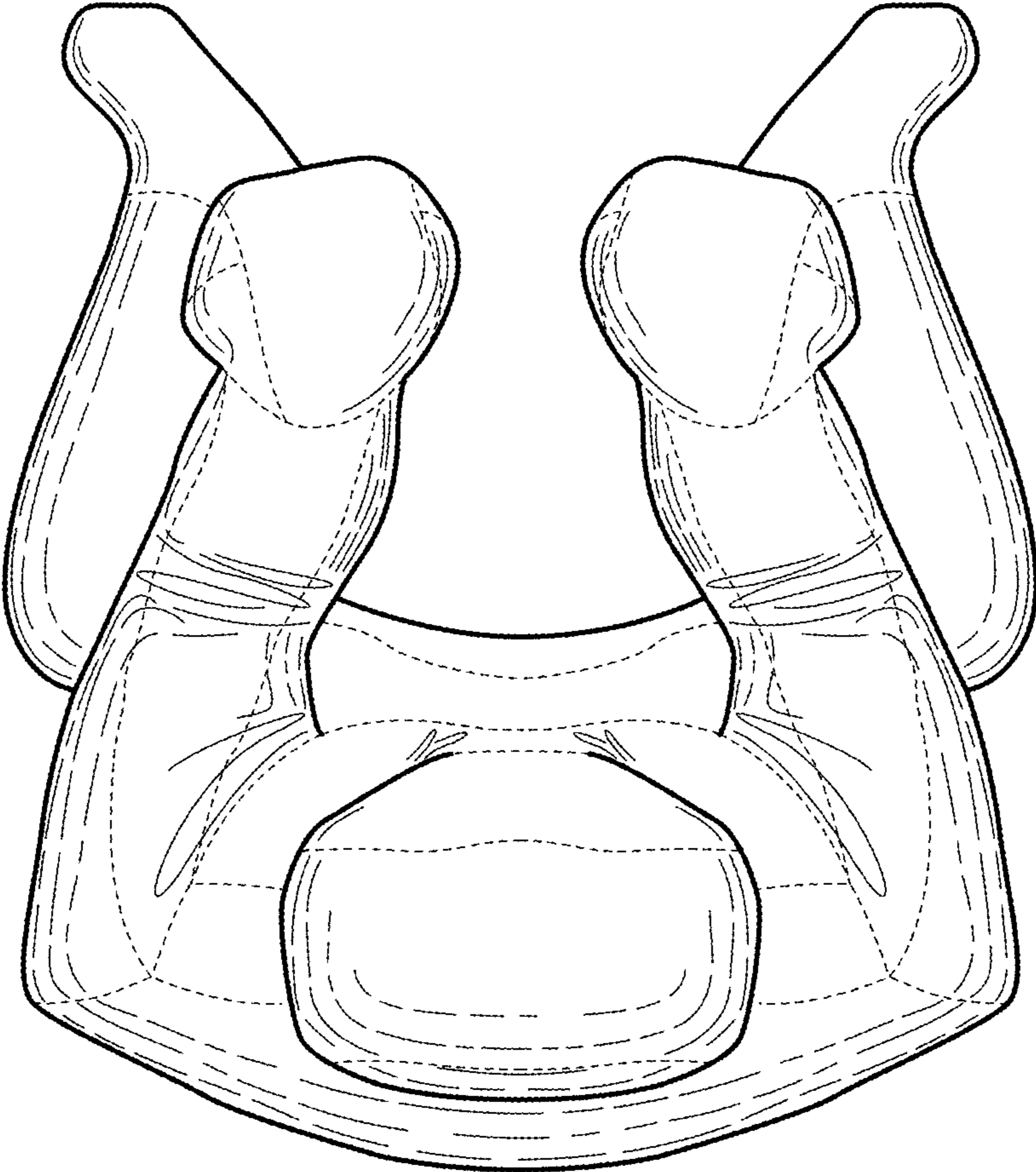
