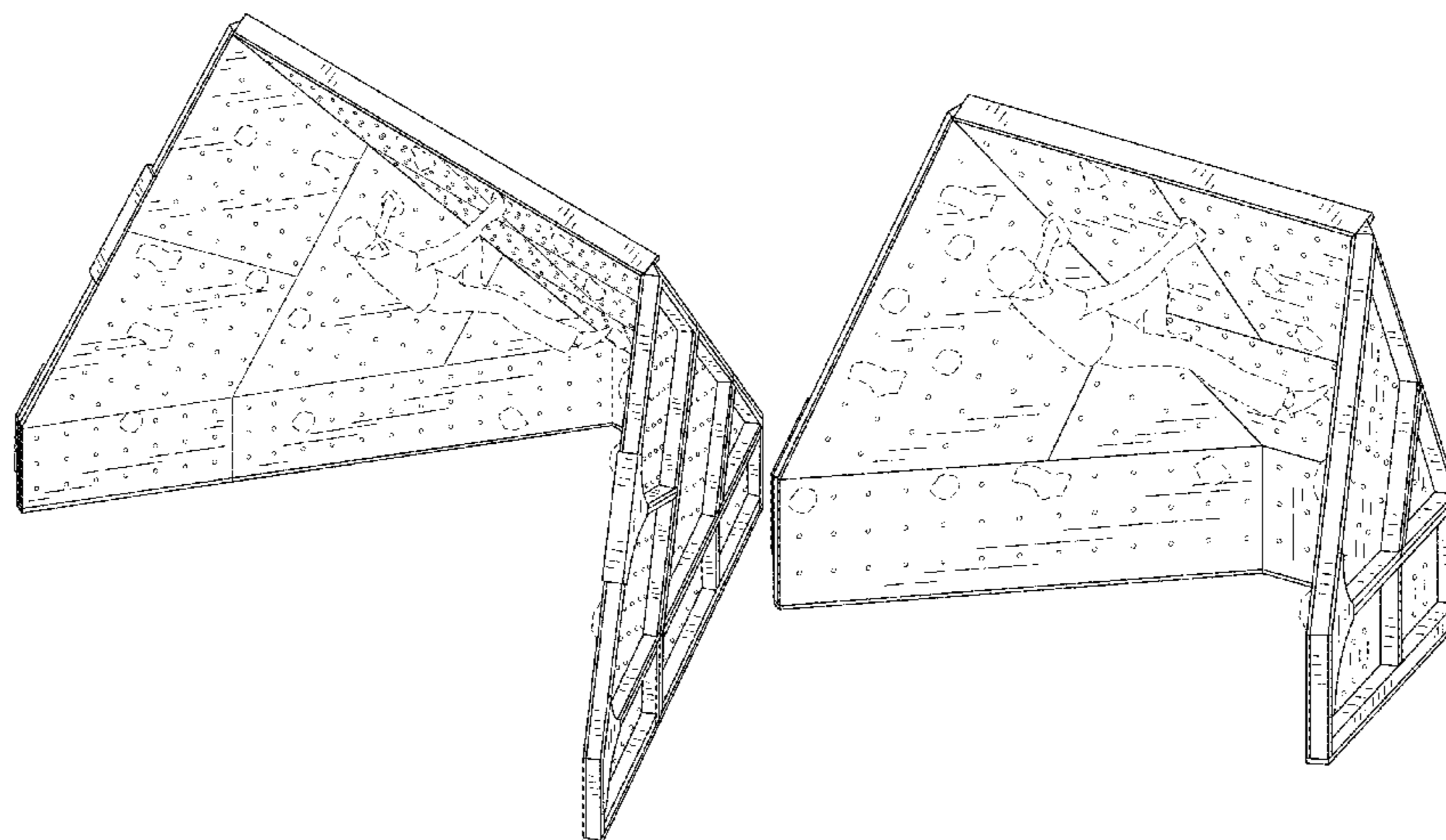


FIG. 24 is a bottom plan view of the climbing wall of FIG. 17.

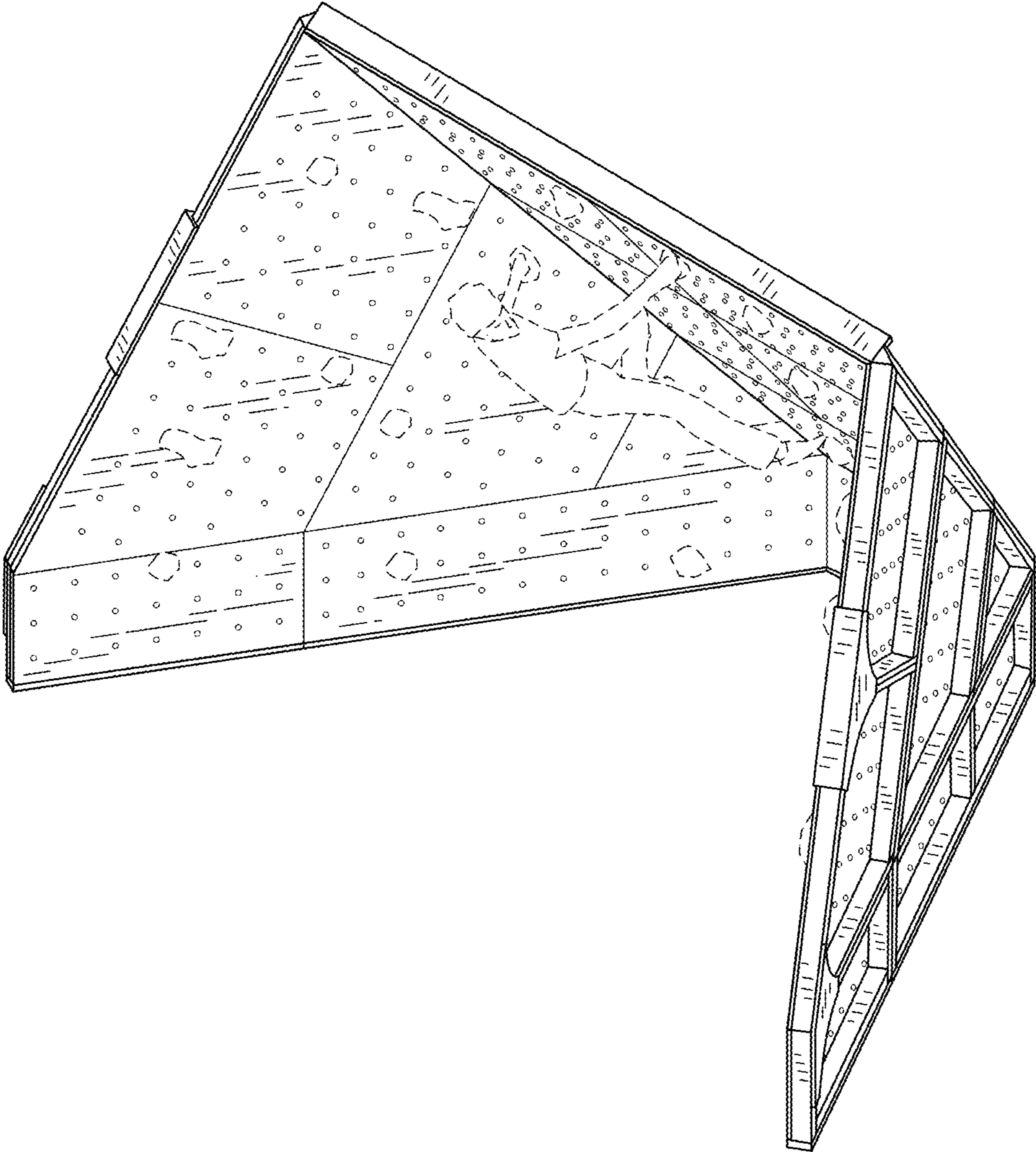

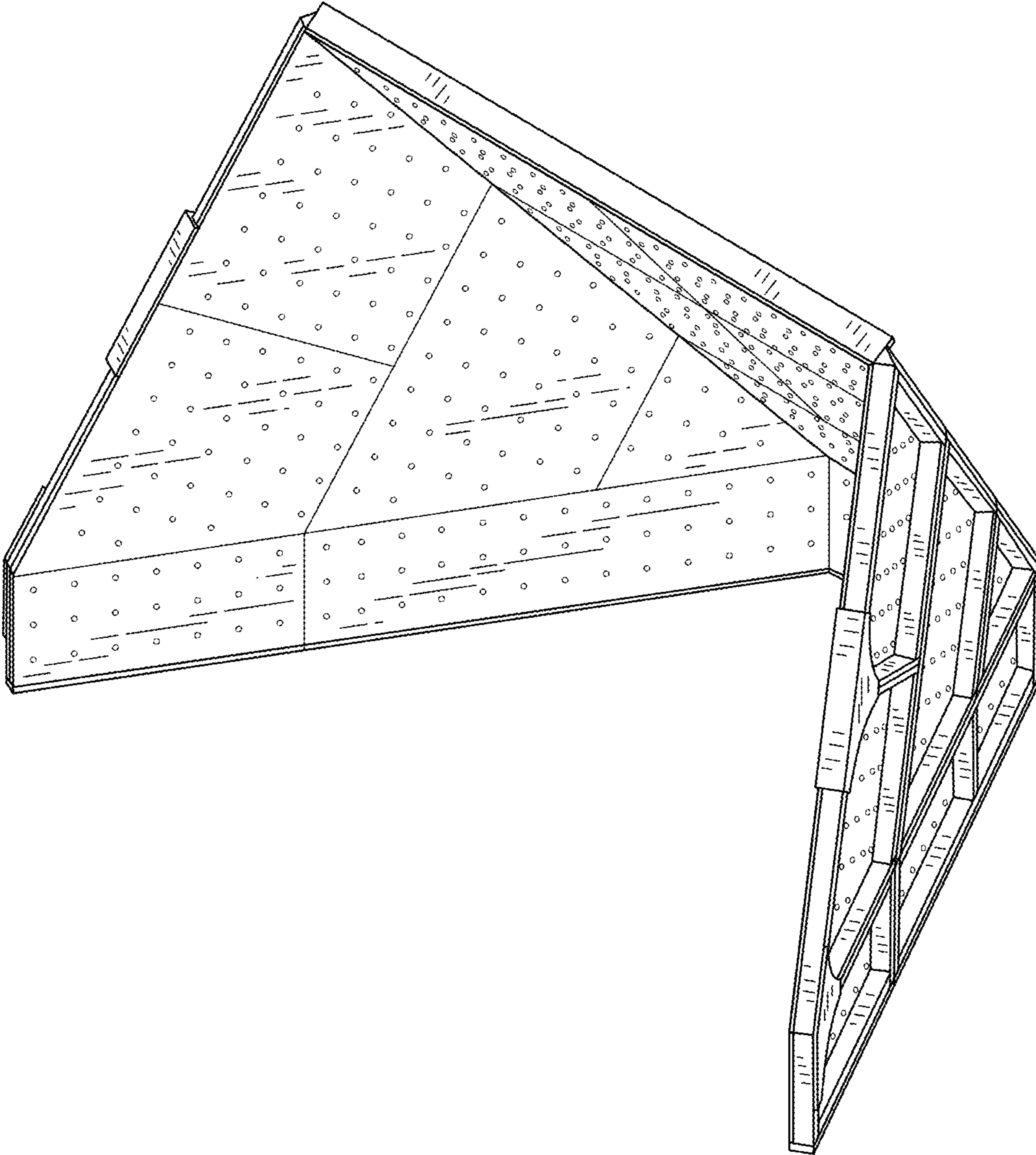

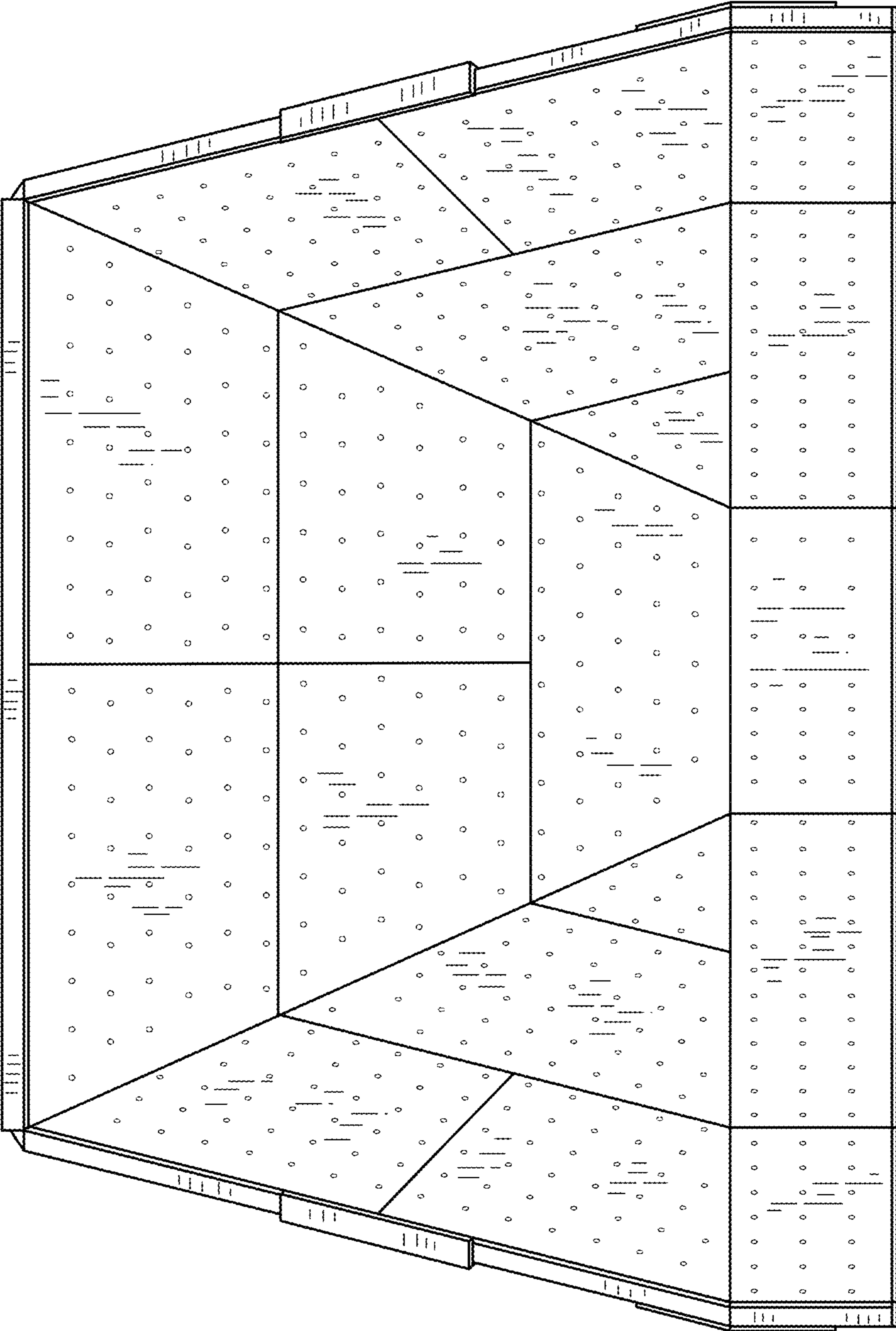

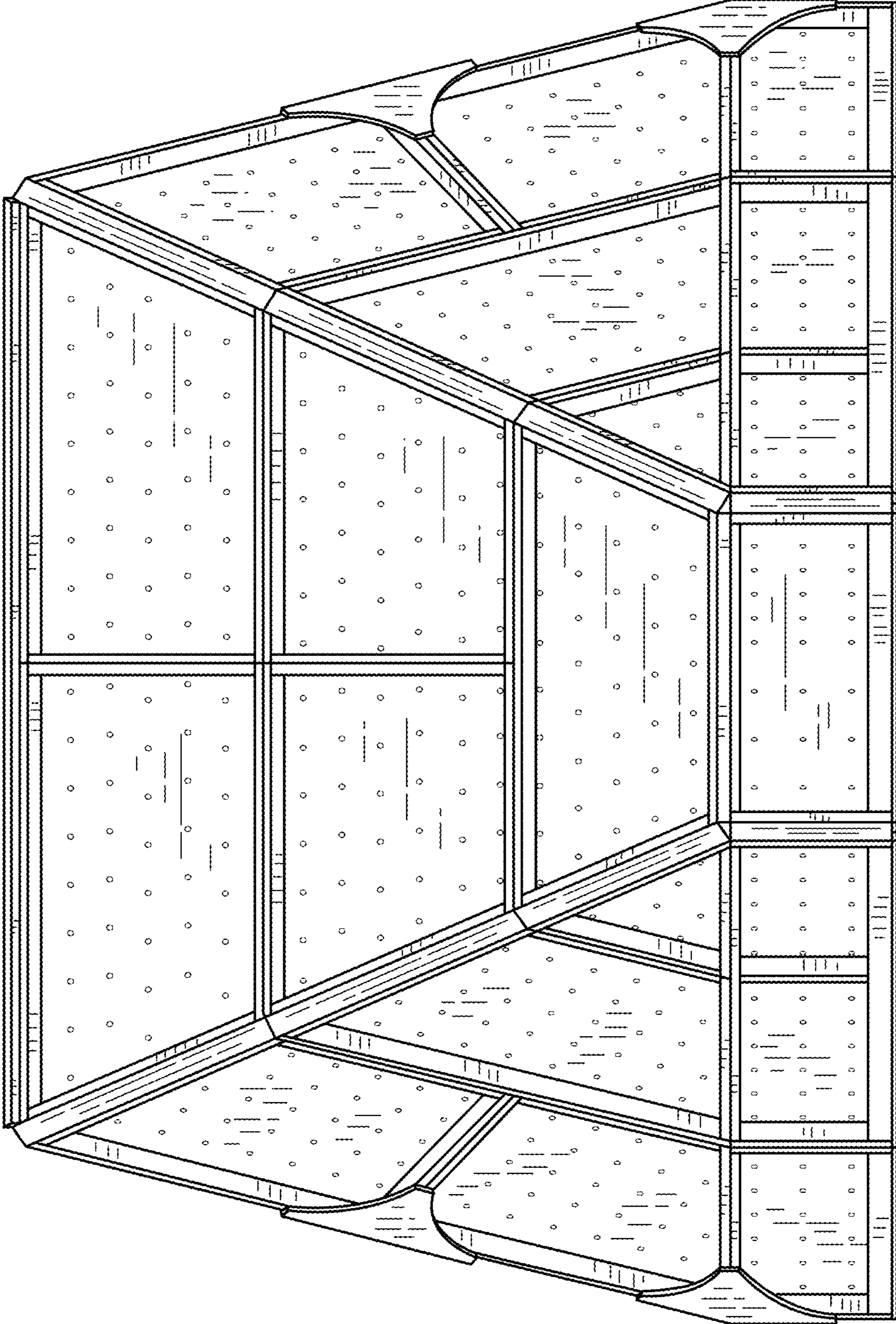

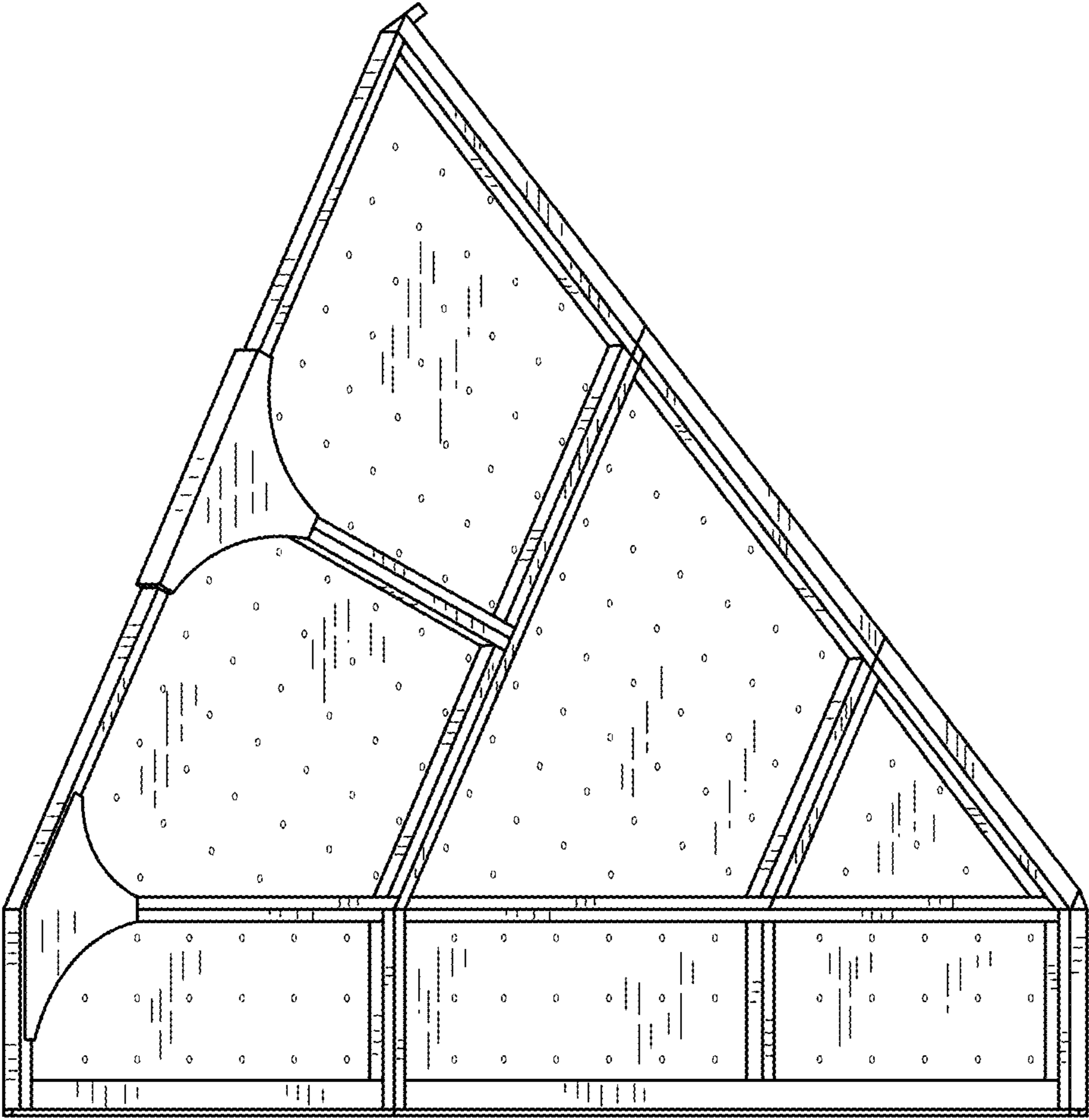

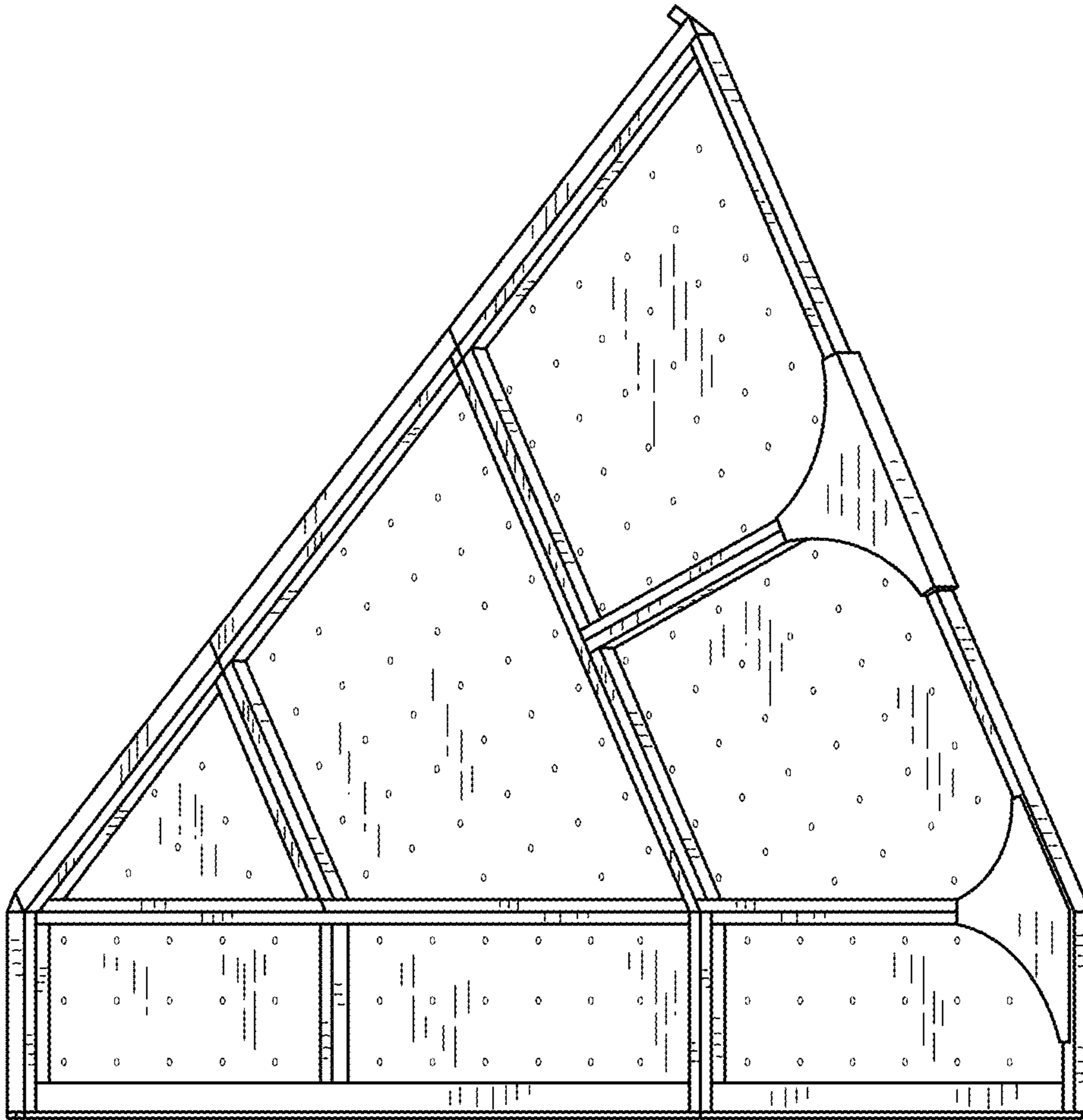

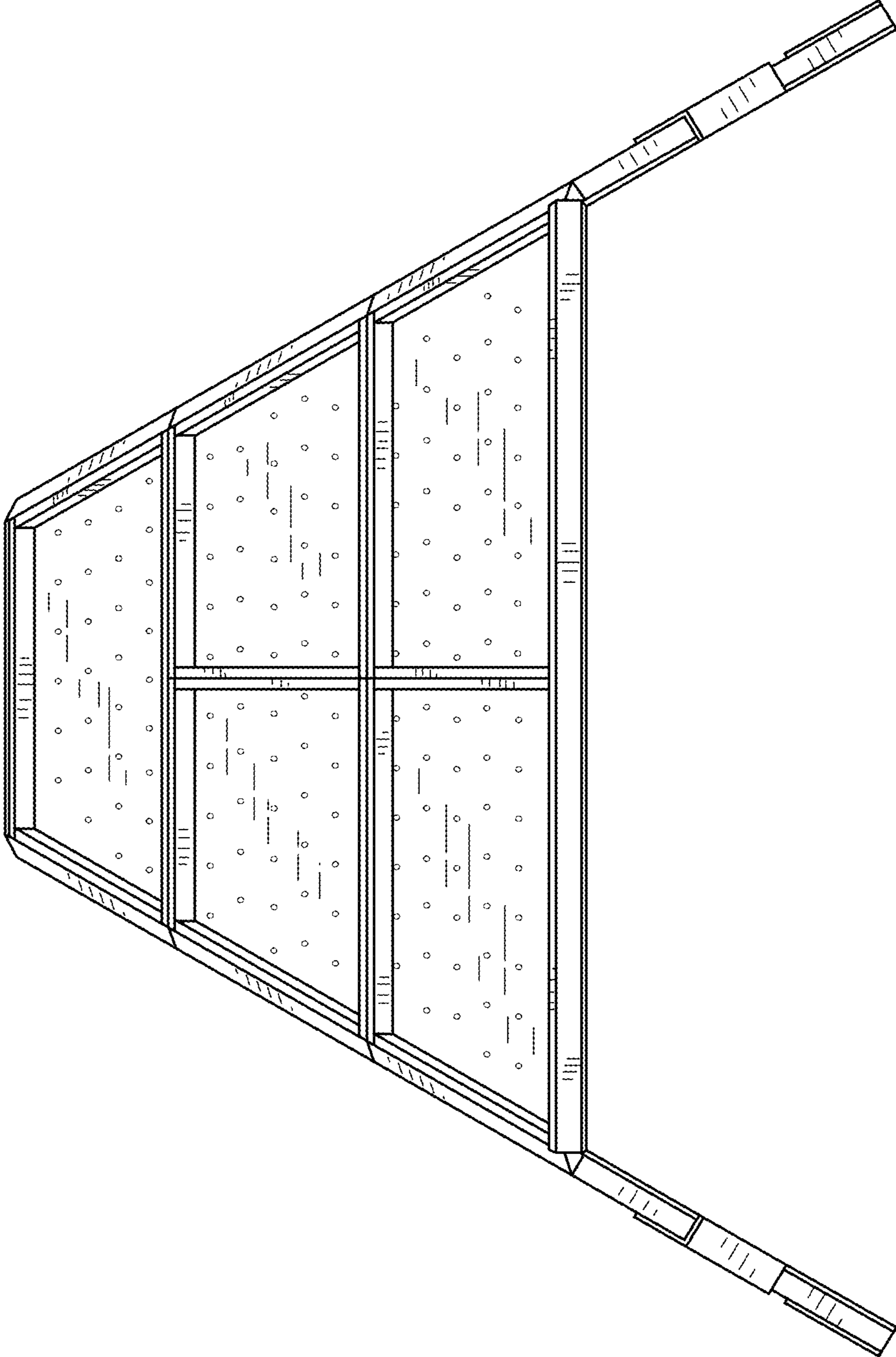

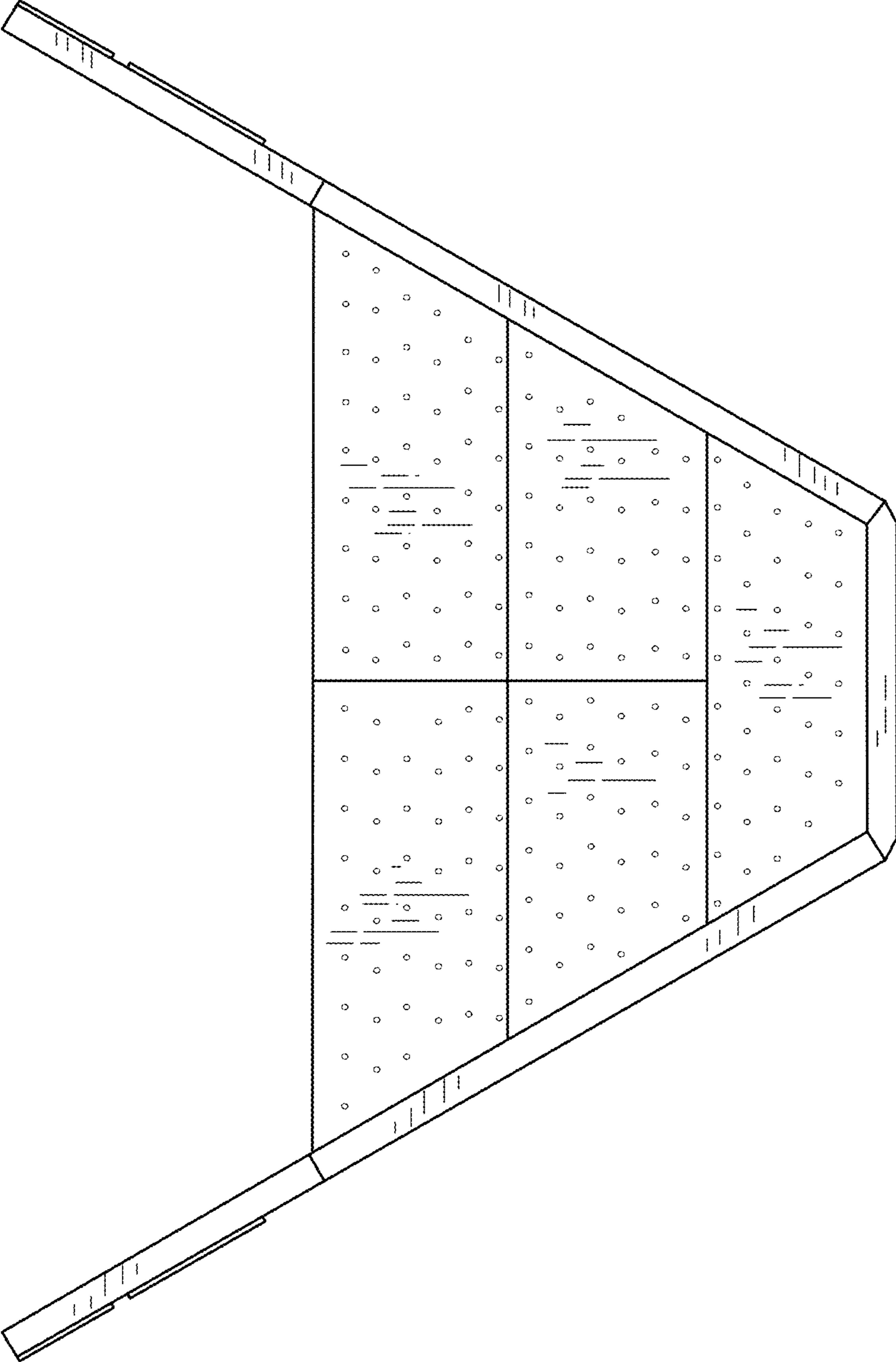

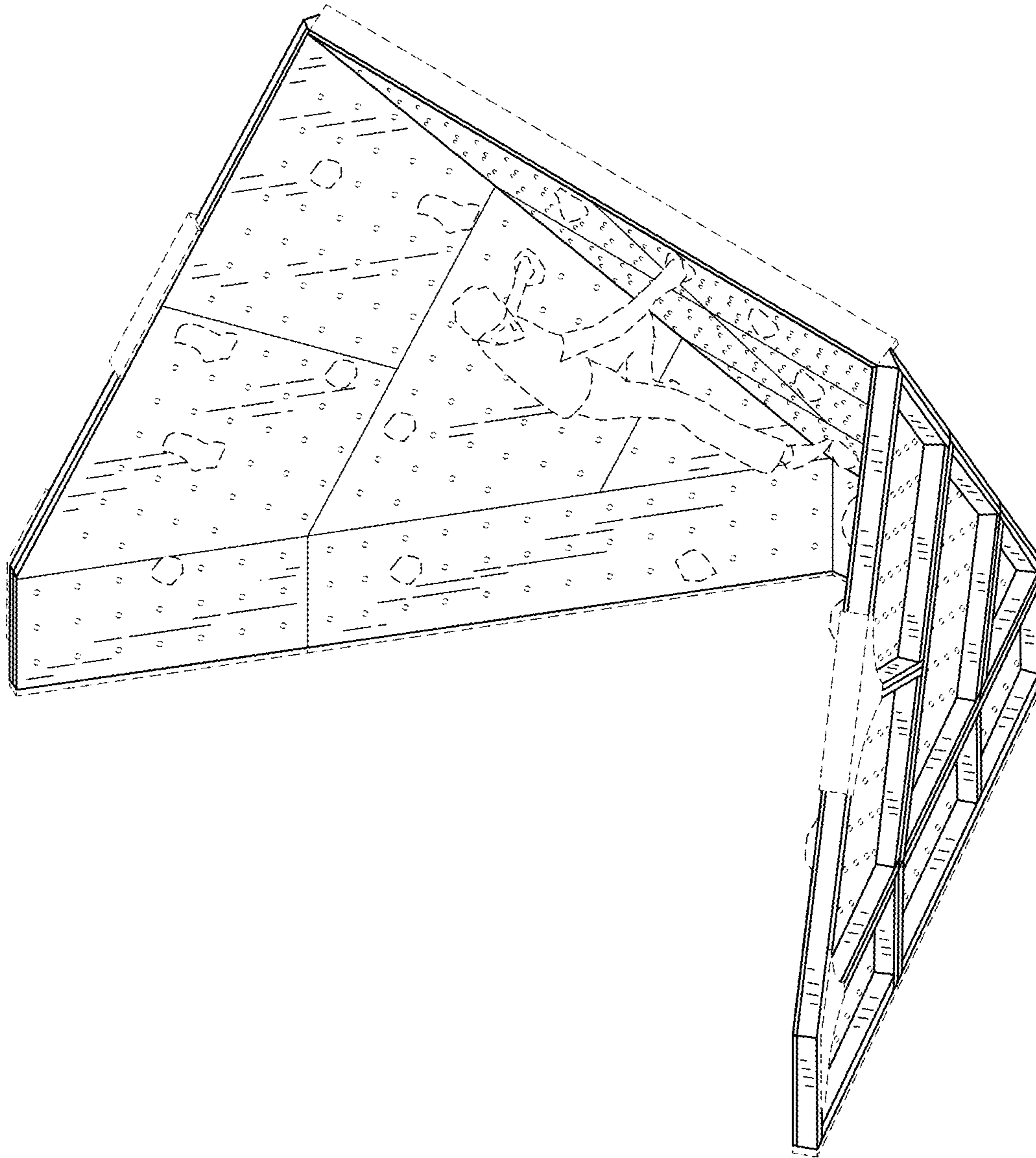

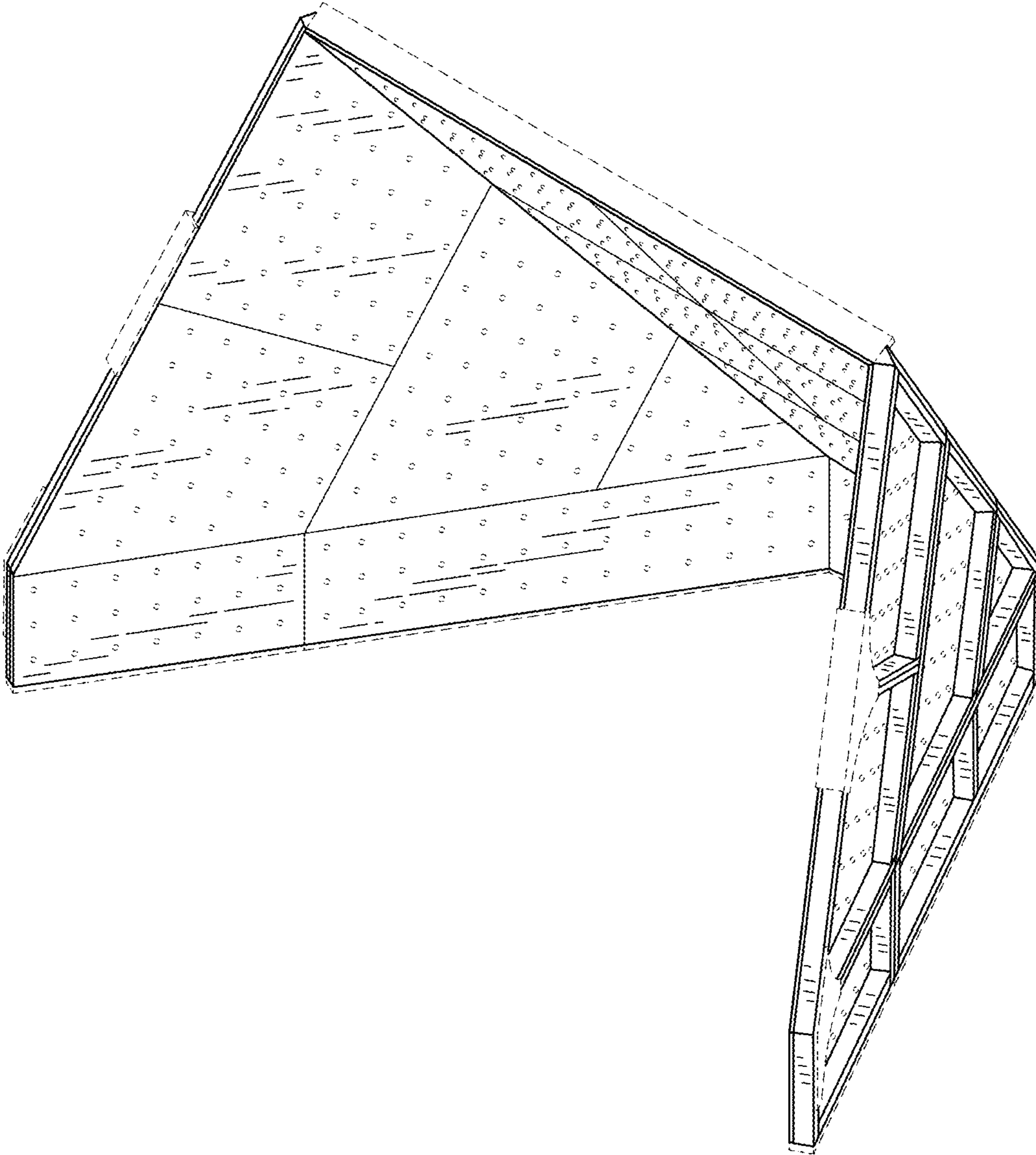

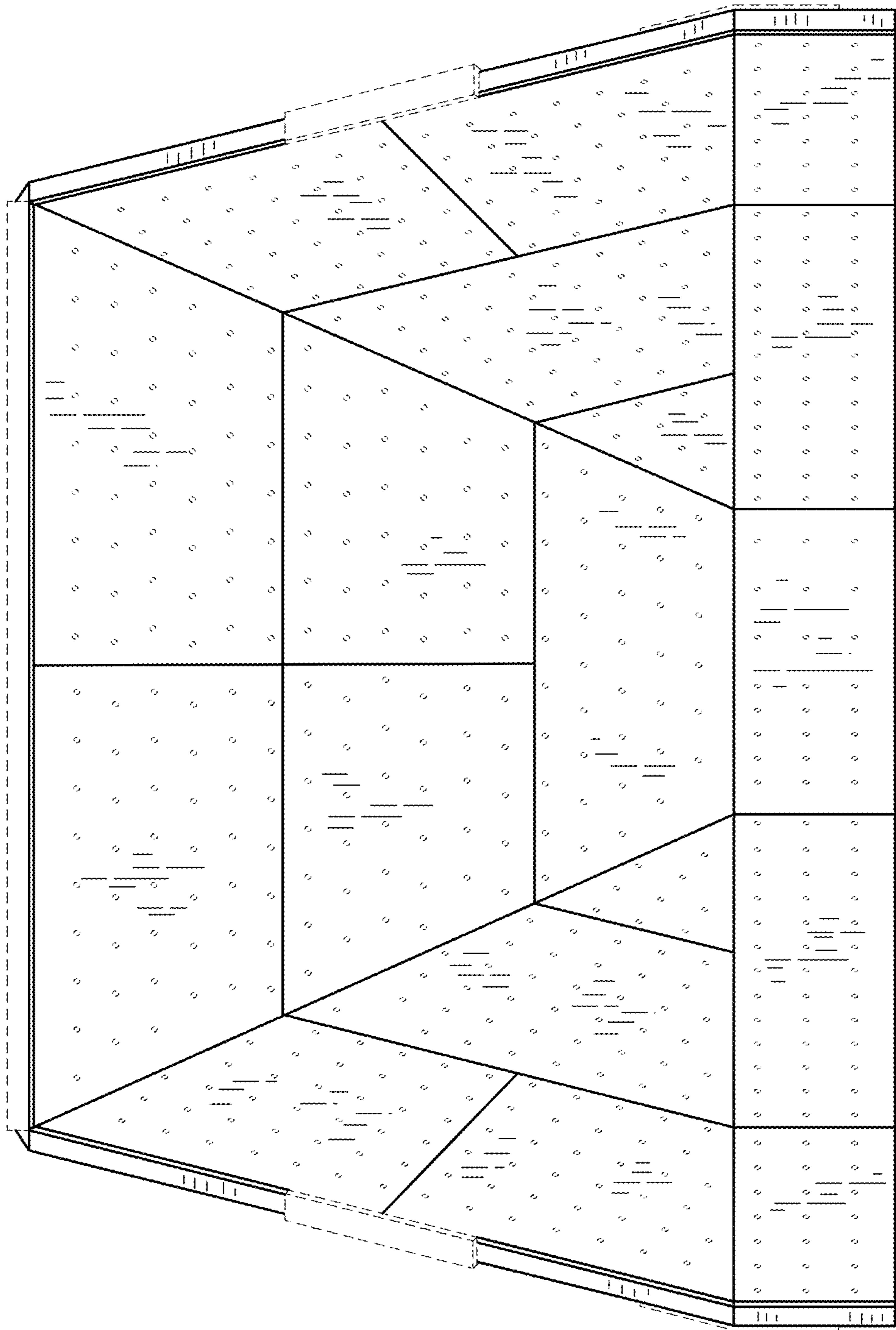

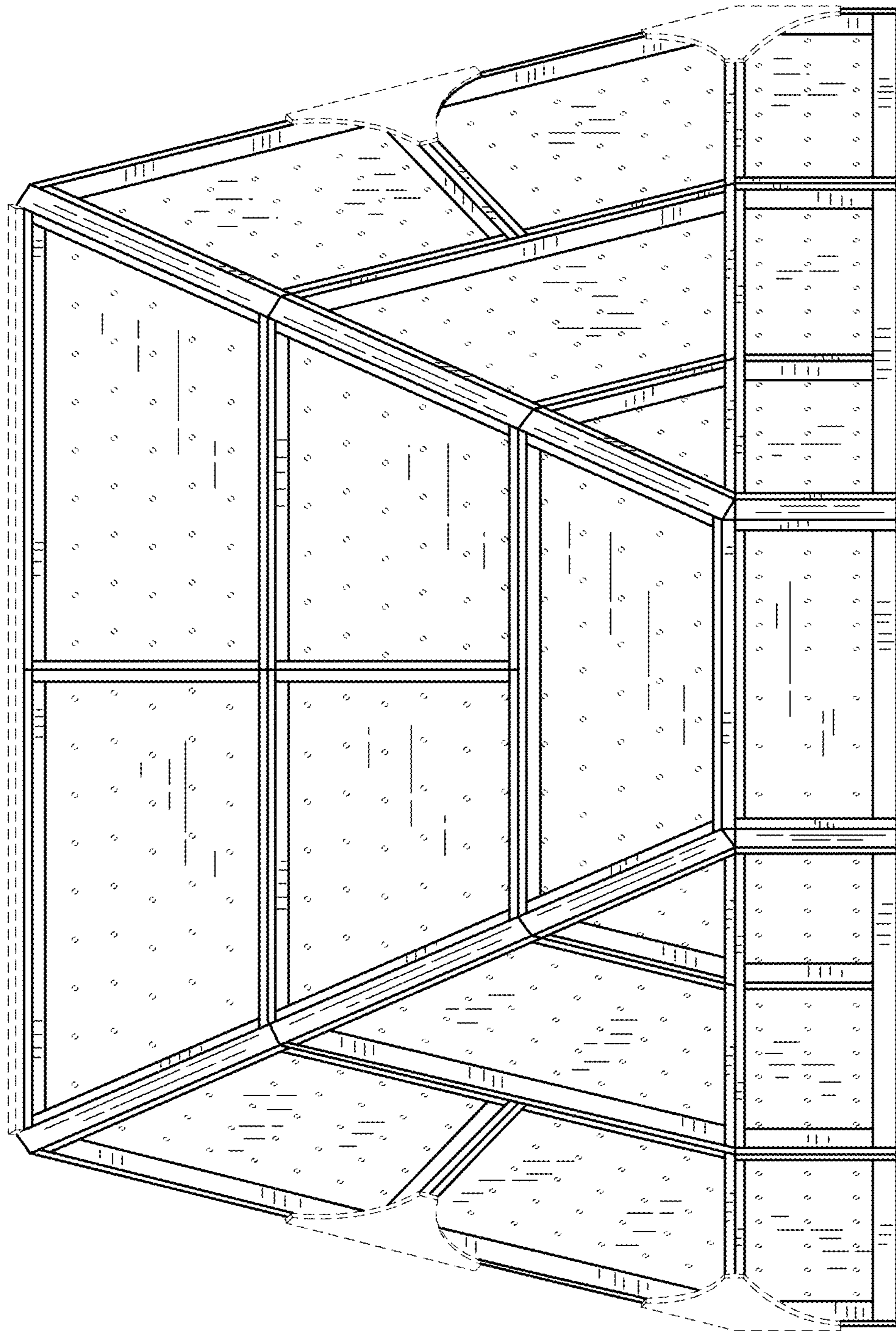

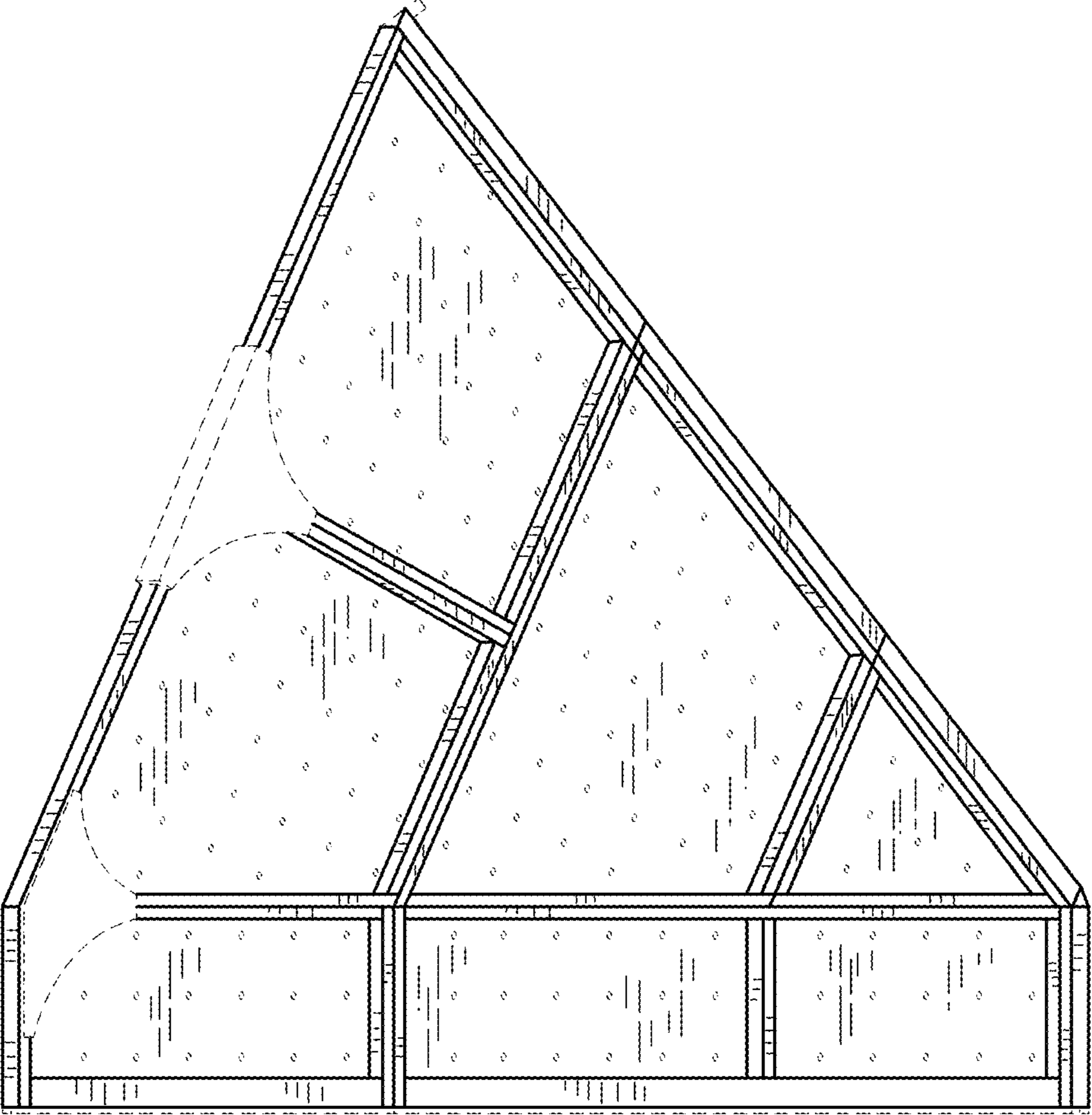

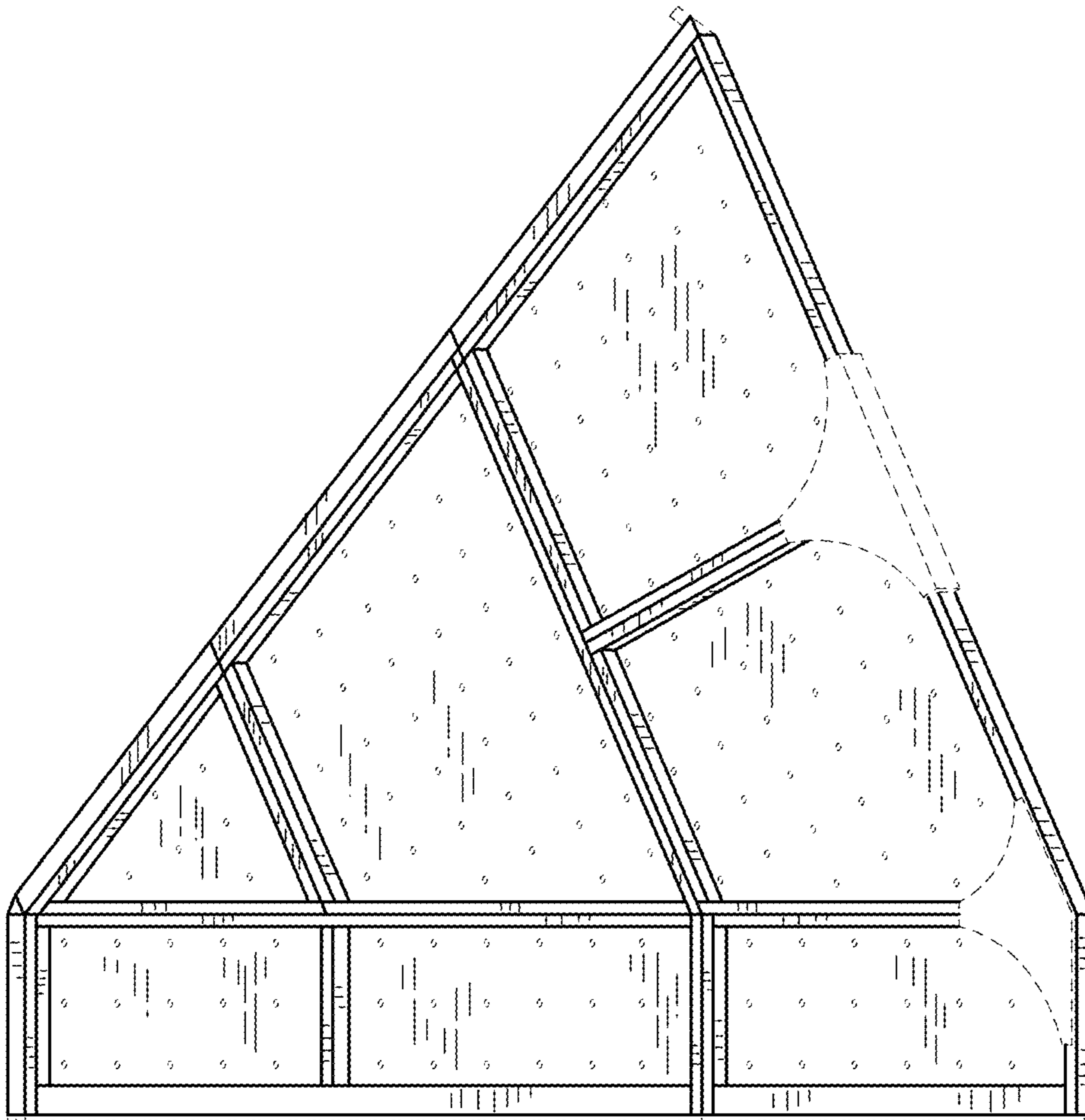

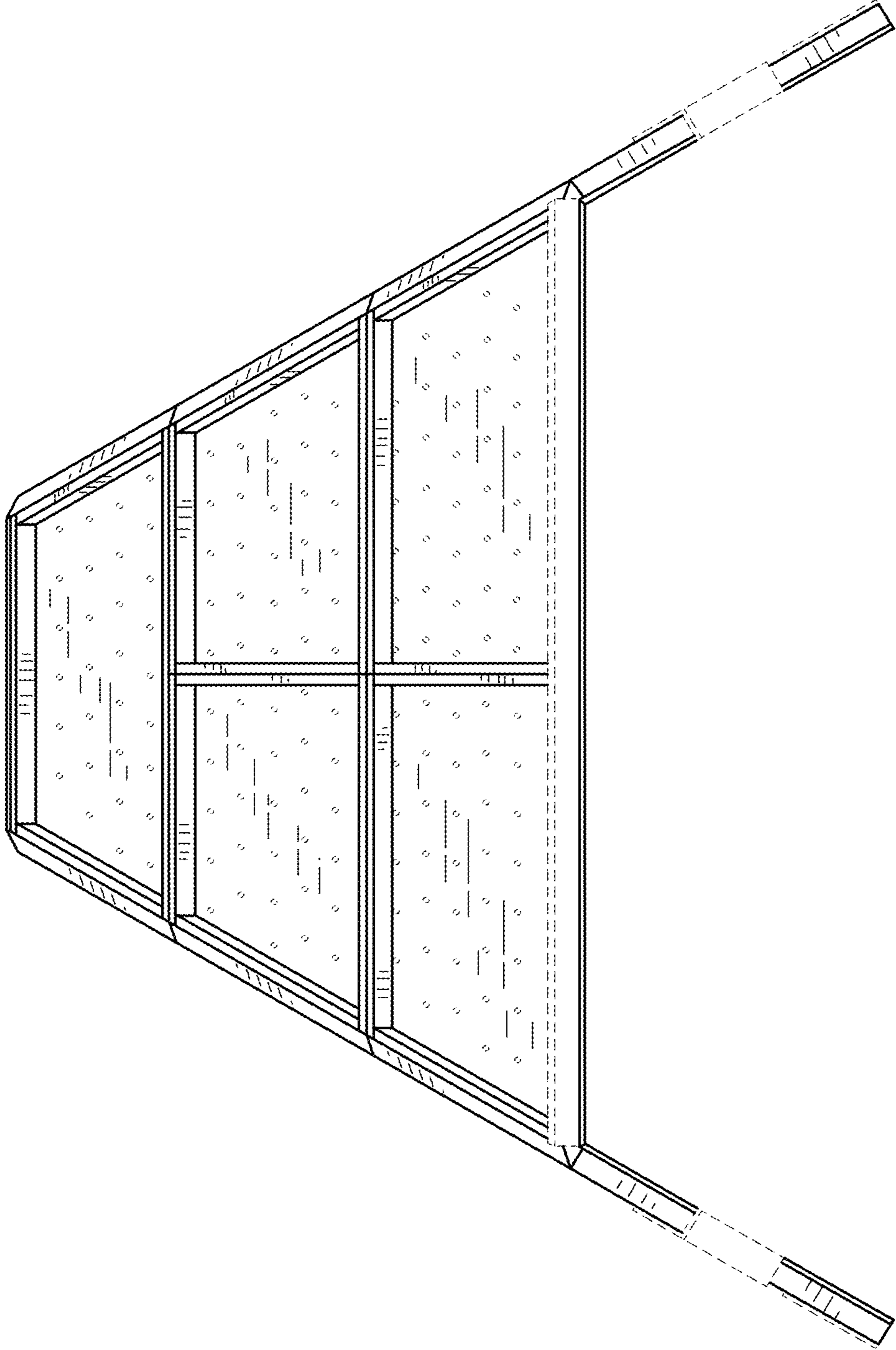

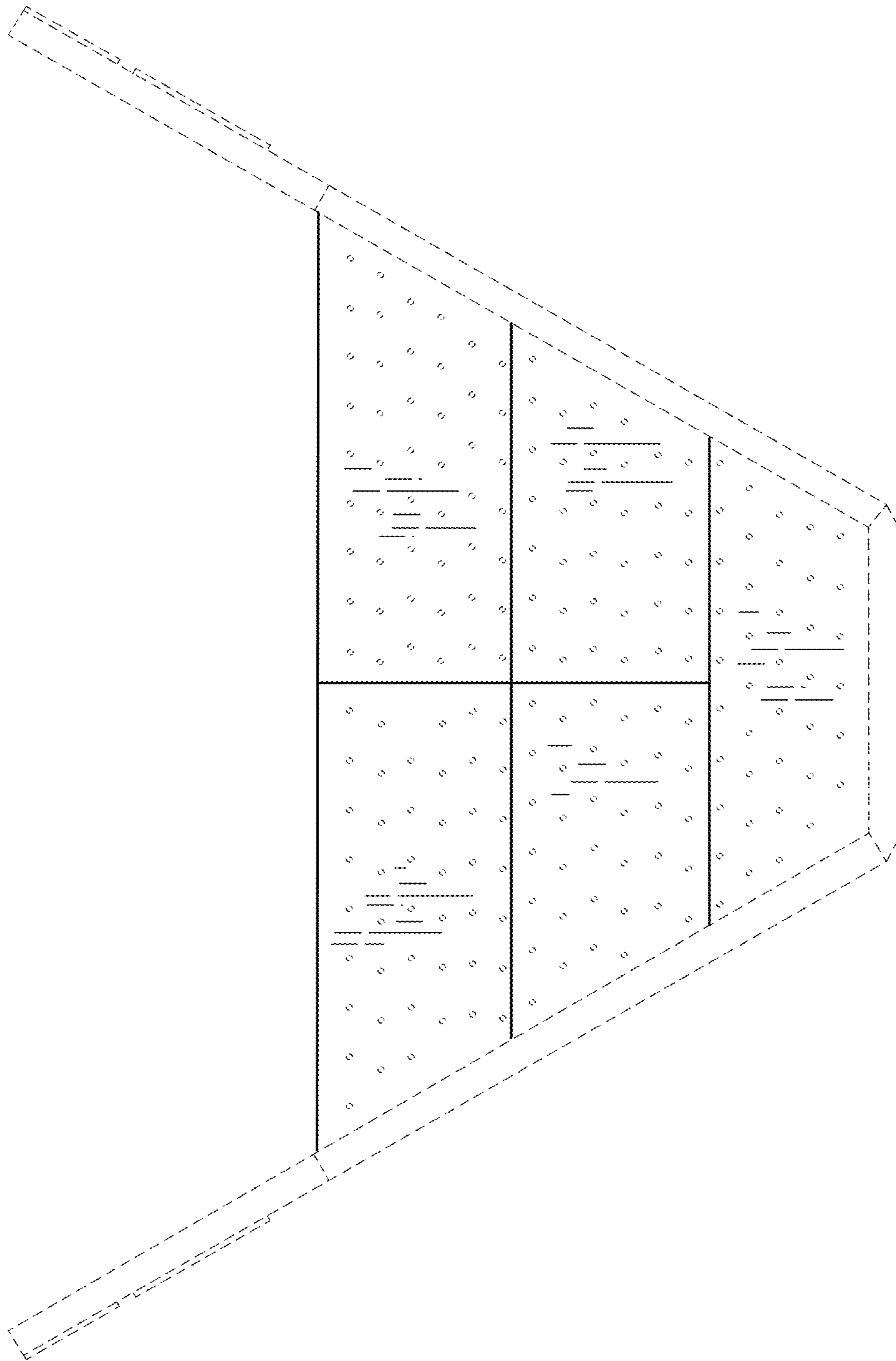

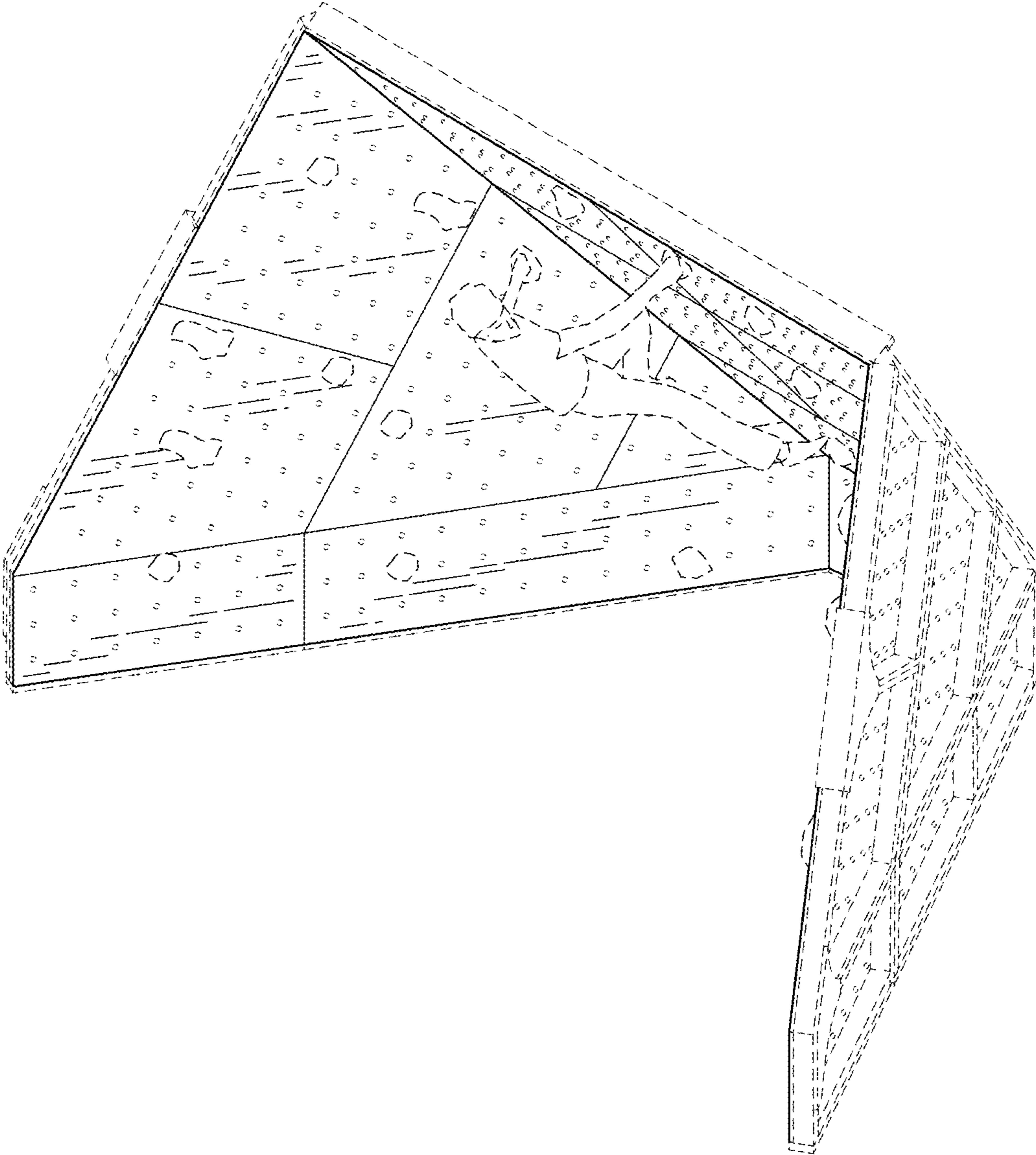

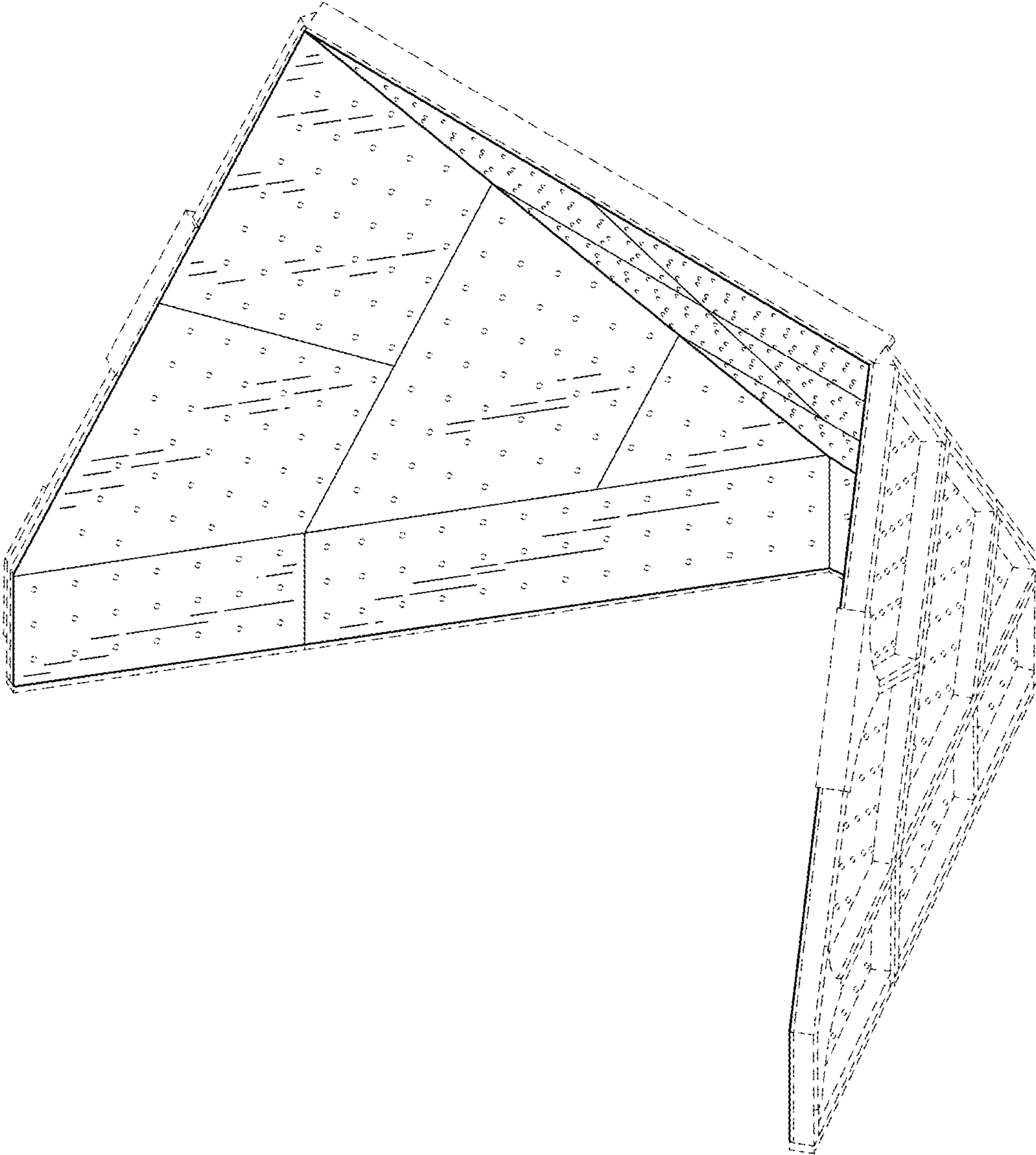

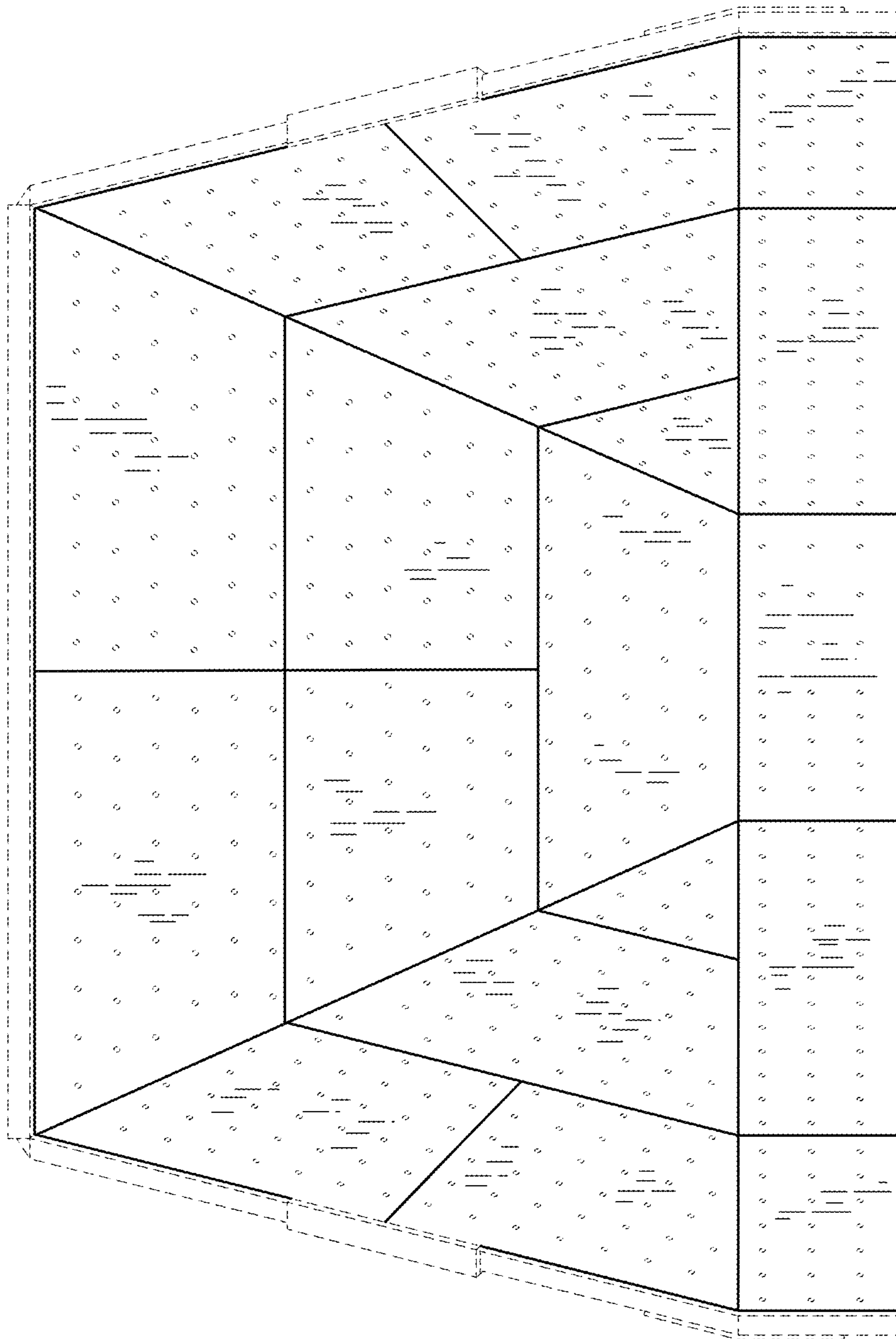

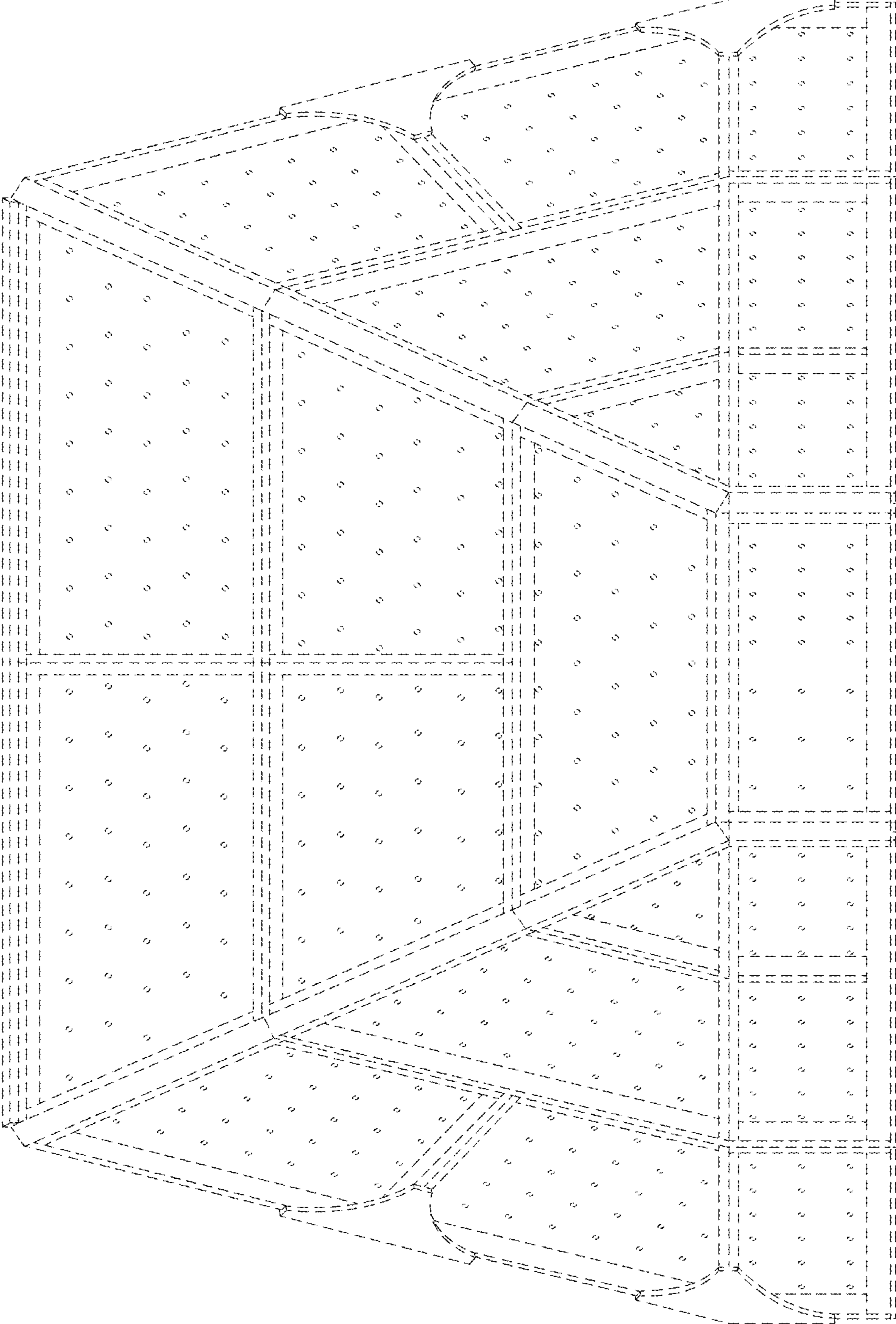

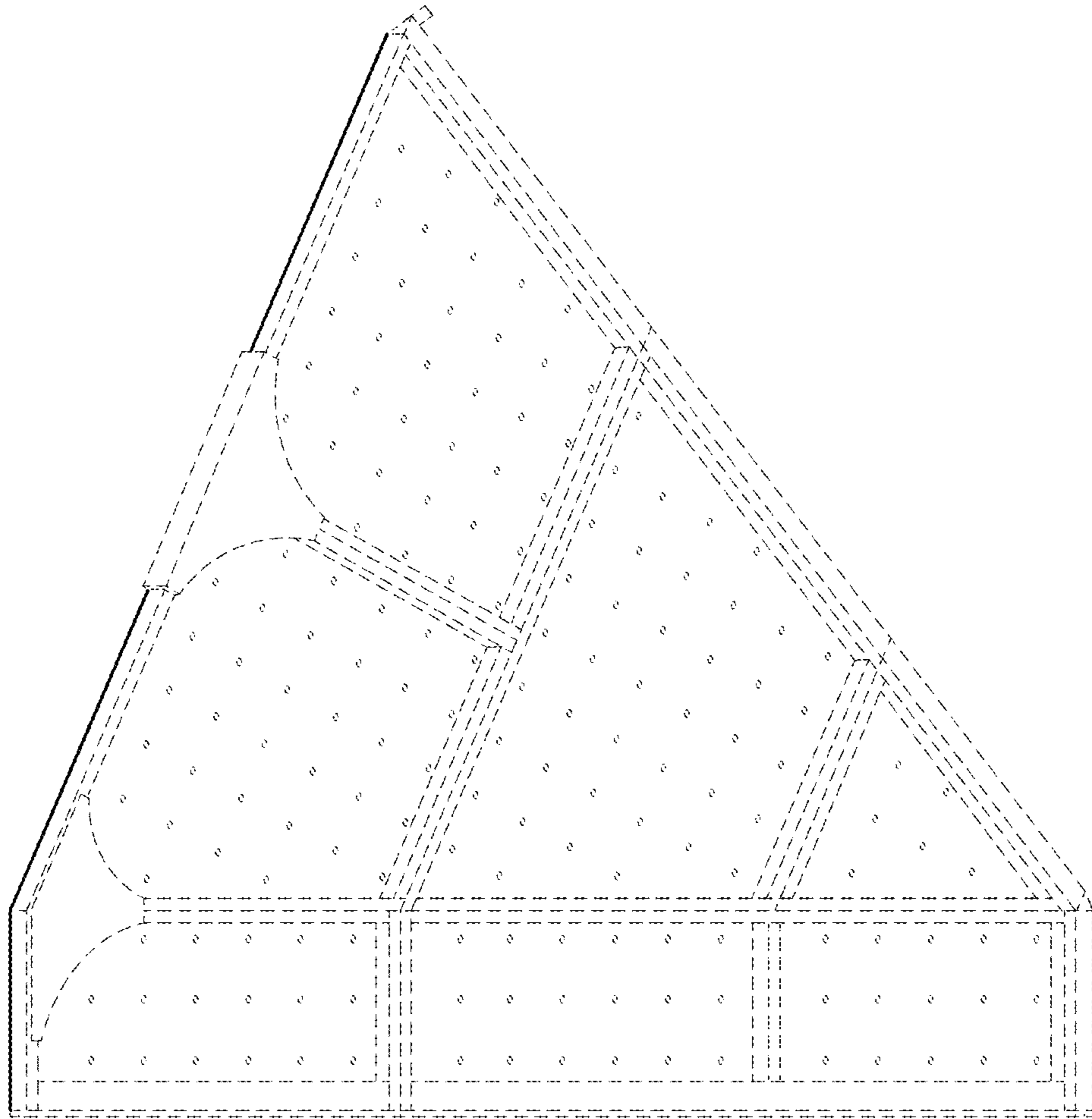

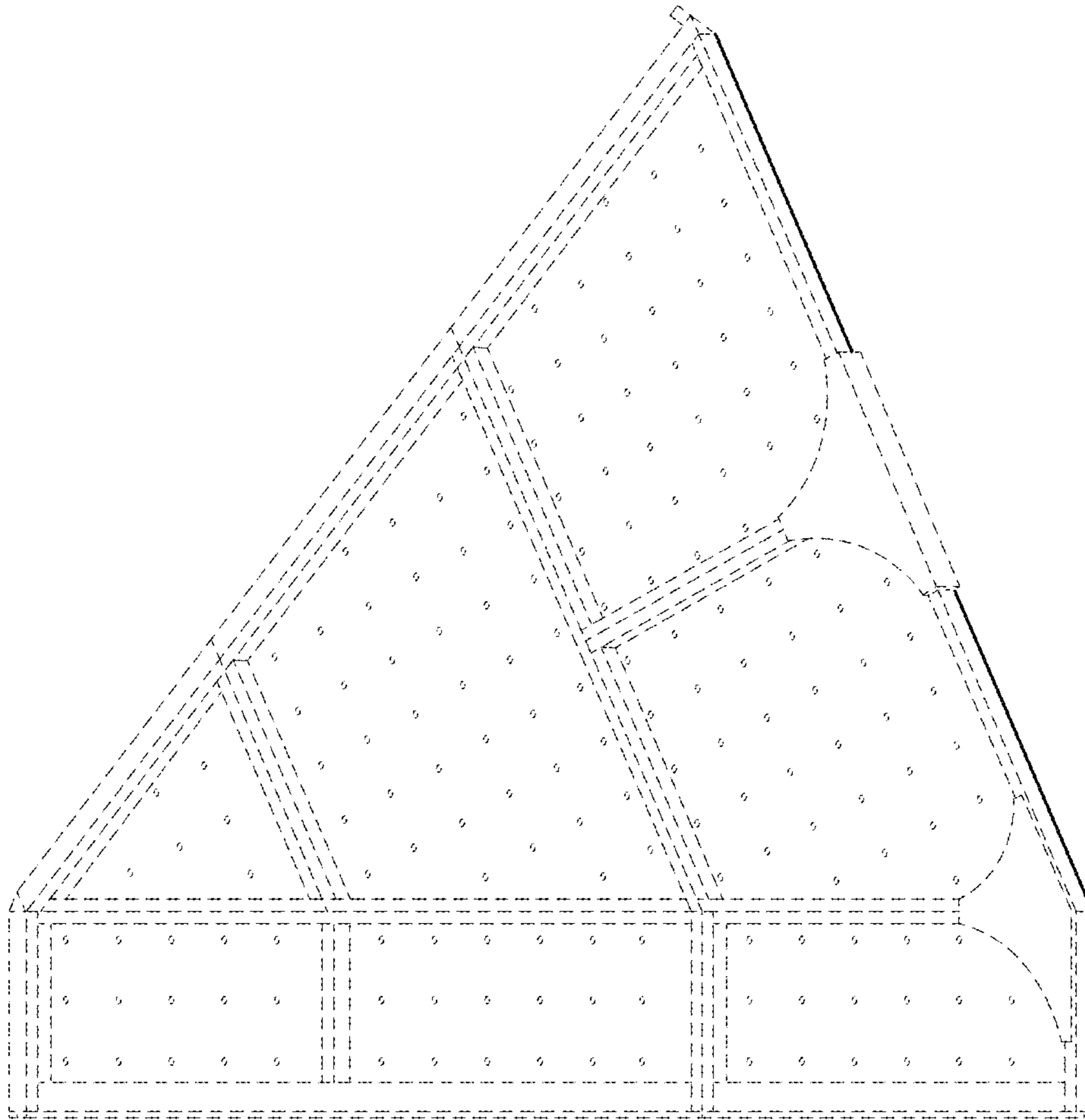

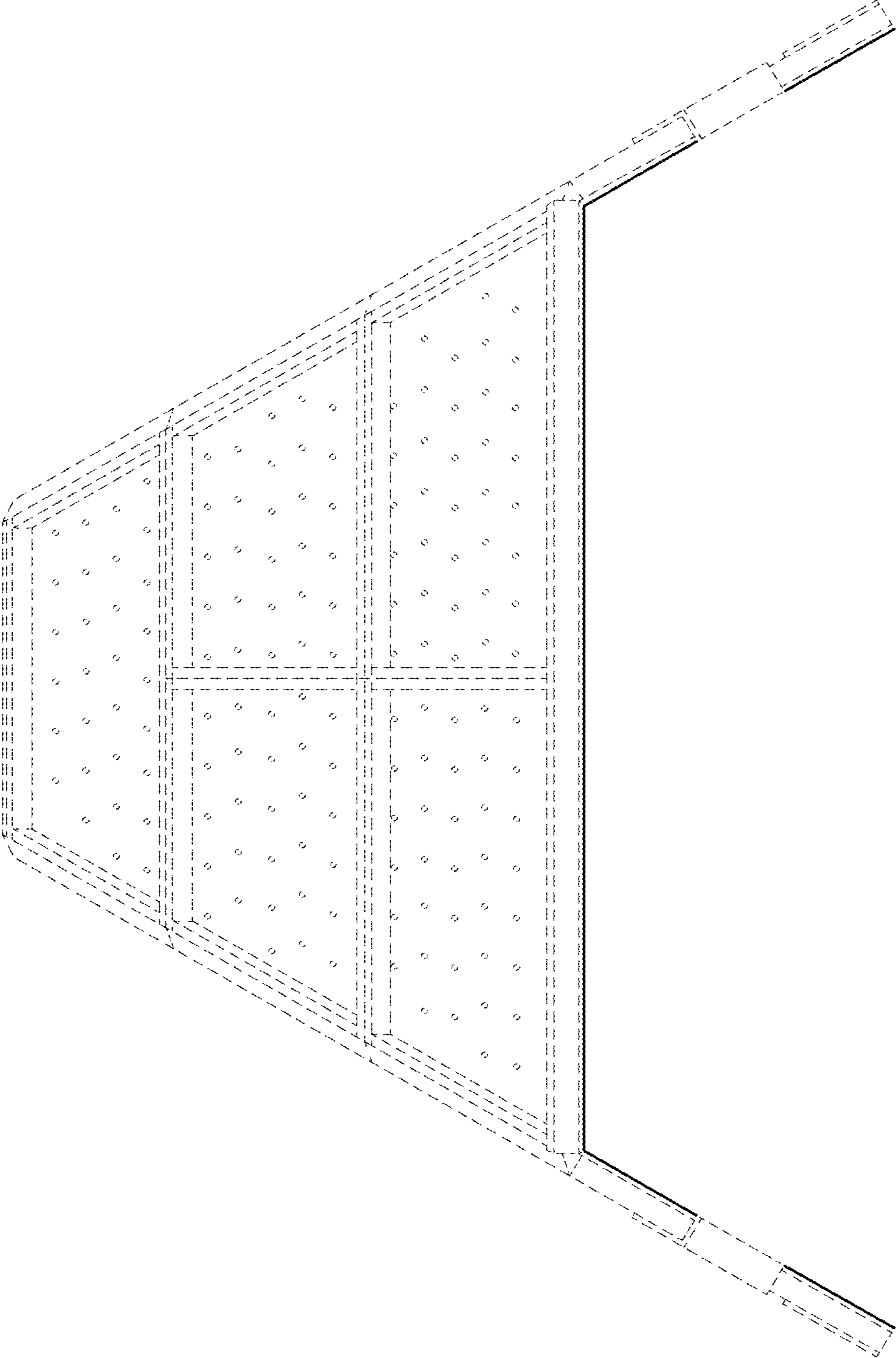

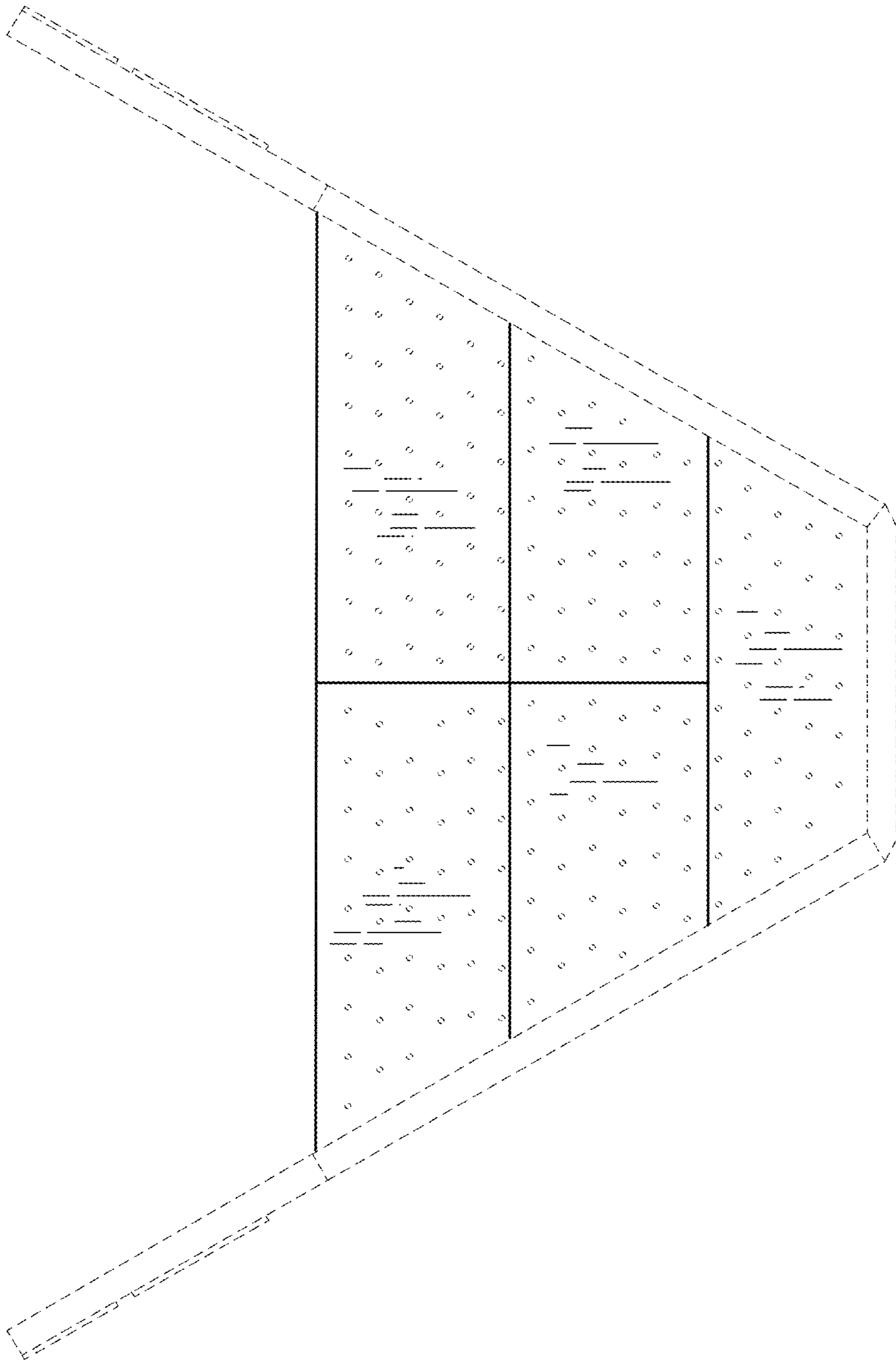

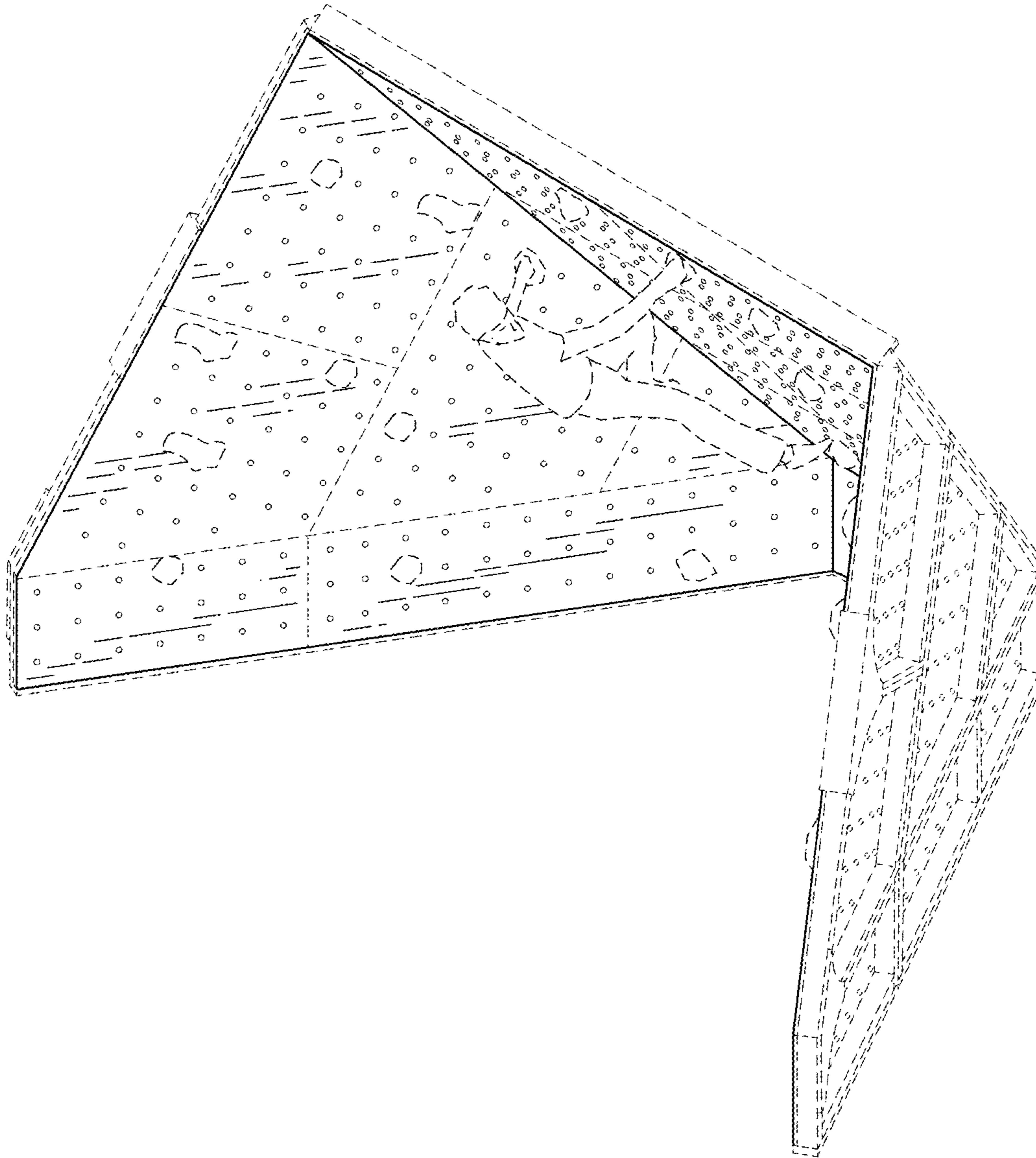

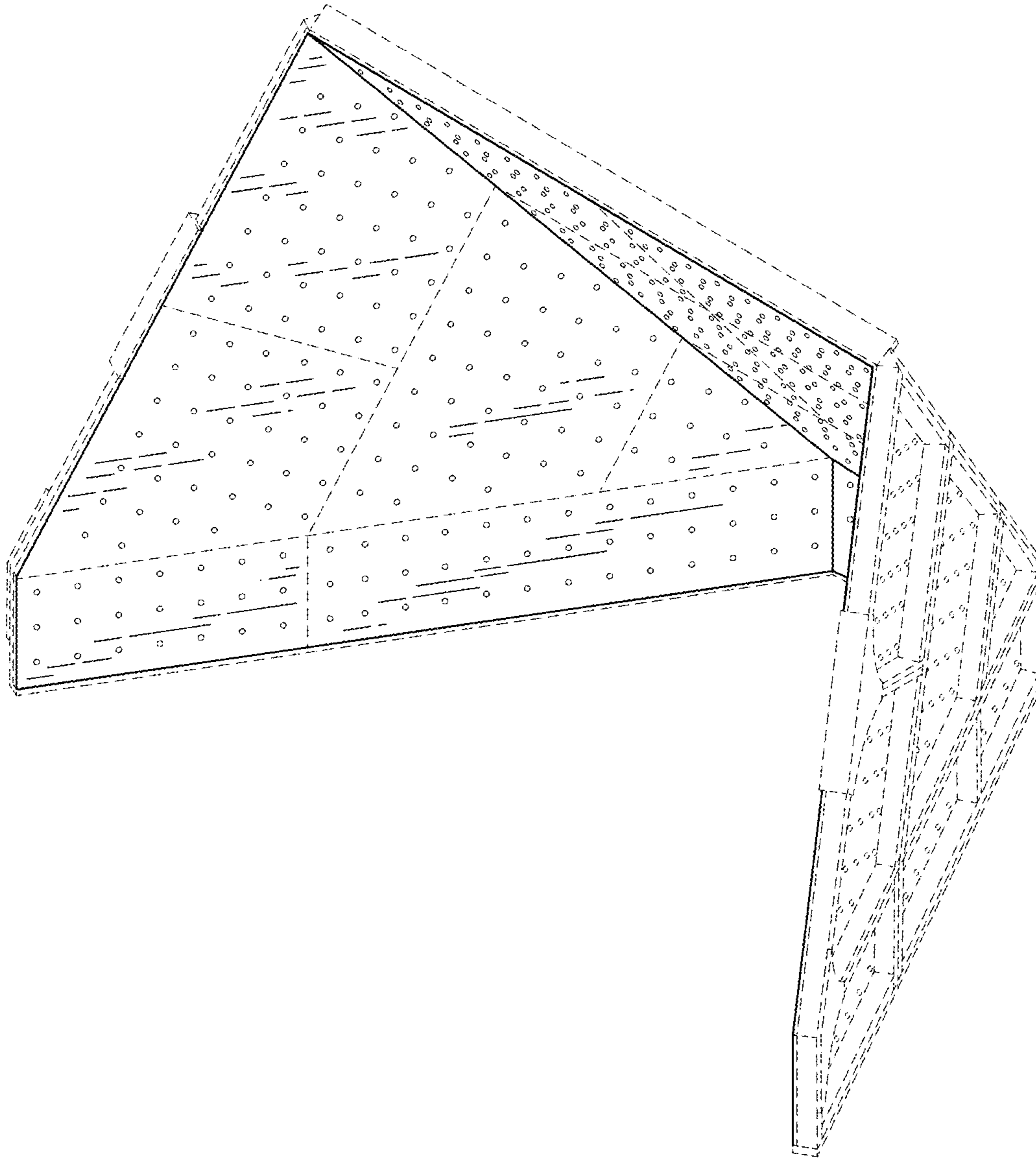

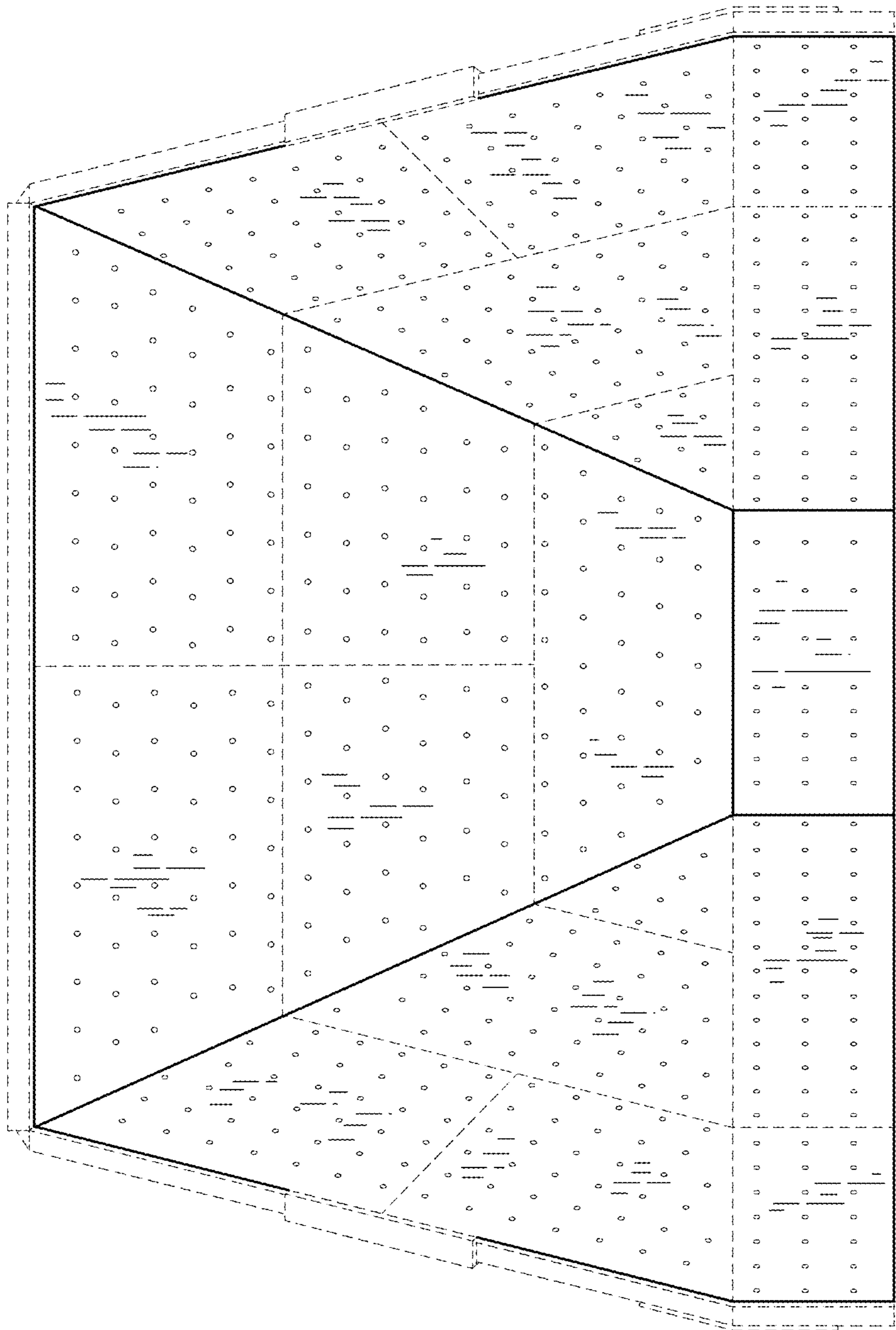

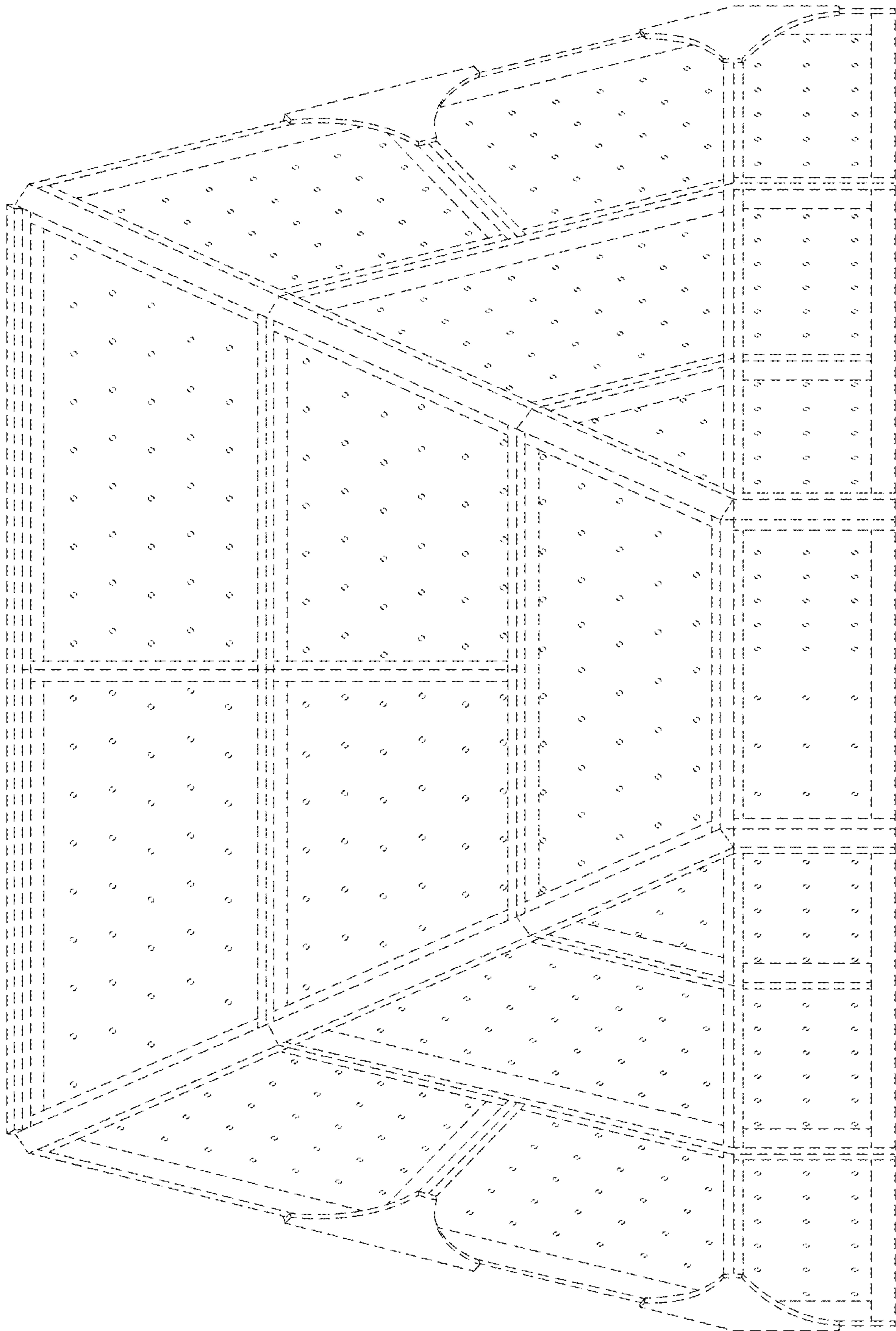

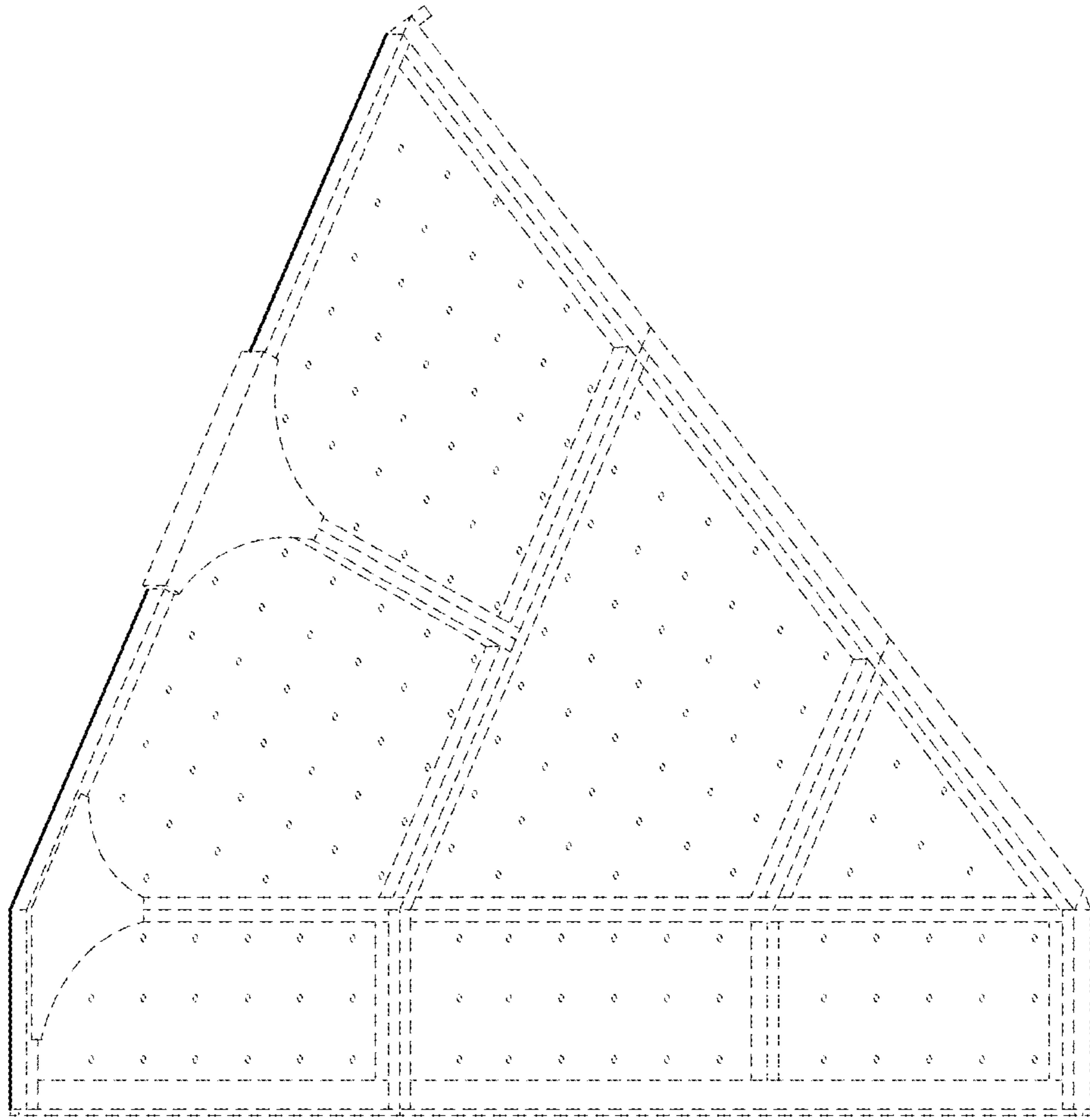

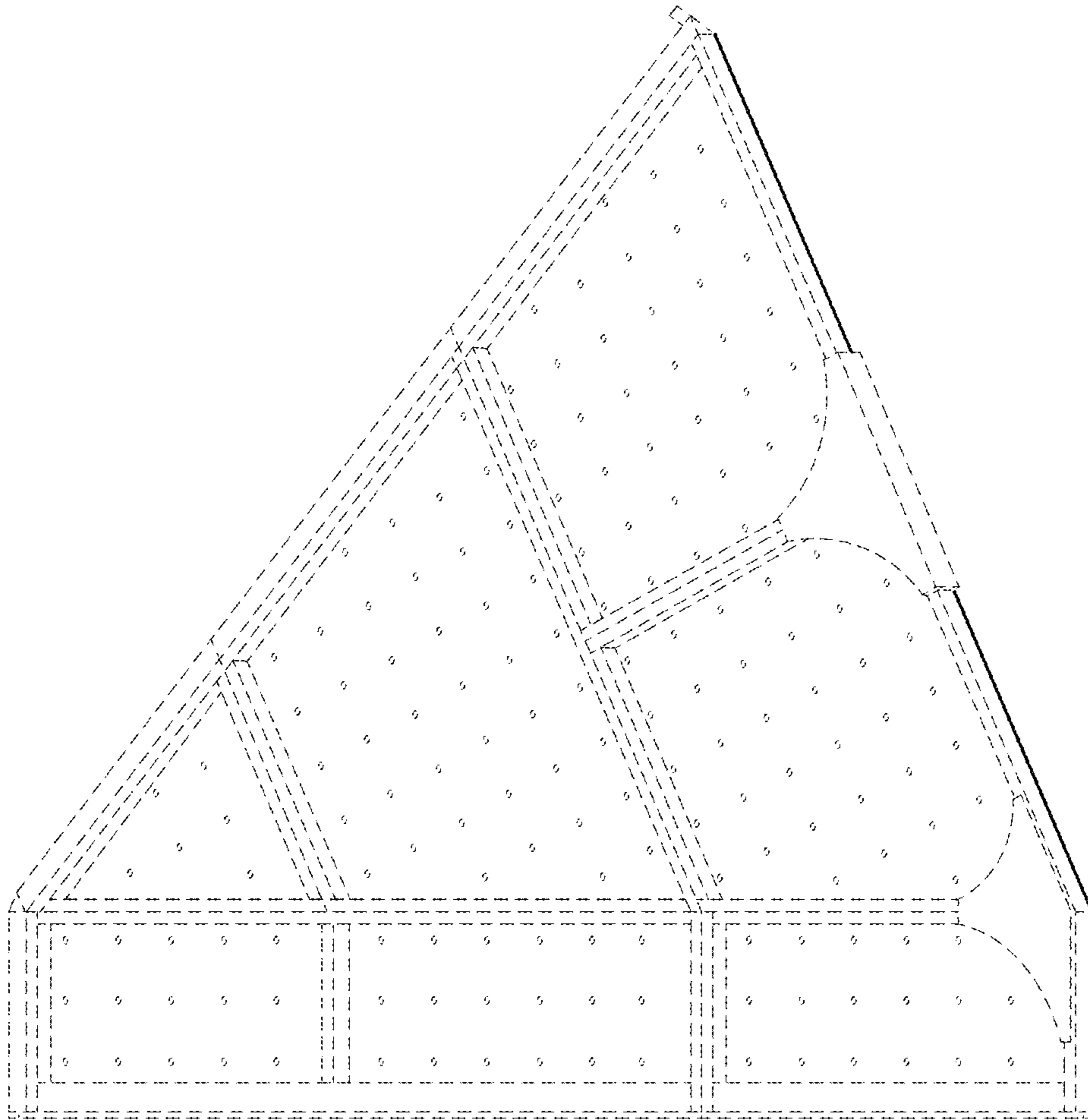

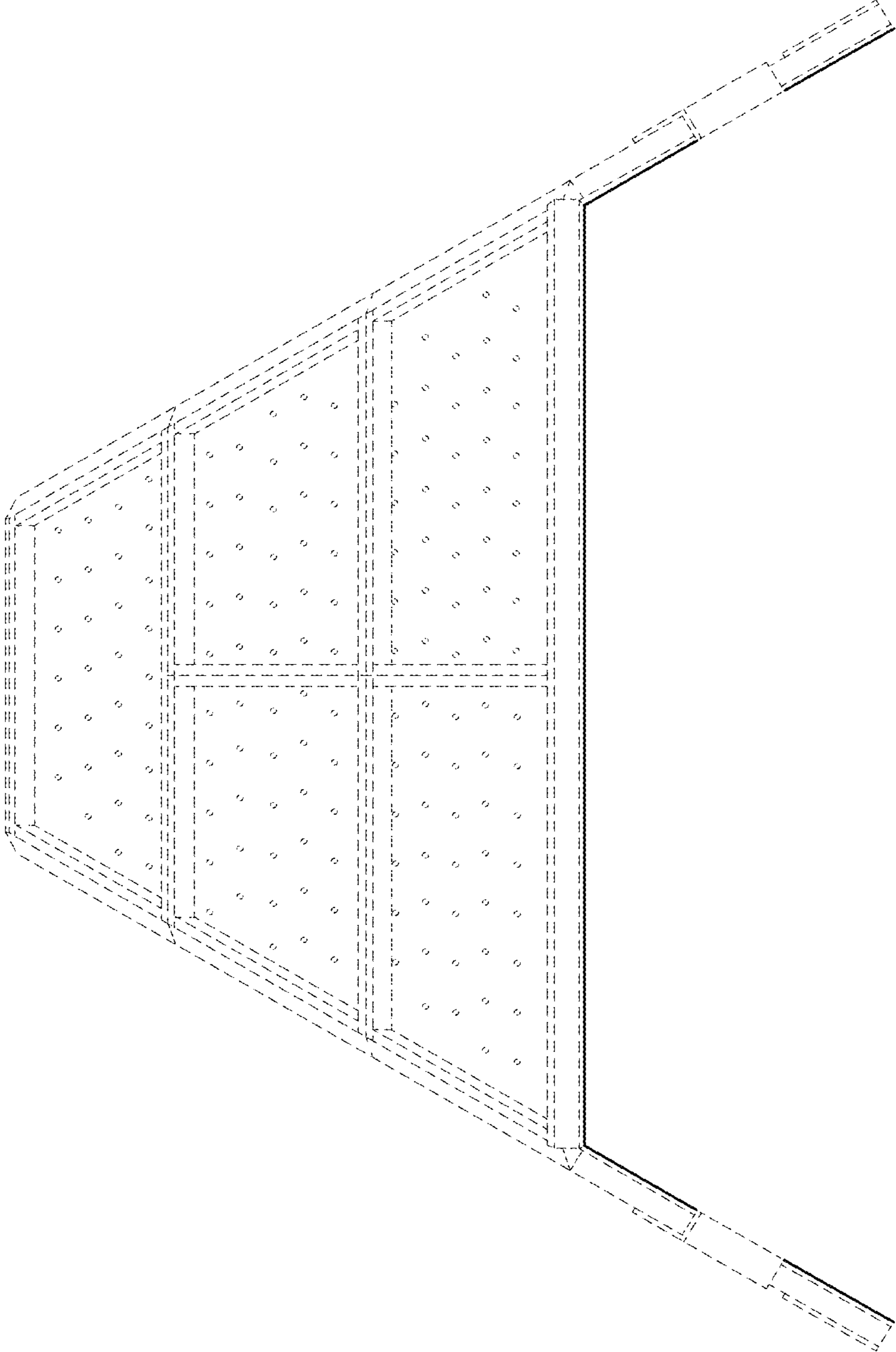

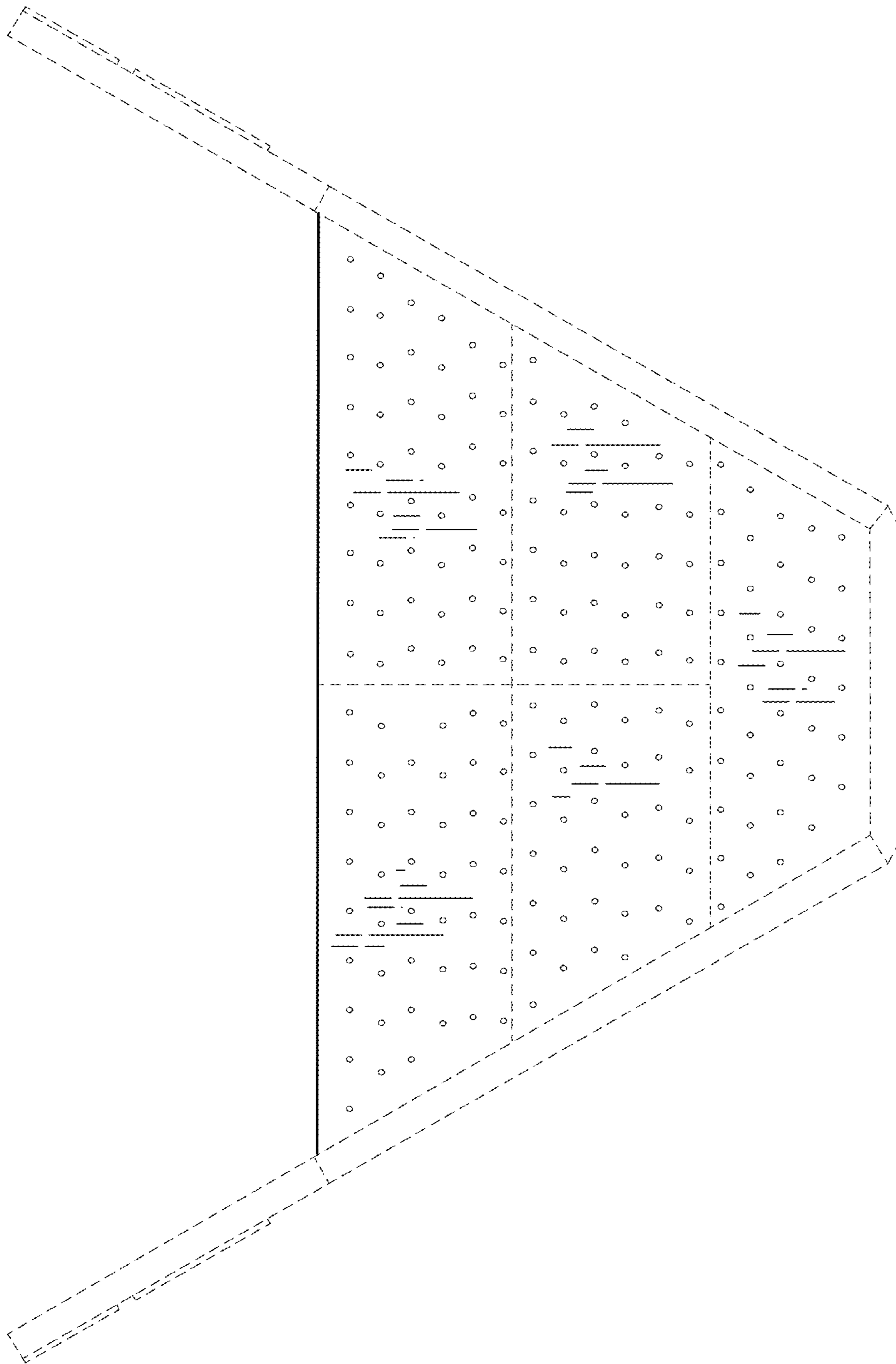

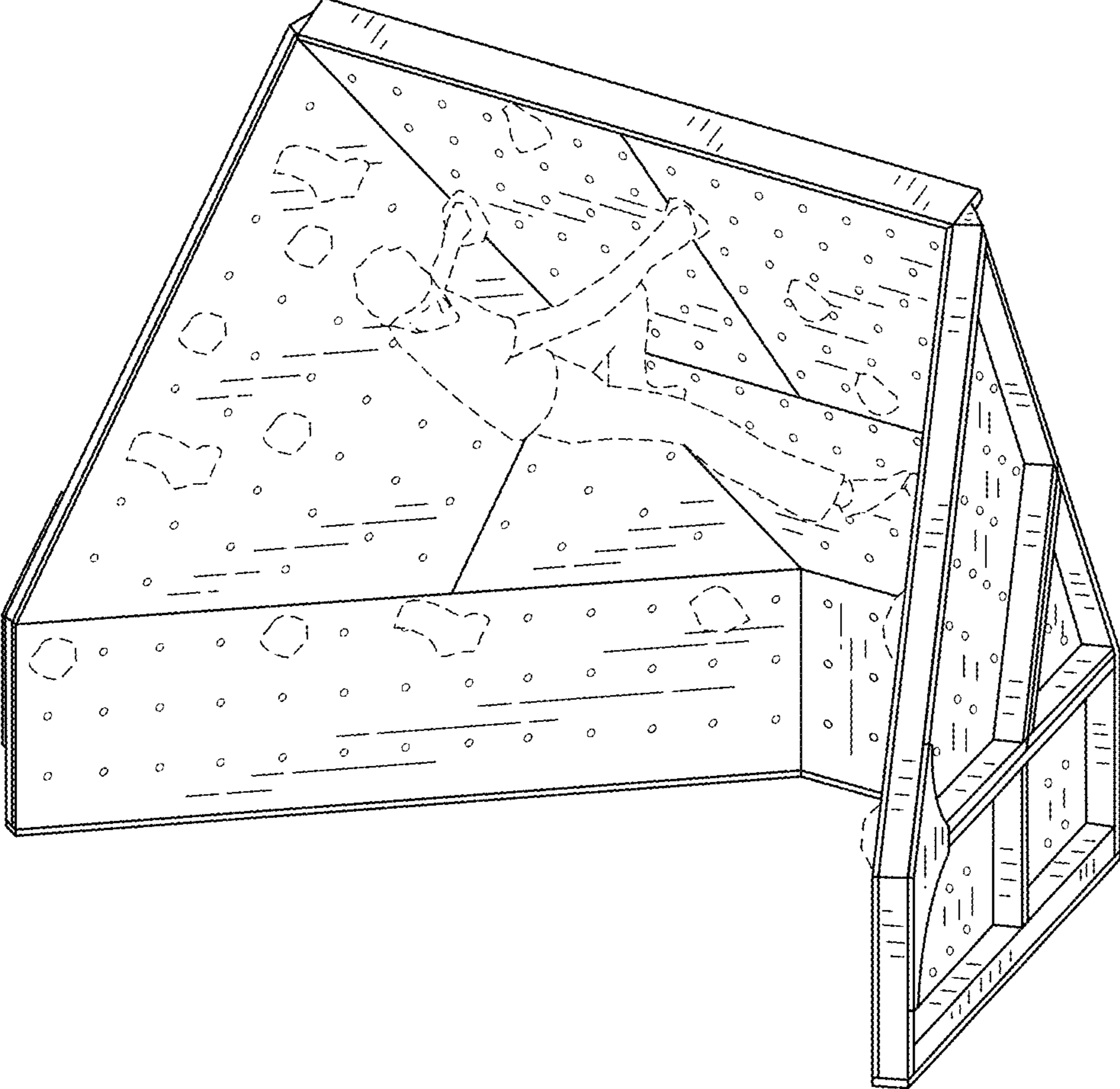

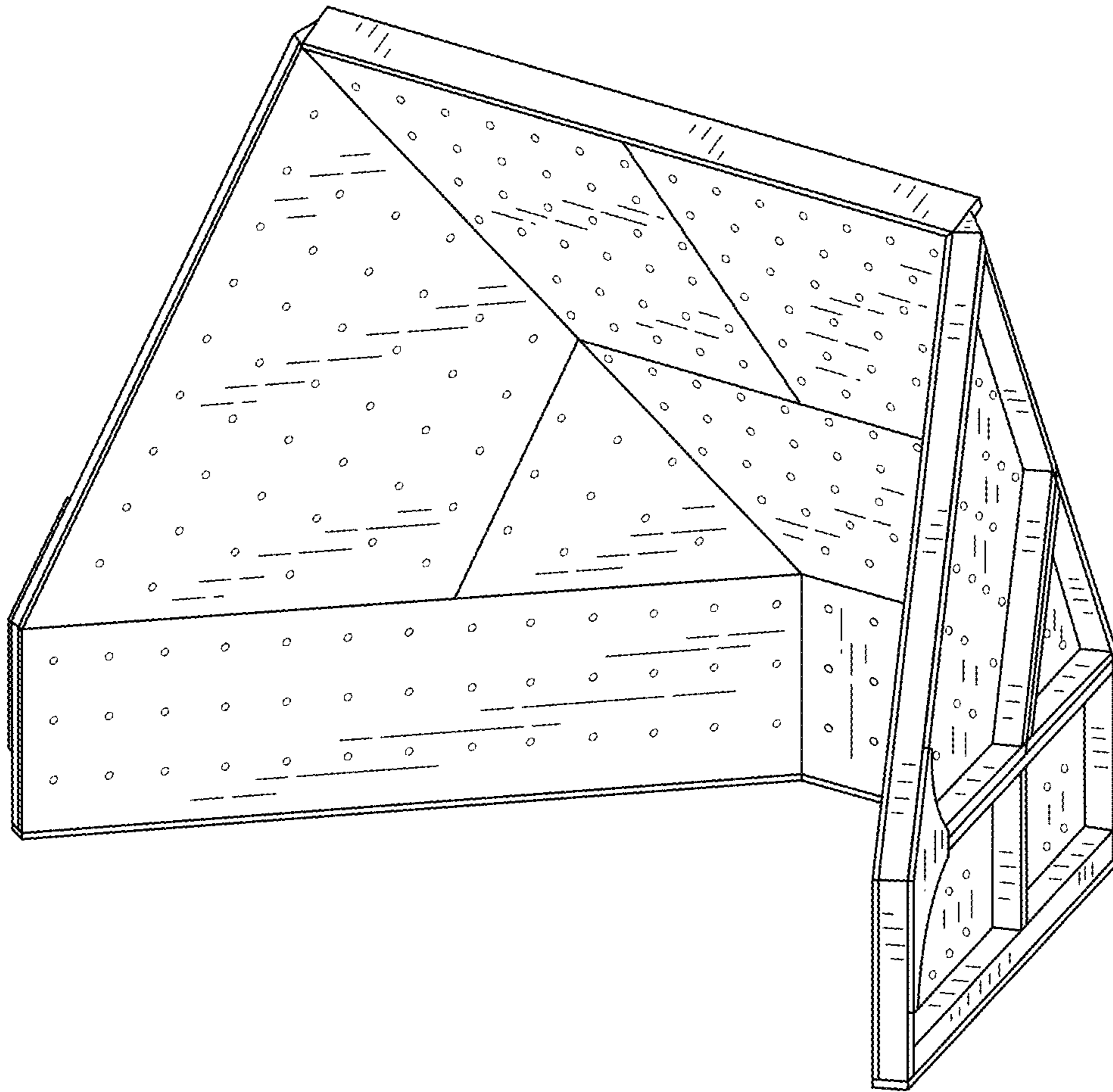

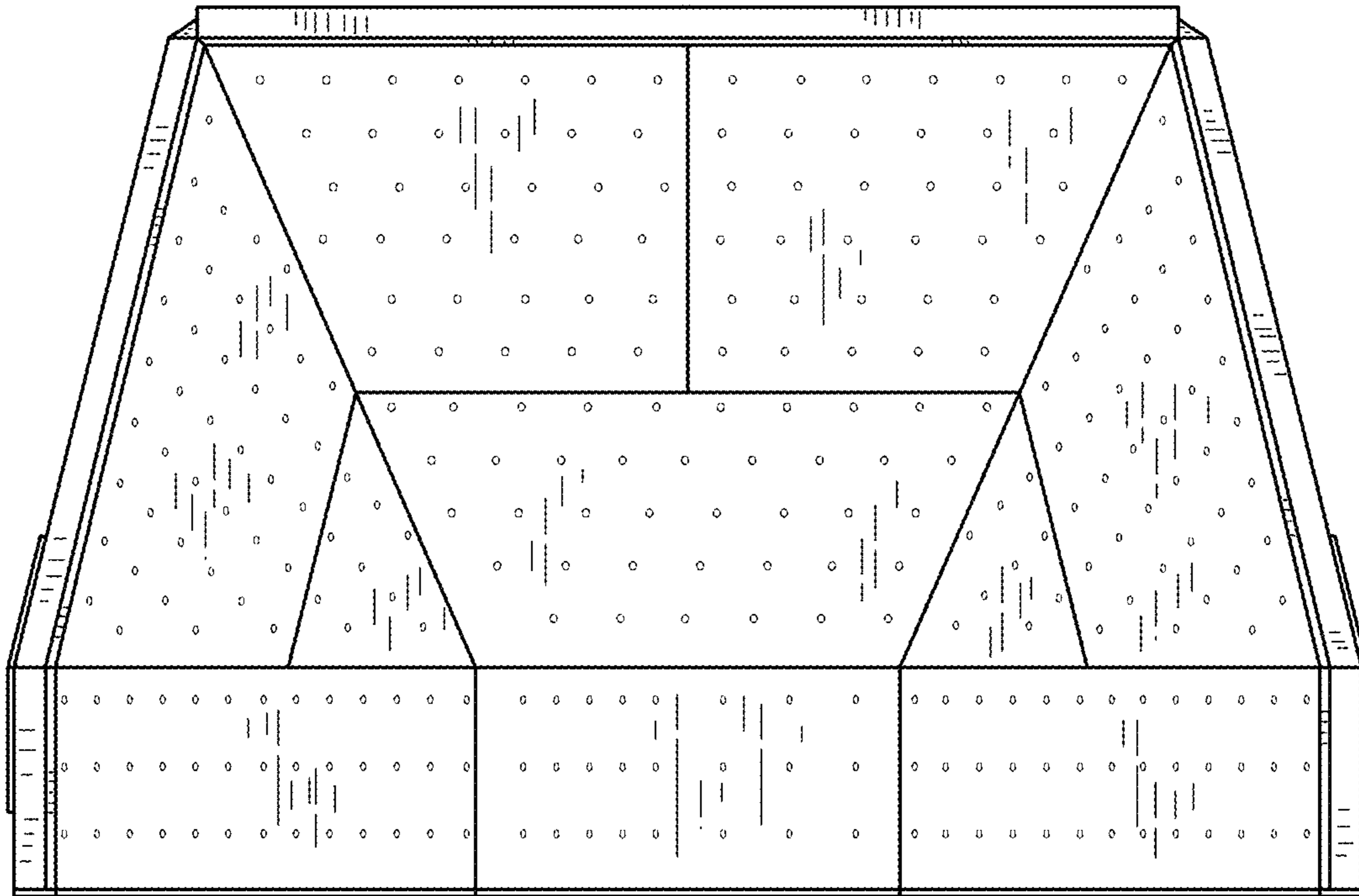

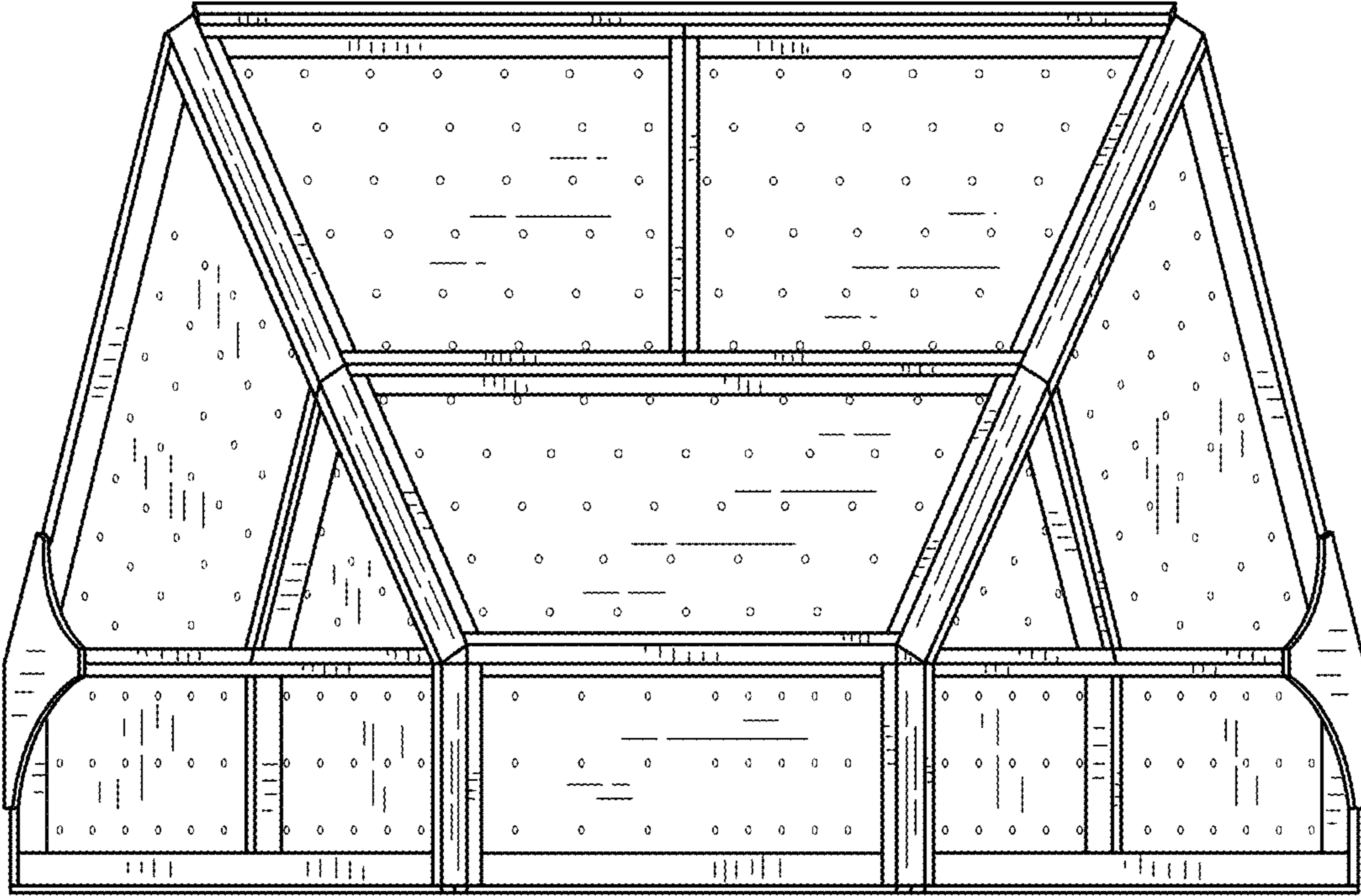

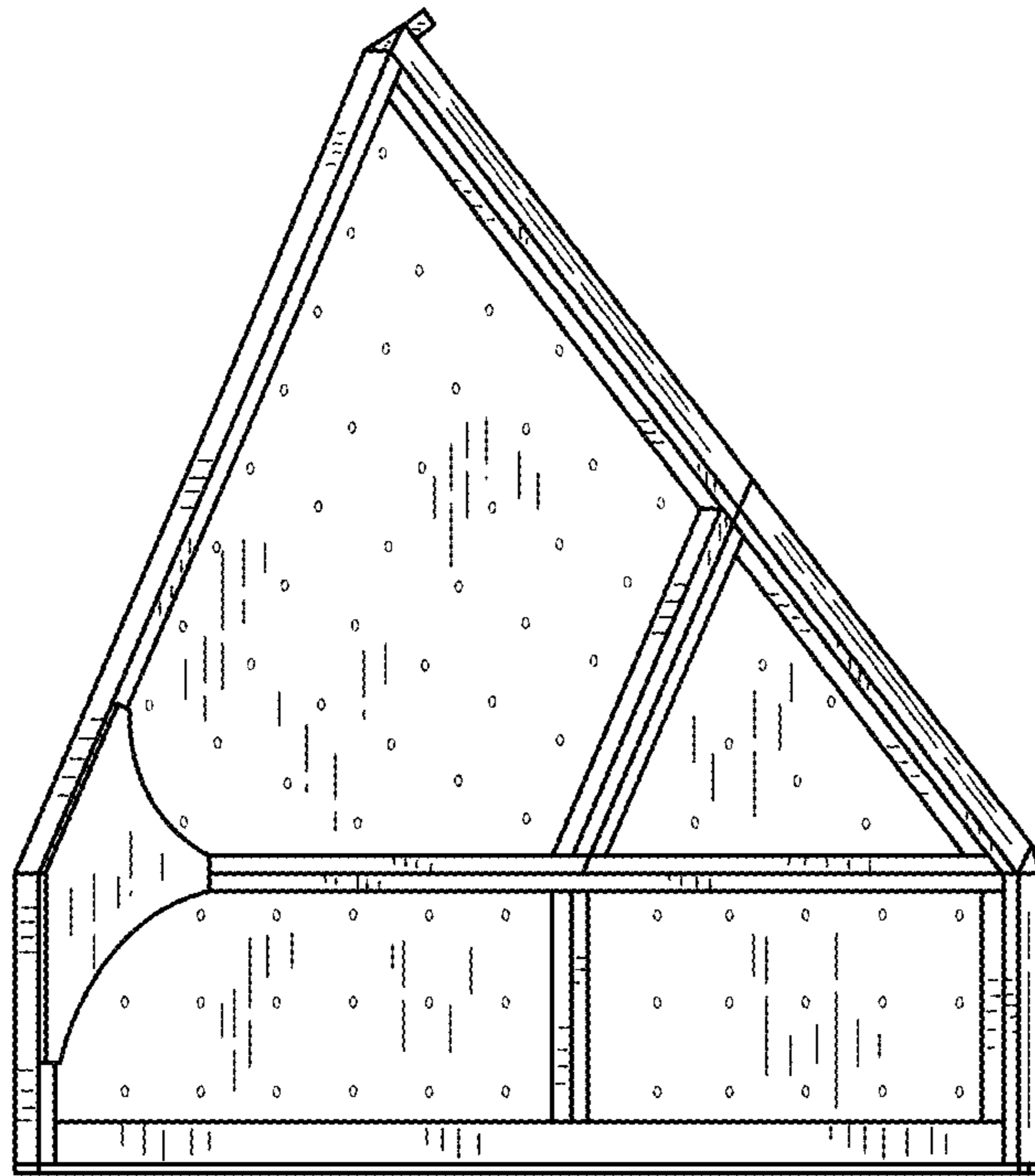

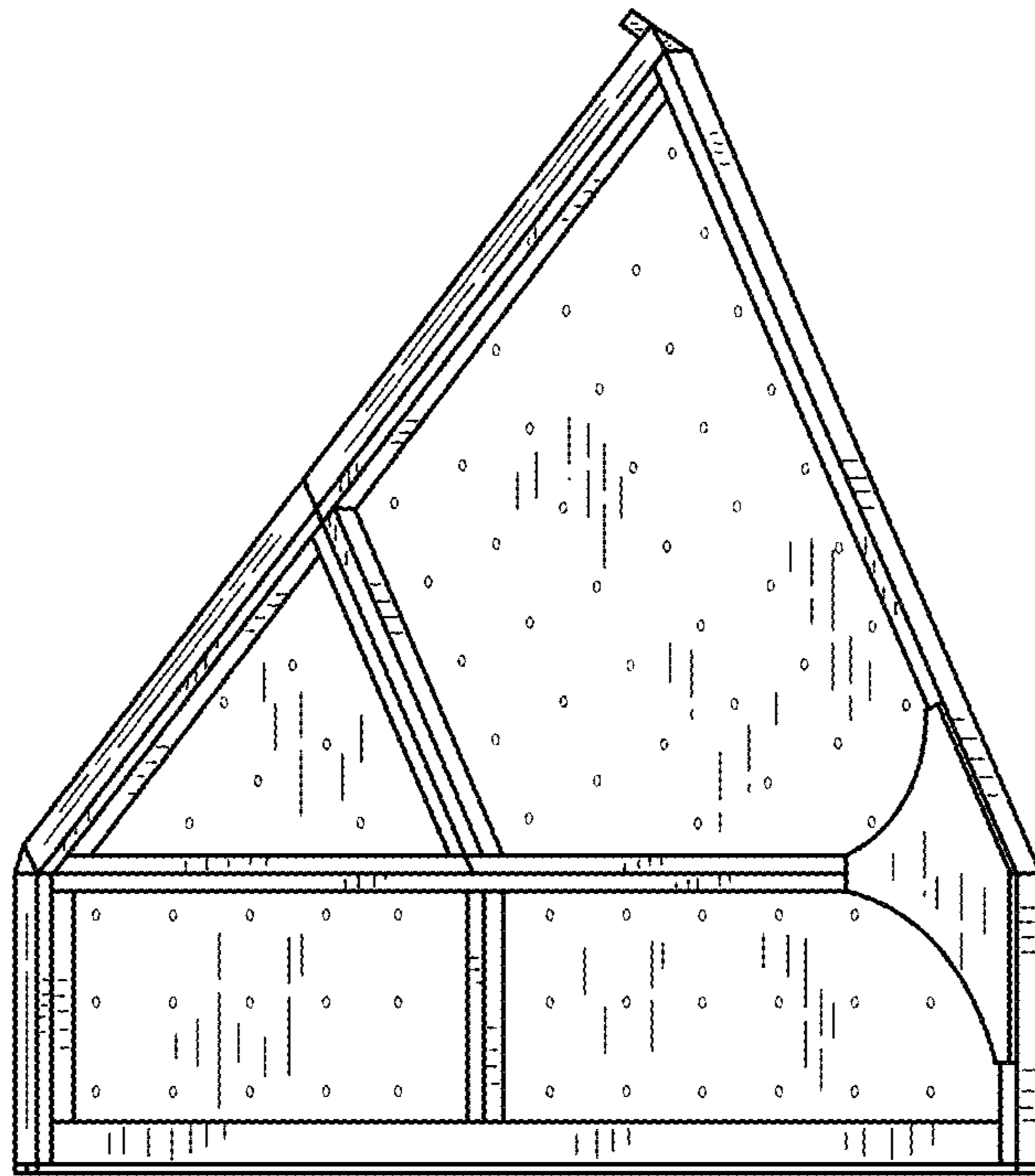

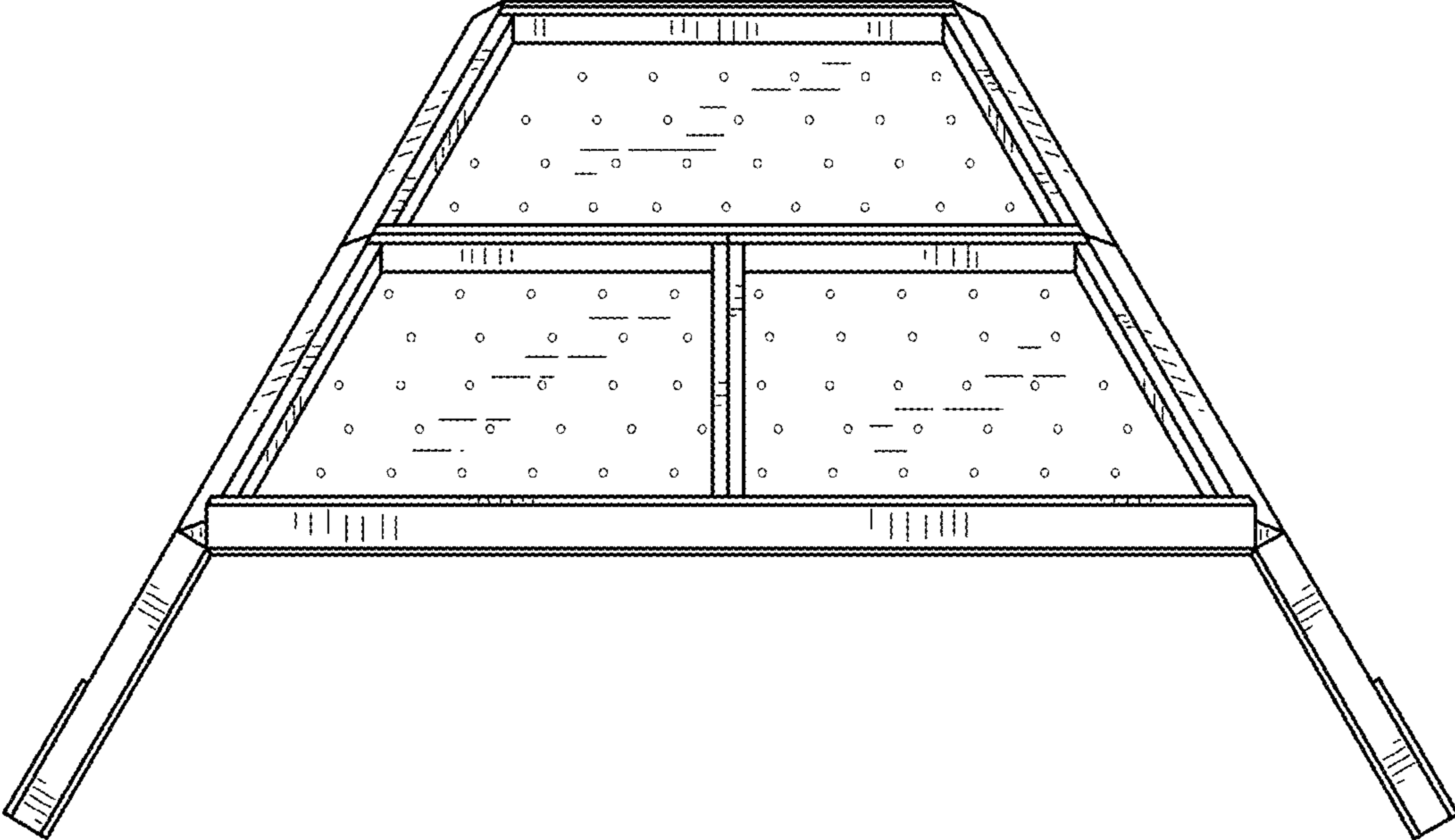

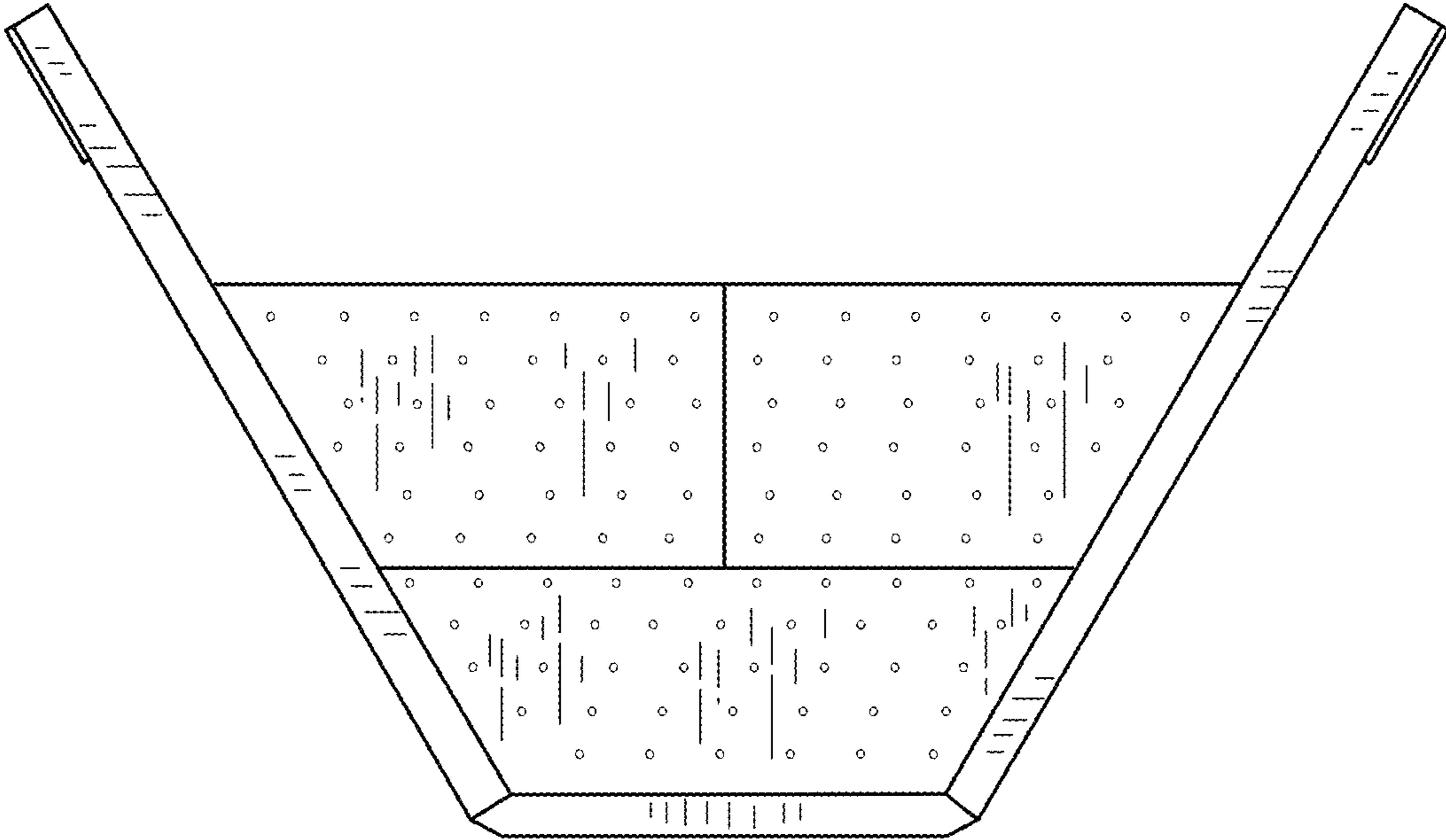

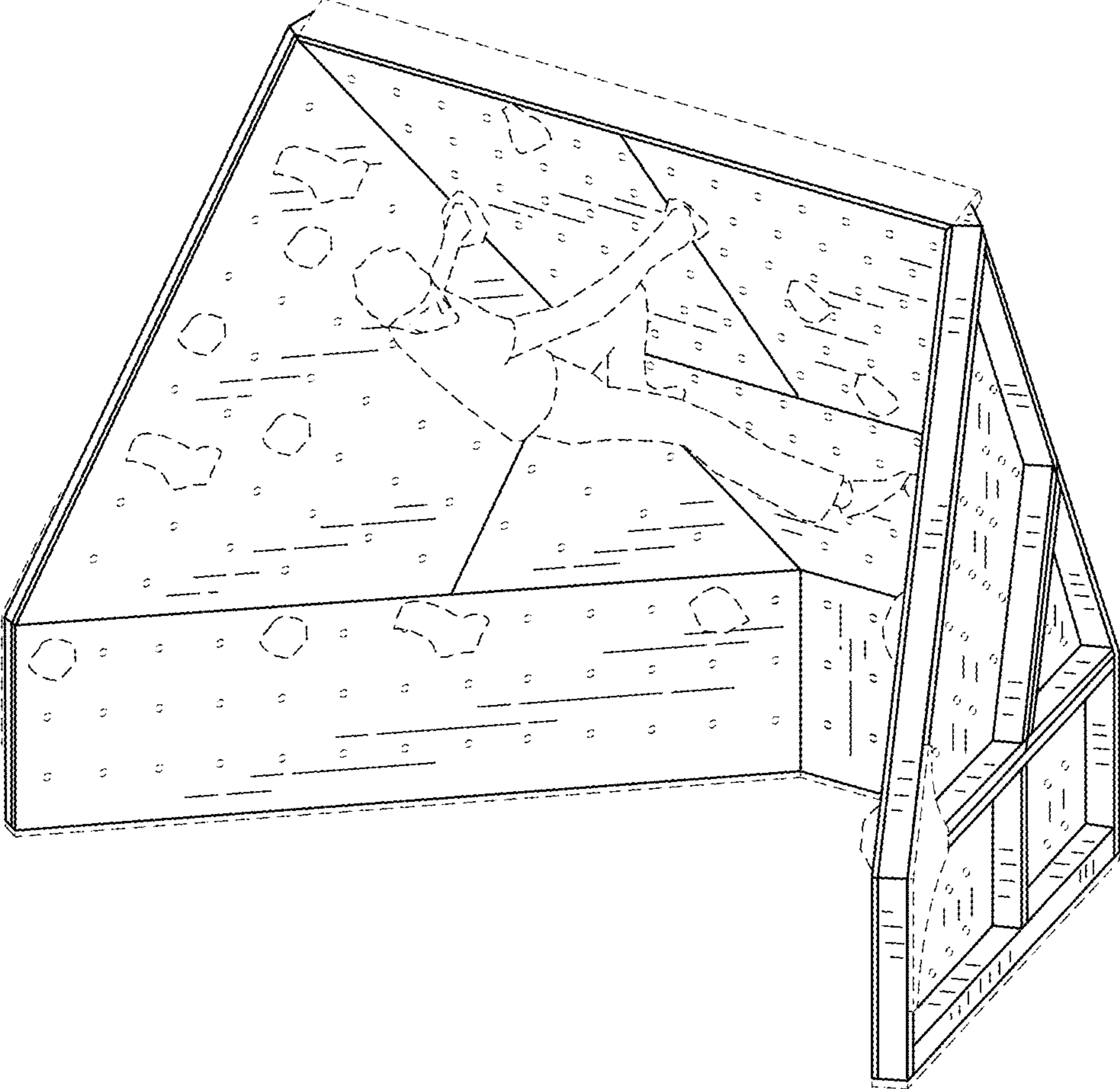

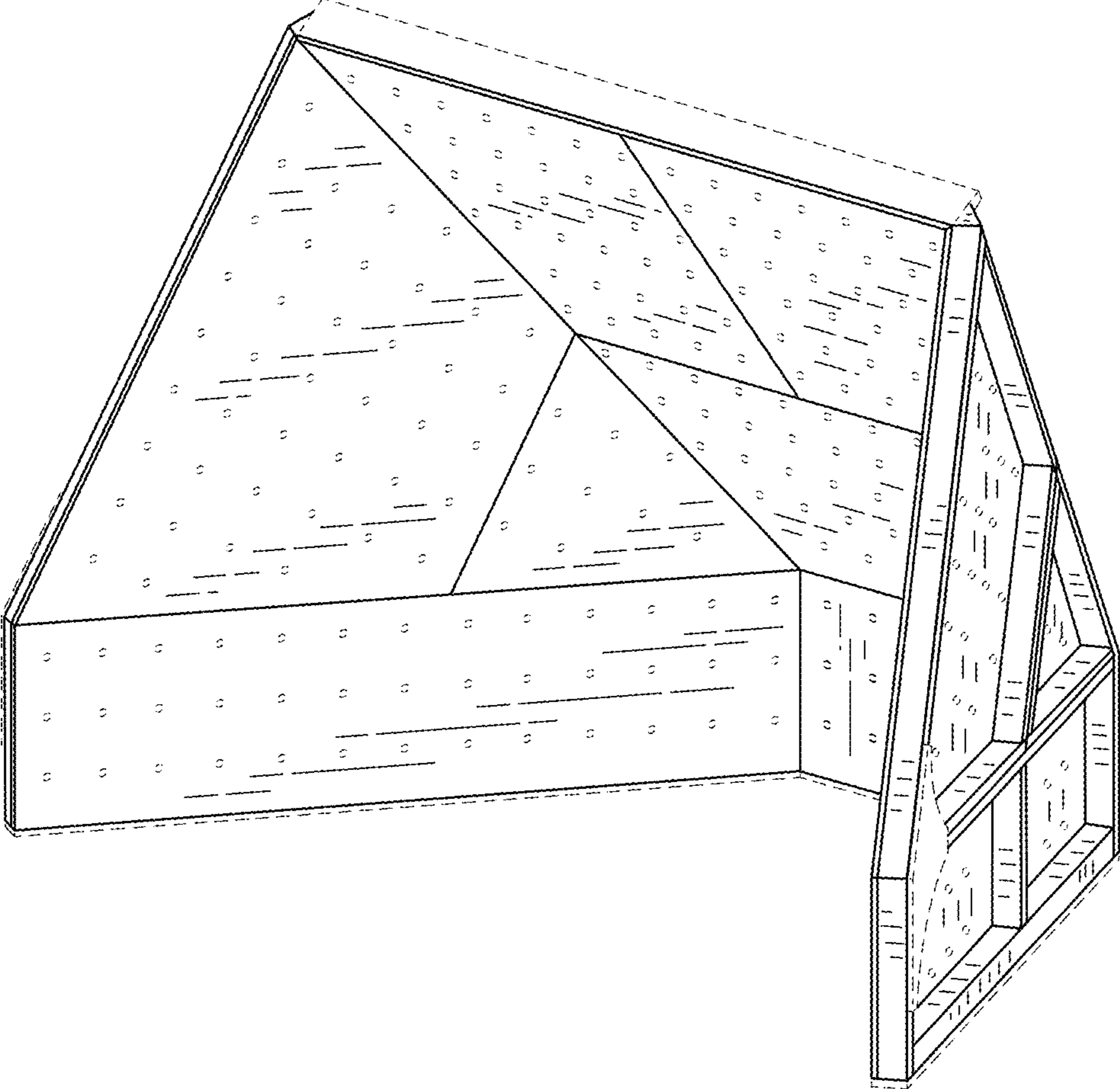

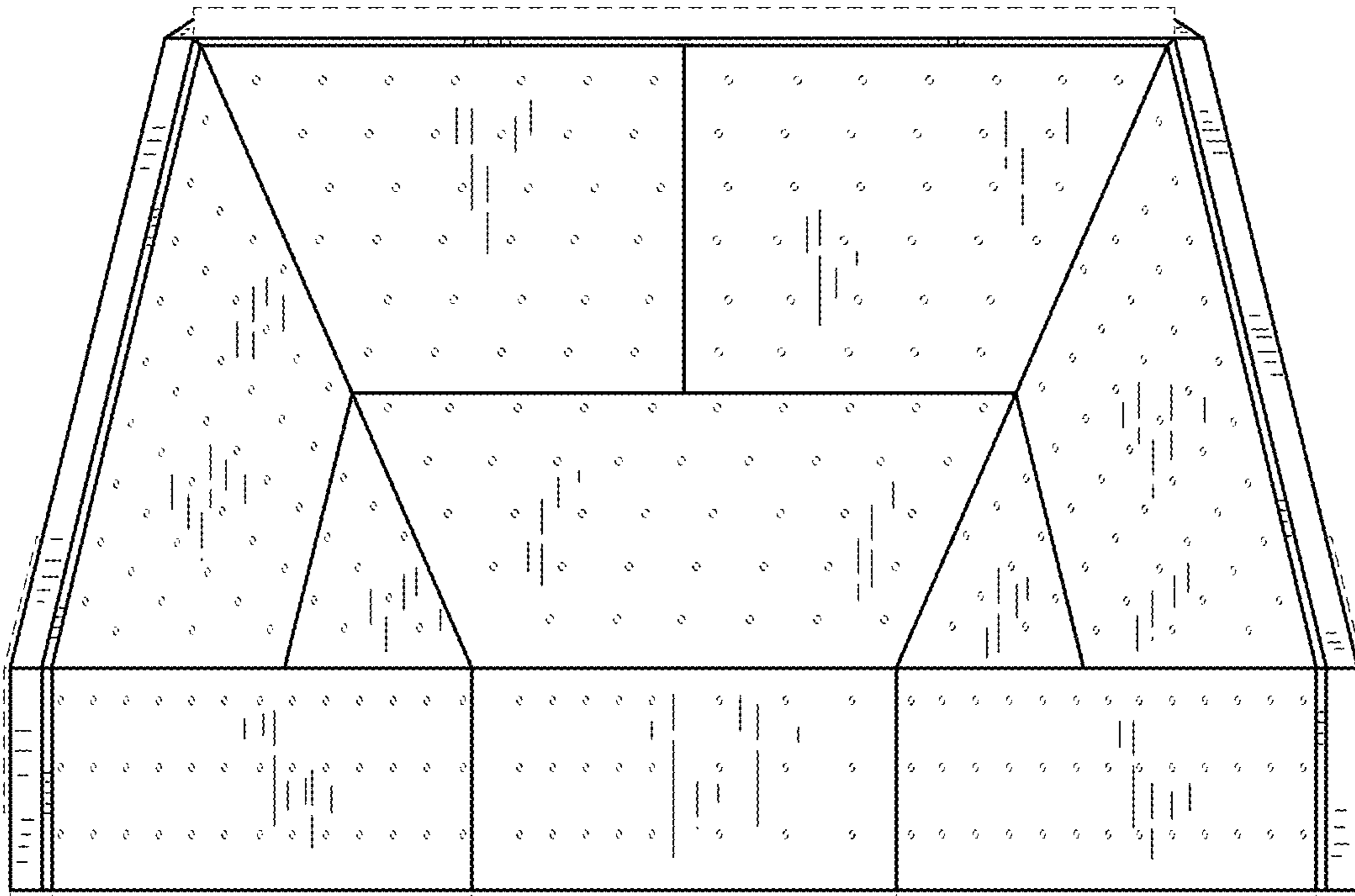

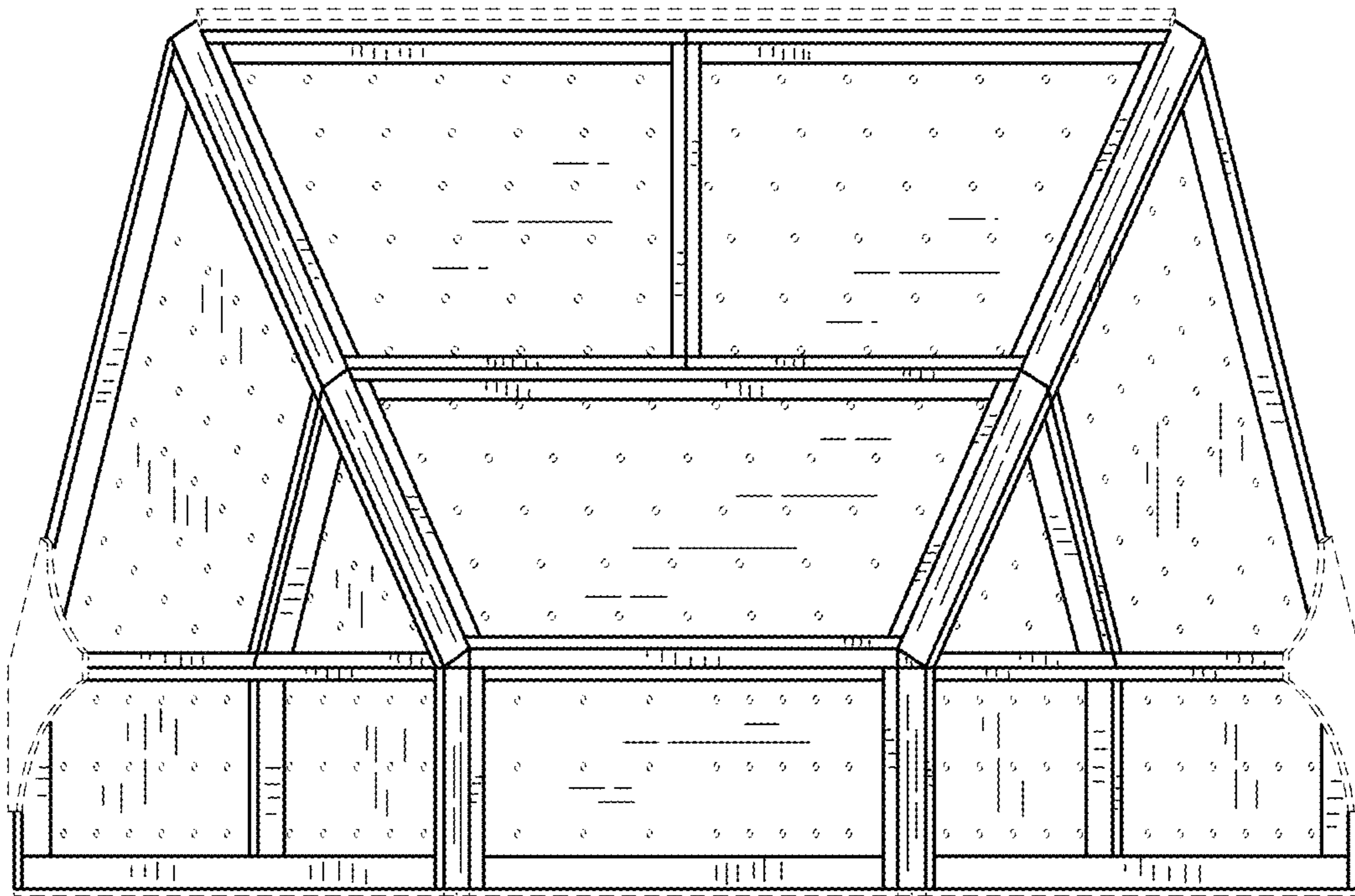

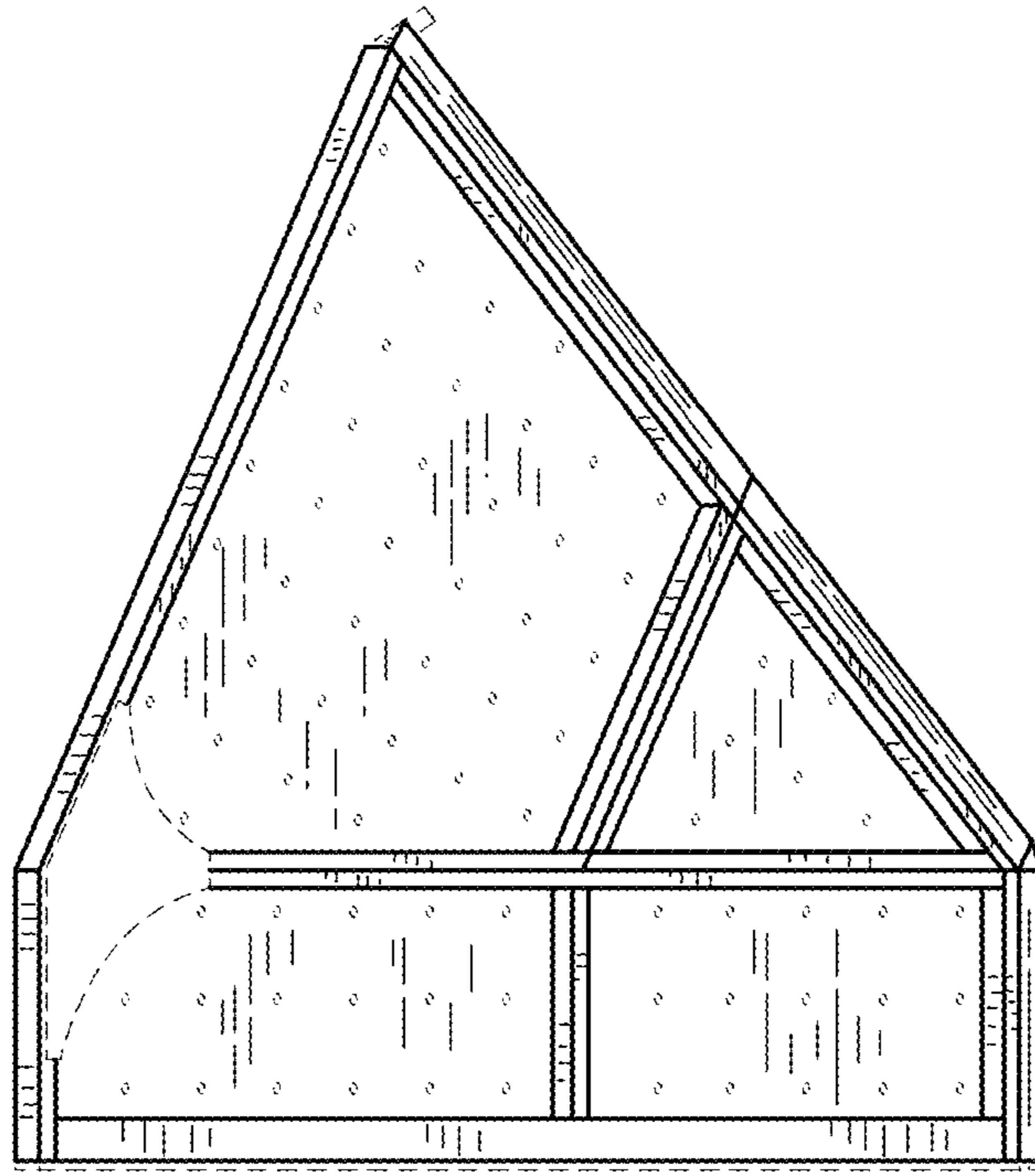

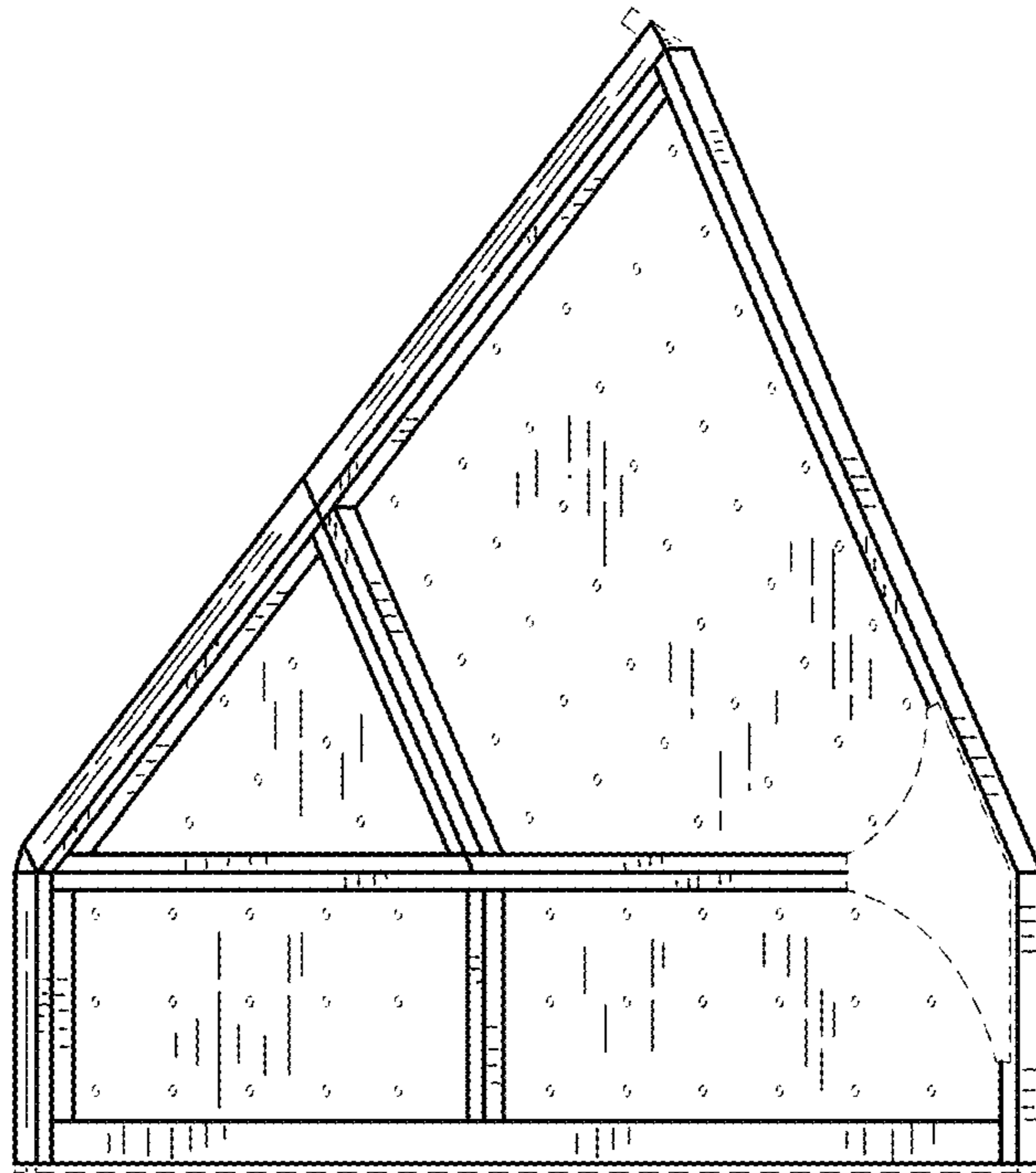

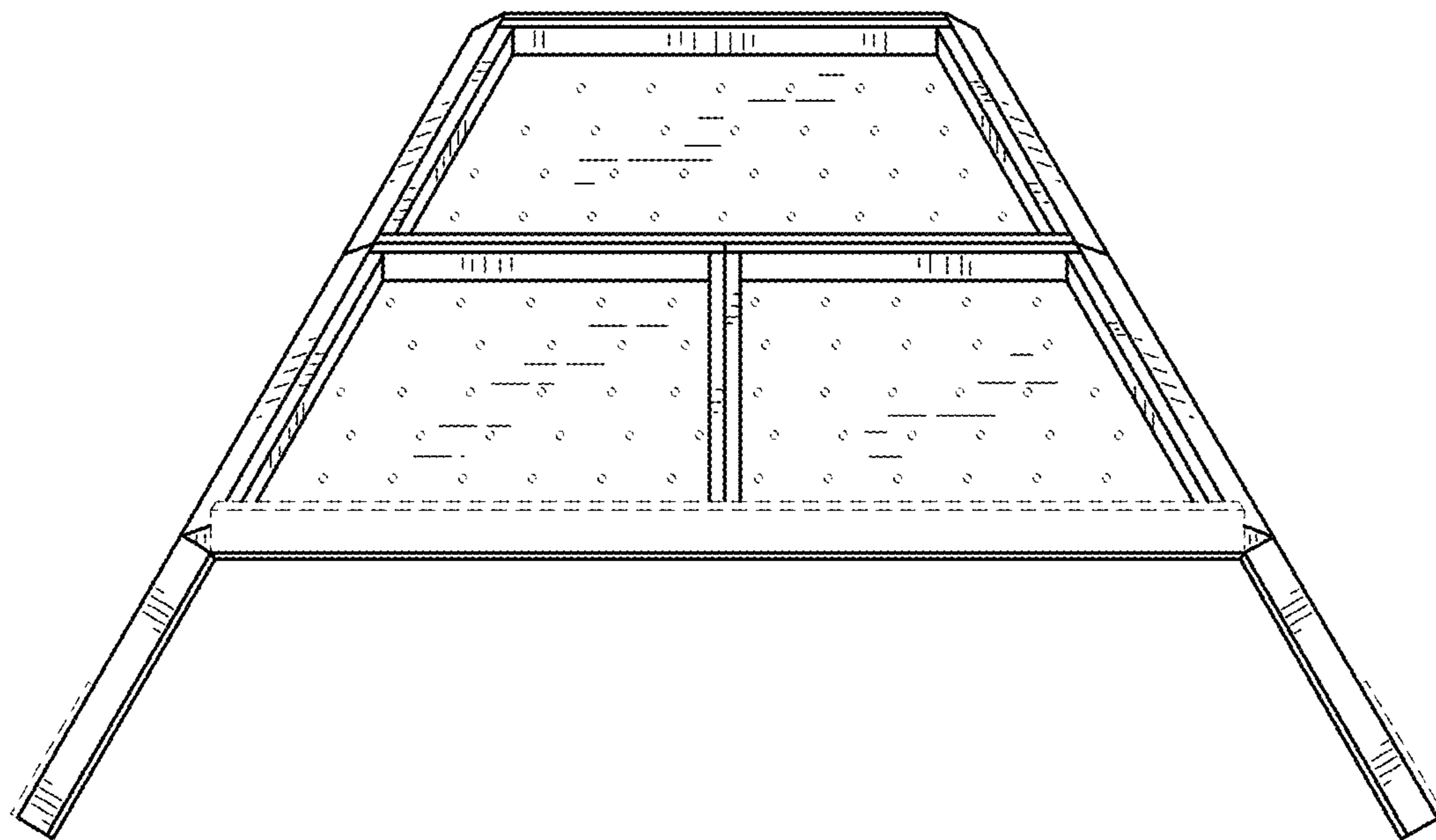

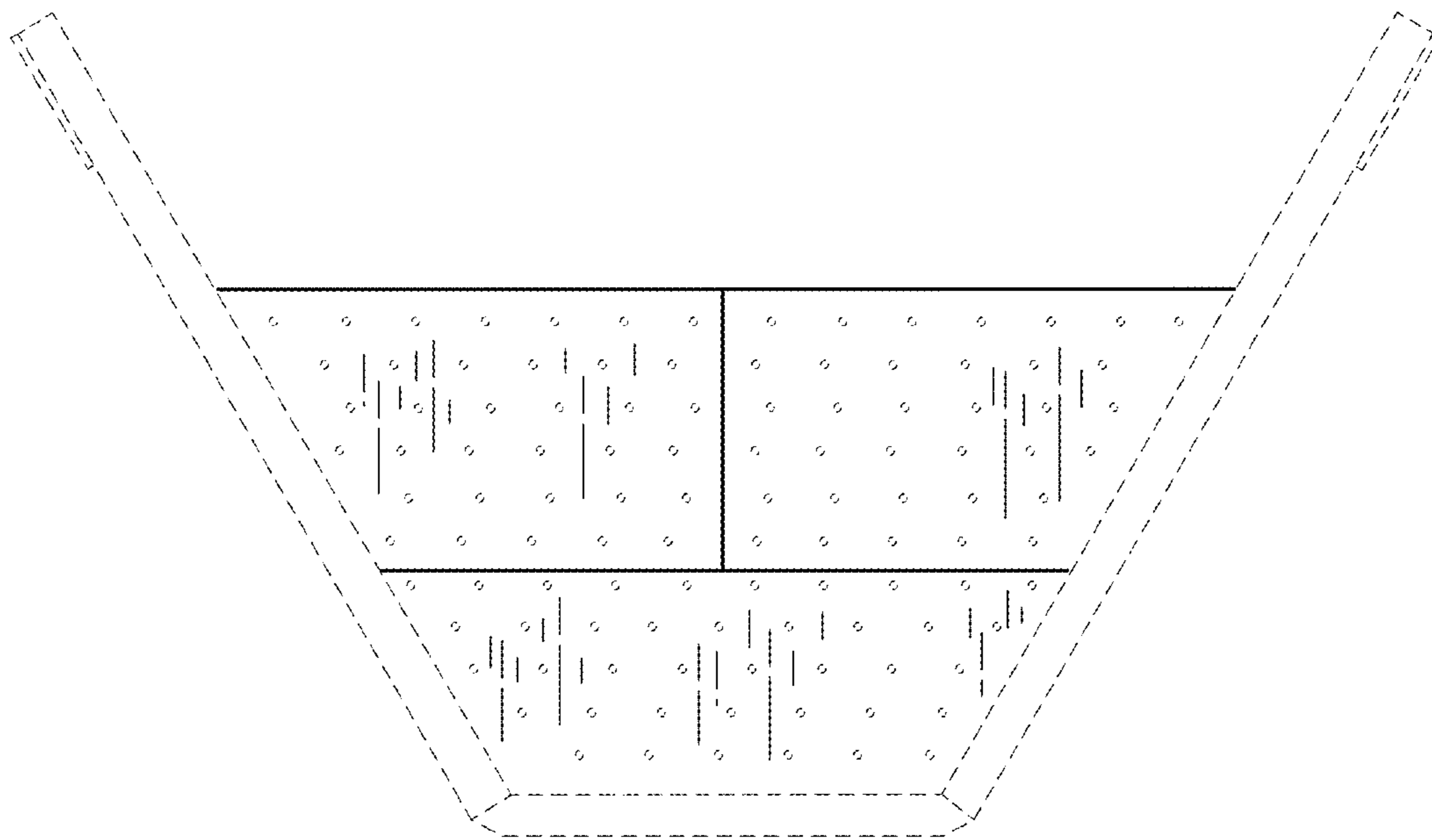

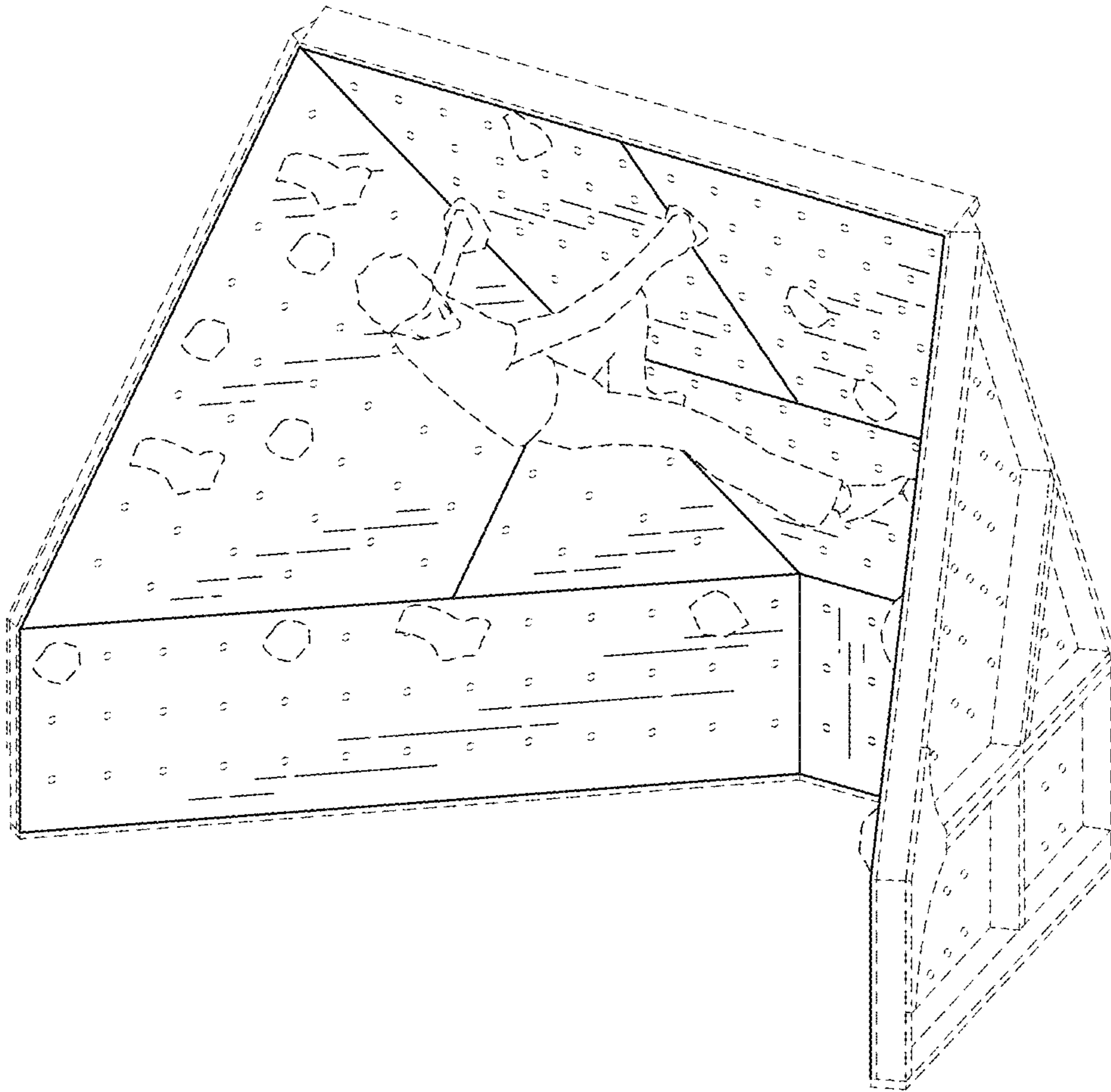

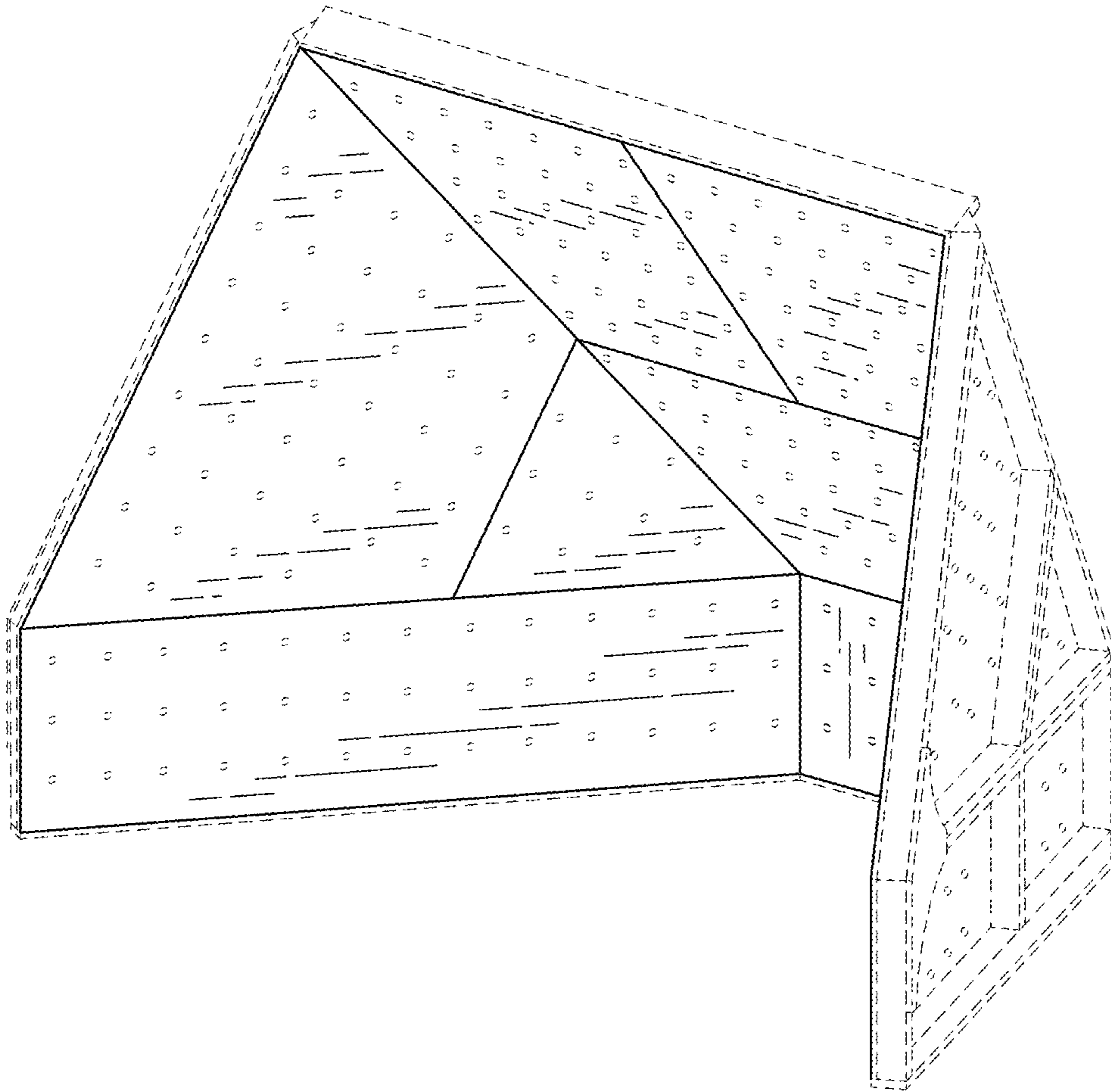

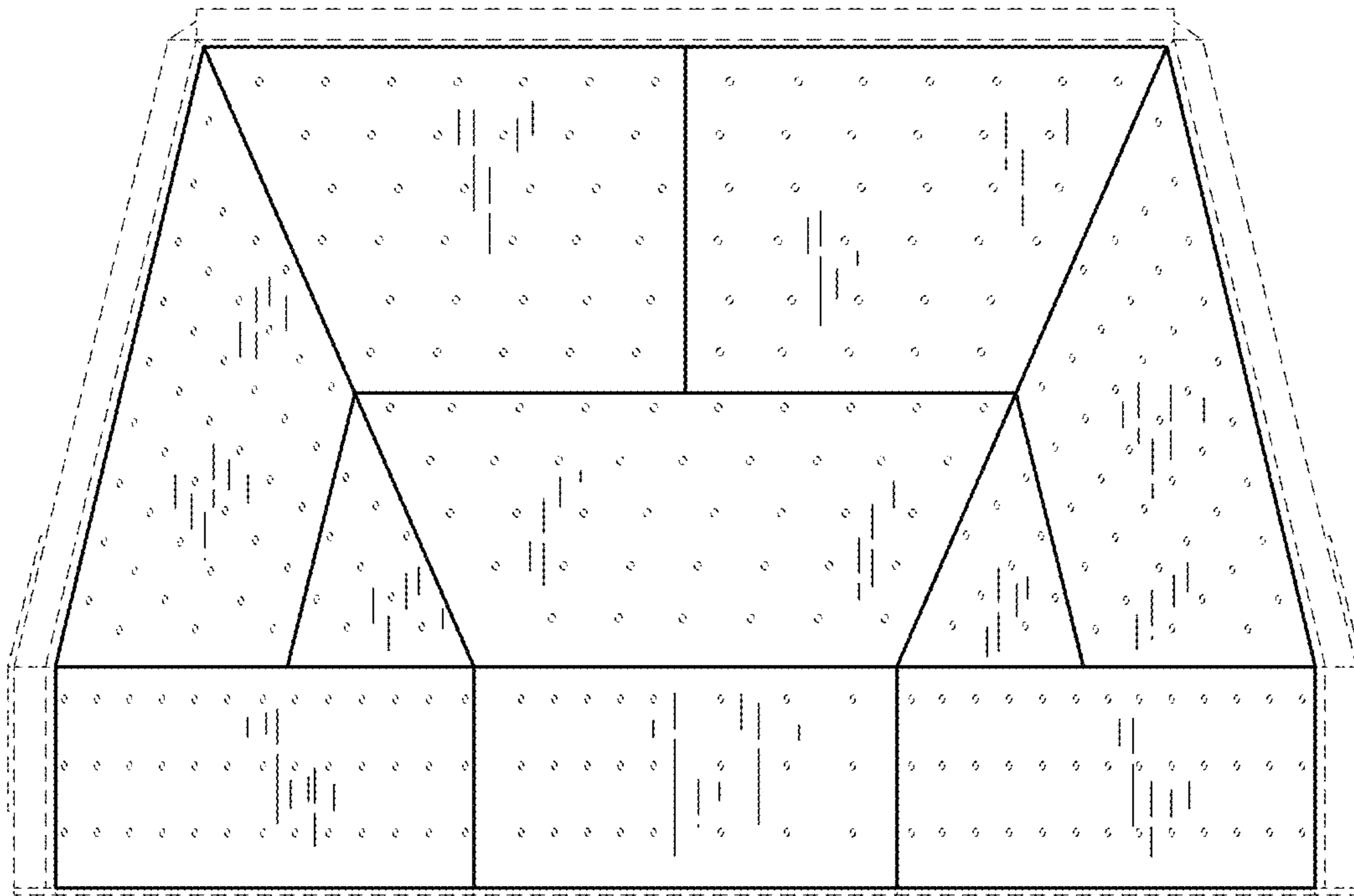

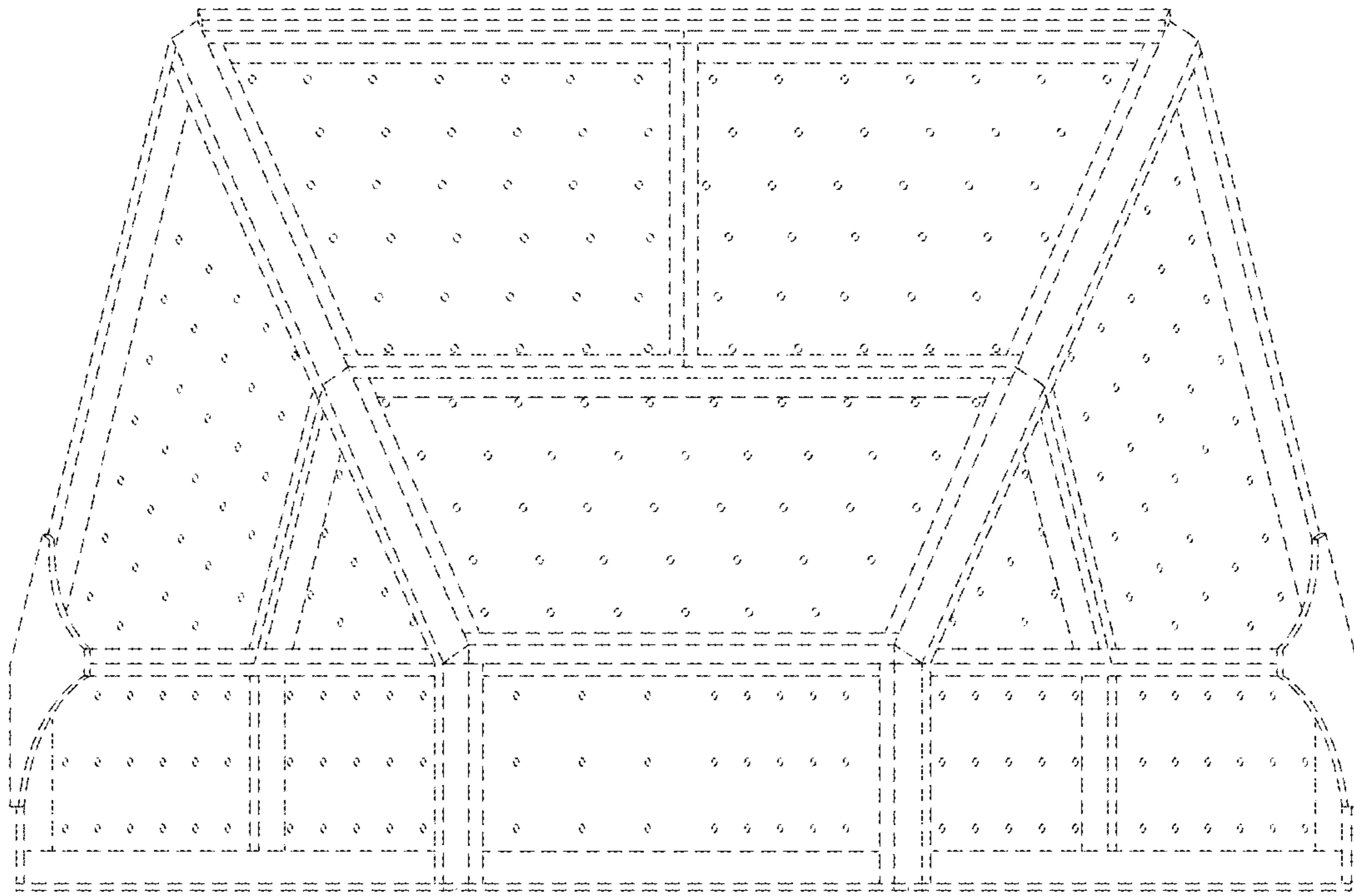

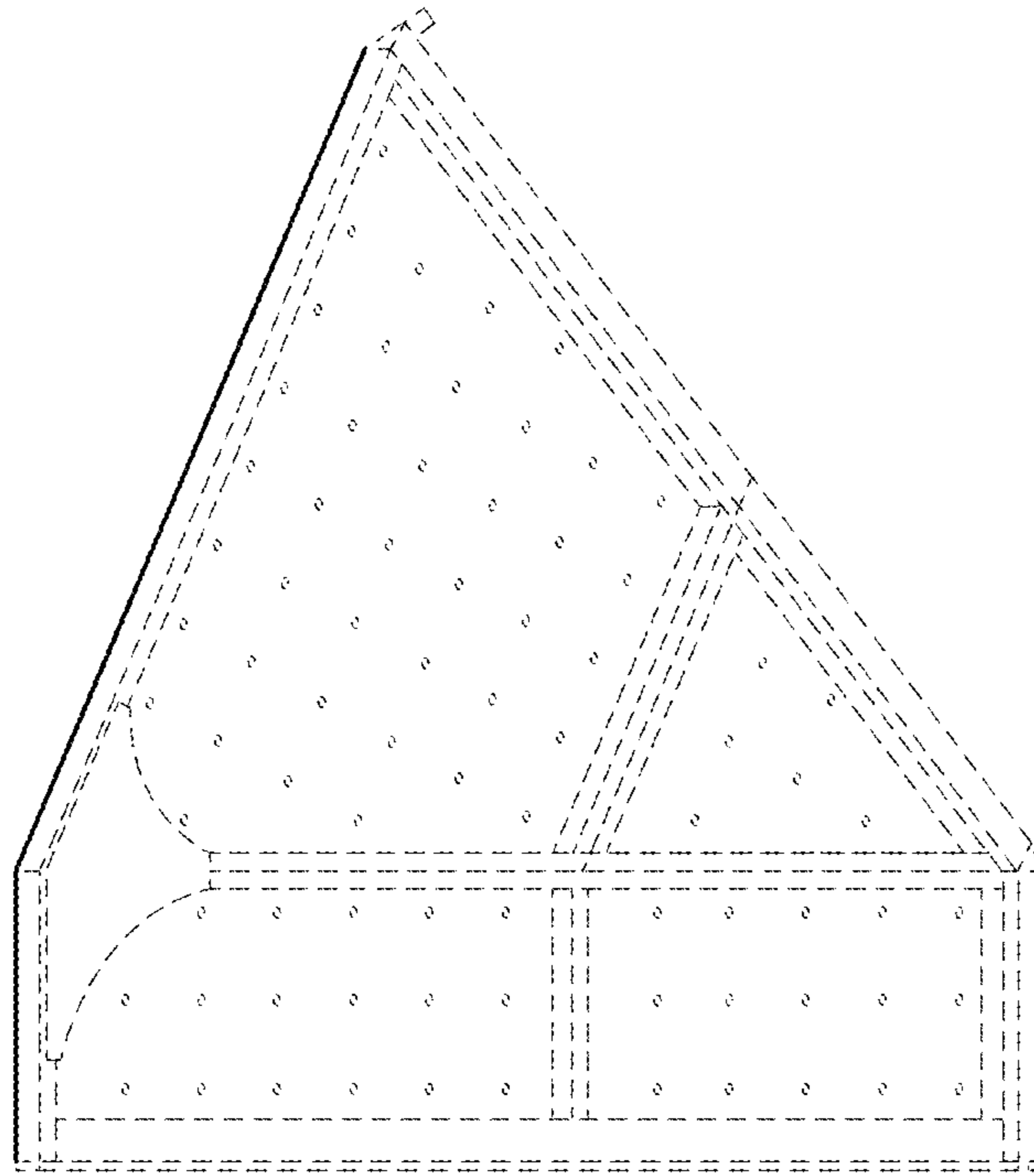

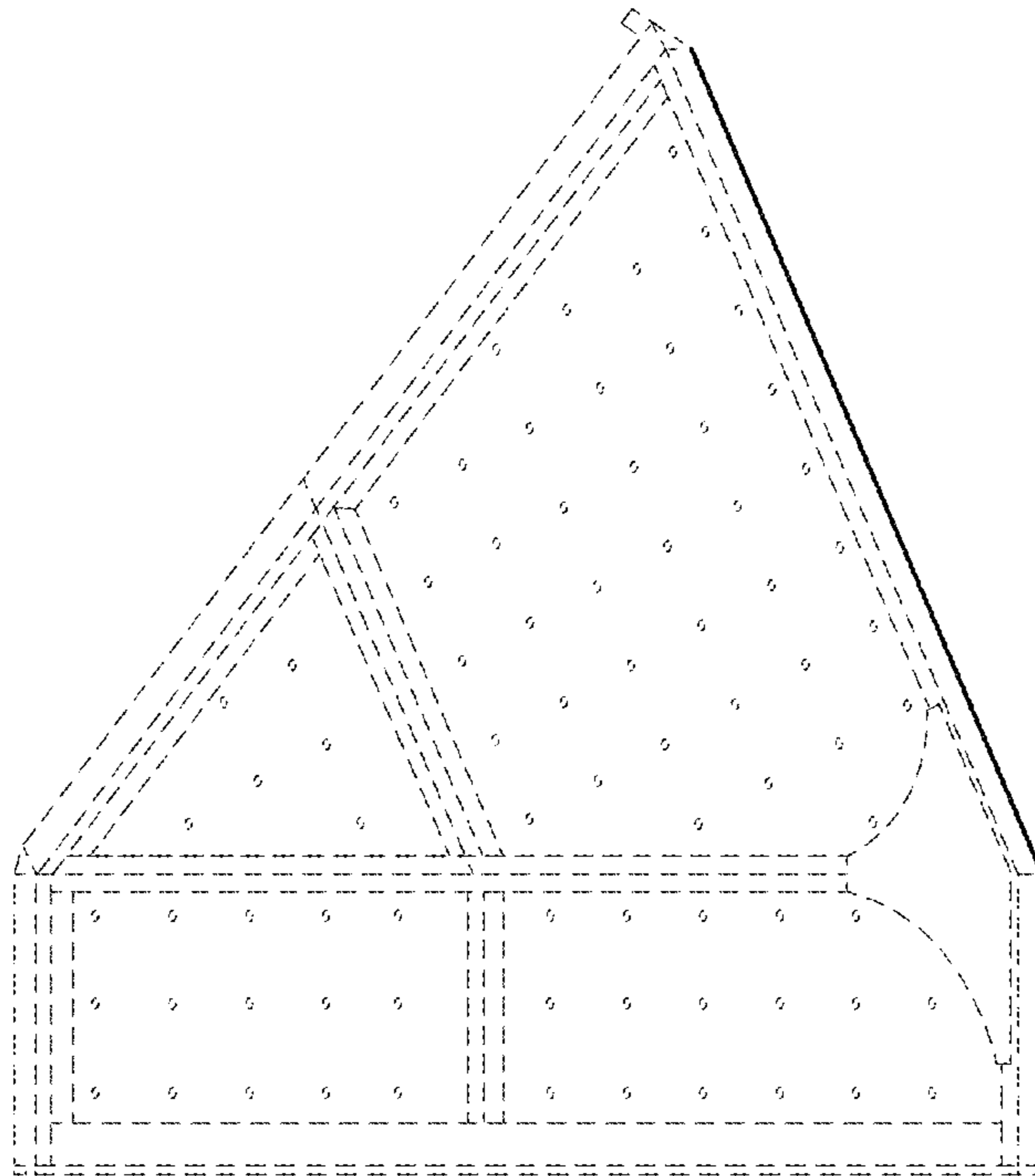

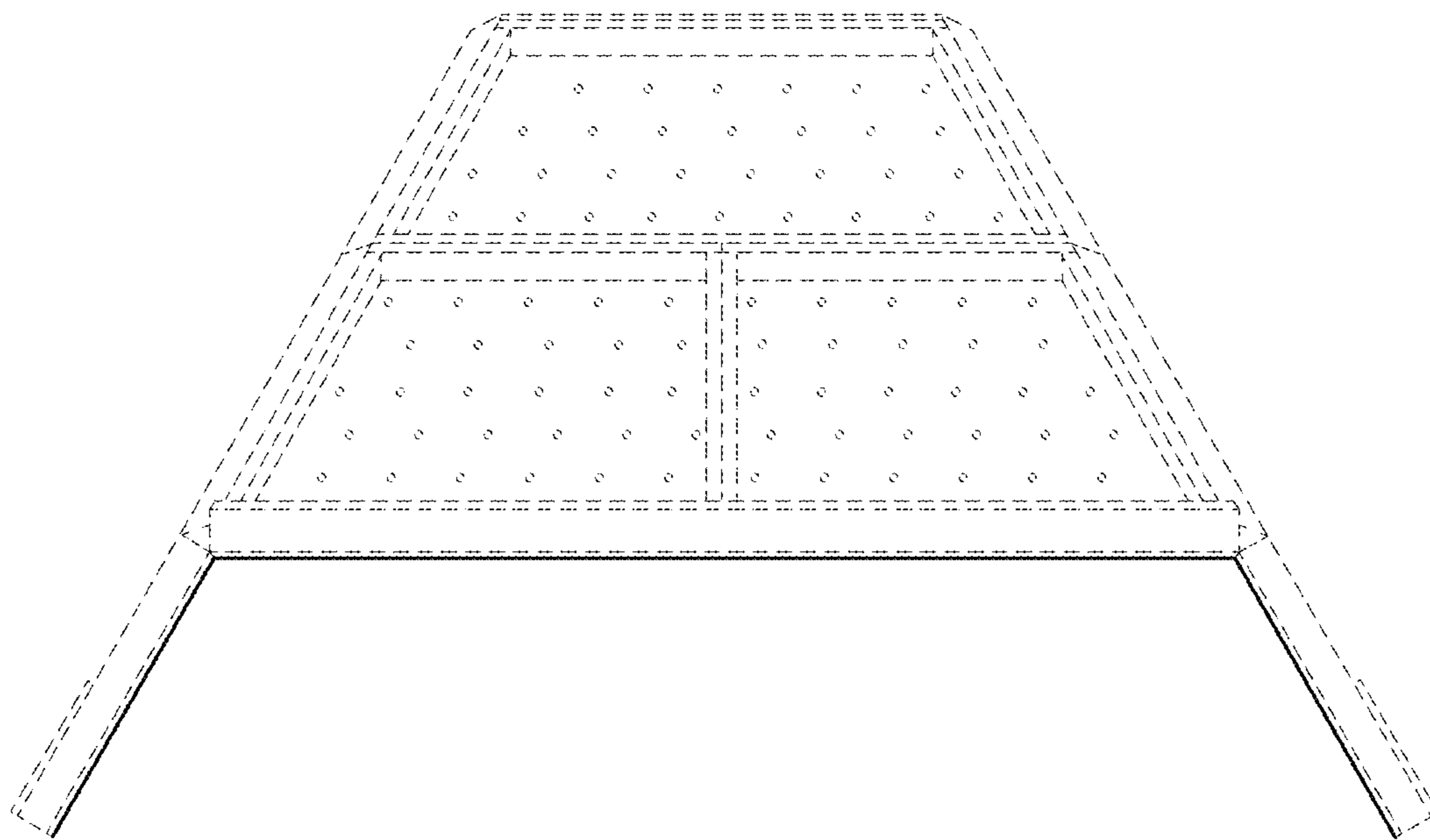

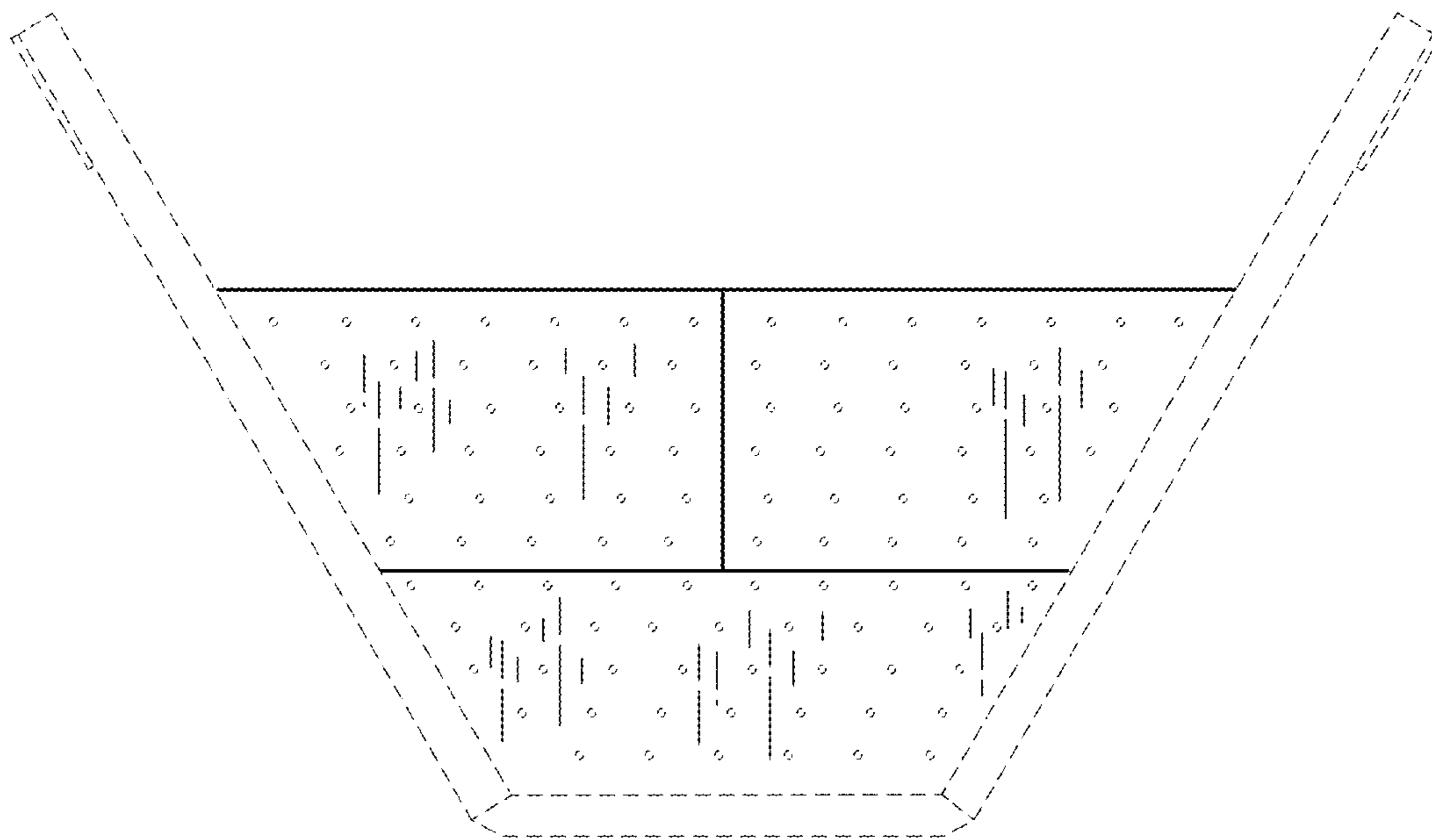

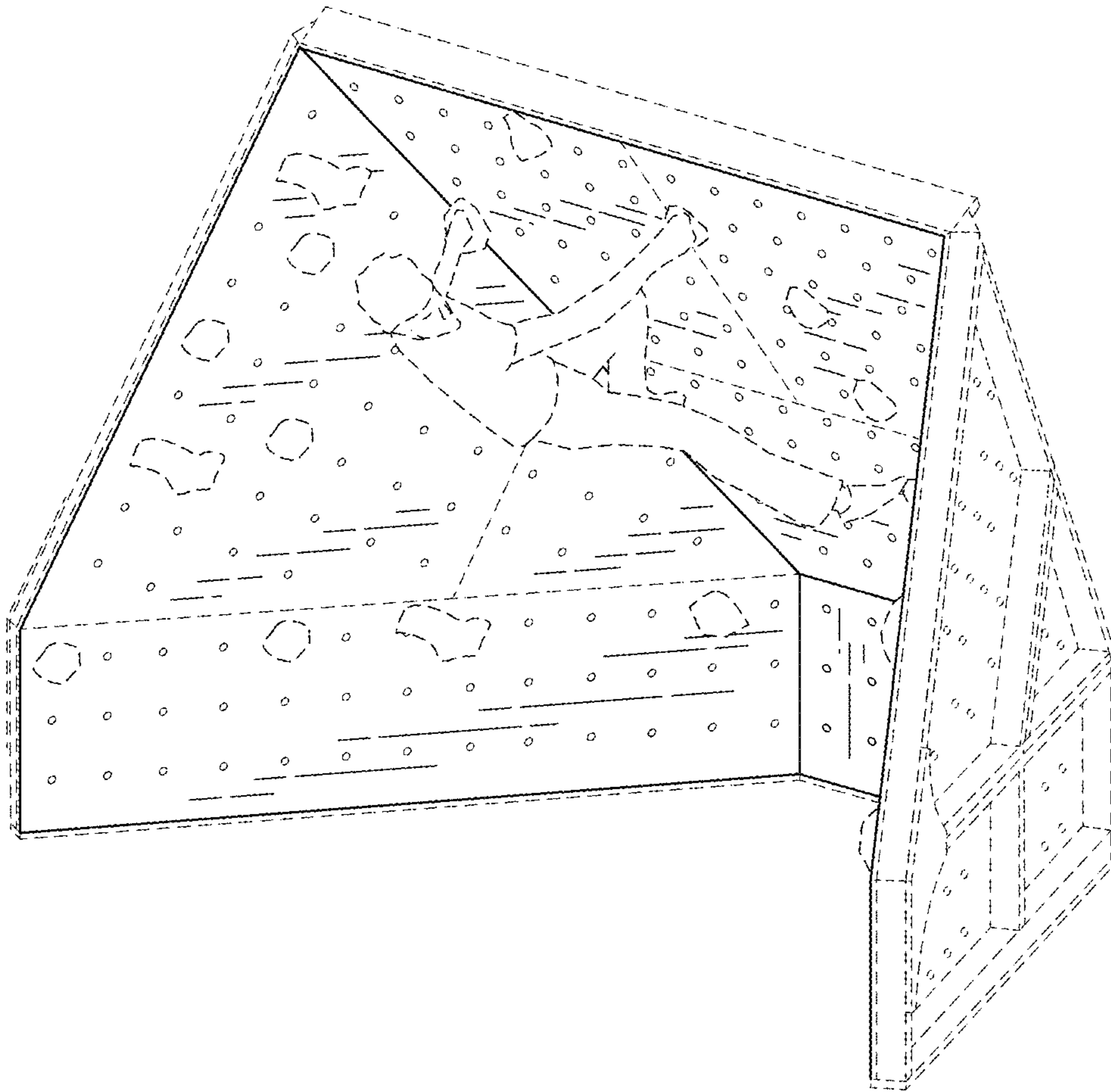

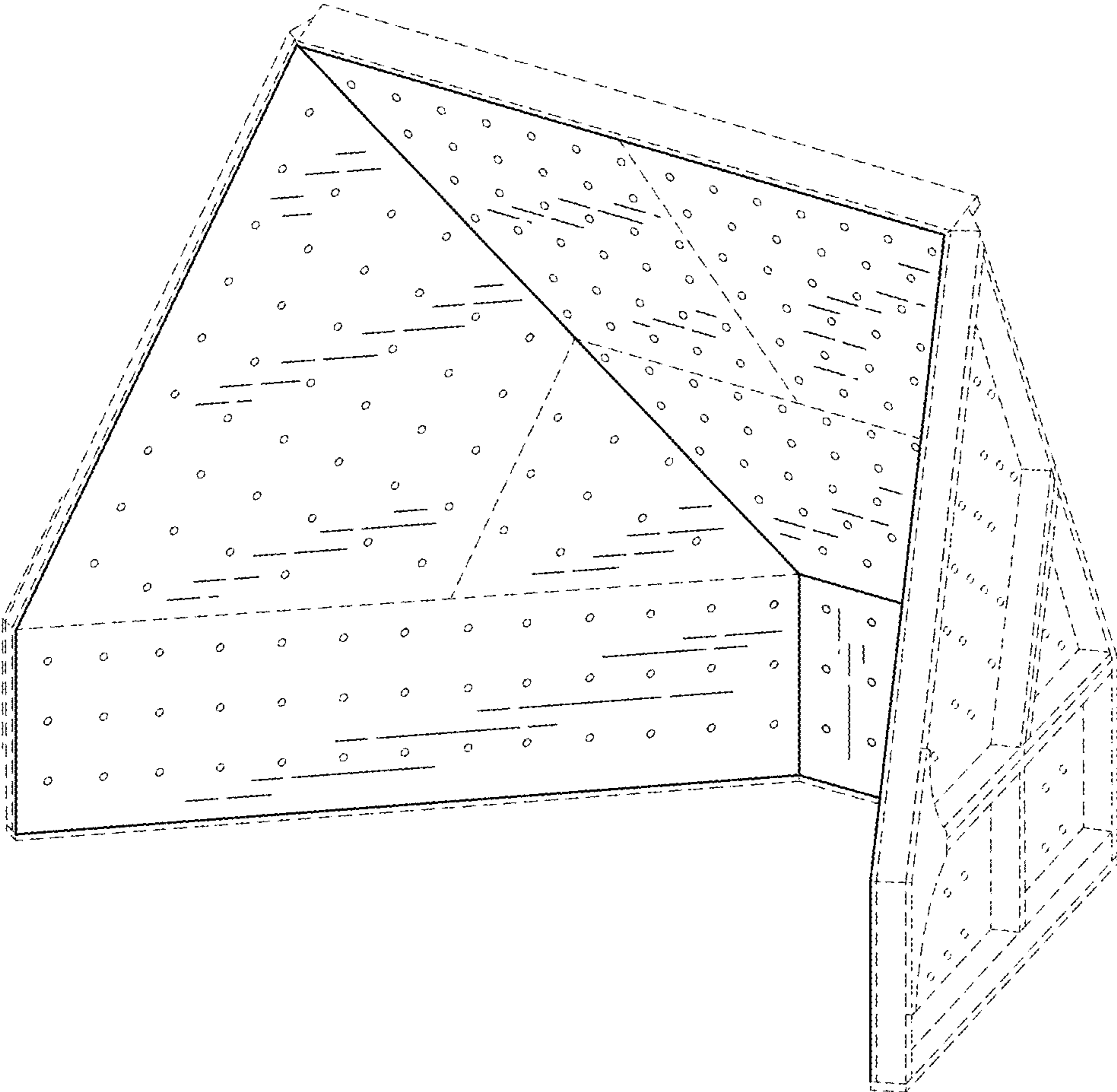

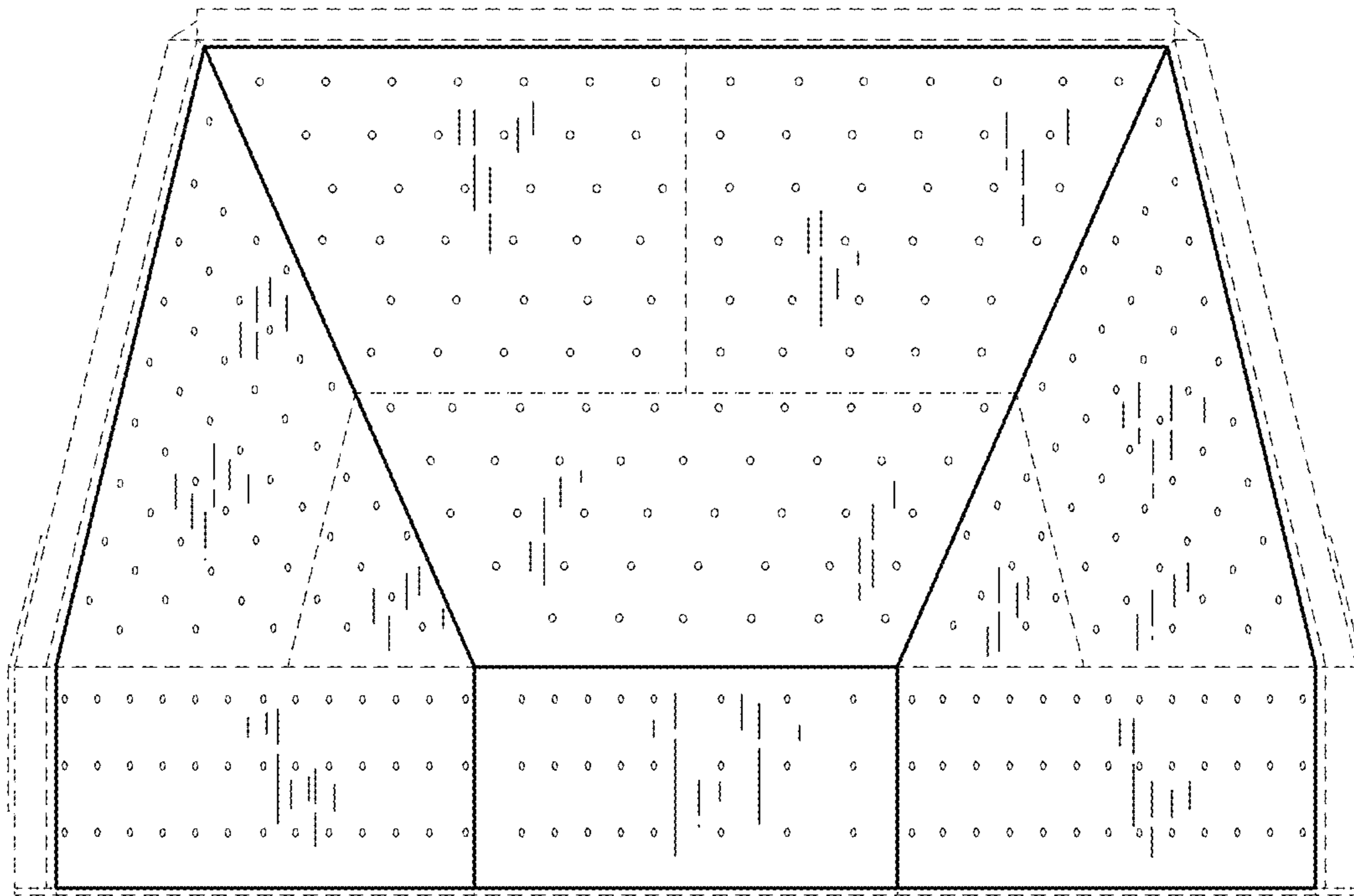

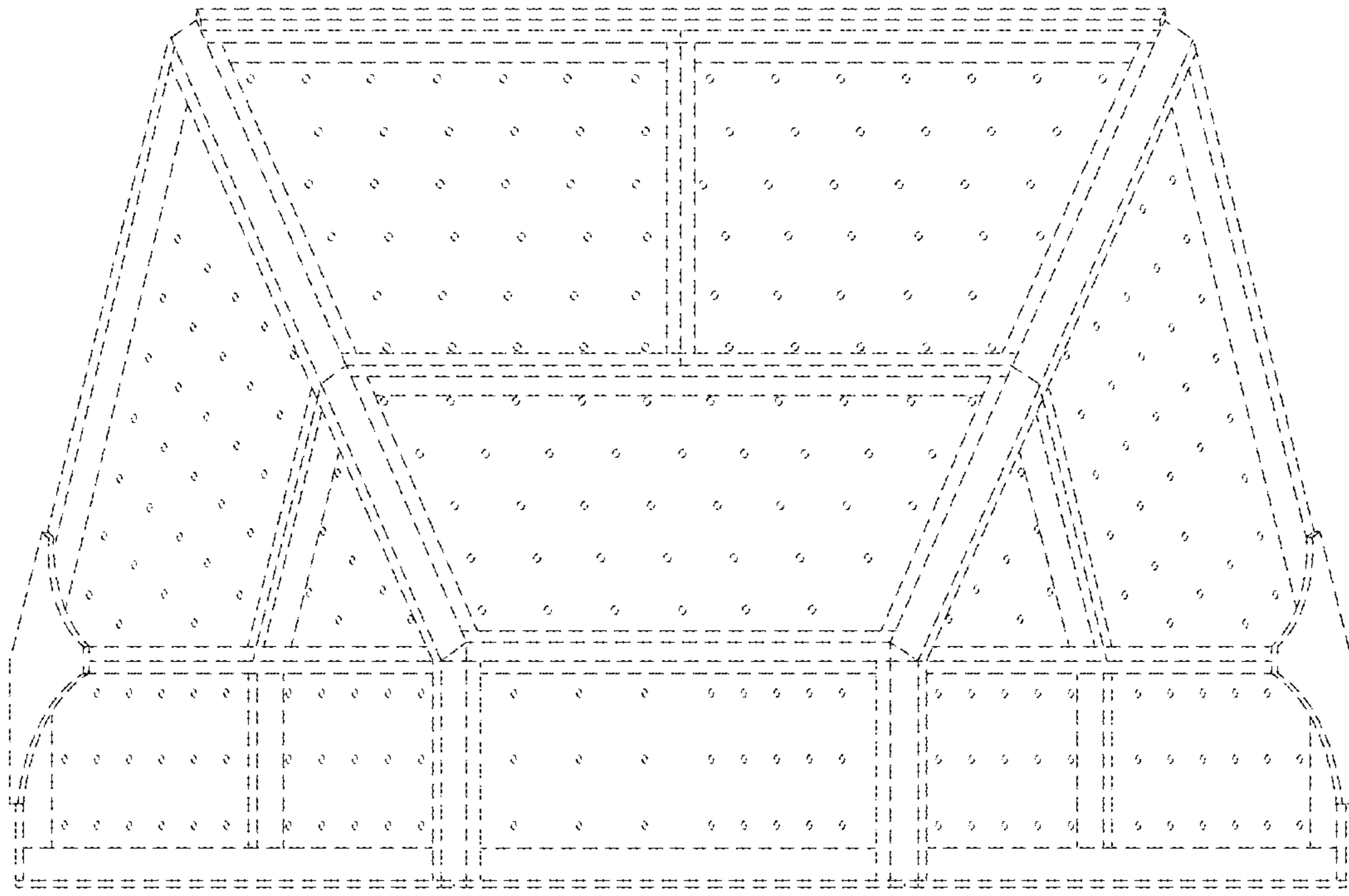

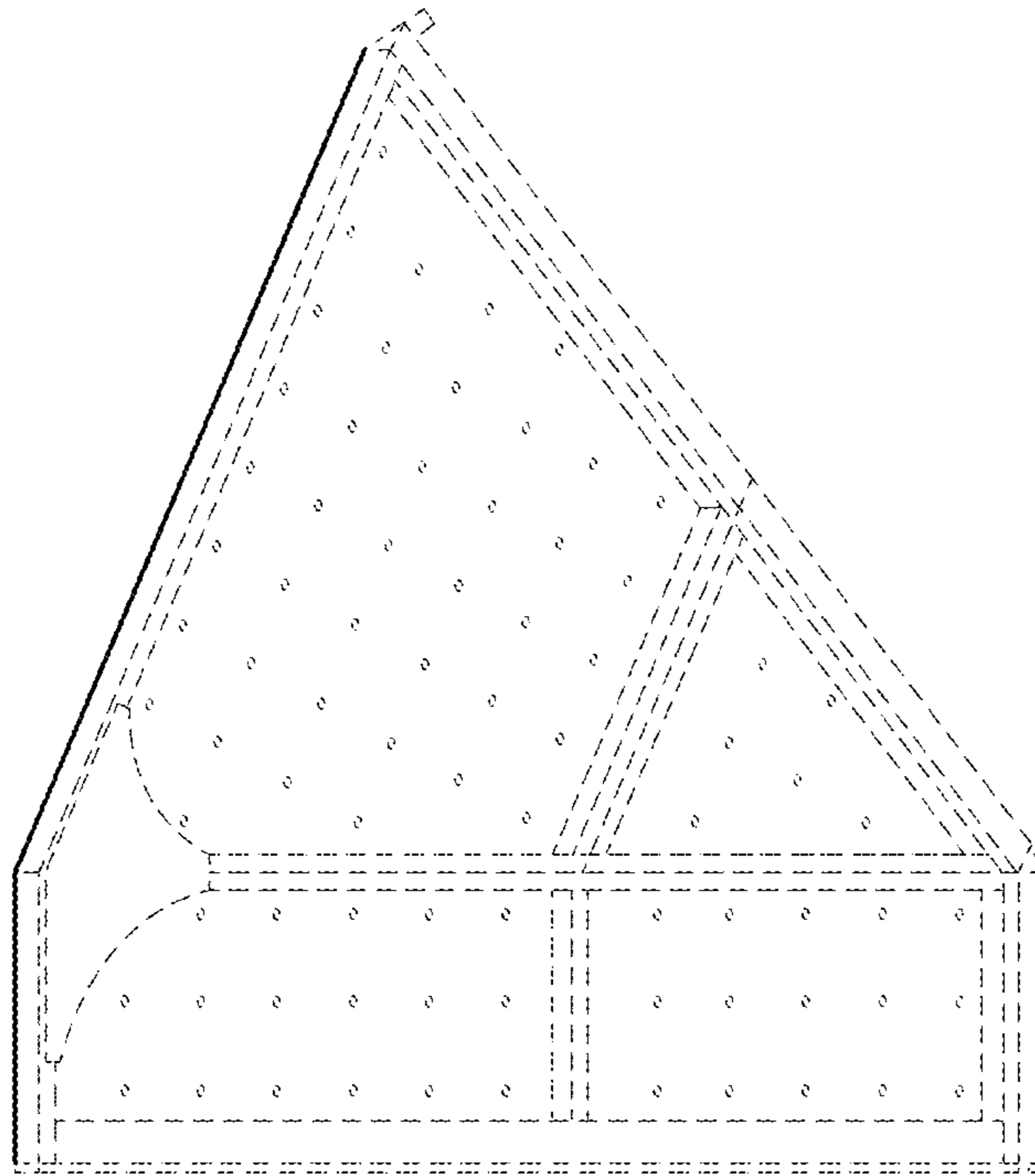

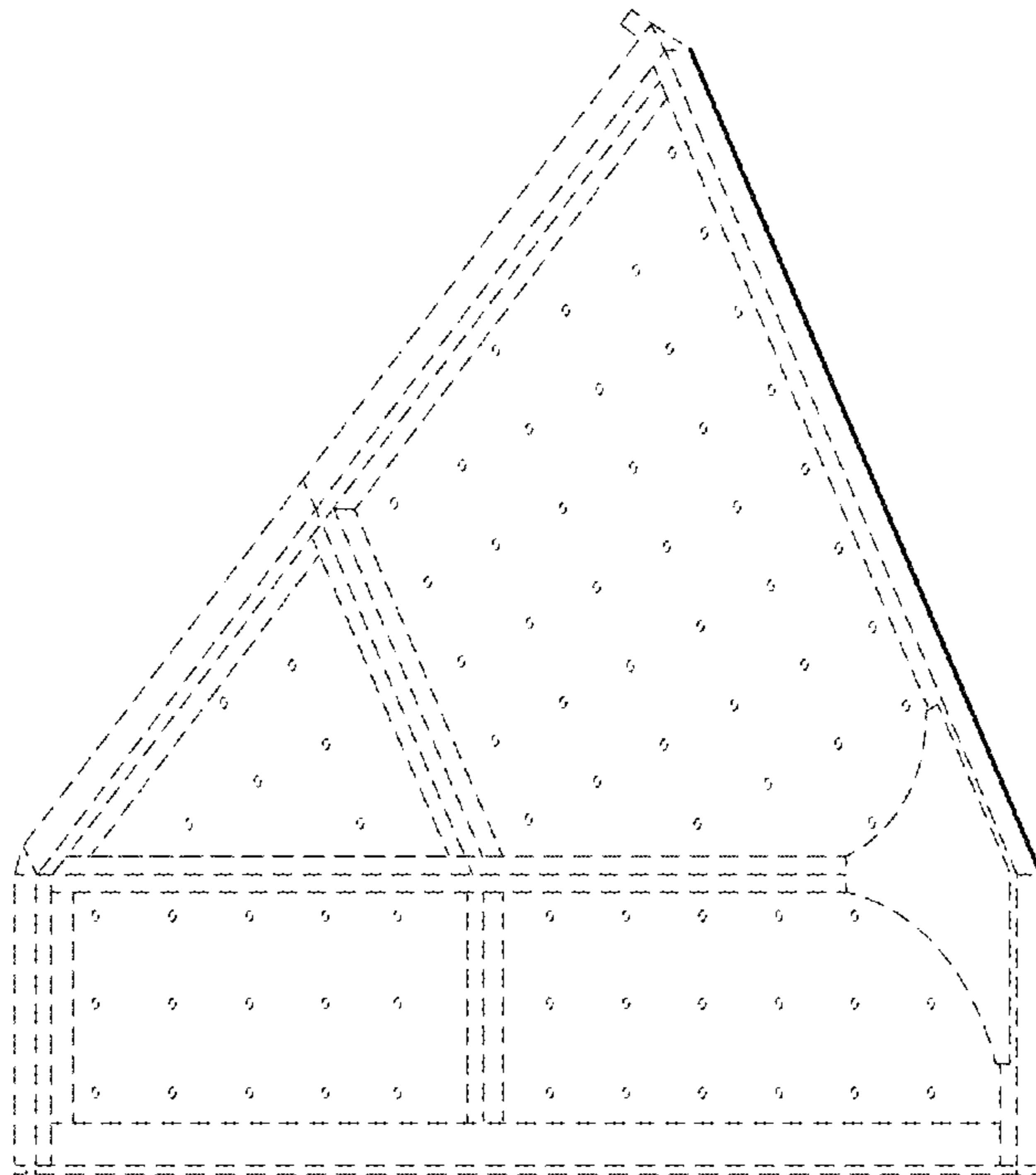

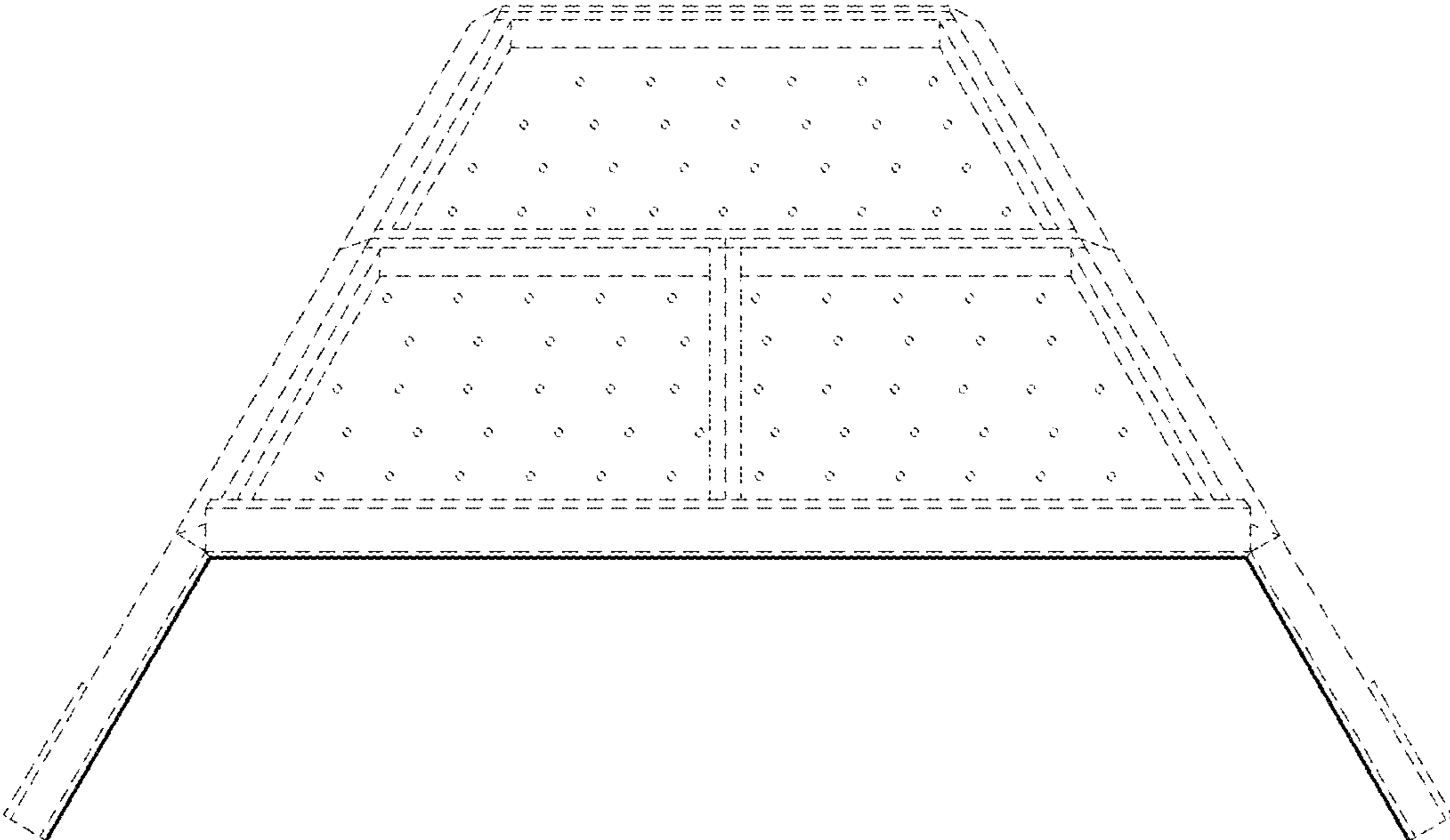

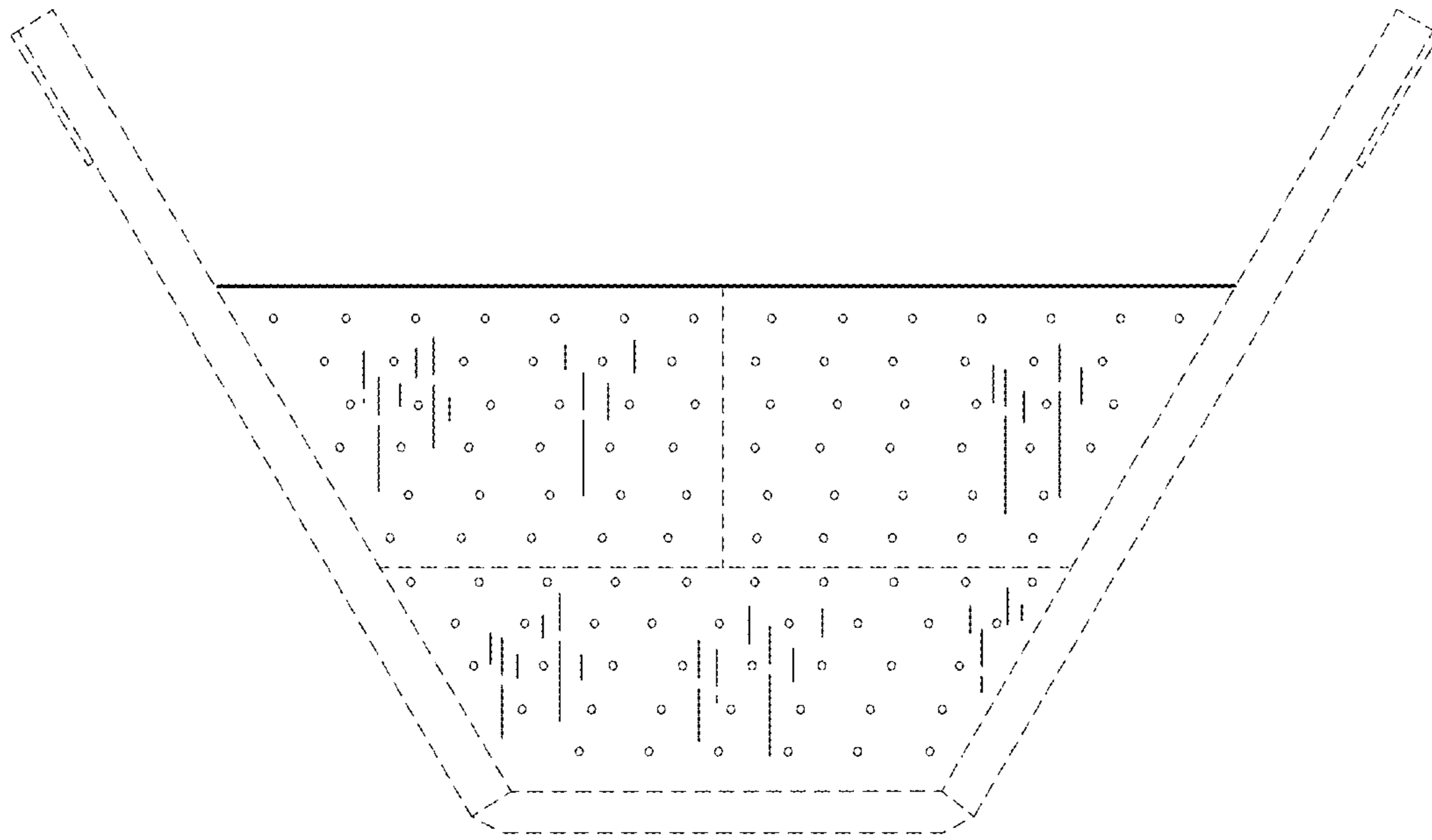
