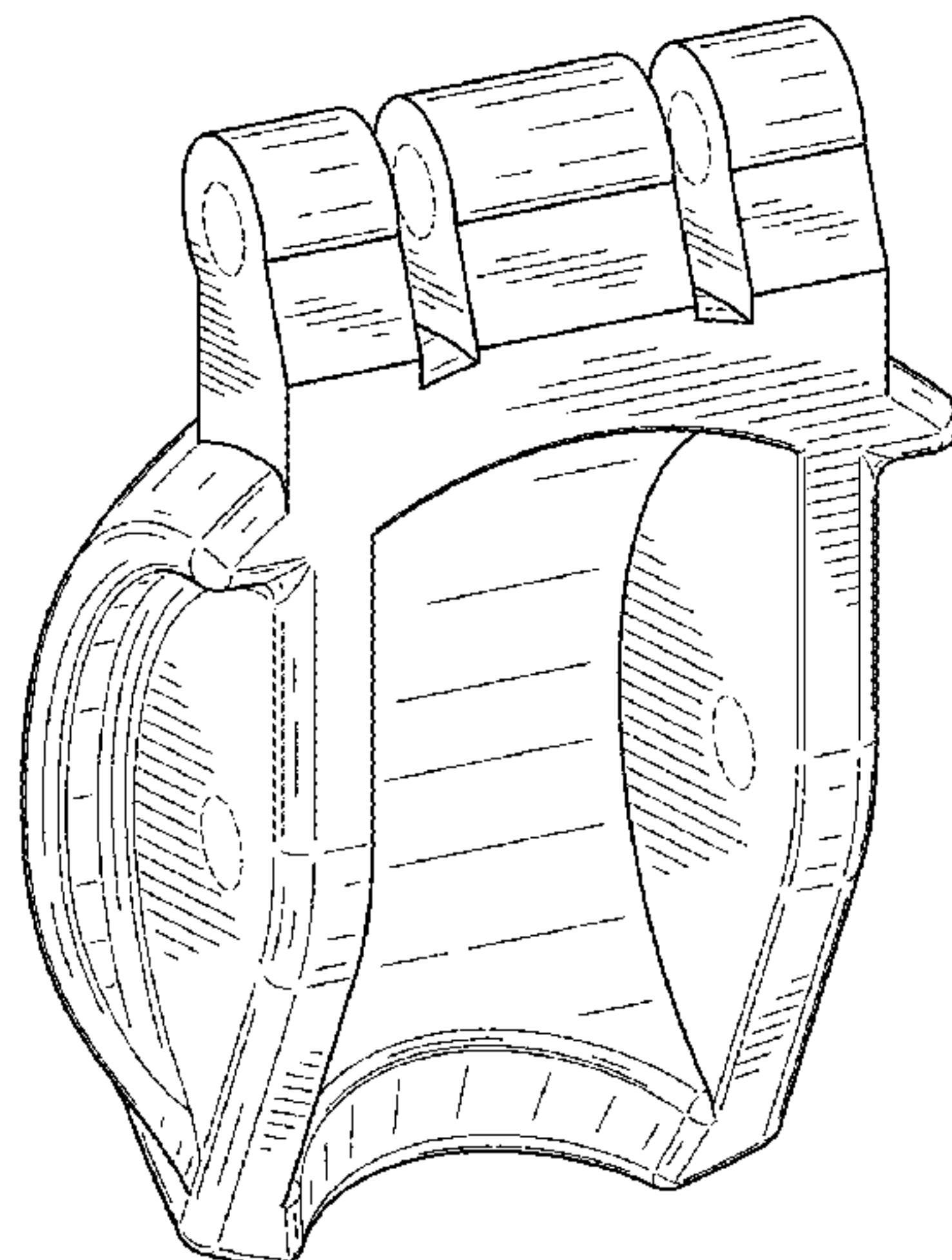


FIG. 23 is a front view of the third embodiment of the fishing gimbal; and,

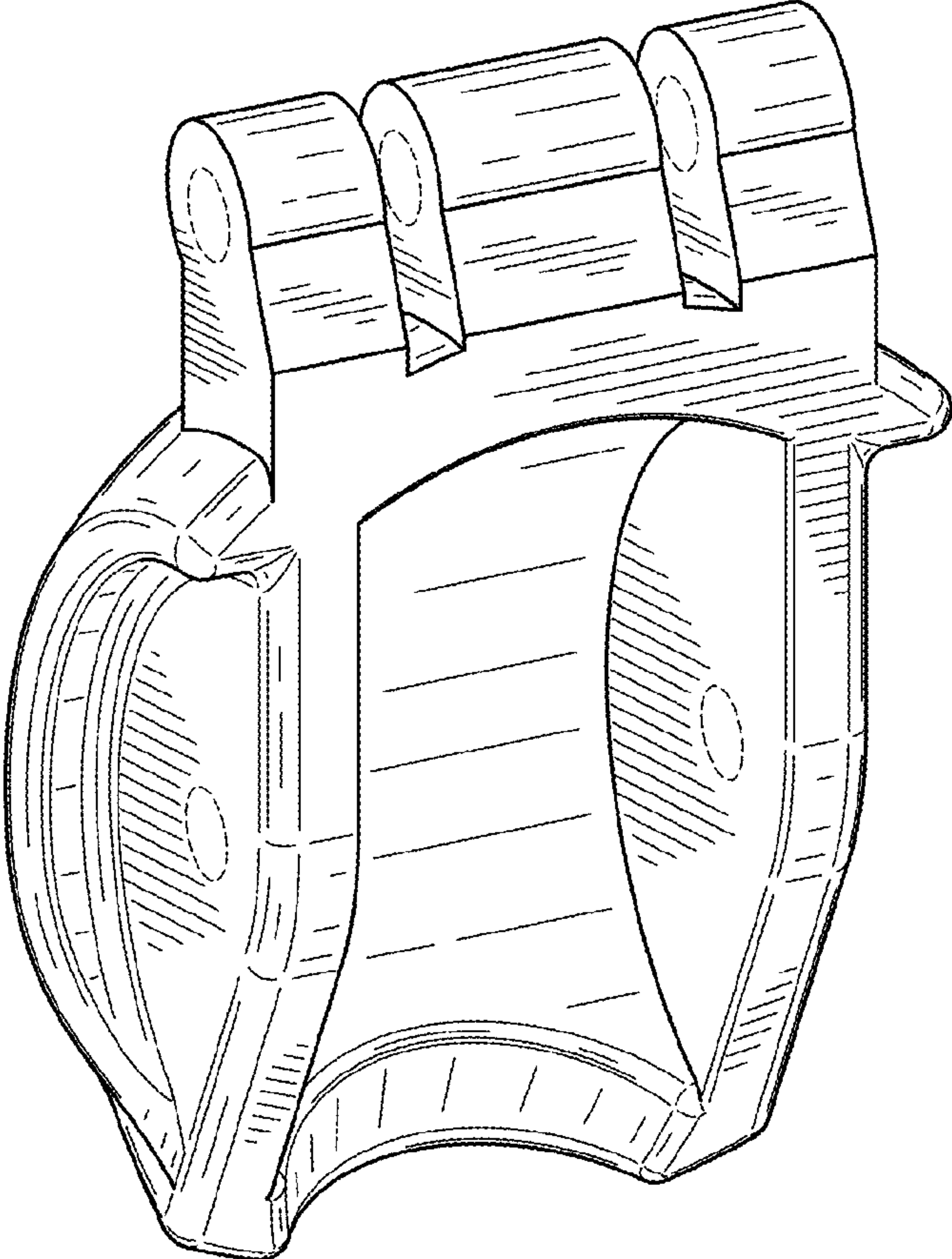

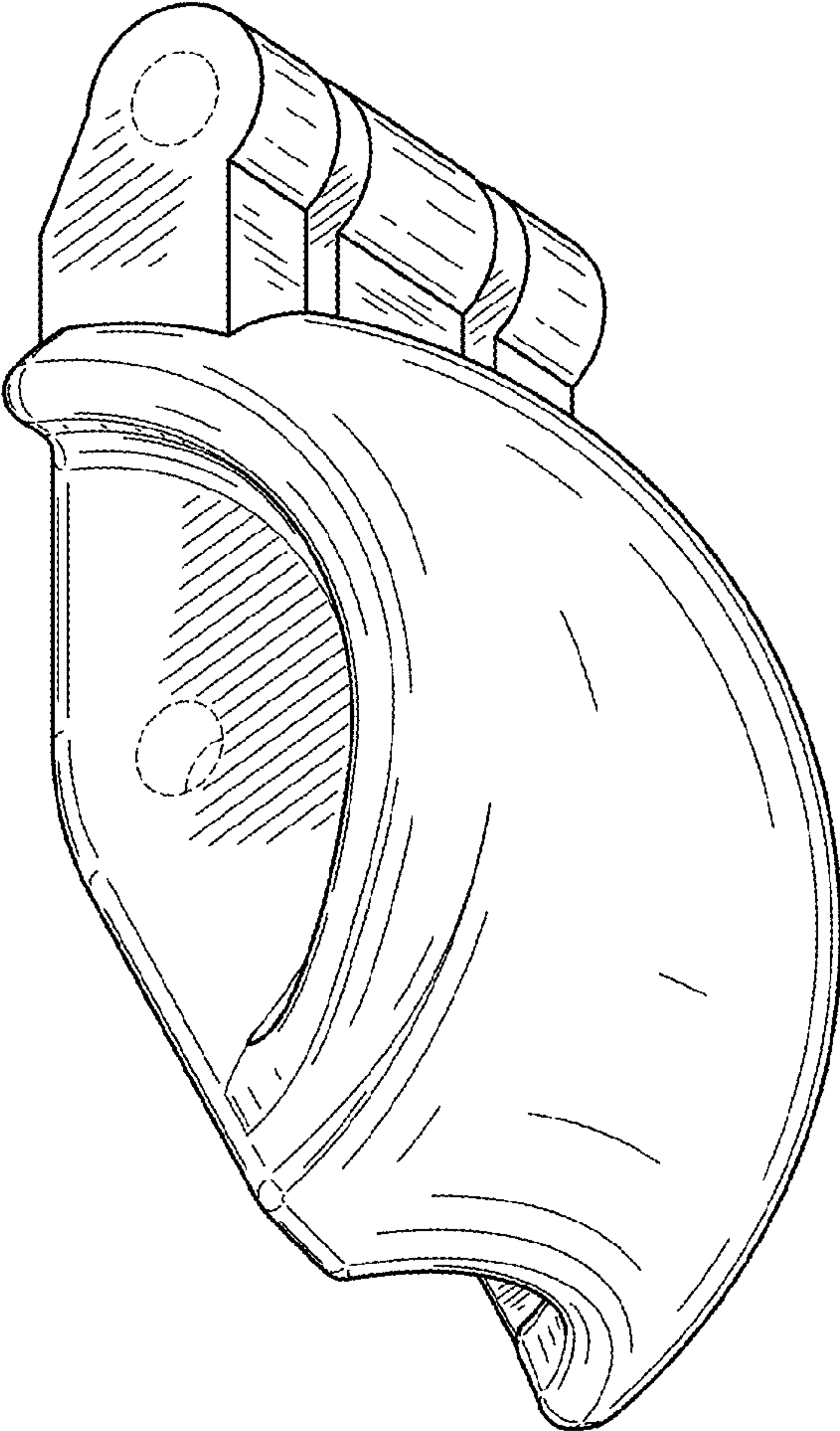

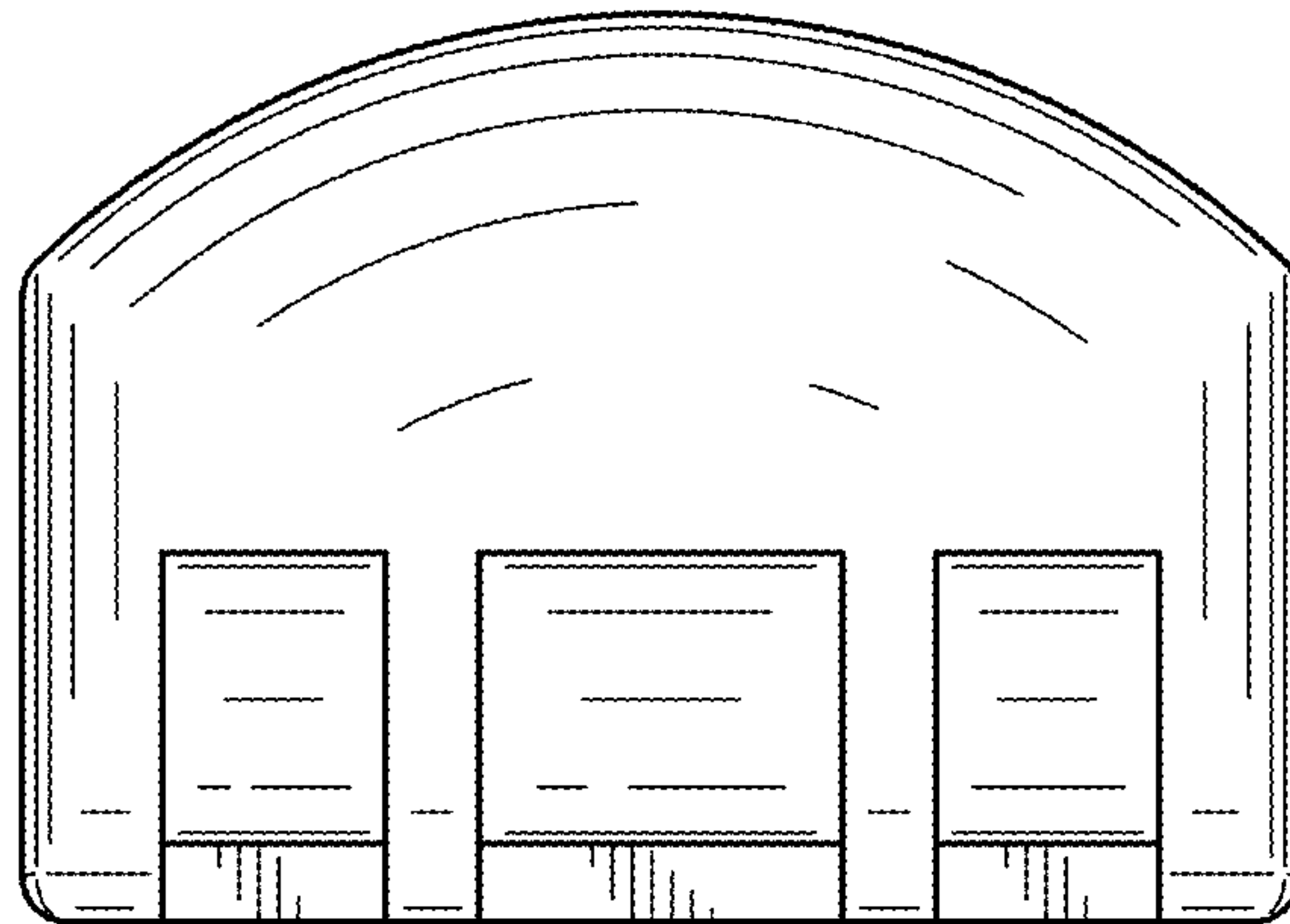

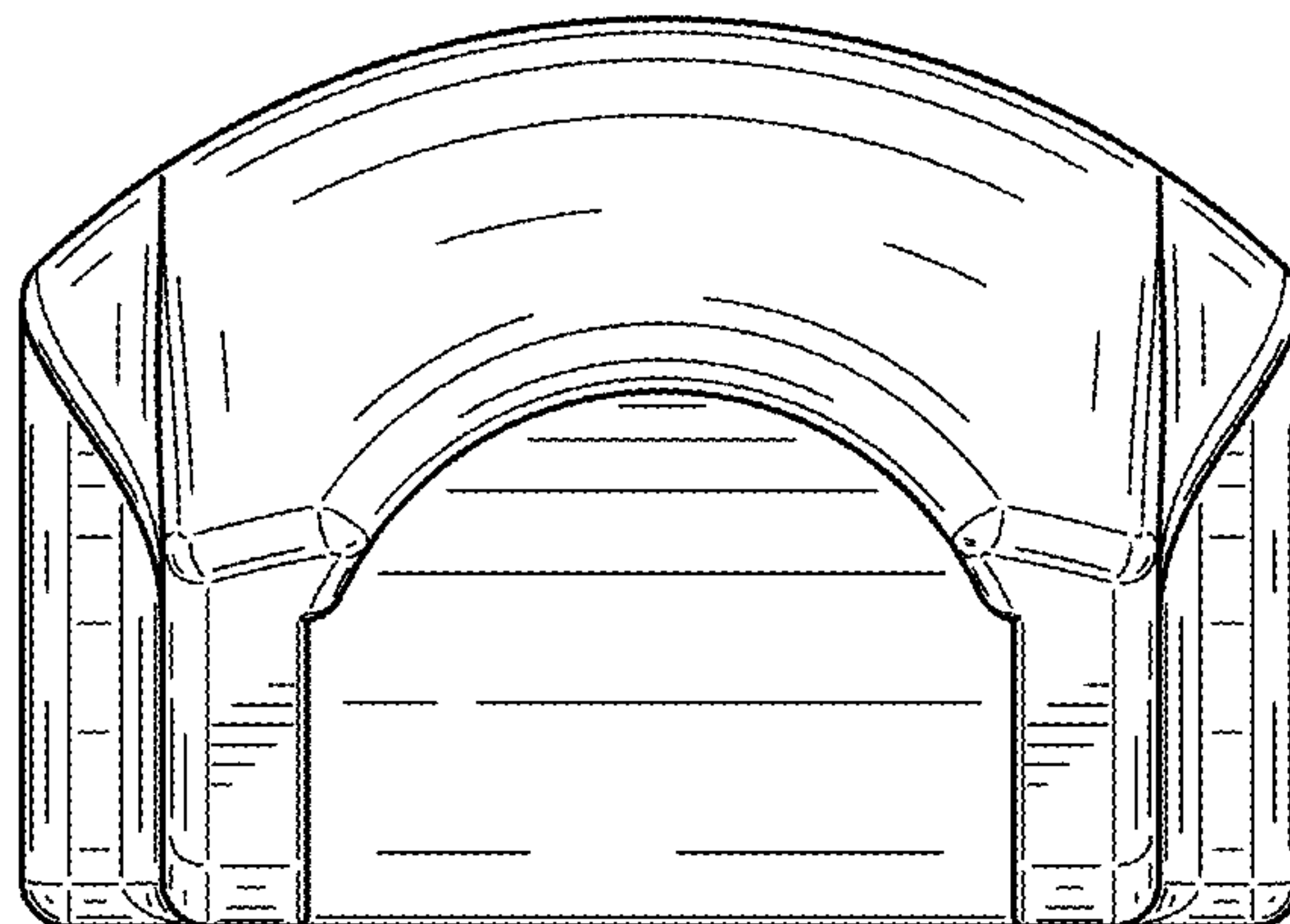

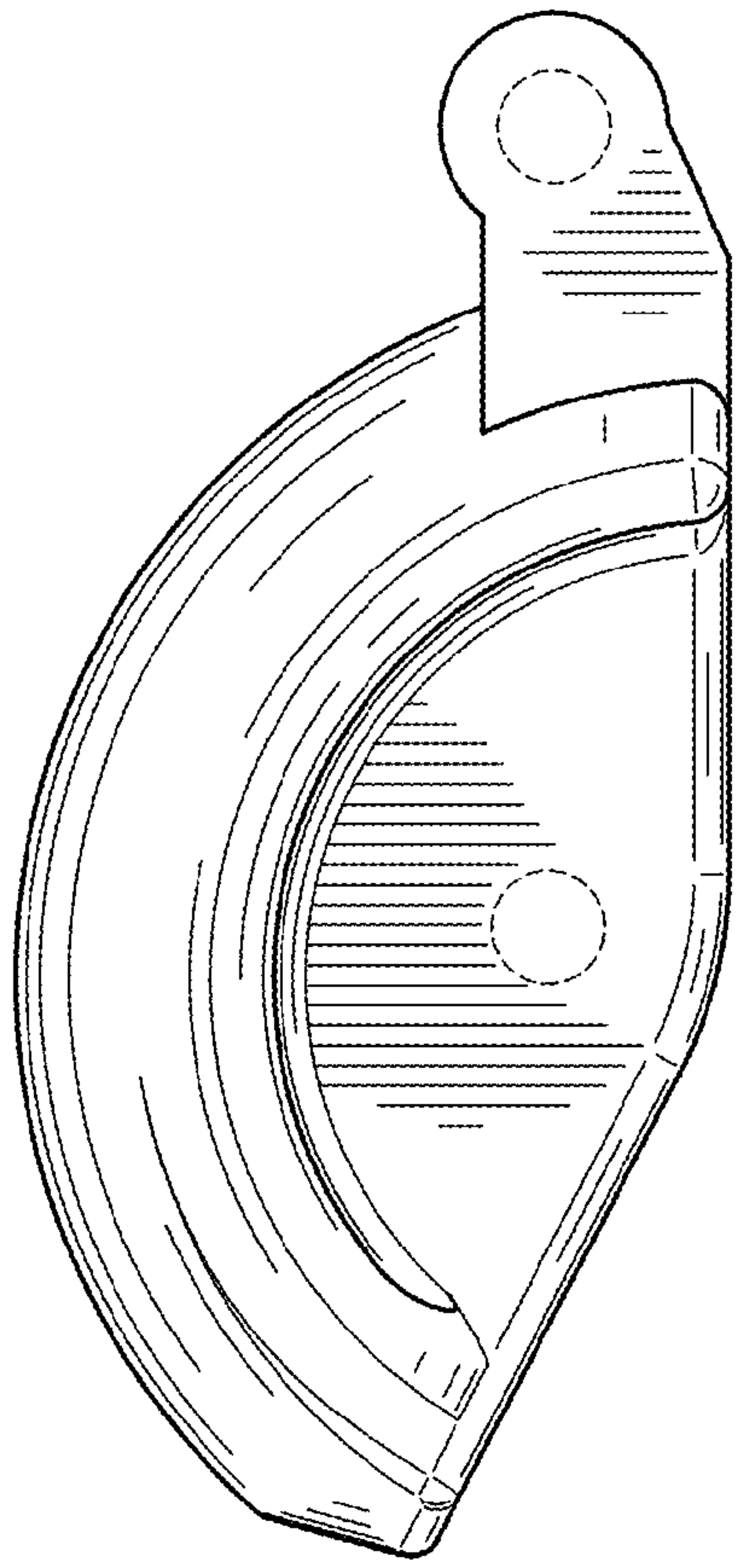

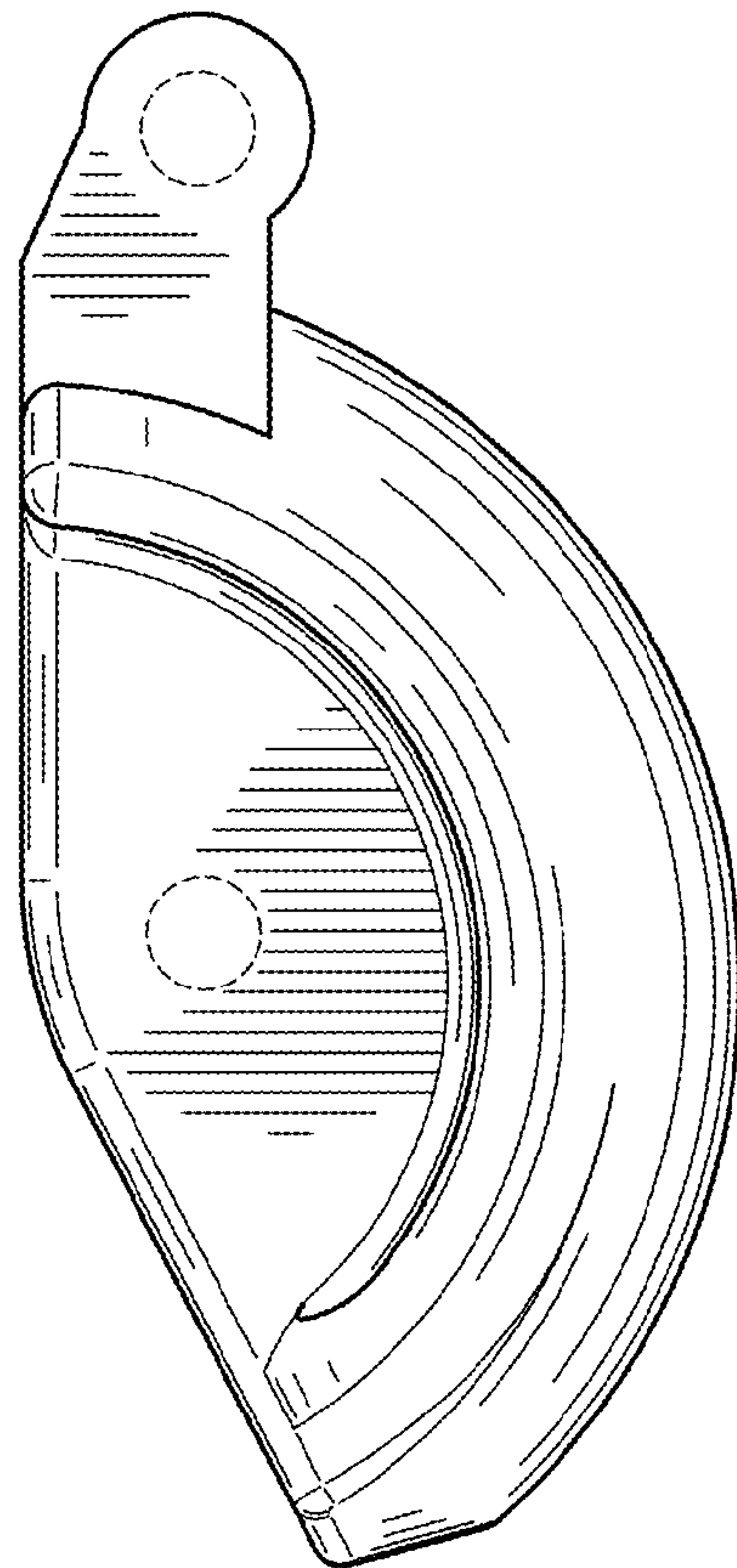

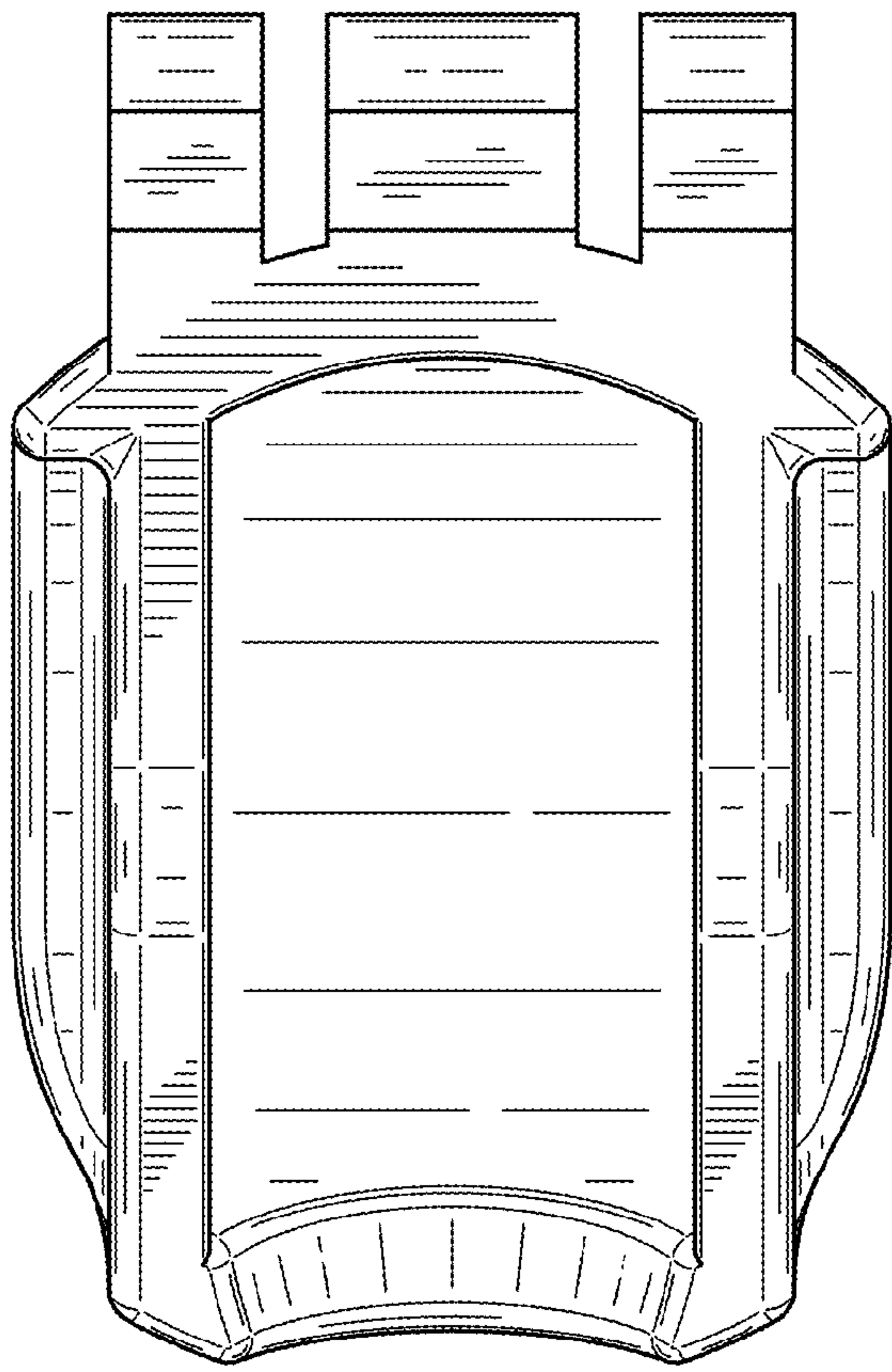

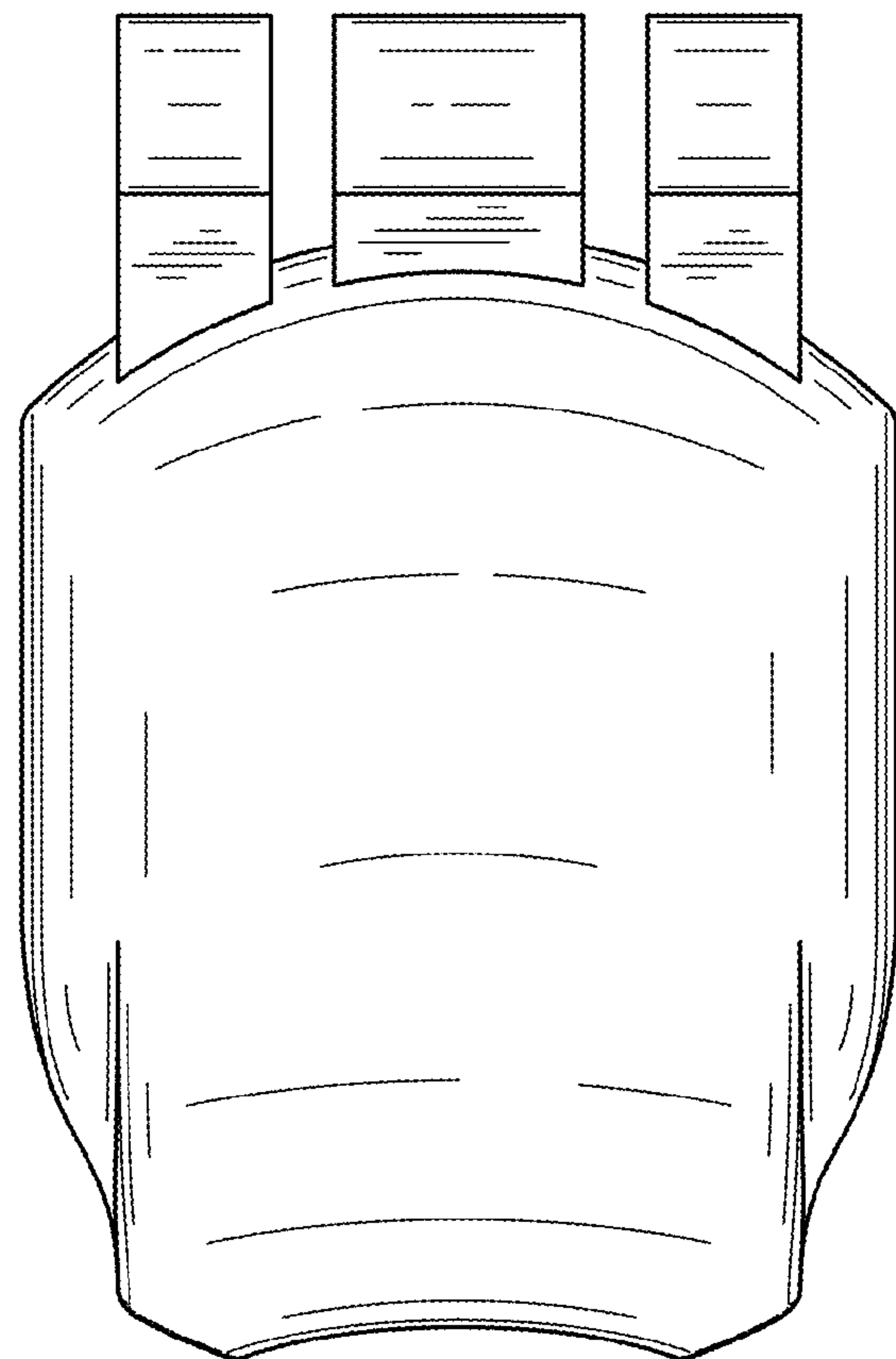

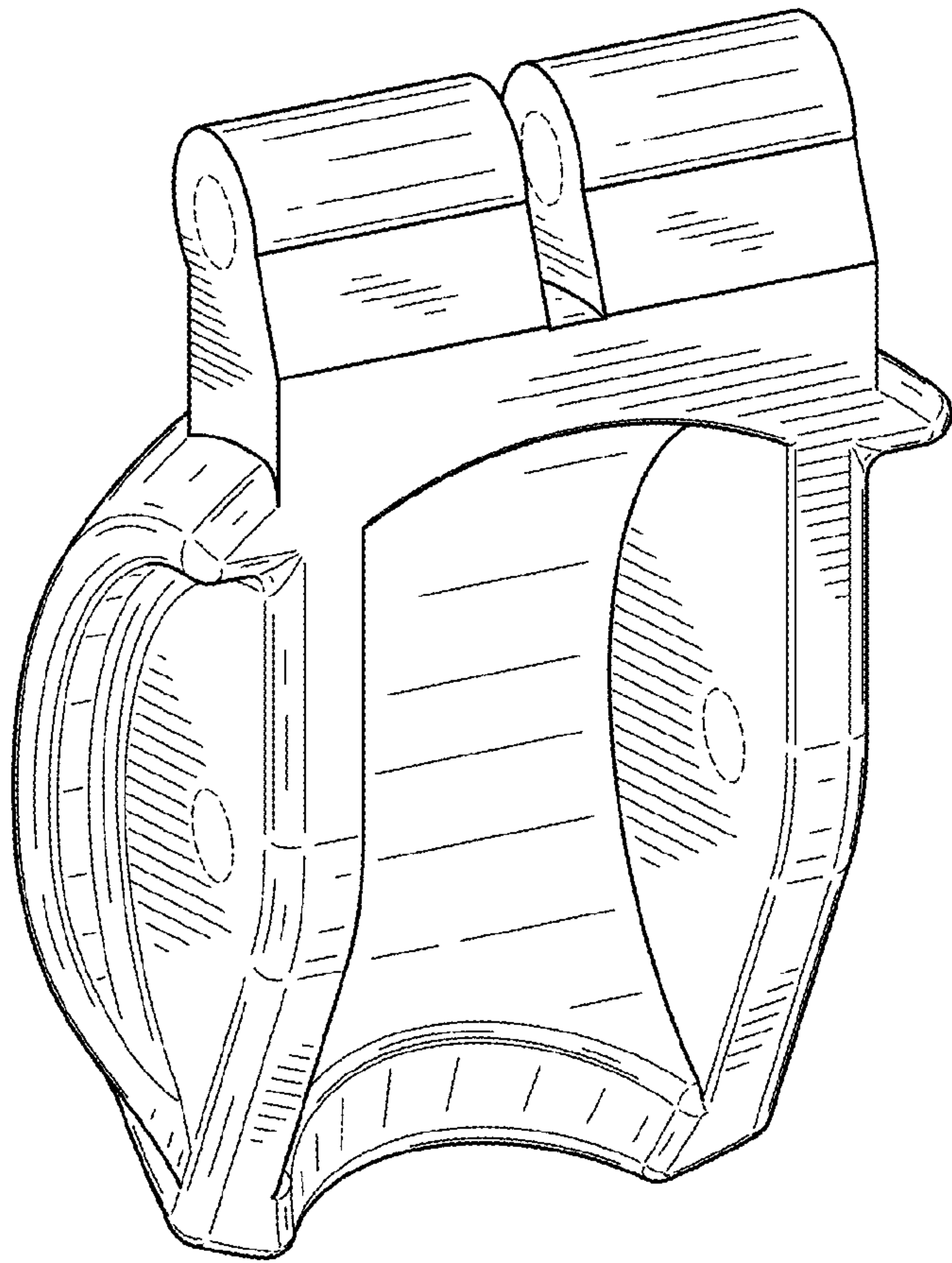

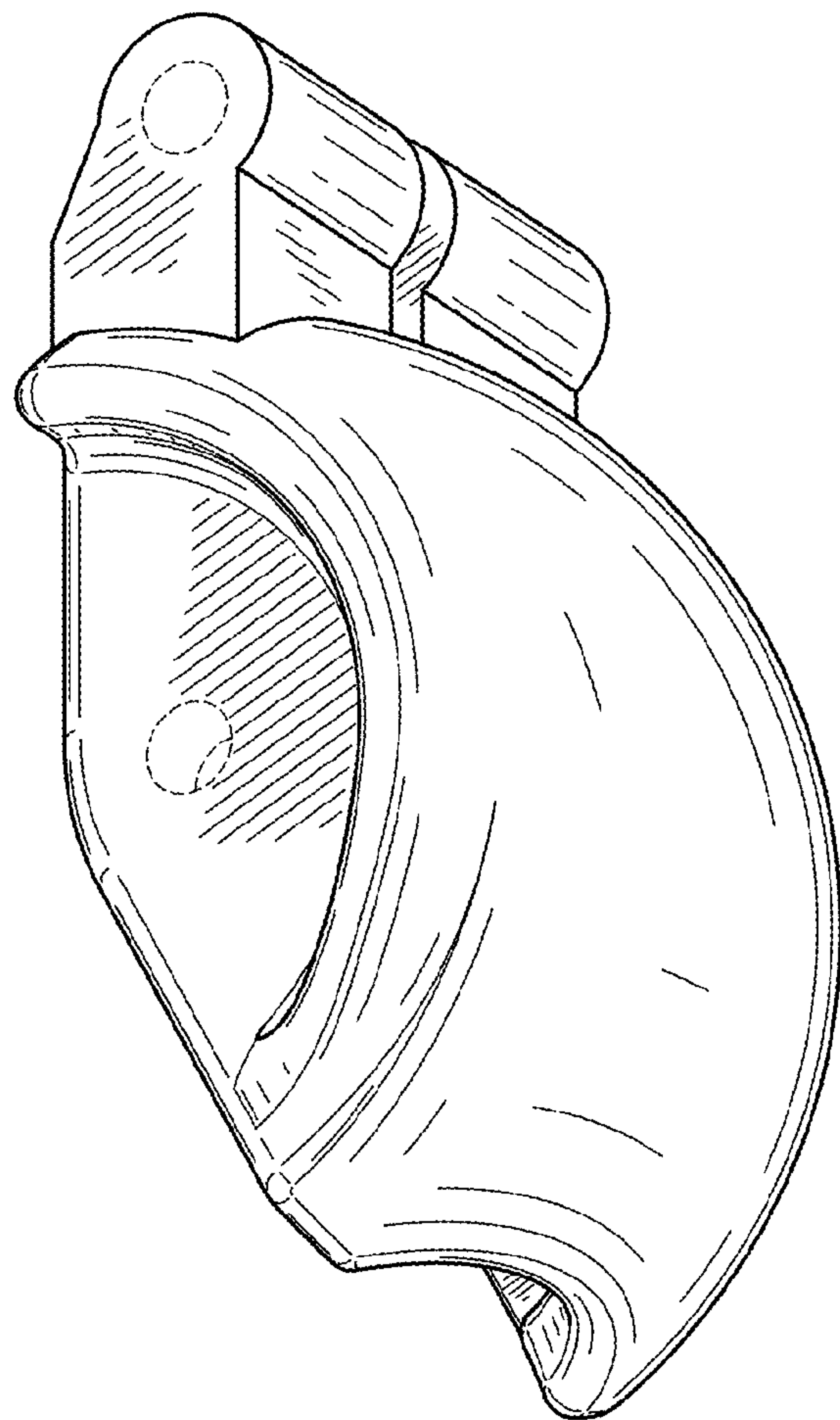

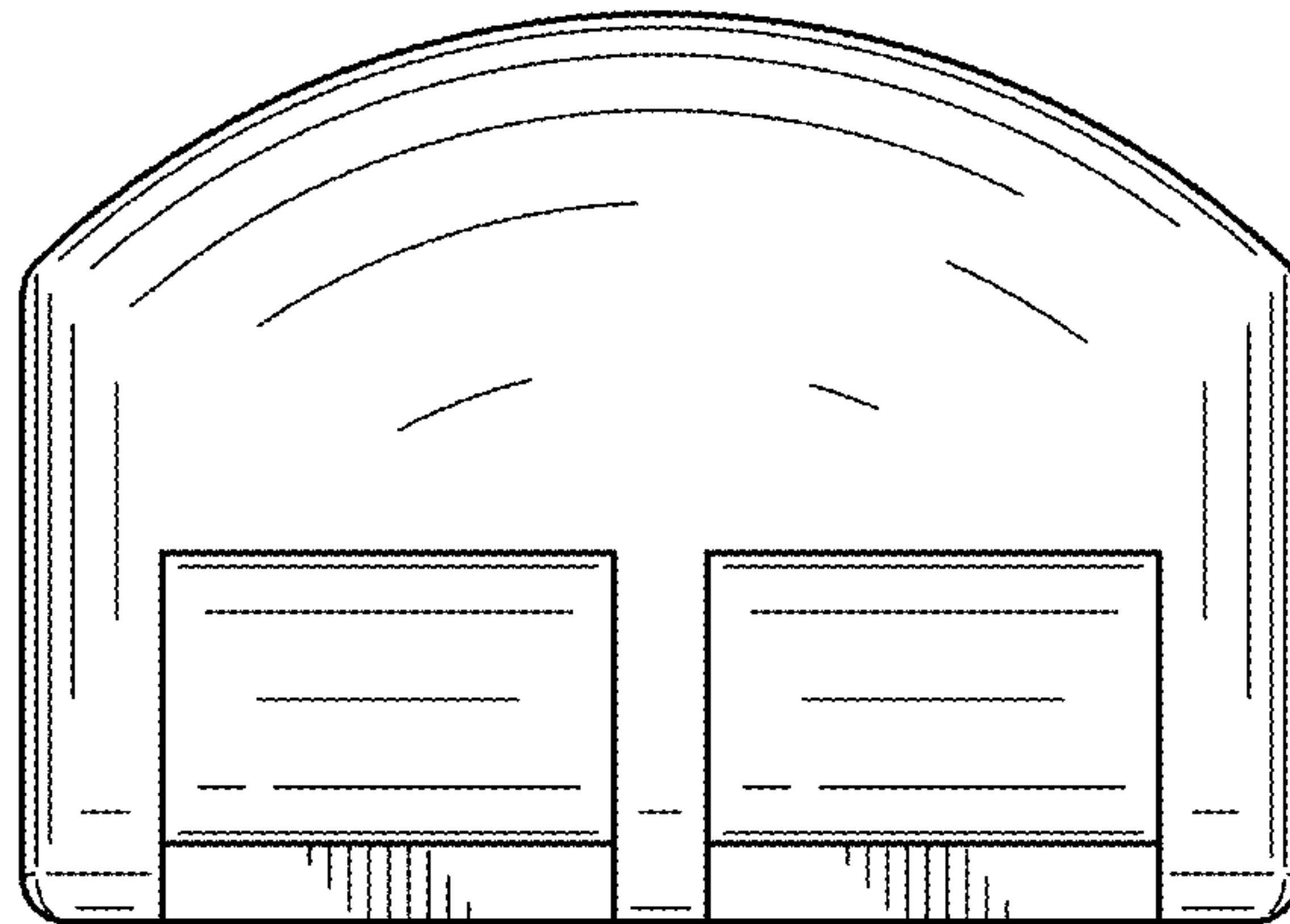

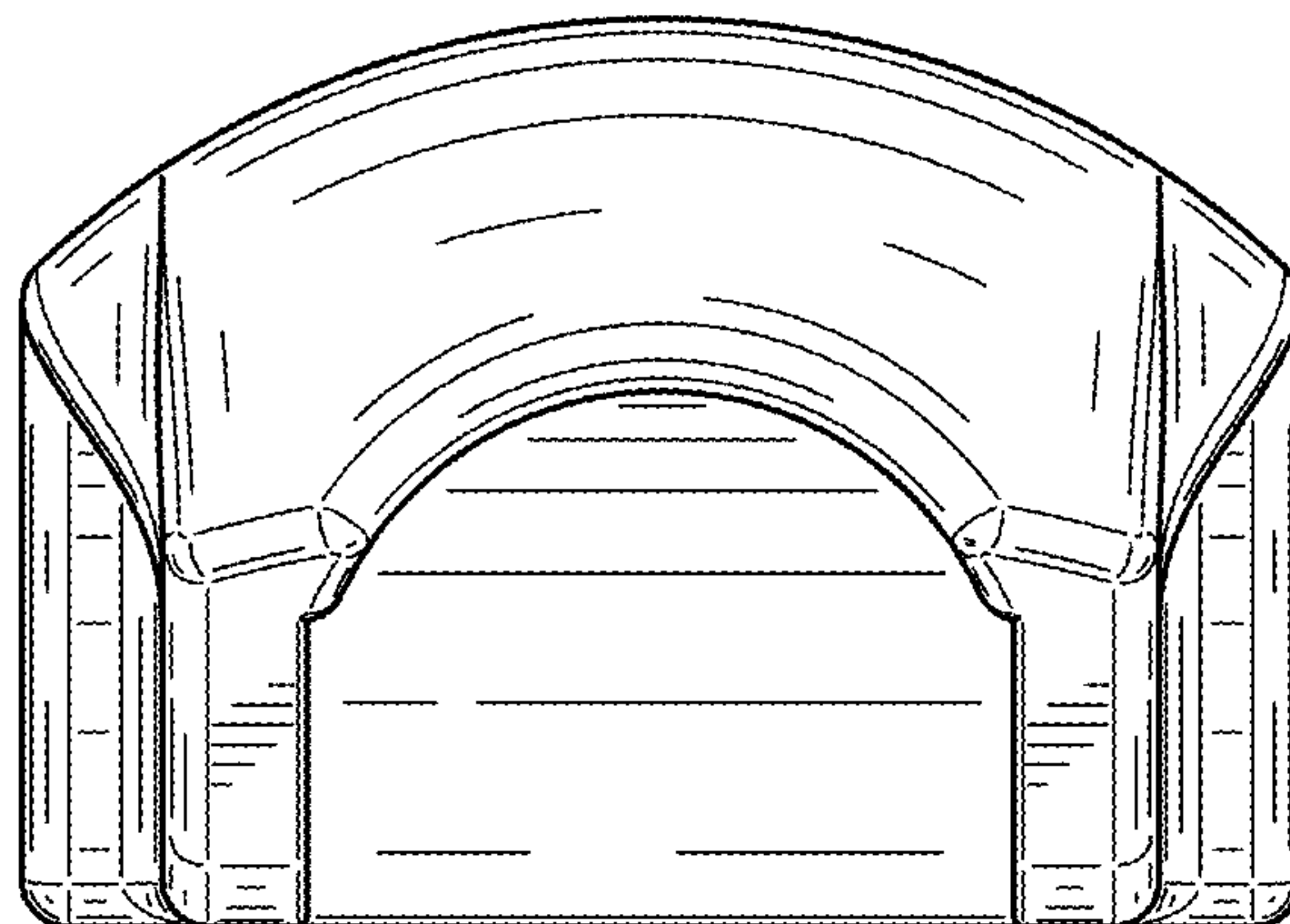

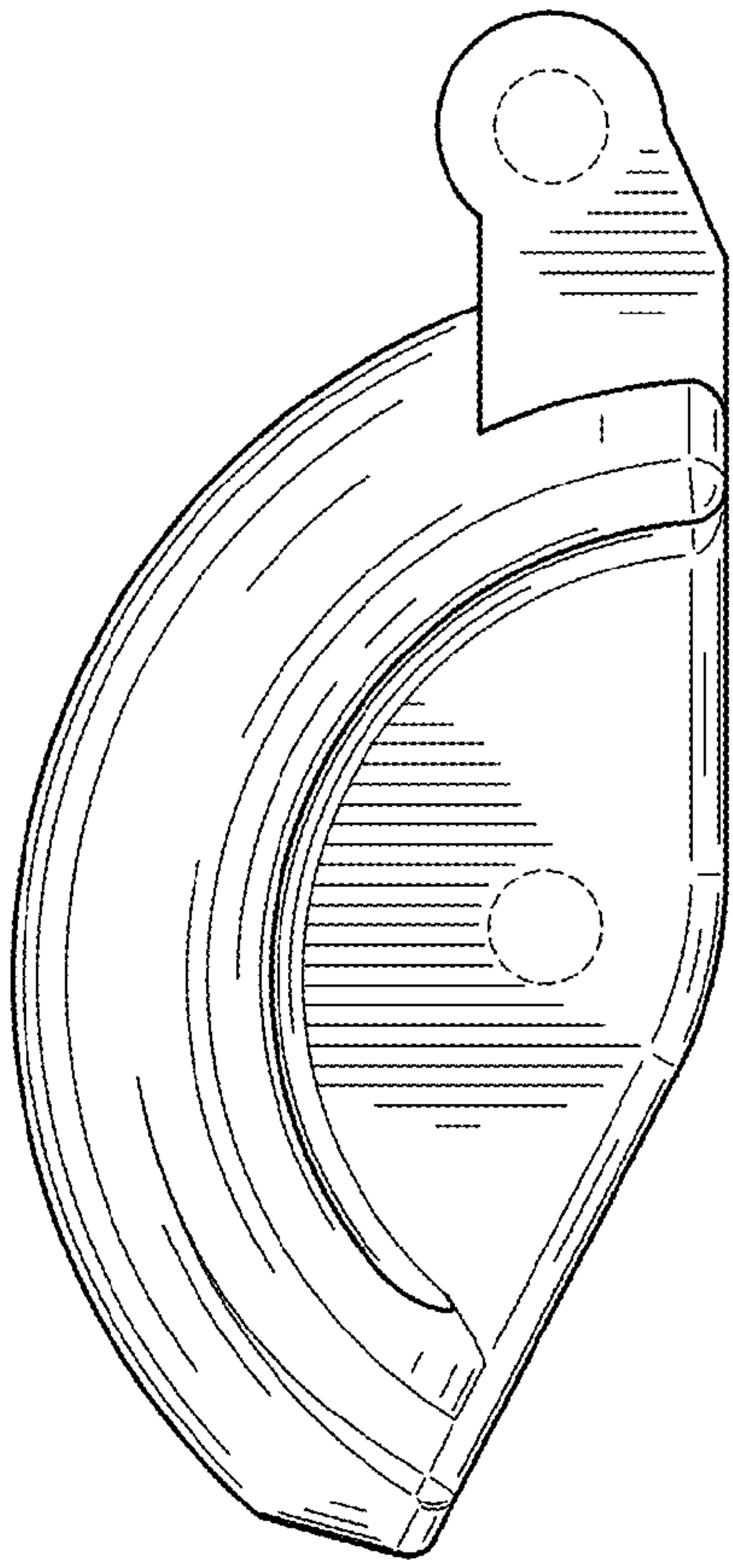

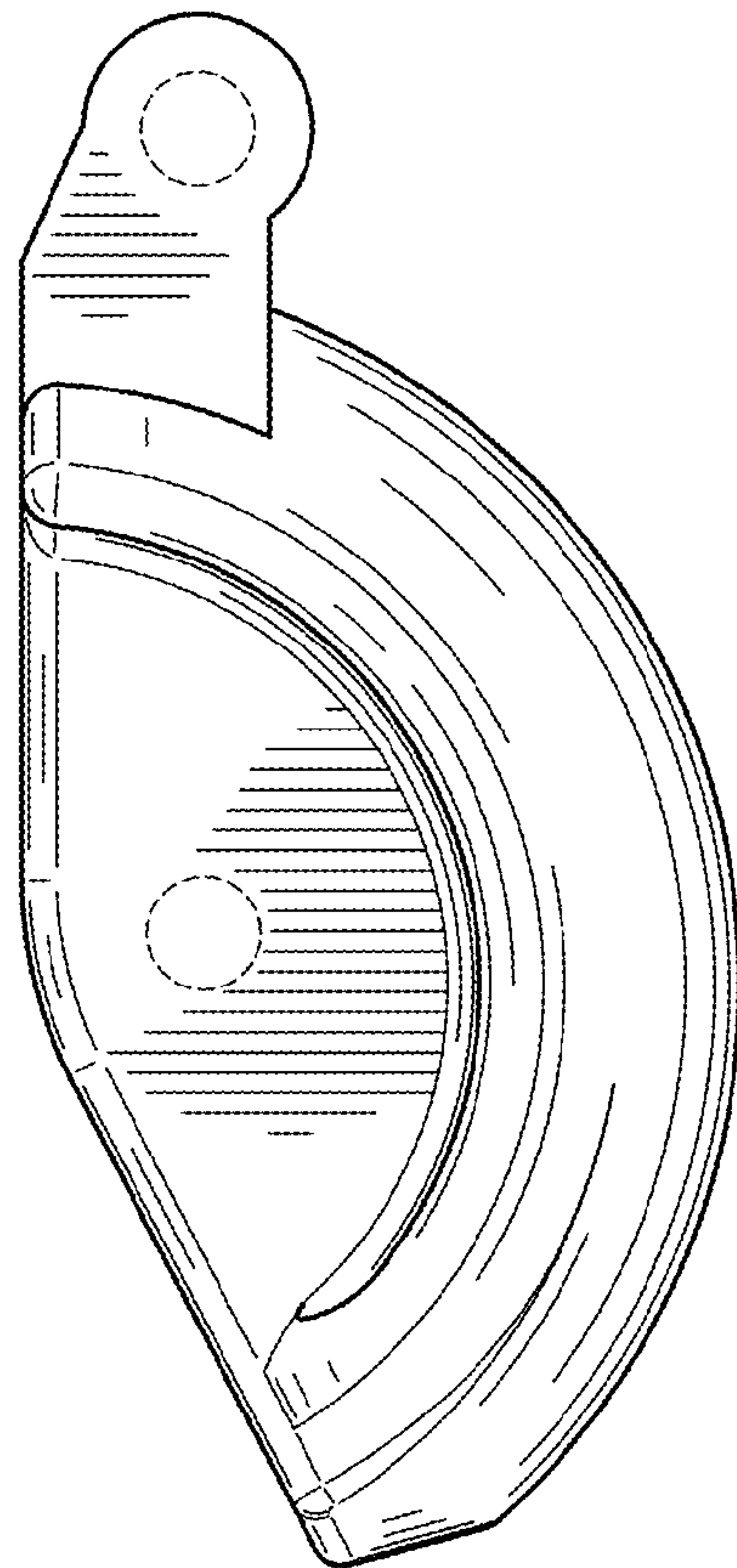

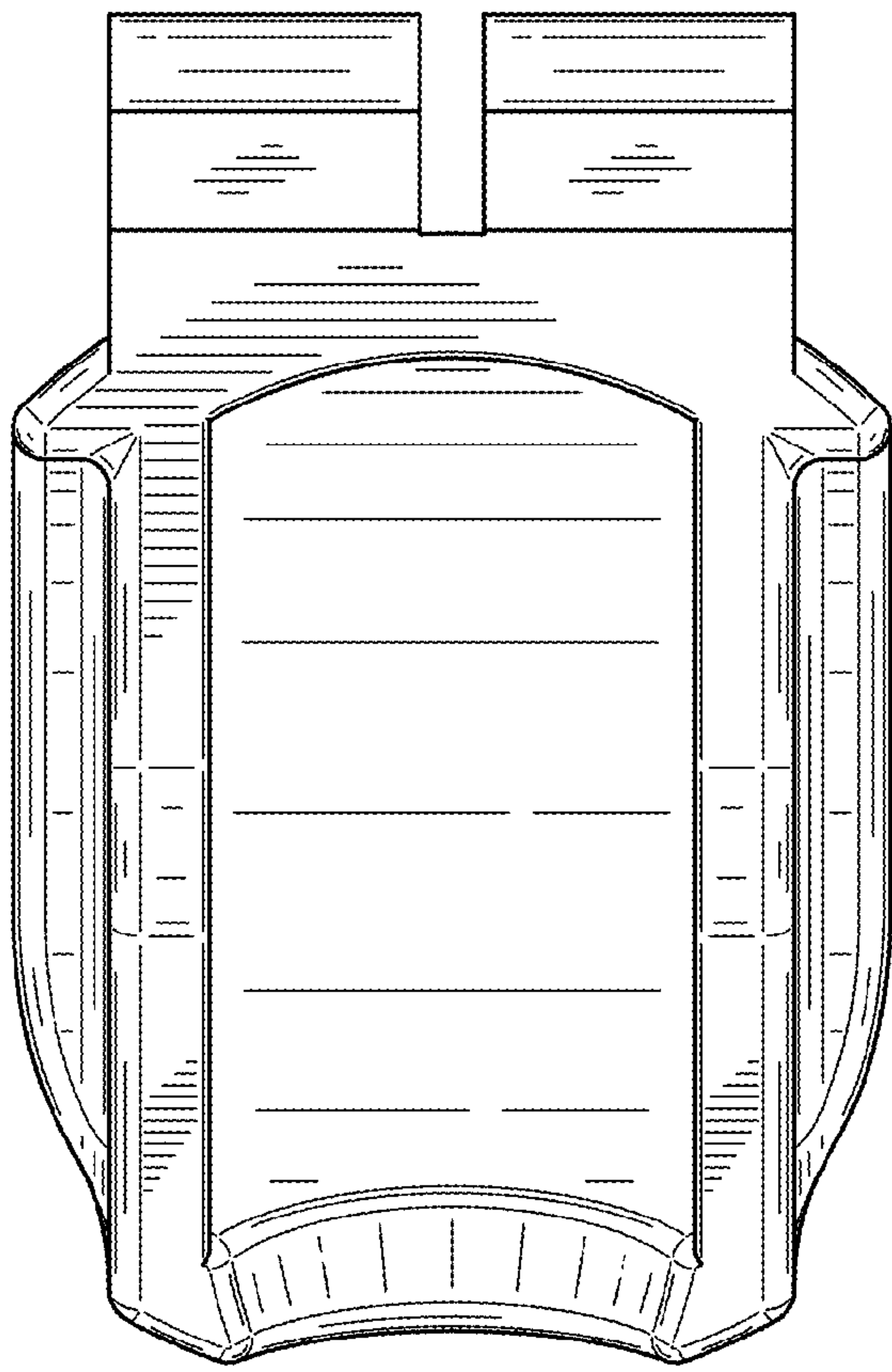

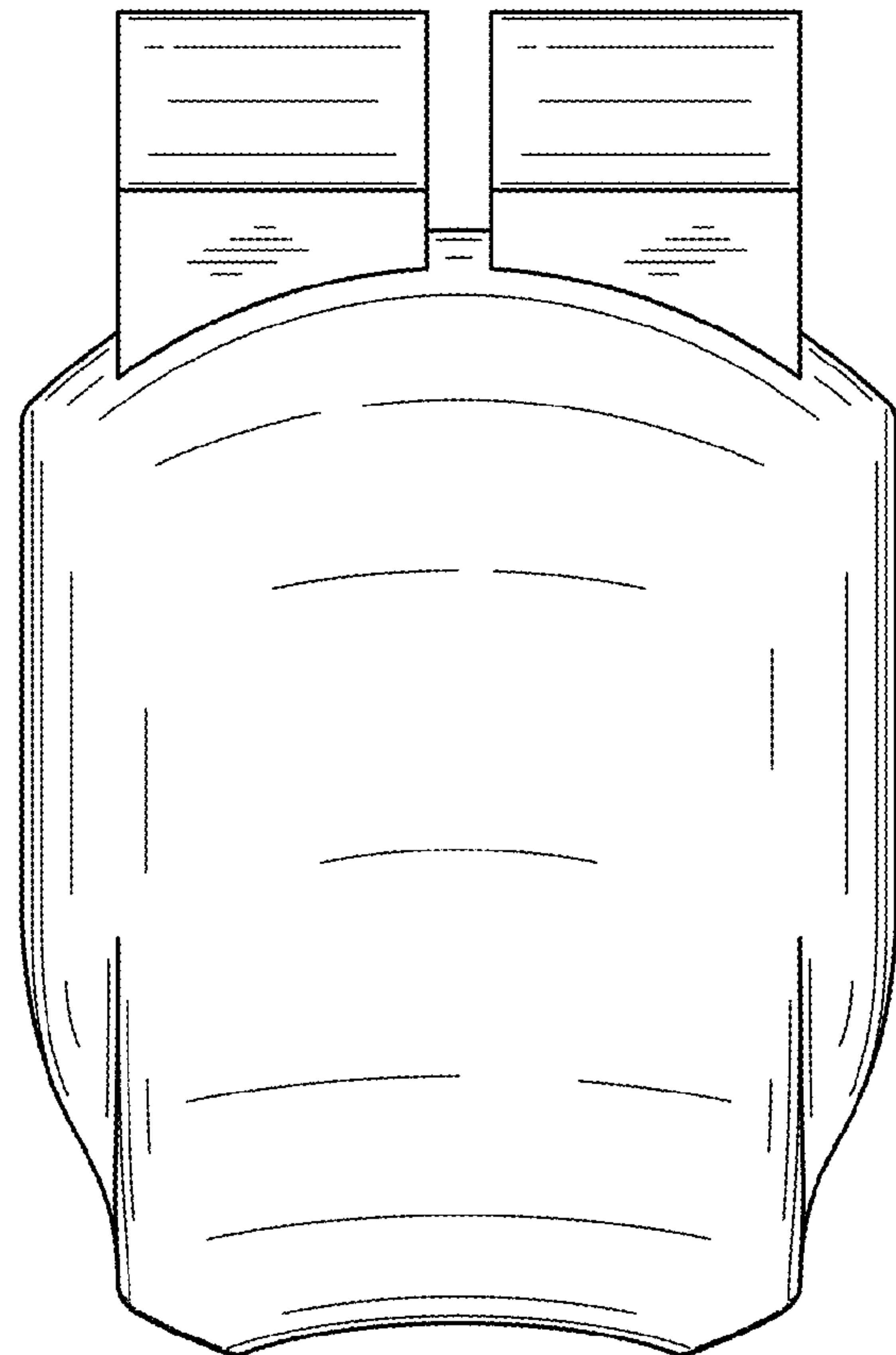

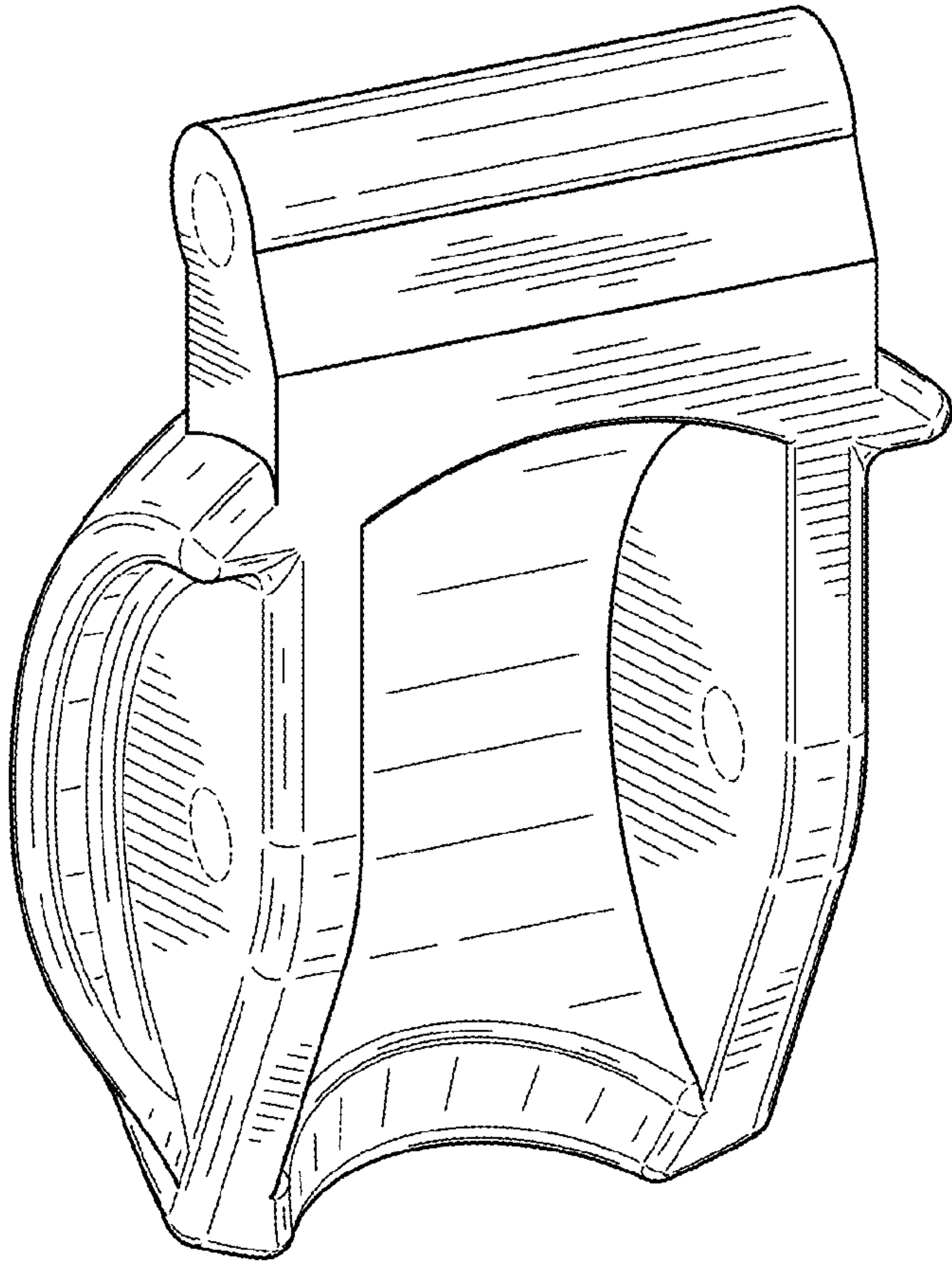

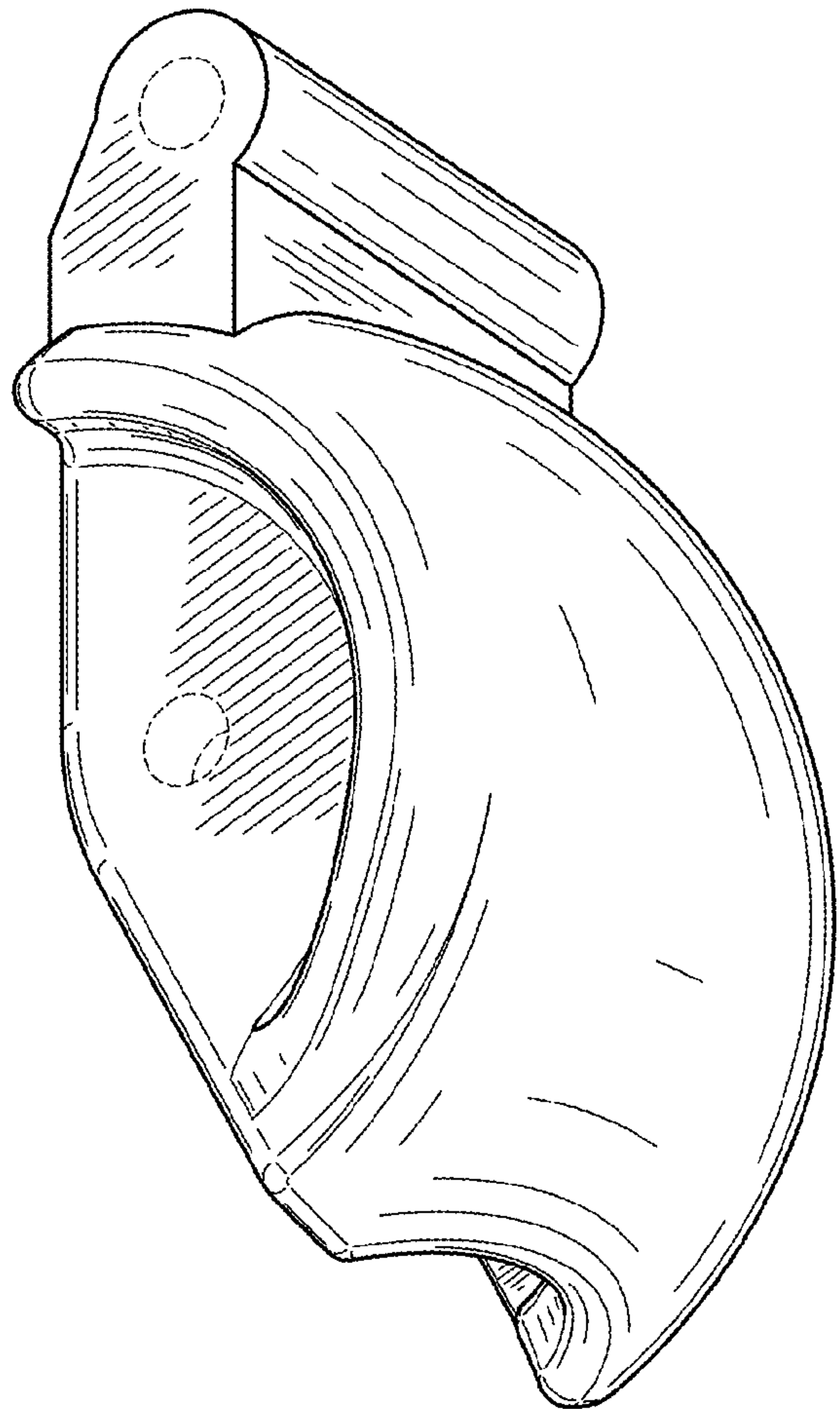

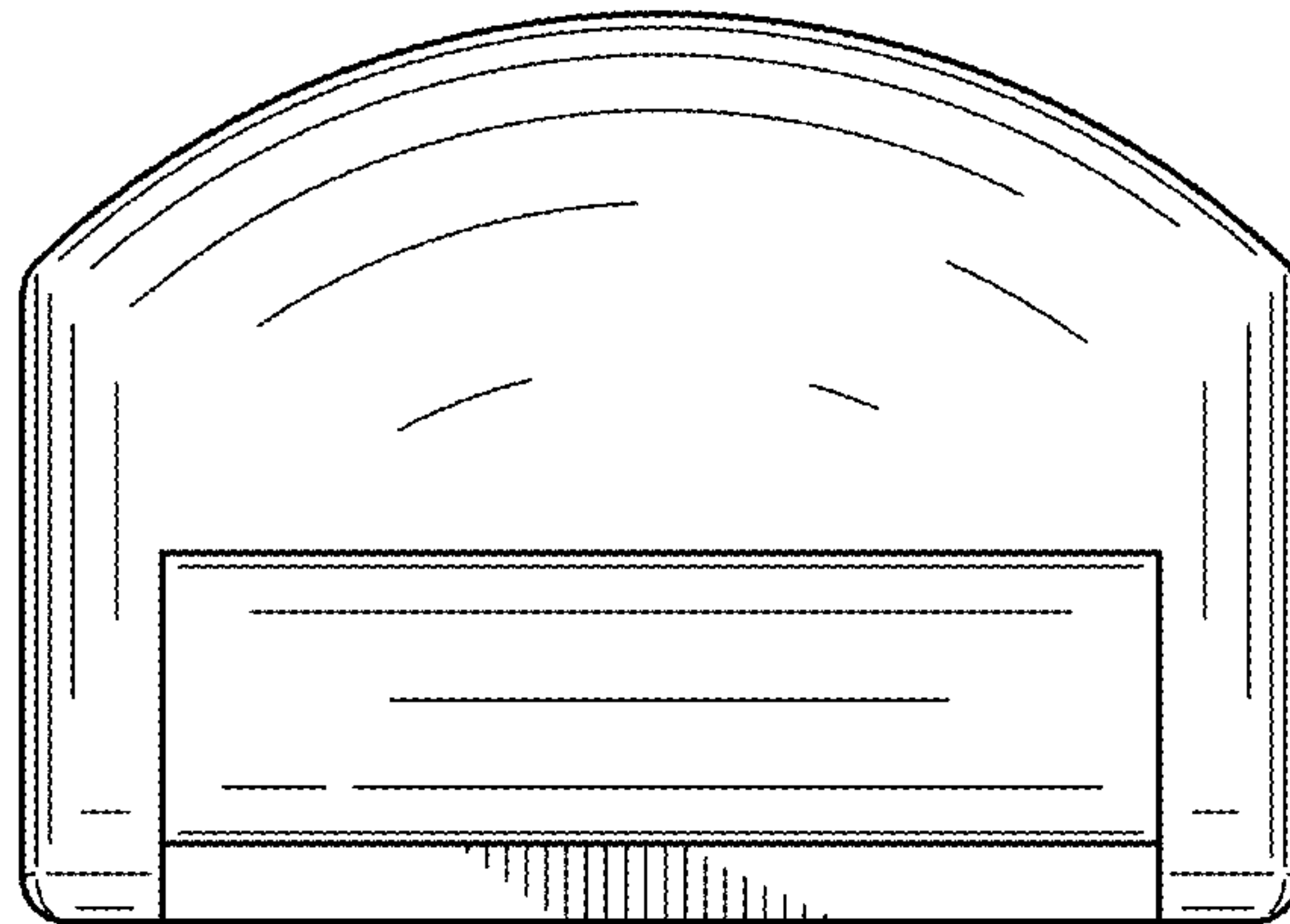

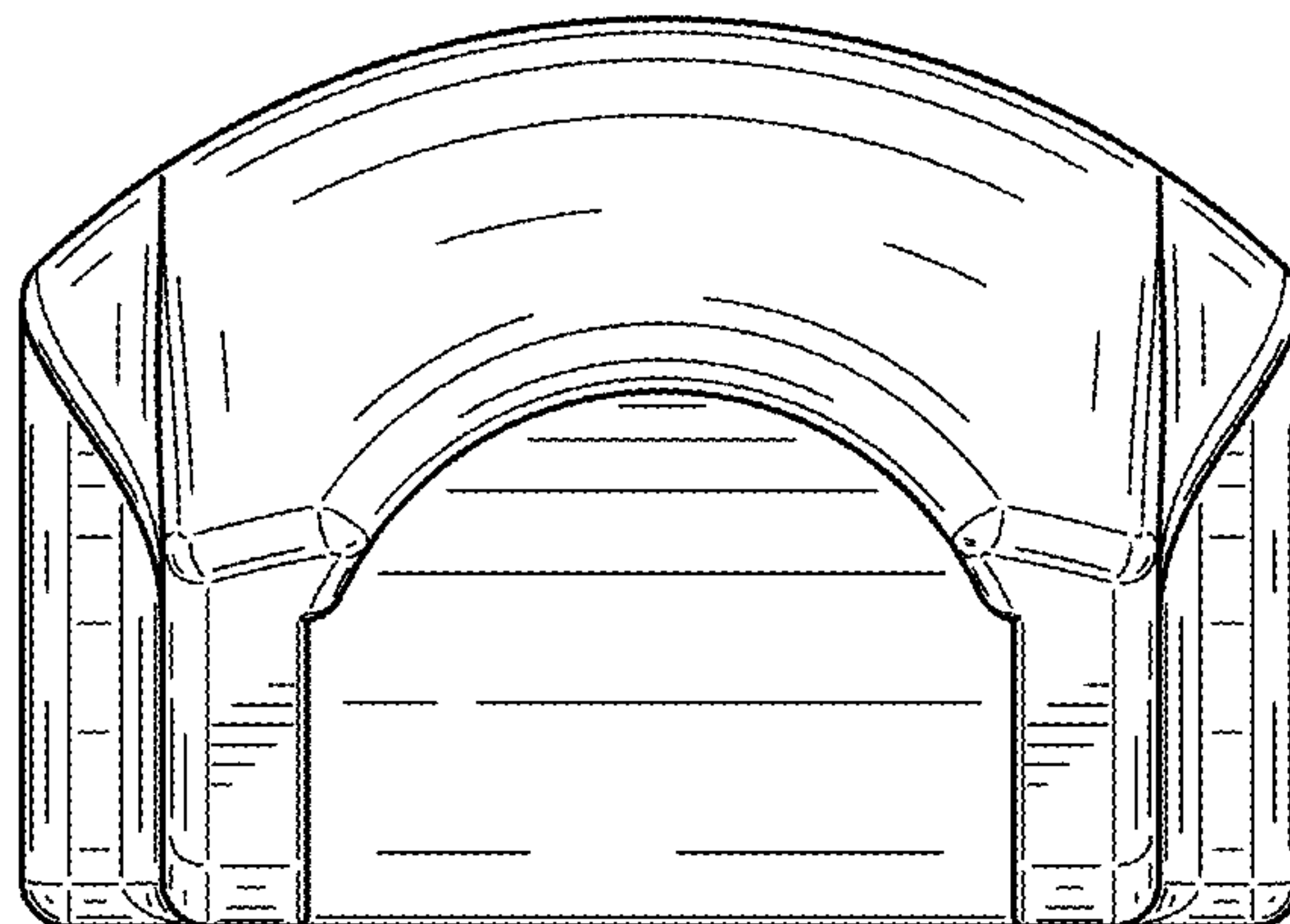

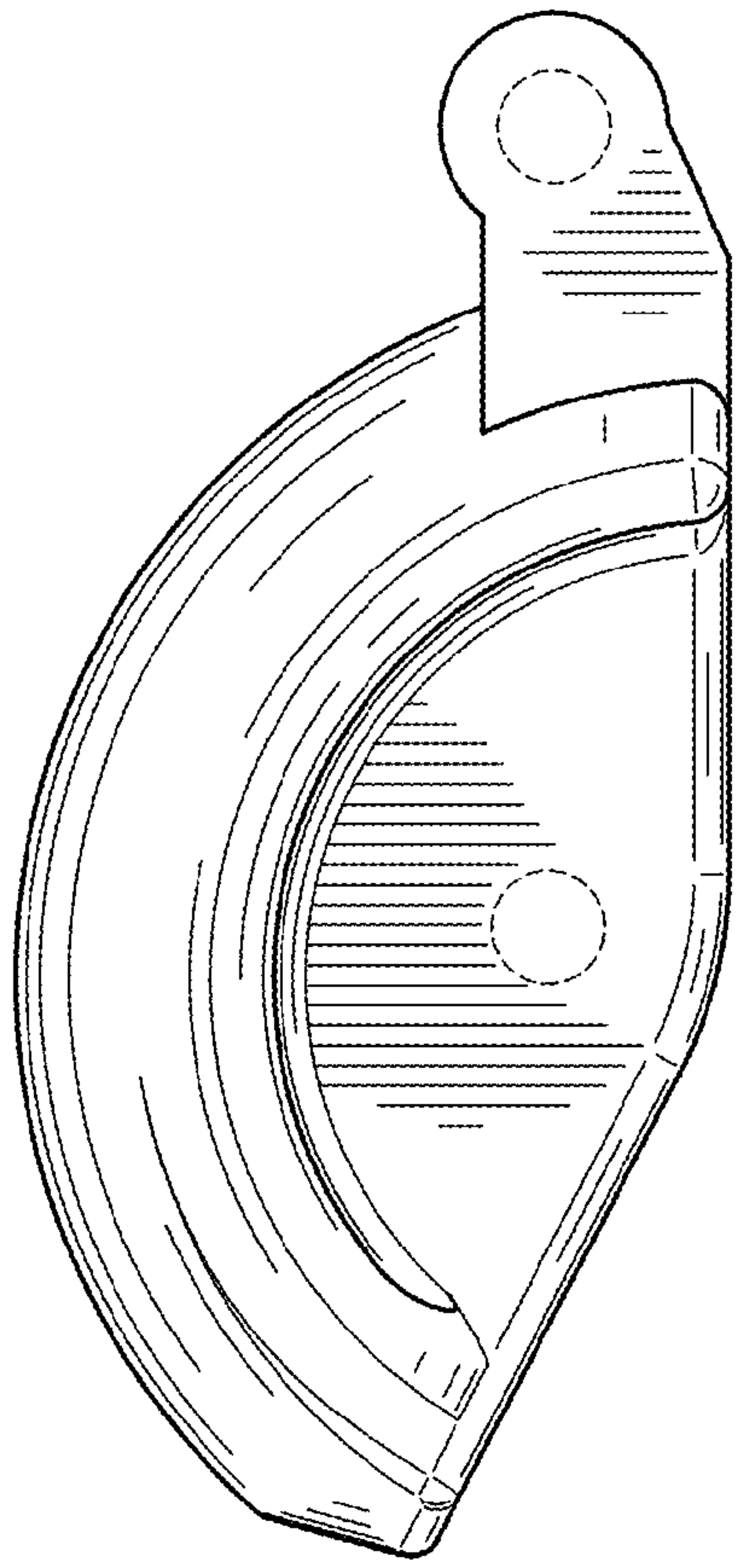

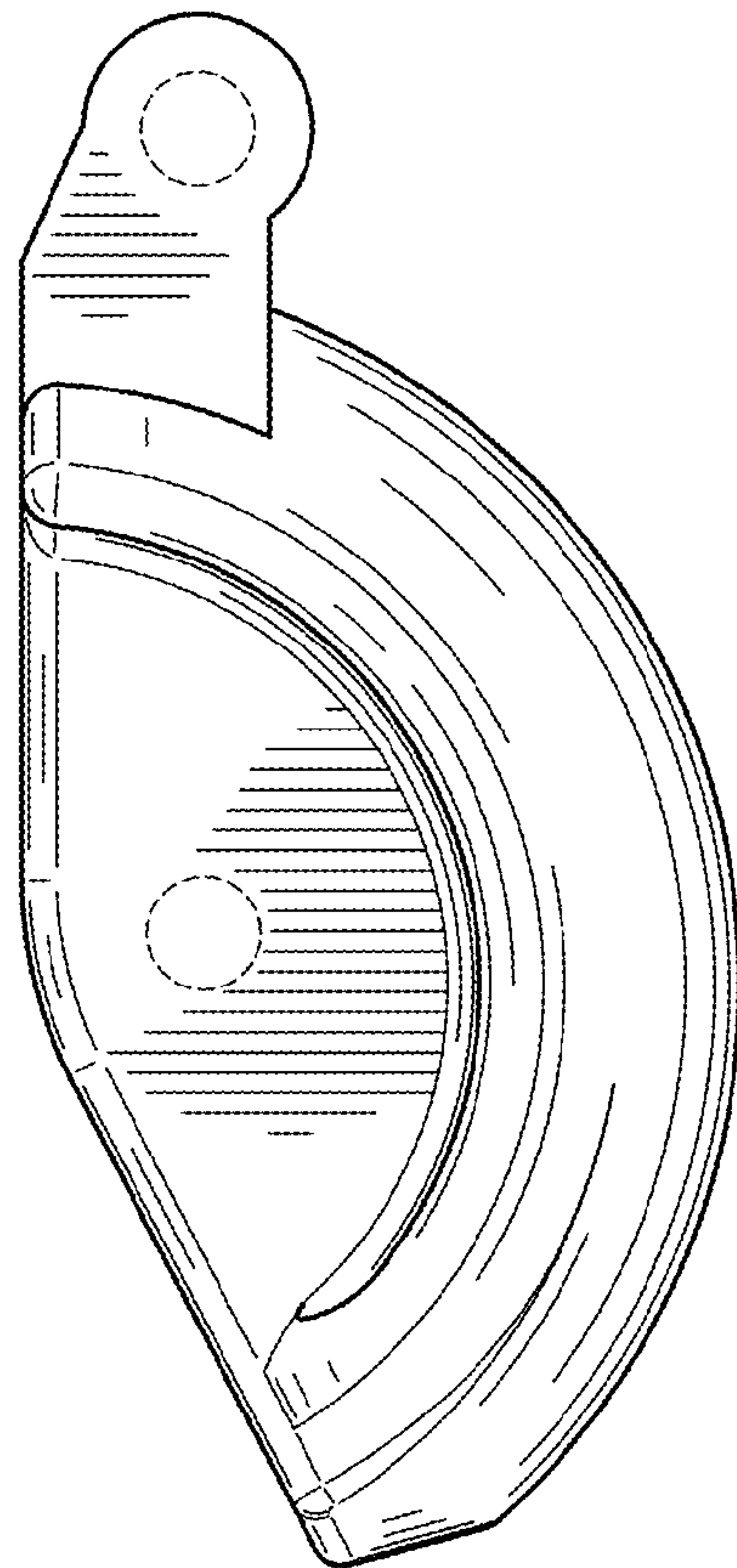

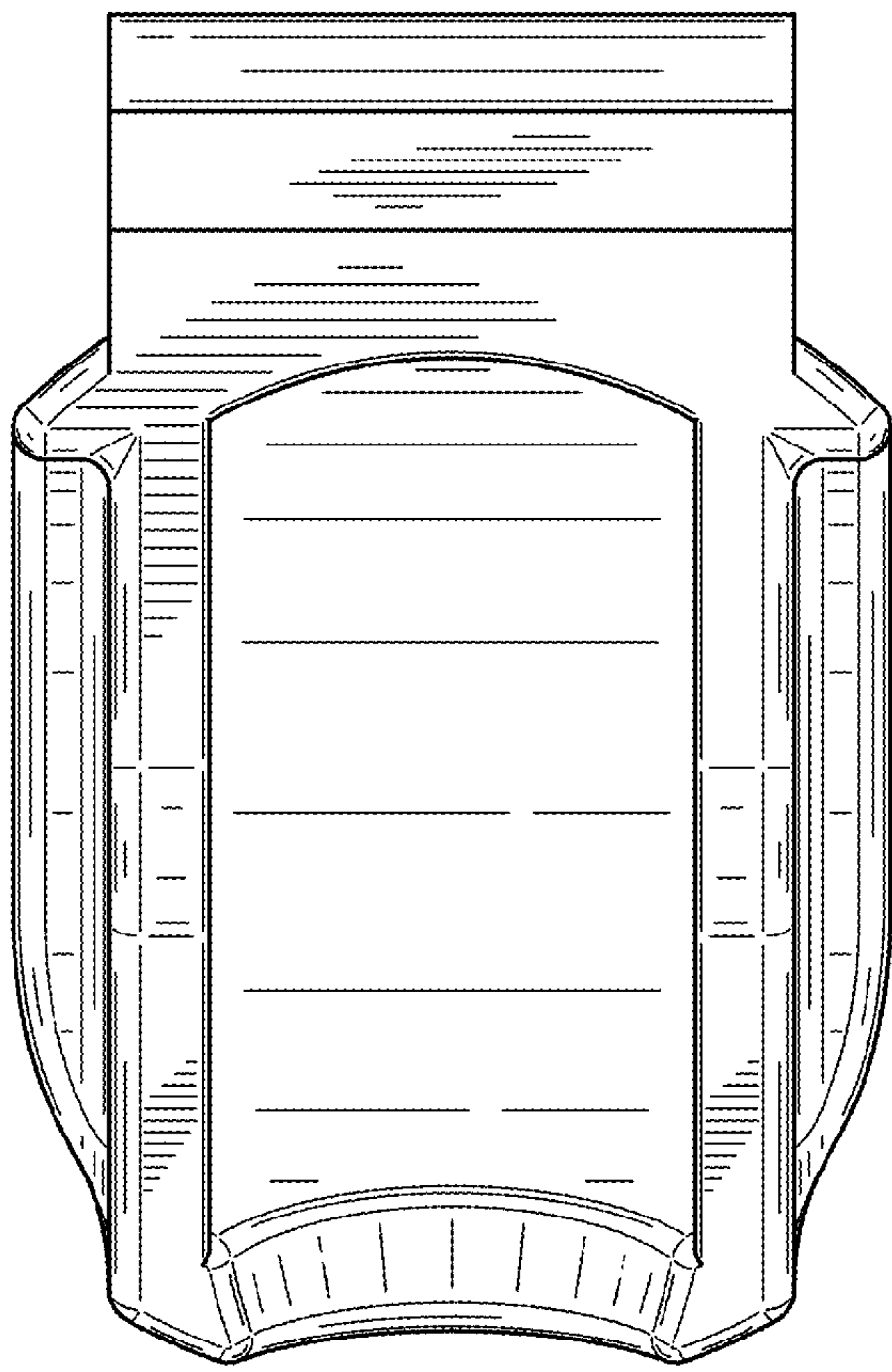

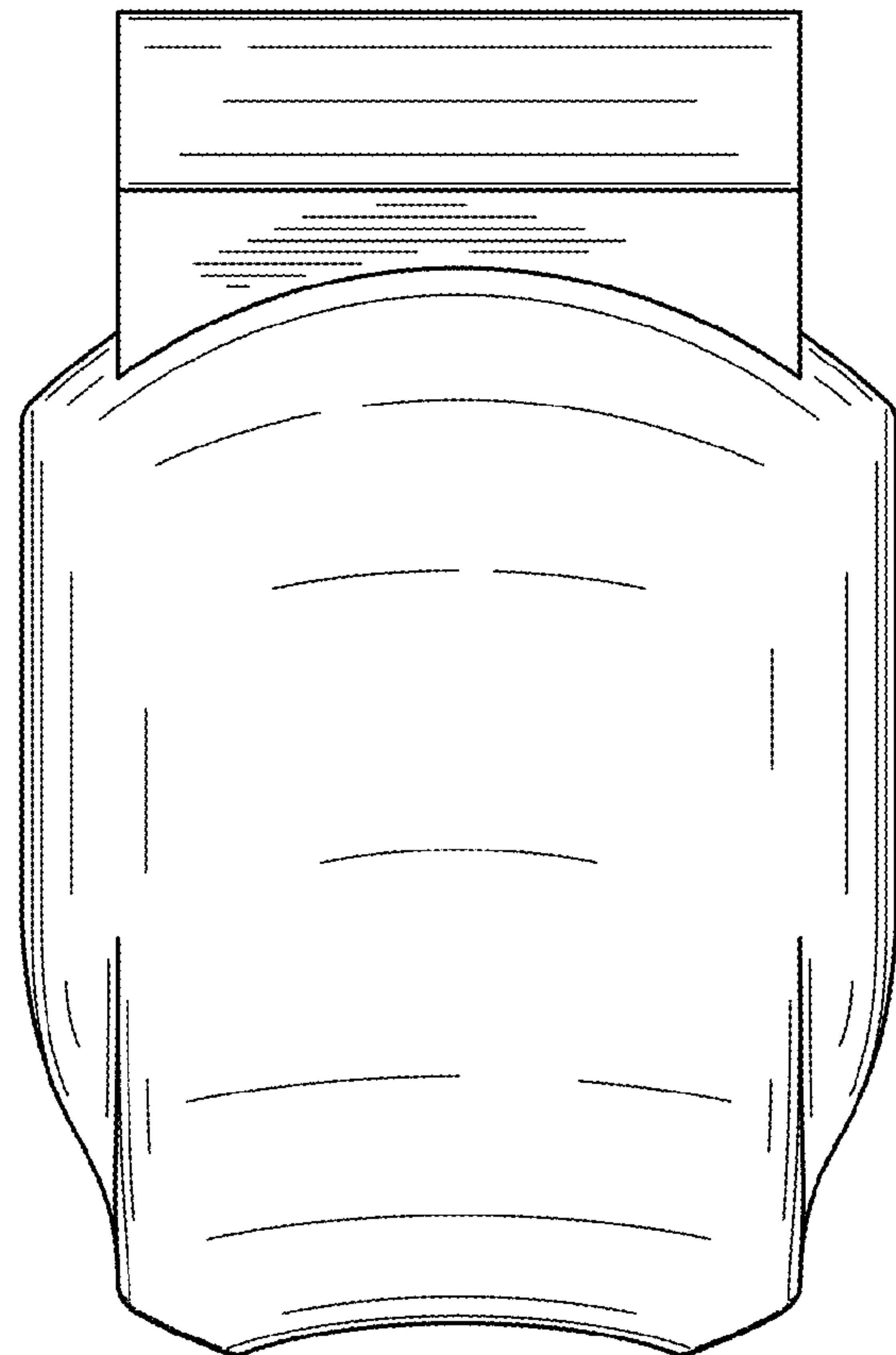
