(57) **CLAIM**

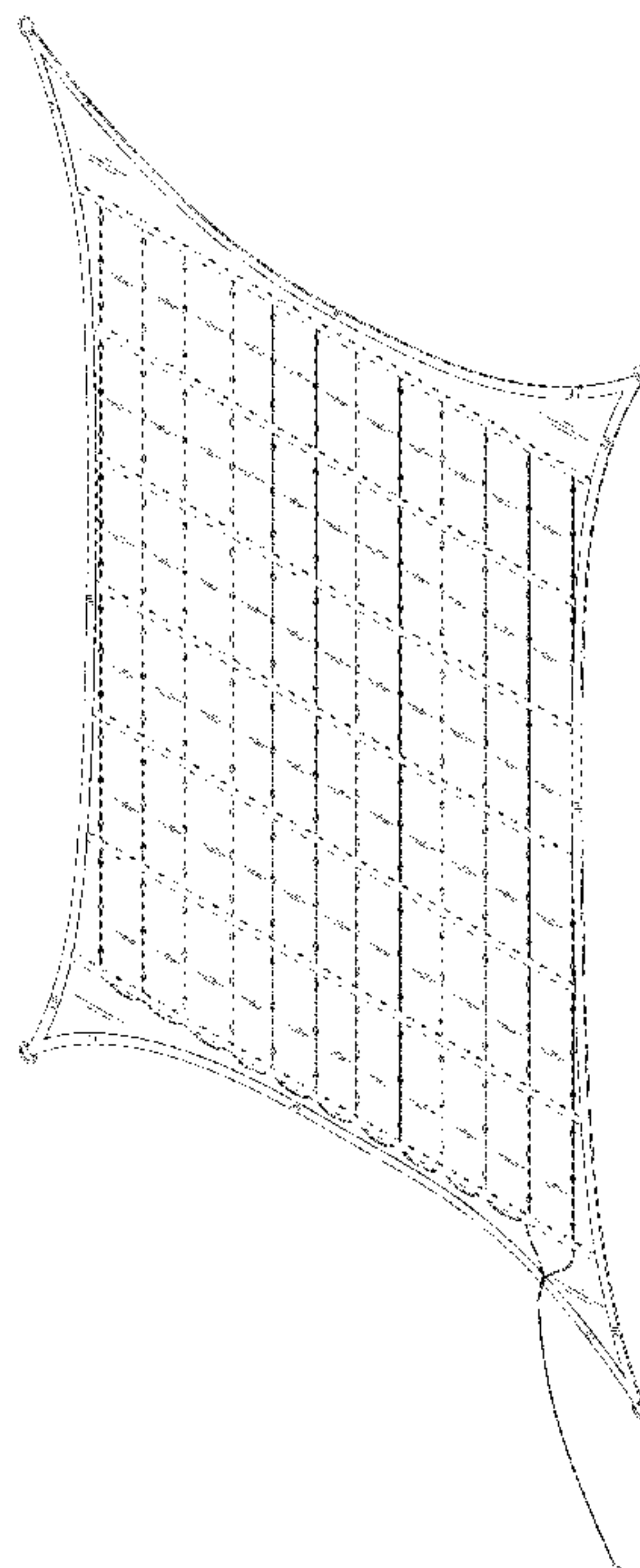
The ornamental design for a canopy with lights, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a canopy with lights, showing my new design;
FIG. 2 is a rear and bottom perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof; and,
FIG. 5 is an enlarged perspective view of detail "5" identified in FIG. 3.

The dashed lines in the figures illustrate portions of the canopy with lights that form no part of the claimed design. The dash dot dash lines in FIGS. 3 and 5 are for the purpose of depicting the boundary lines of the enlarged view and form no part of the claimed design.

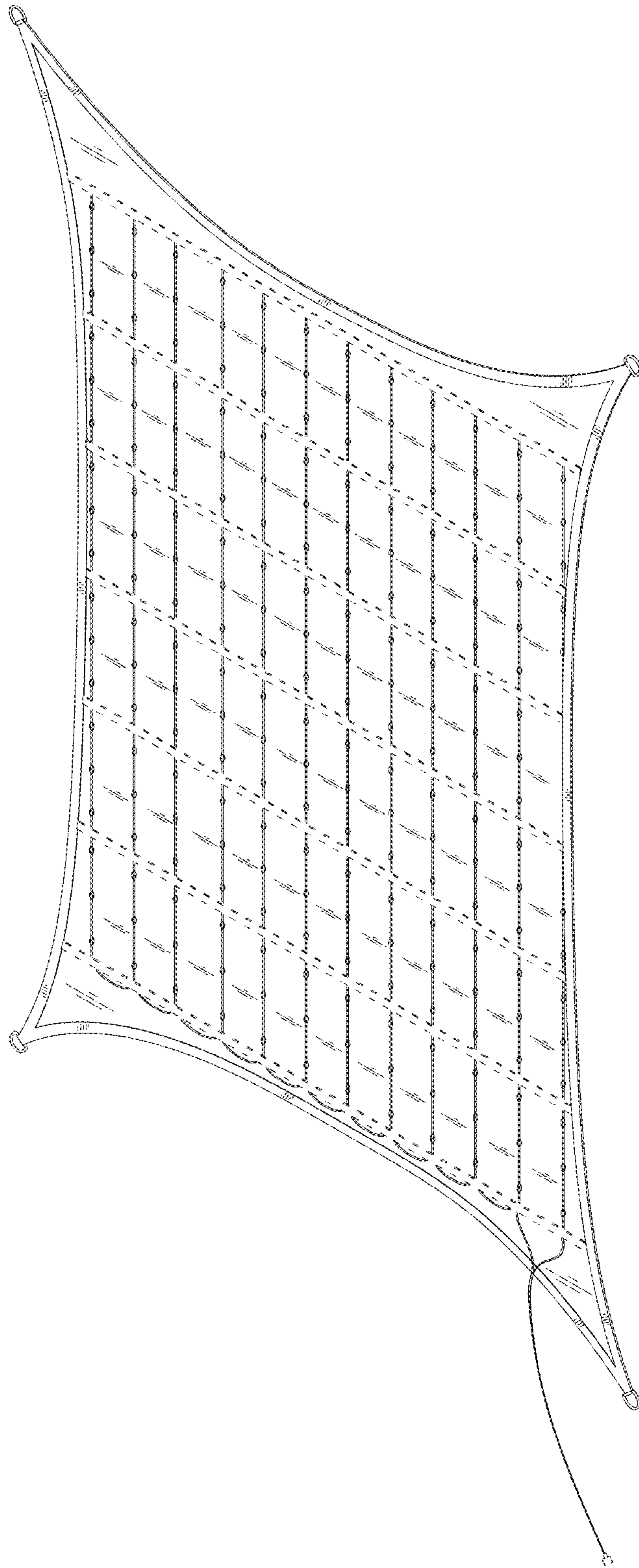

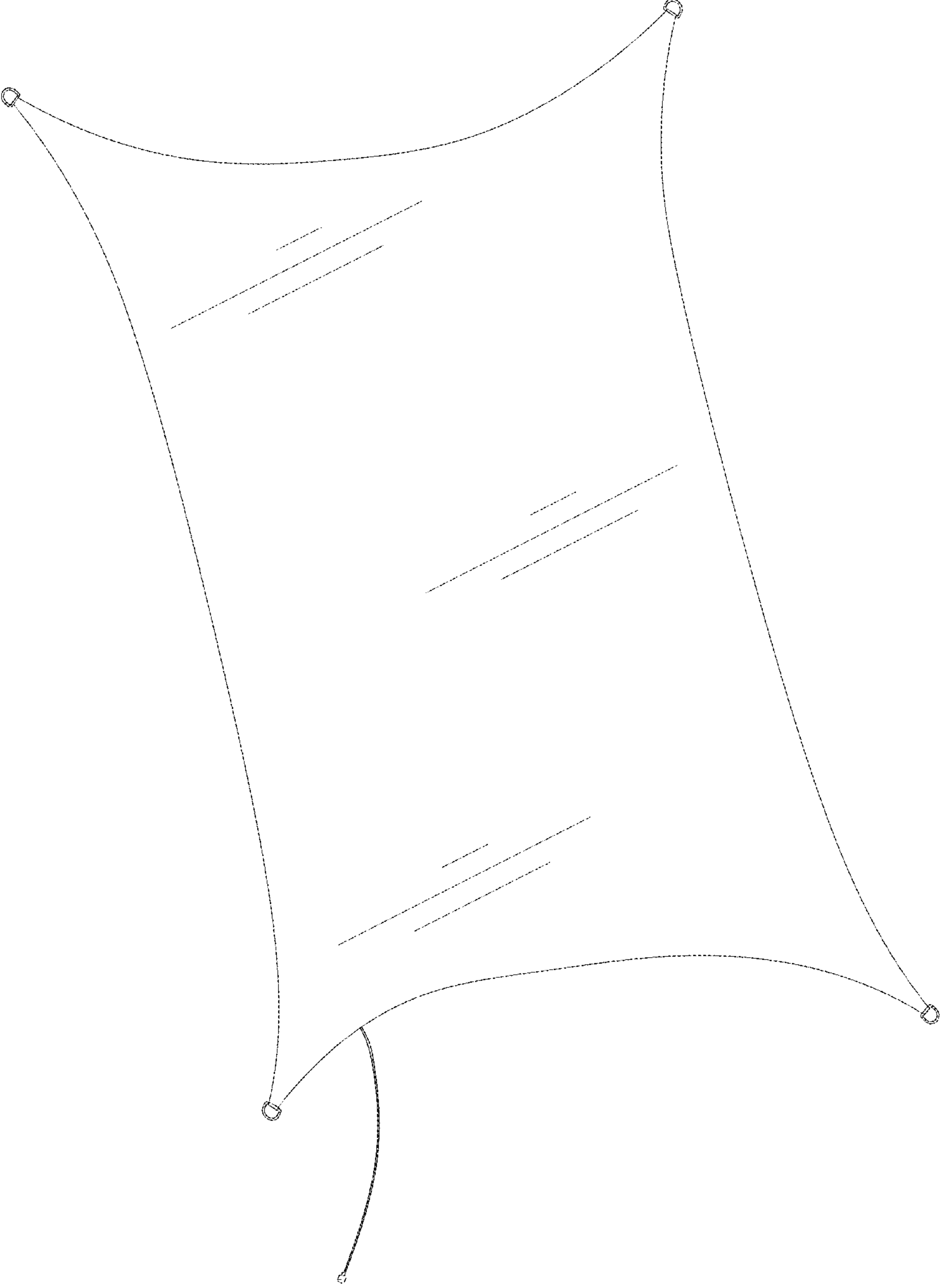

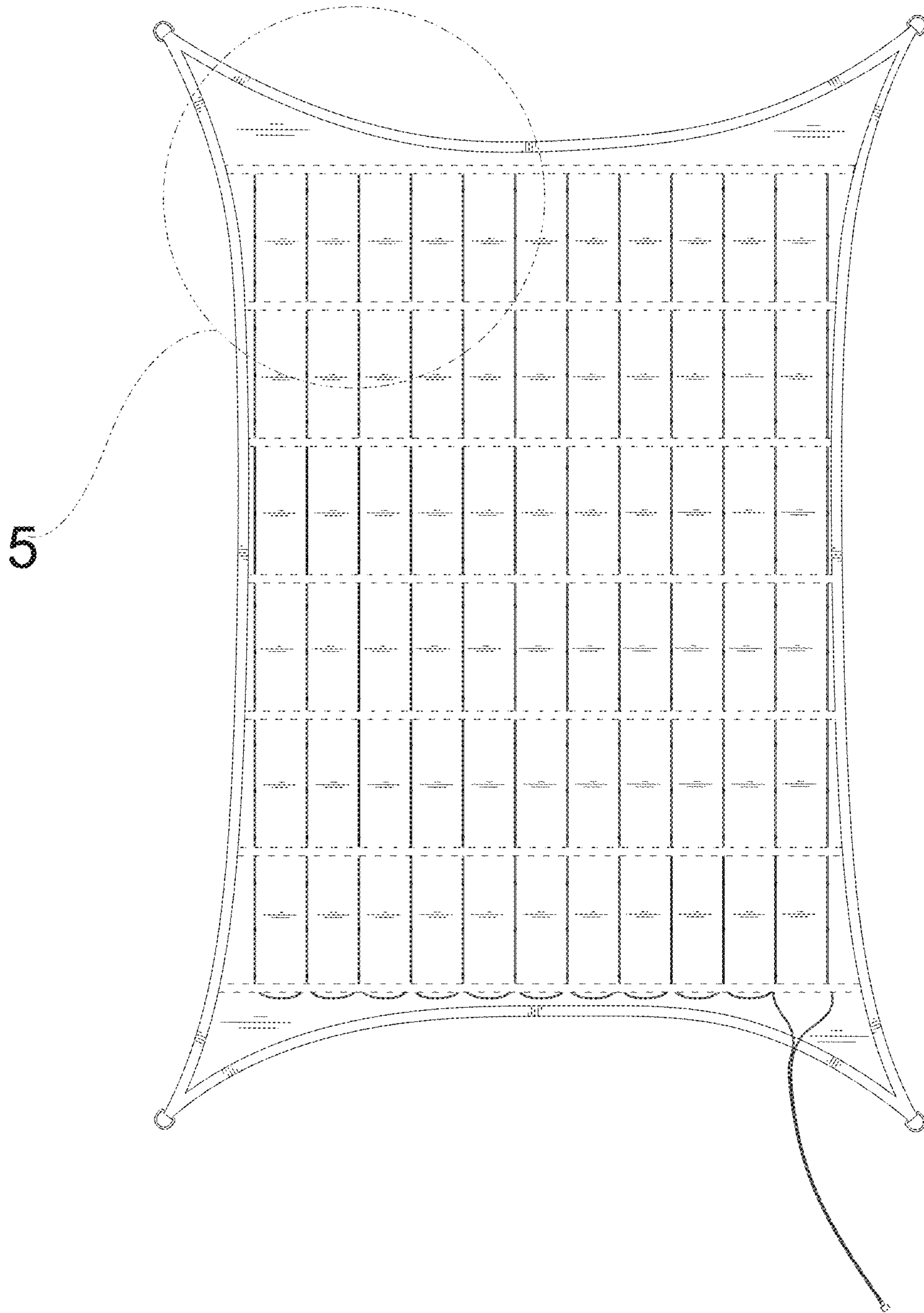

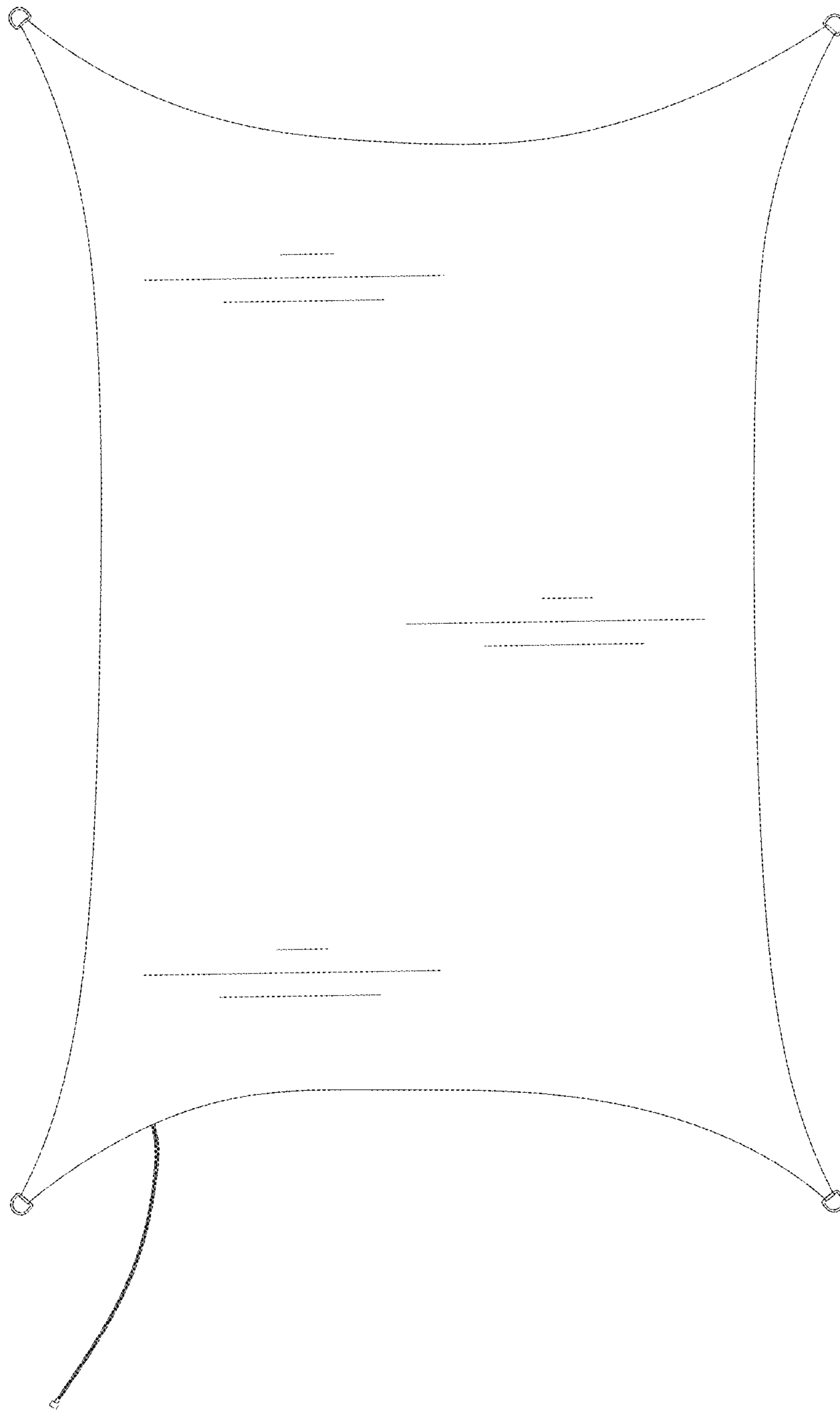

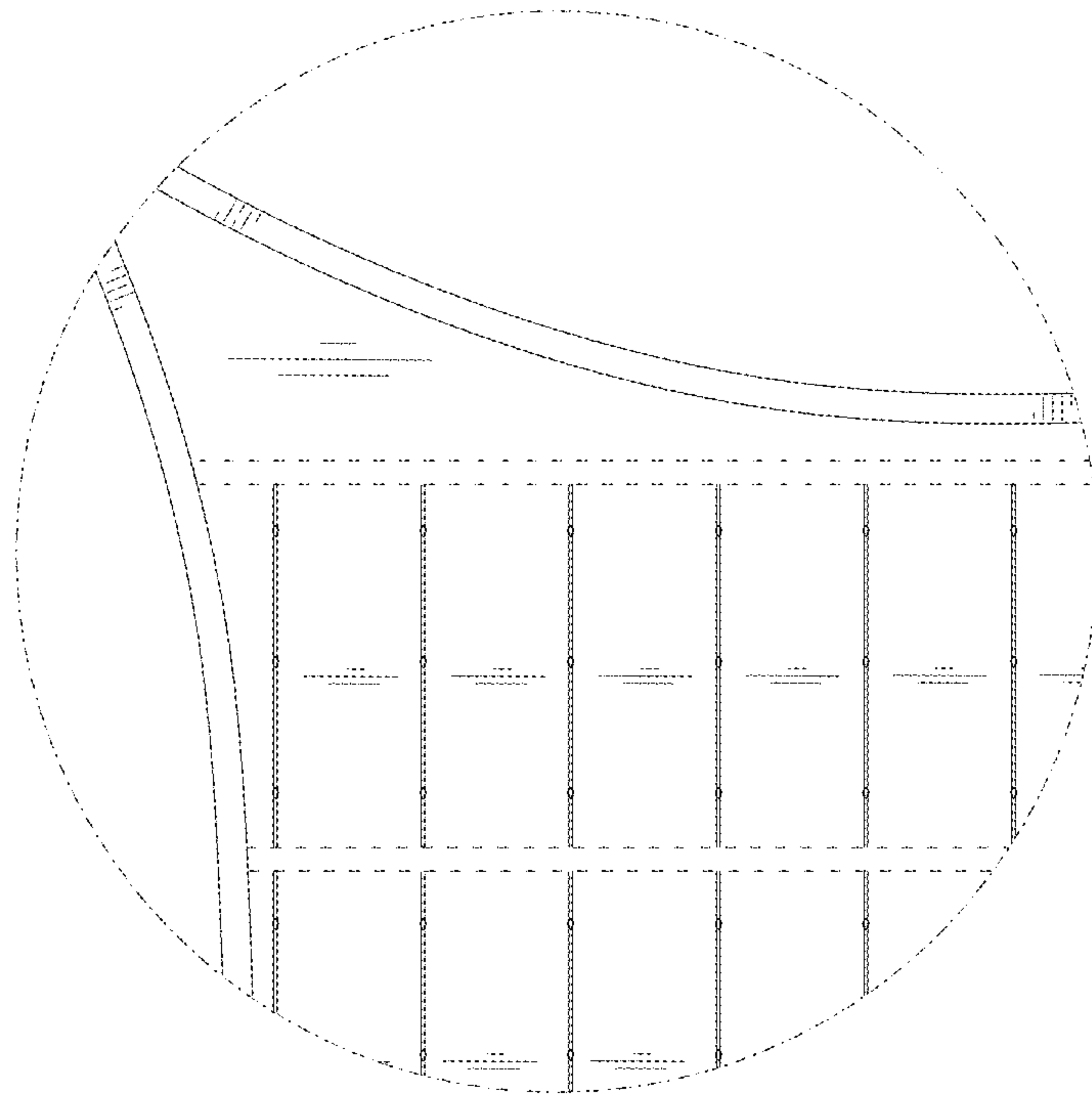
