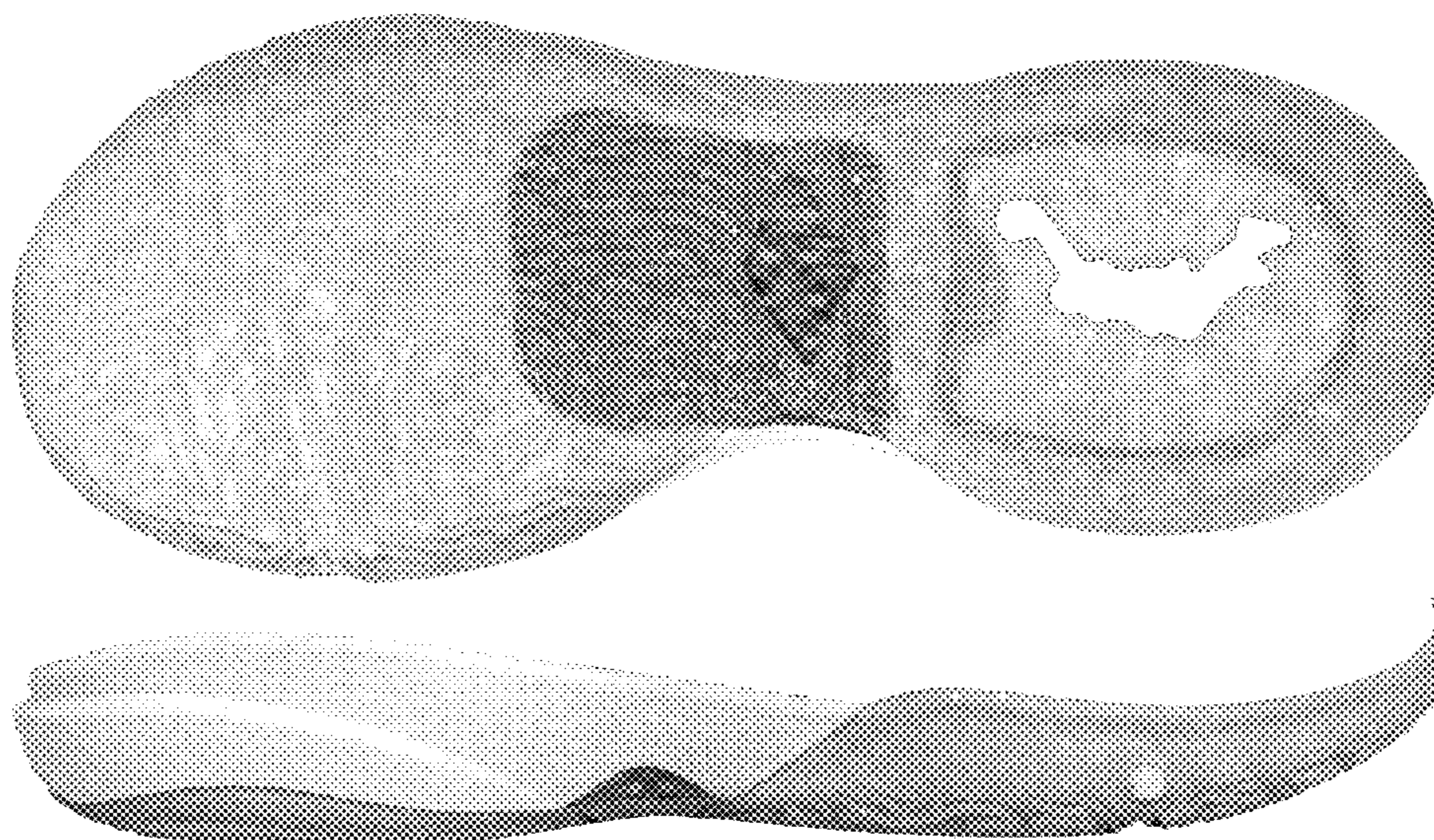
(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a photographic front bottom perspective view of an embodiment of a shoe; midsole and outsole, showing my new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a front view thereof; and,  
FIG. 6 is a rear view thereof.  
The broken lines depict features of the shoe that form no part of the claimed design.

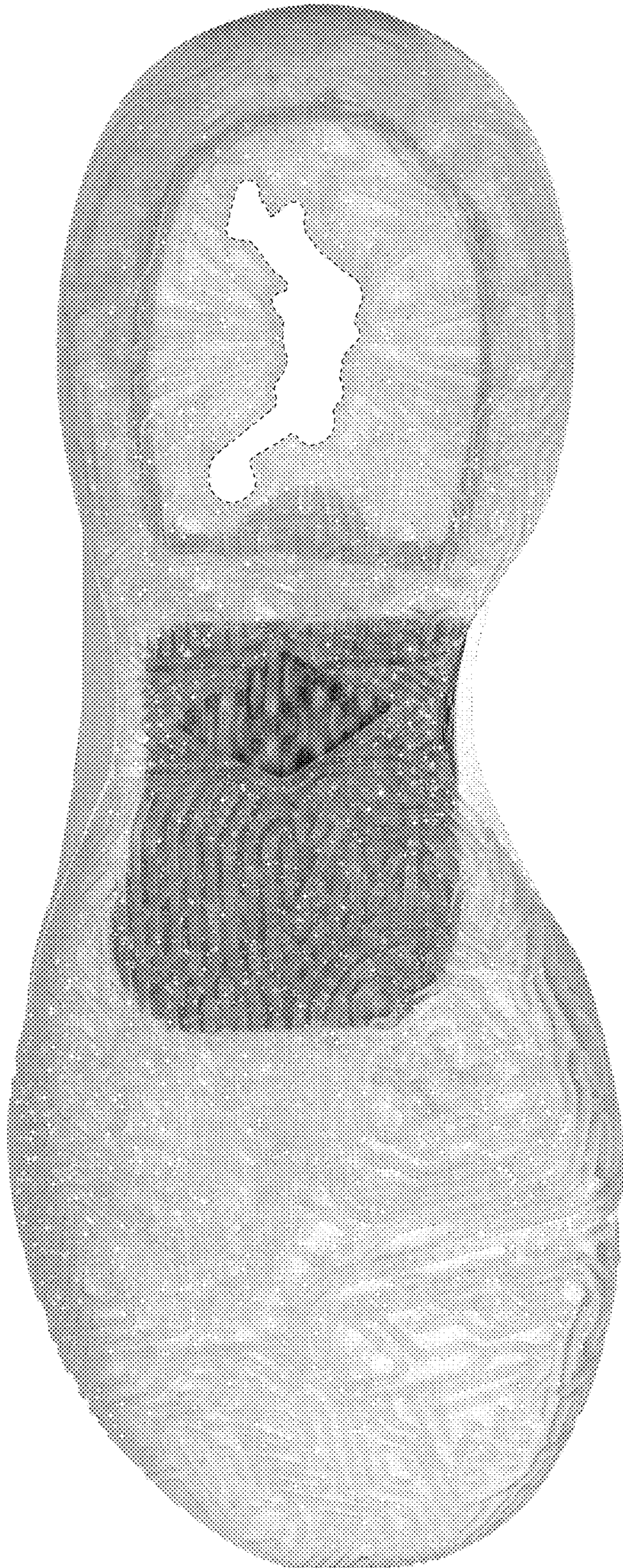

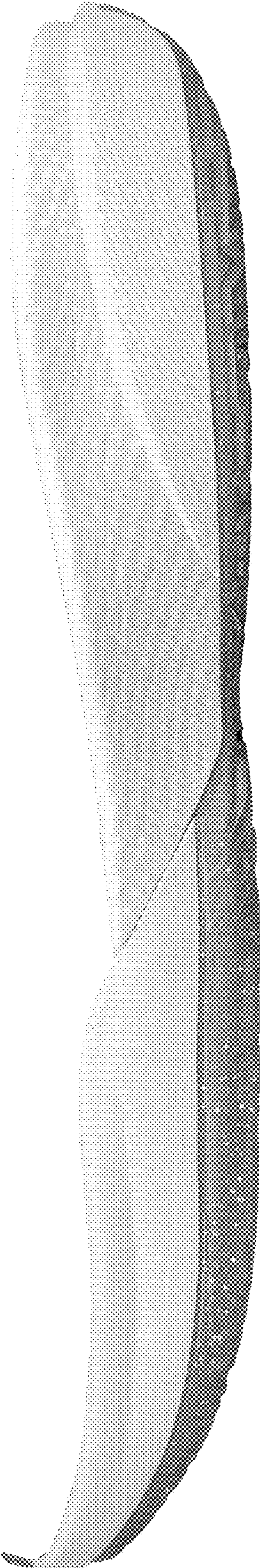

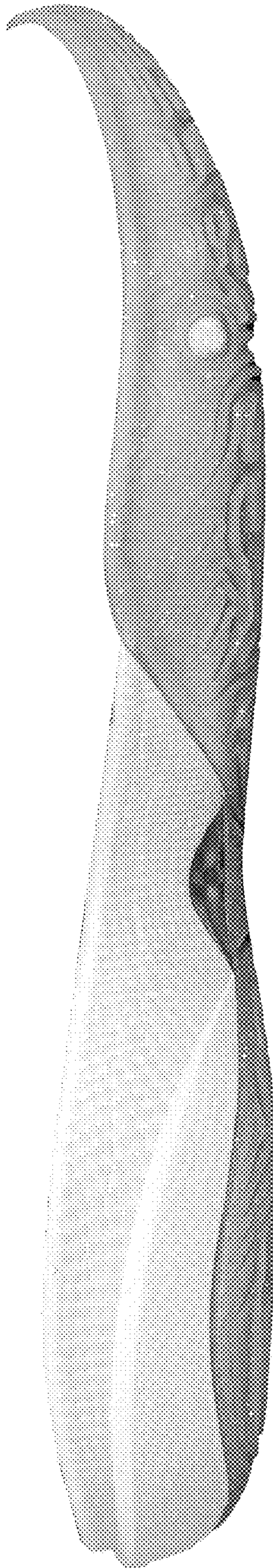

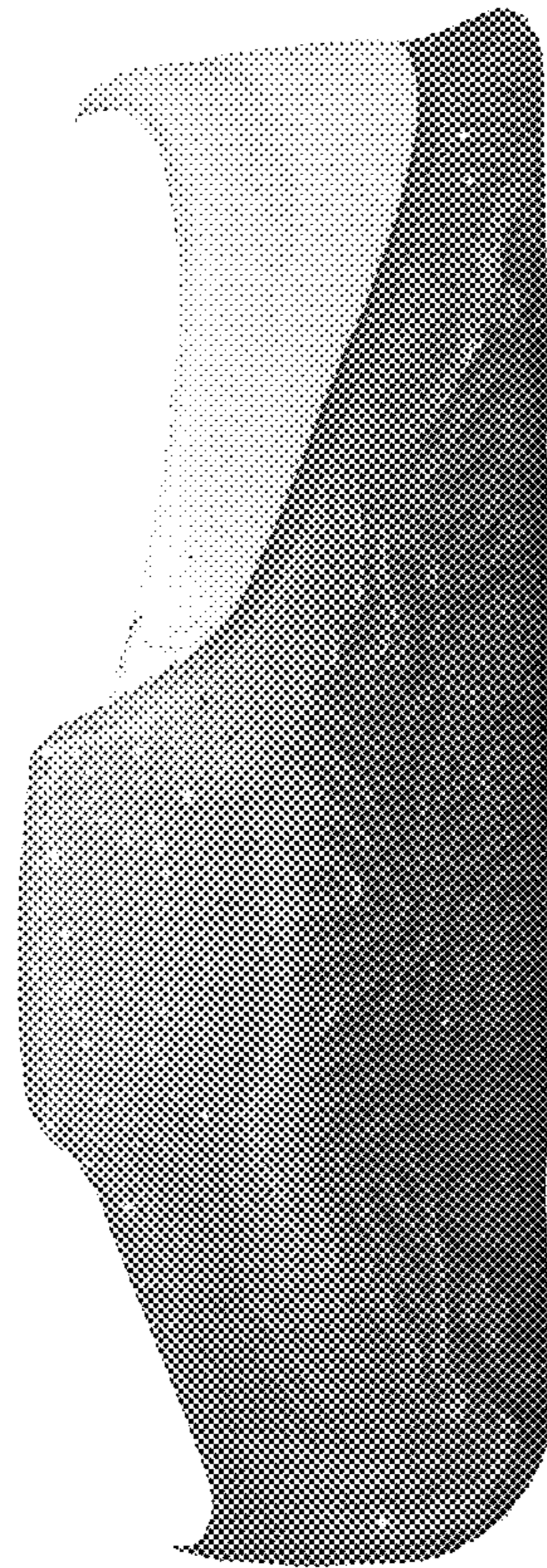
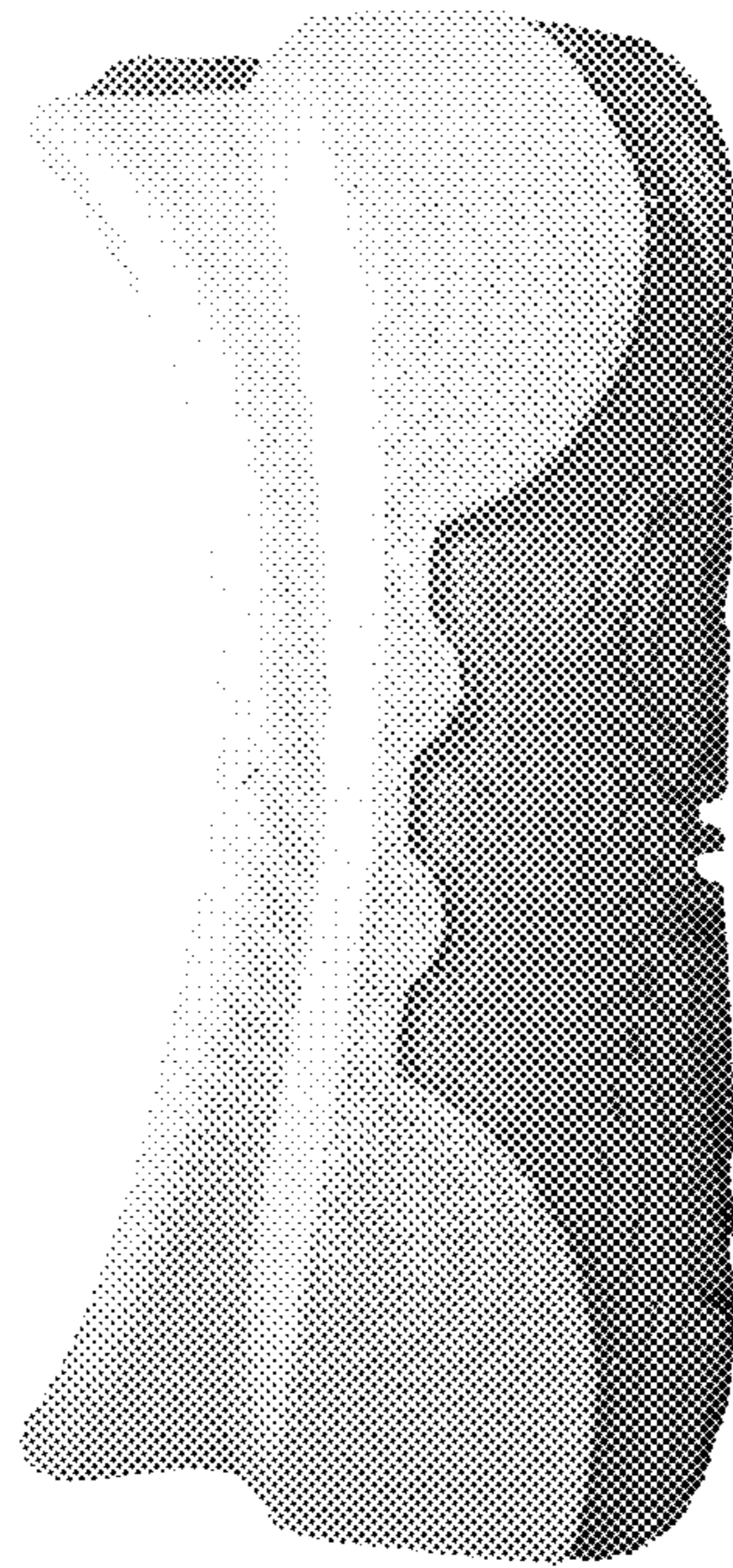
