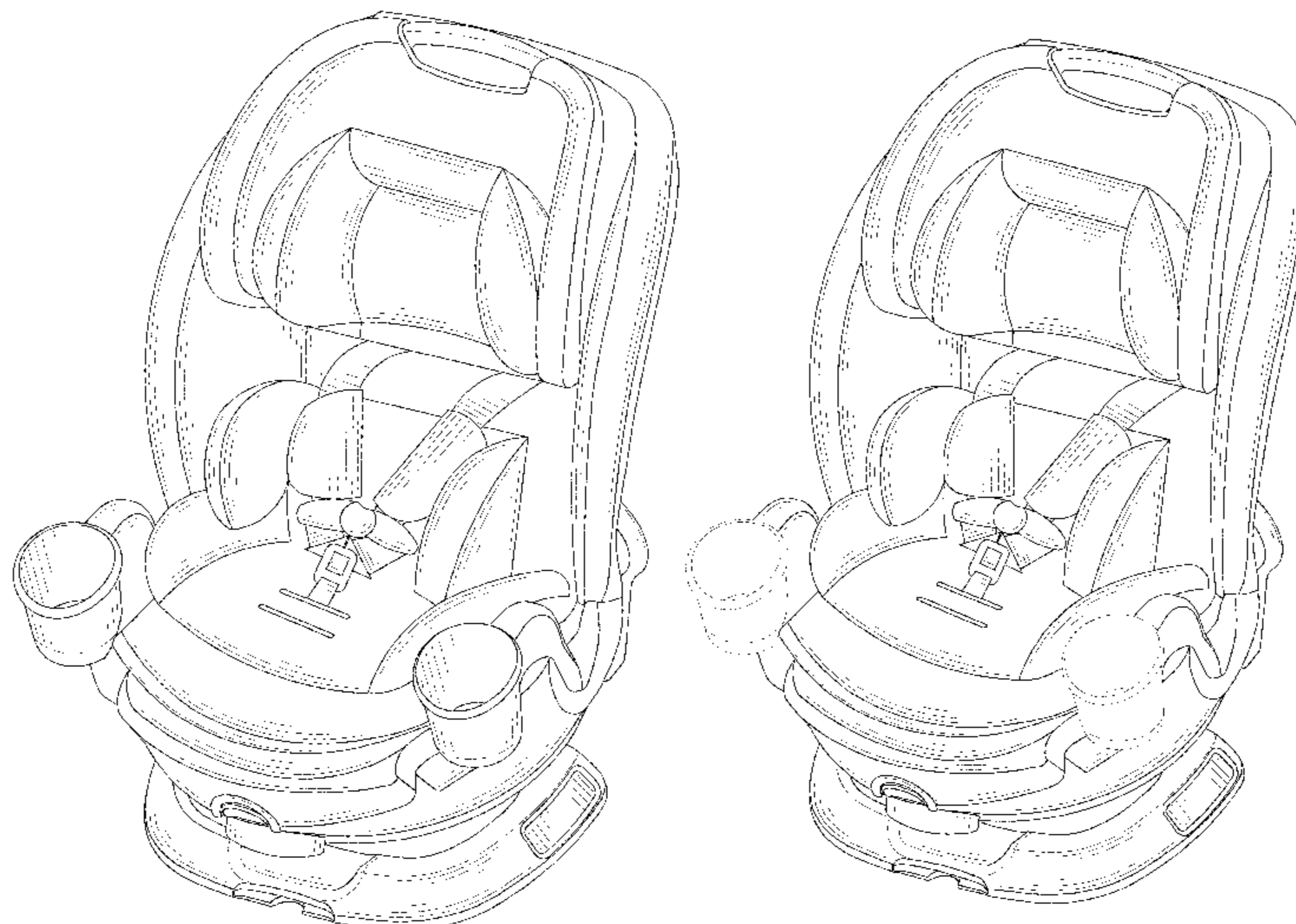
(57) **CLAIM**

The ornamental design for a safety seat, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, and top perspective view of a safety seat, according to an embodiment of our new design; FIG. 2 is a front elevation view of thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is another front, right, and top perspective view of the safety seat of FIG. 1, showing a state where the upper seat is rotated by 180°; FIG. 9 is a rear, left, and top perspective view of the safety seat of FIG. 1, showing the state where the upper seat is rotated by 180°; FIG. 10 is a front, right, and top perspective view of a safety seat, according to an embodiment of our new design; FIG. 11 is a front elevation view of thereof; FIG. 12 is a rear elevation view thereof; FIG. 13 is a left side view thereof; FIG. 14 is a right side view thereof; FIG. 15 is a top view thereof; FIG. 16 is a bottom view thereof; FIG. 17 is another front, right, and top perspective view of the safety seat of FIG. 10, showing a state where the upper seat is rotated by 180°; and, FIG. 18 is a rear, left, and top perspective view of the safety seat of FIG. 10, showing the state where the upper seat is rotated by 180°. The broken line portions of the safety seat in FIGS. 10-18 represent unclaimed portions of the claimed design and form no part thereof.

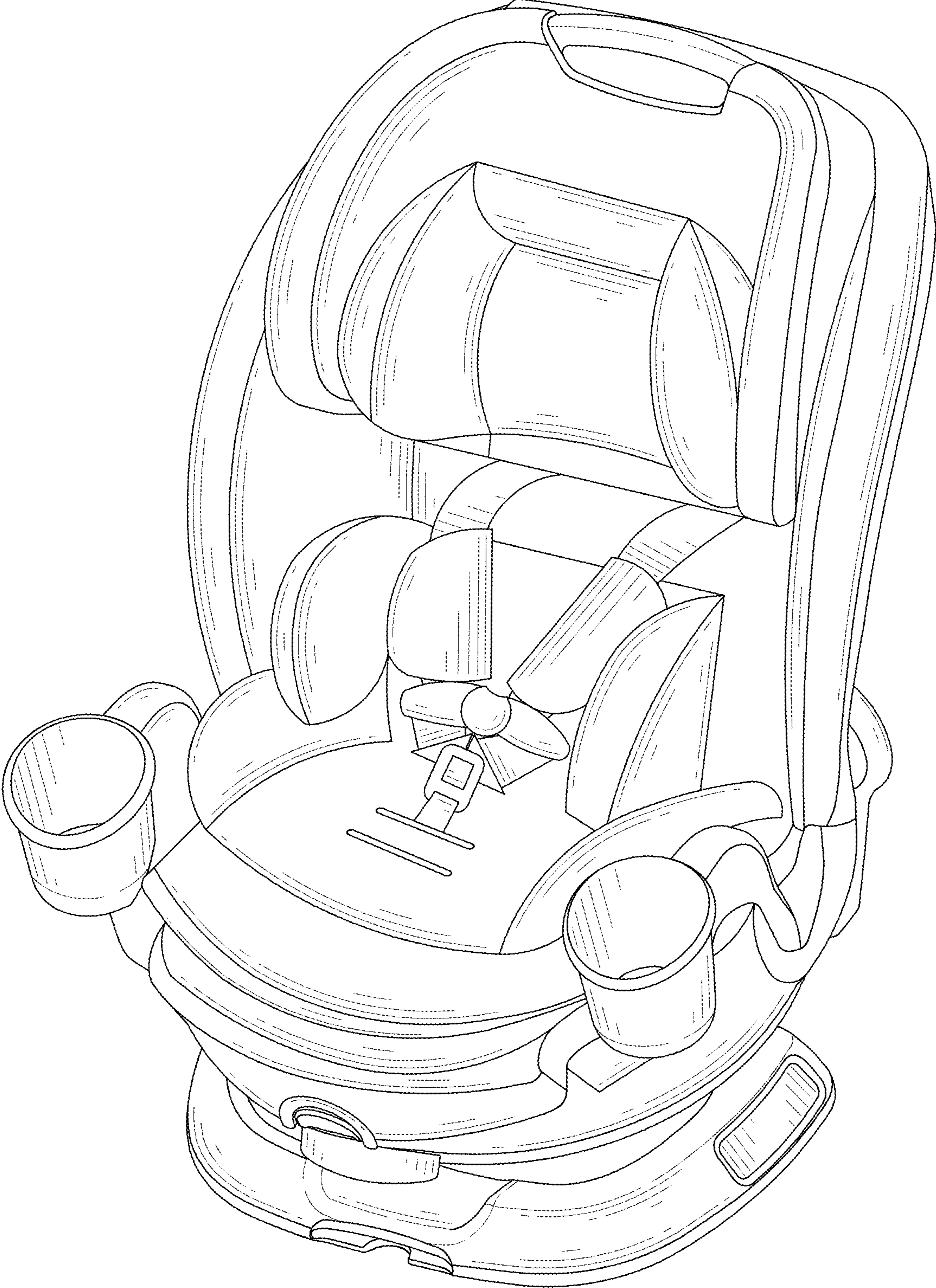

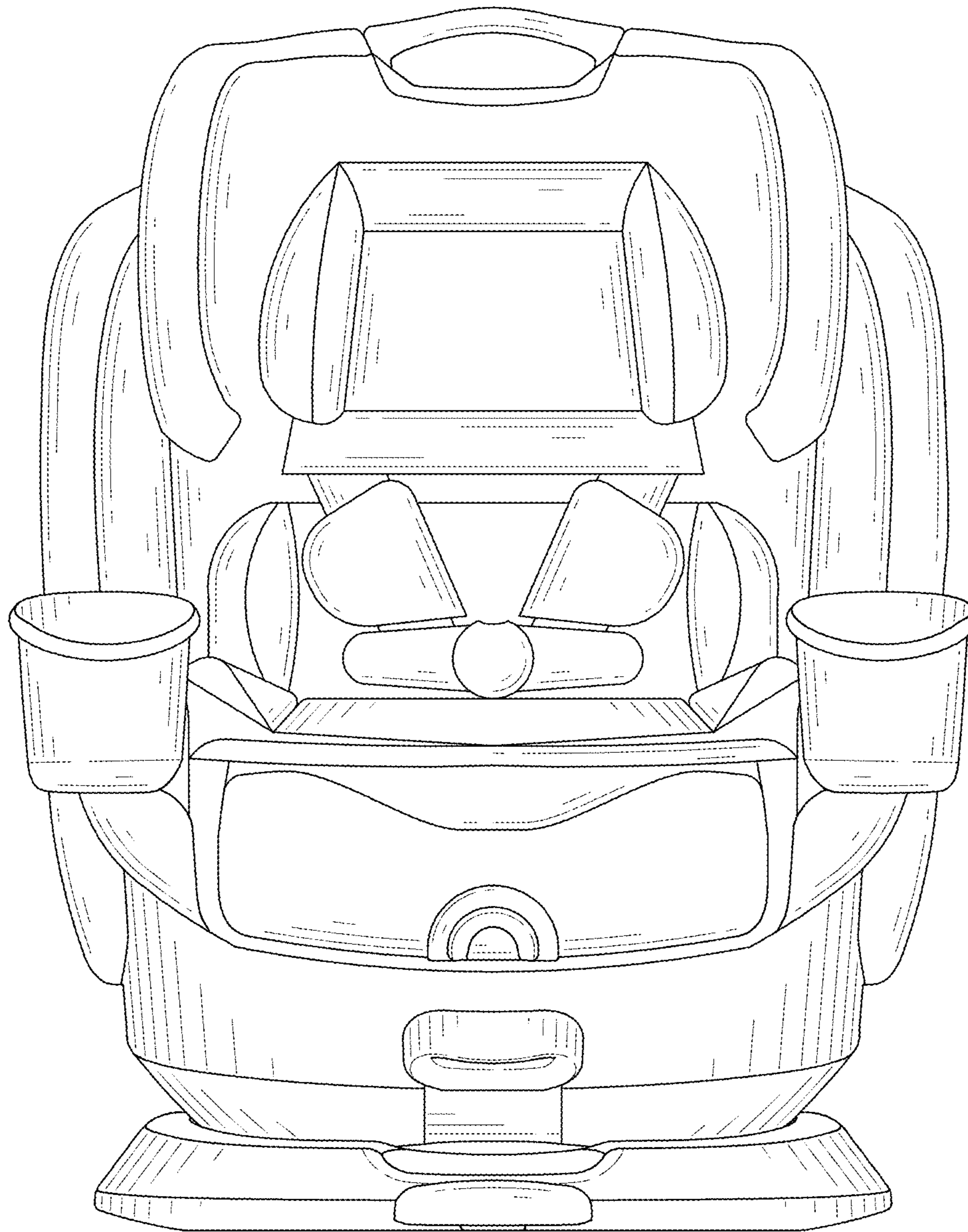

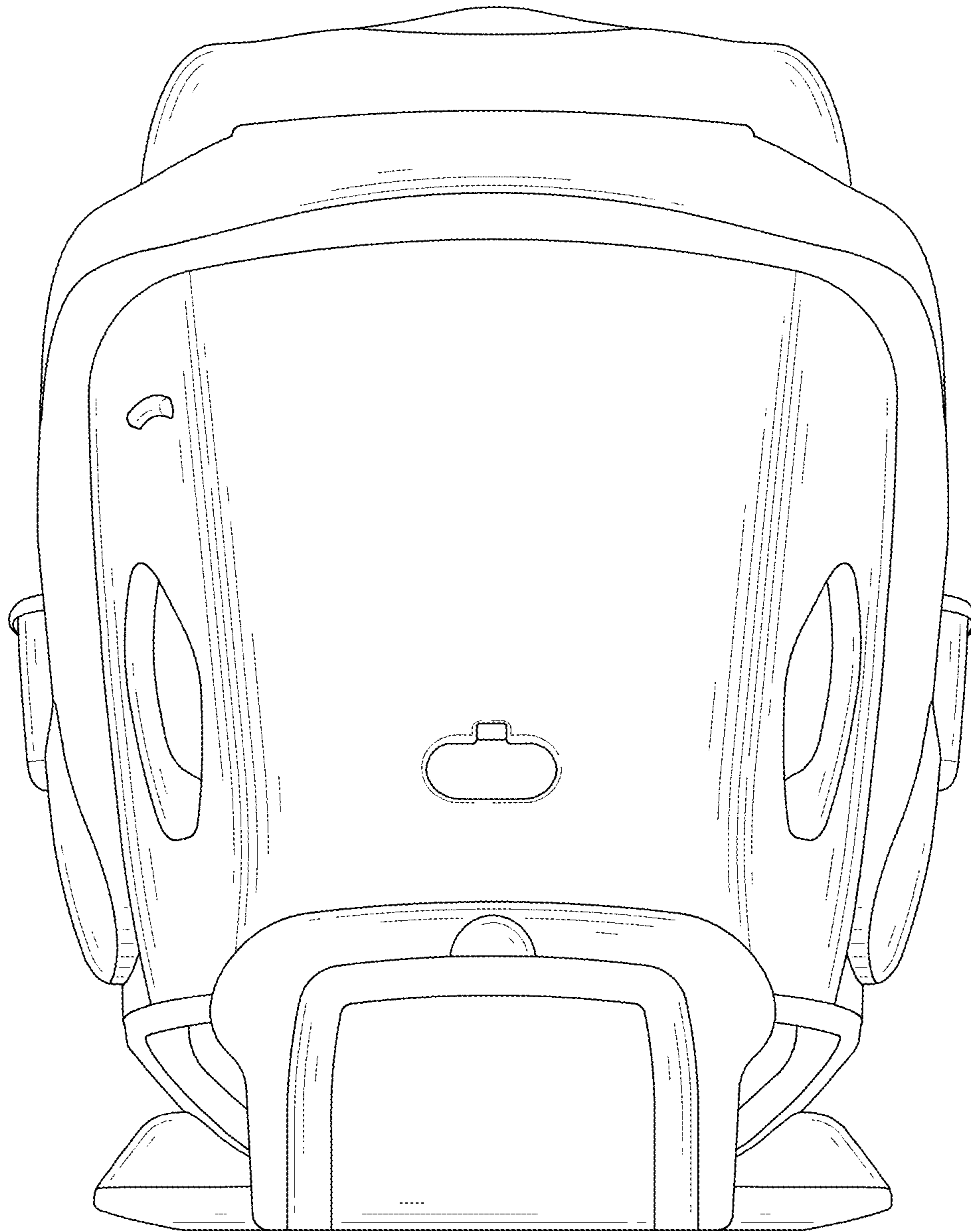

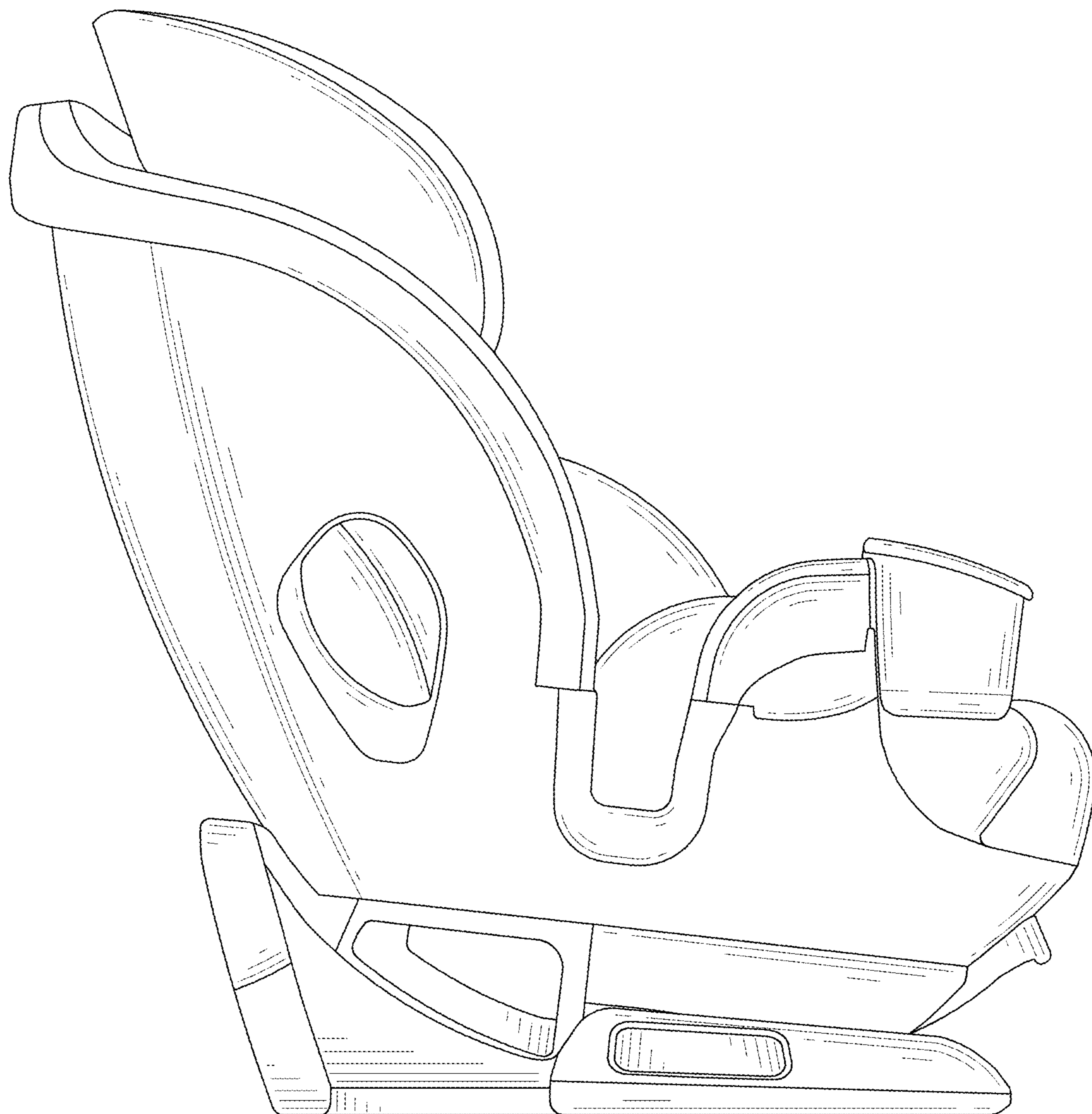

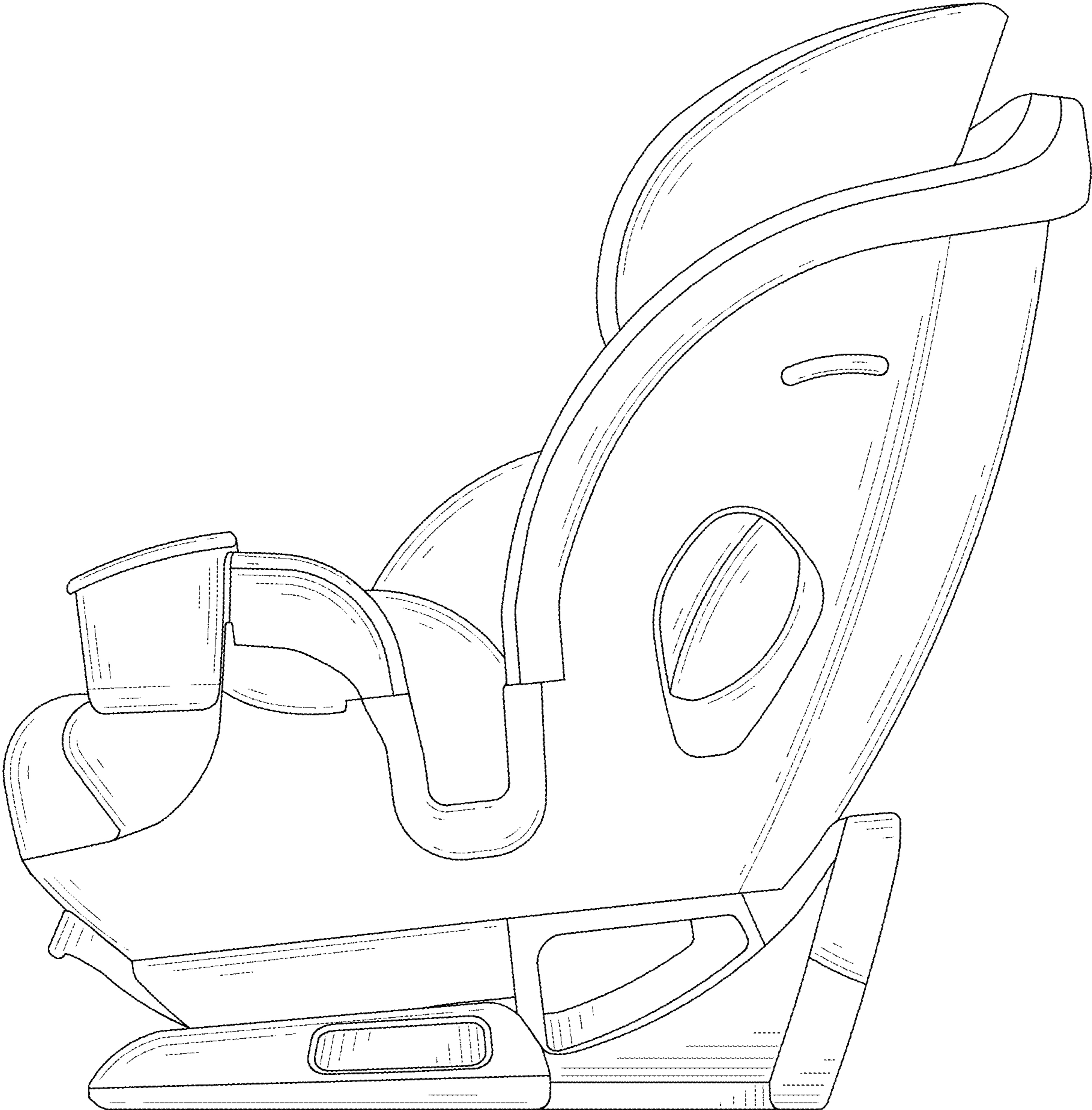

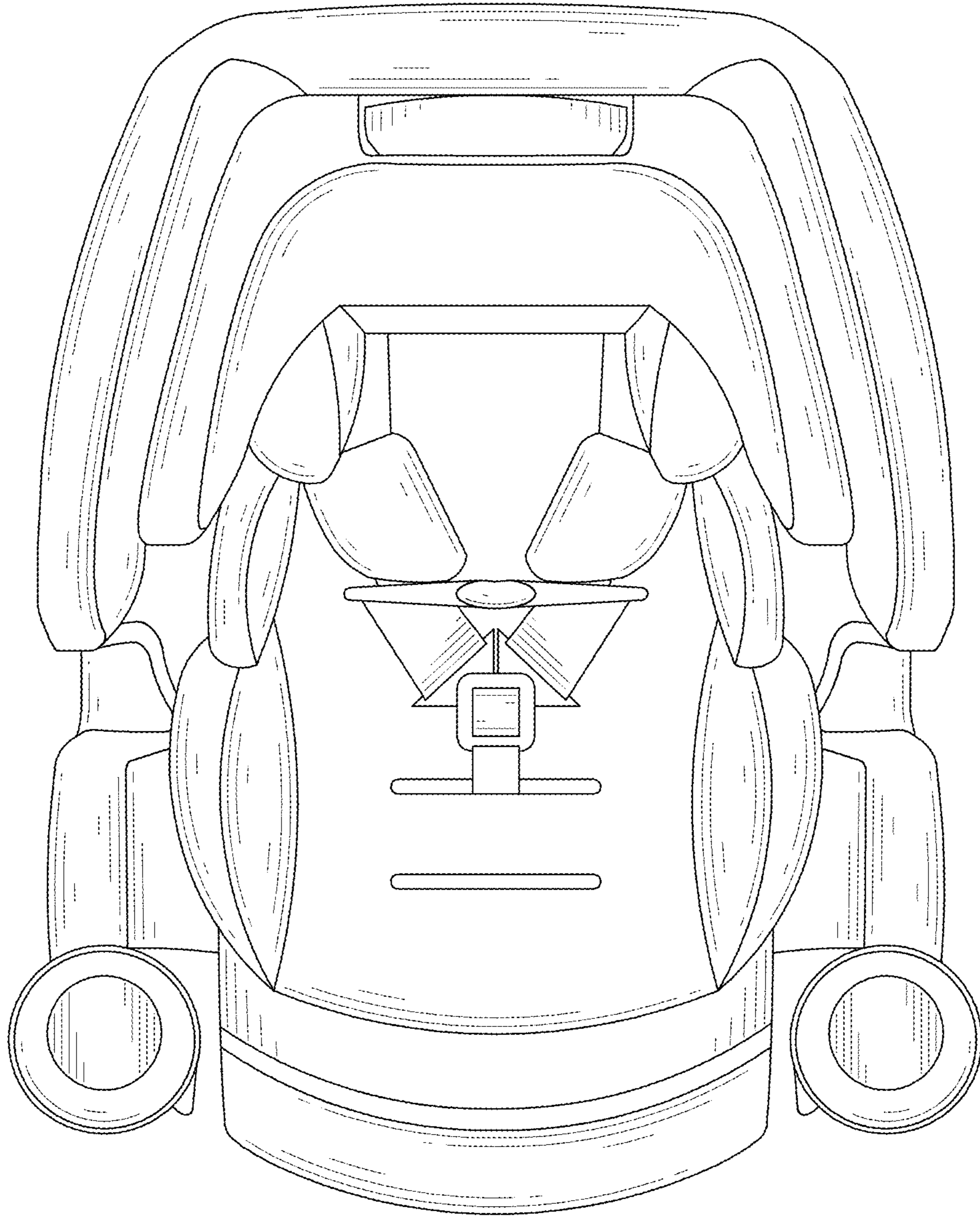

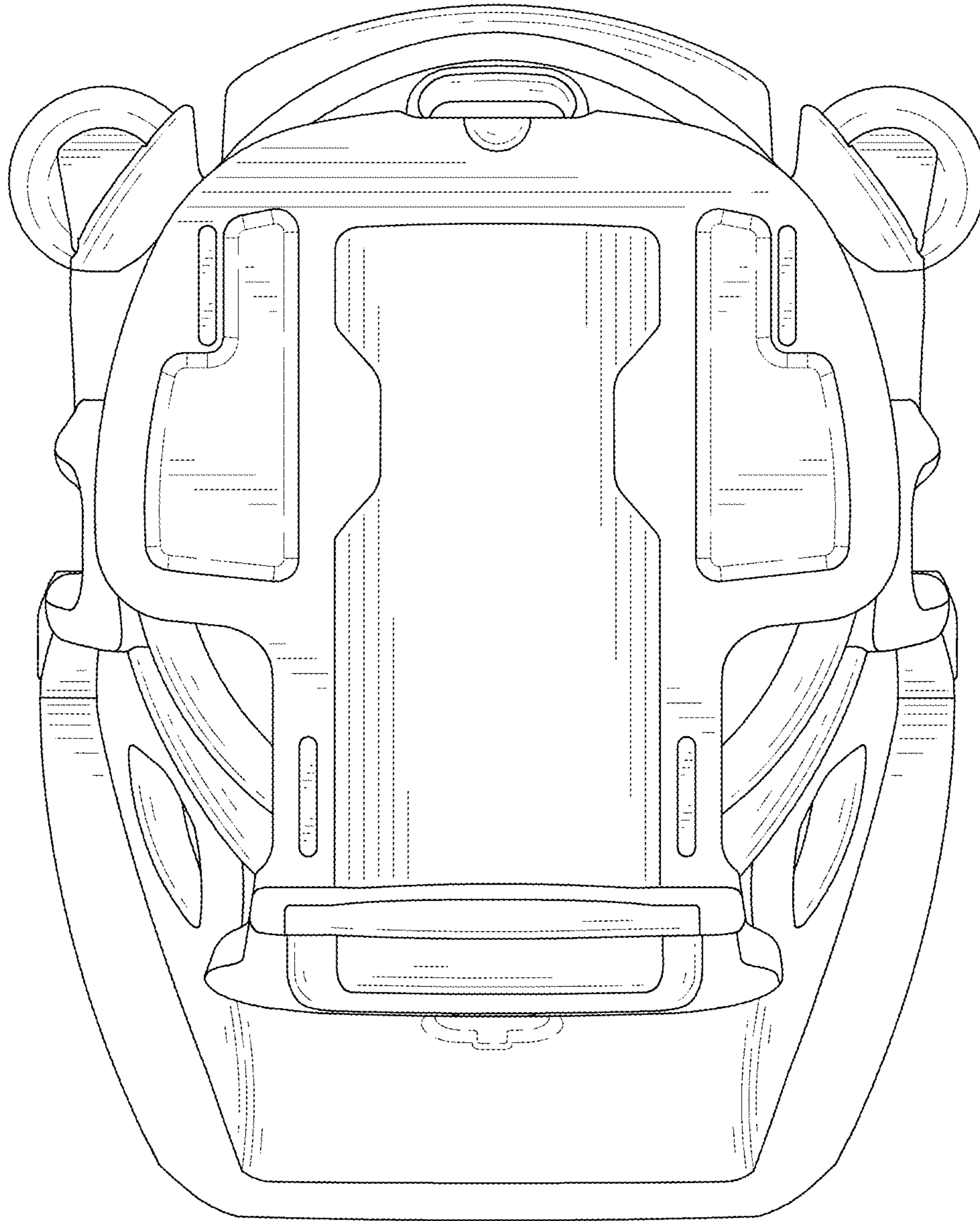

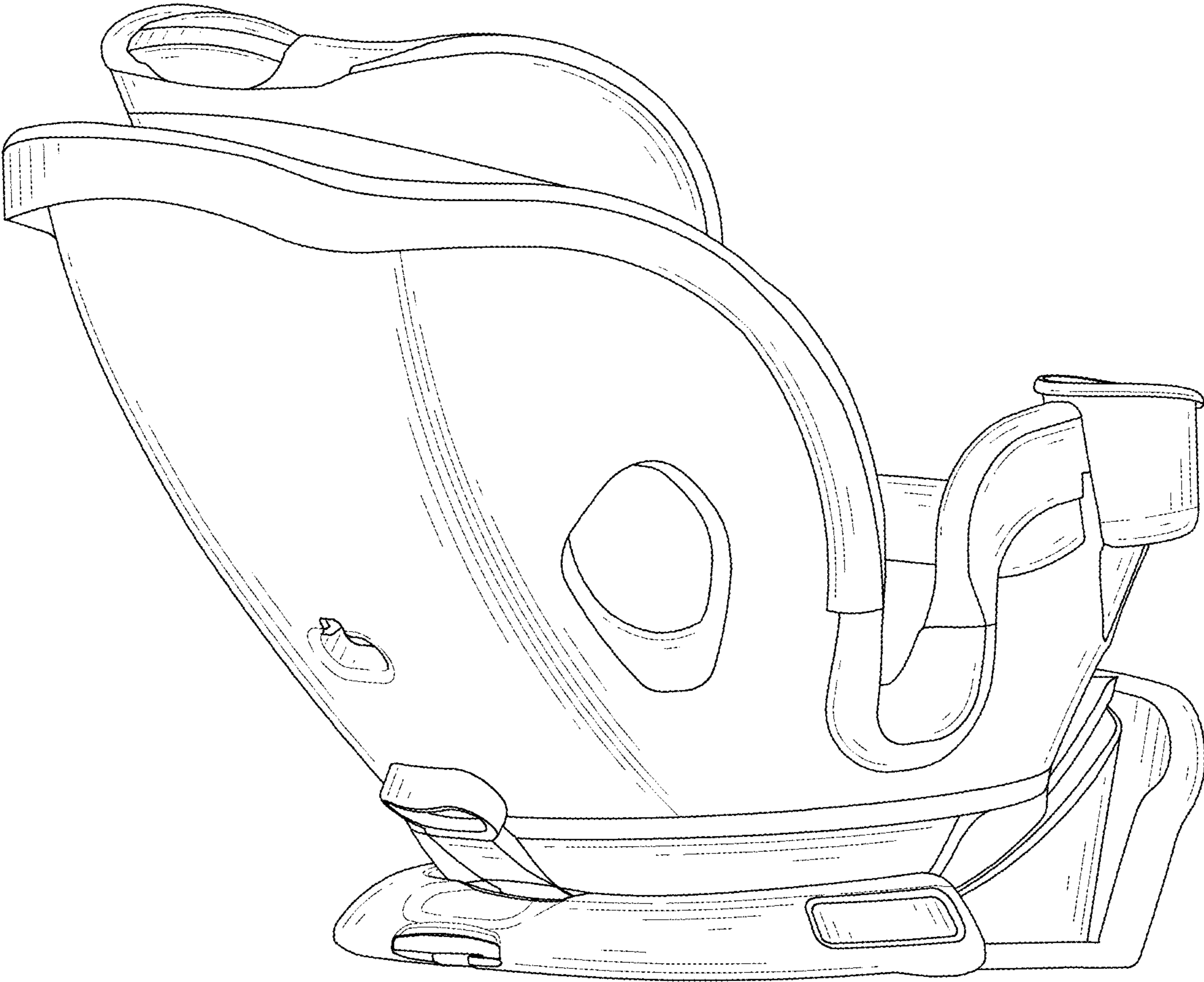

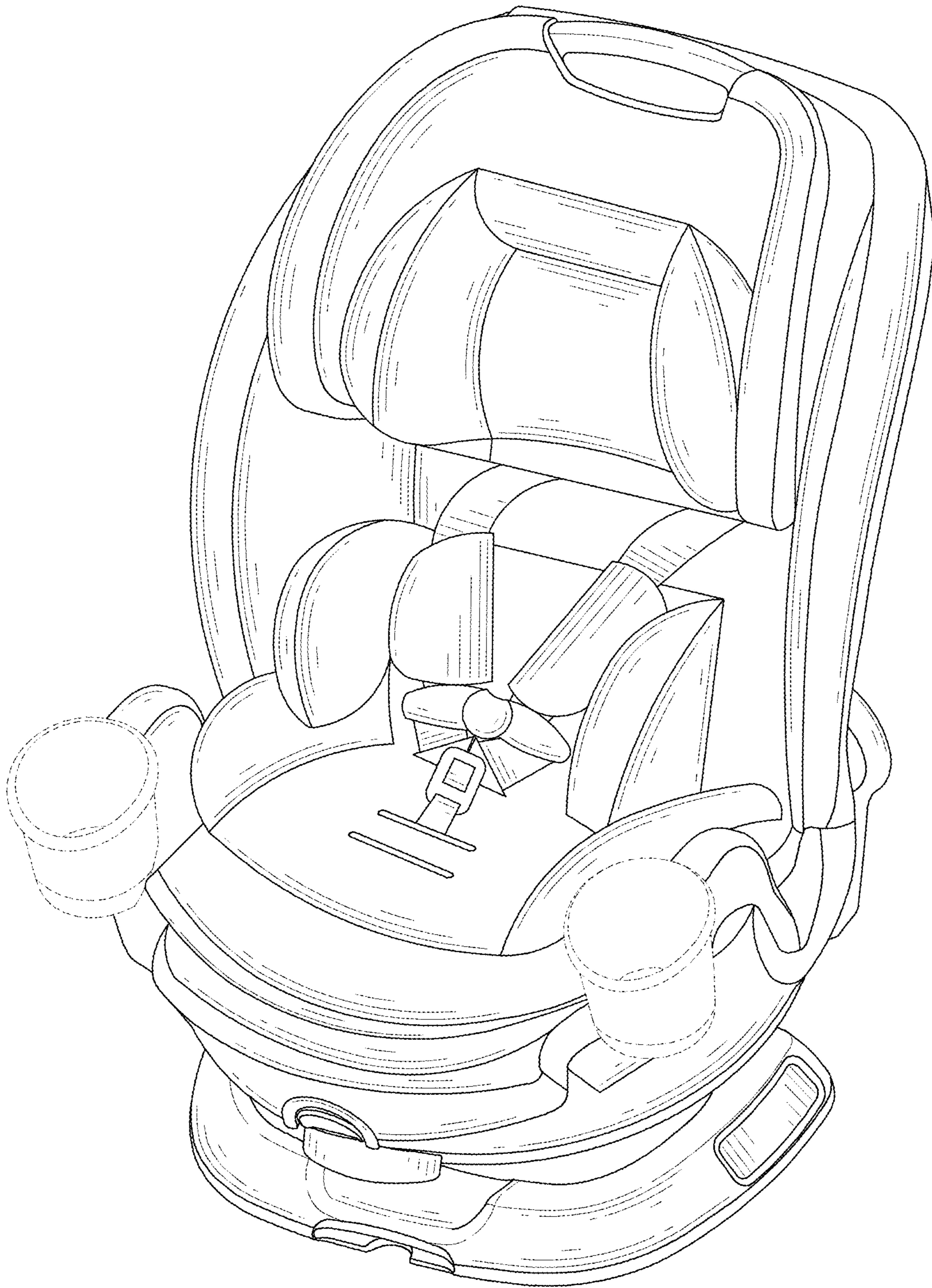

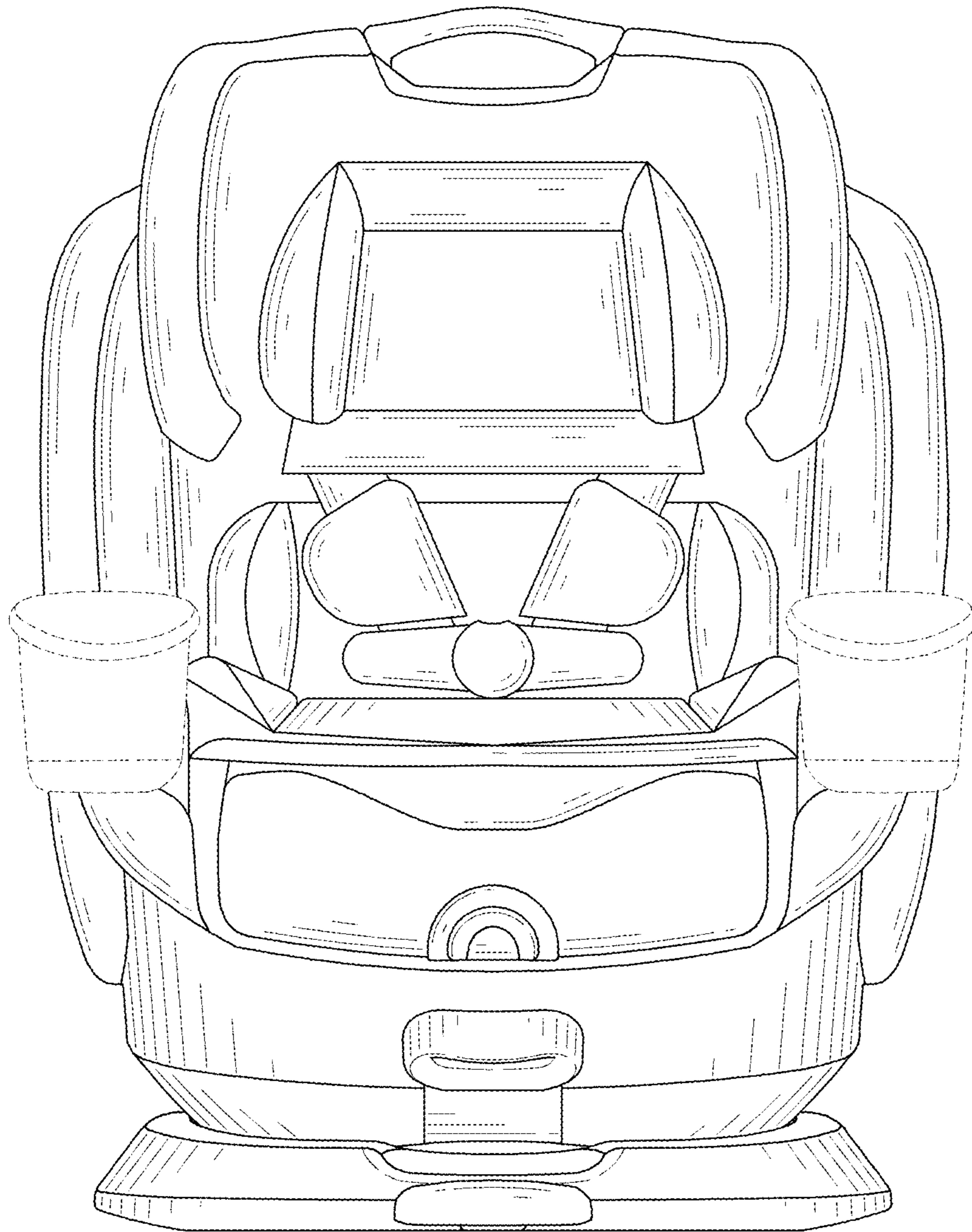

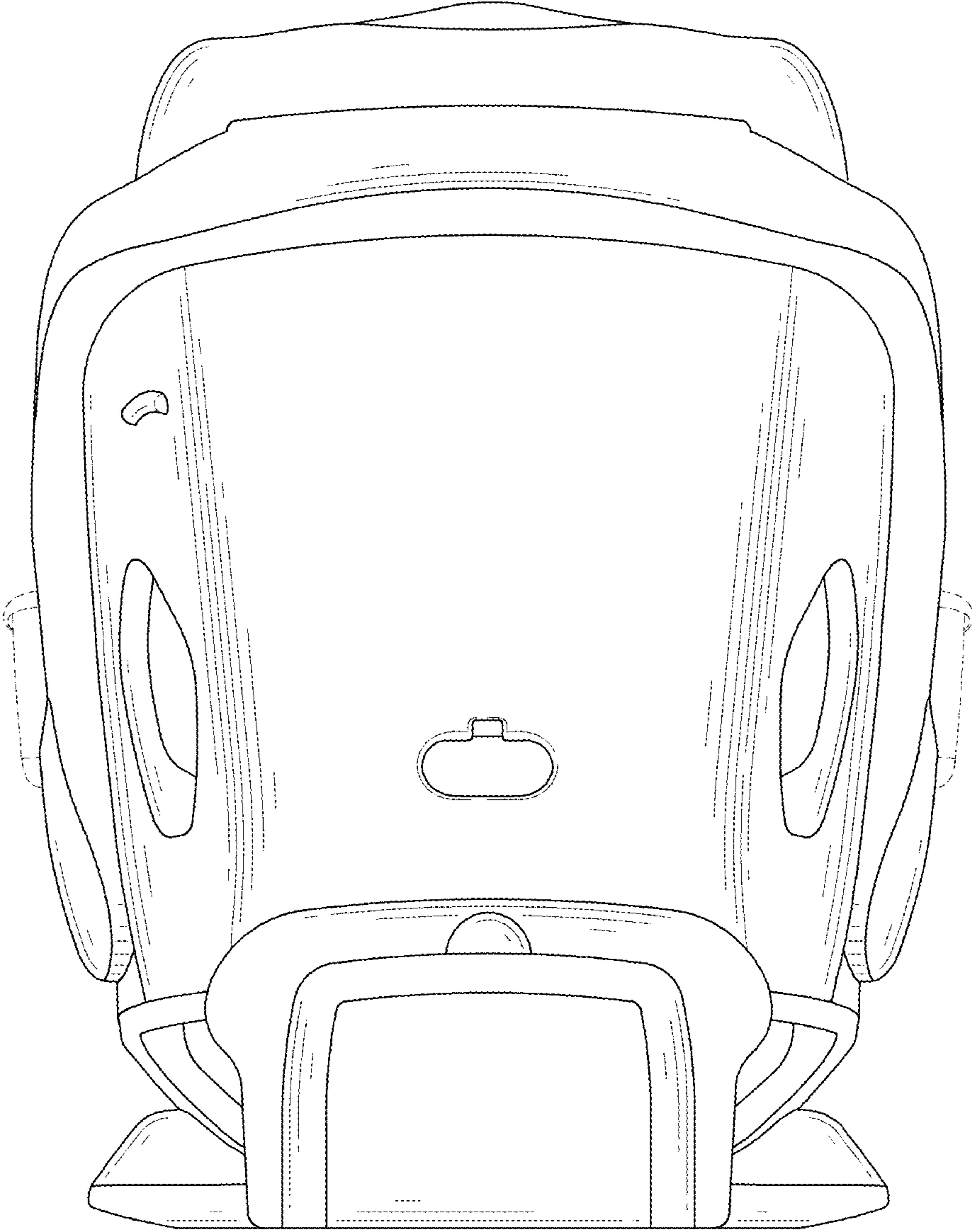

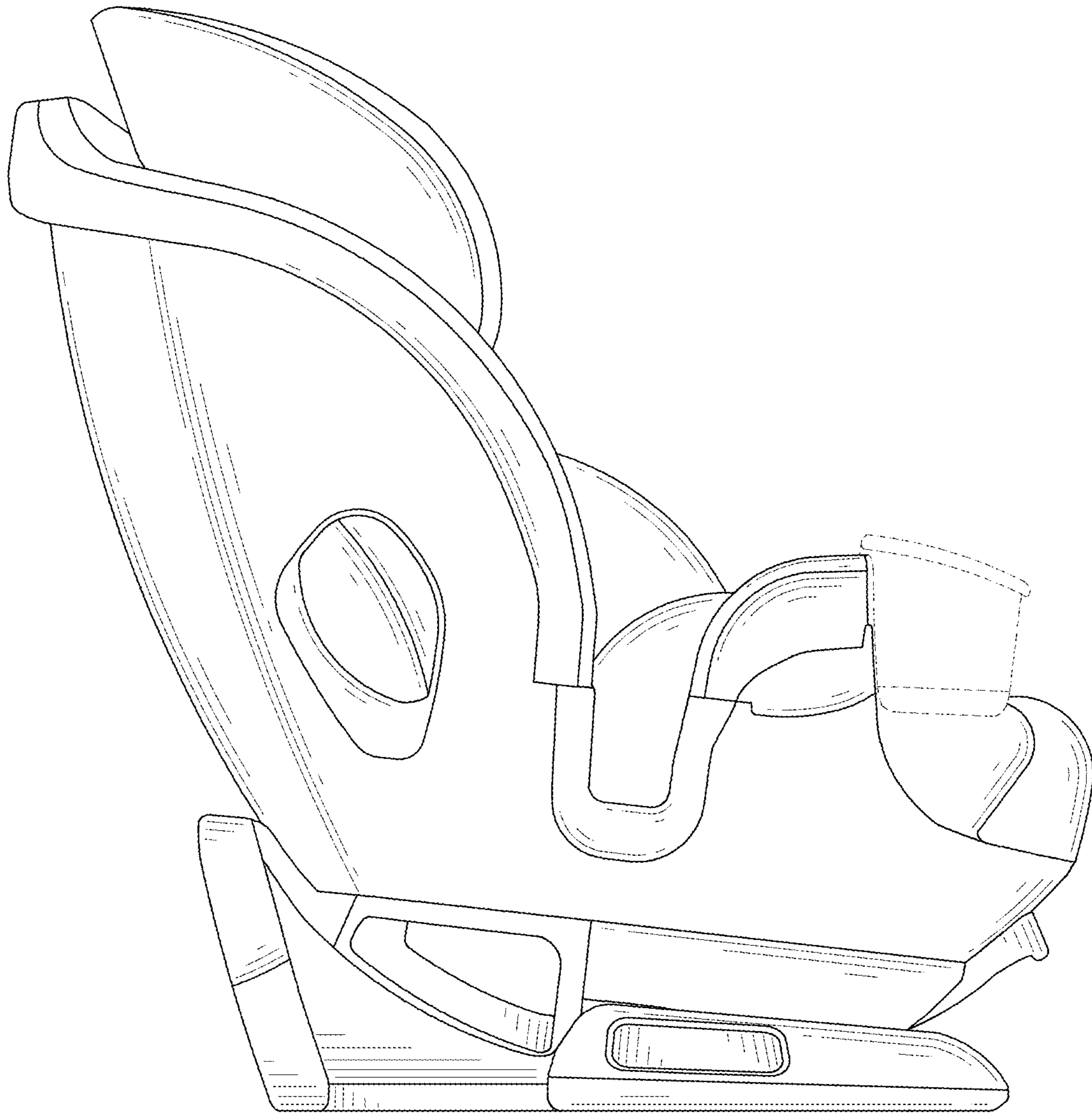

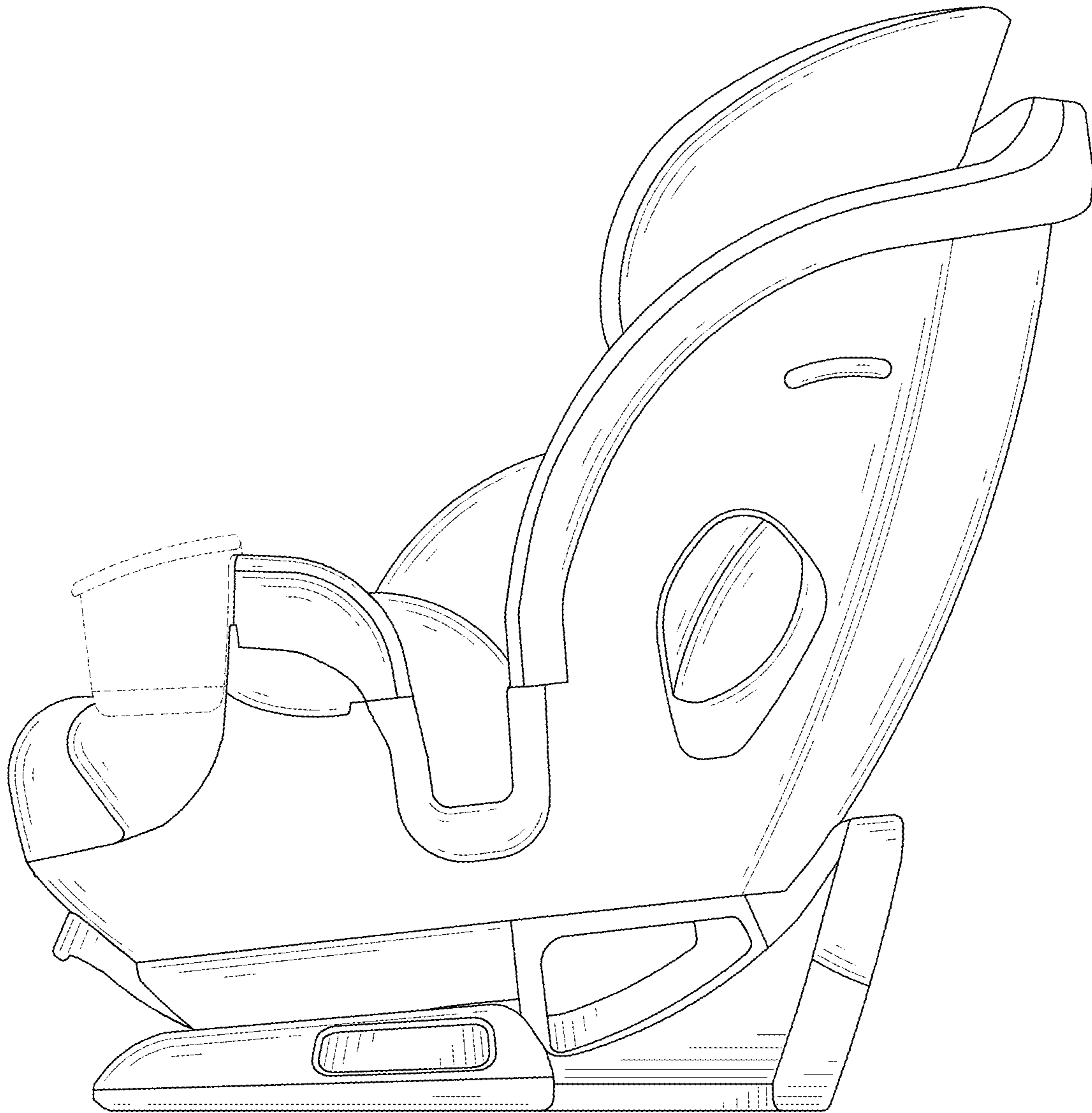

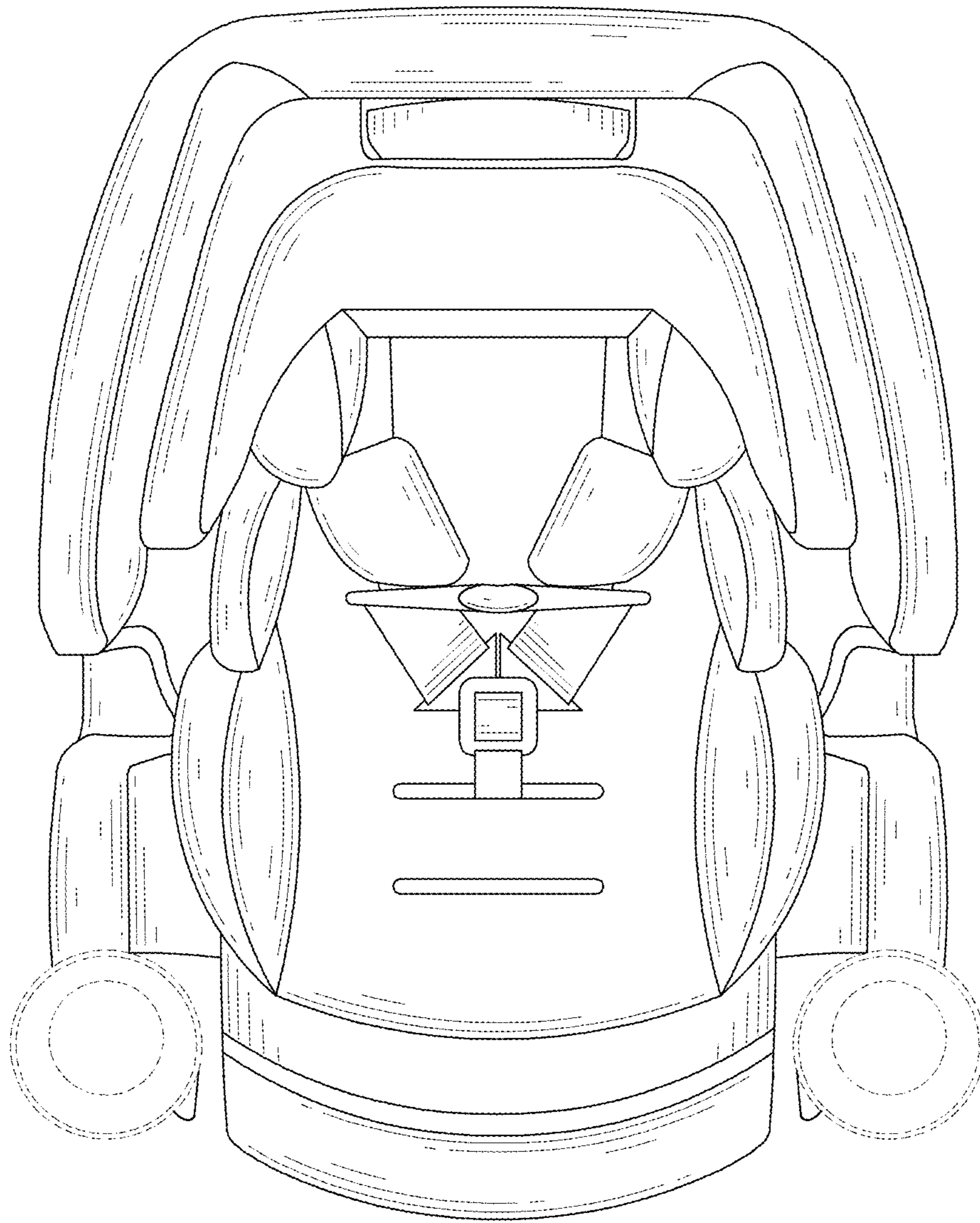

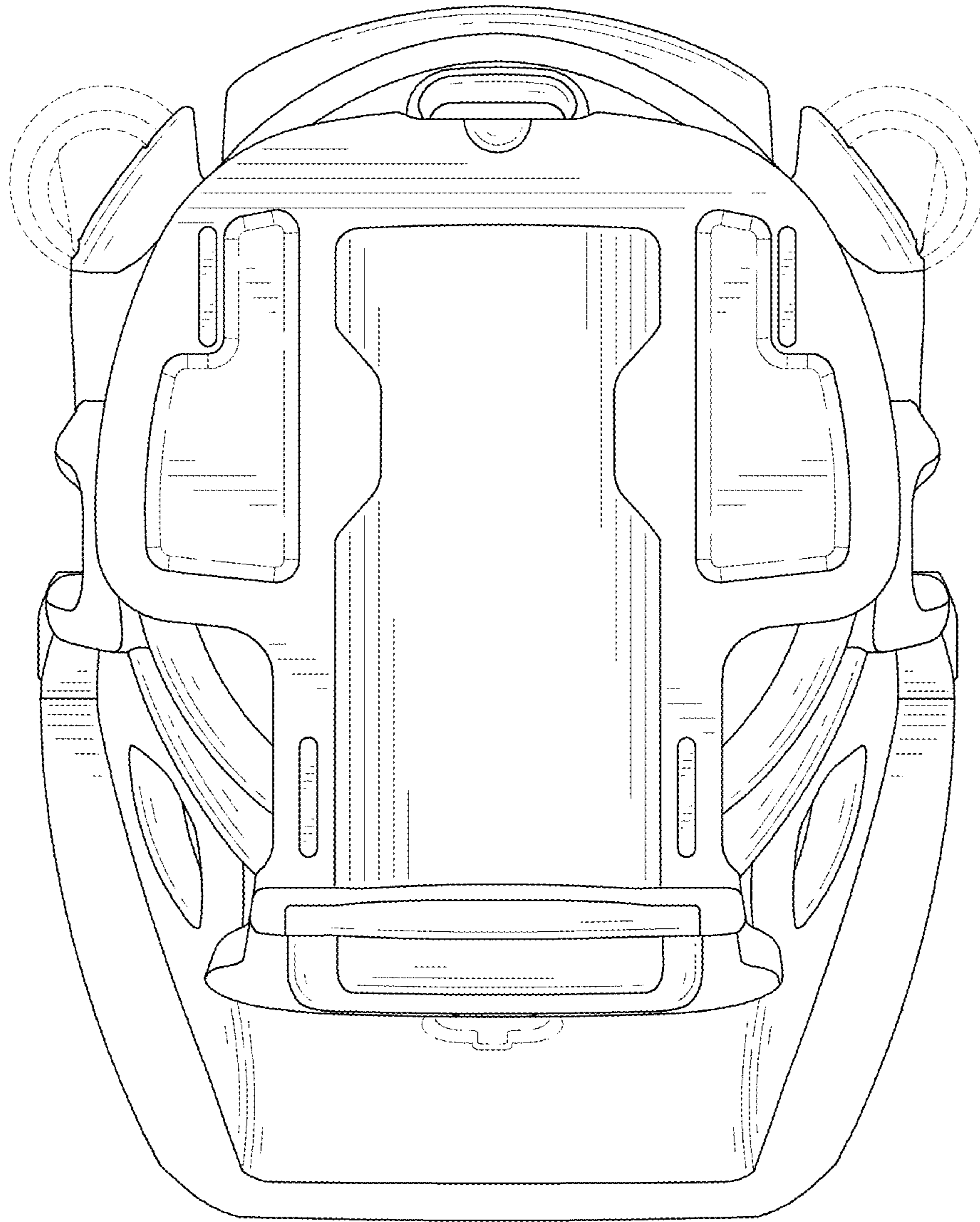

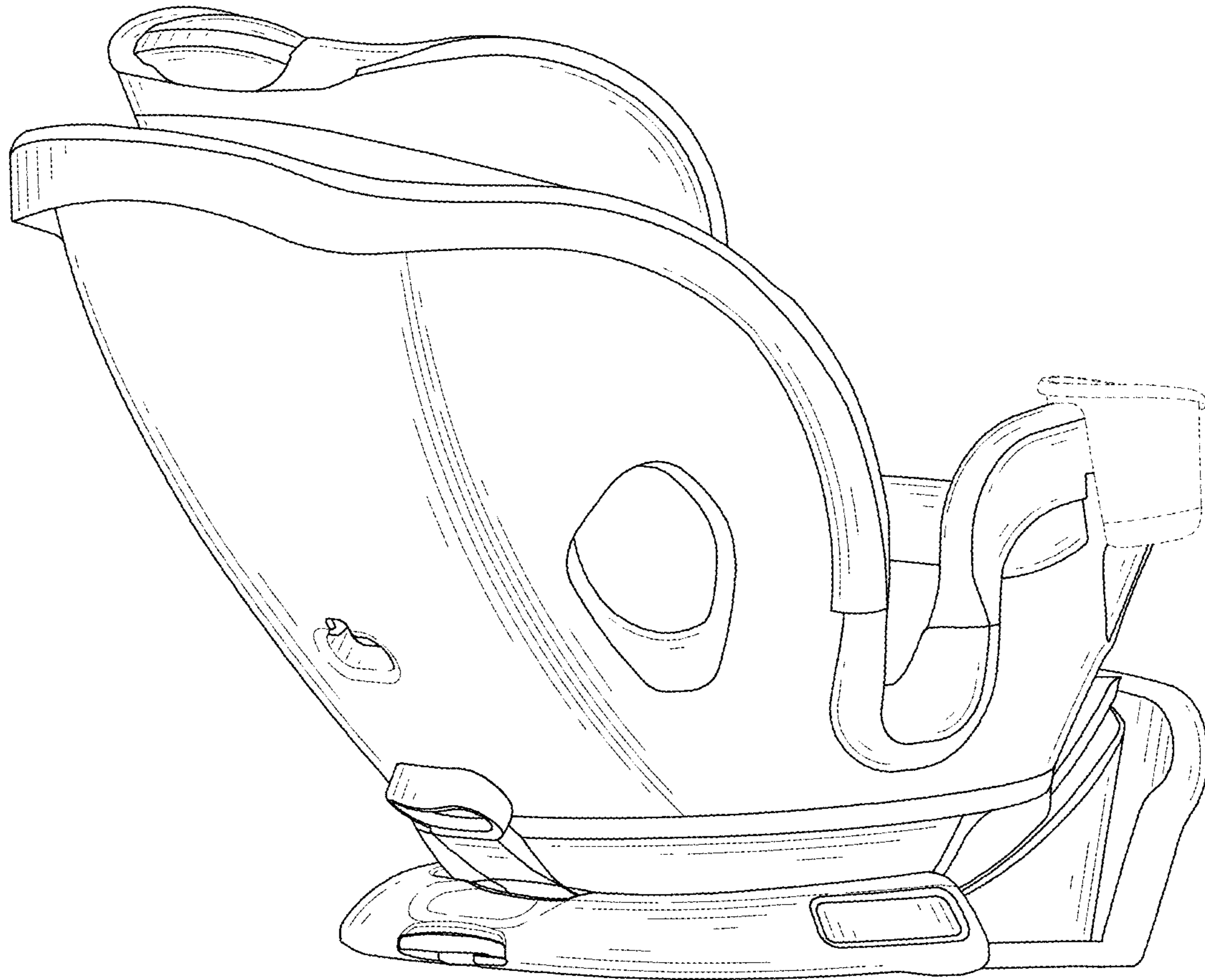
