(57) **CLAIM**

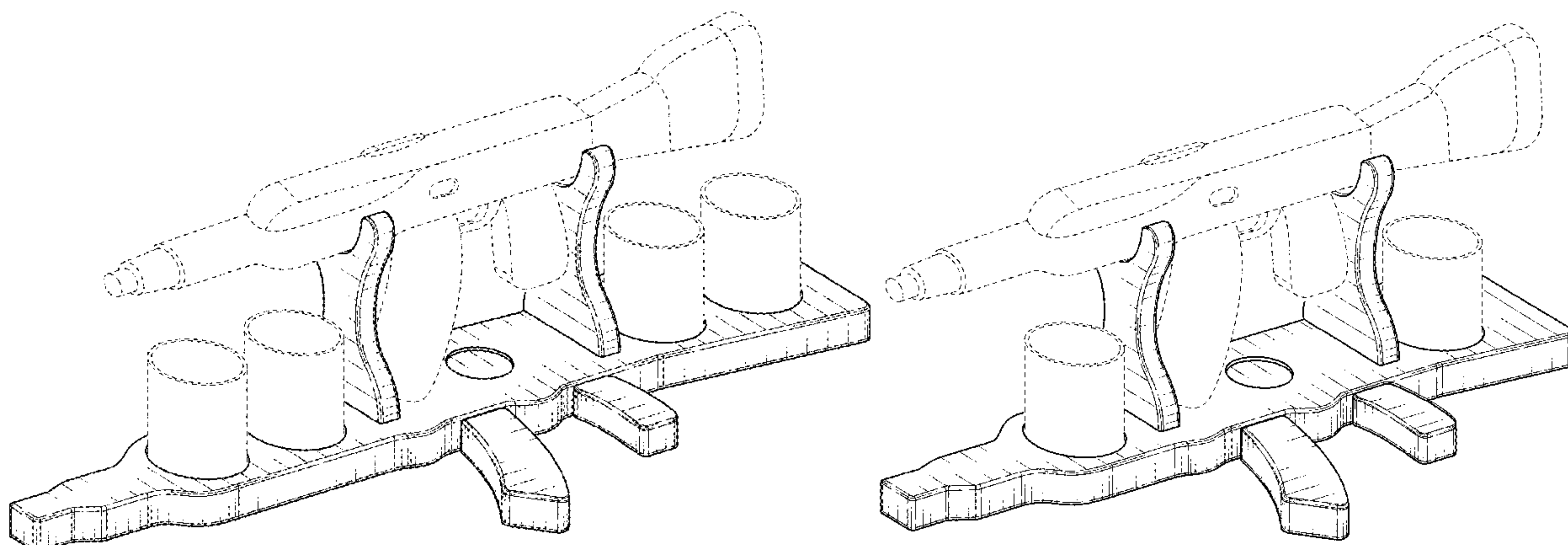
The ornamental design for a liquor decanter base, as shown
and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a first embodiment
of a liquor decanter base, showing my new design;
FIG. 2 is a top plan view of FIG. 1;
FIG. 3 is a bottom plan view of FIG. 1;
FIG. 4 is a left-side elevational view of FIG. 1;
FIG. 5 is a right-side elevational view of FIG. 1;
FIG. 6 is a front elevational view of FIG. 1;
FIG. 7 is a rear elevational view of FIG. 1;
FIG. 8 is a top, front perspective view of a second embodi-
ment of a liquor decanter base, showing my new design;
FIG. 9 is a top plan view of FIG. 8;
FIG. 10 is a bottom plan view of FIG. 8;
FIG. 11 is a left-side elevational view of FIG. 8;
FIG. 12 is a right-side elevational view of FIG. 8;
FIG. 13 is a front elevational view of FIG. 8; and,
FIG. 14 is a rear elevational view of FIG. 8.

The broken lines in FIGS. 1 and 8 depicting glasses and a
rifle-shaped decanter depict environmental subject matter
that forms no part of the claimed design. The remaining
broken lines depict portions of the liquor decanter base that
form no part of the claimed design. The dot-dash broken
lines show a boundary of the claimed design, and form no
part of the claimed design.

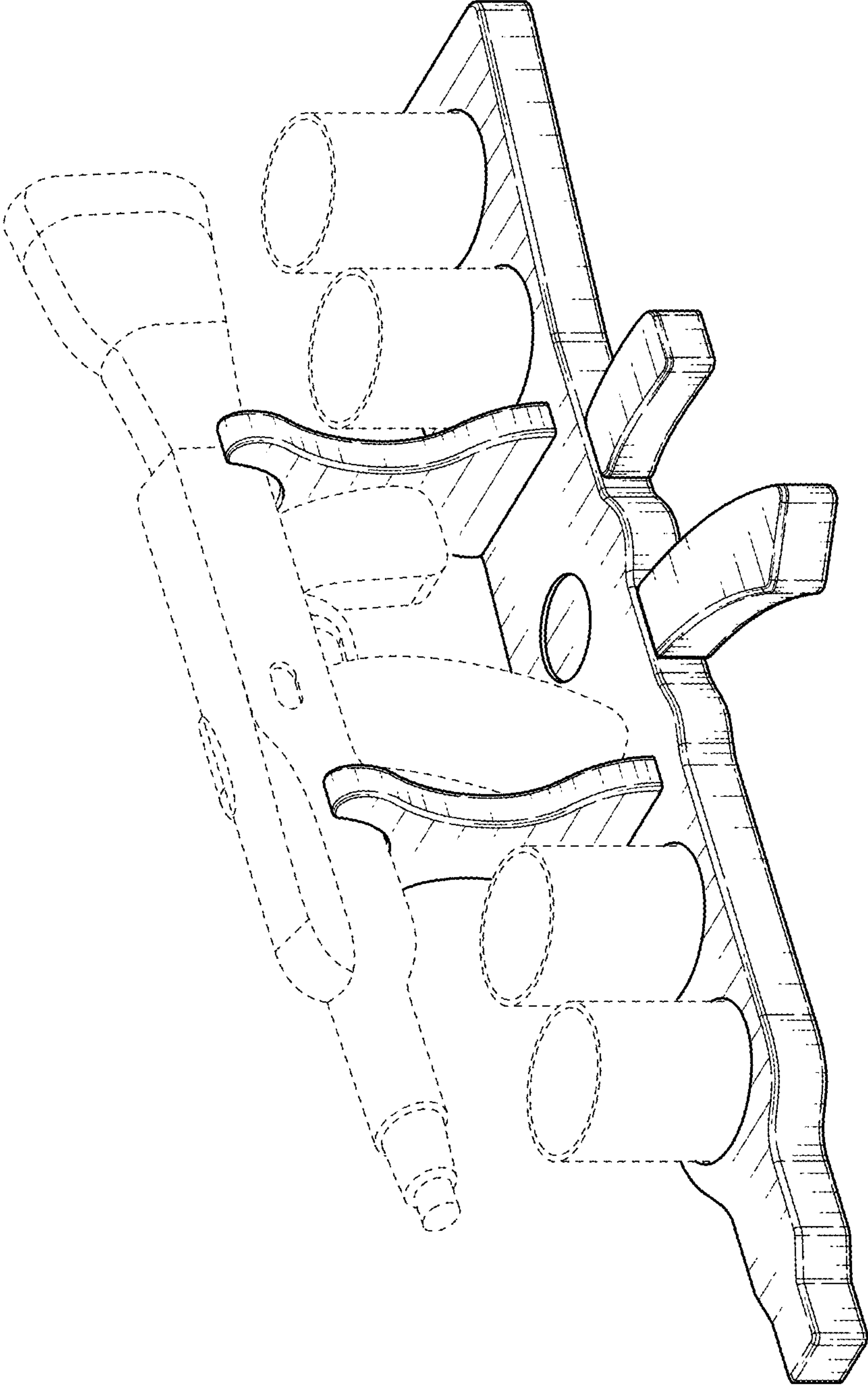

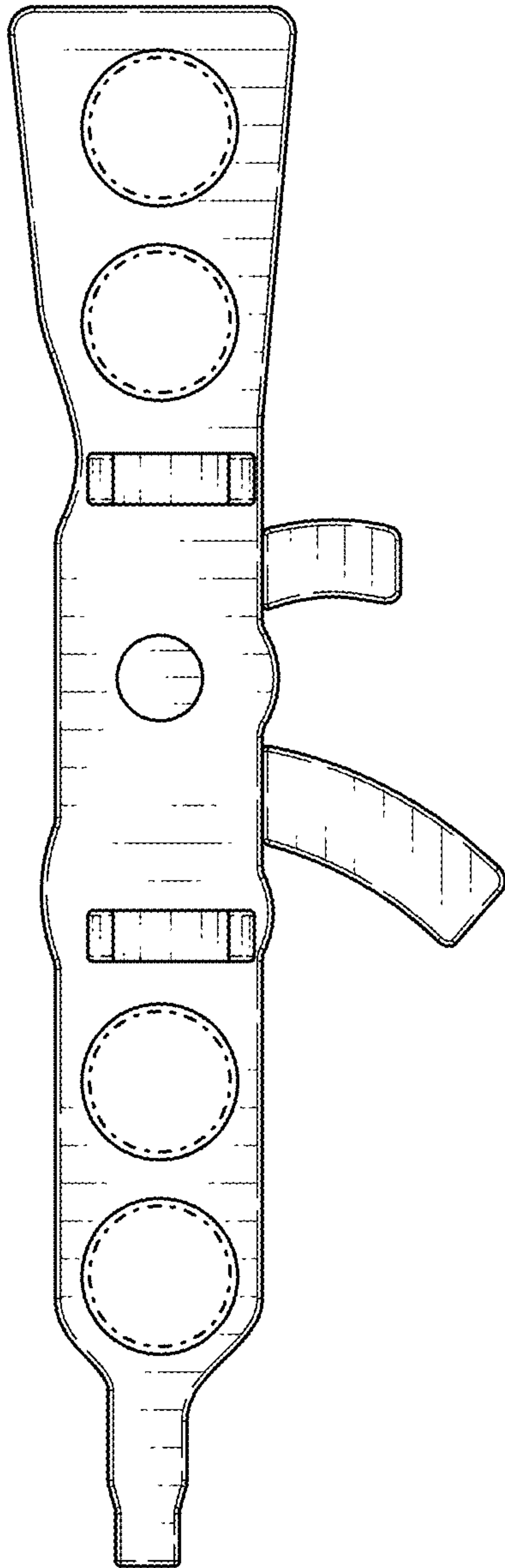

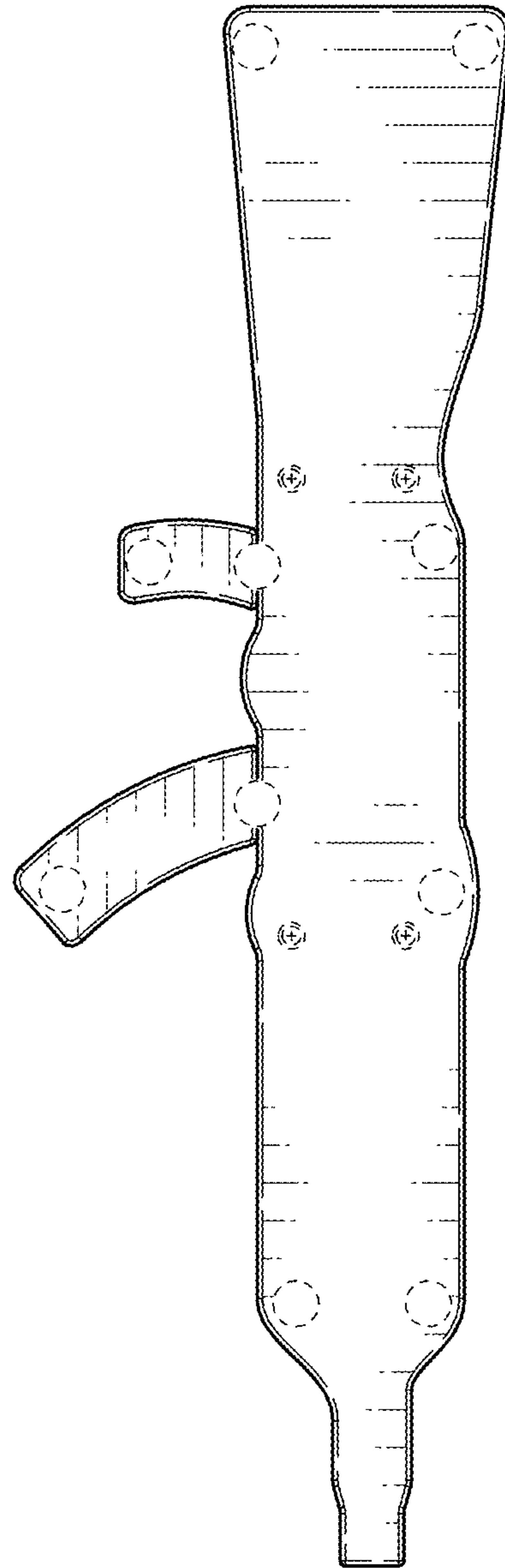

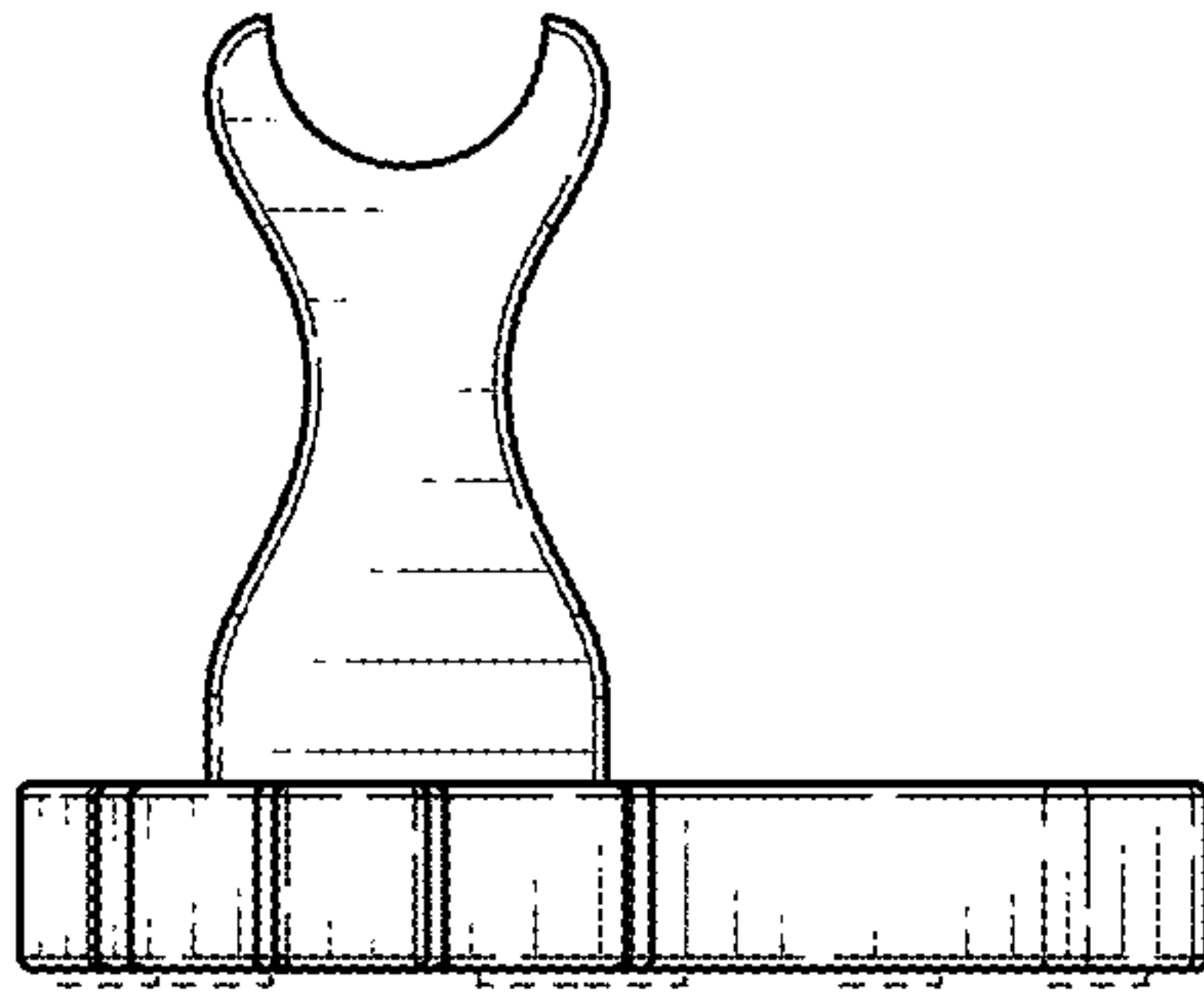

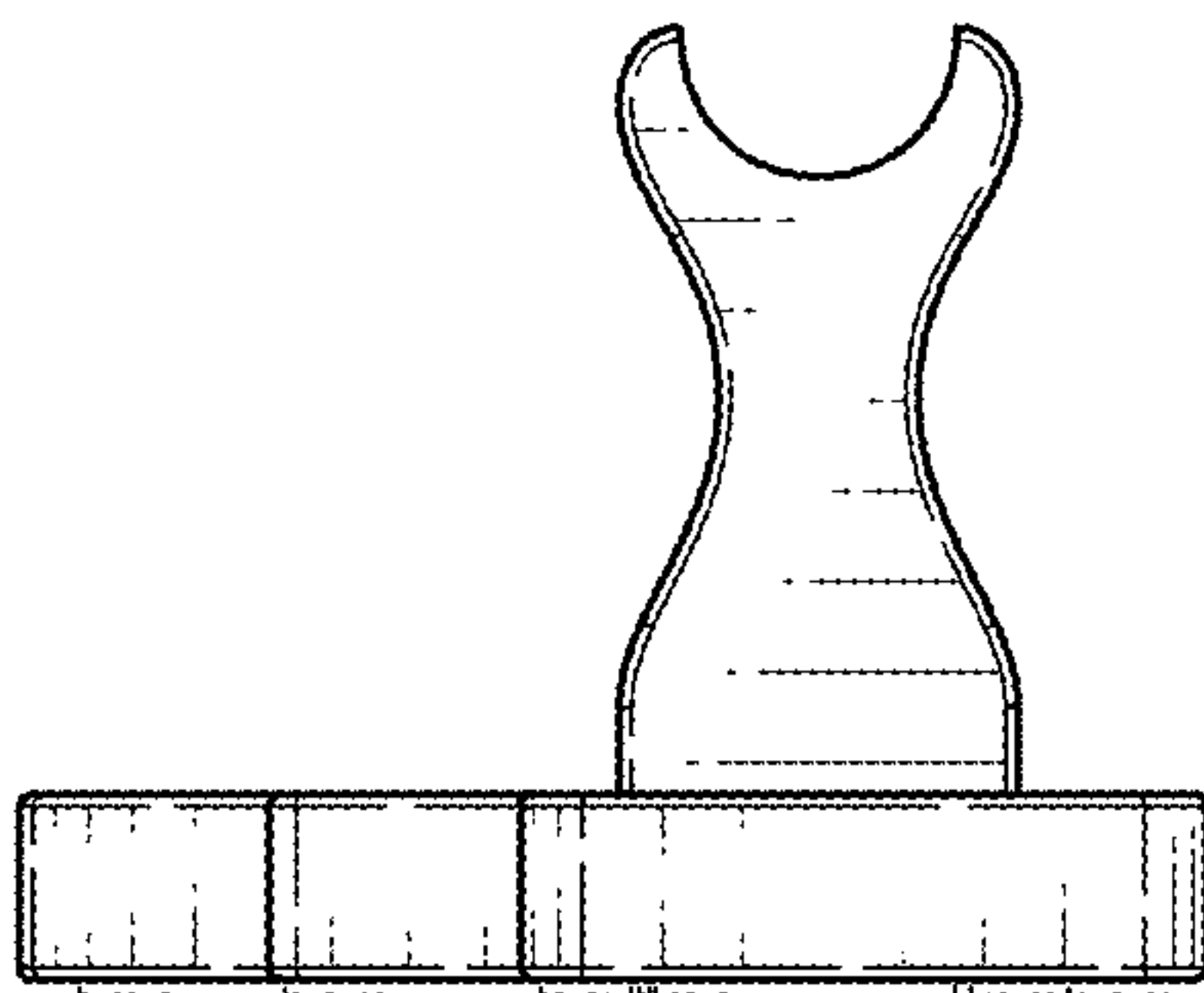

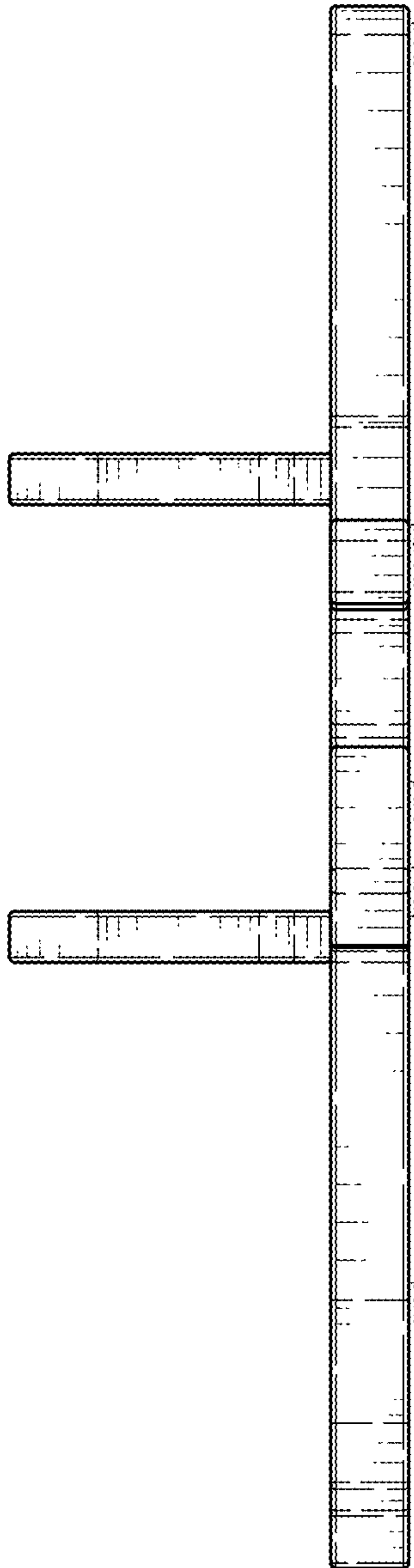

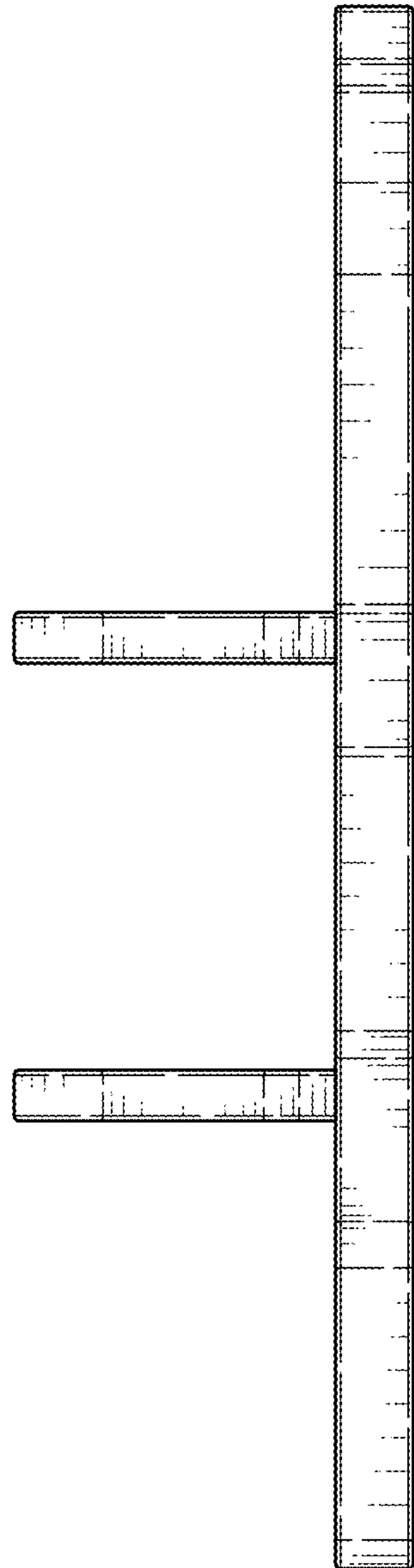

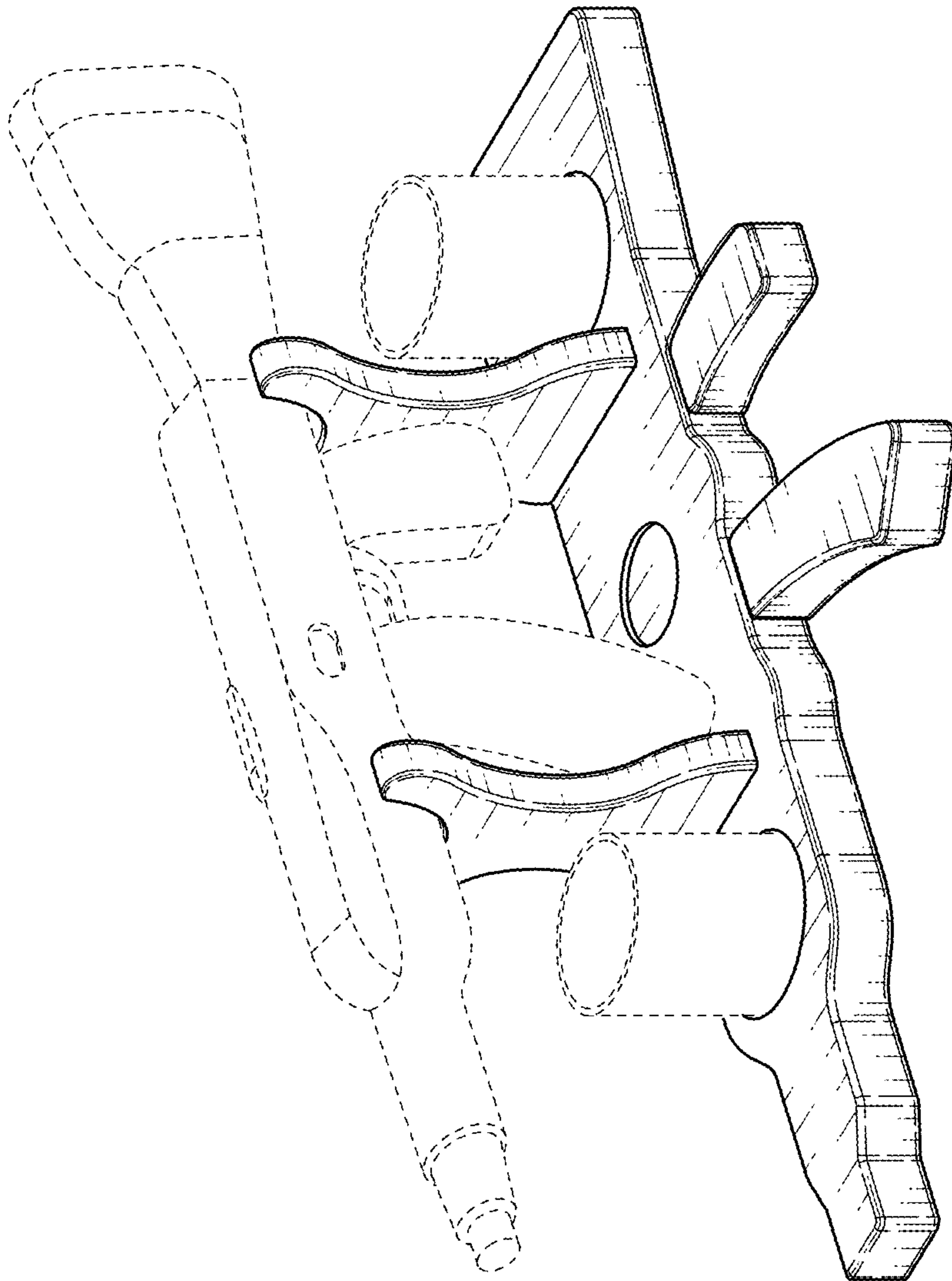

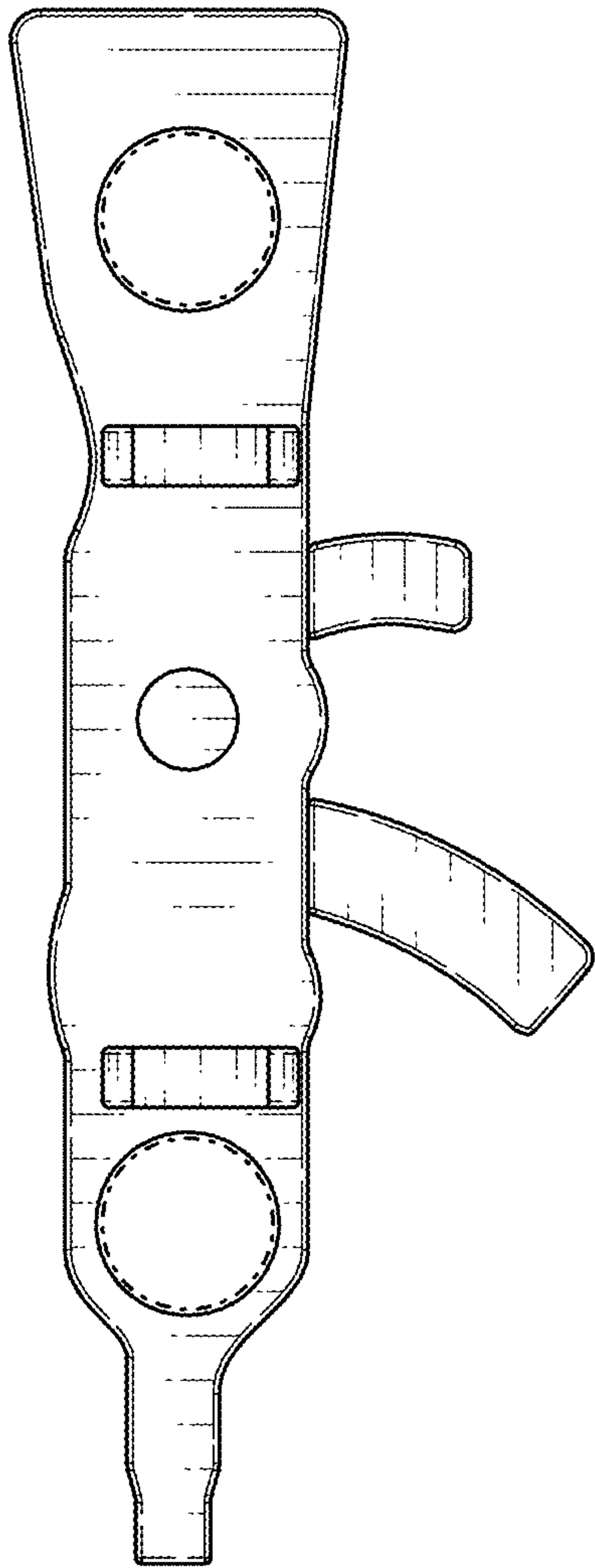

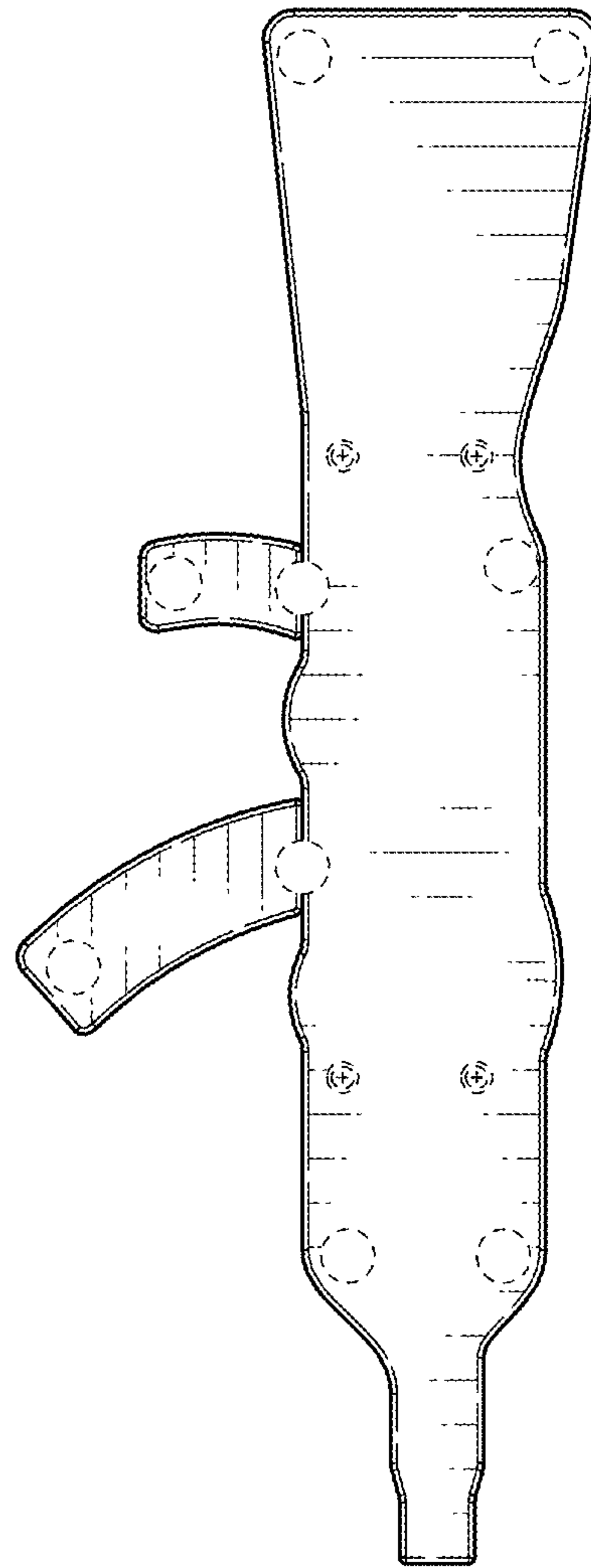

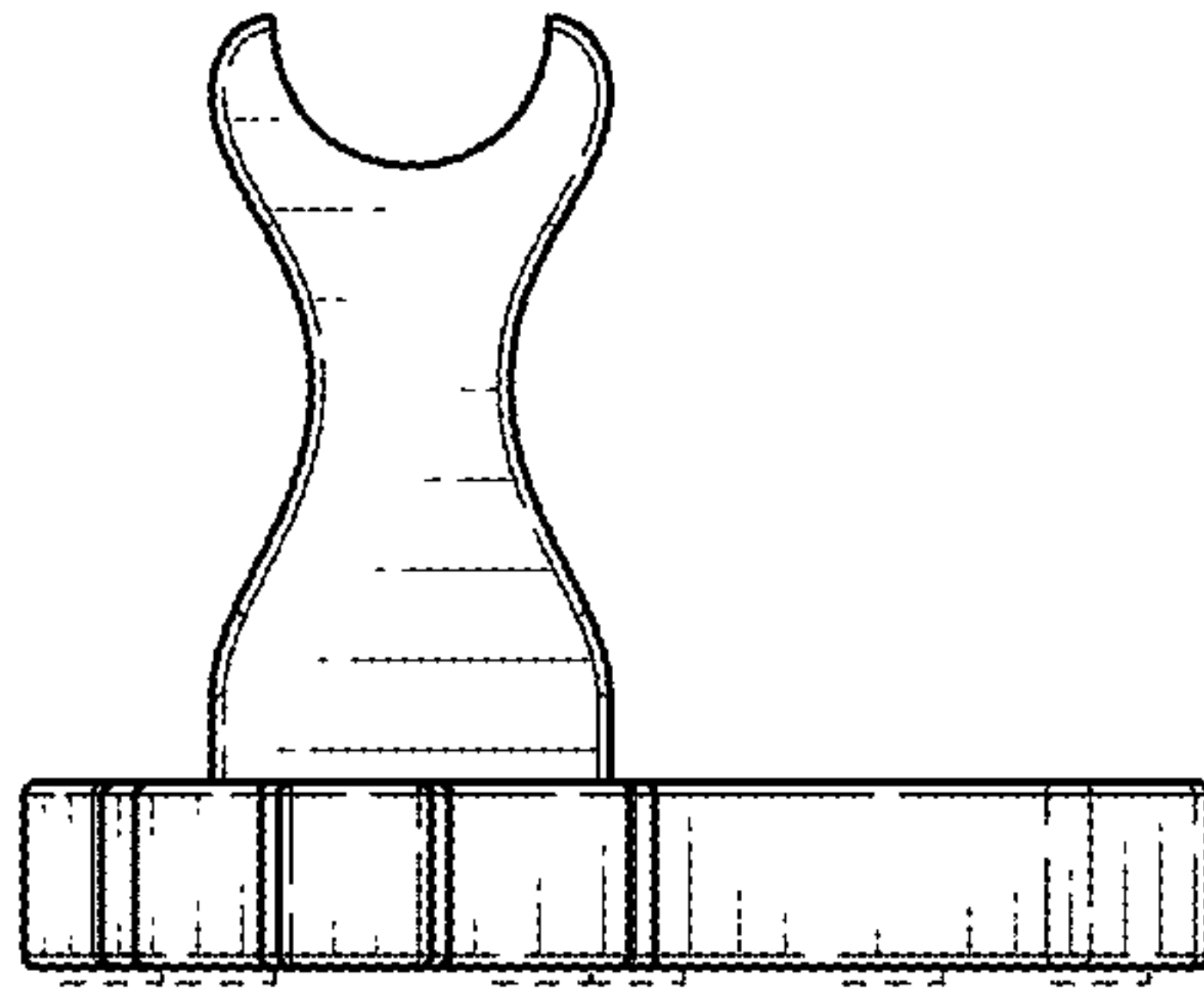

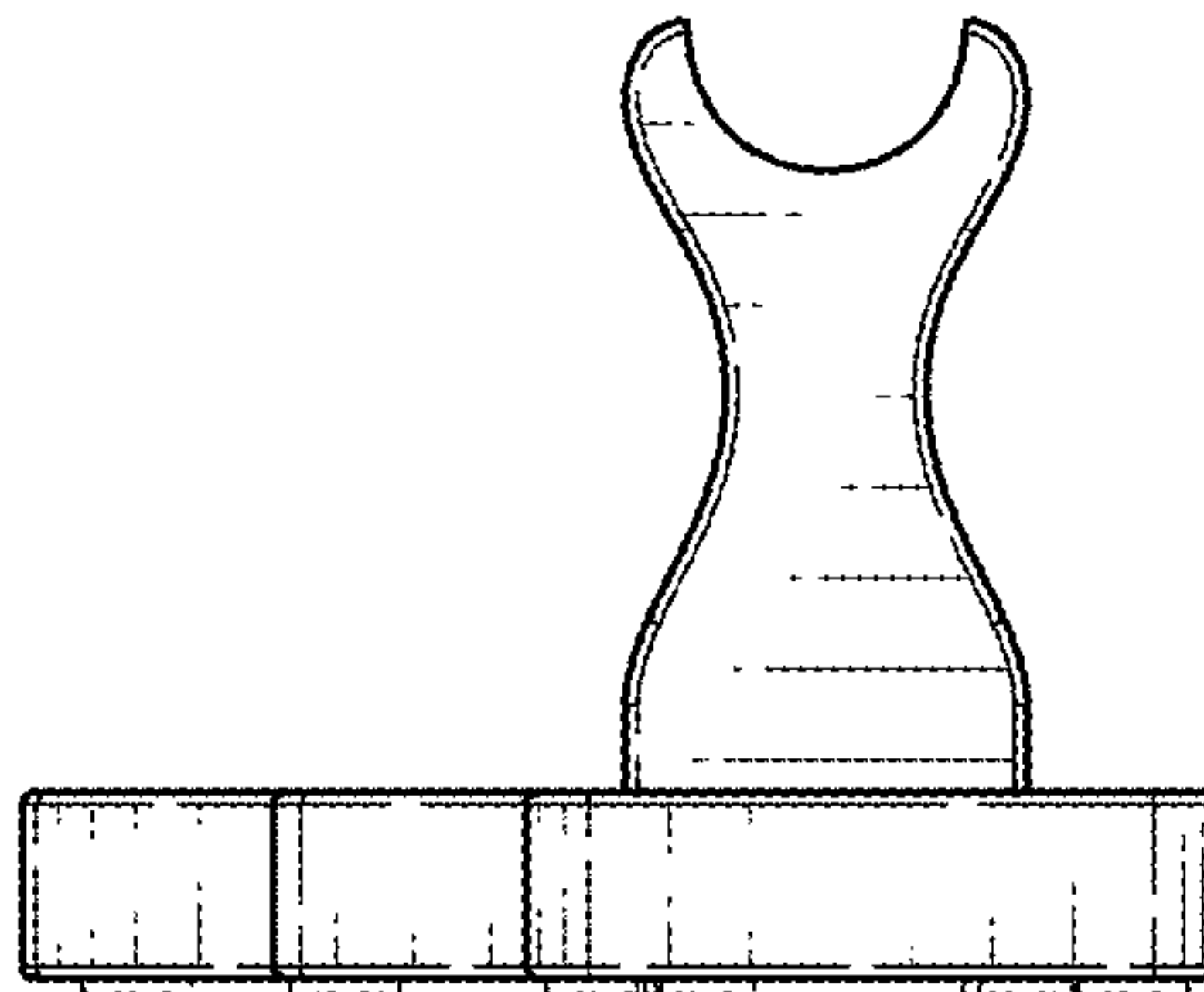

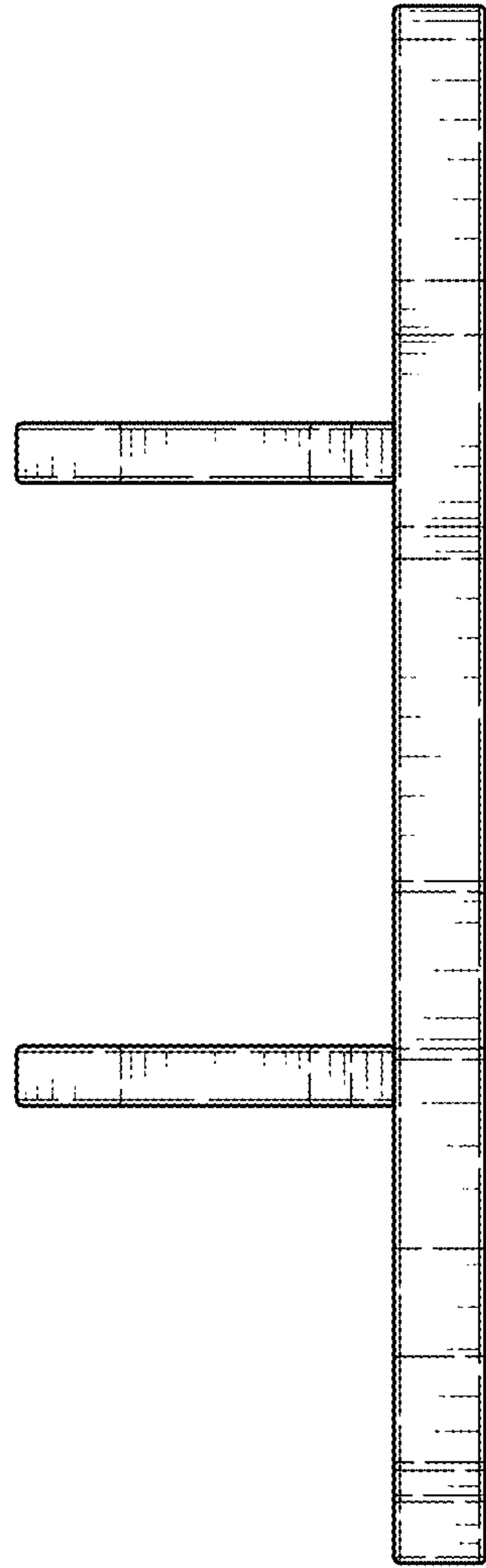
